U. S. CHARGES TITO'S ARMY WITH ATTACKS

Describe Troops Firing Upon American Forces Inside Allied Zones

Washington, Aug. 19.—(AP)—The United States charged publicly today that on July 12 Yugoslav soldiers illegally entered the allied zone around Trieste and fired on American forces investigating their presence.

The American view of the clash was made known with the release by the State Department of a note delivered to the Yugoslav foreign office last week.

At the same time, the State Department made public a three-months old rejection of Yugoslav complaints about American and British administration in Venezia Giulia and said in this connection that we have known for a long time that the Yugoslavs have been doing what they can to discredit the allied administration there.

Yugoslavia previously had contended that the U. S. was responsible for the incident and had protested on that basis. On this point the American note declared, "this government rejects the Yugoslav protest of July 16, which is apparently based on distortion of evidence available to Yugoslav as well as U. S. military authorities. "Once again," the American note said, "the Yugoslavs opened fire which was again returned by the U. S. Patrol. It was not known at this time that there was any casualty among the Yugoslav forces who withdrew."

Vanceboro Man Killed In Wreck

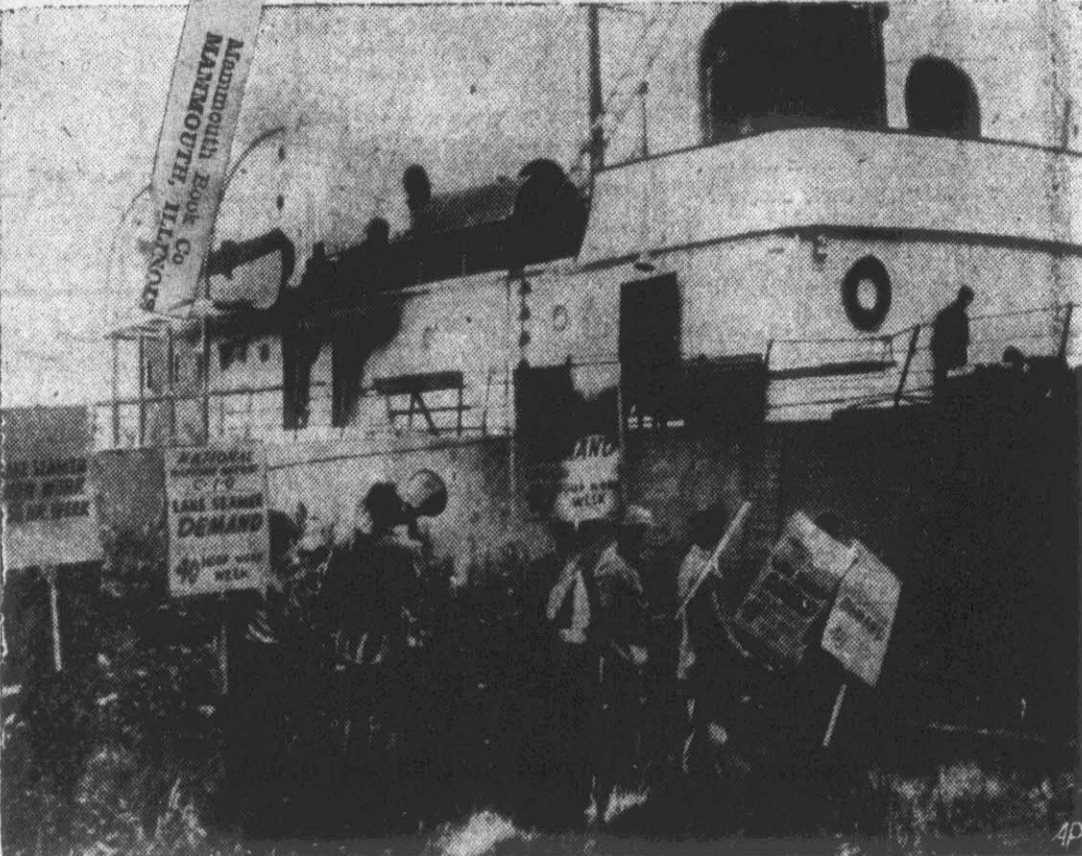

PEACE TALKS IN LOW GEAR

Discussion Of Italian Treaty Slows Peace Makers

Paris, Aug. 19.—The peace conference went into its fourth week in low gear today as the Italian economic committee became involved in a lengthy discussion of how various chapters of the Italian treaty should be divided between it and the political committee.

Committees for the Polish and Hungarian treaties also began deliberations.

France touched off the discussion with a suggestion that the economic committee include on its agenda article 72, which sets up a conciliation commission in cases of disputes over Italian restitution of allied property.

Russia supported the proposal and Deputy Foreign Minister Vishinsky said it should be adopted as a general principle that all questions of a predominantly economic nature should be considered as falling within the committee's scope.

Brazil, Yugoslavia, the U. S., Greece, Belgium and White Russia all joined in the debate, agreeing that practically all chapters of the treaty have both economic and political aspects, and that consultation with the political committee was necessary to establish some line of demarcation. The Hungarian political and territorial committee chose Austrian delegate A. T. Stirling as its vice-chairman, and adjourned after deciding Hungary should make a written request to appeal before the committee.

Greenville Market Opens With Prices High; Prices Average Between 51 And 55 Cents; Close To Two And A Half Million Pounds On Warehouse Floors

With auctioneers chanting the bids on five simultaneous sales, the 1946 season of the Greenville tobacco market got under way this morning with prices high and sellers and onlookers highly pleased at the prospects of a prosperous fall for the tobacco growing section. Unofficial observers placed the day's average sales at between 51 and 55 cents a pound.

Today's offerings included first primings, lugs and some tips with a quantity of inferior tobacco of the higher prices for grades with color was expected to hold up the day's average. Better grades were apparently \$12 to \$15 per hundred pounds higher than last year, with the trashy tobacco showing losses of around \$3 to \$4. The price range, before the noon hour was from five cents to 70 cents, with the major portion of the leaf bringing 60 to 65 cents.

Close to two and a half million pounds of leaf was on the warehouse floors today with indication that about half that amount would be disposed of during the day's selling hours. Heavy sales were registered all over the Eastern Carolina line-cured belt, the world's largest, today and in Raleigh the federal-state agriculture departments' reports said the average ranged from 51 to 65 cents. Prices generally ranged from 41 to 62 cents, the report said, with good leaf, cutters, line and choice lugs bringing from 62 to 64 cents. Some top grades averaged around 66, with nondescript cropping to 40 cents. Principal offerings consisted of fair to line lugs, and fair to good cutters. General quality was better than on last year's opening. There were few tags turned. Quality generally was the same at all of the 16 auction markets. Kinston, one of the largest markets in the eastern, or bright belt, had a range from 35 to 67 cents a pound, with the bulk going for an expected average of about 54 cents. About 2 1/2 million pounds were on the floors there and about 1.1-2 million pounds were expected to be sold today. Cutters and best grades brought up to 60 cents. Nehru's Oriental Bloc

Indian Leader Promoting Inter-Asian Conference To Unite The East In A Powerful Bloc; Analyst Sees Potential Alignment Of East Against The West

The bloody rioting in Calcutta—outgrowth of the Moslem League's observation of "direct action day" in protest against the nature of the plan which British proposes for Indian independence—has been so terrible with its death-toll of over 2,000 as to obscure a Bombay news dispatch which potentially is incomparably more important. I refer to a statement by Pandit Jawaharlal Nehru, famous Hindu president of the politically dominant All-India Congress and likely head of the provisional Indian government which the British plan projects. He is promoting an inter-Asian relations conference which, he declared, when finally organized should unite the East culturally, economically and politically in a powerful bloc. The Pandit made a highly important addition to this startling declaration. He asserted that India should "develop closer relations with Russia," and expressed the hope that the Russians would participate in the inter-Asian relations conference. Now the term "bloc" has become dynamic as a result of European political developments in recent months. Its very mention immediately raises the question of what is happening to the "one world" ideal for which a lot of folk are striving. Of course there are blocs and blocs. Some are better than others. However, when Nehru proposes an Oriental bloc we inevitably come up

BRITISH ARMY CLOSES GATES TO PORT CITY

Report Underground Groups In Holy Land Schedule Offensives

Hai'a, Palestine, Aug. 19.—(AP)—British troops clamped a rigid cordon around the port area of this city today following a tumultuous weekend in which a group of illegal Jewish immigrants attempted unsuccessfully to scuttle a transport assigned to deport them to Cyprus. Tension mounted throughout the Holy Land as a result of the British deportation policy, and reports were published in London that all underground groups in Palestine were scheduled to launch a nationwide offensive today. The first infantry division, using Bren carriers, mounted guard in this city, after the Cyprus-bound transport Empire Heywood returned to Haifa following the unsuccessful attempt to scuttle her yesterday.

The British had used tear gas and fire hoses to drive 640 illegal immigrants from the transport Fenice, on which they arrived here from Europe last week, onto the Empire Heywood for transshipment to a refuge camp being prepared for 10,000 persons on Cyprus. The Empire Heywood finally left port yesterday morning, but returned less than an hour later after two small bombs exploded in her hold. A British announcement said the bombs caused no damage or casualties, but were "introduced into the blowing a hole in the side of the hold with the apparent object of vessel."

Eight hundred other illegal immigrants, who arrived here aboard the refugee schooner were transferred without incident yesterday to the troopship Empire Rival, which then left for Cyprus. (A dispatch from Famagusta, Cyprus, said the Empire Rival arrived there this morning.) Meanwhile, troops sought to maintain order at Tel Aviv, where a mass meeting yesterday to protest the deportation policy ended in violence. (Continued on Page Six)

TRAIN WRECK NEAR HAMLET

One Engineer Killed As Seaboard-Air-liner Is Derailed

Norfolk, Va., Aug. 19.—Engineer M. N. Kirkland of the Seaboard Air Line Railroad train Robert E. Lee was fatally injured, and Fireman M. C. Clark, severely hurt, when their locomotive and four express cars were derailed seven miles north of Hamlet, N. C., today at 7:50 a. m. The railroad headquarters reported the wreck. No passenger was injured.

According to a statement issued by Charles H. Sault, general manager of the railroad, the accident occurred on a double track. The passenger train in derailed train, causing several freight cars to leave the tracks but causing no injury to any of the crew of the freight train.

Kirkland, a resident of Hamlet lived only a short time after the accident. Clark was removed to a nearby hospital for further treatment. The Robert E. Lee, train No. 5 was southbound from Washington to Birmingham. Passengers were taken to Hamlet by motor, and there a train was made up to continue the trip south. Work was in progress on clearing the line, but no definite word was available here as to when it would be open.

Army Takes Up Changes In Awarding Of Honors

Washington, Aug. 19.—(AP)—The army set out today to overhaul the system that permitted more than 2,500,000 medals to be handed out to officers and GIs during World War II. Taking note of criticism aired before the so-called Doolittle gripe board, a department announcement said before the general staff has begun a review of awards and decorations as a first step toward assuring the distribution standards are applied in a uniform manner. Secretary Patterson said changes in procedure cannot affect past insignias that may have excited, but an insure future uniformity. Order Restored Slowly Among Rioting Indians

Calcutta's Streets Strewn With Thousands Of Corpses; Epidemic Threatens; Mobs Loot, Slay And Destroy

By DONALD RUTH Calcutta, Aug. 19.—(AP)—Moslems and Hindus killed each other at a slackened pace today in the stinking streets of Calcutta, which on four days have been strewn with 2,500 to 3,000 corpses.

The situation was the quietest since Friday when the rival factions started the most sanguine riots in Calcutta's turbulent history, quarreling over differences regarding the British proffer of independence. Sporadic shooting continued. Eerie cries rang through the streets. Bodies were piled here and there many of them dead four days and picked by vultures. Many were also bloated. The danger of an epidemic which might tward the number of casualties mounted by the hour.

Several thousands lay wounded. The food situation worsened as stores remained closed. Looting was rife. Police blotters were filled with accounts of women sadistically raped, mutilated; then butchered or burned with their families. One seven-year-old rape victim was removed to a hospital in a critical condition.

Fifty boats, owned mostly by Hindus, were burned on the river. The troops with tanks strove to restore order. Hindu and Moslem leaders tried to regain control of the mobs. They met yesterday and hostilities ceased for a few hours but soon erupted again.

Disposal squads were extending their routes in picking up bodies in areas where the combined riot of troops and police had restored order, generally on the main streets. The hunger and poorer Indians could see fruit, vegetables and eggs rotting at railroad platforms and in barrels. Telephone and telegraph office workers had depleted staffs and services were hampered. Detroit, Aug. 19.—(AP)—CIO seamen striking on the Great Lakes, hampered by what their leaders described as resistance of CIO steelworkers, planned today to appeal directly to the steelworkers' rank and file for support. A rift within the CIO first showed itself in the Buffalo area. Today Joseph Stack, in charge of the CIO National Maritime Union's strike headquarters, told reporters "we are tired of waiting" for regional directors of the steelworkers to "make up their minds." Mass meetings will be held at steel docks, he said, to persuade the steelworkers not to injure the strike.

Meantime the NMU opened a determined effort to push all freight shipping off the Great Lakes by next Sunday. The union announced new charges have been filed with the Coast Guard at ten shipping companies have violated federal regulations by sailing more than 20 ships with inadequate crews.

On the fifth day of the partially-effective Great Lakes strike, this was the picture: 1. An official of the CIO Maritime Union denounced the CIO steelworkers at Lackawanna, N. Y., for "damaging" the strike by unloading iron ore vessels at a steel mill.

PRICE BOARD SPEEDS STUDY

Decontrol Board Will Meet Deadline; OPA Sets New Prices

Washington, Aug. 19.—(AP)—OPA today authorized a retail price increase of approximately six per cent for household mechanical refrigerators. On a standard box, OPA announced the increase will be from \$10 to \$12.

Consumers will pay the higher prices, as soon as dealers receive refrigerators ticketed the new ceilings. The increase for refrigerators follows price hikes of from three to 12 per cent on radios, washing machines, vacuum cleaners and a long list of other household items.

The OPA said dealers had been required to absorb 2.5 per cent of a previous increase granted to manufacturers. Under the new law, this cost absorption is outlawed. With substantial progress toward a decision reported by the three-man decontrol board resumed deliberations on whether price ceilings should be restored on meats, dairy products, etc. The board, which may wind up discussion by nightfall is planning to announce its ruling at 7 p. m. (EST) tomorrow—just five hours before the deadline set by Congress.

It must place in effect by Saturday many more of the price increases required by the new price control law. Coal prices may have to be raised, too, and an increase may be. (Continued on Page Six)

REPORT ARMY PLANE AGAIN UNDER ATTACK

Is Second Such Episode Over Yugoslavia In Twenty-Four Hours

Trieste, Aug. 19.—(AP)—An American transport plane near the Yugoslav border radioed today that it was under fire from anti-aircraft guns, leading to speculation that Marshal Tito's forces again had attacked an American plane accused of infringing upon his territory.

The transport tonight was booby overdue and its flight from Vienna to Udine with a crew of five men. This attack report came less than 24 hours after the U. S. embassy in Belgrade announced that Yugoslav fighter planes fired machine gun bursts August 9 into another transport on the same route.

Both transports were assigned to three U. S. army European transport service, an doth were plying the route from Austria to Udine airport in the British-American occupation zone of the Venezia Giulia area, dispute between Italy and Yugoslavia.

Would Cut Quota Of Immigration

Washington, Aug. 19.—(AP)—A move to slash immigration quotas took shape anew today in a backfire to President Truman's announcement that he would press for the entrance of European refugees to the United States. Rep. Gossett (D-Texas) said he will re-introduce a bill as soon as congress reconvenes calling for a 50 per cent cut in all quotas.

Telling a reporter he has "wide-spread backing" for his proposal, the Texan said a similar measure was defeated by only two votes in the house immigration committee this year.

Mr. Truman said in his statement on Palestine last week that he was "contemplating" asking congress for special legislation to authorize the entry of a "fixed number" of displaced persons from Europe, including Jews.

Even before Gossett's disclosure it appeared that the President's proposal, if he makes it, will be in for rough going.

Senator Andrews (D-Fla), a close friend of Mr. Truman and his seatmate for several years when the President was a senator, said flatly in an interview that the senate immigration committee, of which he is a member, "will not be in favor of increasing the quotas."

Wheat Piles Left To Mercies Of Weather

Spokane, Wash., Aug. 19.—(AP)—Three millions bushels of wheat in the Pacific Northwest left begging for storage space because of an unprecedented crop and a shortage of railroad cars, are being piled in great mounds on the ground at the mercy of the weather, a survey disclosed today.

One reason was the bumper crop. The Washington State Production and Marketing Administration estimated it will total at least one-fourth larger than the previous record crop of 1944. The PMA predicted harvest of 81,138,000 bushels, compared with 63,213,000 last year.

"Nationalized" Coal

Temporary Federal Management Of Coal Mines Gives Workers Best Contract Terms Yet; Operators Fearful Lewis Would Not Sign With Them

WARD (For Marlow) Washington, Aug. 19.—(AP)—After 12 weeks of government operation of the bituminous coal mines, one thing stands out: There appears to be little chance that the coal mine administration—meaning the government—can get out of the mining business for many more weeks—perhaps not before next spring.

On the surface at least there appears to be no big hurry. Here is why: 1. Coal is being mined as usual in fact, production for every full work week since federal seizure on May 22 has been higher than it was a year ago.

2. The miners are working under a contract containing probably the terms they ever had. 3. The operators, although charging, are making about as much money as before, in most cases. OPA upped prices as a result of the new contract and demand for coal continues to be heavy.

The owners have been designated as mine managers and go about the business just as though a four-star admiral was not sitting in Washington overseeing their business. Without doubt much of the smoothness with which this enforced—and emphatically temporary—"nationalization" has taken place is due to the personality and executive ability of Adm. Ben. Morell, boss of the Seabees during the war

and now running the mines as coal mines administrator. Morell has moved the navy into. Commanders and lieutenants have taken over whole wings of the Interior Department here, with well over 100 officers and 100 enlisted personnel (including Waves) shifting from concern over nautical matters to such things as the shortage of coal cars.

Although admittedly not happy over the prospect, Morrell's figure on being boss of the mines for a long while. He told this reporter he thinks government collectivization is a poor substitute for collective bargaining, but he says he does not know what else could have been done to end the critical 59-day strike last spring. Morell has had some collective bargaining to do himself. He made the first contract covering mine supervisory workers in the industry's history. But in doing so he heightened a controversy that poses one big obstacle to a quick return of the mines. Morell was carrying out terms of the original strike settlement, when he negotiated the supervisory pact, and so far two courts have refused to upset the agreement. However, the District of Columbia Court of Appeals has granted Morell priority on his full dockets to a review of the entire body of unionized supervisory workers. PROVIDENCE BEYOND HUMAN UNDERSTANDING

The providences of God are hard to understand. Frequently they are beyond human understanding. Perhaps they are never meant to be understood.
A soldier on twenty-four hour leave recently received a hurried call to return to camp just as he was about to board a bus for a visit home. His disappointment was immeasurable until he read in the paper next day that the bus had plunged over an embankment with the loss of a number of lives and the injury of almost all the remaining passengers. I knew a man more than thirty years ago who fairly tore his hair when he got to the pier a few minutes after the Titanic had pulled out. He was greatly humbled as during the next week he read column after column describing the greatest of all marine disasters and realized that he had been spared suffering and probably death. A number of returned soldiers have told me that they went into battle with several hundred of their companions and returned with a corporal's guard. In World War I, a lieutenant and a top sergeant were suddenly ordered to the rear to receive further training preparatory to their becoming instructors. The day after they left, all the officers of their regiment were killed.
No one can tell why such things happen. The length of our lives is no doubt definitely determined, but certainly we are responsible for many things which may contravene the will of God and take us away before our appointed time.

for India's 90 million Moslems, disliked the British independence plan because the strongly-Hindu Congress party, far the largest political organization in India, gained wide control. Moslem League demands for Pakistan, or partition of India between Hindu and Moslem areas were rejected in the independence scheme.

Evacuees from every section of Calcutta, a city of 1,250,000, continued their frightened treks to rescue stations, police headquarters and precinct stations. The refugees were rejected in the independence to sleep in hallways.

Police reports showed hundreds of men, women and children were butchered or burned to death in the Buxtee (tenement) areas.
The Moslem-Hindu battling continued during the night in many localities of this sprawling city of 1,250,000 population, although police restored some semblance of order in the eastern and northern sections.

British troops, supported by light tanks and civilian police, patrolled the streets, many of which were clogged with bloodied bodies. Some corpses have been lying in the sun since Friday, thus posing a serious health problem and presenting the possibility of an epidemic.

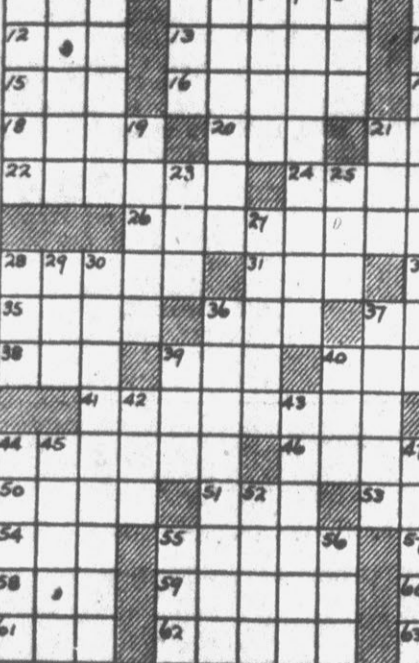
Three carloads of bodies were parked in the middle of the Harrison road, one of the centers of the fighting. Some were covered with water from open hydrants. Vultures picked at the bodies.

today the outlook was "excellent for an entirely effective strike-bound Great Lakes within a week."
Most Lake sailors are unorganized. The NMU has already tied up some unorganized vessels by pulling their own members off, and hopes to persuade many non-union men to join the struggle for a 40-hour week.
Though today's negotiations were with only two companies, settlements could conceivably influence the rest of the industry.
NMU president Joseph Curran was in New York to reopen talks with the Bethlehem Transportation Co. This firm, a subsidiary of Bethlehem Steel, operates about 12 ore and coal vessels, most of which are strike-bound. Other NMU leaders were in Chicago to talk with Standard Oil of Indiana, which operates a tanker fleet.

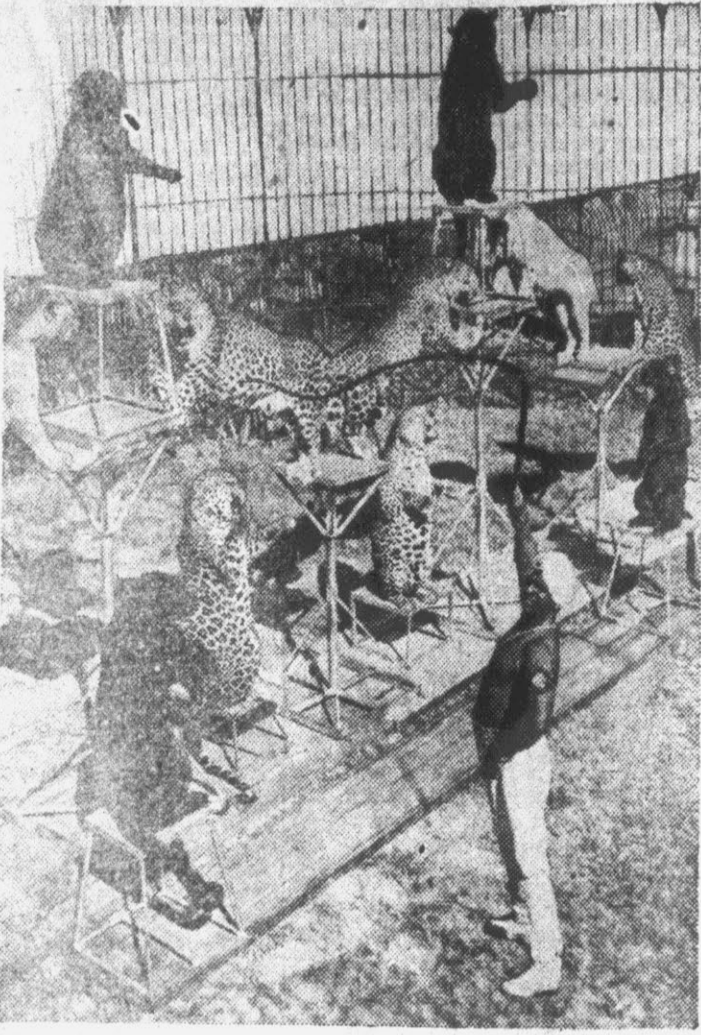
