TURKS REJECT DEMANDS OVER DARDANELLES

Upholds Montreux Treaty; Says Peace Lies In Soviet Friendship

Ankara, Aug. 24 (AP)—The Turkish government, commenting that it was having "difficulties in understanding Soviet apprehensions" with regard to the Dardanelles, has rejected flatly Russia's demands for joint defense of the strategic strait and for narrowing control of that vital waterway to Black Sea powers only.

"The government of the republic is of the opinion that Turkey herself is interested in defending with all her might the country against aggression from whichever side it may come," the government said in a long note to Russia made public last night.

"To want to reinforce the form of defense at a moment when all nations of the world compete with ardor to bring their contributions in creating an era of peace and security would be to deny the existence of the aims of the United Nations and show x x x distrust, the cause of which the Turkish government does not understand.

"The most sure guarantee of the security of the Soviet Union in the Black Sea," said the note, "resides not in a search for privileged strategic position in the strait x x x but in the restoration of friendly and trusting relations with a strong Turkey, which has decided to use all her forces to inaugurate this happy era but whose efforts in this sense need to be seconded by equal goodwill coming from her northern neighbor."

The reply, handed to Russia Thursday, followed precisely the lines of earlier American, British and French notes rejecting both Soviet penetration of the strait and the proposal to shut off control of the Dardanelles from all nations except those on the Black Sea, to which the strait links the Mediterranean.

The latter proposal, Turkey's note said, seems "to bar in the first place the duration on Montreux (the Montreux Convention of 1936 which set up control of the Dardanelles, with Turkey the guardian) which is destined to live at least until 1956," and in addition, the note continued, it seems "to want to ignore the interests of other signatory powers which have an equal right to participate in the negotiations."

The note expressed Turkey's willingness for an international conference to bring the Montreux Convention up to date and urged that (Continued on Page Three)

Call Warehouse Traffic Hazard

Kinston, N. C., Aug. 24 (AP)—After having been aired here in Lenoir County superior court before Judge Leo Carr of Burlington, an injunction hearing against warehouseman C. R. Ross of Clinton, owner of the Center Brick Warehouse there, is headed for the state supreme court.

A restraining order last week closed the warehouse, on the eve of the opening of the tobacco season when the city of Clinton complained to Judge Carr that the warehouse constituted a traffic hazard.

The city of Clinton said that a building permit was given Ross in May, 1945, and that he was allowed to operate last season. A city ordinance, under which a restraining order was issued, provides for a \$50 fine for selling, offering for sale, or buying tobacco on the site of the Ross property, thereby placing a penalty not only on the warehouseman but on the tobacco grower.

Feeling is running high over the matter, and 500 Sampson County farmers signed a resolution to boycott the Clinton market until the warehouse is allowed to reopen.

A Changed Yugoslavia An Old And Well-Liked Friend Suddenly Appears Warlike; Friendliness To America Still Felt By People; Marshal Tito Blamed For Aroused Hostility

The Yugoslavia we have been seeing the past few days isn't the old Yugoslavia we used to know—the gallant little friend beside whom we fought in two world wars.

Of course the Yugoslavs always have been two-faced fellows in defending their rights, but it's against their nature to break the bond of friendship once given.

One cannot believe that the loyal and friendly nature of the average Yugoslav has been changed overnight. Indeed, that thought is supported by the statement made yesterday by Capt. William Crombie, of East Longmeadow, Mass., pilot of the U. S. army transport forced down over Yugoslavia a fortnight ago by gunfire from Yugoslav fighter planes. The crew and passengers of the transport were assigned a Yugoslav captain as liaison man, and of him Capt. Crombie said:

"He treated us so well that before we left we bought him a silver cigarette case."

"So the old spirit of friendliness still lives in Yugoslavia—perhaps in the majority of hearts. However the country is in the grip of a totalitarian dictatorship which has proclaimed a new political code of regimentation. Under that code the individual acts as the government decrees.

U.S. READY TO FILE CHARGES

New York, Aug. 24 (A formal American complaint against Yugoslavia containing a request for appropriate action was held in readiness today for prompt delivery to the United Nations Security Council if Marshal Tito has not responded satisfactorily to the U. S. ultimatum by the undetermined deadline hour.

The U. S. case was prepared after conferences in Washington between acting Secretary of State Dean Acheson and Herschel V. Johnson, American delegate to the security council.

Plads Guilty To Marriage Mill

Camden, N. C., Aug. 24 (AP)—Pleading guilty, through counsel, on 23 of 25 counts charging violation of the state marriage law, J. G. Eberidge, register of deeds of Camden county, was fined \$300 and costs by Judge R. L. Whaley in County Court here today and ordered by the court to restrict the issuance of marriage licenses to his office and to office hours.

Eberidge did not appear in the court, submitting his plea through his counsel, R. Clarence Dozier, and the hearing of the matter consumed less than three minutes. No evidence was offered, the proceeding being confined to the erasing of one warrant by the solicitor, the entry of the plea of guilty on the 23 warrants handed up by the state and the announcement of the fine.

OPA PREPARES ENFORCING OF MEAT CONTROL

Now Perfecting New Machinery To Police Future Meat Sales

Washington, Aug. 24 (AP)—Turning from price rises to price slashes, feverishly busy OPA today concentrated on its next big job—rolling back meat prices without reiving the black market.

Price officials predicted the government would be ready next week to announce more effective machinery for policing meat sales and slaughter than ever before.

In readiness for the restoration of livestock ceilings next Thursday and retail meat ceilings Sept. 9 OPA's staff of meat inspectors is being brought well above its June 30 strength of 800 men. The enforcement team will be strengthened by the Agriculture Department and other agencies.

The agency still was convinced it would make good on administrator Paul Porter's promise to bring meat ceilings back "at or close to" June 30 levels.

The story was different yesterday, the 30th day since Congress breathed new life into OPA. Price boosts for trucks, cotton goods, fats and oils, tuna fish, warm air furnaces, metals and building materials—all most all required by the new price law—poured out from morning until night.

As a climax, OPA opened the door for further price increases on new automobiles, but not in a way likely to please automobile dealers.

Price Boss Porter rejected a proposed general 3-percent increase, designed to cover handling charges on new cars. It was requested by dealers under the price law amendment which guarantees prewar profit margins. The increases would have come on top of a 7.3-percent boost granted two weeks ago.

Instead, Porter offered individual increases to any dealer who can show that he charged substantially more before the war, for "preparing and conditioning" automobiles, than he is getting now.

The price agency announced that ceilings on margarine and shortenings would be 1 cent a pound higher than June 30 levels when fats and oils are placed under ceilings again Sept. 9.

ROY T. COX WILL RETIRE

Register Of Deeds Resigns; Farmville Man Appointed

U. S. Officials Believe Plane Occupants Killed

Beigrade, Aug. 24 (AP)—A mass grave believed to contain the bodies of all five occupants of an American transport plane shot down by Yugoslav fighters last Monday will be opened by U. S. officials today to verify a report by Premier Marshal Tito that no one parachuted from the blazing C-47.

VIOLENCE AT STRIKE SCENE

Winston-Salem, Aug. 24 (AP)—Everything was quiet early today about the Piedmont Leaf Tobacco Company plant in the heart of the Negro business district here after an outbreak of fighting late yesterday between police and pickets of the strikebound plant.

At one time as many as 3,000 Negroes, representing strikers and sympathizers swarmed about the plant as police used clubs to quell fighting which flared up when officers attempted to escort a truck into the plant yards.

Philip Koritz, director of the United Tobacco Workers Local (CIO), succeeded in dispersing the angry crowd early last night but only after at least five pickets were injured and one policeman was hurt about the face.

Early in the fighting Koritz and several pickets were "taken into custody." Police Chief John M. Gold said, but Koritz was released after an agreement with Governor R. Gregg Cherry to attempt to disperse the angry crowd. Authorities had contacted Governor Cherry when it seemed probable the fighting might grow into an uncontrolled riot.

Federal Employment

Washington, Aug. 24 (AP)—Thousands of government workers are being laid off monthly. People ask: How come? I thought a government job was a lifetime job.

Here are questions and answers about working for the government. Q. Why are thousands being laid off? A. Almost all are temporary wartime workers. The government is shrinking back toward peacetime size.

Q. With many thousands still to be laid off, is there any chance of getting a permanent job with the government? A. Yes. But to do so, you must pass a civil service examination. These tests will be held from time to time, as the need arises for special kinds of permanent workers, like stenographers or chemists.

Reported Death Of American Fliers May Affect Future Actions; U. S. Unsatisfied With Yugoslav Reaction To Ultimatum; 48-Hour deadline Is Reached

Washington, Aug. 24 (AP)—The reported death of five American fliers shot down in their unarmed plane raised today a strong possibility that the United States may still hail Yugoslavia before the United Nations Security Council.

The action depends on: (1) A forthcoming report from Ambassador Richard C. Patterson on his conference with Premier Marshal Tito.

(2) Patterson's findings in the two cases of attacks on American transport craft by Yugoslav fighter planes.

Pending an official report, the State Department remained silent on its next step. Its 48-hour ultimatum to Yugoslavia had demanded, technically, only the release of the occupants of the two planes who were still alive.

The Yugoslavs already have released all but one of the men aboard the first American plane downed. A Turkish captain, seriously wounded in the attack, remained behind when seven Americans and two Hungarians were set free.

Technically, that would seem to comply with the wording of the ultimatum.

But Undersecretary of State Acheson made it clear at his news conference yesterday that this government was just as interested in the casualties—including the Turk—as it was in those who were subjected to temporary internment.

In stressing this point, however he declined a yes-or-no answer on whether the United States was "satisfied" that the conditions of the ultimatum have been met by the release of the occupants of the planes alive or travel.

Nor would he say definitely whether the United States still contemplates laying the issues involved in the attack before the Security Council, beyond replying: Look at the note.

With or without intention, Acheson's suggestion lent emphasis to one paragraph of the ultimatum which read:

"The use of force by Yugoslavia under the circumstances was without the slightest justification in international law, was clearly inconsistent with relations between friendly states, and was a plain (Continued on Page Three)

Local Leaf Mart Averages \$52.33

Sales Supervisor W. L. Whedbee announced today that the official figures for the past week's operations on the Greenville Tobacco Market showed 7,054,000 pounds sold, bringing \$3,896,567.10. This put the week's average at \$52.33 per hundred pounds.

Friday's sales cleared all the warehouse floors in town of every pile of tobacco.

Wilson, N. C., Aug. 24 (AP)—The end of the first week of sales on the Eastern North Carolina tobacco belt showed prices for some grades of leaf recovered from Thursday's slump.

Some better qualities, however, registered losses of from \$1 to \$5 on yesterday's market.

Good lemon leaf at \$64 was down \$1, low orange leaf at \$45 was down \$2, and fair orange leaf at \$51 was down \$5.

Cutters changed from gains of \$1 to loss of the same amount, lugs were unchanged to \$8 higher, and primings ranged from \$4 lower to \$1 higher.

Increase in the heavy volume of sales was predicted for next week. (Continued on Page Two)

THE KINGDOM OF GOD... It has always been an amazing thing to those who pondered the gospel that Jesus should have spoken so much about the Kingdom of God and his followers so little about it.

Jesus lived in an age when men were talking a great deal about the coming of a new social order. Jesus said, "The Kingdom of heaven is within you"; and while a new social order might come as a result of the Kingdom of God, the Kingdom of God was then and is now that inner spiritual state of tranquility and power which comes when finite man surrenders his will to the will of the infinite God.

Reports from outside Yugoslavia that Tito had rejected the American note were not borne out here. The reply to Patterson gave permission to an American investigating party to remove wreckage of the plane shot down Aug. 9. Patterson and his military attaché, Col. Richard Partridge, expected to view the wreckage of this C-47 today.

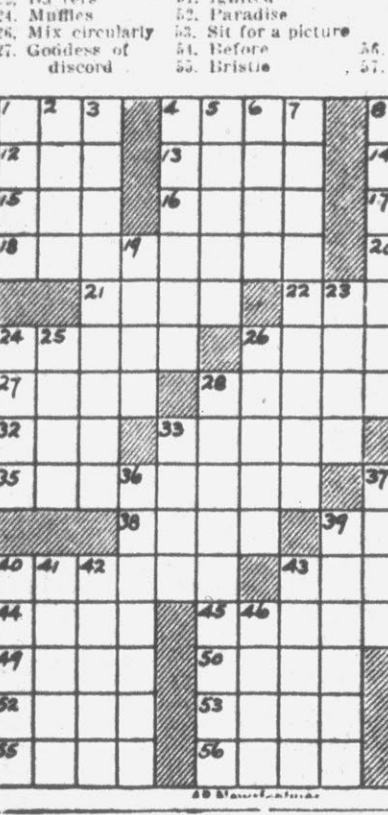

(Continued From Page One) that outside interference wasn't welcomed in the great Slavic bloc of which Yugoslavia is an important unit. We can take that thought a step further. No matter what may be the final word regarding the assault on Uncle Sam, and the American ultimatum to Tito, this much we can say now: Marshal Tito has painted with the flaming red of danger the line of demarcation between the Russian-dominated bloc of eastern Europe and the western democracies. Close observers knew, of course, that this division existed—that two definite divisions had grown out of the great post-war realignment of power—but a lot of folk have been living in the wishful thought that the barrier might be lowered.

Now Tito has made it plain that such hope is vain—at least at this time. Your correspondent, while fully recognizing the dangers (and they are grave) declines to surrender to abject pessimism. Although it's true that communism and western democracy can't successfully amalgamate into one government, there is no reason why a communistic country and a western democracy shouldn't live side by side without going to war.

At another point, it said that if the demands were met, this government will "determine its course in the light of the evidence then secured and the efforts of the Yugoslav government to right the wrong done."

Acheson said that he knew nothing except what he had read in a newspaper of a report by Tanjug official Yugoslav news agency, that Tito had rejected the ultimatum.

The deadline on this country's 48-hour ultimatum to Yugoslavia in connection with the transport plane incidents presumably was reached sometime this morning but no one in Washington seemed certain about it.

Undersecretary of State Dean Acheson spoke the last official word on the matter at a news conference late yesterday, when he said that he frankly did not know exactly when the 48 hours would expire.

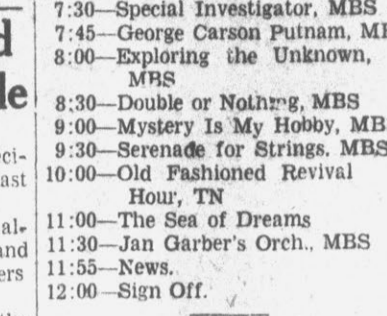
