Secretary of Agriculture Clinton P. Anderson resolved that dispute by taking advantage of the new power Congress granted him. He directed OPA Chief Paul Porter to hike the June 30 live animal ceilings by \$2.25 a hundred for beef and \$1.40 for pork in an effort to stimulate production.

OPA said ceilings still will apply Sunday to slaughterers and packers, on September 9 to wholesalers and on September 9 to the butcher shops.

To complete the program, the reconstruction finance corporation announced last night that effective Sunday it is resuming the slaughter subsidies which lapsed with price control June 30.

Otherwise the food price picture included increases for prepared pancake and waffle mixes, canned Hawaiian pineapple and pineapple juice, canned salmon and most syrups.

Gang Members Given Life Imprisonment

London, Aug. 29.—(AP)—The Colonial Office announced tonight that the death sentences against 18 Stern gang members convicted of bomb attacks on the Haifa railroad yards in Palestine have been commuted to life imprisonment.

The commutation was made by Lt. Gen. Sir Evelyn Barker, commanding officer in Palestine, who had to pass final review of the military court sentence.

Results of the review had been awaited tensely in Palestine, where Jewish underground resistance organizations had threatened reprisals against British officers and officials if the death sentences were carried out.

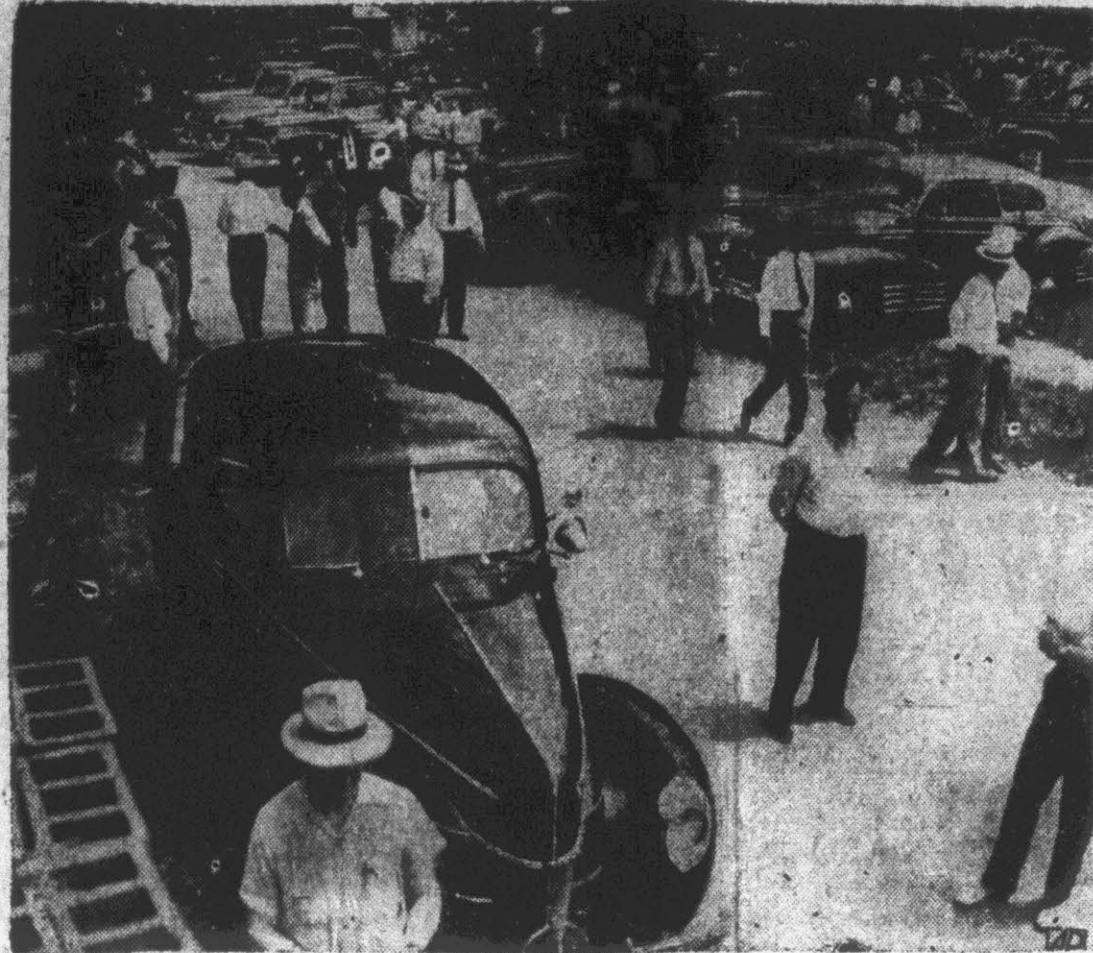
Impending Elections

Publisher's Son Is Found Dead

Elizabeth City, August 29.—(AP)—John Peele, 31, son of Herbert Peele, editor and publisher of the Elizabeth City Daily Advance, and Mrs. Peele, was found dead at the family residence here late yesterday afternoon.

Dr. W. H. C. White, county coroner, decreed that the youth had taken his own life and said no inquest was necessary. The body was discovered by Guy M. Leedy, business manager of the paper and neighbor of the Peeles, who have been vacationing in the mountains of North Carolina, after Leedy went to the Peele home to discuss a proposed trip of the youth to join his parents.

SEEK CLUE TO SUNKEN YACHT

Craft Goes Down, No Apparent Reason; Three Men Missing... South Haven, Mich., Aug. 29.—(AP)—Coast Guard patrols today searched for survivors of the lavish yacht Verano, mysteriously sunk in the rough seas of Lake Michigan yesterday just as a lifeboat bent on rescue reached her.

The 62-foot vessel, owned by Maynard Dowell, Park Ridge, Ill., manufacturer, went down "without a sign of life aboard" three quarters of a mile off shore north of here at 5:32 p. m. (Eastern Standard Time).

A renewed search of the waters by plane and boat was ordered at the hour of daylight today in the hope of finding the three men believed to have been aboard.

The Verano, which seamen said cost nearly \$100,000 to build, left Chicago early yesterday for Holland, Mich., where she was to get repairs.

Shore watchers saw the Verano in trouble seven and a half miles north of here, but already awash, she went down stern first as Coast Guardsmen who sped to her side were about to fling a line aboard.

The guardsmen glimpsed loose lines hanging from one side, indicating, they said, that the dingy she carried had been let down and that her passengers had abandoned her sometime before.

Owner Dowell said he could not account for the sinking. He said the Verano had a leak "along her keel," which was to have been repaired at Holland, but that he did not believe this could have been the cause.

War Dept. Is Concerned Over Large Number Illegally Wearing Uniforms

Washington, Aug. 29.—(AP)—The army, still worried about getting more men into uniform, is almost as fretful over how to persuade perhaps a million to doff their khaki.

That's the number the War Department suspects may be attired illegally in army dress—including some who never packed a rifle. They bought their military garb at surplus stores with no questions asked. The department is concerned for two reasons: 1. The army gets a black eye whenever some individual in uniform commits a crime or otherwise misbehaves in public.

Big Four Gather To Speed Work Of Peace Conference

Experts Predicting Record Nat'l Income

Raise Hopes For Balanced Budget As Trends Indicate Individual Incomes To Be Higher Than Booming War Years

Washington, Aug. 29.—(AP)—Figures compiled by government experts today indicate that individual incomes will set a record of around \$165,000,000,000 this fiscal year—exceeding the booming war year of 1945 by \$5,000,000,000.

Moreover, information gathered by the taxation staff employed by Congress and made available to a reporter suggests that even this estimate might be revised upward before the fiscal year ends next June 30.

This raised a possibility that the federal budget, thrown out of kilter by depression and war, might be brought into balance.

All these things are based on the assumption that the nation will remain relatively free of any large-scale strikes for the remainder of the fiscal year.

The new income estimates, concurring in the Budget Bureau compare with official predictions last year that the 1947 income would be around \$130,000,000,000. On the basis of those figures Congress wrote the first tax reduction in 16 years. President Truman took note of

the unexpected upward trend earlier this month when, in a revised budget message, he estimated tax revenues at \$39,000,000,000, against the January forecast of \$31,500,000,000. The peak income year of 1945 produced \$43,900,000,000 in tax receipts. These fell to \$40,672,000,000 in the year ended last June 30.

Notwithstanding the \$5,000,000,000 slash written by Congress in the 1.5% post-war tax bill, Mr. Truman's latest estimate of tax revenues for fiscal 1947 is only about \$1,000,000,000 below collections in the previous year.

In addition to the possibilities of a further boost in national income and in tax receipts, the treasury now is in the midst of an intensive drive to detect wartime tax evaders. Some officials say returns from this campaign may run into billions.

At the same time the government has ordered extensive cutbacks or delays in various federal construction programs.

All of which adds up to the possibility that America may see something it hasn't seen in a long, long time—a balanced budget.

GOOD ADVICE BY OFFICIAL

Allison James Urging Farmers Invest In Savings Bonds... Allison James, State Director of the U. S. Savings Bonds Division for North Carolina and Ted Merrill, Assistant Director, were in Pitt County yesterday calling on Mr. J. Herbert Waldrop, Pitt County Chairman, and Mr. W. H. Wooldard, Regional Chairman of the U. S. Savings Bonds Division, bankers, newspaper and radio station managers, tobacco warehousemen, and others, regarding the Fall farm program for the promotion and sale of U. S. Savings Bonds.

In urging Pitt County farmers to invest as much as possible of their tobacco dollars in U. S. Savings Bonds this season, James stated that "farmers, in 1946 are in the best financial shape they have ever been. Their mortgage indebtedness is at the lowest point since 1915. Through their splendid support of the War Bond drives they have salted away millions of dollars in War Bonds and have continued purchases of U. S. Savings Bonds."

"To add to this picture in North Carolina, tobacco crops are bringing good prices and it is predicted that the cash income for this state from our largest farm crop will exceed the \$58 million dollar mark of last year."

James warned that this situation is something like the power hooked up in an atom bomb—"It can be a power for good or it can blow the farmer all the way back to the deserts of 1920. And the outcome depends on what is done with these savings and current income. The safest thing to do now for all of us is to hold on to our War Bonds and U. S. Savings Bonds and to invest as much as possible from current tobacco dollars and other crop income, in U. S. Savings Bonds."

James stated further, that "this is not the time for farm families to plunge heavily into debt or over expand their credit. Debt should be held at a very conservative level, for a period of readjustment of prices surely lies ahead. The farmers (Continued on Page Three)

Spotlight Shifts To Foreign Ministers Council As They Attempt To Revitalize Bugged Down Peace Parley; Delegates Express Concern Over Differences

Paris, Aug. 29.—(AP)—The foreign ministers of Britain, Russia, the United States and France met this afternoon in an effort to find a way of revitalizing the Paris Peace Conference.

Shortly before the ministers gathered in the office of Georges Bidault, president and foreign minister of France, the conference had witnessed another of the clashes which have bedeviled the peace making. An Australian proposal to establish a sub-committee to collect factual data on the Italian-French frontier was beaten 13 to 6 in the Italian commission after a heated Australian-Russian exchange.

The four principal powers and nine other nations voted against the Australian plan.

U. S. Secretary of State James F. Byrnes, British Foreign Secretary Ernest Bevin, Soviet Foreign Minister Molotov and Bidault met in the building containing the famous clock room where the Big Four of 1919 framed the treaties which they hoped would end war.

Their first task it was believed, was to devise a common ground for dealing with the 300 amendments to treaty drafts which have snowed out conference action. As they met only the preliminaries to four of the treaties had been adopted in commissions. The conference itself had yet to pass on most of these, having passed on less than 200 of the 55,000 words in the five treaties for Bulgaria, Italy, Romania, Finland and Hungary.

Secretary Byrnes was the first to arrive at the Quai d'Orsay. He was accompanied by his advisers for the meeting, Sen. Arthur Vandenberg (R-Mich.) and Tom Connally (D-Tex.), and his interpreter Charles Bohlen.

This was the second set-back to major Australian amendments in the conference. Yesterday Australia was beaten in her efforts to have Russia's one billion dollar reparations bill against the five former enemy states involved here set aside for six months and made the subject of a special commission.

Polish Delegate Wincenty Witwicki urged the Italian political and territorial commission of the peace conference today to forget petty differences and get down to work. He reminded the commission members they had taken a full month to discuss only six and one-half of the Italian treaty's 92 pages, all of which must be considered by three commissioners and the full (Continued on Page Three)

Richardson said the warrants were issued for Boyce Gant, assault with a deadly weapon; Roy Monford Cline, assault; and Ruth Marr, assault.

The police chief said White was attacked as he attempted to drive a company truck through a picket line after police had partially dispersed the pickets with tear gas. Two other trucks were driven through the line.

White suffered a broken nose, Richardson said. Police reported that Gant had posted \$500 bond to appear in recorder's court tomorrow, that Cline was in Thomasville jail, and that the third warrant had not yet been served.

Step From Isolation

America Takes Another Step Into World Affairs By Agreeing To Let World Court Solve Some Of Our Problems; Background Of U. S. Decision

Washington, Aug. 29.—(AP)—This country has agreed to let the World Court have some say over some of our problems with other nations. This, like our joining the United Nations last year, is another step away from isolation. It took us 25 years to make this step.

The court's purpose is to try to settle international disputes—legal disputes—by international law. The court—called the International Court of Justice—is part of the United Nations machinery for keeping peace. All nations which became members of the United Nations automatically became members of the court. But only those nations which specifically agreed to let the court have authority over some of their problems could sue, or be sued, in the court. Twenty nations, including this country and Britain, have agreed

# JURY FOUND NEGRO GUILTY

## Howard E. Moore, Negro, Guilty Attempted Rape; Mistrial In Grey Case

By CHESTER WALSH  
In Superior Court today a jury returned a verdict of guilty of assault with intent to commit rape against Howard E. Moore, Negro, with the "clacking heel-plates." The jury deliberated an hour and a half. Judge Q. T. Nimmoek will pronounce sentence later.

The jury in the case of A. J. Grey, charged with assaulting a seven-year-old female child last September with intent to commit rape, could not agree on a verdict and Judge Nimmoek withdrew a juror and ordered a mistrial. The jury deliberated some time. The jurors stood nine for conviction and three for acquittal.

Howard E. Moore was charged with feloniously assaulting with intent to rape Mrs. Evelyn Jones on West Fifth street the night of May 26th while on her way home from the Pitt Theater, where she was employed as cashier.

Mrs. Jones testified that Moore followed her some distance, then went ahead of her, and that when she was in the vicinity of the railroad track, Moore blocked her way, grabbed her, made a vulgar remark to her and threatened to shoot her if she screamed. She testified that she ran into Mayor B. B. Sugg's yard, that nobody was up, and that she ran next door, to Sam Northrop's porch. She said her attacker disappeared. She remained at the Northrop home until she regained her composure, and then J. Carroll Waldrop, who lives nearby, took her to her home, she testified. Waldrop was one of the character witnesses for Moore. The case was given to the jury shortly before noon.

Police had slight clues to work on in apprehending Mrs. Jones' attacker. She insisted that the man

who followed and attacked her had very loud "clacking heel-plates." Captain Brewer, veteran police officer, took a cue for this and soon brought in Moore, whose loud heel-plates had attracted his attention. Mrs. Jones identified Moore and he later made a signed confession to Police Chief Jim Tanner, the chief said.

In the Grey case, Mrs. Sue Davis, who lives in the Edwards building next to the courthouse, testified that her daughter, Sue, seven years old at the time of the alleged assault last September, told her that Grey had been unduly familiar with her in the armory, where he had an office. Hearing of the case consumed the better part of two days. A number of witnesses testified as to Grey's good character.

Leroy Allen, who pleaded guilty to larceny of a sum of money from the cash register at Duke's Service Station, across the river, was given a lecture by the court for violating the terms of his probation. After being convicted of breaking and entering and larceny in 1945, he was placed on probation for two years, Probation Officer J. Wayland Sledge testified. Judge Nimmoek ordered Allen to serve his 18 months on the roads.

Luby Worthington, colored, placed on probation for two years in Greene County Superior Court in December, 1944, and who pleaded guilty in court here to breaking and entering and larceny, was ordered to serve his two years.

Yesterday, in the case of Louis Sutton, up on appeal from a lower court's conviction of having improper brakes on his motor vehicle, the court suspended judgment on payment of costs.

## William Gurganus Died In Farmville

William Godfrey Gurganus, 71, died at the home of his daughter, Mrs. R. L. Spivey, in Farmville at 4:15 o'clock Wednesday afternoon after several months' illness.

Funeral services will be conducted at the home Friday afternoon at 3 o'clock by Elder J. B. Roberts, Primitive Baptist minister of Farmville, assisted by Elder A. B. Ayers, Primitive Baptist minister of near Bear Grass. Burial will be in the Gurganus family cemetery near Stokes.

Mr. Gurganus was born and reared near Stokes. He moved to Robertsonville in 1917. He had lived in Norfolk, Va., and Greenville prior to going to Farmville in 1933. He was married to Miss Ella Powell in 1896, and they celebrated their golden wedding anniversary on March 10, 1945.

Surviving are his wife, four daughters, Mrs. Myrtle Roebuck and Mrs. R. L. Spivey of Farmville, Mrs. Roy A. Gray and Mrs. A. G. Roughton of Norfolk, Va., and 11 grandchildren and five great-grandchildren.



Washington.—While Congress de-  
bated its future, OPA's 24,000 em-  
ployees "managed to keep fairly  
busy."  
When President Truman asked

of being paid for their labor and  
loyalty, there was little griping.

"Our boss (Administrator Paul  
Porter) told us this was a period  
of golden opportunity to take care  
of our backlogs and to do some con-  
structive planning for the future,"  
one of them said.

"So we got busy planning in terms  
of whatever eventually comes out  
so that we will not be found flat-  
footed. We really did some funda-  
mental thinking."

He said that the possibility there  
would be no OPA at all hadn't oc-  
curred to any of the employees.

Meanwhile, attendance was nor-  
mal. And the United Public Work-  
ers of America began raising a  
"substantial" fund to help the em-  
ployees in case the payroll didn't  
come through. It also supported the  
agency in its request to other agen-  
cies not to raid its offices.

A lot of unfinished business on  
hand kept the employees from es-  
tablishing a battle-line around the  
soft-drink stands.

For example, the agency wanted  
to have ready for issuance. If and  
when OPA was to be restored, a  
whole lot of price increases that  
were in the works July 1. These were  
increases that came under this  
spring's new wage-price policy.

# Players To Have Voice In Policy

Chicago, Aug. 29—(AP)—Major league baseball owners, in an unprecedented move, have voted to put players on the game's new governing body and they will have a voice in the formulation of the game's rules and policies.

American and National League club bosses announced after a two-day meeting yesterday creation of a seven-member executive council which will include a player representative from each league. In addition to the formation of the governing body, top news to come out of the magnates' meeting with Commissioner A. B. Chandler was the adoption of a 168-game playing schedule for 1947 and approval of all contractual demands asked by players.

The 1947 season will be the longest in major league history, starting April 15 and ending Sept. 28. The new season will be 14 games longer than the present 154-game slate which has been standard since 1904.

Admission of the players to an executive council was the outcome of two recent conferences—the attempt of Attorney Roy Cohn of Boston to unmoor the articles and the talent runs carried on by the Mexican League.

Both the Romanian and Bulgarian governments are under Moscow's sponsorship and guidance. In the Russian zone of Germany communal elections are to be held Sept. 1 and the two following Sundays will provide a test of the strength of the Communist cause supported by the Red Army.

On the other side of the ideological fence, Greece is voting Sunday on whether to restore King George II to the throne. Britain and America are trying to ensure a free, secret ballot, but with the leftist opposition to the monarchy declaring in advance that the election will be unfair and threatening abstention, the full play of Democratic processes can not be expected. And Russia already is making her displeasure known in advance, by permitting her ambassador to leave Athens.

But the major election quarrel of the moment concerns Poland. A national election, intended to produce a new parliament, has been set tentatively for November. However the election laws have not yet been enacted and Tuesday the Warsaw government announced that the parliament session which was to have framed them, set for August 31, had been postponed indefinitely.

Whether this is connected with the current acrimonious exchanges between Washington, London and Warsaw—with Moscow in the background—is not quite clear. The United States and Britain took occasion last week to tell the Poles that reports of the June 30 plebiscite had not been reassuring as to the future of true Democracy in Poland and to ask for certain guarantees as to the November voting. Romania's political future extreme Poland replied with bitter "unofficial" statements saying in effect that it was none of the western powers' business.

That shows how far the nations have split on their interpretation of the agreements and pledges of Yalta and Potsdam. Those agreements in effect provided the charter for the new Polish state and fixed terms for its admission to the family of allied nations.

# Players To Have Voice In Policy

Chicago, Aug. 29—(AP)—Major league baseball owners, in an unprecedented move, have voted to put players on the game's new governing body and they will have a voice in the formulation of the game's rules and policies.

American and National League club bosses announced after a two-day meeting yesterday creation of a seven-member executive council which will include a player representative from each league. In addition to the formation of the governing body, top news to come out of the magnates' meeting with Commissioner A. B. Chandler was the adoption of a 168-game playing schedule for 1947 and approval of all contractual demands asked by players.

The 1947 season will be the longest in major league history, starting April 15 and ending Sept. 28. The new season will be 14 games longer than the present 154-game slate which has been standard since 1904.

Admission of the players to an executive council was the outcome of two recent conferences—the attempt of Attorney Roy Cohn of Boston to unmoor the articles and the talent runs carried on by the Mexican League.

Both the Romanian and Bulgarian governments are under Moscow's sponsorship and guidance. In the Russian zone of Germany communal elections are to be held Sept. 1 and the two following Sundays will provide a test of the strength of the Communist cause supported by the Red Army.

On the other side of the ideological fence, Greece is voting Sunday on whether to restore King George II to the throne. Britain and America are trying to ensure a free, secret ballot, but with the leftist opposition to the monarchy declaring in advance that the election will be unfair and threatening abstention, the full play of Democratic processes can not be expected. And Russia already is making her displeasure known in advance, by permitting her ambassador to leave Athens.

But the major election quarrel of the moment concerns Poland. A national election, intended to produce a new parliament, has been set tentatively for November. However the election laws have not yet been enacted and Tuesday the Warsaw government announced that the parliament session which was to have framed them, set for August 31, had been postponed indefinitely.

Whether this is connected with the current acrimonious exchanges between Washington, London and Warsaw—with Moscow in the background—is not quite clear. The United States and Britain took occasion last week to tell the Poles that reports of the June 30 plebiscite had not been reassuring as to the future of true Democracy in Poland and to ask for certain guarantees as to the November voting. Romania's political future extreme Poland replied with bitter "unofficial" statements saying in effect that it was none of the western powers' business.

That shows how far the nations have split on their interpretation of the agreements and pledges of Yalta and Potsdam. Those agreements in effect provided the charter for the new Polish state and fixed terms for its admission to the family of allied nations.
