AFL Asks To See Industry's Books

Union Calls Upon Employers To Open Financial Books As A "Realistic" Aid To Collective Bargaining; Would Avoid Strikes And Cooperate With Industry

Washington, Aug. 30.—(AP)—The American Federation of Labor called upon employers today to show their financial books to the union as an aid to collective bargaining.

Last fall and winter there was a nationwide controversy on this subject when Walter Reuther of the CIO Auto Workers demanded that the General Motors Corp. open its books.

The AFL, in the September, 1946, issue of its publication "Labor's Monthly Survey," said it proposes to speed production, avoid strikes and negotiate wage increases without price ceilings.

But it declared this policy will succeed only if employers are ready to meet its half way.

The AFL argument goes as follows:

- 1. Some industries, like foods, chemicals, paper products, and service, are earning substantial profits, varying from 12 per cent to more than 20 per cent on net worth.

- 2. Wages are low in some of those industries and many companies can afford a wage increase without raising prices.

- 3. In other industries, such as automobiles and electric equipment, some companies are operating at a deficit.

Then the AFL said: "These records show that workers need the facts if they are to formulate policies intelligently."

"We say to American employers: We have offered to cooperate with you as partners in improving production. Show us the facts so we can know the results of our efforts."

"We are not proposing that the books be published, as Reuther did at one point in his strike. We merely want them to be shown to the unions."

Charlotte, N. C., Aug. 30.—(AP)—More than \$1,200,000 in surplus government property has been purchased by veterans and other priority buyers at the first two standard on-site sales of the Charlotte regional office of the War Assets Administration, Deputy Director George O. Bason said today.

Of this total, \$1,039,000 in property was bought at the sale at the quartermaster depot in Charlotte which opened Aug. 5 and \$160,000 was purchased at the Tradd Street Naval Barracks in Charleston, S. C.

The WAA said veterans had been the heaviest buyers at both sales. In Charlotte they paid \$406,838 for 3587,828 in property while in Charleston they paid slightly more than \$100,000 for property which cost the government \$135,000 to acquire.

New War Dept. Policy

Prepares Atomic Weapons On Premise No Adequate International Controls Can Be Adopted; Tremendous Armament Race Already Under Way Says Analyst

Those responsible for the defense of the nation must make their plans on the basis that there is and will be no adequate control (of the atomic bomb) on the international level.

That is the current policy of the United States War Department as defined by Secretary Patterson.

"The only complete defense against the bomb is a system that will avoid war," says advisors of Bernard Baruch, in a supplement to the American control plan submitted for the guidance of the United Nations atomic energy commission.

CHINESE REDS FILE DEMANDS ON KAI-SHEK

Stuart's Committee Meets New Snag In Finding Road To Peace

Nanking, Aug. 30.—(AP)—U. S. Ambassador J. Leighton Stuart's committee of five, formed only yesterday to work out a peace for China, struck a possible snag today when the Communists demanded that Generalissimo Chiang Kai-shek make two major concessions before they would participate.

The generalissimo's troops, meanwhile, filed unopposed into Chengteh, capital of Jehol province, and by Communist admission captured three other important points to the south, but the Communists claimed they had scored such a resounding victory along the Yangtze it could change the course of the civil war.

The Communist negotiator, Gen. Chou En-Lai, handed his party's demands to Gen. George C. Marshall, special U. S. envoy, who left by plane for the summer capital to present them to Chiang.

It included a demand that the generalissimo guarantee to issue a cease-fire order as soon as agreement is reached on forming a coalition government initially through negotiations.

CIVIL RIGHTS NEED NEW LAW

Says States Should Let Fed. Gov't Act In Violations

Winston-Salem, N. C., Aug. 30.—(AP)—Assistant Attorney General Lamar Caudle called today for legislation that would let the federal government "act vigorously" when local authorities fail to prosecute civil rights violations.

At present, the head of the Justice Department's Criminal Division said in an address prepared for the North Carolina bar association, the government has "little power or authority to deal with the social and governmental situations which give rise to civil rights problems."

Caudle, who also is national president of the federal bar association, made no direct reference to any specific incident. The civil rights section of his division is investigating the postwar resurgence of the Ku Klux Klan and the recent lynching of four Negroes near Monroe, Ga.

Caudle said mob violence "or any attack upon basic rights should be a local problem of primary concern to local citizens, to be handled in the community in which it occurs by local officers."

But, he added, "where a local authority neglects or fails to act, your federal government should have the power and authority to act vigorously in the district where the offense is committed."

"The disrespect for the law, it is true, is the concern of the community in which it breaks out, but it is also a threat to all Americans everywhere and an attack on our established institutions—an attack upon your constitutional guarantees and mine."

Army Uncovers German Underground Movement

Soviet-Sponsored "Free Germany" Group Believed Operating In Western Zones; Arrest Germans In Big Spy Ring

Frankfurt, Germany, Aug. 30.—(AP)—Intelligence officers of U. S. forces in Europe said today a Soviet-sponsored German clandestine movement was believed operating on a large scale in the three western zones of Germany.

The officers made this report in connection with the espionage arrests at Stuttgart of 15 Germans with Soviet sympathies. An announcement said the ringleader has confessed to furnishing the Russians information of American troop movements.

The officers said the free Germany group was, according to best available information, operating in the American and British zones and recently had become active in the French zone of occupation.

The activities of the movement were officially described as illegal. The officers indicated that further arrests might be expected.

The Stuttgart Germans were described as members of the free Germany committee formed in Moscow in 1940, which originally was headed by General Von Seyditz.

Fifty-seven other German generals were known to be a part of it.

The Free Germany Committee, intelligence officers said, "had a membership of about 1,000,000 German officers and men. It is reported that all the members of this movement have been converted to communism and that some of them..."

Set Dates For Union Vote At Atom Plants

Washington, Aug. 30.—(AP)—Runoffs in the indecisive collective bargaining elections at atomic bomb plants at Oak Ridge, Tenn., will be held September 10, 11 and 12, the National Labor Relations Board announced today.

The AFL unions pulled the highest votes in two of the three plants at elections held August 20, 21 and 22, but failed to win a majority of any plant.

The vote for no union at all was highest at the Tennessee Eastman plant, one of the three involved, but a majority was lacking there.

Importnt Notice To Parents

Under a ruling of the North Carolina Department of Health and the Pitt County Board of Health, all children under ten years of age who are entering the Greenville City Schools this year for the first time must present a certificate showing immunization from whooping cough, diphtheria and smallpox.

These certificates may be secured from the Pitt County Health Department or private physician. This includes the children who attended the Pre-School Clinic last May. If these certificates are not presented at the opening of school on Monday morning, the child cannot enter school.

DISORDERS IN GREECE SHOW NEW VIOLENCE

Numerous Clashes As Populace Prepares To Vote On Monarchy

Athens, Greece, Aug. 30.—(AP)—Political violence increased sharply today as the Greeks prepared to vote Sunday on the fate of the monarchy. The ministry of public order said 21 persons had been killed and 32 others seized by Communist bands in the past 24 hours.

Slayings occurred in Macedonia, Thessaly and the Peloponnese. Four minor clashes were reported from Trokila, in Thessaly.

The heaviest attack was by 400 leftists, armed with automatic weapons, on a police station near Grevena, in western Macedonia. The leftists killed a policeman, seized six others and carried off 15 civilians after forcing the station to surrender. A rightist civilian and his son were slain.

Another outlaw gang of 100 attacked a police station near Tripolis, killing three police and wounding two.

Acting Premier Stylianos Gonatas prohibited announcement of the plebiscite results over loudspeakers and also forbade political gatherings. He congratulated leftists and rightists who had attended mass meetings in the past two days for their orderliness.

"Now is the chance to express our free will," Gonatas said in a formal statement. "If this day (Sunday) passes with calmness, everyone will know it is to the credit of Greece and will raise the prestige of the nation before the world."

The military said any complaints during the voting should be directed to the military supervisors at the polls. British observer teams will tour the balloting places. The U. S. State Department said it could not send observers because of lack of personnel. Russia rejected an invitation to send observers.

NEGRO TAKEN STATE PRISON

James Gibson, Escaped Convict, Held For Burglary And Rape

Pitt County Sheriff Ruel W. Tyson said today that Deputy Loyd Manning Wednesday arrested James Gibson, 31-year-old escaped Negro convict, and charged him with first degree burglary and criminally assaulting Mrs. May Reeves, mother of two children, at her home at a rural point, near Hanrahan, five miles from Ayden, last Monday night. Gibson was taken to State Prison last night.

The sheriff said Mrs. Reeves told him her husband, John Reeves, was in South Carolina conducting a revival; that a Negro entered her bedroom through a window, had his hand on her throat, choking her when she awakened shortly after midnight. He threatened her life and got in bed with her, still holding her by the throat, and assaulted her. Her attacker fled when one of the children on another bed awoke and screamed. She consulted a physician next day. Her neck was badly bruised. Sheriff Tyson quoted her as saying, "Gibson worked nearby on the Arthur Mills farm and was familiar with the Reeves premises."

Mrs. Reeves' attacker lost a cigarette case in the bed. When Gibson was arrested on suspicion next day, the officers learned that he had bought another cigarette case of similar make, and it contained the same brand of cigarettes. Deputy Manning measured the footprint.

ORDERS DEATH FOR SABOTEUR

Last Of 23 Members Of Terrorist Gang To Die Says Court

Jerusalem, Aug. 30.—(AP)—Jacob Manahem Alalay, the last of 23 members of the so-called Stern gang charged with sabotaging the Haifa railway yards last June, was sentenced to death by a military court in Jerusalem today.

The sentence is subject to confirmation by the British commander in Palestine, who last night announced that he had commuted to life the death sentences previously pronounced against 18 other members of the same group. Four girls tried with the 18 two weeks ago were sentenced to life imprisonment.

Alalay, whose leg was injured while fleeing Haifa incident, lay strapped to a stretcher reading a Bible throughout most of his trial.

He made no reply when the court asked if he cared to defend himself, to address the judges or to make a plea for clemency. The court then found him guilty of five of six counts connected with the attack on the rail yard's workshops June 17.

Russia Asks Report On Bases Of Allies

Grand Jury Makes Report

Judge Nimmo Praises Efficient Body Of Investigators

The report of the Pitt County grand jury, submitted to Judge Q. K. Nimmo of Fayetteville in Superior Court yesterday by Ben. F. Bullard, the foreman, is an interesting document and should be read by every citizen of the county. Judge Nimmo thanked the grand jurors for their efficient work. The report follows:

"We, the Grand Jury, have passed on all bills presented to us and have rendered our decisions in accordance with the evidence. We reviewed all bills of indictment, passing on all that came before us with the exception of two, which could not be passed upon because the witnesses are out of the state. These were turned back to the solicitor."

"We visited the State Prison Camp and inspected the buildings, grounds and interviewed some of the prisoners. We found it to be kept in very good condition, and the superintendent, Mr. Paul Crawford, is to be commended for his good work. We visited the county jail. We found that Mr. Leggett, the jailer, had a clean, sanitary jail. We talked with some of the prisoners and they said that they were taken care of in good manner. It is our opinion that the jail is kept in good condition. We visited the city jail and found it to be a thorough institution, and after every reason to believe that this is one of the finest and best kept municipal jails that we know of. We particularly want to commend Chief James E. Tanner and his staff for the efficient manner in which the jail is operated."

"We visited the jails in all of the outlying towns and municipalities. We found all of these jails in fairly good condition except the Grifton jail, which was in very bad condition, and which we recommend should either be improved very much or else condemned. We found (Continued on Page Three)

But United Nations circles speculated that it opened a whole new phase of Russian policy in the Security Council, where last night Portugal, Ireland and Trans-Jordan were excluded from the U. N. by Russian vetoes while Soviet-supported Albania and outer Mongolia failed to rally the necessary votes. Sweden, Iceland and Afghanistan were approved for membership without opposition. Their bids now go to the General Assembly for approval.

Hope of the new Russian proposal, which Russian Delegate, Andrei Gromyko hoped to lay before the council at its meeting this afternoon, would call for intelligence on American troops in China, and in fact examine the disposal of "friendly" alien forces over the world.

Gromyko brought his new demand before the council unexpectedly last night. The delegates had been in session almost nine hours and had just completed their wrangling and voting on the new members.

Molotov Charges British Army And American Navy Actively Influencing Vote On Return Of Exiled King; Peace Conferees Vote To Discuss Greek-Albanian Dispute

Paris, Aug. 30.—(AP)—Russia accused the United States and Great Britain today of interference in next Sunday's Greek election and charged the little Balkan country was paving the way for the return of exiled King George II with a reign of terror.

"We know British troops are there and American warships are on their way," Russian Foreign Minister Molotov told the peace conference during consideration of a Greek request to consider the Greek-Albanian border dispute.

Molotov asserted it was his time we put a stop to what he called outside interference and give the people of Greece a chance to select their own form of government. He contended that the present form of government in Greece is very unpopular among the Greek people. Greece is the only Balkan country not strongly under the influence of Russia.

Despite the bitter opposition of Russia and the Slay bloc, the peace conference voted 12 to 7 after four hours of blistering debate to discuss the Greek-Albanian border at its next meeting. The Greeks insist that a part of northern Epirus (southern Albania) now occupied by Albania, actually is Greek territory.

Secretary of State Byrnes during the debate declared: "It seems incredible to me that we would deny one of the 21 governments that furnished troops to aid us in victory the opportunity to present its case—regardless as to our views of their claims. The U. S. has no conviction on the territorial dispute but the U. S. would give the right to every member to be heard."

Molotov responded that Russia was not opposing a discussion of the Greek-Albanian border by the council of foreign ministers of the United States, Russia, Great Britain and France. He said the French had been right in insisting that the matter did not come under the five draft treaties prepared for peace conference consideration. On the vote, France sided with the Slav nations. Belgium and Norway abstained.

Talkative Eurasian Jailed In Gem Theft

Batavia, Java, Aug. 30.—(AP)—Carla Wolff, the slender Eurasian who bubbled that she would sleep in a gold bed, was sentenced to eight months imprisonment today for concealing \$500,000 worth of the \$26,000,000 Nakamura treasure or her Japanese paramour.

The fortune was stolen from residents of the Dutch East Indies during the Japanese occupation. Capt. Nakamura, who fathered Carla's children, turned over the \$500,000 to her at the time of the Japanese surrender.

It was Carla's mouthings which put allied occupation troops on the trail of the treasure. A British officer has been convicted of complicity in the case. The trials will continue Monday when the case of Renee Ulrich, once celebrated a Batavia's most beautiful Eurasian, will face the Dutch court.

Rights Of Employers

NLRB Gives Ruling On What An Employer Can Say To His Employees About A Union They Are Thinking Of Joining; Fine Line Drawn Describing Rights

Washington, Aug. 30.—(AP)—How freely can an employer speak to his employees about a union they are thinking of joining? This story will attempt to answer that question. It puzzles many employers because of two things:

- 1. Freedom of speech is guaranteed by the constitution.
- 2. The National Labor Relations Act, passed in 1935, says an employer shall not engage in unfair labor practices against his employees.

(An example of what that act calls an unfair labor practice: If an employer tries to prevent his employees from joining a union.)

This week the National Labor Relations Board issued a ruling in the case of a New York company. The union had complained to the board, which enforces the labor relations act, that the company had tried to keep its employees from joining the union.

The ruling said in part: "Standing alone and in the absence of other evidence, the representation of an argument (by an employer), temperate in form and containing no intimation of reprisal may not support an inference of coercion. "But the situation is quite different where it is clear that the employer's purpose is not merely to express his views, but rather to engage in an organized, intensive and aggressive campaign forming part of a general course of conduct aimed at achieving objectives forbidden by the act."

(The board, in the New York case, found that company officials one hour before the employees vote on joining a union, had made "an union" speeches and had done previously other things to discourage joining.)

Continued on Page Four the Grimesland jail in the same condition as the Grifton jail, and we recommend the same action to be taken in regard to it. We understand, however, that the Grimesland jail has not been used in the last six months, and that it is not their intention to use it in the future, and all prisoners are brought to the county seat from Grimesland.

The Fountain jail, we found, is fairly good except that it needs to be cleaned up and kept in much better shape than it was at the time we inspected it.

"We further recommend that the Winterville jail be furnished with new bedding for the beds and that it be kept in a cleaner condition in the future than it has in the past.

We visited the County Home and found that the inmates were receiving the best of care and supervision. Members of the Grand Jury were very much impressed with the excellent condition of the home and we commend the superintendent Mr. D. C. Wilson, and his assistants for their excellent work.

"Our committees have visited the various county offices and talked with the various county officers and find these offices functioning well. The records are neatly kept and the personnel capable and efficient. We found, in talking to the Register of Deeds that his office is undermanned and very much overworked. Since the end of the war there has been approximately 5,000 of our service boys back home and the majority of them are having their discharges recorded. The birth rate in Pitt county is estimated to be double that before the war, and these certificates are being recorded. There is an increased number of real estate transfers which is greater now than at any

other time in the history of the county. We, the Grand Jury, were very much impressed with this report, and we recommend that immediate action be taken by the Board of County Commissioners to provide sufficient funds to this department to carry on this increased work.

"Mr. D. H. Conley, superintendent of the county schools, and Mr. Forlines, who is head mechanic of the school bus system, came before the Grand Jury, and in talking with Mr. Forlines, he told us of the difficulties they have had in getting new buses, but he thinks they will have new buses within the next month or two. In the meantime, we were impressed with the efficient and careful manner in which the buses are handled and the care that is being taken in keeping them safe for transportation of the children. We would like to commend the good work he is doing. Mr. Conley explained at length the various difficulties confronting him.

"The Bethel school in particular needs inspection by a licensed contractor.

"We talked with Dr. Dennis H. Cooke, president of East Carolina Teachers College in regard to the college. Everything there appears to be in good shape and running very efficiently except that there were new dormitories for the ever increasing number of students, and some repairs to the Austin building.

"We find everything about the ABC stores in good condition as possible under the circumstances.

### POWER OF A GOOD EXAMPLE

A woman of wealth who owned a number of houses lost most of her money and was compelled to sell all her properties except one in order to get out of debt. This was a property in the center of a slum district. Her friends advised her against moving into such a neighborhood, but she paid no attention to them. She gathered up her beautiful oriental rugs, her lovely furniture, and moved them into this house in the slums. With the little cash she had left, she painted this house, fixed it up with attractive shutters and flower boxes so that it stood out like a bright jewel in an ash pile.

The result was that her neighbors were at first dazzled and overwhelmed. Gradually, however, they came to see that this rich woman who had moved into their midst was not a proud and overbearing creature, intent on lording it over her humble neighbors, but a gracious Christian woman who had made life pleasant for her no matter where she lived. Furthermore the slum dwellers began to look at this bright, lovely house and to compare it ruefully with their tumble-down places.

The upshot of the whole thing was that within five years the whole neighborhood had taken on a new appearance. One woman's silent influence had brought about results which charity and government subsidy could never achieve.

efforts are being made to "catch up" in Britain and in Canada, which co-operated in development of the original bomb but which do not have the complete "know how" even yet, important and expensive experiments are under way. The program in the United States continues at untold expense. No one knows what other peoples may be burdened with this war-preparatory load while struggling to rehabilitate themselves after the last one. But it is clear that if it continues the whole world is headed for a bleeding of resources which will make the costs of Europe's ancient standing army system look like a child's candy allowance, for an era in which uranium will not only substitute for butter, but also for meat, and for bread. Not to mention the fact that somewhere, sometime someone will take the desperate chance of war through sheer fear-weariness and to keep the other fellow from getting farther ahead than he is already.

The scientific committee of the UN control commission is busy studying concrete means of bomb control. It seeks to determine whether segregation of uranium may be an answer; whether there are any essential parts of the bomb, or steps in its manufacture, through control of which the entire making of bombs could be stopped. Others are trying to persuade the nations that it would be better to submit to outside inspection than to continuous fear. They weigh this angle, and that angle, none of which is more than a part of the whole.

But to end the situation in which Mr. Patterson finds himself, the Baruch group says we must learn to avoid war—not atomic war, or bow-and-arrow war, but war. Efforts to control the bomb alone can hardly prove worthwhile unless they are constantly considered as steps toward the ultimate, not the limited objective.

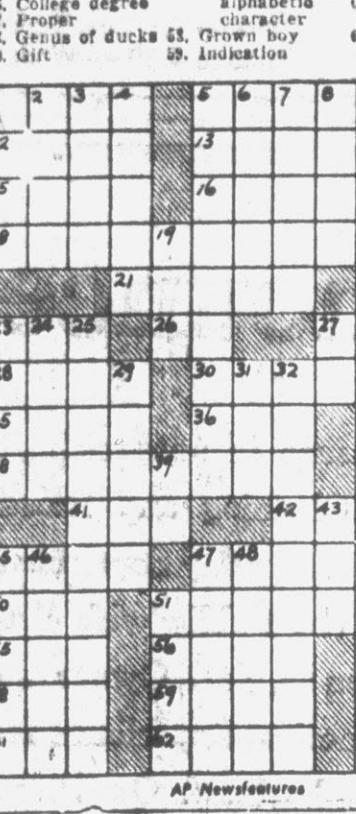


