BOMBAY RIOTS PRECEDE NEW INDIAN GOV'T

Many Killed And Injured On Eve Of Inaugurating New Government

Bombay, Sept. 2.—(AP)—Bombay police, reinforced by British troops pressed a sweeping roundup today of suspected trouble makers in an effort to prevent a new outbreak of bloody communal rioting in which 51 persons were killed and 178 injured during the week-end.

An official announcement said that approximately 500 persons had been rounded up prior to noon and declared the drive was continuing and would be intensified during the day.

Except for a few stray cases of stabbing since morning and a little tension in one or two areas the situation in the city is nearing normal, the announcement added.

Many of those injured in the rioting, which apparently was sparked by bitter Moslem-Hindu differences intensified by the Indian political situation, were reported in serious condition in hospitals.

A curfew beginning at 5 p. m. and ending at 5 p. m. Wednesday was decreed in Bombay riot zones this afternoon.

While many persons, stranded by a curfew suspending public transportation, slept on the floors of railway stations, the rioters faced the threat of a recently announced government edict that the costs of communal disorders would be assessed against the taxpayers of the community found responsible for starting the disturbance.

The city is still under a state of emergency. The outbreaks which broke out on the eve of the first all-Indian government headed by the Congress Party president, Pandit Jawaharlal Nehru, coincided with the first appearance of black flags, which the Moslem League ordered Muslims to display today in protest against the predominantly Hindu government in which the league refused to participate.

British Fleet In Long Maneuvers

London, Sept. 2.—(AP)—The British Mediterranean fleet will cruise in Greek waters for approximately six weeks beginning September 18, the admiralty announced tonight.

The announcement held more than the usual interest because an American task force is due to leave Mediterranean waters at about the same time the British fleet departs from Malta.

The American carrier, Franklin D. Roosevelt and escorting vessels, now in Italy, are due in Greece Thursday and will proceed from there to Malta, Algiers, Tangier and Casablanca under a schedule announced August 28 by the U. S. Navy in Washington.

The Roosevelt is due at Tangier September 18. Navy men have emphasized, however, that her schedule was subject to change, with a possibility the task force would go on to the Dardanelles.

Dam Destroyed, And Private Lake Drains

Tabor City, N. C., Sept. 2.—(AP)—Sheriff H. D. Stanley said today he was investigating an explosion which early yesterday ripped to pieces the privately-owned Gore Lake dam at the edge of Tabor City.

The two mile square lake drained completely by late yesterday the sheriff said and onlookers who gathered at the scene of the blast carted away fish by the sackful.

Wartime Draft Is Back After Crises

Washington, Sept. 2.—(AP)—The wartime draft ground back into action today on the first anniversary of V-J Day.

As the army this returned to conscription to swell its peacetime ranks after a two-month summer holiday for selective service, there were those entirely unrelated but nonetheless significant developments bearing on preparations for the future.

Members of the House Military Committee spoke frankly in Tokyo of their concern over Soviet intentions and urged that United States positions in the Pacific be strengthened against what they termed the imminent danger of another Pearl Harbor.

The assertions by the touring lawmakers followed a three-hour conference with members of Gen. MacArthur's high command.

The Senate War Investigating Committee cautioned that until the peace negotiations are ended and world peace machinery perfected it is essential that this country maintain a strong national defense.

The committee accordingly called anew in its annual report for an immediate program to acquire strategic overseas bases; for a workable industrial mobilization plan, for the stockpiling of strategic materials and for other reforms based on costly experiences of the last conflict.

Taking note of current anxiety, Donald M. Nelson, boss of this country's wartime production made public a personal letter he wrote to Premier Stalin pleading for a better understanding between the United States and Russia.

Nelson, who now is blueprinting a network of permanent armament facilities for this country at President Truman's bidding, proposed specifically that a group of American

Major Peace Threats

Is There Anything To Indicate What Is In Moscow's Sphinx-Like Mind? Is Uncle Sam Prepared To Meet Any Eventuality? Here's An Analyst's Answers

In discussing the insistent question of whether we are headed for another World War because of the clash between Russia and the Western Allies, this column Saturday ventured the view that conflict isn't inevitable if the Soviet Union has about satisfied its ambition for extending its zone of influence, but that it is inevitable if Moscow is bent on further major expansion.

Those conclusions invite two other vital questions: (1) Is there anything to indicate what is in Moscow's sphinx-like mind? (2) Is Uncle Sam prepared to meet any eventuality, should worse come to worst?

BRUTAL ACTS ARE TOLD AT EWING TRIAL

Neighbors Tell Of Attention To Wife's Sister And Cruelties

Fayetteville, Sept. 2.—(AP)—A state witness at the trial of Wall C. Ewing on murder charges for the killing of his wife, Mrs. Douglas Sutherland Ewing, testified today that he had seen the prominent politician kissing Miss Kate Sutherland, the dead woman's sister.

The witness, W. R. Kinlow, a neighbor of the Ewings, said the incident took place about a year ago when Ewing and Miss Sutherland were in an automobile parked near the defendant's home.

Mrs. May Yates, another neighbor, told the court she had seen Miss Sutherland in a long-sleeved slip in the yard of the Ewing home and had heard Ewing order his wife to go into the house.

The witness also said she had seen Ewing kiss Miss Sutherland.

She said she had heard Mrs. Ewing tell her sister that she was going "everything you can to take him away from me."

When the trial was resumed on its sixth day at 11:30 this morning Solicitor Carlyn placed Mrs. Mary Whittle, a next-door neighbor, on the stand.

Mrs. Whittle testified that she had seen Ewing strike his wife on numerous occasions.

One time, she said she saw Ewing knock Mrs. Ewing down with his fist, and when she got up he knocked her down again, and still a third time.

Another time, she related, Ewing came home and complained of finding his wife in bed, and Mrs. Ewing replied:

"I'm not able to get up. You beat me so much that I can't get up."

A few minutes later Mrs. Whittle told the court she heard Mrs. Ewing cry:

"Stop, you're breaking my arm. You've already broken both my arms."

Another time Mrs. Ewing came to her window, the witness testified, and called, "Please, somebody help me. He's killing me."

On cross examination, H. E. Sawyer, one of Ewing's lawyers, attempted to draw from Mrs. Whittle the admission that Mrs. Ewing was a habitual user of sedatives, but the witness said she had never seen Mrs. Ewing take sedatives, but one time and that time the medicine was given her by her husband.

Probe Shooting U. S. Educator In Germany

Frankfurt, Sept. 2.—(AP)—Army authorities today were investigating the death of Edward Harshorne of Cambridge, Mass., employee of the War Department, who was mysteriously shot in the head while driving his jeep on the Munich-Nuernberg autobahn last Wednesday night, it was announced here.

Harshorne, accompanied by his wife, was passing a jeep containing two U. S. soldiers, two women and a German police dog when the shots were fired. Both vehicles were in motion at the time.

In Haverford, Pa., Richard Jenney, brother-in-law of the 34-year-old former associate professor of sociology at Harvard University, said that full details had not been received but that there was "apparently no question" that American bullets killed the educator.

Official Denies Spy Ring Story

Frankfurt, Sept. 2.—(AP)—A high ranking U. S. intelligence officer has officially denied the American army's own story of a Communist spy ring by explaining that the "Free Germany Committee" the army recently broke up at Stuttgart was "purely a local affair" with no evident Soviet connections.

Of the 15 Germans originally taken into custody, the army spokesman said, the only member of the organization who will be prosecuted is its leader, Walter Kazmarek. It was emphasized that Kazmarek's alleged espionage activities "appear to be solely individual."

"Kazmarek's organization, the 'Free Germany Committee,' has no connections with Moscow as far as we can determine, nor any connections with any other similar organizations in occupied Germany," said the spokesman, who declined to be quoted by name.

The army's original story, issued three days ago through its public relations division, said Kazmarek's arrest had uncovered "evidence of Soviet espionage and subversive activities."

New Violations?

BELGRADE, Sept. 2.—(AP)—High diplomatic sources said today that Premier Marshal Tito had protested during a conference with U. S. Ambassador Richard C. Patterson yesterday that American planes "continuing to violate Yugoslav sovereignty."

Earlier a diplomatic informant reported that the U. S. embassy had received a formal note yesterday from Tito which "roughly meets" American demands in connection with the death of five American fliers whose plane was shot down by Yugoslav fighters August 13 for allegedly flying over Yugoslav territory.

KILIAN ASKS VINDICATION

Invites Congressional Probe Of Trial To Find "Truth"

Bad Nauheim, Germany, Sept. 2.—(AP)—Col. James A. Kilian, of Highland Park, Ill., today invited a congressional investigation of the Lichfield trials to "vindicate me and inform the people of the truth."

The former commander of the 10th reinforcement depot at Lichfield, England, issued his invitation in an open letter to Gilbert Harrison, vice chairman of the American Veterans Committee, who recently criticized as a "whitewash of horrors" a court martial verdict finding Kilian guilty of permitting cruelty to soldier prisoners and fining him \$500.

Harrison said the AVC felt the conduct of the Lichfield trials warranted a congressional investigation of the army courtmartial system.

"I heartily agree with you to the extent that the trial of Sgt. Judson H. Smith (the first guard convicted) which was used as a basis for all later trials was grossly mishandled, in an attempt to make me responsible," Kilian wrote Harrison.

Kilian attacked the legality of the verdict in his own trial in which "the court found that I had neither, in fact, authorized nor aided and abetted the shooting of American soldiers."

Greek Monarchist Party Far Ahead In Balkan Referendum

Returned Exile

Athens, Sept. 2.—(AP)—The Interior Ministry announced today that incomplete but conclusive returns from yesterday's plebiscite showed that the royal electorate had voted approximately three to one to retain King George II from exile in Britain and restore him to the throne.

While giving no comprehensive figures the announcement declared that the final total for restoration of the monarchy would not be less than 75 per cent of the votes cast in the stormy election, which cost 18 lives in the 36 hours ending at midnight Sunday.

Approximately 50 persons were known to have met violent deaths in political disorders during the annual week of the tabulation.

A partial vote tabulation by the interior ministry did not wholly confirm its prediction of a three to one majority, although the King held a commanding margin. With 25 per cent of the vote, the King was given as 209,536 for the King and 12,805 for the republic—less than 10 to 1 in the monarchy.

For the 66-year-old monarch the victory announced by the interior ministry spelled his second reign in full since he first ascended the throne in 1923. Ousted by the establishment of a republic in 1924, he fled the country in 1933 when

following a military coup, George regained his crown in 1935 when he was elected monarch by a plebiscite.

He fled the country in 1933 when

it was overrun by the Germans and set up a government in exile in Cairo. Since the end of the war he has been living in retirement in Enclad awaiting an expression of sentiment by the Greek people.

Peter Mavromihalis, minister of war and marine, declared the vote meant that the king will very shortly be among us by the will of his people—a symbol of freedom, calm and work—and he will lead the struggle of Greece for securing the peace for which so much Greek blood was shed.

Acting Premier Gonatas issued a statement declaring that the Greek people have risen to the occasion during the critical moments of our fatherland and have justified absolutely the forecast of the government that free and genuine elections would be held. He said that no victory celebrations would be permitted Communist EAM-KEKEA headquarters announced that it would make no immediate statement on the election.

The royalist-dominated Greek government had been confident for days that the voters would approve the return of the monarch to the throne.

(A Moscow broadcast said the plebiscite was held under Fascist-Royalist terror and with a large troop in the country.)

OPA CONTROLS GO OFF FOODS

Ceilings Removed From More Items By Agriculture Dept.

Washington, Sept. 2.—(AP)—Tomorrow's grocery shoppers will find OPA ceiling tags gone from more canned goods, many fresh fruits and vegetables and from all frozen fruit.

The Agriculture Department yanked those products beyond OPA's control by omitting them from its first list of "agricultural commodities to be short supply" which went into effect at 12:01 a. m. Sunday.

Live beef cattle, hogs and dressed lamb, on the other hand went back under OPA ceilings and slaughter controls at the same moment with prices about ten percent higher than the ceilings which lapsed on June 30. Retail ceilings on meat will reappear one week from today.

The food products decontrolled by the Agriculture Department's action may not be placed under ceilings again this month. The new OPA act provides that no farm commodity can be price controlled unless it appears on the "short supply" list to be issued at the start of each month.

Products not so listed, and therefore price-free, include: fresh fruits—peaches, apples, grapefruit, lemons and tangerines. Fresh vegetables—snapbeans, lettuce, cantaloupes, carrots, onions. (Continued on Page 5)

Big Crowds See Fast Planes Set Records

Cleveland, Sept. 2.—(AP)—Sky-happy fans looked for speed combined with competitive skill in the Thompson Trophy Classic today after witnessing the fastest straight-away dash ever run in a public demonstration—578.3 miles an hour in two trips over a measured mile course.

The speed dash was Sunday's feature event at the National Air Races, with six army air force Lockheed P-80 Shooting Stars flashing past a crowd estimated by show officials at more than 50,000.

Communist Party Ahead In Elections

Berlin, Sept. 2.—(AP)—Unofficial returns from 1,066 to 2,416 precincts in Saxony today showed the Soviet-enclosed, Communist-dominated Socialist Unity party (SED) more than 250,000 votes ahead of its conservative rivals in the first community elections in the Russian zone of Germany.

The unofficial count late this morning as compiled by the Russian-controlled radio Berlin showed the SED had polled more votes than its two chief rivals combined.

This count was: Socialist Unity party 797,747; Liberal Democratic party 373,920, and Christian Democratic Union 158,868.

Gambling Ship Still Operates Off Coast

Los Angeles, Sept. 1.—(AP)—Tony Cornero Stralla's gambling boat "Bunker Hill" welcomed thousands of suitors of Lady Luck today despite a multiplicity of arrests that failed to halt the operations of water taxis taking patrons from shore to the floating casino.

District Attorney Fred Hawser admitted that criminal laws of California "apparently do not give the necessary power" to stop George Garvin's fleet of water taxis. Garvin insists his boats are for hire to any destination on the high seas, rather than only to the gambling ship, anchored about eight miles off Los Angeles harbor.

Political Camps Ready To "Draft" Candidates

STAGE IS SET FOR S. C. RACE

Gubernatorial Candidates In Run-Off Held Tomorrow

Columbia, S. C., Sept. 2.—(AP)—Two gubernatorial candidates who survived a field of 11 three weeks ago will be trying tomorrow in a run-off South Carolina Democratic primary for the bulk of 104,000 votes that went to nine also-rans.

Dr. James McLeod of Florence, 40-year-old surgeon and a veteran of two world wars, and former circuit judge J. Strom Thurmond of Edgefield, an officer in the recent war, were the finalists.

The vote drawn by the other candidates were easily overshadowed by Thurmond's 96,591 and McLeod's 64,464, and despite a lighter vote—credited by party officials—than the first race's 295,000, tomorrow's election will hinge on the renewed casting of these ballots.

FBI Charges Two With Kidnaping

Asheville, N. C., Sept. 2.—(AP)—John C. Bills, head of the Charlotte Federal Bureau of Investigation office, announced here today that the FBI had charged Ralph Vernon Litteral, 34, of Winston-Salem and Marvin C. Bell, 23, of RFD 1, Roaring River, with the kidnaping of a 17-year-old Elkin girl.

Bills said the men had followed a bus in which the girl was riding shortly before midnight, August 23, and when she alighted near her home at the end of the line they forced her to enter their car. The FBI charges that she was abused and beaten before being let out more than six hours later the next morning at Bristol, Tenn.

Bell was taken into custody today and placed in Yadkinville jail to await a hearing before a United States Commissioner.

Bills said Litteral was sentenced on August 26 to 60 days with a road gang for parole violation.

Cheap Silver Measure

Story Of A Congressional Compromise That Failed; Congress Held Off Price Of Silver But Industry Buys Most Of Its Needs From Foreign Sources

Washington—Almost overlooked in the rush to pass OPA legislation at the close of the recent Congress was an act introduced in an effort to make government stocks of silver available for purchase by industry.

The silver legislation was a House-Senate compromise and has not resulted in any more than a trickle of silver into industry. Industry is buying most of its silver from foreign sources.

Congressmen from the industrial states had been pleading for use of the government's unmonetized silver to prevent shutdowns in factories.

Legislation designed to authorize sale by the Treasury was stalled in the Senate on a disagreement over price. The miners wanted \$1.29 an ounce. Industry was willing to pay only 71.11 cents.

The Senate insisted that the producer should receive the same price that the government would receive when it sold silver to industry. Shortly before adjournment an agreement was reached and Congress authorized purchase and sale at 90.5 cents an ounce. The bill was signed by the President on July 31.

But during the first month since the bill became law, only one sale was made by the Treasury—a total of 3,400 ounces out of the approximately 225,000,000 in storage.

"Hundreds, if not thousands, of American businesses" were being stifled, Rep. McCormack of Massachusetts, Democratic floor leader, told the House during debate on the authorization bill.

At that time industry estimated its need at about 125,000,000 ounces for 1946. No foreign silver was available at 71.11 cents, then the price ceiling. Domestic production (Continued on Page Four)

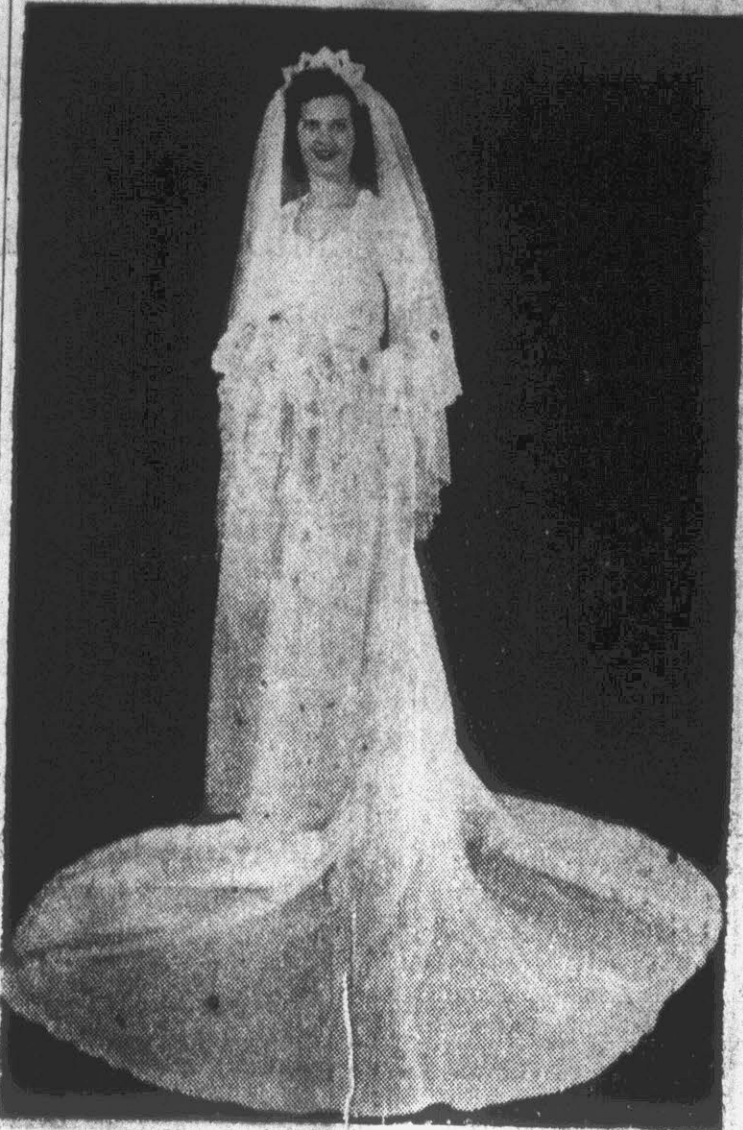

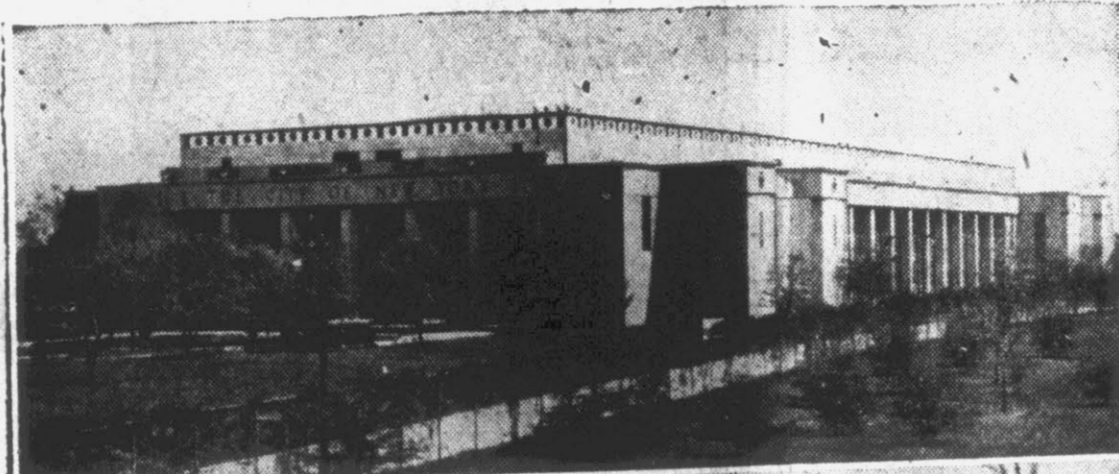

Lillie was a gangling girl of ten when Violet was born, the undisputed ruler of the Posey clan, who, knowing what was good for them, deferred to Lillie.

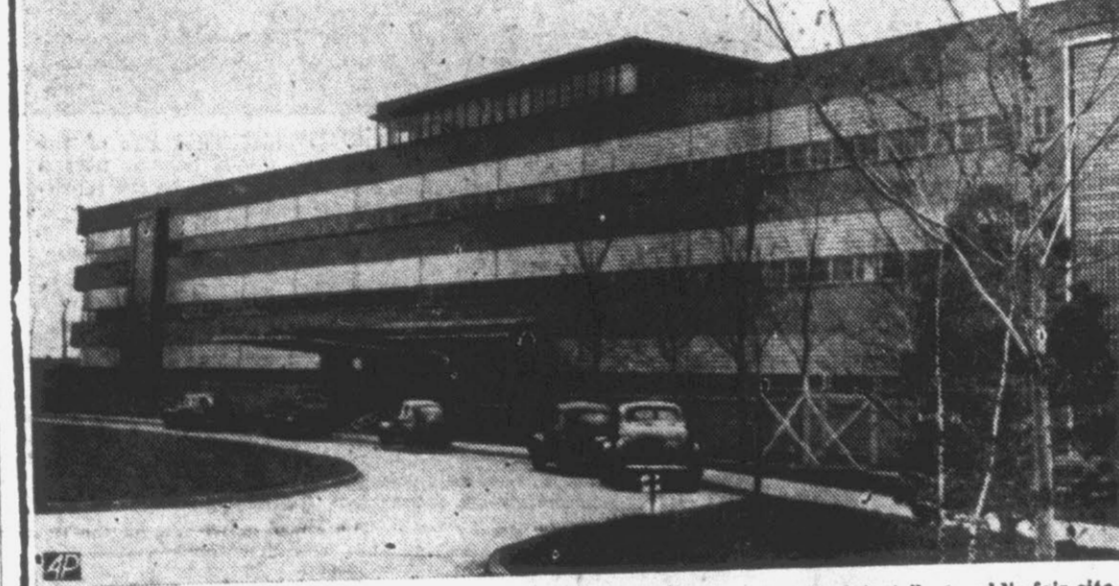

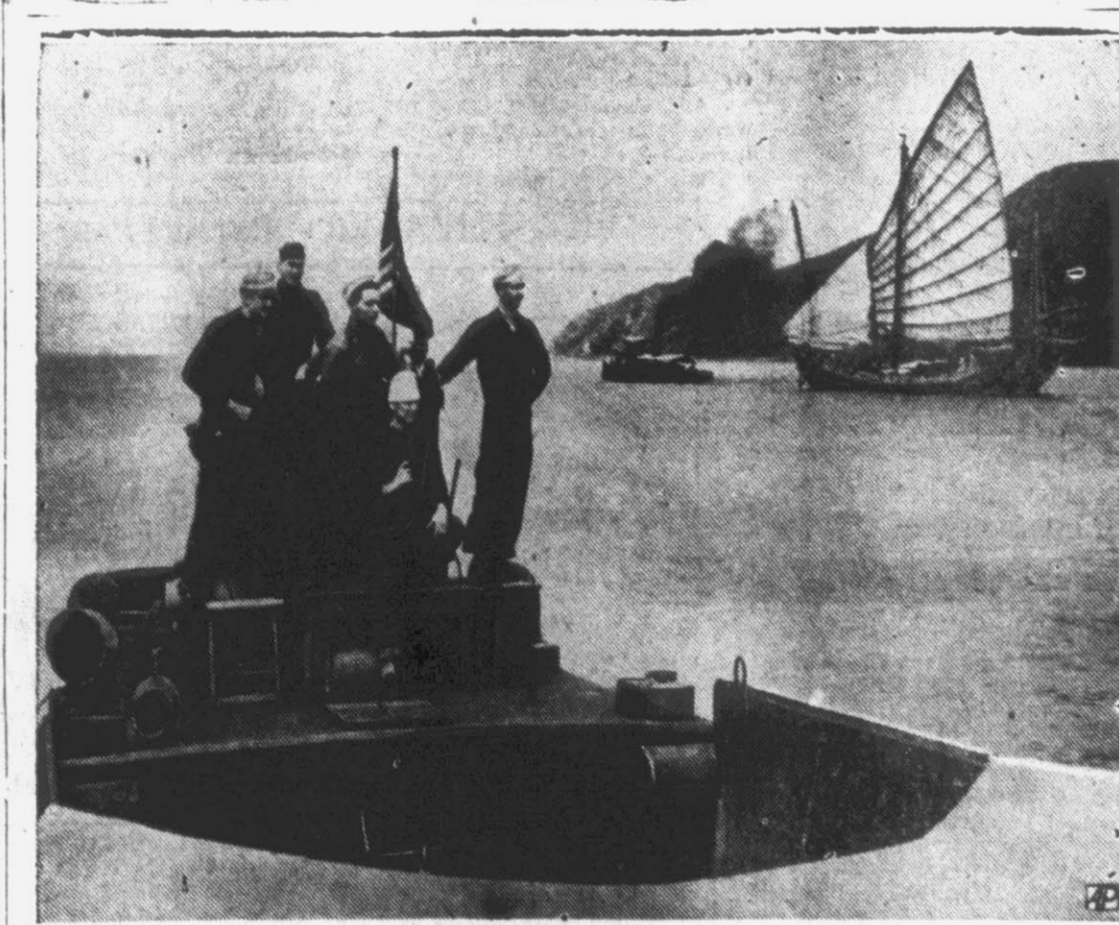

## Strength FOR THE DAY

**THOUGHTS ON LABOR DAY**  
Labor Day is a time when we need to recall the importance of balance in all social relationships.

Our Federal government is built on the principle of balance, each branch of government checking the other branches and seeing that they do not exceed their authority or contravene this public will.

Every true American rejoices in the advances which have been made by labor in the last generation. Before labor unions became powerful, multitudes of men in this country were slaves.

The increased power of labor unions put a stop to this sort of thing, but the pendulum has swung to the opposite extreme, and we are in danger of having the whole of our economy brought to a standstill when some group which produces a commodity needed in the production of other things, goes on strike.

Let laboring men as well as employers ponder on this day the necessity of balance. The entrepreneur has his place and the manual worker has his place. Neither can exist without the other. Either will become a tyrant if given the opportunity. Healthy national life depends upon their co-operating together as fellow citizens of a beloved country, as brothers of a vast and influential national family.

## NO SECOND FIDDLE

On Saturday, Rep. Sabath (D-Ill.) protested to the State Department that American officials are supporting Britain's foreign policy in securing and sustaining her colonial empire and in the establishing of new zones of influence. The fear that the United States plays "second fiddle" to the British lion is not new and has been often expressed.

Close observation of the facts would indicate that the two nations were working in harness for the same ends... settlement of factional strifes, a democratic way of life, the raising up of under-privileged peoples, and finally... a just peace.

Anglophobes overlook the numerous occasions when British statesmen have followed the American lead and see only the instances when our own officials have adopted the same or similar policy as England. The fact that these two great countries see eye-to-eye on so many issues, and adopt similar courses of action should be a source of satisfaction to proponents of a democratic and richer world. Wisdom in statecraft is a monopoly of neither nation.

The history of recent years shows the U. S. insisting that Britain permit more freedom and higher standards among her colonial peoples. Results are apparent in the Empire's attempt to provide an independent government for India, the (up to now) futile negotiations in Palestine, and the acceding to American demands for free trading privileges. Egypt is on the verge of a greater freedom than she has ever known. Would these things indicate



**American subversion to the British Foreign Office?**  
Our people recognize that the United States can no longer be isolated from the rest of the world. The role American statesmen are now playing in Europe is a vital one. The goals of both Britain and America are virtually identical. There must be no confusing of issues by the unhappy conviction that because the English are "foreigners" our ideals are necessarily different.

ment. "Is gradually and inevitably running most of our cities, and far too little is being done to combat the economic and social consequences of the deterioration."  
"The huge task that confronts us clearly is not the responsibility of the nation's architects alone, but our profession recognizes the gravity of the problem and recognizes its responsibility to plan with other appropriate groups in developing a working solution to the problem."

"If the investment is guided," he says, "by integrated planning designed to improve the pattern of our physical plant as we replace and expand it, then we can have a vastly better way of life in our communities."

Japan's surrender. It is no secret that the conflict between Russian and Western ideologies will be one of the dominant aspects of the second year of the occupation.  
On Sunday the six members of the military committee of the U. S. House of Representatives, who have been touring American bases in the Pacific, called for a strengthening of the United States position in that vast area to meet the threat of Russian encroachment on American zones of control.  
Then today we have from General MacArthur himself the declaration that the "dread uncertainty" of ideological conflict between Democracy and Communism hangs over Japan—a country which can be "either a powerful bulwark for peace or a dangerous spring-board for war."

### ARCHITECTS PLAN EVERYTHING OPEN AND ABOVE GROUND

Washington—Unbashed by suggestions that people may have to take to the underground if atomic energy isn't controlled, the American Institute of Architects is planning a bigger and fancier America on the surface.  
"Rebuilding America" is the theme of the AIA, which has no intention of living like the mole.  
The AIA has just organized a committee on urban planning. Louis Justement, nationally known Washington architect, is chairman.  
According to the institute, the committee will work on its "theme" in collaboration with other groups. It will endeavor to "develop far-reaching plans for rebuilding obsolete portions of American cities and for planning the orderly future development of our communities."  
"Obsolescence" explains Justement.

Economists in the U. S. Department of Agriculture tell us not to expect tea soon from the once-great tea areas of Java. The Japanese ruined the tea gardens.  
Col. Timothy A. McInerney, who did intelligence and counterintelligence work in Europe before the invasion of Europe, will tell the inside story of what happened in that neutral country under wartime censorship. The tale will be unfolded in a book, "Green Citadel," due to come out in September.  
Washington, a one-industry city (government), is looking for more business. The Board of Trade is launching a campaign to lure in more conventions and visitors.

So there are several critical situations which are definite threats to world peace. It remains to be seen whether they will be developed to the point of war.  
But supposing they are developed, is Uncle Sam prepared for eventualities? There can be no doubt that he not only is fully aware of the dangers but is laying defensive plans. Two statements from Washington last week would in themselves be enough to indicate this. Secretary of War Patterson directed key officials to make their defense plans on the basis that there will be no international control of atomic weapons. John D. Small, civilian production chief, announced that the nation's system of industrial mobilization could be swung back into operation within 24 hours if necessary.

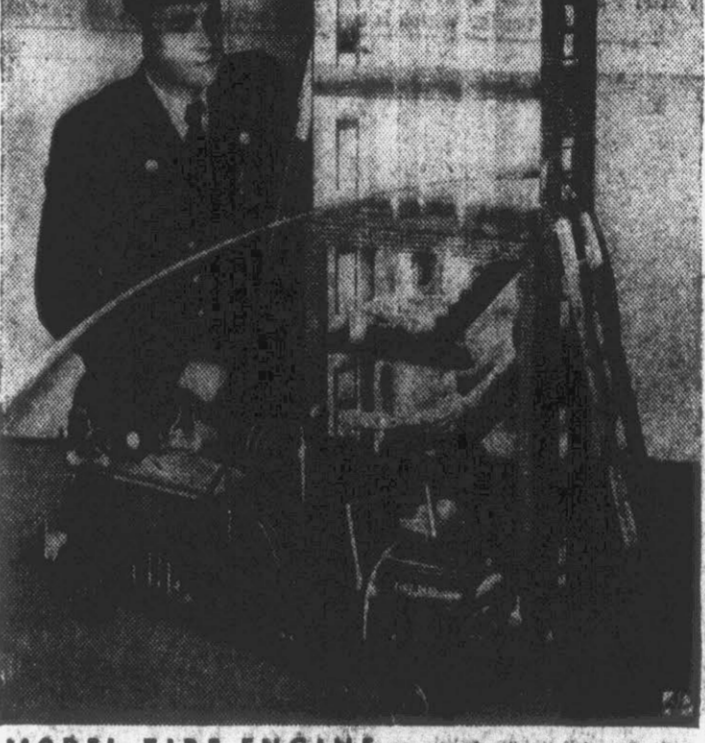

for 1945 was only about 67,000,000 ounces and there was little likelihood the output would be larger this year.  
Since the price-fixing bill was passed, OPA has raised its ceiling to 90.5 cents an ounce, or the Treasury selling price, whichever is higher.  
But the commercial market can buy foreign silver at 90 1/8 cents and sell at 90 3/8, and indications are that the Treasury stock will increase as domestic silver becomes available.  
The bill limited the Treasury's purchase to silver mined after July 1, 1946, to protect the government against speculators.  
The issue, as always in the case of silver, stirred up a bitter congressional fight. When the Senate pigeonholed the original House bill the House wrote its provisions into the Treasury-Postoffice appropriations bill.  
This move, however, accomplished nothing but a delay in authorization of funds for the two departments.  
Manufacturers of silverware spearheaded the publicity campaign in behalf of the bill, but a need for the metal was felt by manufacturers of photo supplies, one of whom melted down silver dollars to obtain the metal at a cost of \$1.29 an ounce.  
Other users reported in distress were manufacturers of dental supplies, electrical devices, brazing alloys, dental and pharmaceutical products, engine bearings, jewelry and military insignia.  
The Senate held its ground. Silver producers, the Banking and Currency Committee reported, had no price increase since 1939. Costs meanwhile had mounted. The 90.5-cent price, the committee said, represented a fair compromise between the 7.11 proposed by the House and the \$1.25 asked by the producers. The House finally accepted the compromise.

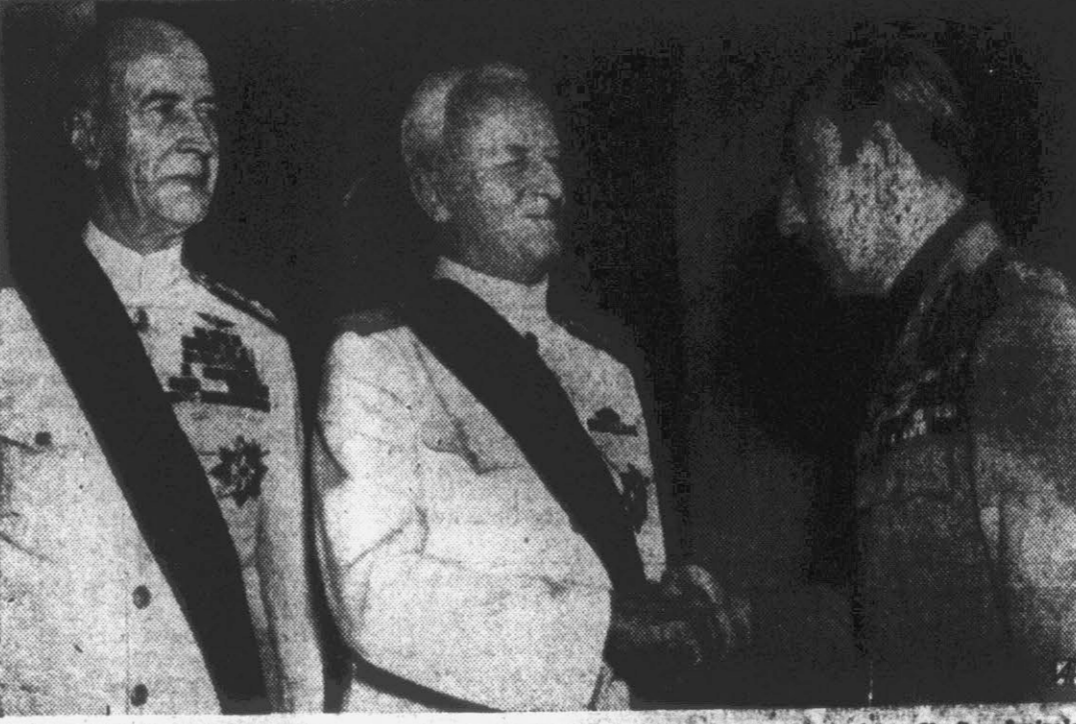
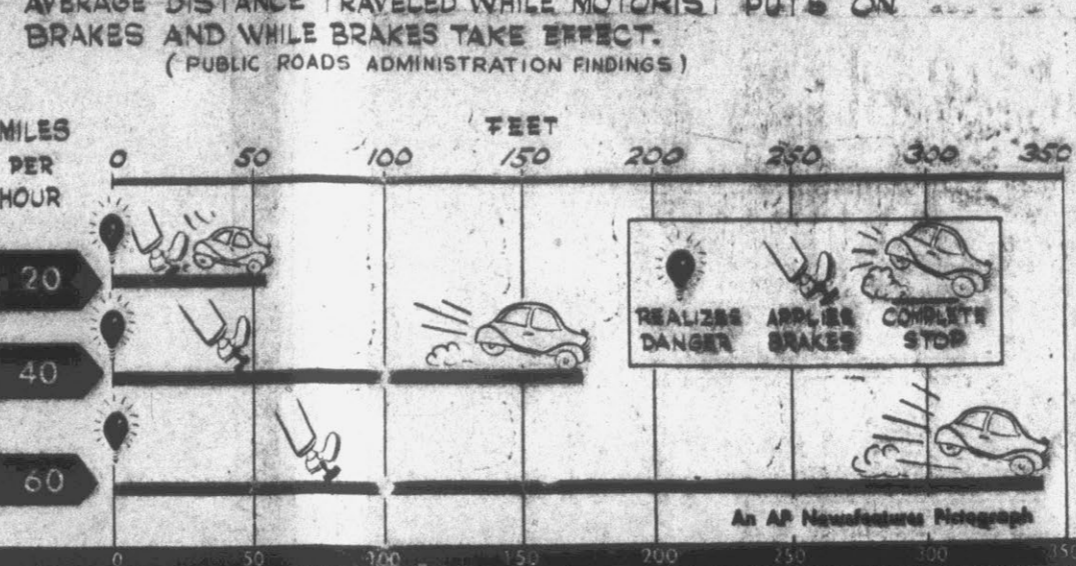

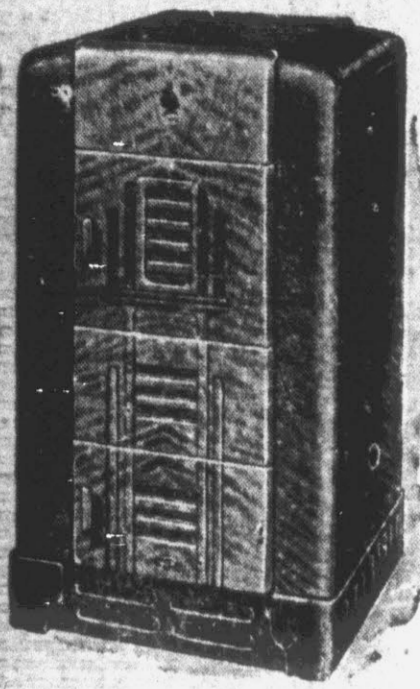
