DEFENSE ENDS TESTIMONY IN EWING TRIAL

Attempts to Prove Insanity of Family And Ewing A Good Husband

Fayetteville, N. C., Sept. 5.—(AP)—The defense rested its case today after having sought vainly to present testimony that there is insanity in the family of Wall C. Ewing, Cumberland County political leader who is on trial for his life on a charge of slaying his wife last March 13.

The defense notified Judge R. Hunt Parker shortly after noon that it had completed its case, and the judge ordered a recess until Friday morning to allow Solicitor F. Briel Carlyle to prepare rebuttal testimony. The case now is not expected to reach the jury until early next week.

In attempting to present testimony that there is insanity in the Ewing family, the defendant's youngest brother, Kent C. Ewing, was asked the following question: "Do you know of your own knowledge that there is insanity in your family?"

Solicitor Carlyle objected to the question and to others in the same vein. Judge Parker sustained the objections, and the witness' answers were whispered to the court reporter so that the jury could not hear.

In his whispered testimony, young Ewing said that there had been several cases of insanity in his family, that his brother, Robert Ewing, committed suicide at the age of 15 and that his aunt had been committed to a hospital for the insane.

The defense also sought to show that Ewing had been a kind and loving husband. It introduced an affectionate letter written by the defendant to his wife when he was in New York on a business trip, and the defendant's insurance policies which named Mrs. Ewing as beneficiary. Ewing's will also was offered as evidence. It named Mrs. Ewing as executor of his estate and left all his real and personal property to "my beloved wife."

Dr. John Turner, psychiatrist for the Veterans Administration hospital here, testified yesterday that he had examined Ewing and found him to be "nervous, incompetent, restless, forgetful, and suffered from hallucinations."

The psychiatrist said that Ewing told him that "practically every night he saw his wife in his room in the jail." He said that Ewing reported his wife: "telling him not (Continued on Page Six)

LaGuardia Pleads For Food Board

Copenhagen, Sept. 5.—(AP)—UNRRA Director F. H. LaGuardia made a fervent plea to the United Nations Food and Agricultural Organization today for immediate action to set up a world food board and said that price stabilization "will put every gambling grain exchange out of business in Chicago, Winnipeg, Liverpool or wherever it is."

LaGuardia, making his plea on the basis of lifting living standards of farmers of the world, said it was impossible to eliminate price fluctuations of commodities without disturbing present trade practices.

LaGuardia brought an UNRRA council resolution to F. A. O., asking that organization to "consider special problems of liberated countries with the view of providing maximum technical assistance in the expeditious establishment of their agricultural production."

He said the liberated countries had lost "over 2,000,000 draft animals and 15,000,000 cattle and that 20,000,000 acres of arable land are not in cultivation because of lack of machinery and fertilizers, draft animals, seed and manpower."

New Relief Problems

Rising Complaints Of U. S. Policy In Sending Supplies To Former Enemies And To Former Friendly States May Bring Drastic Revision Of Relief Work

The resolution of the Veterans of Foreign Wars against shipment of American food to former enemies serves to remind that, with the demise of UNRRA, the United States faces development of a new policy regarding relief for other countries.

UNRRA has operated very largely on the basis of need, and has even been attacked for the blindness of their justice under which it may have bolstered interests which were alien to the policies of the largest contributors.

Recent public flareups over continued shipments to Yugoslavia, and the attention paid by the U. S. government to the protests, make it pretty obvious that the new policy will take into consideration the premise of some that help should be continued only to our friends, and perhaps even be denied even to some of them if it would also bene-

Vishinsky Raps Italian Bid For Disputed City

Insists Trieste Should Go To Yugoslavia, That Russia Supports Free City Plan Only Because Of Political Reasons

Paris, Sept. 5.—(AP)—Andrei Y. Vishinsky, Russian deputy foreign minister, called on the 21-nation peace conference today to reject emphatically Italian claims to disputed Trieste.

Outlining Soviet Russia's stand on the leading territorial issue before the post-war conference, Vishinsky said that Yugoslavia has an unquestionable right to Trieste. He said the Soviet Union was supporting the big four agreement to make a free territory of the port only because of political considerations.

The Russian diplomat, in a speech before the Italian Political and Territorial Commission, accused Ivanoe Bonomi, former Italian premier, of cloaking annexations with the flag of justice in claiming the important Adriatic port for Italy.

Vishinsky made it plain that Russia would abide by the big four foreign ministers decision to create the free territory of Trieste but declared sharply:

"Yugoslavia has an unquestionable right to the port and town of Trieste. The decision of the foreign ministers contains a minimum of justice. In our opinion, it should contain a maximum of justice."

"But to have a maximum of justice in dealing with political considerations. Sometimes when we are dealing with politics two and two don't make four—sometimes they add up to five."

Russia's voice in the Trieste dispute was heard on the fourth day of debate on the Istrian settlements. Italy and Yugoslavia have filed conflicting claims for the port, and Sen. Tom Connally (D-Tex) yesterday declared the United States wants to see an autonomous Trieste government that will command respect of both Yugoslavia and Trieste.

In a biting personal attack on Bonomi and the Italian people, Vishinsky said that Italy's claim to Trieste was a manifestation of the old annexationist and expansionist policy. Italy's motive, he added, was a desire to grab up foreign properties. Yugoslavia's claim to Trieste was based, Vishinsky continued, on (Continued on Page Six)

FOUND TRYING TO TAKE LIFE

Guard Foils Heirens' Attempt To Hang Himself

Chicago, Sept. 5.—(AP)—William Heirens, triple murderer awaiting court determination of his punishment, tried unsuccessfully to hang himself in the Cook County (Chicago) jail early today, his guard reported.

The guard informed Warden Frank Sain that when he came on duty at 1 a. m. Heirens was hanging in a noose fashioned crudely with a bedsheet. The guard cut him down before the youth lost consciousness.

Heirens' attempt to kill himself was his third since his capture and confession of three killings and more than a score of burglaries and assaults. Previously he had tried to break open head wounds in the hope that he might bleed to death. He also had collected a store of aspirin tablets in the belief that a large overdose might kill him.

The 17-year-old student's newest attempt on his life came as the state prepared to close its presentation of evidence upon which Chief Justice Harold G. Ward of the criminal court will determine the penalty to be levied against him.

The state reportedly is not going to ask for the death penalty but will recommend that the University of Chicago sophomore with the rare dual personality be given a series of sentences which will insure his imprisonment for the rest of his life.

Heirens, without any apparent emotion, yesterday entered pleas of guilty to 29 indictments, including the kidnap-killing of little Suzanne Degnan and the murders of the Chicago women.

The state then began offering testimony in connection with all the crimes, including 26 indictments charging burglary robbery and assault. Although Heirens entered guilty pleas the law requires the state to present at least a prima facie case, enough evidence to establish a case against the defendant.

Counsel for the husky, black-haired youth, whose criminal career dates back to his grade school days, said he would not take the stand and that the defense would offer no testimony in mitigation.

Gunfire Still Heard In Troubled Bombay

Bombay, Sept. 5.—(AP)—Scattered police and military gunfire still echoed today in troubled Bombay but order appeared to be returning slowly after four days of bitter communal strife in which officials said 189 persons had been slain and 527 wounded.

Unofficial estimates placed the casualties at more than 200 dead and 600 injured.

A government communique issued at 1 p. m. said stray stabbings still were being reported in scattered sections of the city and warned there would be no hesitation in imposing a 24-hour curfew in troubled areas if the situation warranted.

Meanwhile all the city's 70 mills remained closed. Few shops remained open and in the northern section of the city traffic was completely suspended.

British and Indian troops not on duty were confined to their barracks.

ORGANIZER IS FOUND GUILTY

Said Urged Attack On Police In Demonstration

Winston-Salem, N. C., Sept. 5.—(AP)—Philip M. Koritz, 29-year-old director of Local No. 22 of the United Tobacco Workers (CIO) was sentenced here yesterday by municipal court Judge Leroy W. Sams to serve six months on the roads on charges of resisting arrest which grew out of an Aug. 23 strikers' demonstration at one of the gates of the Piedmont Leaf Tobacco Company plant.

Three Negro pickets, two of them women, were also convicted on the same charges.

Police Captain C. M. Stutts testified at the hearing that Koritz had urged a milling crowd of striking employees and sympathizers to attack police after they had arrested Cal Robertson Jones, Negro.

Koritz later denied a statement by Stutts that the union leader had urged the crowd to prevent the (Continued on Page Six)

One Survivor In Airliner's Wreck

Elko, Nev., Sept. 5.—(AP)—Spilling open when it struck a low hill only two miles from the Elko airport, a Trans-Luxury Airlines two-engine plane crashed today, killing probably 23 persons.

There was one survivor, a two-year-old boy who was found in a sitting position about 100 feet from the shattered wreckage.

Airline officials at San Francisco said the plane had 24 persons aboard, including the crew, when it took off from New York yesterday for the west coast city, where it was due at 3:45 a. m. Pacific Standard Time, today.

Bodies of many of the passengers were strewn in a 100-foot area about the wreckage. Rescue parties led by Deputy Sheriff Edward Lundberg, brought 17 bodies from the wreckage and Lundberg said other bodies were recovered still in the wreckage cabin.

The left side of the plane was split in the crash and fire broke out in the nose of the ship. Smoke continued to stream up from the wreckage five hours after the crash, which occurred about 2 a. m. PST.

Crossroad Command Discloses That A-Bomb Poison Penetrates Vessels

Washington, Sept. 5.—(AP)—The atom bomb's radium-like poison can penetrate a tightly closed ship and spread death throughout the interior.

This was disclosed today in an "Operation Crossroads" report dealing with the animals used in the Bikini tests.

Among other things, the report said that radiation sickness proved fatal to all of the 23 pigs stationed on four of the target ships used in the underwater bomb test.

The pigs had been placed in the medical quarters of the vessels, which were in "buttoned up" battle condition with hatches and ports closed. Six pigs were found dead within four days, the remainder died within two weeks.

The atomic depluchage, by creating a deadly radioactive mist and tossing tons of heavily contaminated water aboard the target ships, produced a far more poisonous effect than the first airburst bomb.

In that test, 3,000 rats, 176 goats and 146 pigs were used, stationed at points in 22 target vessels to simulate crewmen.

MAY SUBMITS OFFER TO BE INTERVIEWED

Again Denies Any Profits In Association With Munition Firms

Washington, Sept. 5.—(AP)—Rep. Andrew J. May offered today to submit to Senate War Investigating Committee questioning—either immediately at his Prestonburg, Ky. home or later in Washington.

A subcommittee of the group that spent weeks earlier this summer delving into the wartime operations of the Garsson munitions combine could meet with him in Kentucky. May wrote Chairman Mead (D-NY), or a formal session could be arranged here at a date as determined by his physician.

Simultaneously, the chairman of the House Military Committee made public a prepared statement which he said would have been read to the Senate Committee on July 26 if illness had not prevented his appearance in response to a subpoena.

In the statement, the Kentucky Democrat reiterated previous assertions that he did not profit in any way from his association with the combine, and specifically that he received no compensation for aiding in the operations of the Cumberland Lumber Company, one of the Garsson affiliates.

On the contrary, May declared, he still has coming at least \$659.31 for out of pocket expenses which he said he incurred in its behalf.

The Kentuckian became ill on the eve of his previous scheduled appearance. His Washington physician said a chronic heart condition had become aggravated. He returned to Kentucky August 3.

Concerning that he had acted as Kentucky agent for the Cumberland (Continued on Page Six)

Clear Garsson Firm Of Defective Shells

New York, Sept. 5.—(AP)—The Times said today in a Washington dispatch it had learned that the Garsson munitions firm now under inquiry by the Senate war investigating committee had been freed of any responsibility in the death of 38 American soldiers caused by defective chemical mortar shells.

"An exhaustive War Department report on malfunctions of ammunition for the devastating weapon which could pour 20 shells a minute on the enemy stated that all defects were found in the fuses, and in the shells, the Times said adding:

"The companies headed by Dr. Henry M. Garsson manufactured only shells. Thus the 'Garsson munitions empire' was acquitted of manufacturing errors and 'bugs' which cost G. I. lives."

Maritime Walkout Opens Noon Today

AFL Seamen Strike In Atlantic, Pacific And Gulf Ports; Schwollenbach Gets Job Of Settling Wage Scale Dispute

New York, Sept. 5.—(AP)—AFL seamen struck in Atlantic, Pacific and Gulf ports at noon (EDT) today in a tieup union leaders predicted would stop all saltwater shipping.

President Truman announced that the dispute over limitation of negotiated wage raises by the Wage Stabilization Board was in the hands of Secretary of Labor Schwollenbach.

In New York and Baltimore, the members of the Seamen's International Union and the Seamen's Union of the Pacific began walking off ships several hours before the scheduled hour.

Shortly after noon John Hawk, vice president of the SIU, announced here the strike is on; it is in effect and 100 per cent effective.

The strike involved approximately 10,000 AFL seamen and 300,000 other AFL union members and the CIO National Maritime Union which has announced it would observe picket lines.

As Mr. Truman announced at his press conference in Washington that Schwollenbach now was handling the problem, but that he would act when it was put before him, the Association of American Railroads

embargoed all railroad freight shipments to ports, with certain exceptions.

The embargo applied to all carload and less than carload freight consigned or reconsigned to any port area and intended for export, coastwise or inter-coastal movement by water, including export freight intended for storage within the port area.

Longshoremen worked throughout the forenoon in New York but Charles Spencer, secretary of the N. Y. district council, International Longshoremen's Association (ILA), declared New York's 25,000 longshoremen would respect picket lines as soon as they were established tomorrow.

Picketing began at dawn, however, along the San Francisco, Oakland and Portland, Ore., waterfronts.

The exact number of seamen who walked out in New York was not known immediately, but the U. S. Maritime Commission said there were 37 ships in port manned by the SIU crews and 16 manned by the SUP.

William Rantz, SIU business agent in Baltimore, estimated that 2,000 men were on between 35 and (Continued on Page Six)

BIG CARRIER IS WELCOMED

F. D. R. Arrives In Athens; Cancel Air Show Plans

Athens, Sept. 5.—(AP)—The busy new United States aircraft carrier Franklin D. Roosevelt and escorting war craft arrived here this morning for a four-day courtesy visit which caused much diplomatic furor when it was first announced prior to last Sunday's plebiscite of the return of King George II.

The naval attaché's office of the U. S. embassy announced shortly after it arrived that no air show was scheduled for Athens during the visit. Such a show was considered—with planes from the big carrier (Continued on Page Six)

'War Of Nerves' Laid To Russia

Lake Success, N. Y., Sept. 5.—(AP) Vassil Dendramis, Greek representative to the United Nations, charged today that the Soviet Union is carrying on a "war of nerves" against the Greek government. He vigorously denied Russian accusations that Greece is threatening the peace of the Balkans.

Dendramis appeared before the United Nations Security Council to present Greece's answer to the charges made yesterday by Dmitri Manuilsky, foreign minister of the Soviet Union, and outlined earlier by Andrei A. Gromyko, the Soviet Union delegate to the council.

The Greek representative called today's situation, in which Greece has been called on to defend itself before the Security Council, a "bitter drama."

Instead of threatening the Albanians and Bulgarians, Dendramis said, Greece is more than ever devoted to peace. He called the Albanians and Bulgarians "hideous collaborationists" in the war.

POOR GRADES OF LIVESTOCK ARE MARKETED

Stockyards Nearly Empty; Workers Laid Off; Inferior Animals Sold

Chicago, Sept. 5.—(AP)—Some weird looking meat animals were stumbling into the stockyards today as arrivals at all livestock markets declined drastically in the first week of revived OPA ceilings on hogs and cattle.

Most of the cattle received here for slaughter were dried up cows, offering a highly unappetizing type of meat for consumers. They were practically lost in the Great Union Stockyards which last week were jammed with bawling steers. All former low volume Chicago records were broken yesterday when only 1,200 cattle, 700 hogs and 800 sheep and lambs arrived. Nearly all of the 8,000 pens were empty.

An equally sorry lot of hogs was being unloaded. These consisted of emaciated sows, boars and inferior grades of pigs. Livestock observers said there was not one good pork chop in the bunch.

Similar unimpressive runs were reported at other marketing centers. A few small concentration points in the mid-west did not receive any animals at all, traders stated. As the receipts dwindled, many packers began laying off workers.

The number of salable cattle arriving at 12 major mid-western markets the first three days this week totaled 59,800 head. In the same period last week, 246,500 head arrived.

An even more drastic drop was shown in hogs. Salable arrivals this week totaled only 15,800 head against 122,100 head in the same day last week.

Meat packers were not surprised at the dearth of offerings. They had predicted it.

Nearly everything which could be marketed, including some light cattle and hogs which should have been held back on farms, was unloaded in the period of price-free (Continued on Page Six)

Railroads Order Freight Embargo

Washington, Sept. 5.—(AP)—The Association of American Railroads today ordered an embargo on all railroad freight shipments to ports, with certain exceptions, as a result of the threatened shipping strike.

The embargo is effective immediately. It applies to all carload and less than carload freight consigned or reconsigned to any port area and intended for export, coastwise or inter-coastal movement by water including export freight intended for storage within the port area with a number of exceptions, especially petroleum or petroleum products in tank cars to be unloaded from cars before overseas movement.

Wins Stork Race In Journey To Germany

Frankfurt, Germany, Sept. 5.—(AP) Mrs. Margaret Allen of Santa Ana, Calif., won her 10-day race with the stork.

Rushing by plane and train from the United States to join her husband, Lt. Jack V. Allen, in Erding, Germany, before the birth of her second child, Mrs. Allen arrived safely yesterday afternoon with her two-year-old son, Bobby, the army newspaper Stars and Stripes reported.

Army regulations forbid transportation of children under the age of six months, so Mrs. Allen set out to beat the stork's arrival in order not to delay her reunion with her husband.

Controls Over Trade

The Federal Trade Commission And How It Works; Benefits To Honest Businessmen Explained; How Individual Is Protected From Dishonest Practices

Washington, Sept. 5.—(AP)—The Federal Trade Commission, whose work affects all of us, is going to speed up its job.

The very name—Federal Trade Commission—probably leaves most readers cold. What is it? What does it do?

Briefly, its job is this: To see that businessmen don't use methods unfair to other businessmen or to the buying public. You, an individual, or you, a businessman suffering from unfair claims of a business rival, could complain to the commission.

Here are two main fields in which the commission works:

1. Misleading advertising. For example: Where a manufacturer claims his product will do something it can't do.
2. Price-fixing. For example: Where a group of firms, or a whole industry, gets together to fix prices. The public suffers here.

Here's an example of the commission's work:

Recently it ordered a vitamin manufacturer not to claim his product could stop gray hair and not to advertise that gray hair is due to lack of vitamins.

Vitamin deficiency isn't the cause of gray hair, the commission said, and vitamins won't turn gray hair back to its original color.

The commission, made up of five men appointed by the president, provided the Senate approval, was created by act of Congress in 1914.

All five members are lawyers. They serve seven years each. The chairman, William A. Ayres, is a former Kansas Congressman.

The commission has a staff of about 500 people.

It used to be that the commission would act on one complaint at a time. But it's going to try to speed up its work.

Here's an example of how it used to be.

GOOD MONEY AND BAD

Bad money drives good money out of circulation. This is a basic law in economics. What happens in the money market when good and bad money circulate together is that people sell the good money for its metallic content and keep the poor money with which to carry on trade. But this law is more than a basic law of economics; it is a basic law of life. In the field of everyday living, things poor and unworthy are always trying to drive good things out of circulation. Were it not for sufficient policing, the criminal element would take over most of our communities very quickly. Disease is always trying to drive health out of a community. The lazy, and those people who want to get something for nothing, are all the time trying to arrange working conditions so that they can be paid much for little work. Poor literature tends to drive good literature out of circulation. Cheap and demagogic ideals are constantly assailing the plans advanced by statesmen, and frequently they overwhelm the good ideas. The world is trembling at the present time for fear the spirit of war may again be unleashed and may drive everything good out of the world. The way to deal with the money situation is to see that debasing currency is never mixed with the good. The same principle operates effectively in all fields.

WASHINGTON LETTER

NEPAL GUESTS TAX OFFICIAL ENTERTAINMENT INGENUITY

Washington—The State Department had to bone up on some special protocol, and many folks studied encyclopedias, maps and almanacs in preparation for a visit here of five men from Nepal. Because Nepal has followed a policy of exclusion and travel has been discouraged for many years, little was known of the country. A lot of people didn't even know where it is. Most of the Nepalese are Hindus and practice unusual customs. Hindus are supposed not to eat or drink with any but members of their own faith. They also are supposed not to drink any alcohol. And they don't usually take their womenfolk around with them in public. These things created problems for their hosts.

figurehead. The job is done by the Maharaja, or prime minister, who is also military commander in chief. Under him is a council consisting of relatives of the king and a few others. The country's former savage legal code, with ordeals by fire and water and punishments by mutilation and torture, was abolished in 1851. Treason, rebellion and desertion are punishable by death. Murder and the killing of cows is a capital offense. Manslaughter and the maiming of cows brings life imprisonment. Brahmins and women are exempt from capital punishment. Among certain tribes a woman at any moment can divorce herself by placing a betel nut under her husband's pillow.

The recent loan to Britain was made in an atmosphere that practically promised there would be few if any other direct treasury loans and the Export-Import Bank does not have the money to finance foreign relief. It has declined to guarantee a \$35,000,000 loan which a New York concern was prepared to grant to Austria. Now the Austrians, who have been very little helped by UNRRA (26,509 tons of supplies up until March this year) but who have depended heavily on aid from our military forces, are expected to appeal directly to the treasury. Yugoslavia has done much to send herself to the bottom of our allotment list, even if she could pay, which she cannot. Yet she received 1,554,970 tons up until last March, and is expected to be in dire straits without outside aid. Then there is Greece, which received 2,857,093 tons (70 per cent American), as are all UNRRA allotments, and is unable to pay except through loans. Politics, with not particularly well served by throwing this burden over to the British, who would be bound to take it up to preserve their own position, yet would thereby diminish the mutual benefits of our loan to them. These are just some of the problems involved. China represents one in herself. The politics involved this time is not so simple as that in American cities where food baskets during the year are translated almost automatically into votes on election day.

Suppose there were 100 soapmakers in this country. Twenty were making false claims about what their soap would do. The commission received complaints against the 20 but acted against one at a time. That was slow going. This is the way the commission would handle the situation now: It would try to get the whole industry—including the 20 offenders—to agree not to use an unfair trade practice, like those false claims.

Caught Eight Big Fish Ocean City

On a recent fishing trip off Ocean City, Md., Dr. J. L. Winstead and Ben P. Bullard and W. L. Hampton of Currituck, N. C., each caught two marlins, the gamest and wildest of all saltwater fish. The party, made up of Washington, D. C., and Baltimore sportsmen, were fishing from Capt. Calvin T. Lilliston's boat "Prescilla," caught eight of the big fish. The three southerners caught six of them. The Yankees in the party caught only two. Incidentally, the Tarheels used North Carolina bait. "Catching a marlin on a hook and line is like riding a bucking broncho," Bullard said.

George (Red) Munger, who only six weeks ago, was wondering whether he would leave Germany in time to join the St. Louis Cardinals this season, may prove the deciding factor in the Redbirds' battle with the Brooklyn Dodgers for the National League pennant.

Munger last night celebrated his second week with the Cards since his discharge from the army by pitching the Redbirds to an 8-1 victory over the Chicago Cubs for his first triumph of the year.

The victory enabled the Cards to preserve their two game lead over the second place Dodgers, who defeated the Braves in Boston 3-1.

Munger's six-hit performance comes as a surprise to most observers since he failed to retire a man in a relief role against the Dodgers Aug. 25, and had to be removed after tiring badly in his initial starting assignment last Sunday.

In a battle between lefthanders, Brooklyn's Joe Hatten had the better of Boston's Warren Spahn although the Braves outthit the Dodgers eight to six. Three bases on balls proved Spahn's undoing as all figured in Brooklyn's scoring.

The Boston Red Sox moved to within five games of clinching the American League pennant, defeating the Washington Senators 4-1 in the capitol city while the Athletics were shading the New York Yankees 4-3 in Philadelphia. The Sox now lead the runner-up Yankees

by 16 1/2 games, the biggest margin they have enjoyed this season.

Phil Marchildon gained his 12th victory for the A's as Pete Suder drove in the ti-breaking run in the seventh with a single.

Chet Laabs drove in all St. Louis runs with two home runs and a single as the Browns took the measure of the White Sox in Chicago 5-1.

Bucky Walters and Joe Beggs cooperated to pitch the Cincinnati Reds to a 6-0 victory over the Pittsburgh Pirates in Cincinnati.

Although they collected only six hits, the Philadelphia Phils made five count for extra bases, including two home runs by Andy Seminick and one by Del Ennis, to down the New York Giants 6-5 at the Polo Grounds.

In the day's only daylight game, Hal Newhouse hung up his 24th pitching win as the Detroit Tigers whipped the Cleveland Indians, 4-1.

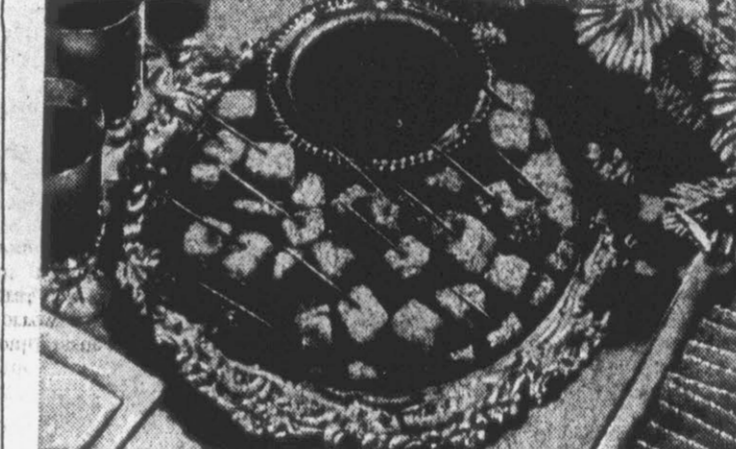

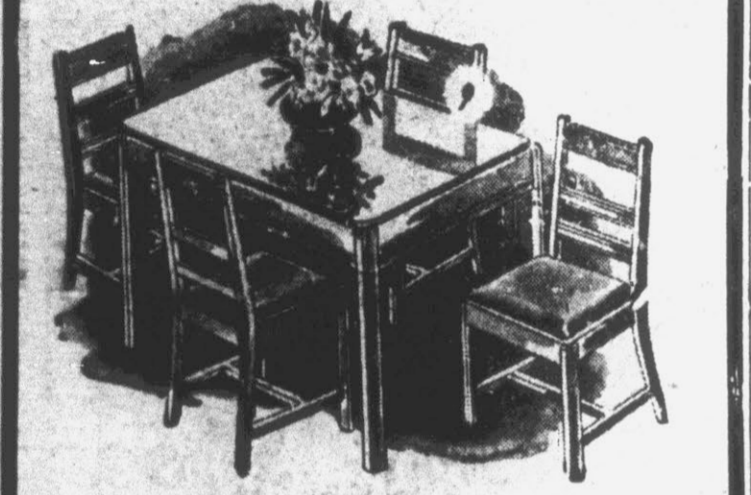
