Greatest Maritime Strike In History Freezes Ports

Hundreds Of Vessels, Of All Registries, Immobilized By Walkout; Shippers Powerless Strike Is Against Decision Of Government Board

The greatest maritime strike in history spread through the nation's coastal ports today, freezing the port of New York, the country's busiest harbor into complete paralysis, the U. S. Maritime Commission announced.

The commission's statement came about three hours after the striking AFL Seafarers International Union and the Sailors Union of the Pacific established picket lines along the extensive waterfront.

The commission listed 344 vessels of all nations tied up in New York by the strike. This varied with a union claim that 594 craft of all types were stranded in New York and 2,834 on three coasts.

A commission survey said 70 ships of all flags were immobilized in ports from Portland, Me., to Savannah, Ga. Of these, the commission said 548 were American and 157 of foreign registry.

Spokesmen for the striking AFL Seafarers International Union and the Sailors Union of the Pacific in New York said 334 ships were tied up in the port of New York, 350 in other Atlantic coast ports, 450 in Gulf ports and 1,200 in West Coast ports.

A possibility of an international truce was hinted in a bulletin issued from strike headquarters in New York. It said expressions of support had been received from all other world.

An estimated 90,000 sailors packed their gear and walked off ships yesterday to protest a Wage Stabilization Board order denying them a full increase won in recent contract negotiations.

The action was followed by an appeal by the Maritime Commission to participants in the strike to keep refrigerating machinery aboard the ships in operation to prevent spoilage of thousands of tons of perishable food.

In telegrams to heads of the two maritime unions involved in the strike, Vice Admiral W. W. Smith, chairman of the commission, said: "In view of the world-wide shortage of food, we request your union to give assurance that provisions will be made for such operation as may be necessary to protect valuable refrigerated food stuffs which would have to be replaced from civilian stores already critically short."

Nearly 200,000 workers, including dock employees, tugboat operators and CIO seamen, said they would honor picket lines.

Utilities Asks For Big Bond Issue

Commission Urges Aldermen To Pass Resolution Calling Election To Provide \$1,250,000 For Electric And Water Works

The Greenville Utilities Commission appeared before the Board of Aldermen at the City Hall last night and requested the board to pass a resolution providing for calling for a special election to vote on an issue of \$1,250,000 of bonds for new buildings, electric generating equipment and a boiler and four 750,000-gallon-per-day filters and auxiliary equipment and a settling and coagulating basin for the water department.

All members of the Utilities Commission (except J. H. Blount, who was out of the city) and Supt. Martin Swartz were present when the request was made.

He also presented a resolution passed by the commission on August 30, calling attention to the inadequacy of the electric and water plants in the face of increasing demands. The resolution stated that the plans for enlargement of the electric and water plants had progressed to a stage, "where it is only a question of providing the funds

with which to prosecute the projects to completion." The Utilities Commission's resolution also stated that "it be understood and agreed that the Utilities Commission will provide for the payment of interest and the redemption of these bonds from its revenue as it falls due from year to year."

After some discussion, Mayor Jack Boyd suggested that since three aldermen were absent, the matter is so important that it should be considered and passed on by the entire board at a meeting on September 16. This was agreed upon.

The demand on the municipal electric plant has increased from 8,554,470 kilowatt hours in 1936 to 16,330,700 at this time. The output has been doubled in the 10-year period, it was stated.

The city of Greenville's total indebtedness at this time is \$1,168,000, and this includes schools, utilities and special paving bonds sold this year. (Continued on Page Six)

BRITON FLAYS GREEK ATTACK

Cadogan May Press For Dismissal Of Ukraine Plaint

New York, Sept. 6.—(AP)—The United Nations Security Council meets here late today (3 p. m. EDT) in secret session after two days of heated debate over the Soviet Ukraine's complaints against Greece and Great Britain.

Public discussion of the Ukraine's charges that Greece was stirring up incidents in the Albanian frontier with British troops in the background was put over until 3 p. m. Monday, when the delegates will return to the U. N. interim headquarters at Lake Success.

The closed session was called for discussion of the council's report to the Sept. 23 meeting of the General Assembly in New York. The secretariat has asked the council to expedite its report, which will include statements on the handling of the unsettled Russian-Iranian, Spanish and Ukrainian cases, all of which were brought before the council when the assembly meeting in London last winter.

Resigns Regency Awaiting King

Athens, Sept. 6.—(AP)—Archbishop Damaskinos, regent of Greece since December, 1944, has resigned the regency in anticipation of the return of King George II, the press ministry announced last night.

Latest returns from last Sunday's plebiscite on the monarch's return from five years of exile gave King George II 1,166,512 votes to 521,267 for a republic.

A cable from the ministry to King George was as follows: "After the outcome of the plebiscite I consider my mission terminated. . . . And I wish your majesty's days and works blessed by God Almighty."

The king's reply said: "I am deeply moved by your wishes and I believe that God Almighty will help me in the difficult task I am about to assume."

HEIRENS GETS LIFE PENALTY

Saved From Chair, To Spend Rest Of Life In Prison

Chicago, Sept. 6.—(AP)—The bloody and vicious crime career of young William Heirens was ended today as the state prepared to put him in prison to begin serving three consecutive life sentences.

The 17-year-old college student escaped death in the electric chair for his brutal crimes but the three life sentences for three murders and an assortment of other penalties ranging from one year to life for more than a score of burglaries and assaults indicated he will remain in prison until he is nearly 80 years old.

Heirens, under Illinois parole laws, can not be freed for at least 61 years, probably 63 years. His incarceration for at least 61 years is assured as under the state penal practice, parole is not considered for a life prisoner until a minimum of 20 years has been served.

In his Cook County jail cell, after he was sentenced, Heirens told reporters that "as far as I'm concerned the penalty is okay. I had felt for a long time I was going to get the chair. I didn't lose that conviction until I heard judgment pronounced. Then I was relieved."

The former University of Chicago sophomore, who had expressed no remorse for his crimes, appeared unmoved as he was summoned before Chief Justice Harold G. Ward in criminal court for sentence late yesterday.

"Have you anything to say before sentence is pronounced?" Judge Ward asked the husky, black-haired youth.

STATE FIGHTS INSANITY PLEA IN EWING CASE

Parades Witnesses Testifying Defendant Was "Normally Sane"

Fayetteville, N. C., Sept. 6.—(AP)—Solicitor F. Ertel Carlyle today made a vigorous attack on the defense contention that Wall C. Ewing, local political leader who is being tried for the murder of his wife, was insane and incapable of planning and executing the crime of murder.

In rebuttal testimony, Solicitor Carlyle paraded 12 witnesses, including a minister, local businessmen, and police officers to the stand as the trial went into its 10th day.

Although the witnesses used different expressions, the import of their testimony was the same as that of Charles E. Lee, employee of a local bank: "He was a normally sane man."

The Rev. C. Herman Trueblood, Baptist minister, said that he conducted a religious program on the local radio station managed by Ewing and that he talked to the defendant on numerous occasions prior to the death last March 13 of Mrs. Douglas Sutherland Ewing.

Trueblood testified that Ewing's mental condition was "all right when I was dealing with him. There was nothing that I could detect that would lead me to believe that I was dealing with anything but a sane man."

Norman Butler, the county judge, said: "My opinion is, he's sane. He talked like a normal person and acted like a normal person."

The judge admitted on cross-examination that it was necessary to give Ewing liquor and sedatives since he had been in jail.

The defense contends that Ewing's excessive drinking rendered him insane and incapable of knowing right from wrong and of planning and executing a crime.

Judge R. Hunt Parker, presiding here over the sessions in Cumberland County Superior Court, has announced that there will be no court tomorrow, and the case will continue next week.

Trial recessed at noon yesterday at the request of Solicitor F. Ertel Carlyle who spent the afternoon in conference with witnesses he expects to call to the stand today.

Blame Fog For Wreck Of Plane Near Elko

Elko, Nev., Sept. 6.—(AP)—Dense fog is believed to have caused the crash of a trans-luxury airliner which scattered 212 people dead over 100 yards of a hill near here but spared the life of a two-year-old boy who today cried for his "Mommy," one of the victims.

After a preliminary investigation of the disaster, T. R. Mitchell, civil aeronautics board investigator from Oakland, Calif., said informally that fog was to blame for the crash before dawn yesterday.

CALL ADDRESS BOLD ATTEMPT TO SELL U. S.

Diplomats Say Byrnes' Speech Offers Alternative To Communism

Washington, Sept. 6.—(AP)—Diplomatic authorities today called the Stuttgart address by Secretary of State Byrnes a bold attempt to sell to the German people an American-type political system as an attractive alternative to both Nazism and Communism.

Officials familiar with the background of the speech said it was partially a counter move to the statement on Germany by Soviet Foreign Minister Molotov in Paris July 10.

They underscored as top importance Byrnes' reference to the eventual need of a federal constitution for Germany which should insure democracy and the basic freedoms.

American officials have talked in general terms for months of the possibility of a federalized Germany, but none has ever put the idea into words which suggested so very strongly the American type of federal union.

Molotov strongly opposed the federal plan. He said it would dismember Germany and was favored only by allied authorities in the western occupation zones, not the German people.

Byrnes went into far greater detail than Molotov in his proposals both for the political and economic reconstruction of Germany and his efforts to persuade the German people that the U. S. intends to treat them justly and fairly within the terms of the Potsdam Big Three agreement.

But although the speech was primarily for German consumption many parts of it were aimed simultaneously at Russia. Some were directed at France and Poland.

One section certain to cause surprise in some foreign capitals was the dealing with Germany's eastern border. Byrnes made it plain the U. S. might oppose Poland's permanent claims to the former German territory it now holds provisionally under the Potsdam agreement.

Poland has served notice it regards that territory as "permanent compensation for the area it ceded to Russia in the east.

PAC TACTICS

Republican Leader Says Group Gave Distorted Picture

Washington, Sept. 6.—(AP)—Carroll Reece, Republican National Chairman, asserted today that the CIO's Political Action Committee "stacked" its boxscore on congressional voting in an effort to cast in an unfavorable light G. O. P. legislators seeking reelection.

Reece made that contention in the September issue of the Republican News, official party organ. He questioned in an editorial the CIO-PAC's selection of subjects when it compiled the tabulation it is circulating of how lawmakers voted on a dozen issues.

The G. O. P. chairman commented that the compilation omitted votes on veterans legislation, on "moves to curtail government extravagance," and on legislation to aid farmers. He added: "It was obvious that the selection was made on a basis designed to present Republican members in the most unfavorable light possible from the viewpoint of the PAC."

"The entire performance appears to have been staged with the aim of seeking to rescue the present Democrat administration."

The same issue of the Republican News carried an unsigned story asserting that primary results thus far have "registered the American political need as being definitely to the right."

MAY MUST SEE MEAD PROBERS

Senate Group Insists Rep. May Must Appear At Hearing

Washington, Sept. 6.—(AP)—The Senate war investigating committee made it plain today it will insist that Rep. Andrew J. May (D-Ky.) tell as a full dress hearing about his activities in connection with war contracts obtained by the Garsson munitions combine.

In a letter to May, Chairman Mead (D-NY) asserted that the Kentucky Congressman's statement disclaiming any profit from his connection with the Cumberland Lumber Co., a Garsson affiliate, "does not give adequate information" and "is not satisfactory to the committee."

Mead ruled out, too, any subcommittee excursion to question May at the latter's Prestonsburg, Ky., home. Brushing off that possibility, he asked that May advise the committee "when it may be expected that your physical condition will be such as to allow you to appear and testify before the committee in Washington."

May was taken ill on the eve of his scheduled testimony to the committee last July. In a statement yesterday, he said he was now able to "be out of bed for a short time each day and would be very happy to meet with a subcommittee here in Prestonsburg."

He also declared he received no compensation for acting as Kentucky agent of the Cumberland Company and that the sole motive for everything he did was furtherance of the war effort.

The committee subpoenaed May, chairman of the House military committee, after hearing testimony from army officers that he interceded with them to get war contracts for a manufacturing combine organized by Dr. Henry Garsson.

A War Department report, meantime, apparently wrote off one question raised by the committee about the Garsson operations. This was whether Garsson companies made the defective 42 mortar shells which killed 38 American soldiers. The army answer was, "No." It said premature explosions of the shells were due to defective fuses and the Garsson firms made no fuses.

CIO Dixie Drive Makes Progress

Charlotte, Sept. 6.—Van Bittner, chairman of the CIO Southern organizing campaign, said here today the drive has been amazingly successful to date.

So far, he added, the union has won more than 100 employe elections, and has filed 293 petitions with the NLRB for certification.

Bittner made his statements after attending a conference of top executives of the campaign which seeks to add 1,000,000 new members to CIO rolls.

By EDWIN SHANKE Stuttgart, Sept. 6.—(AP)—Secretary of State James F. Byrnes' speech in Stuttgart, establishment of a centralized German government, rejected France's claim to the Rhineland and Ruhr and warned Russia that the United States does not consider Germany's eastern boundary fixed on the Oder.

In an unprecedented speech regarded as the most important American foreign policy pronouncement since the end of the war, Byrnes outlined a broad plan for eventual unification of the German people under a national council which, he said, should be charged with drafting a federal constitution for Germany.

Byrnes' original text, distributed last night in Germany and at Washington, spoke of this constitutional as being a "United States of Germany," but Byrnes later eliminated this phrase from the text and omitted it in delivery.

At the same time Byrnes made plain the intention of the United States to continue indefinitely her interest in European affairs and emphasized that "security forces probably will have to remain in Germany for a long period."

"I want no misunderstanding," Byrnes said. "We will not shrink our duty. We are not withdrawing. As long as an occupation force is required in Germany, the army of the United States will be part of that occupation force."

The secretary addressed an audience of German and allied leaders in this seat of the German provisional government for the American zone. The city was gaily decorated with flags. For security reasons, the military detachment was increased four times the normal size.

While emphasizing the determination of the United States to see Germany rise again as a peaceful, centralized nation, Byrnes rejected French claims to the Rhineland and Ruhr and warned Poland and Russia that America does not consider Germany's eastern boundary fixed on the Oder.

Territories now occupied by Poland and Russia were "provisionally assigned" at Potsdam, Byrnes asserted, and "the protocol of the Potsdam conference makes clear the heads of government did not agree to support at the peace settlement the cession of any particular area."

British Firm On Free City Issue

Paris, Sept. 6.—(AP)—Great Britain warned the peace conference today that she would withdraw from the Big Four agreement on division of Venezia Giulia if Trieste is not given a genuine international status as a free territory.

Charging that Yugoslavia is now claiming a very special position in the administration of the disputed Adriatic port, British Delegate Hector McNeill said Britain would reconsider the whole agreement if Trieste's independence is impaired.

France, too, lined up with Britain in opposing Yugoslav claims to domination of Trieste, though in less unequivocal language.

Maurice Couve de Murville, the French delegate, said his nation Trial recessed at noon yesterday the core of the whole situation. He warned flatly that "We'll honor our bargain but if the statute is so changed as to impair the conception of a free territory we will have to reconsider our whole agreement."

Byrnes' Speech And Other Developments Indicate Russian Challenge For Control Of Germany Is Accepted; Western Powers To Speed Independence

The Byrnes speech and other developments in Germany indicate that the British and Americans have accepted the challenge of the Russian refusal to co-operate either politically or economically, and that there will now be a relatively open contest for the support of the Germans themselves.

Economic pressure and Russia's efforts to spread into the American zone the political "unity" which she has forced in eastern Germany, has led to counter-measures.

Russian talk about ultimately unifying Germany has been met by actual economic unification in the Anglo-American zones. Although this was done as a part of a general policy calling for control of Germany as an economic unit, Mr. Byrnes' phraseology makes it obvious that we also intend to reap

Tobacco Prices For Eastern Belt Go Up

Opening of five-cured tobacco market yesterday following a five-day sales holiday was marked by prices on the eastern North Carolina belt which pleased growers and by less satisfactory bids on the North Carolina-South Carolina border belt.

The Federal-State Marketing News Service at Raleigh, N. C., reported gains of from \$1 to \$15 per hundred pounds for tobacco sold in the eastern belt. The bulk of advances ranged from \$4 to \$11, the service said, with the largest jumps for the poorest grade leaves, long and primings.

The News Service said that some grades offered on the border belt showed increases partially recouping losses registered before the holiday, but that more declines than gains were registered.

M. G. Mann Of FCX Urges Farmers To Balance Their Farm Program

Declaring that Pitt County would be one of the hardest hit counties in North Carolina in the event of another depression, M. G. Mann, general manager of the Farmers cooperative Exchange, urged the patrons and stockholders of the Pitt FCX Service to take advantage of these good times by balancing their farm program in order to avoid such tragedies as North Carolina farmers suffered in 1933-34.

Mann, administrative head of the FCX organization throughout the state, was speaking at the annual stockholders meeting and barbecue picnic here Thursday afternoon at the Greenville High School.

"I do not wish to appear to be an alarmist today," he said, "but we may as well face the facts that the American farm income will decrease in due time and if we are not prepared to meet this emergency it's going to be a real crisis like we experienced in the early thirties."

Bus Lines Seek New Franchises

Greenville was well represented at a hearing before the N. C. Utilities Commission in Raleigh yesterday when a number of passenger bus companies applied for franchises to establish passenger bus schedules in and out of Greenville. Willard T. Myer, executive secretary, and Joe Koye, represented the Chamber of Commerce, and Charles E. Blair the Merchants Association. Other sections were also represented.

The Seashore Transportation Co. applied for a franchise to operate from Washington through Pictouville to Greenville. The Norfolk Southern Bus Corporation sought a franchise for a line from Williamson, through Stokes and Robersonville to Greenville. The Carolina Coach Co. also sought a franchise for a line from Washington via Pictouville to Greenville, and from Williamson through Stokes to Beulah over the dirt road. The Ricks Bus Line sought a franchise from Williamson by way of Stokes and Robersonville to Greenville.

## Women in the Church

by Mary Fowler

Although statistics are as yet too meagre for a final determination, they seem to bear out the idea that woman's new role in the working world, enlarged by the war, has increased the crime rate among women, says a statement, "Is a Crime Wave Coming?" prepared by the American Historical Association. They explain: "Women commit only a small proportion of crimes in normal times. Murder is almost the only crime of violence in which they are likely to figure. There are almost no women robbers or burglars. The woman criminal depends on deceit, fraud, and the use of sex appeal as a rule, rather than on strength, skill or agility. Students of criminology have always assumed that one reason for this state of affairs was the fact that woman's role as wife, mother, and housekeeper sheltered her from many of the conflicts and temptations that confront men. But the war wrought enormous changes in women's lives." The Association believes that full employment, eradication of slums, and racial and religious tolerance will do much to combat crime.

Liberia is the scene of a gigantic struggle between the American-Liberian, nominally Christian woman, and the pagan woman of the native population, according to Bishop Willis J. King, American head of the Methodist Church in that land. He points out that each group is influencing the other, but that the pagan group, larger in numbers, is pulling the Christian women to a lower level of civilization. Both groups are relatively helpless in the face of the changing social order, the bishop says, due largely to lack of educational opportunity and economic insecurity. "The only hope for womanhood in Liberia is of lifting both groups to the complete level of the Christian conception of home and family," he adds. The Woman's Society of Christian Service of the Methodist Church is making a beginning in establishing a hostel for Christian girls in Monrovia, the capital city.

Two thousand women, representing sixty-eight American Protestant denominations are expected to attend the third biennial assembly of the United Council of Church Women, in Grand Rapids, Mich., November 11 to 15, also delegates will attend from Switzerland, Wales, England, Holland, Italy, Belgium, Puerto Rico, Cuba, Chile, Japan, Korea, China, India, the Philippines, Ceylon, and Canada.

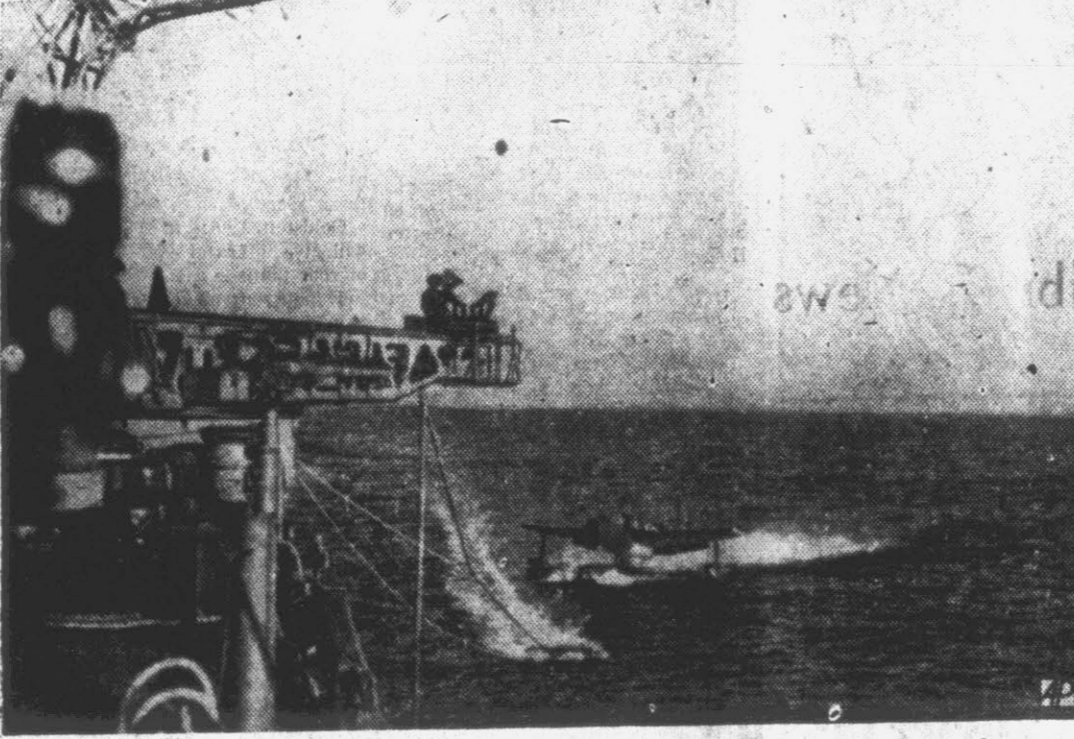
"No, Lillie said sharply. "He can't come here. I've got to go out. You go back to Miss Miller's."

## Strength FOR THE DAY

**BEHIND THE TIMES**  
There should be city ordinances  
everywhere requiring "people who  
put a clock on public display to  
keep it regulated. When the town  
clock stops, or the clock in the  
church tower, or in the railroad  
station, or in the hall of the office  
building, quite a few people are  
liable to be inconvenienced and  
misled. If one sets his watch by a  
clock that is stopped, he finds him-  
self late for every engagement un-  
til the mistake is discovered.  
Some people set the watches of  
their lives by clocks that have  
stopped. Some people regulate their  
religious lives by a variety of the-  
ology long since outmoded. Many  
people think economically in terms  
of concepts that were valid a hun-  
dred years ago but thoroughly in-  
adequate today. We say such people  
are behind the times, and literally  
that is exactly what they are. The  
standards by which they are guided  
were one time correct but are not  
correct now. We have to have  
standards—something by which to  
set our watches—and we cannot  
afford to set a watch by a clock  
that has stopped.  
In other words, have you stopped  
thinking? Have you stopped grow-  
ing, spiritually? When we stop  
growing, we stop living. Our funeral  
service may not be held for some  
years to come but we die when we  
stop thinking and growing. Our  
lives look to the past, not to the  
future, and when that happens, we  
have ceased to live.

**CHILDREN IN CHAINS**  
The matter dealt with in  
the following editorial from  
the Goldsboro News-Argus  
is one that should grip the  
attention of every North  
Carolinian and hold that at-  
tention until something is  
done about it. Adequate  
care of the feeble-minded,  
whether they are Negroes or  
whites, is a state obligation  
and no more time should be  
lost in taking steps to fulfill  
this obligation.

The News-Argus has this  
to say on the matter:  
Did you happen to see the Asso-  
ciated Press dispatch out of Fayetteville which read:  
"Fayetteville—(AP)—C. D. Carter  
of the Cumberland county sheriff's  
office said he had found a 16-year-  
old Negro girl with her ankles  
chained to a 15-pound iron ball  
hobbling around near her home out-  
side Fayetteville.  
Carter quoted a woman as  
saying that her daughter had  
been in a state institution for  
feebled-minded at Goldsboro until  
two years ago when she was released.  
She said that the girl was kept  
chained to prevent her from wan-  
dering away during the day.  
The mother said the girl was un-  
chained at night.  
Carter said he had ordered the  
mother to remove the chains and  
to bring her daughter before Clerk  
of the Court Charles W. Broadfoot  
in Fayetteville to determine if such  
treatment were proper.  
That ends the AP report.  
Naturally such a report makes us  
shudder.  
But there isn't anything so very  
unusual about the report. Such in-  
stances must be taking place in  
many counties of the state every  
day.  
The State Hospital for the Negro  
Insane is not charged with ac-  
cepting feeble-minded Negro chil-  
dren. It is charged with the care  
and treatment of the insane.  
This probably explains how the  
Fayetteville child was received at  
the Goldsboro institution at one  
time and later discharged.  
Negroes look after their own.  
Their sense of family obligation is  
strong. If it is at all possible they  
prefer to do what they can for one  
of their own rather than to ask for  
state help, even if what they can  
do may seem and be most meagre  
and makeshift.

groups of the state asked for the creation of an institution for the feeble-minded children. An institution comparable to Caswell training school for white children at Kinston. Governor Broughton directed that a survey be made to find out the need for such an institution. The state welfare department conducted a survey through its 100 county offices.  
This survey listed 1,200 Negro children of feeble minds who are being cared for at their homes. The survey was made very quickly and it is probable that it is not complete.  
The survey did show that the state is under a real and deep obligation to its Negro children to provide for the feeble-minded adequate facilities where they can be cared for in comfort and without suffering, disease and squalor that is the rule where the makeshift of home care is adopted.  
The survey showed that there are many feeble-minded Negro children where the parents have to chain them to beds or keep them confined in cages or behind locked doors. The parents have to do this because the State has not provided facilities for the feeble-minded Negro child at any of its institutions.  
So don't feel shocked at the report of the child in chains in Fayetteville.  
It is only the unusual and unexpected that shocks us, and in North Carolina it is not unusual for feeble-minded Negro children to be chained or caged.

**SOIL EROSION EXPERT FETED**  
**Soil Conservation Farming Boosted By Program**  
Soil Conservation farming such as is being carried out in Pitt county as a part of the Coastal Plain Soil Conservation District program, will be given a big boost throughout North Carolina on September 9.  
Governor R. Gregg Cherry has proclaimed September 9 as Hugh Hammond Bennett Soil Conservation Day in North Carolina. The occasion is a homecoming celebration at Wadesboro on this date in honor of Dr. Bennett, Chief of the U. S. Soil Conservation Service and a native of Anson County.  
The Governor's proclamation follows:  
WHEREAS, Hugh Hammond Bennett, an Anson County farm boy, has through his deep love for the soil become an outstanding figure in soil conservation in this land and many lands, and  
WHEREAS, he has tirelessly dedicated some 43 years to study and instruction in land preservation first in his own state, then in the nation, and finally in the nations of the world, and  
WHEREAS, he has waged an unremitting fight for wise land use in the past which led to his eventual appointment as Chief of the Soil Conservation Service, and is at present still conducting a vigorous fight for the nation-wide adoption of soil conservation measures to protect the nation's soil resources for this and future generations,  
THEREFORE, I, R. Gregg Cherry, as Governor, hereby designate and proclaim—in connection with a homecoming celebration in Mr. Bennett's home county of Anson—that the day of September 9, 1946, be Hugh Hammond Bennett Soil Conservation Day in North Carolina.  
IN WITNESS WHEREOF, I have hereunto set my hand and caused the Great Seal of the State of North Carolina to be duly affixed.  
The program at Wadesboro is sponsored by the supervisors of the Brown Creek Soil Conservation District to honor the district's internationally famous native son. As indicated by the Governor's proclamation, however, the event is of more than local significance as Dr. Bennett has become a symbol throughout this nation and many foreign lands of the fight against improper use of the land and other natural resources.

the country as an economic unit now.  
In the meantime the western allies tried to hold a rather passive line. Now they appear to have been forced to set some backfires.  
Such statements as those of Byrnes and General McNarney holding out to the Germans the hope of some measure of self-government soon, a respected place in the society of nations, and in the United Nations organization, have their part in this developing picture. So does establishment of an American radio station offering equal facilities to all political parties, after the Russians blocked American efforts to gain a share of control over radio Berlin.  
There is a difference still, of course, between the Russian moves toward actual political control of Germany and the western desire to see western political beliefs on the ascendancy among the Germans. But the issue, obvious but unofficial heretofore, now seems rather drawn. It is whether Germany is to be developed along what westerners call democratic lines, or whether the Russian "sphere of influence" will eventually be advanced to the Rhine.  
The most immediate effort is likely to be an improved economy with the Germans reaping benefits while relations between their conquerors deteriorate.

Time is rapidly running out on Bobby Feller's hopes of setting a new major league strikeout record as the Cleveland Indians' great pitcher wallows in the worst slump of his baseball career.

The speedy righthander, who has figured a good bet to become the first pitcher since Dizzy Dean of 12 years ago to notch 30 victories when he registered his 20th win last July 31, has hit an amazing decline since then, losing six of his next eight starts, including his last three.

Feller's sudden reversal of form also has practically ruined his chance of overtaking Rube Waddell's 42-year-old listed record of 343 strikeouts.

In his last eight starts, Feller has whiffed only 40 batters to increase his season's total to 283. He is expected to make five more starts which means he must average 10 strikeouts per game to equal Waddell's mark.

But Feller suffered his most humiliating defeat yesterday in Detroit at the hands of the Tigers who clubbed him for eight runs in the fourth inning, the most runs ever scored against Feller in one frame since he joined the majors in 1936. The previous high was five by the New York Yankees.

In all Feller was tagged for nine runs and 11 hits in the three and one third innings, he worked with the Tigers beating him for the third straight time, 10-0. Fred Hutchinson hurled the shutout for the Tigers.

The heated National League pennant race continues unabated as the front-running St. Louis Cardinals and runner-up Brooklyn Dodgers both won, the Cards shelling the Chicago Cubs in a night game at St. Louis, 10-1, and the Brooks shaming the Braves in Boston, 1-0. The Cards retained their two-game bulge over the Dodgers, with 22 games remaining on each team's schedule.

Jim Bagby moved the Boston Red Sox to within four games of clinching the American League pennant, scattering nine hits to defeat the Senators 1-0 in Washington at night.

The Yankees protected their two-game margin over the Tigers by defeating the Athletics in Philadelphia, 6-2.

After tying the score at 3-all with

three runs in the bottom half of the seventh, the Chicago White Sox defeated the visiting St. Louis Browns 4-3 in 11 innings.

Jack Graham's second home run of the day, with two mates aboard in the ninth inning, gave the New York Giants a 6-5 victory over the Philadelphia Phillies at the Polo Grounds.

Held scoreless for eight innings, the Pittsburgh Pirates got to Johnny Vander Meer for three hits and two runs to defeat the Reds 2-1 in Cincinnati.

That's all for veterans of World War II—and the cost runs into billions. In addition are the costs of hospitalization and pensions of veterans of World War II and previous wars.

(This year—fiscal 1947—the government expects to receive in revenue—taxes—about \$39,600,000,000. There's \$1,900,000,000 less than the \$41,500,000,000 it figures to spend for all reasons.

(That \$41,500,000,000—called the budget—covers all expenses from the money for veterans to the pay for government clerks in Washington and the President's salary to running the army and navy.)

Here's how the \$10,000,000,000 appropriated for veterans breaks down:

- \$559,505,915—is the cost of running the Veterans Administration and includes salaries, mail, printing and binding.
- \$147,442,500—operating veterans hospitals.
- \$1,905,000,000—pensions for all veterans.
- \$1,472,900—military and naval insurance.
- \$169,535,000—National Service Life Insurance.
- \$3,491,387,000—readjustments benefits, such as education and job training.
- \$30,000,000—cars for amputees.
- \$4,000,000—canteens for veterans, such as in hospitals where they can buy cigarettes, candies.
- \$243,708,000—terminal leave pay.
- \$441,250,000—hospital building.
- \$853,927,000—housing, such as temporary stuff near schools and premium payments to get materials where necessary.

of a central German government Byrnes declared that the four-power allied control council "so far as many vital questions are concerned is neither governing Germany nor allowing Germany to govern herself."

All that the allied governments can and should do is to lay down the rules under which Germany can govern itself," he said. "The allied occupation forces should be limited to the number sufficient to see that these rules are obeyed. x x x

"It is the view of the American government that the provisional government should not be hand-picked by other governments, but should be a German national council composed of democratically responsible minister-presidents or other chief officials of the several states or provinces which have been established in each of the four zones.

"Subject to the reserved authority of the allied control council, the German national council should be responsible for the proper functioning of central administrative agencies, which should have adequate power to assure the administration

of Germany as an economic unit as was contemplated by the Potsdam agreement."

The secretary said the American government took the stand that "the German people throughout Germany under proper safeguards should now be given the primary responsibility for the running of their own affairs."

He explained that the leaders and minions "of the ruthless Nazi dictatorship" had to go, and added, "But it never was the intention of the American government to deny to the German people the right to manage their own internal affairs as soon as they were able to do so in a democratic way, with genuine respect for human and fundamental freedoms."

Byrnes also reiterated the United States contention that Germany should be administered as an economic unit.

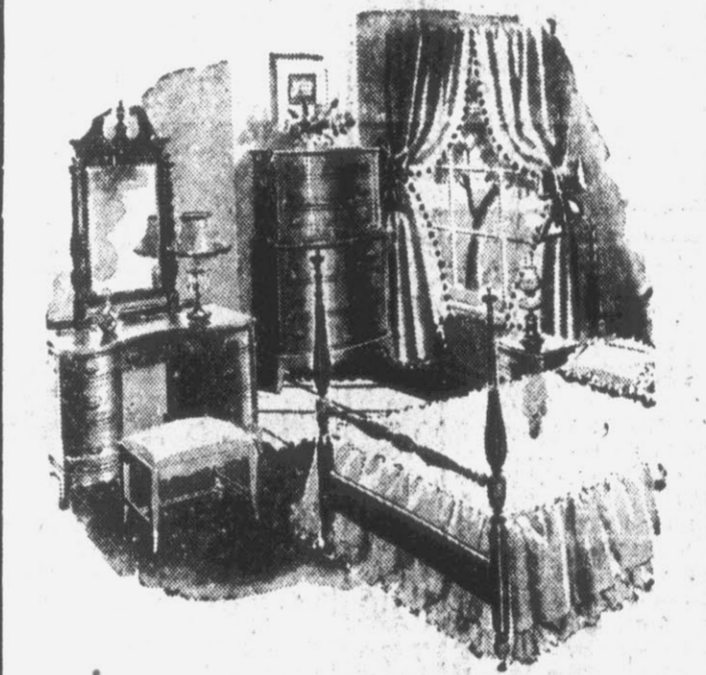
