TRIESTE SAID OUTPOST FOR FUTURE WARS

Yugoslav Spokesman Accuses Western Powers of Seeking Bridgehead

Paris, Sept. 17.—(AP)—Yugoslav spokesman Ales Bebler accused the western powers today of seeking to establish a bridgehead in the free city of Trieste for future military action against Yugoslavia.

Opening the Slav bloc's attack on the proposed boundaries of the free territory, Bebler told a peace conference commission the only reason these were expanded beyond the Trieste city limits was to allow space for the deployment of armed forces.

Bebler referred to the governor's powers in the free state as envisaged by western nations, and said they could be explained only by considerations of power politics.

"He can even call in foreign soldiers," said Bebler. "But against whom? The object of their action is never named but is always implied—Yugoslavia."

Bebler spoke as statesmen lined up once again in the Italian political and territorial commission on opposing sides of the Trieste issue—this time in connection with the frontiers of the projected free area.

Bebler urged the adoption of a Yugoslav amendment which would push the boundaries back to the city proper, a proposal paralleled by White Russian amendment and contested by South African and Australian amendments which would extend the free state south in Istria to include Pola and other Italian coastal communities.

The military committee, meanwhile, upheld the foreign ministers' council draft of disarmament clauses in the Italian treaty after rejecting, 16 to 4, a South African amendment which would have held Italy to military and naval restrictions at least five years regardless of decisions made by the United Nations Security Council.

Only Australia, New Zealand and the Netherlands supported South Africa in this move whose defeat confines Italy to the military clauses until the United Nations Security Council makes some agreement with Rome for peace enforcement.

Some conference sources predicted that the Slav delegations, mindful of Senator Tom Connally's words yesterday that Trieste must be free from intrigue and conspiracy, might do what they did yesterday in the case of Bulgarian quietly drop demands for extra territory in order to concentrate on the defensive struggle against opposing demands.

Connally's counter-blast against Russian Foreign Minister V. M. Molotov's Saturday speech seemed convincing evidence to the 21-nation parley that the U. S. State Department was sticking to its "tough" policy toward Russia despite last week's criticism by Commerce Secretary Henry Wallace.

Gerald ran to Mrs. Orrico and won her the decision. The mother was told she could renew her application in six months if she had a home for Gerald.

Henry Wallace To Visit Truman Tomorrow At The White House

Washington, Sept. 17.—(AP)—Henry A. Wallace, whose speech on Russia last week churned up an uproar, is going to the White House tomorrow to talk things over with President Truman.

Wallace's oratory has presented the Chief Executive with the problem of permitting him to continue to speak up on a ticklish situation, as he has said he will do, or possibly asking him to resign as Secretary of Commerce.

Presidential Secretary Charles G. Ross told reporters today that Wallace has an appointment with Mr. Truman for tomorrow afternoon. Asked if it was made at Wallace's request, Ross replied:

"I don't know just how the appointment was made. He will be in sometime tomorrow afternoon."

A newsman told Ross that Wallace is reported to have written the president a letter "pointing out the dangers of war between the United States and Russia" and that copies of it have reached outsiders.

Ross said he did not know a thing about it.

The presidential secretary said no when asked whether Mr. Truman had heard from Secretary of State Byrnes or had talked with him this morning.

Wallace declared his intention yesterday of keeping up his fight for changes in the conduct of this country's international affairs. That was before his appointment with the president was made.

High among the considerations involved in that across the desk meeting will be the fact that the congressional elections are only seven weeks off.

Republicans already are making

political capital of Wallace's speech in New York last Thursday and the resulting controversy over it, while Democrats acknowledge privately that they consider the incident the toughest they have faced.

Democrat National Chairman Robert E. Hannegan discussed the situation with Mr. Truman at some length late yesterday.

As for Wallace, friends represented him as pleased over the results of his initial efforts to make a national issue of the state of American relations with Russia.

In Paris, Secretary of State Byrnes maintained complete personal silence on the whole question of Wallace's demands for a softer policy toward Russia. But there was ample evidence that State Department officials here were considerably disturbed by what they regarded

Ship Seized

LONG BEACH, CALIF., Sept. 17.—(AP)—The Coast Guard announced today it had seized Tony Corcoran Stralla's luxurious gambling ship, the Bunker Hill, "for a violation of federal law."

A statement from Commodore L. L. Bennett, commanding the 11th Coast Guard District, read:

"The Bunker Hill has been seized by the U. S. Coast Guard at the request of the U. S. Department of Justice for a violation of federal law. She will be turned over to the custody of the collector of customs, by order of the commandant, U. S. Coast Guard, Washington, D. C."

Coast Guard officers said it could give no further details.

The action came a day after Stralla and three co-defendants were bound over in Los Angeles for Superior Court trial on charges of conspiracy to violate the state penal code by soliciting persons to board the vessel.

OCEAN QUEENS IN CONVERSION

Luxury Liners Readied For Atlantic Passenger Runs

New York, Sept. 17.—(AP)—The United States and Great Britain are racing to get their respective superliners—the America and the Queen Elizabeth—back into the North Atlantic passenger trade.

A bit of foresight—the storing of the Elizabeth's furnishings in hiding places around the world when war broke out—gave the British an advantage from the start. The furnishings of the America were sold.

The America, which is being converted by the Maritime Commission to carry 1,050 passengers, was scheduled originally to leave Newport News, Va., on October 5 with her first trans-Atlantic voyage from New York scheduled on October 17. However, this schedule is expected to be delayed.

The Queen Elizabeth, equipped to accommodate 2,314 passengers, is scheduled to sail from Southampton on October 16, the first large luxury liner to make the postwar Atlantic crossing. Her sister ship, the Queen Mary, will enter drydock for conversion in about two months and awaiting her will be most of her prewar furnishings, which likewise were stored in ports around the world during the war.

The other competing prewar queen of the Atlantic, the Normandie, lies in Brooklyn waiting to be scrapped. Her luxurious furnishings, valued at \$2,000,000, and her stock of 18,000 bottles of liquors, were removed and stored when the U. S. Navy took over.

Electrocuted

WALLACE TALK CENSORED BY TOKYO PAPERS

Delete Criticism Of Allies And Of Split Over Foreign Policy

Tokyo, Sept. 17.—(AP)—An emaciated version of Secretary Wallace's speech and the resultant controversy on U. S. foreign policy—heavily censored by occupation authorities—re front page copy in metropolitan newspapers.

Censors eliminated from reports of the Associated Press and other news services Wallace's criticism of British imperialism in his contention that U. S. policy was leading toward war with Russia.

Japanese editors said the U. S. government's information service (USIS) report, which had been torn down, suffered further deletions from Tokyo sources.

Editors said they were prevented from commenting editorially on the censored report or suggesting that the speech indicated differences of opinion between the U. S. and Britain.

Col. W. B. Putnam, civil censorship officer, confirmed that censored deleted Wallace's remarks on four broad points.

Putnam said the time the deletions were made there was no indication that Mr. Wallace was speaking for anyone other than himself. Criticism of one allied power by an individual or another allied power is not allowed in the Japanese press; criticism of one allied power by another is allowed in the Japanese press only if the state-

OPA REDUCES CAFE PRICES

Meat Meals In Restaurants Sent Back To June 30 Level

Washington, Sept. 17.—(AP)—An OPA edit sent restaurant price ceilings on meat meals back to June 30 levels today, but the cost of cotton clothing inched up another notch.

Also on the price front: 1. OPA studied a petition for higher prices on General Motors automobiles after granting an average six per cent increase in retail ceilings for Ford-built cars.

2. The price decontrol board which meets tomorrow to decide on whether to restore ceilings on dairy products, reported opposition to removal of controls in nine of the first dozen written statements received.

The OPA order restoring June 30 restaurant ceilings immediately applies to all meals and individual menu items in which meat is the major ingredient.

In issuing the order last night the agency said the cost of dining out was being rolled back, but it did not estimate how much.

Until yesterday ceilings on meat-based restaurant meals had been frozen temporarily at prices in effect August 31, just prior to restoration of ceilings on live animals.

At retail, ceilings restored on many early this month averaged about 31-2 cents a pound more than those of June 30.

While meat was no longer price control restaurants were permitted to base their ceilings on the actual cost of raw meat. They continue under this principle in the case of menu items which still are ceiling-free, such as fish, poultry and dairy products.

'Squatter' Movement Growing In Australia

Brisbane, Sept. 17.—(AP)—The "squatter" movement, launched recently in Britain, spread to Australia today when more than 100 families moved into vacant military camps in two Brisbane suburbs.

"There will be serious trouble if they try to send us back to the hovels from which we came or throw us out into the streets," a spokesman for the squatters declared.

Ship's Survivors Tell Of Terror In Big Storm

Lewis, Del., Sept. 17.—(AP)—Twenty-four survivors of the Norwegian tanker Marit II that broke in two on Friday 148 miles off Elizabeth City, N. C. on the cold front of a tropical hurricane rested safely today in east coast ports as hopes waned for 14 other missing crew members.

Six of the crew, picked up from a life raft Sunday night by the S. S. Gulf Hawk, were landed here yesterday and taken to Beebe hospital. They suffered exposure and minor cuts but none was seriously injured. Eighteen others, picked up by the tanker Panamoco and landed at Morehead City, N. C., yesterday prepared to leave today for Rocky Mount, N. C., where they will board a plane for New York. Three sustained minor bruises but all were in good physical condition.

Meanwhile as army, navy and coast guard aircraft and surface craft continued their search for possible survivors of the foundered 7,417-ton Marit II, Lt. Cmdr. J. R. Scullion, coast guard public information officer at Norfolk, Va., said it was unlikely that additional survivors would be found.

With lips still parched, the six seamen who were landed here told of the terrifying 56 hours they spent clinging to a life raft that pitched and wallowed in a 30-foot sea after the ship broke in two at the spot where a German torpedo had struck the vessel four years ago.

ELECT BISHOP TO HIGH POST

Protestant Episcopal Church Has New Presiding Bishop

Philadelphia, Sept. 17.—(AP)—The Rt. Rev. Henry Knox Sherrill, D. D., Bishop of Massachusetts, was elected today as the new presiding Bishop of the Protestant Episcopal Church in the U. S. A.

He succeeds the Rt. Rev. Henry St. George Tucker of Richmond, Va., who has held the office since 1937 and who will retire on age December 31.

The new presiding bishop was chosen at a closed session of the House of Bishops at the church's 53th triennial convention. His election was announced immediately after the church's House of Deputies, also meeting in closed session, concurred with the bishops.

Bishop Sherrill served as a chaplain with the first army in World War I. During World War II, he served as head of the church's army and navy commission, now called the Church's National Council.

Following the war, he became rector of the church and in 1930 became Bishop of Massachusetts following the death of Bishop Charles L. Slattery.

He has been a member of the church's National Council and for a time was vice chairman of the House of Bishops and assessor to the presiding bishop.

Last year he was named chairman of the General Commission on Army and Navy Chaplains with head-

Stranglehold On U. S. Shipping Broken; CIO Shortens Picket Lines; Thousands Of AFL Sailors And Longshoremen Start Back To Work; No Picketing Of Foreign Ships

The strike stranglehold clamped on America's maritime fleets for 13 days was broken today by a voluntary shortening of CIO Seamen's picket lines so AFL sailors and longshoremen could return to work.

Within a few hours after Joseph Curran, president of the National Maritime Union (N.M.U.), announced his decision to restrict pickets to CIO-contracted vessels, thousands of AFL maritime workers reported for duty in New York, Boston, Baltimore, Portland, Me., and other ports.

Ships flying foreign flags also were released from CIO picket lines in Curran's order.

In Boston, six ships including cargoes of raw sugar, wood pulp, granite and goods from India were being unloaded. AFL waterfront crews went back to work at Baltimore without interference from CIO pickets.

In New York about 500 longshoremen were at work at six piers and hundreds more longshoremen were expected back on the job later today. At Portland CIO pickets quit three AFL-manned Liberty ships and workmen, who had refused to pass the picket lines, resumed delayed repairs to two of the vessels at the former New England Shipbuilding Corporation yard.

AFL seamen began the strike September 5 in protest against a Wage Stabilization Board decision limiting negotiated wage increases.

All foreign ships not under contract to the N.M.U. also were exempt from picketing under the new directive, issued this morning by N.M.U. President Joseph Curran after a conference with his aides at union headquarters in New York and in the name of the National Strike Policy Committee of the N.M.U.

Curran's order did not mention the future action to be taken by N.M.U. members regarding ships manned by the AFL sailors union of the Pacific.

The N.M.U. head said the union's action would free about 40 SIU ships in the port of New York, permitting them to prepare at once to sail.

Curran's directive followed by several hours a request by the AFL maritime trades department that the N.M.U. withdraw its picket lines around all vessels on the Atlantic Pacific and Gulf coasts except CIO-contracted ships "to eliminate

Grant Injunctions Against Squatters

London, Sept. 17.—(AP)—The British government, acting in the face of threatened opposition by organized labor, obtained an interim injunction today against the invasion of government-vacated buildings in the spreading squatter movement.

The government brought four cases testing the rights of the squatters which would restrain them from entering, remaining in or otherwise trespassing on premises occupied in a Communist-sponsored invasion last week.

It was granted in the first of the proceedings, dealing with occupancy of the Duchess of Bedford apartments. The squatters were given three days to vacate the premises. Colin Pearson, attorney for the government, first had insisted they move within 48 hours.

Commenting on the evacuation order, the court observed: "The defendants might well go quickly. They must have known from the beginning that their act was illegal."

ABC's Of An Uproar

A Simple Summary Of The Widespread Reaction Caused By Henry Wallace's Speech Advocating A Change In Foreign Policy; The Background And Results

Washington, Sept. 17.—(AP)—Here's an ABC on the uproar over the Henry Wallace speech on this country's foreign policy.

President Truman and Secretary of State Byrnes shape our foreign policy. They decide how we deal with other countries.

Byrnes is in Paris now. He's working with other nations on World War II peace treaties.

He's working and battling in line with the foreign policy he and Mr. Truman have laid down.

Wallace, being Secretary of Commerce, does not make foreign policy. But he thinks we ought to make some changes in the policy we have.

He wrote a speech, saying so. This was unusual in itself. Members of Mr. Truman's cabinet, like Wallace and Byrnes, usually stay out of one another's field.

Byrnes, in Paris, didn't see the speech. And Wallace did not show it to any of Byrnes' helpers in the State Department.

Instead, he took the speech directly to Mr. Truman last Tuesday for his approval, and got it. He went off to New York to deliver it Thursday night.

Thursday afternoon, a few hours before Wallace talked, Mr. Truman told a news conference in reply to questions that he not only had approved the whole speech but that it was in line with Mr. Byrnes' foreign policy.

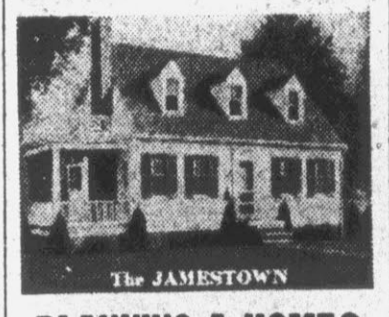

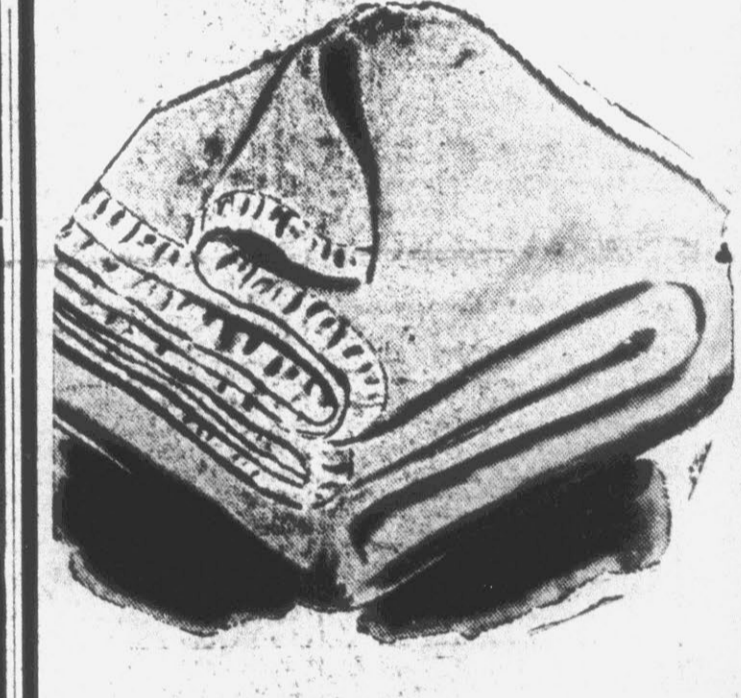

IT'S UP TO US
Do you ever complain about your bad luck and the injustice of the world? If you do not, you are exceptional. Most of us are ready upon the least pretext to assail others for our failures, or to blame circumstances for our unhappiness. We are wretched, we declare, because we do not have something which we very much want to have, and which by rights, we should have.

We are unhappy, let us never forget, because we are the kind of people we are. Happiness is neither created by the possession of certain things, nor denied us because we lack these things. Happiness is an inner state of contentment with the world and particularly with ourselves. Things have practically nothing to do either with the creation or the maintenance of such contentment. We are happy when we have made up our minds to put up with what we cannot change and when we are giving the best we have in us to change the things that can be changed. If things made a difference in people's happiness, the rich would all be happy and the poor would all be miserable. This is not the case, and never was.

WASHINGTON LETTER

ARMY'S '10-IN-1' FOOD PACKAGE IS NOW FEEDING EUROPE

Washington—The Cooperative for American Remittances to Europe (CARE) is a non-profit organization through which individuals or groups may order "10-in-1" food packages for delivery to relatives, friends, groups and organizations in certain countries. You can send food without designating a beneficiary, too.

The "10-in-1" is a standard food package, originally designed by the U. S. Army to feed American soldiers. It could be used either as a ration for 10 men for one day or one man for 10 days.

Miss Mary Barber, a very efficient person who was director of home economics for the Kellogg Company of Battle Creek, Mich., was called to Washington in January 1941, as food consultant to the Secretary of War.

She was assigned to the Quartermaster General's office and saw the early progress of rations to guide the diet of young men in selective service. The object was to get a ration that would be nonperishable and which would be met with the greatest acceptance by the troops.

After Pearl Harbor it was necessary to develop rations to meet the different exigencies of the battle front. Finally the "10-in-1" food package was evolved.

Miss Barber says the "10-in-1" is perfectly packaged for shipment overseas. The containers keep out all moisture and gases and prevent any possible spoilage.

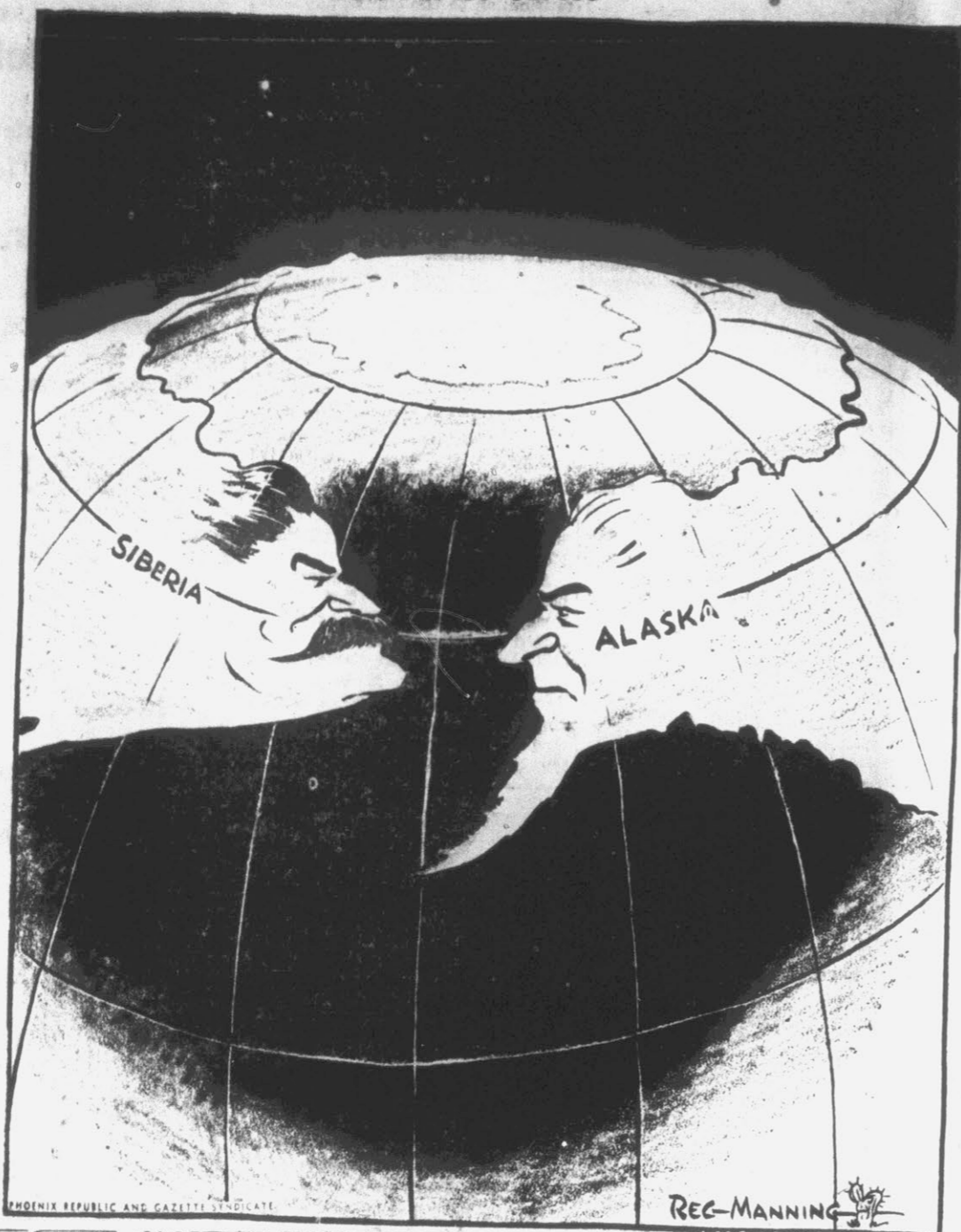
To provide variety in diet, government specifications called for five different assortments. Through the package was set up for American food habits, its contents can be prepared in a variety of ways preferred by Europeans.

Miss Barber described the "10-in-1" food package as a "practical and nutritious contribution to the people in Europe."

Gotten together originally for the GI overseas, with its 4,000 calories a man a day considered necessary to keep the American soldier up to par, the rations for the use of a European family can be stretched much farther.

It has been roughly estimated that 2,000 calories will sustain life, thus

the number of persons the "10-in-1" could feed in one day could be 20 or one person could be fed for 20 days.

Among the foods contained in the package are canned fruit for breakfast and a cereal. The last the Army calls a pre-mix. It is ready to eat, with sugar and powdered milk added. It can be eaten hot or cold dry or moist. It can also be used successfully as a baby food.

In addition, the package contains more powdered milk, army biscuits, canned meat of some type, canned cheese and canned vegetables. All of these are ready to eat, except the bacon.

For her work during the war Miss Barber received the meritorious award for exceptional civilian service. She was the tenth woman ever to receive this award in the history of the U. S. Army.

as an appearance of American disunity to the rest of the world. It was understood from top officials that State Department leaders are considering a recommendation to Mr. Truman that any further speeches by Wallace on foreign policy should at least be subject to State Department clearance.

However, most diplomatic and political authorities here seemed to be of the opinion that Mr. Truman was confronted with the necessity for positive action with two main considerations in mind. Either (1) he could approve additional speeches by Wallace on foreign policy in the hope that it could be made clear that they did not necessarily represent administration thinking, or (2) he could ask Wallace to leave the cabinet in order to counter any charges of disunity in American diplomacy.

Pressure to keep Wallace as a member of the government was reported fairly strong because of what many of Mr. Truman's advisers consider to be the commerce secretary's considerable political following.

Yet among lawmakers of both parties there were increasing de-

mands for what Senator Kilgore (D-WVa) called a "unified front" in the handling of foreign affairs. Kilgore told reporters that "Americans must present a unified front behind the administration in dealing with foreign affairs."

2. But since Mr. Truman said he had approved the whole speech, did this mean that what Wallace suggested would be our new foreign policy?

3. Where did that leave Mr. Barber? Why was Mr. Truman letting Wallace announce a new foreign policy instead of Mr. Byrnes?

4. How could Byrnes remain Secretary of State if Mr. Truman without consulting him, had changed our foreign policy to a line different from the one Byrnes was following in Paris?

Here were main points of difference between what seems to be our present foreign policy and what Wallace suggested:

1. We have a "get tough with Russia" policy, although the State Department doesn't like that kind of language. Wallace suggested we cut out the tough stuff.

2. We've been standing shoulder to shoulder with Britain in bucking Russia repeatedly. Wallace says we ought to have a foreign policy independent of Britain and not let Britain lead us into trouble.

3. We're on record against "spheres of influence." That is, domination by big nations of smaller nations around them. Wallace speaks of Russian and American spheres of influence as if they were now operating.

And Wallace says further: Let's keep our nose out of the political goings of nations close to Russia and let Russia do the same for us. The storm became furious Friday after Wallace's Thursday night talk. Republicans jumped on Wallace for making the speech and on Mr. Truman for approving it. Editorial writers condemned the talk.

And State Department officials threw up their hands in dismay. Pretty quickly it became clear Mr.

Truman was going to have to say this was the new policy of the United States or else, in some way make it clear that it wasn't.

He called a special news conference Saturday and read a statement which said:

"I can't mean, when he said he approved the whole speech, that he had approved the speech as constituting a statement of this country's foreign policy."

Mr. Truman said further he only meant that he had approved Mr. Wallace's right to deliver the speech. In this way Mr. Truman took himself and Mr. Byrnes off the hook and all that Mr. Wallace had said, then, was simply what Mr. Wallace thought. This seemed to cool things off a bit.

But yesterday Wallace, not finished at all, said: "I intend to continue my efforts for a just and lasting peace and I shall, within the near future, speak on this subject, again."

So it seems Mr. Truman soon again will have to approve—or disapprove—Wallace's right to speak on foreign affairs. If he disapproves then Wallace seems to be faced with this:

Either keeping quiet, so long as he remains in Mr. Truman's cabinet as Secretary of Commerce, or quitting his job and saying what he pleases as a private citizen.

the brunt of the hurricane struck her survivors, he said. One of the survivors landed at Morehead City said the ship broke in two at 12:40 p. m. (EST) Friday, apparently so suddenly that she had no time to radio an S. O. S.

"The rain started; the wind got higher, the troughs of the waves ran 15, 20, 30 feet deep. Everybody went overboard but me," Williamson recalled.

Thorsteinson said he was swept off the raft into the sea three times. Rekvik twice, Knutson once and Skarning twice, but "each time one went over the rest of us pulled him back."

When the storm subsided, the long wait began, Williamson said. "No food was not so bad, but no water . . . well, we just waited, and after a while we were rescued."

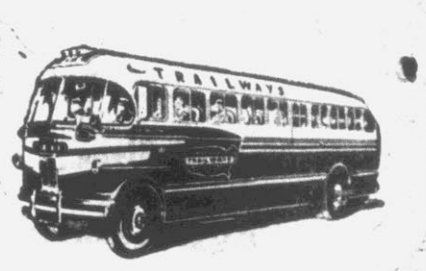

(Continued From Page One) umn has pointed out before—he deliberately debased his own people and those of other countries which came under his control.

Well, now, the majority of Germans find no answer to any one of these three problems in adopting Communism.

Problem number 1 speaks for itself. Even those Germans who adored Hitlerism—and there were many among the older folk—still are fearful of the Red tide from the east.

Concerning the economic ills of problem 2, I found during my recent visit to Germany that there were few in the zones occupied by the three Western Allies who saw any remedy in Communistic doctrines. Germany's economy has been essentially that of the west, although Hitler's totalitarian dictatorship imposed some striking variations, including barter which he practiced with much profit for the fatherland.

The third issue—that of spiritual and moral rehabilitation—looms large in the calculations of the many who believe that these elements are essential for the stability of a nation in the long run. You will see recognition of this in the fact that the heaviest vote appears to have been polled in all three western zones by religious combinations. Denominationalism was cast aside for the purposes of the election.

Here again the answer is that Communism—which holds that religion is the opiate of the masses—obviously doesn't fill the bill for anyone who has religious leanings. Hitler robbed many of his young folk of their religions but my observation is that the great majority of Germans still subscribe to religion in some form.

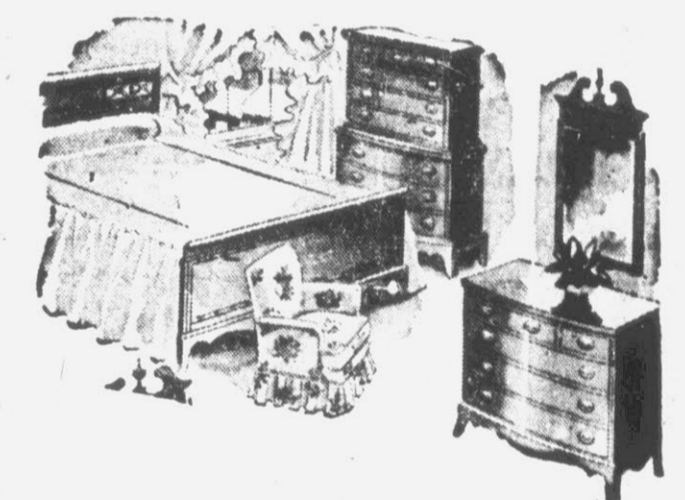

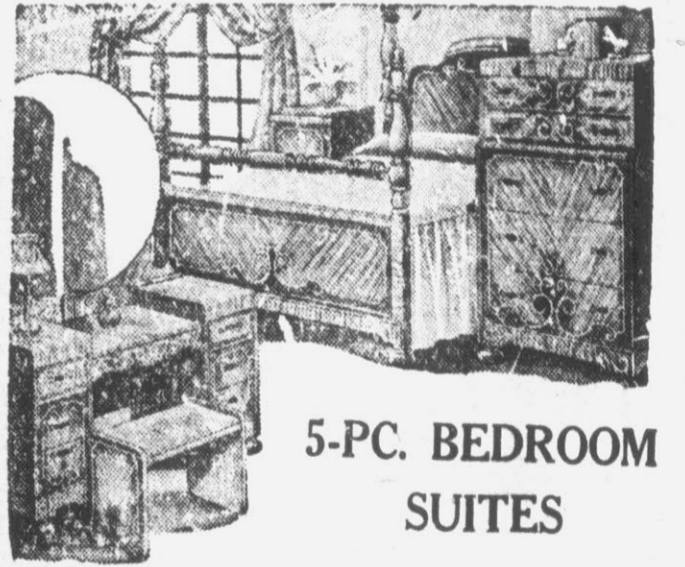

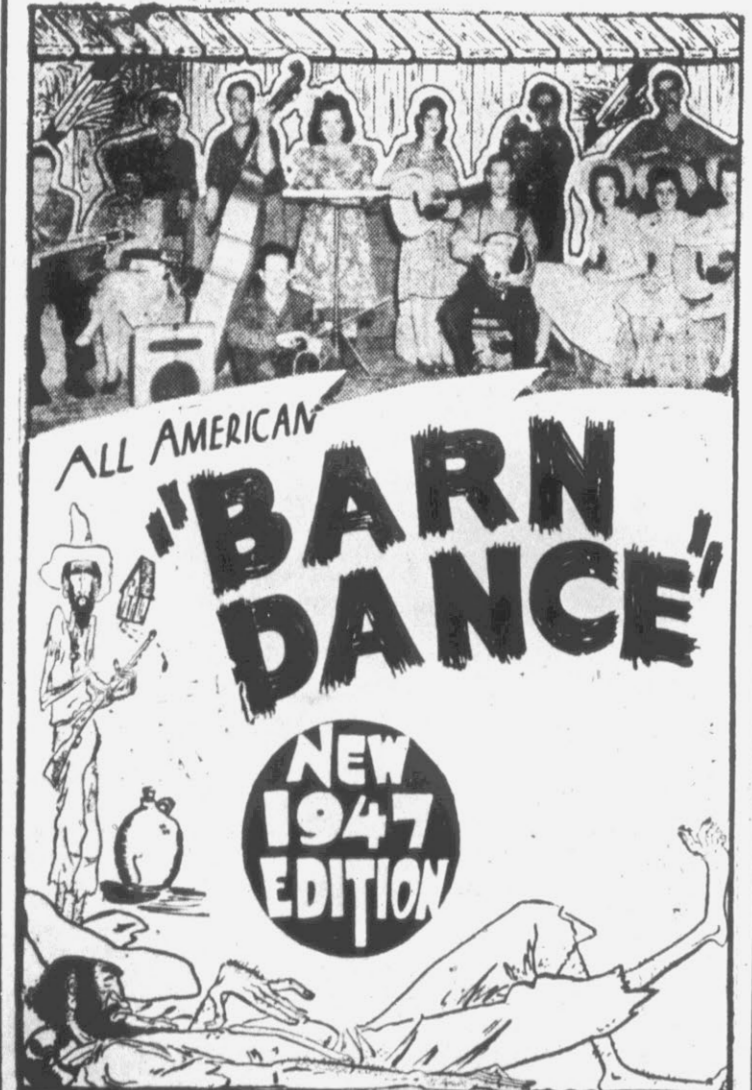
