STRIKE CLOUD HANGING OVER TIED UP CITY

New Walkouts Threatened In Pittsburgh Over Anti-Strike Injunction

Pittsburgh, Sept. 26—(AP)—The Allegheny County Common Pleas Court has dissolved its stern anti-strike injunction—crux of the city's three-day-old power strike—and dropped contempt charges against 10 union leaders who had defied the injunction.

Pittsburgh, Sept. 26—(AP)—A walkout by street car operators started today in this strike-harrassed steel capital, already in the grip of a power strike now in its third day.

Other strikes were threatening in apparent sympathy with the walkout by the power workers union.

The strike on the street car system of the Pittsburgh Railways Company, main method of public transportation in the city, was called suddenly at 4 a. m. and left thousands of early morning riders without transportation. The company announced all cars had been withdrawn from service.

A company spokesman said the stoppage was in sympathy with the power workers but the local leaders of the Amalgamated Association of Street and Electric Railway Workers denied it. They said the strike sprung from their own dispute with the railways company.

Both the Pittsburgh Railways Company and the Duquesne Light Co., whose production of electrical energy to an 817 square mile area has been reduced to 40 percent by the power strike, are subsidiaries of the Philadelphia company.

National and city labor leaders were rallying to the support of the power workers in their fight against an anti-strike injunction handed down by the Allegheny County Common Pleas Court. Leaders of CIO and AFL organizations in Pittsburgh with approximately 375,000 members called special protest meetings.

Normally the railways company serves about 1,000,000 riders daily with 950 cars. However, since the start of the power strike the number of cars has been reduced to 225 as a measure to conserve electricity.

Meanwhile, the strike of the 3,500 power workers hit an impasse.

More than 2,100 union members voted better than four to one against considering any company offer to end the three-day old strike until the injunction is lifted.

The strike had made more than 35,500 idle—3,500 workers of the struck Duquesne Light Co., 8,000

Seventh Victim On Tanker Dies

Wilmington, N. C., Sept. 26—(AP)—The toll of Tuesday night's explosion and fire on the tanker Benjamin rose to seven today when James L. Faulkner, 50-year-old seaman, died in a Wilmington hospital of burns.

Faulkner, a resident of Jacksonville, Fla., had been given little chance to recover as his burns were described by a physician as almost 100 per cent.

Previously six other members of the crew had died. They were caught by shock and flames when the terrific explosion blasted great holes in the forepart of the Benjamin at 10:38 p. m. Tuesday.

Meantime A. H. Pike and James H. Galloway, inspectors for the coast guard and the Q Merchant Marine Service left Wilmington for Southport at the mouth of the Cape Fear River to continue their investigation of the tragedy. The tanker was anchored at Southport.

They said they would make a thorough examination of the bent and shattered forepart of the ship and question officers and surviving crew members before holding an open hearing.

Conflict In Greece

A Ready Made Opportunity For Stalin To Support Words With Actions; Attempt For Un-Biased Investigation Of Greek Border Trouble Vetoed By Reds

In Greece there is a ready made opportunity for Joseph Stalin to support with actions his declaration that he believes unconditionally in "the possibility of a friendly and lasting collaboration of the Soviet Union and Western Democracy despite the existence of ideological discord." There the worldwide conflict between East and West has reached its most dangerous stage; all accounts show that large scale civil war is near.

In London a Greek embassy spokesman characterizes the fighting as "an invasion by subversive elements from Albania and Yugoslavia with the connivance of the two governments." The British government lends support to this view. There is no charge that the Soviet government is directly respon-

Work To Declassify Material; Ban Iwerks Committee Members; Staff To Study Housing Situation In Effort To Get Rid Of Red Tape And Build Living Quarters

Washington, Sept. 26—(AP)—An official tag of secrecy on files of the joint chiefs of staff snagged a Senate committee investigation of the \$33,000,000 wartime Canol oil project today.

The subject was dropped until Saturday and the War Investigation Committee turned to other matters, including the return of surplus property from abroad.

Senator Ferguson (R-Mich.) said he would seek prompt action on a thorough inquiry into home building delays, telling reporters he considers the administration's housing program a fraud upon the American people.

Obviously irked by a military ban on making the Canol oil project files public, committee members ousted Adm. Ernest J. King from testing until Saturday morning when they hope the material can be released.

King, the navy's wartime representative on the joint strategy board, had come prepared with a long statement and supporting letters.

Recalling that King had criticized the committee's annual report as "containing a willful distortion of facts concerning his part in the Canol oil producing and refining venture in Canada, Ferguson declared:

"We can't pass on distortion of the facts until we get the facts." The joint chiefs, it developed, had turned over the Canol files to the committee last Monday, but under a "confidential" label.

Col. Andrew J. McFarland, secretary of the joint chiefs of staff, was asked why the files were kept secret so long after the fighting ended.

He said the committee hadn't

Duke And Duchess Of Windsor Plan Visit

Paris, Sept. 26—(AP)—The Duke of Windsor is planning to take his Duchess to England next month for the first time since he renounced his throne to marry her 10 years ago, his secretary disclosed today.

The secretary said she did not know whether Edward and the American-born former King would have any plans to stay in Britain permanently, or whether they would stay at Fort Belvedere, the Duke's home in England, during their visit.

"We've just arrived from the Riviera and nothing has been decided," the secretary said.

BYRNES OPENS BIG SESSION

Plenary Council Meets To Speed Drafting Of Treaties

Paris, Sept. 26—(AP)—Secretary of State Byrnes rapped a gavel made of Utah copper tonight and summoned the peace conference in full session in an effort to "accelerate the work" of drafting five peace treaties.

The secretariat general called the session on a notice of less than five hours, apparently because of a deadlock over the proposed agenda for approving the treaty draft with Finland, first of the five European peace treaty drafts to be completed after two months of conference.

The original agenda of the 21-nation secretariat called for a plenary session tomorrow to discuss approval of the Finnish treaty text, but the American, Russian, British and French members were reported to have pressed for convening the plenary session as soon as possible.

The foreign ministers council program to speed the conference has been drafted for presentation by the foreign ministers' deputies, an informed source said.

The major point in this program would be a time limit on speeches in commissions to enable the conference to meet an Oct. 15 deadline for completing its deliberations.

In the military commission, meanwhile, the delegates decided to order Bulgaria to disarm her armed forces and to include frontier troops in a total strength of 55,000

Searchers Plunge Deep Into China's Bad Lands

Chengtu, China, Sept. 26—(AP)—A U. S. Army search team plunged deeper into China's wild and mountainous far west seeking long-lost American airman feared captive of the fierce slaveholding Lolos.

On the second day of cloud-capped mountains, half-savage Mongolian-featured warriors and Pandas, the soldiers were believed to be from five to 11 days march from their goal.

That goal is the valley of the Chinkiang, which carves its course from headquarters in the world's highest mountains in Tibet.

Missionaries have reported at least eight enslaved whites were seen grinding corn or tending flocks in that region, where few white men save the missionaries have ever ventured.

Lt. Col. Herbert W. Wurtzler and his detachment expected to set up headquarters at a remote Catholic mission and try to learn there if the white captives are U. S. airman owned two and more years ago on the perilous flight "over the hump" from India to China.

His party flew down to Sichang about 300 miles southwest of Chengtu. The mission is an estimated four days march west of Sichang. The region where the white men were seen is from two to eight days march farther westward.

Wurtzler hoped to talk with those who saw the white men. Then he will try to locate the captives

GREECE PLANS WELCOME FOR KING GEORGE

Return Of Monarch Is Expected To Stabilize Factional Strife

Athens, Sept. 26—The Greek government completed today its plan for welcoming King George II back to his throne despite fierce border fighting and the threat of a military Greece which Premier Constantinos Tsaldaris says has reached the magnitude of war.

Athens will close down completely Saturday morning for the king's return and police announced that all persons lining the route of the king's return to Greece after five years of exile would not be permitted to salute and that any person was liable to search.

All persons were forbidden to watch the parade from rooftops or balconies and a 500-foot radius from the route of march which will begin at 10 a. m. and continue to the Greek cathedral in Athens.

The king was to arrive at an airport on the Peloponnese and then board a destroyer for the journey to Piraeus, the port of Athens.

(In London, a source close to the king's return home by a recent visit, said the monarch's return was expected to stabilize the tense situation in Greece, and was expected to depart for Greece either today or tomorrow.)

Greek army corps, meanwhile were conducting virtual military operations to put down the rebellious positions in Thessaly and Macedonia, the major trouble spots, but although an estimated 30,000 British troops were dispersed in those areas there was no indication that they were involved in the fighting.

In London, the Laborite Daily Herald said today that British forces would leave Greece "as soon as the necessary transport can be provided," and added: "The British government has made it plain that British troops cannot be used for dealing with the present internal troubles in Greece." The paper said "early announcement" of the date of withdrawal could be expected.

Dynamite Blasts Atlanta Stores

Atlanta, Sept. 26—(AP)—A terrific blast, which police said they believed was caused by dynamite, early today ripped off the fronts of four business establishments located on the edge of the downtown section. No one was injured.

The explosion ripped open the front of Parker's Shoe-White laundry pickup station at 603 Washington Street, S. W., near the State Capitol and tore windows and doors from two delicatessens and a beauty shop.

Windows were broken in several houses and residents were awakened from their sleep. Streets were littered with glass.

Radio Patrolman L. O. Davis and J. B. Evans said they believed the blast was caused by dynamite.

Police began a search for several men who were reported seen near the wreckage examining it with flashlights shortly after the explosion.

Profit Estimates Too High Say Shipbuilders

Lake Success, N. Y., Sept. 26—(AP)—Scientists of the United Nations Atomic Energy Commission were ready for a showdown today on their report on atomic energy controls, with Soviet Russia holding the key to a unanimous vote.

The scientific and technical committee of the commission, made up of scientists from each of the 12 nations on the commission, was summoned to meet in secret session at the United Nations headquarters here at 3 p. m. E. D. T.

Members of the committee were represented as agreed that some final action must be taken on the report, which was adopted after 18 meetings, mostly in August, and which has been awaiting the formal approval of Soviet Russia for about

Islander Reports People Starving

Batavia, Java, Sept. 26—(AP)—Tens of thousands are starving on the island of Madoera, whose 2,500,000 people have been cut off from Java for more than a year, a prominent Madoerese who reached Batavia reported today.

Dutch authorities, confirming the report, said more than 5,000 Madoerese crossed the shark-infested three-mile channel to Soerabaja, Java, in the past three months, by swimming or using rafts.

The visitor told newsmen three quarters of his village of 5,000 had died of starvation and disease. Asking that his name be withheld because his family still was on the island, he charged that 10,000 soldiers of the unrecognized Indonesian Republic were rulling the people "iron-handedly."

An Indonesian spokesman here countered that the Dutch Navy contributed to Madoera's "very serious" famine by intercepting Indonesian relief ships carrying rice.

Why Is Meat Scarce?

Plenty Of Arguments Heard On Why We Have A Scarcity Of Meat; Fact Remains That Ranges Are Loaded With Cattle; How Controls May Be Taken Off

Washington, Sept. 26—(AP)—Why is meat scarce? There's no single, clear-cut answer. It's a jumble of arguments. The truth lies somewhere among them.

Here are the main arguments: 1. Farmers have plenty of cattle but are holding them back until OPA allows better prices or until price ceilings are knocked off entirely.

2. Farmers are not holding back. They're fattening up their cattle to make better beef. They won't be ready for market for weeks.

But, no matter what the arguments, the ranges are loaded with cattle. This much is true: Last summer—between the time Congress let OPA and meat ceilings slide and the time it revived OPA and the ceilings—a record number of cattle reached the market. Since there were no ceilings in that period, cattle-growers could charge any price for their meat they could get. Prices went up.

The prediction was made at the time that the record summer-run of cattle would mean less meat in the autumn. The reason: The cattle—which otherwise would have been sent to market through July, August, September, October—were rushed to market in that July-August period of no ceilings and good prices.

How did price ceilings get back on cattle? When Congress let OPA die June 30, all price controls died. Finally after wrangling through July, Congress set OPA up again. In the new law it created a three

Chairman Of House Rules Committee Asks Probe Of Packers; Administration Supporters Split Over Meat Control; Army Serves Priority Papers On Industry

Washington, Sept. 26—Charging that collusion among packers is depriving the people of meat, Chairman Sabath (D-Ill.) of the House Rules Committee today asked for an investigation of an "apparent conspiracy" to violate the anti-trust laws.

"This is a strike of organized greed against the American people," he declared in a telegram from his Chicago hospital room to Attorney General Clark. The packers have contended they are unable to obtain livestock supplies.

As administration supporters split on the question of suspending meat price controls and a hungry clamor arose throughout the nation these other developments occurred in swift succession:

1. Rep. Rogers (R-Mass.) told reporters after a White House call that President Truman took the stand that Congress had taken price control action out of his hands "when it legislated the decontrol board."

2. Mr. Truman himself arranged to see reporters at 4 p. m. in his regular weekly news conference.

3. The Agriculture Department came up with a report that fewer hogs are going to market now than ever before in modern history. (A similar situation with respect to cattle was reported earlier this week.)

4. The army moved in to take one-fourth of all meat produced by federally inspected slaughterers.

5. Mr. Truman's press secretary Charles G. Ross, turned aside with "no comment" reporters' questions about House Majority Leader McCormack's (D-Mass.) proposal that price controls be suspended or 60 days.

Horse Meat Sold In Beef Famine

New York, Sept. 26—(AP)—Sale of horse meat for New York City's dinner tables appeared imminent today to offset the shortage of other meats and skyrocketing poultry and fish prices.

Sale of horse flesh for human consumption is lawful in New York, but was violently opposed by former Mayor La Guardia, who called it a sign of national degradation.

Health Commissioner Israel Weinstein said horse meat was "just as nutritious and just as good as any other type of meat." Any persons wishing to sell horse meat in New York City are required by law to obtain a health permit, sell no other type of meat, and identify his shop plainly as a horse meat market.

FDR's Estate Valued Over Million Dollars

Poughkeepsie, N. Y., Sept. 26—(AP)—The late President Franklin D. Roosevelt left a net estate before taxes of \$1,085,486, according to a tax appraisal filed here today with Dutchess County Surrogate Frederick Untermyer by Henry Hackett, an attorney and an executor of the estate.

The appraisal indicated Roosevelt's gross estate was \$1,821,887 and was subject to deductions of \$736,400 for funeral expenses, debts, and other costs.

Social Security

INACCURATE WAGE REPORTS AFFECT BENEFITS OF COMPANY EMPLOYEES

October is the month in which employers, engaged in business or industry, will file with the Collector of Internal Revenue, their Social Security tax returns for the third quarter of 1946. Such reports must show the name, Social Security account number and amount of wages paid to each employee during the three-month period, July, August and September. The employer's tax return is audited by the Bureau of Internal Revenue and the wage information contained therein is then transmitted to the Social Security Administration to be used in maintaining a wage record for each worker concerned.

Madison H. Barney, manager of the Rocky Mount, N. C. office of the Social Security Administration called attention to the fact that during recent months, industrial plants and business firms in this section have taken on new workers, some of whom have never before had Social Security account numbers. Many of these workers are approaching retirement age and some are already 65 years old or more. It is especially important that the name and Social Security account number of each of these older workers be shown on the quarterly wage report. Why? Because they may be leaving their jobs before long, and they should have credit for all wages earned in covered employment in order to insure full payment of their Old-Age Insurance benefits.

Other workers, young or old, may die, leaving dependents who are entitled to benefits under the Social Security Act. But unless employers for whom they have worked include their names, account numbers, and wage earnings in quarterly tax returns, as required by law survivors may be deprived of benefits to which they are entitled.

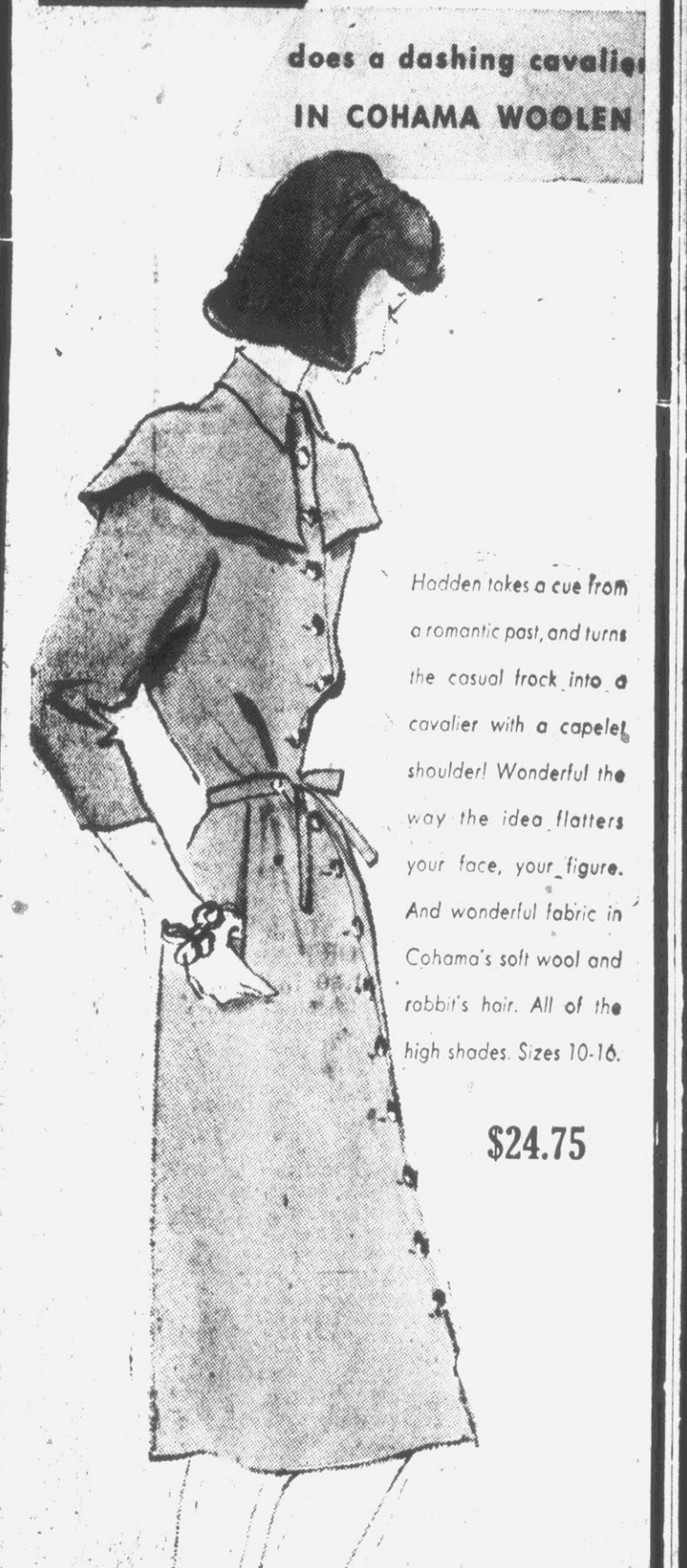

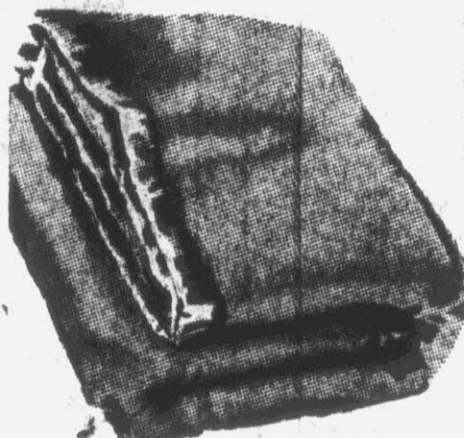

THE KINGDOM UNSEEN

One of the accusations brought against Christians in the early centuries was that of treason. The Roman authorities could not understand how a group of people could be loyal to the Roman emperor and still maintain that they recognized the sovereignty of "another king, one Jesus".

But the Christians did claim to be loyal citizens of the Empire and yet to give their allegiance to an unseen heavenly King. It was this conviction that beyond the seen order was an unseen order which strengthened them in times of persecution. It was their trust in the power of the unseen heavenly King which enabled them to live right-out lives in the midst of widespread temptation.

A story is told of Coligny, the French commander, who lived about 300 years ago and who was appointed to defend the little town of St. Quentin against the Spaniards. When it seemed that surrender was inevitable, the Spaniards offered reasonable terms. Coligny's reply consisted of two Latin words, "Rex est in Caelo"—"We have a King." This show of valor on the part of the commander strengthened the garrison until the day of victory arrived.

So it has always been with Christians. Citizens of different nations we nevertheless keep our minds anchored loyal upon a celestial kingdom. Loyal to our earthly magistrates, we give our supreme allegiance to a King who is unseen.

WASHINGTON LETTER

HE'S WHALE OF A MAN
By JANE EADS

Washington—He bears the distinguished name of Wilbert E. Longfellow and is actually a relative of the famous poet, but everybody calls him "The Amiable Whale".

Mr. Longfellow is the number one life saver of the American Red Cross and inaugurated its life saving program in 1914. It is estimated that 4,070,000 persons have been taught his methods. He's retiring in December.

At one time he weighed 300 pounds, but he's managed to knock off about 30 in recent years. He doesn't mind being nicknamed "The Amiable Whale".

"Webster says that while most blubber, a whale is a useful animal. I try to be useful no matter what shape I'm in," he chuckles.

He has been useful indeed. He wrote the life saving text for the Boy Scouts of America Handbook, the best seller since 1911. The Boy Scouts gave him the silver buffalo medal for distinguished service to boyhood.

Mr. Longfellow says most drownings occur between the ages of 10 and 19. That's why he likes to concentrate on the young, before they are afraid of the water.

"I believe in teaching them to live to grow up," he says.

His Junior Red Cross swim and life saving courses are designed for youngsters from 12 to 15 years of age.

"They are used by the Boy Scouts, the Girl Scouts, the Campfire Girls and at camps, municipal beaches, schools and colleges. The Red Cross now has 23,873 volunteer water safety instructors. There are 150 paid teachers on its professional staff.

Out of the course has grown a large number of summer aquatic school camps. Volunteers go for about 10 days intensive training. They return home to teach classes all summer. This is the twenty-fourth summer the courses have been taught.

Longfellow floats well on the water and stays floating for hours. He treads water while delivering his lectures. These he illustrates dramatically.

For many years he would have a child pull him around by the hair to demonstrate that a lightweight person can rescue a heavy one.

He stopped this, however, when



his hair began getting sparse. Longfellow invented breaks to release the so-called death grip of the drowning. . . . A sort of jiu jitsu to replace the knockout blow of earlier days. His breaks and releases have been adapted into armly-hand-to-hand combat training.

He has lived in Washington 29 years, is married and has a married son and daughter. He also has grandchildren who his says have been well "water-proofed".

A jolly man, with merry eyes, salt-and-pepper mustache and a rolling walk, he has scores of friends who are often invited at banquets. His hosts usually reserve two seats for him.

They succeeded the other day at the Security Council x x x in achieving their darkness, which is shrouding their intentions and their aims. Tsaldaris declared that the whole world "can see what we are doing x x x we do not want to hide anything from anyone."

But the fact remains that the Greeks and the British—and the American government, too—would welcome an unbiased investigation, while the Russian bloc would not.

Meanwhile the imminent return of King George II to Athens promises to bring the crisis to a new pitch of intensity and peril to the east.

attempt to have the council take action against the Greeks and British as a threat to peace ended in defeat for the Soviet bloc.

Soviet Delegate Andrei Gromyko's effort to compel Britain to report on the strength of her forces in Greece (and the United States to do likewise concerning its forces in China) was thrown out. In the course of this conflict Gromyko killed, by his veto, an American proposal, which had the backing of the overwhelming majority of the council, for an investigation of the whole Greek border situation.

The need for such an impartial study seems to most observers to be pressing; only by some such measure can the world get an ordered account out of the conflicting charges that come from Athens, Belgrade, Tirana and Moscow. Trygve Lie, Secretary General of the United Nations, has declared that he still may undertake such a study on his own responsibility.

The Greek Premier, Constantine Tsaldaris, speaking yesterday at Salonika, declared that Greece would welcome such a neutral and objective investigation.

"Foreign influences," he said have tended "to perpetuate disorder and a continuation of darkness

man decontrol board. It was the board's job to decide when and where ceilings should be removed or restored.

The law said meat ceilings should be restored unless the decontrol board said "No." The board did not say "No." So ceilings came back on meat. All were back by Sept. 13.

How can price ceilings be removed if the government declares that what is necessary to get the farmers to send their cattle to market?

There are two ways:

1. CFA can do it, the Agriculture Department, which is boss over livestock, approves.
2. A fairly long, roundabout way which goes like this: Representatives of the meat industry—called an Industry Advisory Committee—will have to ask Secretary of Agriculture Clinton P. Anderson to remove meat ceilings. They haven't done so yet, but are expected to if they asked him to do it, he'd have until Oct. 10 or 11 days, in which to do it or not to do it.

Dairying Prospects In South Are Bright

Memphis, Tenn., Sept. 26.—(AP) Dairying is slated to replace cotton as the biggest money maker for the southern farmer, perhaps within a decade, says Secretary Charles W. Holman of the National Cooperative Milk Producers Federation.
Addressing the Mid-South Milk Producers Association here last night, Holman declared the South had gained more than any other area in the nation in milk production since 1924. He said the gain was 80 per cent, adding: "That's not enough—for the South, now importing much of its supply of dairy products from other states, should be at least self-sufficient. And it can be."

CHINESE ARMY CUT OFF REDS

Move To Close Communist Escape Routes From Kalgan

Peiping, Sept. 26—(AP)—Government troops struck westward from Jehol Province today to cut off the Communists' northward retreat routes from Kalgan as three other forces moved closer in their maneuver to encircle the city.

The independent newspaper Hsin Min Pao said Chiang Kai-Shek's forces approached both Kuyuan, 90 miles north of Kalgan, and Tolun 183 miles north of the Red's military base.

Gen. Fu Tso-Yi's troops, approaching Kalgan from East Suiyuan Province, captured Hsinho, 90 miles northwest of Kalgan, and continued eastward, the paper said. This was the first report on Fu's troops since the Kalgan operation opened. It also carried an unconfirmed report that the Communists had moved their Kalgan government to Tolun.

Military sources here asserted government forces would converge on Kalgan along eight routes and said that would close all escape routes. Travelers arriving from Kalgan said comparatively few Communist troops remained in the city.

Meanwhile, the Communists acknowledged they were having internal troubles in Kalgan—an abortive uprising. They said Liu Chen Hsueh, former vice commander of the government fourth army, and several other nationals were captured in Kalgan while attempting to organize former Japanese puppet troops and bandits to strike at the Communists. Liu was executed on Monday, the rebels added.

Without explanation, the government said Gen. Tu Li-Ming, commander in Manchuria, would move his headquarters next month from Mukden to Changchun.

USN BUILT UP RED NAVY ARM

Trained Pilots; Gave Red Fleet Air Arm Bomb Sight

New York, Sept. 26—(AP)—The New York Journal-American said today the U. S. navy trained and equipped the foundation of what- ever naval air arm Soviet Russia has today.

The Journal-American said the project began in April, 1944, at the U. S. Naval Base at Elizabeth City, N. C., and by the end of the war the United States had supplied Soviet Russia with 15 squadrons of long range navy bombers.

The newspaper said the deal involved \$100,000,000, and was called project Zebra, "one of the longest kept secrets of World War II."

"The Russians who came here were Red army fliers because the Soviets had no naval aviation in the sense the U. S. and British navies possess," the Journal-American said.

"They took back to Russia bombers equipped with all the latest radar then workable, except long-range navigation device we were trying to perfect ourselves—and they took the celebrated Norden bombsight."

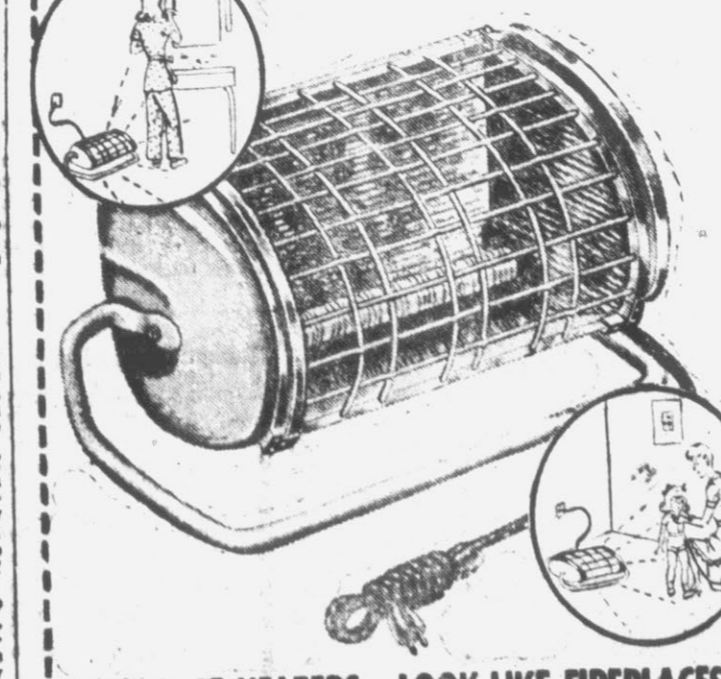
"The first bomber equipped with the Norden bombsight took off for Russia Oct. 31, 1944."

The newspaper said Vice Admiral P. N. L. Bellinger, commander of the air force, Atlantic fleet, supervised project Zebra and his fleet air wing No. 5 furnished the components.

"An A-1 priority was given to project Zebra," the Journal-American said, "and U. S. navy officers who could speak Russian were abruptly summoned from farflung assignments to Elizabeth City, when some of our own anti-submarine operations in the Atlantic were being conducted."

Senator Kilgore (D-WVa), leaving through King's prepared but undelivered testimony, noted that it contained a letter dated October 26, 1943, from Adm. William D. Leahy to James P. Byrnes, then war mobilizer, which he said also appears in the files still classified as secret.

It developed that the joint chief

had authorized King to make use of certain material.

Ferguson remarked that the material was still classified as secret as far as the committee was concerned.

Chairman Mead (D-NY) commented:

"We cannot proceed under the disadvantage we have here. Our committee is not able to use this information publicly and yet some of the witnesses are using information which we are denied."

In calling for a housing investigation, Ferguson told reporters "thousands" of experts are studying and planning without achieving production.

He said the committee should put its entire staff to studying the housing situation—dropping all other investigation if necessary—in an effort to get rid of red tape and to build actual living quarters.

Ferguson said "What is going around the country telling what is going to do, but is not getting anything done."

His final act as the Redleg boss was to mastermind his hirings to a 6-0 victory over the St. Louis Cardinals—an act which might cause the Brooklyn Dodgers—a team Bill admits he dislikes—to nose out the club he formerly managed for the National League flag.

McKeechie knew full well what the Dodgers, who earlier in the season he had accused of "dirty playing" against his Reds, had lost 11-9, to the Philadelphia Phillies. A St. Louis victory would just about seal Brooklyn's pennant hopes as it would give the Cards a two-game advantage with only 3 games left.

He nominated Bucky Walters, always a tough cookie for the Cards, to pitch Walters pitched one of the finest games of the season to blank the Birds with seven hits. Twice McKeechie signalled for sacrifices and each time it paid off.
