Labor And Management Hold Economic Key As Price Controls Ditched

Only Rents, Sugar And Rice Curbs Retained In Policy Announced By President Truman Saturday; All Other Controls Dropped

By MARVIN L. ARROWSMITH Washington, Nov. 11.—(AP)—Labor and management—free of government curbs after five years—held the key to America's economic future today as President Truman heaped the junk pile with wage and price controls.

Only ceilings on rents, sugar and rice survived the chief executive's sweeping decontrol act. And federal officials termed rent increases inevitable.

In killing off all other controls in a weekend order, Mr. Truman said: "I am convinced that their further continuance would do the nation's economy more harm than good."

At the same time the chief executive placed squarely upon management and labor the responsibility for economic stability.

His decontrol edict brought immediate promises from industry and business leaders that prices will be held at reasonable levels—after a period of adjustment.

But some of these leaders tempered their pledges with a big "if"—if wage demands don't upset the apple cart.

From labor unions, many of which already are seeking higher pay to offset living cost increases. There was nothing but silence on the president's action.

While the unions said nothing the U. S. Chamber of Commerce called on labor to exercise self-restraint in wage demands and in the use of the strike weapon to enforce wage demands.

And Robert R. Watson, president of the National Association of Manufacturers, declared that prices after a temporary rise, will be adjusted downward under restored competitive conditions, unless industry costs are forced up by another round of wage demands.

Mr. Truman's order wiped price ceilings off building materials as well as scores of other items, including clothing, automobiles, furniture, paper, steel and other metals.

Officials of the National Housing Agency, which fought elimination of building material controls, expressed doubt that the \$10,000 sales limit on new homes can be held for long.

The Associated General Contractors of America called for removal of controls on prices of new housing, saying this would speed up construction.

As for rents on existing dwellings the consensus of government officials is that there will have to be no increases.

In lifting other controls, Mr. Truman noted that some shortages remain and some prices will advance sharply. But he added: "The consumers of America know that if they refuse to pay exorbitant prices, they will get no goods."

Attlee Says The Matter Of Creating An Economically Strong Germany Offers Difficulties; Powers Jockeying For Political Position

TRUMAN LEADS CELEBRATION

World War I Armistice Day Observed Throughout The Nation Today

By The Associated Press Armistice Day tributes to the dead of two world wars mingled today with calls at home and abroad for their sons to stand on guard that war may never come again.

Here in the United States, President Truman led the observance by laying a wreath of chrysanthemums on the unknown soldier's tomb in Arlington cemetery.

Saying the nation's defense program is aimed at keeping the peace, the President added in a brief address:

"The welfare of the United States and the welfare of the world are wrapped up in one package: Peace and the welfare of the world as a whole."

The President handed back symbolically to the various states the colors which their national guard units carried in the last war. The actual return of the flags was accomplished in the capitals of the states today.

In a ceremony at the amphitheater, following the President's appearance, national American Legion Commander Paul H. Griffith called for a strong national defense program, and asserted that "scrupulous strength and fighting strength" is the formula for "insuring American peace and security."

Termining spiritual strength the "first requisite of national defense," he declared "that is why the silences that are sweeping our land have as their first objective our spiritual disarmament by seeking to make disbelievers in America."

Griffith said the Legion will propose "a comprehensive" national defense and preparedness program to the new congress, with universal military training as the plan's "backbone."

In France, school children decorated graves of French and Allied soldiers. American veterans of 1917-18 were represented by the Paris post, Veterans of foreign wars, at ceremonies at the Arch of Triumph.

President George Obalut placed a wreath on the tomb of the unknown soldier. German prisoners of war laid flowers on the graves of 6,000 American war dead buried near Cambrin. (Continued on Page Six)

Jaycees Condemn Drunken Driving

Asheville, N. C., Nov. 11.—(AP)—In resolutions passed at yesterday's concluding two-day session, the state board of directors of the Junior Chamber of Commerce condemned drunken driving, called for amendments to the state's general statutes relating to drunken driving, and went on record for promoting a highway safety campaign for 1946-47.

The board also adopted and endorsed the North Carolina good health program, voted to hold its next meeting at Greensboro next February, and voted to hold finals for the next North Carolina beauty pageant at Wilmington.

The resolution for amendments to the state's laws on drunken driving would include the following provisions:

(A) A minimum fine of \$200 or 30 days prison sentence plus a two year revocation of driver's license for the first drunken driving offense.

(B) A prison sentence of 90 days and a permanent revocation of driver's license for second offense.

The temperance board's report also requested all pastors not to appoint to official church positions persons who drink, advertise, manufacture, sell, advocate its use or in any other way seek to promote the liquor traffic. The report was made by Mrs. B. B. Slaughter of New Bern.

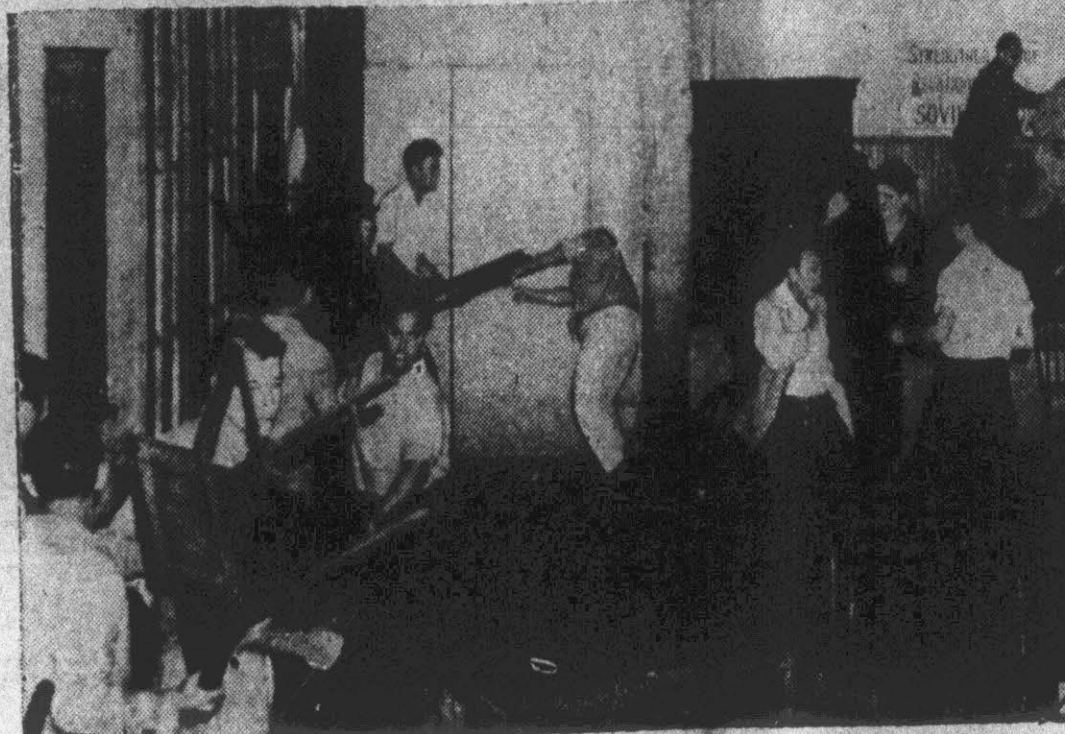

President Urges Exercise Of Wisdom And Restraint

Senate To Continue Same Foreign Policy

Overwhelming Support For Vandenberg-Byrnes Policies Predicted

By JACK BELL Washington, Nov. 11.—(AP)—Republican leaders predicted today that the new Senate will give overwhelming support to the Vandenberg-Byrnes foreign policy.

They pointed particularly to a dozen first-term GOP members listed as enthusiastic backers of international cooperation.

Former Gov. Harold E. Stassen of Minnesota, who campaigned for many of the leading members, said he is satisfied the new majority party will offer even stronger support than Republicans gave in the past to the program worked out by Secretary of State Byrnes with the advice of Senators Arthur Vandenberg (R-Mich.) and Tom Connally (D-Tex.).

Stassen told a reporter during a weekend visit to Washington he believes there is solid foundation for Vandenberg's declaration of United Nations delegates that the change in control of Congress will bring no deviation from the present bi-partisan policies. Vandenberg is expected to succeed Connally as chairman of the Senate Foreign Relations Committee in January.

In a separate interview, Senator Joseph Ball (R-Minn.) similarly counted the voting results as strengthening the position of those senators who have advocated an active part in world affairs for this nation.

"There is nothing in this election that indicates we are going back to isolationism," Ball declared. "If there are any isolationists left among the Republicans of the Senate, they certainly are badly outnumbered."

The party's so-called internationalist wing reportedly is counting heavily on such new senators as Raymond Baldwin of Connecticut, Henry Cabot Lodge, Jr., of Massachusetts, Edward J. Thye of Minnesota, Irving M. Ives of New York, Harry F. Cain of Washington and Joseph R. McCarthy of Wisconsin.

Despite the confident forecast however, there were indications that proposals for extending economic aid to other countries may continue to encounter strong Republican opposition in the Senate.

Rep. Joseph W. Martin Jr., of Massachusetts, who will become speaker of the Republican House in January, replied in a statement:

"We welcome an opportunity to work with the president in carrying out the mandate of the people and to return this government to the people and to sane Americanism."

"America's position in international affairs must be kept non-partisan."

"We believe in America and the American way of life. We shall be glad to cooperate with the president and the patriotic Democrats in Congress to achieve progress and security in the American way."

Rep. Charles A. Halleck of Indiana, a candidate for the House Republican leadership, told reporters: "We Republicans recognize our responsibility and we are going to meet it."

"The president probably refers to the three branches of this government and of his desire to cooperate as head of the executive branch," Halleck said. "Certainly those of us in the legislative branch will join him in that cooperation."

Rep. Leslie Arends of Illinois, the House Republican whip, said Republicans in Congress "will carry out their responsibilities under the new powers which came to them through the elections."

"The country, of course, is first and uppermost in the minds of our party," Arends added. "I think we should and must continue the non-partisan approach to our foreign relations problems. Our foreign policy program should be made and kept clear in the minds of people."

Senator Brewster (R-Me.) called the president's statement "great" and "worthy of the office that he holds. He shows that he is an American before he is a Democrat. I am sure he will find that Republicans will meet him in the American majority."

MANY KILLED ON HIGHWAYS

Eighty Seven Killed And 488 Injured In State In September

Raleigh, N. C., Nov. 11.—(AP)—Eighty-seven persons were killed and 488 injured on North Carolina streets and highways during September, compared with 82 killed and 486 injured in August, Motor Vehicle Commissioner T. Boddele Ward reported today.

Fatal accidents by types were: motor vehicle with pedestrian, 28; ran off roadway, 24; motor vehicle with other vehicle, 23; motor vehicle with fixed object, 3; overturned on roadway, 3; other non-collision, 2; motor vehicle with animal drawn vehicle, 1; motor vehicle with bicycle, 1.

Ward said 412 accidents occurred in cities and towns, accounting for 13 deaths, eight of which were pedestrians, while 485 accidents occurred on rural highways, accounting for 74 deaths, 19 of which were pedestrians.

Guilford County led with five persons killed. Wake was second with four, while Anson, Garteret, Davie, Gaston, Haywood, Mecklenburg, Robeson and Rutherford had three each. Fourteen counties reported two fatalities each: Bladen, Catawba, Chatham, Cleveland, Columbus, Duplin, Durham, Halifax, Jackson, Pitt, Rowan, Stokes and Surry. Twenty-six other counties had one fatality each and 50 counties had none.

Time Will Tell

Immediate Future Uncertain As Nation Scraps Wartime Controls And Returns To Free Economy; Many Difficulties Must Be Overcome

Washington, Nov. 11.—(AP)—To-day we head into one of the golden periods of American history—or into withering disaster. Time—it may take years—will tell which.

For we have reached that point—that "free economy"—which businessmen and labor leaders, each in their own way, have screamed for. The government has stepped aside. On Saturday—except for all sugar, rice and rents—it dropped all controls on prices and wages.

This ended the controls which had been part of our daily lives since 1942. They had been kept 14 months after the war's end to get us over that hump of re-conversion which goods were scarce and prices might have rocketed.

Two Killed In Airliner Crash

Cleveland, Nov. 11.—(AP)—A United Airlines plane crashed into trees and high tension wires just north of Cleveland airport early today, killing the pilot and co-pilot and injuring 17 passengers and the stewardess. The plane, flight 404 bound from Chicago to Boston crashed during a rainstorm.

The victims: Pilot F. L. Brown, 25, Chicago. Co-pilot Robert L. Arnold, 25, Hammond, Ind.

The plane was demolished as it spun into the ground, the engines being torn from the wings and the fuselage breaking in half.

MECHANIZED HUNTING Weldon, Ill., Nov. 11.—(AP)—A farmer Mike Seal didn't have time to get a horse or a hound or a gun so he used his car to go fox hunting. When a fox fled to a state highway from Seal's farm, Seal jumped into his automobile and pursued the animal down the road until the headlights-blinded fox ran smack into another car.

Seal recovered the net and collected the county bounty.

Local Tobacco Market Enjoying Record Year

W. L. Whedbee, Supervisor of the Greenville Tobacco Market, today revealed that in the 35 sales days that the market has been open this year that it has already paid out the astounding sum of \$35,311,636.03. Whedbee stated that this was over nine million more dollars than had ever been paid out on the Greenville market in any whole year in the market's entire history, and that the figures would go still higher, as the marketing season is not yet over. The nearest approach to this all-time high record with the year 1945, when the Greenville market sold \$30,454,820 pounds of tobacco for the sum of \$25,947,845.94.

The foundation for this prosperity that now exists in our county, said Whedbee, was laid back in the days of a group of foresighted men

of our community laid the plans for crop control of tobacco. Whedbee recalled the recent year of 1939 in which crop control was abandoned and prices went down so low that the market had to be closed. This was a costly lesson, not only to the farmers, but to every man, woman and child in this community. This mistake said Whedbee, should never be allowed to happen again.

Crop control was voted in again for the year 1940, and the following statistics, including the banner year of 1946, speak for themselves, said Whedbee: 1940—49,594,306 pounds, \$8,667,268.09 averaged \$17.48; 1941—43,760,734 pounds, \$13,500,374.65 averaged \$30.85; 1942—50,692,332 pounds, \$17,883,216.59 averaged \$35.29; 1943—44,201,278 pounds, \$17,734,636.81 averaged \$39.90.

Roberts convicted Noah Harris, Negro, owner of the Victory Cafe, on Bonner's Lane, of receiving stolen goods from two small Negro boys, and sentenced him to serve six months in jail, to be served at hard labor on the roads. The boys will be tried in Juvenile Court Thursday.

The two boys, 11 and 13 years old, respectively, testified that they had a key to Laura Wooten's store on Fleming street; that they took two cases of beer and sold it to Noah Harris for two cap pistols and \$2. On questioning by the judge and Solicitor, Ed Bloom, Harris admitted buying the beer for the two cap pistols, but denied paying any money.

The judge and the solicitor sharply denounced the practice of small storekeepers acting as "fences" and buying stolen goods from juveniles. They pointed out that these boys had been up before for stealing bicycles, and selling them at rural points; that the 11-year-old lad is just out of a reformatory; that their mothers don't care for them and that this was evident from the fact that neither mother appeared at the trial this morning. Police officers testified that the youngsters would not attend school and that they slept in warehouses and subsisted by petty thieving. Police Officers R. W. Dennis and W. E. Peterson investigated the case and made the arrests.

When the court pronounced sentence on Harris, his attorney gave notice of appeal to Superior Court Bond was \$200.

It was brought out during the trial that Noah Harris, who last week had James Powell, Negro, arrested on a charge of stealing his watch; was taxed with the costs for false and malicious prosecution after Powell was found not guilty.

Incidentally, police stated that there are nearly a dozen small Negro boys to be tried in Juvenile Court this week for petty thieving.

It exploded as he picked up and destroyed his right eyeball," a Bethel official said today. The firecracker was tossed from a passing car.

Marcus Monroe Riley, Jr., 11-year-old son of Mr. and Mrs. Marcus Monroe Riley, was the victim. He was taken to Pitt General Hospital, where it was stated he would lose the eye.

Bethel Chief of Police said it is against the law to explode firecrackers in the town limits.

Incidentally, innumerable complaints are being made about cars speeding over the streets of Greenville nightly, exploding firecrackers, endangering traffic and making life miserable for people by keeping them awake. Residents of the College View section said that exploding firecrackers annoyed them and kept them awake. Between 11 and 12 o'clock last night the cars making these pyrotechnic explosions traversed the College View section causing explosions which sounded like the battle of the Rhone. One excited resident said the motorists throwing out the explosives were "advertising for some fireworks dealers outside the city limits."

Finally she built a beautiful plant in Kobe where she could care for a number of women and children. When Kobe was bombed in the spring of last year, Mrs. Jo's beautiful plant was completely destroyed. Most women of seventy-two would have felt that their work was ended, but Mrs. Jo carried on. Now she has been given some old army barracks near Sonoda. They are not much to look at, but they are larger than the plant she lost, and here this old lady, stone deaf and crippled, cares for 150 women and children!"

Davidson, the state's fifth and most unsuccessful member of the Southern Conference, will rest this weekend after losing to Richmond, 27 to 6.

For rivalry and competition one of the better games should come off when the Guilford Quakers go up against Catawba at Salisbury Saturday night. The Quakers, beaten once and scored on only twice this year, disposed of Lenoir-Rhyne, 34 to 7, while the Indians nosed out the Tribe from Newberry, 6 to 0, last week.

The contest will go a long way toward settling the North State Conference if Catawba wins. Should the Quakers come through, Catawba would be tied with Appalachian which plays at Milligan Saturday.

The Mountaineers smothered Western Carolina 42 to 6 Saturday in a game regarded as a toss-up. Western Carolina meets East Carolina in a Teachers' battle this week.

High Point, which defeated Elon, 31 to 6, entertains Wofford, a South Carolina visitor, Saturday night, while Elon plays host to Lenoir-Rhyne in another North State Conference encounter.

The stock of both UCLA and Georgia rose several points over the weekend as they protected their perfect unbeaten-untied records with respective decisions over Oregon and Florida. Neither, however, was in the nature of a romp.

Florida gave Georgia plenty of trouble, forcing the Bowl-minded Bulldogs to come from behind in the second half for a 33-14 verdict. Coach Wally Butts' Bulldogs next foe is a sub-par Auburn eleven which bowed to Mississippi State, 33-0.

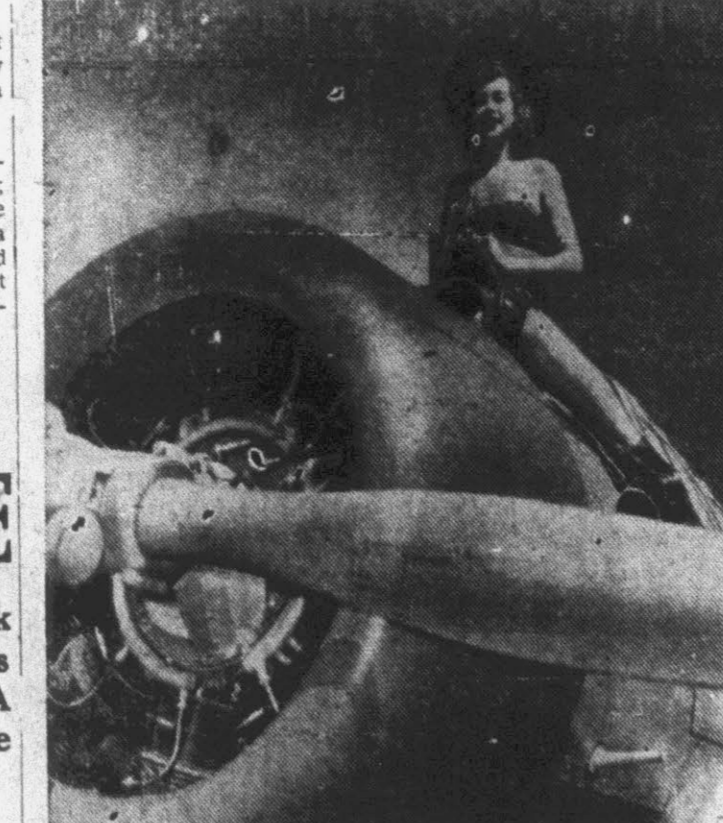
UCLA was hard pressed by Oregon, 14-0, a team that took a 43-0 pasting from Southern California a week ago. Arkansas scrambled the South-

ORDINANCE DESIGNATING EAST FIFTH STREET, EAST FOURTH STREET AND EAST THIRD STREET AND JOHNSTON STREET AS THROUGH STREETS AND REQUIRING ALL VEHICLES TO STOP BEFORE ENTERING SAID STREETS AT ALL INTERSECTING STREETS

The Board of Aldermen of the City of Greenville do ordain:

Section 1. Definitions. The term "through street" whenever used in this ordinance shall be construed to mean street or streets upon which vehicles shall not be required to stop at street intersections except for the protection of life, limb and property in the exercise of due diligence and care.

The term "stop light" whenever used in this ordinance shall mean any stop light or other signal device placed at any street intersection requiring vehicles to stop at such intersection or intersections.

Section 2. From and after the adoption of this ordinance, the sections of Third Street, Fourth Street and Fifth Street, between the East property line of Evans Street and the eastern boundary of the City of Greenville, and Johnston Street from Jarvis to Lewis Streets shall be, and they are hereby designated as through streets for all vehicles using said sections of streets. Provided, however, that this ordinance shall apply to street intersections where stop lights are maintained while said stop lights are actually in operation.

Section 3. From and after the adoption of this ordinance, it shall be unlawful for any person while operating any automobile, truck, bus, motorcycle, bicycle, or other vehicle of any kind to enter from any side and/or intersecting street either of said-through street or streets, without first bringing such vehicle or vehicles to a complete stop at such intersection or intersections and immediately before entering the same. Provided, however, that this ordinance shall not apply to street intersections where stop lights are maintained while said stop lights

FACE THE FUTURE HOPEFULLY

One full year of peace has passed since last Armistice Day. Or should we call it peace? Twelve months at least have passed, with humanity mulling about and trying to find normal life again. There are just as many displaced people in the United States as there are in Europe. They are not displaced in the same way, but they want to rent or build homes, to plant and harvest, to work without being called out every whistpost on a strike, to plan sales campaigns and increase production without being stymied by an inability to get materials.

Perhaps we should not be astounded by the present chaos. The war was much more of a disturbing experience than most of us realized when it was going on. We cannot take our industry off one basis and put it on another, lift millions of men out of civilian life and send them off to war, turn the thoughts of nations from life-saving to life-taking without disturbing our national life to its very foundations. Many people are saying today that these and other situations are making another war inevitable.

While war is always a possibility, even a superficial reading of history should lead us to see that international affairs are never composed without tremendous bickering and strife.

It took a number of years to win the war; it may take an equal number of years and perhaps more to win the peace. Let us not be discouraged.

WASHINGTON LETTER

LEGISLATORS CAN NEVER STAY AWAY FROM THEIR JOBS

By L. T. EASLEY
(For Jane Eads)

Washington—Congress is experiencing its longest recess since 1938, but that doesn't mean the city is without its lawmakers. Apparently five months is too long for most of them to stay away from Washington, so accustomed have they become to being here throughout most of the year. Dozens are here at any given time. They return for a week or two of conferences with federal agencies or at the White House.

A good number of the younger legislators have come back to enter their children in the local schools. Some in town now are old timers who won't be on the roll when the 80th Congress convenes Jan. 3. Rep. Hatton W. Summers (D-Tex.) is among the latter group. Retiring voluntarily after 34 years in the House, he figures it will take most of the rest of the year to sort through the tons of letters and documents he has accumulated over the decades. Some of the material he will keep for himself. Some will go to schools and other institutions. Much will be thrown away.

Most of the congressional offices remain open during the recess, with one secretary on hand to handle the mail and occasional home district visitors.

Correspondence these days includes numerous requests from all parts of the country for tickets to the Army-Navy football game at Philadelphia Nov. 30.

Each congressman gets two tickets free. (He must pay an 80-cent federal tax on each), and in addition may buy a limited number to satisfy the desires of his grid-enthusiast constituents.

While voters write in only once each year for football game tickets—and of course only relatively few have this on their mind—they do write throughout the year, and in large numbers for such things as farm bulletins and pamphlets on raising babies.

This prompts much swapping between congressional offices, for each is allowed a certain number of publications. Consequently a legislator from a busy seaport, for instance, will trade off most of his Agriculture Department literature on raising hogs or alfalfa to a mid-western congressman for the latter's share of navigation charts of coast-

al waterways. Federal agencies sell their old and damaged furniture and office equipment at auction. (Continued From Page One) averaged \$40.12; 1944—\$6,546,466 pounds, \$24,16,145.39 averaged \$42.75; 1945—\$6,454,820 pounds \$25,947,845.94 averaged \$42.92; 1946—\$5,846,592 pounds, \$35,331,636.03 averaged \$35.65 (to date). And the 1946 season is not yet over.

It is interesting to observe, said Whedbee, that in the boom year of 1919, which has always caused so much comment that the total amount of money that was paid out on the Greenville Tobacco Market was only \$15,867,518.33, not even half as much money as has already been paid out this year.

Whedbee stated that making this the banner year in Greenville, and that not the least of these was the wonderful cooperation that had existed this year between the tobacco industry in Greenville and the businessmen and merchants of this city. They have worked hand in hand this year, giving generously of their time and their money in the promotion of an advertising campaign which he, as supervisor, had attempted to put across for Greenville.

That this has born fruit, said Whedbee, is evidenced by the fact that this year, even though Greenville started with a tremendous acreage of drowned out tobacco in its normal drawing territory, yet by drawing tobacco from many sections of the state which have never before sold their tobacco in Greenville, we have already sold more tobacco here by over five million pounds, than has been sold in Greenville since crop control was voted back in in 1940.

Whedbee stated that he wished to congratulate the businessmen

and merchants on their cooperative effort with the tobacco industry. They can be justly proud of themselves for the part which they have played in this wonderful record. This year's results, he stated, marks clearly the path of cooperation that we should follow next year and in the years to come.

Whedbee stated that if it were his privilege to speak to every farmer and businessman personally who had sold his tobacco in Greenville this year, that he would urge each of them to do three things: First, to bank and save at least a part of this year's increased income as a bulwark against future years; second, to try by every means possible to produce the 1947 crop with much less expense; and third, to end this marketing season with an honest and sincere spirit of Thanksgiving for the wonderful prosperity that God has seen fit to bestow upon the people of this community this year, together with a clear realization that without His help our work would have been ineffectual, and without His approval all of our future plans are laid in vain.
