Russia May Compromise Stand On Atomic Bomb

Molotov Continues To Hammer Disarmament Theme; American And British Ministers Say They Will Consider Matter At Proper Time

By JOHN M. HIGHTOWER. New York, Nov. 12.—(AP)—Fresh evidence that Russia may eventually agree to some form of international inspection to enforce the disarmament, including elimination of atomic weapons, was seen today in an assertion by Soviet Minister Molotov that Russia had American arms reduction proposals can be harmonized.

At the same time he declared that an armaments race has already started, and he urged prompt action by the United Nations to stop it.

From Secretary of State Byrnes came a promise that the American government, which is insisting on an inspection system, would have more to say of disarmament at the proper time, and British Foreign Secretary Bevin declared that the effort to obtain worldwide arms reduction "my government will not fall behind."

The three foreign press associations after completing their first review have of five projected Axis "satellite" peace treaties. Reports on their work to date showed them to be still stalled on all major issues ranging from control of Trieste to free navigation on the Danube river.

One source of prolonged dispute between the U. S. and the Soviet states appeared to have been removed. Diplomats reported Byrnes had informed the foreign ministers council that the U. S. had ordered occupation authorities in Germany to release several hundred seized Danube river vessels of Hungary and other eastern European countries—something those countries, with Russian support, have been demanding for months.

Today the foreign ministers turned over to their deputies and technical experts some of the disputes which have knotted their own discussions and themselves prepared to return to an attack on major differences in the Italian treaty.

Inspection and the continued manufacture of atomic bombs in the U. S. has thus far been the chief points of dispute in atomic energy control talks under the U.

Altmeyer Believes Seven Billion Insurance Fund Will Stave Off Big Unemployment

By NORMAN WALKER. Washington, Nov. 12.—(AP)—Social Security Commissioner Arthur J. Altmeyer declared today this country's employment insurance fund of nearly \$7,000,000,000 will serve as an effective brake against any widespread depression.

With that amount of emergency purchasing power available to workers, Altmeyer told a reporter he doubts that any postwar economic shakedown could mushroom into the proportions of the 1929-33 break.

While emphasizing that he is siding neither with those economists who look for at least a temporary recession next year nor with those who say the country is in for a long period of prosperity, the social security chief said he believes "the healthy accumulation of reserves in the fund" will:

1. Tend to help prevent a depression from occurring because "people know the money is there waiting for workers who lose their jobs"; and

2. Prevent any "really serious depression," because payments from the fund will tend to bolster purchasing power just when it begins to decline dangerously.

The fund is based on payroll taxes ranging up to three percent on employers of eight or more persons. The money thus collected is held in trust for the states, which administer their own unemployment compensation systems.

These vary widely, but the present average for the nation is a \$19 weekly payment for a potential maximum of 20 weeks.

The Truman administration has been urging a uniform maximum up to \$25 a week for 26 weeks—the level a few states are paying now.

The Social Security administration estimates that the various state funds have enough money to pay 63.5 per cent of the 28 million workers insured under the system the full amount of benefits their state laws allow. But no one expects that number of workers, two out of three, ever to become jobless at the same time.

"We have a system ready and functioning to meet any situation which might arise," Altmeyer said. He helped plan the system and has stayed with it since its inauguration in 1936.

TRUMAN MUST HUE THE LINE

Republicans Say He Must Follow Middle Of The Road If They Are To Cooperate

By JACK BELL. Washington, Nov. 12.—(AP)—Republicans stipulated today that President Truman will have to go down the middle of the road in his legislative proposals if he wants their cooperation in the new GOP-controlled Congress.

From senators William F. Knowland (Calif.) and C. Wayland Brooks (Ill.) came assertions that their fellow-Republicans will not accept what Knowland called a "completely socialist proposal."

"We need some of the same unity of purpose that has marked the development of our non-partisan foreign policy in solving the nation's grave, domestic problems," Knowland told a reporter.

"We don't want the nation to swing either too far to the left or to the right. We want to keep it on an even keel. And we don't want any Pac-drafted legislative program shoved at us as it has been in the past.

Brooks said he wondered whether the president's conciliatory bid yesterday for a political truce on pressing national problems would be any more lasting and effective than Mr. Truman's appeal for the same sort of cooperation when he took office 19 months ago.

"When Mr. Truman first became president," the Illinois senator said, "he asked for cooperation from the Congress. Then he proceeded to present and tried to force through completely socialist proposals. The people have spoken and they have said they don't want that kind (Continued on Page Six)

Prices Of Soap Take Big Jump

New York, Nov. 12.—(AP)—A sharp rise in the prices of many soaps, one of the major scarcity items, began to appear today in the wake of the abolition of OPA price ceilings.

In Boston, Walter McKee, vice president of Lever Brothers, one of the major soap manufacturers, reported his company's products were being increased immediately by "approximately 50 per cent."

He said raw materials—fats and oils—had increased from nine cents a pound under OPA to 21 or 22 cents a pound.

Other trade sources said price increases were inevitable.

"There has to be a sharp increase in the cost of finished product," one industry spokesman said. "Prices of fats have more than doubled since their decontrol recently and the industry has no inventory of low-priced materials.

Skating that tallow prices have risen from a ceiling of 8 5/8 cents to as high as 22 cents, he said fats and oils account for at least 50 per cent of the total cost of soap.

Besides that soap makers are faced with higher prices for containers and wrappers, transportation, equipment and labor, he added.

Grave Problems Ahead Present Critical Hour In International Affairs Awaiting That Cooperation Promised Between President Truman And Republican Leaders

This is the most critical hour in international affairs since war's end. It is with good reason that the chief executive characterizes the foreign policy as a national and not a party program, for peace is in the balance.

General Motors Boosts Prices

Detroit, Nov. 12.—(AP)—The price tag on General Motors passenger cars and trucks was higher by \$100 today while Ford and Chrysler other members of the automotive industry's "Big Three," marked time on possible action following the removal of OPA controls.

C. E. Wilson, GM president, announced the increases yesterday and said they would be effective immediately. He said the corporation had an application for such an increase on file with the OPA "for several months" and pointed out that the boost placed GM prices "in reasonable relationship" to costs of production.

Wilson also announced: Adjustments in the prices of certain household appliances will be announced later by the Frigidaire and Delco appliance divisions; no general increases on automotive parts will be made at this time (OPA recently authorized increases up to 15 per cent on automotive parts); no general increase is contemplated on diesel-electric locomotives or other diesel engines.

Earlier, the Ford Motor Co. said no immediate price increase was contemplated.

New Violence Reported In Hollywood Strikes

Explosion Does Property Damage; Negotiations In Coal Dispute Delayed Until Tomorrow; Other Strikes Continue

By ASSOCIATED PRESS. New Violence broke out in the draw-out AFL jurisdictional dispute in the Hollywood movie studio today, following the first production shutdown in nearly 100 months and resumption of mass picketing and wholesale arrests.

In other labor disputes across the country, government mediators made efforts to settle two major strikes while in Washington Secretary of Interior Krug and John L. Lewis were to resume negotiations tomorrow to avert a walkout next week by 400,000 soft coal miners.

In the movie strike, an explosion which police said apparently was caused by a hand grenade shattered a window and severely damaged the home of Norman Potte, a non-striking film technician in Van Nuys, Hollywood suburb. He told police no one was hurt in today's blast. The missile apparently was thrown from the street against the front of his house.

Yesterday 36 pickets were arrested and charged with parading without a permit when mass picketing was resumed at Metro-Goldwyn-Mayer studios. There was no violence.

There was no hint as to what progress, if any, was made at yesterday's first meeting between Mr. Krug and Mr. Lewis since the president of the AFL United Mine Workers demanded wage-hour negotiations. Lewis has contended that the present contract with the government will end on Nov. 20 and in keeping with the union's "no contract, no work" policy, a work stoppage could become effective at any time.

Meanwhile, government mediators sought to bring peace to the 196-day strike at the Allis-Chalmers manufacturing plant at West

Alton, Wis., and in the 23-day-old strike of 1,400 AFL Trans World Airline pilots.

In San Francisco, efforts to end the 42-day-old maritime strike in all Pacific coast ports, were resumed at a conference of labor department, union and employer representatives.

After a strike of more than two months, the 525 members of the Los Angeles Herald-Express unit of the CIO Newspaper Guild accepted management's offer of a 14 per cent wage increase upon return to work. However, final settlement hinged on the outcome of disputes between management and two other groups the CIO News Vendors and the AFL-Allied Printing Trades.

The guild accepted the 14 per cent pay hike upon return to work, with the stipulation that negotiations start on its revised demand of \$80 weekly on minimum for experienced reporters, photographers and district circulation managers. The original demand was \$100 weekly. Top newsmen would go back, pending negotiations and arbitration at \$80 weekly.

King Opens Parliament With Policy Statement

London, Nov. 12.—(AP)—King George VI, in a Parliament opening speech presenting the views of his labor government, called today for legislation continuing conscription for the British armed forces and for nationalization of inland transport and electric utilities.

The monarch presented his message to Parliament after a traditional ride through London's streets during which he was guarded against any possible attack by Jewish extremists by every policeman Scotland Yard could spare—more than 5,000, all told.

The king's brief message was simply a matter of fact presentation of the labor government's legislative intentions for the second parliament since it climbed to power 15 months ago.

In one short paragraph, the king indicated that the government had plan to set up tighter controls for the London stock exchange and not to permit return of the free cotton market closed during the war.

"A measure dealing with exchange control," he said, "will be placed before you and you will be asked to approve legislation to provide for an amendment of the companies act and for establishment of a commission to purchase, import and distribute raw cotton." (Continued on Page Eight)

Republicans Facing Leadership Worries

Two Candidates Already Out For Floor Leadership And Another In The Offing

By WILLIAM F. ARBOGAST. Washington, Nov. 12.—(AP)—Leadership worries beset House Republicans and Democrats alike today.

With two candidates already in the field and a third in the offing, GOP leaders arriving early for a steering committee meeting Thursday began scouting around for compromise possibilities in the fight for the coveted post of Republican floor leader.

Reps. Charles A. Halleck of Indiana and Thomas Jenkins of Ohio formally tossed their hats into the ring for the assignment yesterday. Friends of Rep. Clarence Brown of Ohio said they expect his formal announcement momentarily.

Halleck's announcement followed a meeting of party heads, including Rep. Joseph W. Martin, Jr., of Massachusetts. Martin is unopposed in his party for election as speaker of the House, and the elevation will leave vacant his present position as Republican floor leader.

While there was no sign of an imminent compromise in the three-way contest, party chiefs said they are hopeful it can be settled without a serious rift that might divide GOP ranks when they organize the House next January 3.

Unless all candidates except one withdraw, a party caucus will make the selection, probably late next month. Its choice will be submitted to the House proper for formal ratification by the Republican majority.

The possibility of a fight over the Democratic leadership leadership developed when it was learned that a group of Southerners are seeking to persuade Rep. Eugene E. Cox of Georgia to seek the post.

Normally, Sam Rayburn, of Texas, now speaker in the Democratic-controlled House, would step down into the minority leadership. But Rayburn has announced a desire to be freed of the chore and let the toga fall upon the shoulder of Rep. John W. McCormack of Massachusetts now Democratic floor leader.

Should P. McCormack-Cox fight result, Democratic chiefs said they will ask Rayburn to reconsider his decision and to accept the leadership in the interest of harmony.

Cox has seniority over McCormack, while Rayburn outranks them both.

In addition to discussing the leadership fight, Republican chiefs at their meetings starting Thursday will attempt to formulate a policy program for the new Congress. Among other things they may decide to take a stand on price and rent controls, Army-Navy merger, universal military training, taxes, budget balancing and labor legislation.

Thirty Five Die In Train Wreck

Mets, France, Nov. 12.—(AP)—At least 35 persons were killed and 80 injured today when an east-bound local train on the Paris-Strasbourg line smashed into the rear of another east-bound local standing in the station of Revin-sur-Ornain, 138 miles east of Paris.

Fog blanketing most of northern France was blamed by rail officials for the accident.

The second train drove into the Revin station with such force news agency reports said, that all six passenger coaches of the waiting passenger train were smashed and persons standing on the station platform were killed, along with those in the cars.

PRIZE CATCH. Tokyo, Nov. 12.—(AP)—The newspaper Yomiuri reported today that Japanese sideshow operators, flourishing fat bankrolls, were shoudering each other aside in Golembia to buy the latest rat even captured in Japan—three feet long.

It displayed characteristics of a Chinese gutter rat, the paper said, without elaboration—and was engaged in a textile plant where it "wreaked havoc."

THREE GIRLS KILLED. Greensburg, La., Nov. 12.—(AP)—Three teen age girls were killed and six others injured last night when a truck in which they were riding to a high school basketball game collided with another truck near here.

All were residents of Greensburg. O. C. Anderson of the state police said the impact of the two trucks left dying and injured girls scattered for about 75 yards along the highway.

NEW HOPE FOR BLUE BABIES

Three Northwestern Physicians Today Announced Success Of New Operation

Chicago, Nov. 12.—(AP)—A new way of performing the operation to save the lives of "blue babies"—introducing a surgical feat previously considered impossible—was announced today by three northwestern University physicians.

Instead of connecting with a less important artery, the surgeons for the first time tapped the body's main artery, the great abdominal aorta, which springs from the heart's left chamber and gives rise to all the arteries of the circulatory system.

Physicians said the operation would not benefit all "blue children" who are born with crippled hearts. It would help the majority to overcome otherwise hopeless invalidism and in some cases prevent death.

LaGuardia Hints Nation Wants To Use Food As Political Weapon; Russia Charged With Continually Blocking Trusteeship Council

By MAX HARELSON. Lake Success, N. Y., Nov. 12.—(AP)—Reported U. S. opposition today virtually ruled out any likelihood that the United Nations would approve a proposed \$400,000,000-emergency food fund to help meet Europe's food deficits after the expiration of UNRRA.

Shortly after acting Secretary of State Acheson indicated in Washington that the U. S. would oppose the proposal put before the United Nations yesterday by F. J. LaGuardia, director general of the UNRRA, informed quarters said members of the U. S. delegation to the general assembly also were opposed to the plan.

Although the delegation took no formal decision as to how it would vote on the issue, the members were understood to have taken the position that any further aid to Europe after the expiration of the UNRRA should be handled on an annual rather than an international basis.

Under LaGuardia's proposal the U. S. would be expected to contribute 49 per cent of the total \$400,000,000 or approximately \$200,000,000. It was generally agreed that the plan would not be put into effect if the U. S. refused to take part.

LaGuardia said this appeared to be a weapon to use food as a political weapon against countries whose actions were not approved by the United States. LaGuardia said such an attitude would jeopardize the whole structure of the United Nations.

Closed Shop Showdown Republican Senator Says He Will Try To Get Congress To Pass Law Outlawing Closed Shop; Five States Have Already Amended Constitution

Washington, Nov. 12.—(AP)—A closed shop is one in which every employee must be a member of the union which has a contract with the employer there. If he isn't, he can't work there.

Closed shops are not new in this country. They date back as late as 1790 when unions of carpenters and tailors bargained with their employers not only for higher wages but for closed shops, too.

Congress itself—in the National Labor Relations Act (the Wagner Act) which it passed in 1935—said an employer could make a closed shop agreement with a union.

A closed shop contract, of course, is not the only kind which unions make with employers. But they argue for it on these grounds, among others: It prevents "free riders." That is, it prevents people who work in a (Continued on Page Four)

Dr. Cooke Speaks Albemarle Club

"An effective school executive must be more than a man; he must be a man plus a cause," said Dr. Dennis H. Cooke, president of East Carolina Teachers College, in an address before the Albemarle Schoolmasters' Club in Hertford on Monday evening, November 11.
Dr. Cooke pointed out to his audience that the successful executive must be "more than a driver of teachers, a worker of men." The administrator, he said, must support his profession in conflict and debate and live by his cause, the art of teaching.

Classifying school administrators into various groups and describing their characteristics, Dr. Cooke said that the autocrat, the stand-patter, the courageous though sometimes unwise and domineering administrator, the abdicator, are easily recognized types of undesirable executives. The true leader he described as one who places human values above the minutiae of plans and policies; who gains the respect and cooperation of students, teaching staff, and professional associates; and who has definite, well-organized plans and the courage to put them into action.

Pay Amendment Still In Doubt

Raleigh, Nov. 12—(AP)—The deciding votes on a proposed constitutional amendment to authorize expense money for state legislators, cast a week ago, were still outstanding today.

With 1850 of the State's 1929 precincts reported, the proposal was trailing 137,357 to 137,436.

Still to be tabulated were the returns from Watauga, Graham, Jackson, Polk, Northampton and Hyde counties. There was no indication when these would be made available.

A second amendment to permit women to serve on juries was approved. Latest returns from 1350 precincts showed 178,351 in favor and 123,713 opposed.

ARMY IS STILL OUT IN FRONT

New York, Nov. 12—(AP)—Army and Notre Dame fought to a scoreless tie in their historic grid battle here last Saturday but when the votes were counted today in the weekly poll of the Associated Press to pick the nation's ten top teams the Cadets wound up in first place by a very narrow margin.

Among the 144 writers who participated in the poll, including the sports editor of the Stars and Stripes in Germany, 57 of them cast first-place ballots for Army and 31 decided that Notre Dame should be on top.

Thirty-six of them had as much trouble reaching a decision as the teams themselves had on the field. These 36 voted for a first-place tie between the two.

On the basis of 10 points for a first-place vote, 9 for second, and so on, the Cadets came up with a total of 1,300 1-2 points against 1,266 1-2 for Notre Dame.

Georgia's all-victorious Bulldogs who downed Florida, 33-14, for their seventh triumph of the season, retained the third position in the standings with 12 first-place votes and a total of 1,061 1-2 points.

The seven remaining first-place votes went to the University of California at Los Angeles, which kept its record clean with a 14-0 victory over Oregon and held on to fourth place with 961 1-2 points.

Pennsylvania, which bounced back from its upset by Princeton to humble Columbia, 41-6, jumped from ninth to fifth place, succeeding Rice, a team that was tumbled completely out of the first ten on a 7-0 upset by Arkansas.

Texas clung to its sixth-place berth, whipping Baylor, 22-7, while Georgia Tech moved into seventh place after its 28-20 conquest of Navy.

Tennessee dropped from seventh to eighth, although the Vols got

two months ago, were announced in the journal of the American Medical Association by Drs. Willis J. Potts, Sidney Smith and Stanley Gibson of Children's Memorial Hospital at the university's medical school. They said the operation achieves the same result as one originated by Dr. Alfred Blalock and Dr. Helen B. Taussig, who in 1944 performed the first successful operation on a "blue baby" at Johns Hopkins Hospital in Baltimore.
The malformed hearts of "blue

babies" cannot pump enough blood to the lungs to pick up the vital oxygen needed by the body. This deficiency results in blue fingernails, purple lips, bluish complexion and, sometimes, death.
In the Blalock-Taussig operation, the physicians said, a lung artery is joined to either of two big arteries near the heart, the subclavian or the innominate. This rerouting of the blood stream forces blood into the lung artery and on through the lung.
However, physicians said, using the subclavian artery sometimes results in a little danger to arm circulation and using the innominate artery entails the hazard of an inadequate supply of blood to the brain.
In connecting directly to the Aorta, surgeons had to devise a special lamp which permits most of the blood to flow through the artery while the vessel is being sewed to the pulmonary artery.
The physicians said that only because of the surgical work pioneered by Drs. Blalock and Taussig "did we have the courage to attempt this new operation."

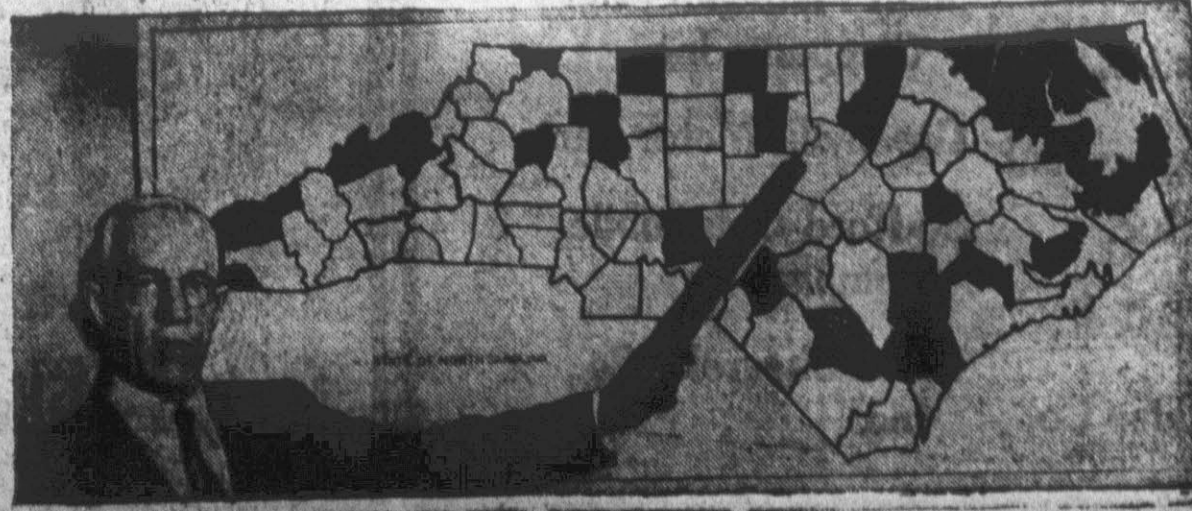

Social Security

"What do recent amendments to the Old-Age and Survivors Insurance provisions of the Social Security mean to Veterans or their families?"

Amendments to Old-Age and Survivors Insurance provisions of the Social Security Act, which were enacted by Congress in August 1946, mean that thousands of veterans who otherwise had no protection under the Old-Age and Survivors Insurance law are now insured for

at least 3 years, so that in case of their death their survivors may receive benefit. These new amendments extend insurance protection to those whose jobs (before entering military service) were covered by the law; and now they are assured of financial protection for their dependents until they can re-establish insured status. The amendment also provides social insurance protection for the survivors of some veterans who have never been employed by a business or industrial concern. Under the terms of these new amendments, hundreds of survivors of deceased veterans already

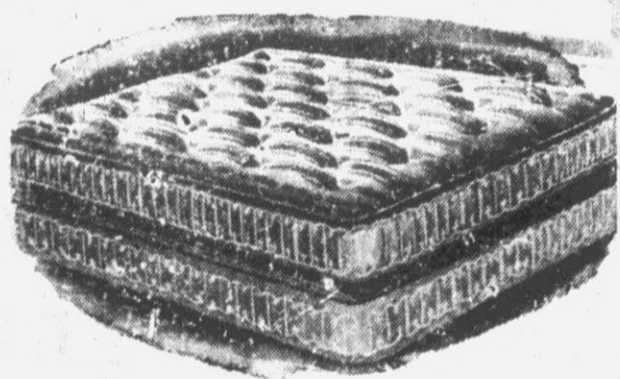

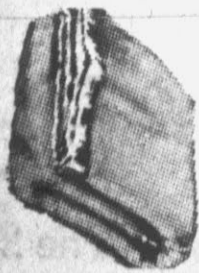

DR. ELMER R. BROWNING

Approximately forty members of the Faculty Lecture Club at East Carolina Teachers College at a meeting on Monday evening in the Classroom Building heard Dr. Elmer R. Browning, chairman of the business education department, describe American GI universities in England and France and discuss his impressions of English schools and universities as compared with those in this country.

Dr. Browning, who was instructor in accounting in army universities abroad during and just after World War II, visited such schools as Oxford, Cambridge and Eton and had an opportunity of observing British students at work. He was impressed he said, not always favorably, by such differences as the smallness of English universities and public schools, the tutorial method of instruction, the emphasis upon classical learning, the exclusiveness of the student bodies, the thoroughness and efficiency of instruction.

At Surinham University in England, Dr. Browning said, he saw the excellent work of a fellow citizen of Greenville, Colonel Thomas M. Metz, who as head of the special service division, arranged trips for the GI students and made their stay at the university pleasant and valuable culturally.

Dr. Walter Browne, president of the club, welcomed a number of new members. Dr. Lucile Turner of the English department, introduced Dr. Browning. The next meeting of the club is scheduled for December 9, when Dr. Browne will talk on Geography and the Geographer's Sphere.

(Continued from Page One) disarmament theme and Byrnes devoted the bulk of his dinner speech to expressing Britain's support for universal arms control. Secretary Byrnes referred to it but briefly.

Instead, he sought to drive home to his audience of newsmen and diplomats that the Republican victory in last week's congressional elections does not mean any change in U. S. foreign policy.

"The American people voted for a change in control of the Congress," he said. "They did not vote for a change in foreign policy. Our policy is not a democratic or republican policy. It is an American policy," Byrnes said.

(Continued from Page One) 85,000 square miles—a little more than a third bigger than New England—is small on size but mighty in strategic value—so much so that it long has been a pawn in the Asiatic game of power politics.

Control of Korea was one of the chief causes of the Russo-Japanese war of 1904-5, as it had been of the Chinese-Russian conflict a decade earlier.

Now we find Korea divided in two at the 38th parallel, with Russia in control of the northern portion, and the United States of the south. The 38th parallel is like a Chinese wall to the unhappy country. The north is the industrial part of the state, and the south the agricultural.

The Russian permit no traffic between the two, and Korea thus is in a bad way. President Roosevelt, British prime minister Winston Churchill and Generalissimo Chiang Kai-Shek at a secret meeting in Cairo in November of 1943 agreed that Korea should be made free and independent "in due course." But the way things now stand she is looking at independence through the big end of the telescope.

All the signs are that the Soviet intends to stay right where she is in Korea, which is a mighty buttress to her great Siberian port of Vladivostok and to the Manchurian ports of Dairen and Port Arthur in which Moscow is vitally interested. Under the 30-year treaty of friendship signed by China and Russia in August, 1945, Dairen was to be a free port, open to all nations, but administered by China. The great naval base of Port Ar-

thur was to be used jointly by Russia and China.

Just as Russia intends to stay where she is, so there are no indications that Uncle Sam intends to decamp. Thus the only ease of this impossible and highly dangerous position can come on through simultaneous withdrawal of both countries after a cut and dried agreement that assures Korea independence. That's a tough situation even than the Japanese situation.

"In the territories for which my government are responsible they will seek actively to promote the welfare of my peoples, to develop the economic life of the territories and to give my peoples all practical guidance in their march to self-government."

"Britain," by its example, and leadership, will work for the promotion of all nations toward greater freedom and prosperity," the king said.

Winston Churchill, the wartime minister, and now the leader of the opposition, was scheduled to open debate when the House of Commons gets down to work.

(Continued from Page One) place where there's a union contract—from enjoying all the benefits a union wins without paying dues or sharing other union obligations.

But the closed shop has been a battle-ground for years, with the unions on one side and on the other not only labor-baiters and labor-haters, but a great many sincere people who oppose it because they think it violates an individual's freedom.

The voters of Florida and Arkansas—on Nov. 7, 1944—and the voters of Nebraska, South Dakota and Arizona—on Nov. 5, 1946—approved the amendments to their state constitutions forbidding closed shops.

Soon after the Florida amendment was approved, the AFL and CIO went to bat against it. They took it to the federal district court in Florida. That court upheld it. Then they appealed to the U. S. Supreme Court.

The Supreme Court—in its opinion of March 25, 1946—declined to give a decision. It said the test should have been made in the first place in a state court, not in a federal court.

So now the AFL is carrying its fight through the Florida state courts. The case undoubtedly will land back eventually in the U. S. Supreme Court for a final decision.

Whatever that high court verdict is in the Florida case, it almost surely will apply to the constitutional amendments approved by the other four states.

When the AFL and CIO appealed to the Supreme Court—in the first round of the Florida case—they did so on these grounds:

1. That Florida law outlawing the closed shop was in conflict with the National Labor Relations Act which they claimed permitted a closed shop.

(The theory here was that when a state law conflicts with a federal law, the federal law is supreme.)

2. That the Florida law violated the U. S. constitution, because, they said, it interferes with freedom of contract (Article 1); it interferes with freedom of speech (first amendment); and it interferes with citizens' privileges and property rights (fourteenth amendment).

But the Supreme Court may have to decide more than whether the state amendments forbid a closed shop. Those amendments are so worded that they may, at some time, be interpreted as meaning they forbid a union shop or maintenance of membership.

Unlike a closed shop where an employer must be a member to have a job, a union shop is one where a worker does not have to be a union member to get a job but must, within a stated time, join the union after going to work.

This is what maintenance of membership means: an employee can join the union which has a contract with the employer, or he can refuse to join. But if he is a

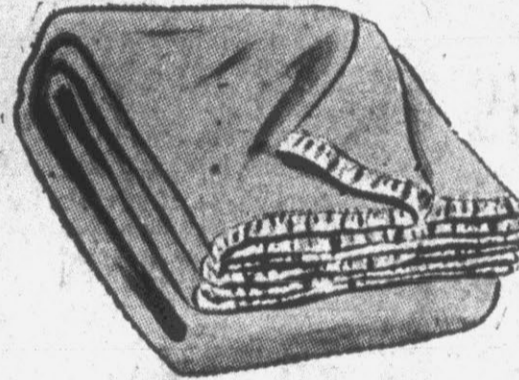

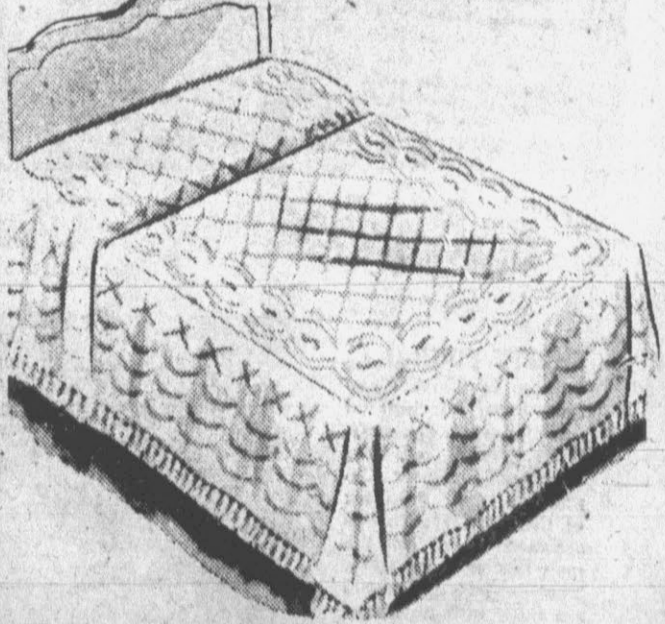
