

Admit Three Nations Into United Nations Assembly

Afghanistan, Iceland And Sweden Sign Articles Of UN Charter; Ceremony Marks First New Membership Since Origination; Assembly To Vote On Council Members

New York, Nov. 19.—(AP)—Afghanistan, Iceland and Sweden signed articles of adherence to the United Nations charter today to increase the membership in the work peace agency to 54 countries.

The simple ceremony admitting the three newcomers was held in a small, ornate conference room of the massive assembly chamber where the three delegates took seats for the first time.

Abdul Hosayn Aziz, Afghan minister to the United States; Thor Thors, Iceland's minister to Washington, and Oesten Unden, Swedish foreign minister, signed the pact in alphabetical order.

All three used personal pens and pocketed them for presentation to the home governments.

The three were the first countries taken into the world circle of nations since the signing of the charter by 51 nations.

For the formal signing the representatives stepped up singly to a circular table where Paul Henri Spaak of Belgium, president of the assembly, was flanked by Secretary-General Trygve Lie and his assistants.

After the ceremony the three returned to Spaak's office for private greetings before entering the chamber to take their seats in the assembly.

Outside the assembly building three special flagpoles were erected in the center of the circle where the flags of the original 51 members fly.

Election of three new members of the security council and six of the economic and social councils is the first principal business before the assembly.

Colombia appeared almost certain to win one of the security council seats, while main contenders for the remaining two were Belgium, India and Syria.

The seats will go to the three nations who receive the greatest number of votes in secret ballot.

Asheville Scene Of Baptist Meet

Asheville, N. C., Nov. 19.—(AP)—The 118th annual session of the North Carolina Baptist State Convention got under way at the First Baptist Church today with 1,500 messengers in attendance.

Contract Signed By Wake Forest

Fayetteville, N. C., Nov. 19.—(AP)—The board of trustees of Wake Forest College signed a contract with the Z. Smith Reynolds Foundation here yesterday whereby the college will receive the annual income from the \$10,500,000 Reynolds Foundation of Winston-Salem.

By its terms the college will receive up to \$350,000 a year, all interest over that amount reverting to the foundation.

The trustees have pointed out that it will take about five years to transfer the college to Winston-Salem. They said the new buildings which will have to be provided for will cost approximately \$5,000,000.

Debate In Commons

Dangerous Conclusions In Britain's Foreign Policy Debate; Attlee's Response; No Exclusive Anglo-American Alliance Sought; Blocs And World Unity

The battle in the British House of Commons between left-wing Socialists and the Labor (Socialist) Government over foreign policy developed highly interesting though in some respects, dangerous conclusions.

The debate revolved about the rebel motion that the government's foreign policy steer a middle course between the United States and Russia. This was based on the premise that the Soviet Union and the United States were headed for war, and that Britain was bound to become involved in it by being in the American line.

R. H. S. Crossman, leader of the revolt, charged that the formation of "a complete and exclusive Anglo-American tie-up" as urged by Winston Churchill in his Fulton, Missouri, speech early this year—

had been followed up by a steady split of the world into American and Russian blocs.

Well, now, the "complete" (though not exclusive) "Anglo-American tie-up" was made in the first world conflict, and it has continued ever since. Also we must remember that the end of the recent war found the Russian bloc already "firmly established. It was not a post-war development and it's safe to say it would have materialized irrespective of Anglo-American relations. It is true that the wholly different ideological viewpoints between the East and the West have resulted in a widening of the division. By the same token it is equally true that Britain couldn't lessen the danger of difficulties with Russia merely by steering clear of American policy.

Health Officer Warns Of Influenza Epidemic

Urges All North Carolinians To Take Influenza Vaccination; Epidemic Year Overdue; Expect Outbreak This Winter

Raleigh, N. C., Nov. 19.—(AP)—Dr. Carl V. Reynolds, state health officer, in anticipation of a possible influenza epidemic, is urging all North Carolinians to take the influenza vaccination.

Dr. Reynolds said the commission on acute respiratory diseases had reported that an influenza epidemic is overdue. "Since this epidemic did not occur in 1945-46, as was expected, the probability is now much greater that it will occur during the coming winter of 1946-47."

The State Laboratory of Hygiene has advised all North Carolina institutions that it will secure the vaccine serum for them at cost. Dr. Reynolds said that "with the unusually heavy enrollment of students at our institutions of higher learning this year, living quarters and classroom facilities are necessarily going to be overcrowded. This in turn, creates a situation that is extremely favorable to an outbreak of acute respiratory disease."

He added that there would be a natural tendency for any outbreak developing in these institutions to spread rapidly throughout the state.

Seeking to forestall such a possible epidemic, several colleges have already begun vaccinating their students. The University of North Carolina at Chapel Hill has virtually completed its program, while N. C. State College here is now in the midst of vaccinating more than 5,300 students and faculty members according to Dr. A. C. Campbell college physician.

Dr. Reynolds said this year was the first time the influenza virus vaccine was being made available.

Livestock Price Level Holding

Chicago, Nov. 19.—(AP)—Prices which farmers received for livestock today, at the start of the sixth week of decontrolled markets, were only slightly under peaks established immediately after ceilings were removed.

Other result: free trading include more meat, a corn-hog price relationship favorable for expanding the hog population, record number of cattle moving into midwestern feed lots and increased cold storage meat holdings.

The Executive Committee of the Greenville Tobacco Board of Trade at a meeting this morning decided that the Greenville Tobacco Market would hold its final sale on Tuesday, November 26.

The local tobacco market to date, has enjoyed the most prosperous season in its history, having already paid out \$36,929,983.26, over 10 million dollars more than was ever paid out in a single season.

Nearest approach to this record was during the 1945 season when 23 million dollars was paid out for leaf tobacco.

Official average for this season is \$53.32, as compared with an average last season of \$42.92.

The Directors of the Greenville Merchants Association, in their regular monthly meeting held last night, announced a two-day holiday at Christmas. Leard S. P. Martin, Swartz, of the Greenville Utilities Commission explain the issues of the coming Bond Election and were given a report of the State Association's meeting yesterday by J. H. Blount.

C. E. Blair presided over the well-attended meeting.

The Association had made a point on closing for the approaching Christmas season and from the replies received, twenty-two N. C. towns plan to observe two days at Christmas—Wednesday and Thursday.

At a general meeting of the membership of the Association last February it was voted that Greenville would again observe two days holiday for Christmas.

Chairman Glover of the Christmas Committee reported that plans for the street decorations were going forward, as well as the Santa Claus Parade, which will be held Friday, December 6, 3:30 p. m.

Martin Swartz, Supt. of the Greenville Utilities Commission, was special guest of the Directors and spoke on the coming Bond Election (December 16).

He outlined and explained the planned program for improvements in the electric and water plants in order to serve the homes and business firms.

In answer to questions, Mr. Swartz emphasized that the proposed bond issue would be paid for out of increased earnings of the utilities and would not increase the tax rates.

The State Director of the N. C. Merchants Association, J. H. Blount reported on actions taken by the State Association at Monday's meeting. It had been called primarily to formulate a Legislative program, he said, and they endorsed a resolution to ask the General Assembly for a 20 percent pay boost for teachers; endorsed in principle the Good Health Program.

Landlords Will Vote On "Strike"

Oklahoma City, Nov. 19.—(AP)—The National Apartment Owners Association prepared to vote at its annual convention today on the question of a landlords' "strike" against OPA controls as a Texas delegation led a vigorous campaign for the move.

"We will not give one inch in our fight against the OPA," L. A. Weiser of Houston, executive secretary of the Texas Landlords, Inc., said. "There is only one time to end controls and that is now."

"We have been confiscated by the OPA and we refuse to longer submit to arbitrary controls."

Leaders of groups urging the move said if their plan is adopted landlords will withhold units from renters as they become vacant but will not evict tenants.

Bowden, who was sentenced to 30 years for the slaying of a Burgaw policeman, had been the object of an intensive manhunt ever since he escaped from the Caledonia prison camp on November 28, 1942.

Chou En-Lai Departing Nanking Peace Parley

Nanking, Nov. 19.—(AP)—Gen. Chou En-lai, the Chinese Communist No. 1 negotiator, left for Yenan today but the U. S. peace envoy, General Marshall, stayed on, giving rise to slender hopes that talks yet may be resumed.

The Chinese never completely close a door to negotiations. Discussions "definitely ended" one day may be resumed the next without explanation.

A spokesman at Marshall's headquarters denied Shanghai newspaper reports that Marshall would leave for home before Nov. 30. "That is not true. General Marshall has not made any plans."

He also said reports that U. S. Ambassador Stuart would resign because peace negotiations failed "are equally incorrect."

Yenan, Nov. 19.—(AP)—This incredible Communist capital of China is being stripped for action in the expectation of assault by Central Government forces. The decision of Gen. Chou En-lai, the chief Communist negotiator, to return from Nanking means virtually a clean

break with Generalissimo Chiang Kai-shek.

The gravity of the situation cannot be overemphasized.

Yenan is becoming hourly more like a ghost city—stripped of its hospitals, educational institutions, factories and anything that could hamper its defense or be of use to an invader.

The Communists are convinced that Chiang's troops will strike anew at Yenan with the hope that once it came into his hands he could proclaim to the world that the Communists have been reduced to impotency.

Policy Vote Is Upsetting

British Non-Voters In Parliament Point Up Party Rift

London, Nov. 19.—(AP)—Official lists disclosed today that 163 Labor members of Parliament failed to take part in last night's 353-to-170 vote of confidence in their government's foreign policy.

Allowing for those who were ill or otherwise unable to be in the House of Commons—despite the urgent summons from the government to all its supporters—well over 100 Laborites must have abstained when Foreign Secretary Ernest Bevin's policies were put to a vote.

"This is a disturbingly high proportion for the government," said the British Press Association, noting that 250 Laborites voted for the government along with 104 Conservatives, seven Liberals and twelve members of minor parties.

The 353-to-170 vote was a striking demonstration to the world that Britain backs her foreign secretary's policies. It was the substitute as evidence that the Labor party policy split is far from healed.

Expect Tighter Cotton Trading

New York, Nov. 19.—(AP)—Tightened margin requirements for cotton trading and a new national independent supervisory agency are expected to result from a committee report adopted yesterday by managers of the New York Cotton Exchange.

The margin proposals will be submitted to the membership for incorporation into rules of the exchange. An exchange spokesman said similar action was expected to be taken by the New Orleans and Chicago exchanges.

Proposed margin requirements for the three exchanges are: Cotton—prices up to 9.99 cents a pound, \$5 a bale; from 10 to 19.99 cents a pound, \$10 a bale; from 20 to 24.99 cents a pound, \$15 a bale; 25 cents a pound and over, 20 per cent of the contract value. These margins would be doubled on total positions of more than 30,000 bales long or short interest in all three markets and positions.

The new margin required would be 250 to 300 at yesterday's prices, compared with \$33 under previous requirements.

Shaggy UMW Chieftain Maintains Stony Silence On Federal Court Order; Mines Shutting Down; "We'll See You In Five Weeks" Is Ominous Word Of Men At Pits; Time Running Out

Washington, Nov. 19.—(AP)—Thousands more soft coal miners walked out today while their chief, John L. Lewis, maintained a stony silence on a federal court order aimed at averting an industry-wide shutdown Wednesday midnight.

At that time, Lewis had less than 36 hours to comply with the court's order calling for continued coal production. Any alternative might be contempt of court, which carries with it the risk of landing in jail.

Approximately 70,000 men were reported out today in contrast with 25,000 yesterday.

The stoppages spread despite a federal court order issued in Washington against a strike.

The score of idle miners in the large producing states stood: Alabama 16,000; Illinois 17,000; Pennsylvania 16,000; West Virginia 14,200; Virginia, 1,600; Kentucky 13,000; Indiana 4,700 and Ohio 2,500. Most of those who left their jobs

this morning were in Alabama where 16,000 of the state's 20,000 miners were idle, suspending 60 out of 84 Alabama mines. Yesterday only 3,000 stopped work in that state.

John L. Lewis, president of the AFL-United Mine Workers, has notified the government that the union's contract with the government expires Wednesday midnight.

Among the mines closed today were two captive pits of the U. S. Steel Corporation. A company spokesman reported these were the Bridgeport mine, near Brownsville, Pa., with more than 800 workers and the Hazel Mine at Canonsburg, Pa., with 111 workers.

Some unionists predicted a complete shutdown would occur Thursday if the miners follow their traditional "no contract, no work" contention.

Even as the shaggy mine chieftain faced a possible jail sentence if he disobeyed a court order designed to prevent a walkout, it appeared the miners would follow their time-honored maxim, "no contract, no work."

"We'll see you in five weeks," was the ominous word of miners at the Montour 10 at Liberty, Pa., as they filed out of an afternoon shift yesterday.

James Caspar, a track layer at the Westland, Pa., mine, summed up the miners' reaction to the strike injunction with:

"They can't do anything to a man for not coming to work when he doesn't want to. Not in this country, they can't."

A spokesman for the big 1,300-member Robens mine, local in Greene county, Pa., declared:

"We are coming out at midnight Wednesday, strike or no strike, unless a contract is signed before then." He ended harshly, "and we don't expect a contract to be signed before then."

Lewis' grip on the coal diggers was illustrated at the Westland mine Monday when 600 miners reported as usual. But as the men drew their lamps, the query rippled through the crowd:

"Are you or aren't you for Lewis?"

The men turned in their lamps, poured the water from their pails and went home.

Wraps Are Off

Key West, Fla., Nov. 19.—President Truman called the plays from this vacation retreat today as the government penned an all-out offensive against John L. Lewis.

The usually mild-mannered Missourian threw off the wraps yesterday after ordering Interior Secretary Krug to institute injunction proceedings against the president of the United Mine workers.

His press secretary, Charles G. Ross, told a news conference at this naval submarine base:

"Every step being taken is being taken in accordance with the president's instructions."

Greece May Ask UN For Support

London, Nov. 19.—(AP)—Alexander A. Pallas, chief press officer of the Greek Embassy, said today leftist guerrillas were defeating government troops in northern Greece with "carefully planned support" from Yugoslavia, Bulgaria and Albania.

Pallas said a formal appeal for United Nations intervention had been delayed because the American and British ambassadors in Athens had advised Premier Constantinos Tsaldaris against its immediate submission. He said the advice was based on "procedural grounds," but did not elaborate.

Quick Inquiry Of Housing Planned

Washington, Nov. 19.—(AP)—A congressional investigation of the veterans' housing program to determine whether government controls impede rather than spur new building, today was made the first business for the House Banking Committee in January.

Rep. Wolcott, Michigan Republican who succeeds Rep. Spence (D-Ky.) as committee chairman, told newsmen the quick inquiry will be aimed at uncovering the "basic faults" of the program with the view to speedy passage of remedial legislation.

Atlantic City, N. J., Nov. 19.—(AP)—The CIO has kept its unity by acting on its Communist problem. But it hasn't solved the problem at all.

For months CIO unions, some of them, have been bolting with fights over efforts by Communist union members to win control or get key posts. These Communist efforts—some real, some cooked up by enemies of the CIO—had been widely and publicly denounced.

There was talk before the convention opened that a fight over Communism on the convention floor might split the CIO wide open. Such a split, now when the CIO is getting ready for what may be a bitter wage struggle in 1947 might be fatal.

But there was no split, and no fight. The delegates yesterday approved a resolution opposing Com-

munist "interference" in the CIO. (The vote was unanimous, although, since there were Communists among the delegates, this meant) Communists voted against Communist "interference.")

And that's as far as the CIO went. The CIO is simply an organization of 40 unions. The vote meant only: the national CIO is against Communist "interference."

But if any one of these 40 unions has Communist trouble, it will have to settle it itself. So nothing is solved.

But the CIO as an organization by avoiding a convention fight will be able to present a united front to employers in any 1947 wage battle.

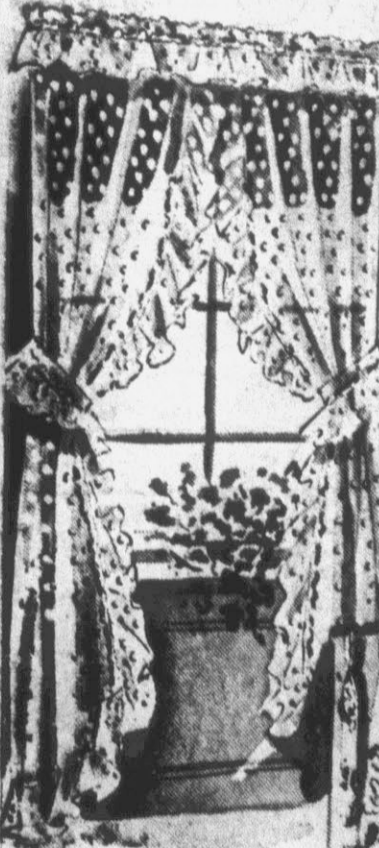

Meet Reorganize National Guard

The meeting of citizens of Pitt County and Greenville in the city court room at the City Hall Wednesday night at 7:30 to perfect plans for the reorganization of a National Guard unit in Greenville was called, stated Mayor J. H. Boyd in response to popular demand of the citizens. A representative of the state adjutant general's office will be present at the mayor's request, to explain in detail the requirements, operation, benefits and advantages of such a unit.

Greenville and Pitt County, stated the mayor, cannot afford to be without a National Guard Unit. The payroll alone to enlisted men and officers is increased considerably over that of the units which existed before the war. An example of this is the scale of enlisted men, which runs from \$5.50 to \$2.50 per armory drill, according to grade. The new unit will have the most modern equipment obtainable, and in such quantities that it is doubtful that it can be stored in the county-city armory, making it necessary that additional space may be required, which will be provided at government expense.

Service in a National Guard unit under the reorganization plan, will enable young men liable for military service, to obtain part of their required training at home instead of in the regular army, Mayor Boyd said. Citizens of the county and city whether eligible or interested in serving in the National Guard, are invited to attend this meeting, to get full details and assist in the plans for its reorganization.

WE NEED SANITY AND SANITATION

Someone has remarked that the writers of this country are going through a period of illness. One is amazed at times to see the length to which a certain variety of writer will go in order to give a narrative what is usually called "sex appeal." If the publishers only knew it, they are inviting a disgusted and indignant public to sit them up with legal proceedings, which, of course, would be a calamity.

It is not true that realism requires the detailed recitation of everything that goes on in life. Neither is it true that if people exercise a decorous restraint in speech or writing they are therefore hypocritical in their attitude. If everybody said what was on his mind every day to every friend or enemy who happened to meet, traffic in every city would be held up by street fights and the homicide rate would rise a thousand per cent overnight. Restraint in speech is required by good breeding. Restraint in writing, if it touches a man's character or motives, is enjoined by the law of libel. But we presume that it is all right for a little group who call themselves literary folk to indulge in the rankiest kind of adulatory obscenity, turn their minds inside out on paper, and send the whole putrid mess through the mails, and to do this in the name of art.

THOMAS JEFFERSON MEMORIAL STATUE NOW BEING CAST
 By WARREN A. McNEILL
 (For Jane Eads)

Washington — Within a few months visitors to the Thomas Jefferson Memorial will see a statue of the third President that is real bronze instead of painted plaster. It will be at least two more years, however, before they can expect to see heroic sized groups in gilded bronze at the end of the Arlington Memorial Bridge, although the statue has been planned since 1931.

Crossword Puzzle

Another piece of painted plaster which the casual observer might mistake for a real bronze is a group of statues the American Gas Association which stands near Constitution Ave.

It has not been accepted by the National Fine Arts Commission, which must pass on monuments for the capital, nor have funds been provided to complete the latter work.

The Rudolph Evans statue of Jefferson was completed and accepted in full-scale model form in 1943, but the sculptor found it impossible to have the bronze casting made. So he made a copy, keeping the original plaster model in his studio for use in making molds for the bronze.

The casting is now being done. It is hoped to have the permanent statue in place by Jefferson's birthday next April 13.

The story of the bridge sculptures is more complicated.

In the summer of 1931 the Fine Arts Commission approved designs prepared by James E. Fraser, of Westport, Conn., for groups representing "Harvest" and "Peace and Arts of Peace," and of Leo Friedlander, of White Plains, N. Y., for groups representing "Valor" and "Wars and Arts of War."

The groups, each approximately 18 feet long and about the same height, were to be carved from white "Quint Airy marble."

The depression delayed a start until 1936. Scale models were completed in 1938, but the sculptors then said that increased costs had made it impossible for them to do the work in granite.

In 1941 the Fine Arts Commission

 of the convention delegates. He's an avowed Communist, a member of the Communist party executive committee.

Asked how he could bring himself to vote for a resolution against "interference" by Communists in CIO affairs, Gold said:

"I will maintain the unity of the CIO and resist the attacks of the employers and the reactionary Republican machine. If the employers thought the CIO was going to engage in a purge of witch-hunting they must be disappointed."

Last week, realizing that something would have to be done about all the talk of Communism in the CIO, Murray set up a special committee of six CIO union presidents.

The committee's job was to try to agree on some kind of recommendation — or resolution — upon which the convention would agree.

Three members of the committee were anti-Communists. Three, including Gold, were so-called left-wingers.

They drew up the resolution which avoided a fight in the convention. Murray stayed off any argument about the resolution when he presented it. He indicated he wanted a quick vote—and no talk—by telling the delegates he expected "unanimous rising vote." This is got, and up talk. But last week the CIO executive board—a 51 man board of top CIO people—did some

Communism—if the CIO wants to use it—than yesterday's resolution. The board changed the CIO rules.  Prime Minister Attlee in reply to the left-wingers said:

"I think this motion is misconceived, is ill-aimed and based on a misconception of the facts. This government does not believe in the formation of groups or opposing groups of the East, West or center. We stand for the United Nations. We perhaps are more accustomed to compromise than some of those with whom we have to deal, but compromise is the basis of a peaceful civilization."

Answering the "rebel" demand that he repudiate Churchill's full-throated support, Attlee gave this middle-of-the-road reply:

"We are not seeking an exclusive Anglo-American alliance. Whether the left-wingers were satisfied, the fact remains that the government's foreign policy received a unanimous voice of confidence. Mr. Attlee will find plenty of people in America who agree with

his dislike of blocs. Still he presumably wouldn't deny that as world affairs now stand, blocs are necessary evils. Furthermore the present division (if there must be) is on logical lines—ideological and racial. It's natural for the Slavic states to cling together, and the same is true of much of the Western group, especially the English speaking peoples. And, of course, totalitarian communism and Western democracy are as oil and water to each other.

Paradoxically enough, it is possible that the "bloc" system may work out all right in the end. To make the United Nations organization function properly there must be world unity. That unity will come by degrees. We have disunity now between two great blocs, but while that is disconcerting we mustn't overlook that there is a very considerable degree of unity within

Danforth's story said "this was a tip from a press source as representatives of the Pacific Coast Conference and the big nine went into a day-long session in Berkeley."

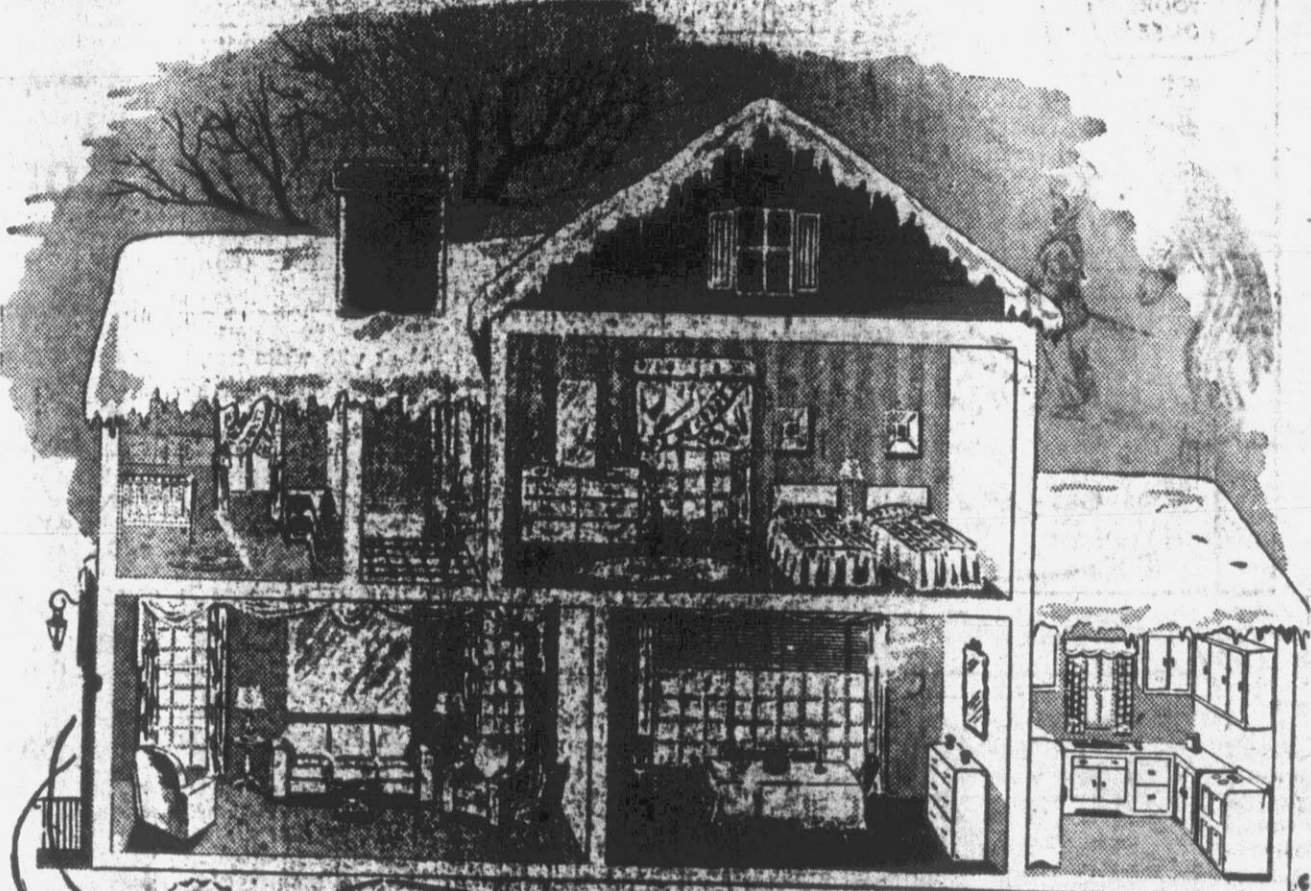

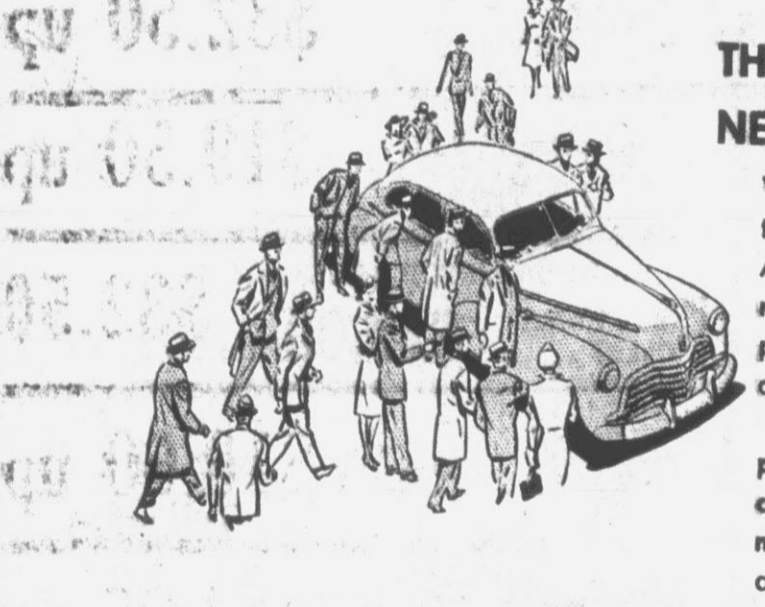

He said workers at the State Board of Health and Laboratory of Hygiene had taken the injection and all without any "bad results" from the "shot." He advised, however, against taking the vaccination while suffering from a cold or any other type of respiratory infection.
The Laboratory of Hygiene received its supply of the vaccine from commercial manufacturers. Dr. Reynolds said it was relatively scarce, but that he thought the laboratory had a sufficient supply on hand to fill all North Carolina requests.

A load of buckshot striking his head, Virgil Wilson is charged with the shooting. From the testimony, it appeared that Wilson mistook Kennedy for Jake Greene, the man he had the argument with earlier that night. When the officers and coroner arrived at the scene of the shooting Kennedy was lying on the ground dead, both hands in his pants pockets, one hand holding an open knife.
After the inquest authorities said it appeared that Kennedy was

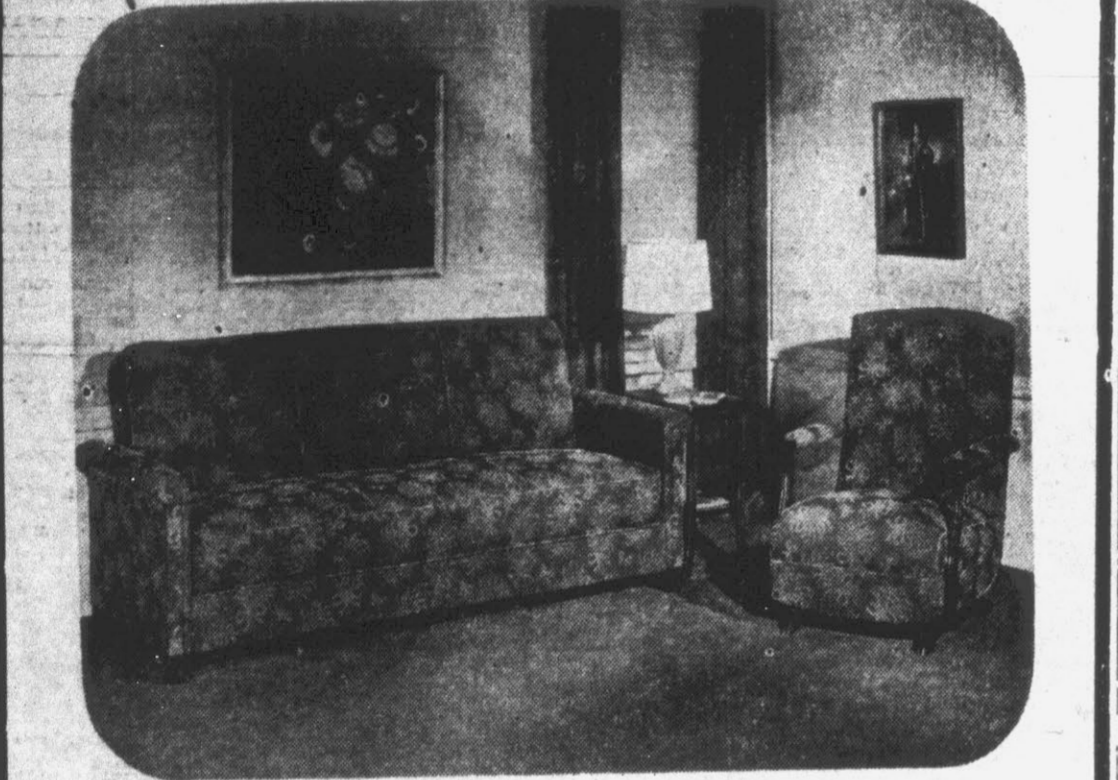
