ROCKET PLANE PASSES FIRST TEST FLIGHT

High-Speed Experimental Craft "Loafs" At 570 Miles Per Hour

Los Angeles, Dec. 11—(AP)—A tiny plane with which the Army Air Forces and Bell Aircraft Corp. expect to delve into the uncharted realm of supersonic speed, has successfully completed its first tests.

The XS-1, with 32-year-old Pilot Chalmers (Slick) Goodlin, New Alexandria, Pa., at the controls, was cut loose from the belly of a B-29 bomber over Muroc Army Air Base Monday. Seconds after America's first rocket-propelled plane dropped away from the big bomber, Goodlin turned on the power, and the craft darted away with a momentum which the former Navy pilot compared to the thrust from a catapult aboard a carrier.

The plane is designed to fly at 1,700 miles an hour, but Goodlin made no attempt to step it up that high. He loafed along at a mere 550, using first one cylinder, then two, and finally—for only a few seconds—all four.

The plane was cut loose at 25,000 feet. Goodlin climbed over his own power to 35,000, meantime diving banking and climbing. He flew for 19 minutes, not quite seven under power, and made a perfect landing with his fuelless engine idle.

The plane's power is measured in terms of torque, rather than horsepower. But R. M. Stanley, E. C. Okla, Bell's chief engineer and designer on the plane, said by the only available means of comparison, the engine could be said to develop 30,000 horsepower. It burns ethyl alcohol, oxidized by liquid oxygen.

Former Police Officer Freed

Lansing, Mich., Dec. 11—(AP)—An Michigan county circuit court jury today freed a former police officer, Smith, 36-year-old former police officer, of a murder charge in the fatal shooting of his wife, Roxanne.

The jury of nine men and two women deliberated for two and a half hours and cast seven ballots. A twelfth juror was excused.

The defense contended that Mrs. Smith, 22, was killed by a bullet from a service revolver fired accidentally by three-year-old Clayton Smith, Jr., son of the couple and not by her husband. The three were alone in the bedroom of their home at the time of the shooting last August 22.

The boy demonstrated in the judge's chambers how he could fire his father's revolver. This was reported to the jury by the judge.

Small Industries Needed In State

Roxboro, N. C., Dec. 11—(AP)—More than \$500,000,000 can be added to North Carolina's farm income by increased processing and manufacturing of the state's farm products within the state.

Authority for this figure is Dr. L. D. Bayer, State College Dean of Agriculture and Forestry, who spoke here yesterday at the 10th of a series of meetings on rural industries. Many of the state's agricultural difficulties, he asserted, can be attributed to exporting of resources rather than processing them within the state.

Housing Control Hearing Called

Washington, Dec. 11—(AP)—Senators called 17 industry representatives to a hearing today on proposals to junk government housing controls.

The hearing, before the subcommittee of the Senate Small Business Committee, will continue through Saturday. Government officials and representatives of veterans organizations also will testify.

Senator Stewart (D-Tenn.) chairman of the subcommittee, said the purpose of the hearing is to draw "a clear line between the arguments in favor of decontrol and those that insist upon the retention and strengthening of existing controls as the sole means of providing homes for veterans."

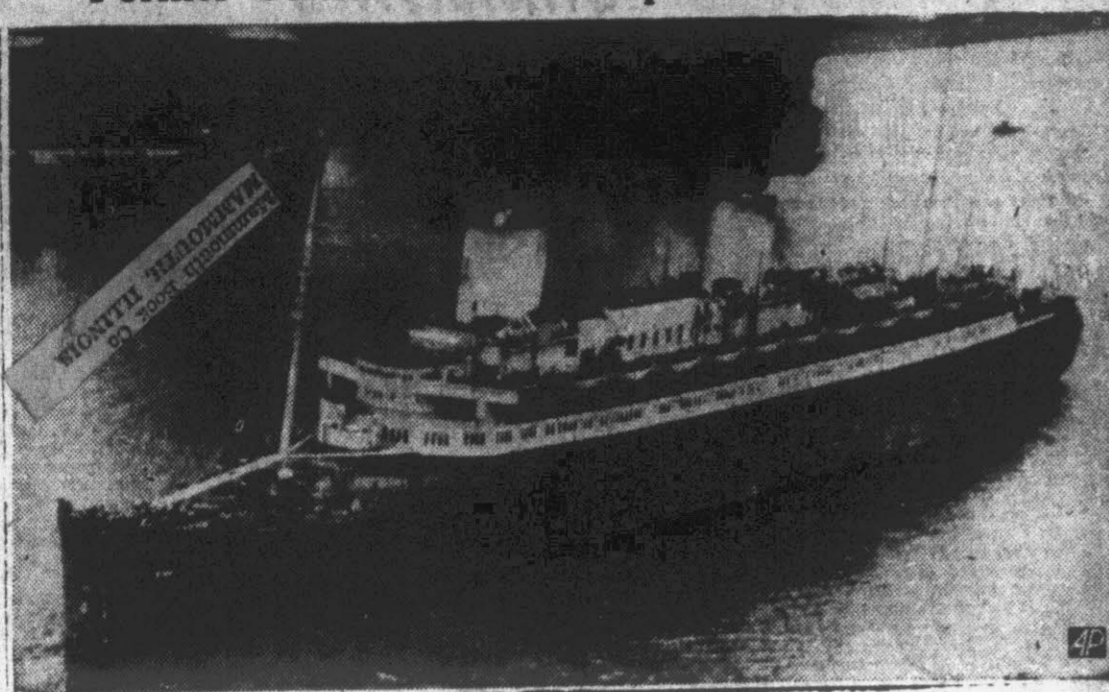
Convict Gets Death Verdict From Jury

Senators Ask Leaders Of Union To Give Advice

Lawmakers Suggest Labor Chieftains Be Called Upon For Proposals On How To Frame Laws To Avert Strikes

Washington, Dec. 11—(AP)—A suggestion that union leaders themselves be given the first opportunity to propose strike-averting changes in labor laws came today from four senators.

One of them, Republican Ralph E. Flanders of Vermont, 66-year-old industrialist embarking on his first term, said this would reverse the "New Deal technique" of the Roosevelt administration.

"When any anti-business law was planned in those days," Flanders told a reporter, "the whole act was set up and then business was invited in to say 'no' just before it was passed."

"But now that Congress is going to deal with labor laws, we should call upon labor for proposals, even before we start writing the law."

Senators William F. Knowland of California, another Republican, and Democrats Edwin C. Johnson of Colorado and John L. McClellan of Arkansas agreed in separate interviews that organized labor should be consulted at the outset.

Flanders and McClellan both expressed some doubt, however, that many suggestions would be forthcoming because of the opposition they said previous reform proposals have aroused in union circles.

"But I don't concur in that," Johnson said. "I don't think it would be just an idle gesture to call upon labor for its ideas. I think they will have some very constructive proposals."

Venezuela Scene Of Revolution

Caracas, Venezuela, Dec. 11—(AP)—Insurgents seized the major airport of Maracay, about 50 miles from this capital, in a surprise attack today and immediately dispatched captured planes on a bombing mission over Maracay and Caracas.

One bomb, estimated to be a 25-pounder, landed near the presidential palace. Another struck within 500 yards of the Jardin Hotel in Maracay and yet another on the airfield of the military aviation school near Maracay—all without causing damage.

A military spokesman said anti-aircraft fire drove the aerial raider away from the palace.

A chambermaid of the Jardin Hotel was the only casualty. She was struck by a stray bullet when Loyalist soldiers in a jeep fired Loyalist soldiers in a jeep fired their rifles at the plane.

Furore Over Nothing Standardized Arms For Britain And U. S. A Logical Step; British Leftists, Fearing Fight Against Communism, Doing Best To Weaken Democracies

There is a furore among British leftists over the Anglo-American-Canadian agreement in principle on standardization of arms. The Communists even charge, in an obvious effort to stir up trouble in the United States where Senate approval would be necessary, that a secret treaty has been made.

The latest flap was set off in Parliament Tuesday by a statement in the Communist Daily Worker of London that "an arms understanding between two great power must have a political and military significance."

"Political and military significance" is a mild way of putting this manifestation of one of the most fateful developments of the century—the community of interest, the recognition of interdependence, the mutuality of ideals which have

led the English-speaking peoples to accept as a foregone conclusion that they will stand together in any time of world crisis. There are many issues on which the British and American people differ or fail to understand each other, sometimes drastically. But there is no fear between them. There was no outcry in the U. S. when the standardization proposal was revealed. It was accepted as a logical application of lessons learned during the war. The British leftists, of course depict it as a combination against Russia. Yet a combination against Russia would be desirable for two purposes only—in preparation for aggression against Russia, or in preparation for Russian aggression against us. TRADE BODY FAVORS BONDS

Chamber Of Commerce Would Improve City's Utilities

The utilities bond issue for \$800,000, on which the citizens of this city will have the opportunity to vote Monday, December 16, was endorsed unanimously by the board of directors of the Greenville Chamber of Commerce at its meeting Monday night, Executive Secretary Willard T. Kyzer stated after the meeting.

In endorsing this bond issue, the Chamber of Commerce directors stated that its members were convinced of the need for improving Greenville's water plant to provide an adequate supply of pure water to meet the needs of this rapidly growing community. These improvements are also necessary to meet the requirements of the State Health Department, and with the demand now exceeding the present plant capacity of a million and a half gallons per day, neither of these conditions can be met unless this improvement program is carried out.

The work is being done under the supervision of City Engineer Henry L. Rivers and by local labor. The city is saving considerable money for the taxpayers on this job. The lowest bid submitted by a contractor was \$35,000. The city engineer and the aldermen estimated the project would cost \$11,000. When the job is completed the cost will not be over \$35,000, a saving of approximately \$20,000. And no accident has occurred during construction.

QUICK INQUIRY IS SCHEDULED

Immediate Grand Jury Probe Of Columbians Promised

Atlanta, Dec. 11—(AP)—An immediate grand jury investigation of charges that Columbians, Inc. sought to seize power in this country—assertions which one of the anti-Negro group leaders termed a "pack of lies"—was promised today.

Fulton County (Atlanta) Solicitor General E. E. Andrews said the charges disclosed yesterday by State Attorney General Eugene Cook would be placed before the grand jury starting Friday and would be "prosecuted vigorously."

Homer L. Loomis, Jr., secretary of the Columbians which were organized here recently and since have figured in several anti-racial incidents, characterized the charges as "falsehoods."

"I am surprised at the charges," he told newsmen reaching him at Columbus headquarters last night. President Emory Burke was not available for comment.

Cook forwarded a voluminous record, gathered in large part by investigators of the non-sectarian Anti-Nazi League of New York but including statements from two members who turned state's evidence, to Gov. Ellis Arnall.

The record included charges of dynamiting a Negro home, a plot to "beat up or lynch" prominent Georgians and plans to drive the Negro population and to seize power by fostering racial hatred.



British-Russian Proposal May Divulge Atom Secrets

DISPARITY IN PROFITS AND WAGES NOTED

Economist Warns Of Collapse If Prices And Pay Not Adjusted

Washington, Dec. 11—(AP)—Robert R. Nathan, a former top-rank government economist, said today the nation will be "flirting with collapse" unless industry promptly raises workers' pay or cuts prices sharply.

The former chairman of the War Production Board's planning committee and later deputy war mobilizer asserted that industry's present profits can support wage boosts ranging up to 25 per cent without further price rises.

Profits, Nathan said, still would be near their war time peaks.

The survey, made jointly by Nathan and Oscar Gass, an associate, pictured a growing disparity between wages and profits and said this spread means purchasing power soon will shrink to bring on a depression.

"Unless there is an immediate increase in wages or a sharp drop in prices, we are flirting with collapse," the report said. "There is no evidence to date to indicate that business will cut prices prior to a depression in which unemployment, declining incomes and shrinking demands will make price decreases unavoidable. This is too high a price for bringing wages and prices into sounder alignment."

The report emphasized its findings were based on average industrial conditions and should be applied differently among various industries.

"The facts all lead to the conclusion," Nathan said, "that not only from the workers' point of view, but also for the benefit of the whole economy, a further substantial wage increase without a general price increase is possible, justifiable and essential."

Rescue Refugees From Greek Isle

Jerusalem, Dec. 11—(AP)—The British Navy announced today that 742 shipwrecked Jewish refugees had been evacuated from the lonely Greek island of Syra by two British warships and now are enroute to Suda Bay at Crete, where the immigrants are to be transferred to a hospital ship and thence to Cyprus.

The announcement said the rescue was carried out "in extremely rough seas and in extreme difficulty."

Jewish agency sources here said Cyprus detainees now were being sent to Palestine in a gradual immigration process and said the shipwrecked refugees probably would have to take their turn in the immigration mill.

Pastors Refuse Concede Defeat

Staubenville, O., Dec. 11—(AP)—Despite a defeat of a bill authorizing extra police, Staubenville's crusading ministers said today they had no intention of quitting their campaign to rid the city of crime.

"Moral issues are not settled by a vote of city council," said the Rev. R. K. Russell, head of the Staubenville Ministerial Association.

"We are going to see the campaign through until we get the kind of government people deserve in this city."

A tie vote of 4 to 4 by council last night defeated a measure which would have empowered Safety Director Alfred Schaefer to appoint one or more private policemen to enforce city and state and federal laws in this city of 40,000.

The pastors' campaign is centered on gambling and prostitution.

Aged Confederate Is Given Special Party

Asheville, N. C., Dec. 11—(AP)—J. W. Dickerson, one of the few survivors in the thinning gray Confederate ranks, was tendered a party here today by the Confederate Daughters on his 100th birthday.

His wife died 10 weeks ago and Dickerson has turned to religion for solace.

Surprise Agreement Could Force U. S. To Disclose Atomic Secrets To World; Veto Would Halt Immediate Action

By JOHN A. PARRIS, JR. Lake Success, N. Y., Dec. 11—The United States faced the dangerous possibility today of being forced to disclose her vital atomic secrets to the rest of the world immediately.

Members of Britain's delegation to the United Nations said the U. S. could forestall immediate disclosure by using the veto in the U. N. security council. But American representatives did not share this view.

This vital issue was raised as Russia and Great Britain agreed in principle last night in U. N. assembly plenary session at Flushing Meadow Park on a vast program enveloping arms reduction and a world-wide troop census with all the spot verification checks of all forces and armaments.

In a resolution calling for all members of the United Nations to report on their armed forces at home and abroad by Jan. 1, Britain submitted an amendment to establish an inspection commission to verify these reports.

Russia insisted that this include armaments also, to which Britain agreed.

This is the text of the new British proposal: "The general assembly recommends immediate establishment of an international supervisory commission, operating within the very framework of the security council but in its operation not subject to the veto of any power on the security council, which shall be entitled by the agents of any nations acting in its behalf to verify and confirm on the spot any or all information submitted in accordance with any requirements of the general assembly of the security council as to troops and armaments."

When this supervisory commission is established the member states shall be required to submit full particulars on armaments of different categories as well as armed forces."

U. S. Senator Tom Connally (D-Tex.) said he would like both British amendments to go to the subcommittee on armaments reduction. It was finally agreed to turn the matter over to the sub-committee.

Azerbaijan Submits To Security Forces

Teheran, Dec. 11—(AP)—The Tazir radio announced today that Dr. Sallamollah Javid, the communist general governor of Azerbaijan province, had wired Premier Ahmed Qavam that the provincial council agreed to the assignment of government security forces in Azerbaijan.

Four columns of government troops were dispatched only yesterday across the frontier of the semi-autonomous state which had rejected Qavam's orders for government supervision of coming elections throughout the nation.

The supreme war council of Iran met here for three hours this morning.

Gen. Razmara, chief of the general staff, was in attendance, as the troops struck northward against the Azerbaijan Pedals (militia) of Dr. Sallamollah Javid, the communist general governor, in a movement which may challenge Soviet Russia's interest in the northwestern border province.

Premier Ahmed Qavam ordered the military action after the Azerbaijan regime rejected his plan for army supervision of coming elections.

OPA "Secretive" On Sugar Stamp

Washington, Dec. 11—(AP)—OPA officials said today they will keep secret until January 1 the number of the new sugar ration stamp which will become valid then to prevent users from "spending" it in advance.

The new stamp will be good for five pounds of sugar from the first of the year until April 30. Current individual Stamp No. 51 and home coming Stamps 9 and 10 will expire December 31.

Although OPA said yesterday a second stamp also might be validated during the first quarter of 1947, Department of Agriculture officials said they doubted this could be done before April 1. By that time the size of next year's sugar crop and of Cuban imports can be taken into account.

The Debt And Taxes

Important Question For Congress Next Year Is, Which Comes First... Tax Reduction Or Debt Reduction; Opposing Forces Explain Their Viewpoints

By FRANCIS M. LE MAY (Substituting For James Marlow) Washington, Dec. 11—(AP)—One of the biggest questions the new Congress must answer next year is this: Which should be cut first: taxes or the \$260,000,000,000 national debt?

In the background is the fact that interest payments alone on the debt amount to \$5,000,000,000 a year—a sum greater than the government's average annual take from all revenues in pre-war years. That poses a lot of questions.

Lawmakers are dividing sharply into two camps. One demands that, by all means cut down the debt by every dollar possible during the flush postwar era. Otherwise, this group says, a recession at some later day may play havoc.

ROCKEFELLER OFFERS FUNDS FOR UN HOME

Gift Of \$8,500,000 To Purchase Manhattan Site Is Submitted

Lake Success, N. Y., Dec. 11—(AP)—John D. Rockefeller, Jr., today offered the United Nations a gift of \$8,500,000 with which to buy a large tract of land in mid-town Manhattan for a permanent site.

In a letter and memorandum read to the United Nations permanent headquarters committee by Warren R. Austin, chief United States delegate, Rockefeller stated he had obtained a "firm offer" for property located between First Avenue and Franklin D. Roosevelt Drive and between 42nd and 47th streets. He said the cost of the property would be \$8,500,000.

Rockefeller said he had already received assurances the city of New York was prepared to give to the U. N. the balance of a city block on which his gift purchase included two small plots.

He added that he predicted his gift for the land purchase on assurances New York City would permit the U. N. to use the entire area without restriction and would also turn over to the U. N. use all bulkheads and piers on the East River frontage between 42nd and 48th streets.

The gift, he added, must be declared free of all federal and state taxes.

Action must be taken within 30 days from December 10.

In a letter asking that the communication be transmitted to the site committee, Rockefeller stated that he had ventured to locate territory on the East River in the midtown area, both because he believed the people of New York City wanted the United Nations among them and because New York City afforded the best spot for the U. N. to locate permanently.

Broadway's King Dies Of Cancer

New York, Dec. 11—(AP)—Damon Runyon, newspaper columnist and author, who made the "guy" and "dolls" of Broadway—the gambler, light promoter, and small time actress—a part of American folklore, is dead at 62.

The creator of "Little Miss Marker," the "Lemon Drop Kid," and "Harry the Horse" died last night in Memorial Hospital where he was admitted last Friday for treatment of a liver ailment. He had been ill for a long time, and for the past year a throat ailment prevented him speaking.

Paul Small, his agent, who was at his bedside, said Runyon died of a cancer.

There will be no funeral services for Runyon. His body will be cremated at an unspecified time and place. Friends said Runyon had requested this.

Albania Warned Of UN Action

London, Dec. 11—(AP)—Great Britain, demanding apology and reparations, has warned Albania that unless a "satisfactory reply is received within 14 days" for losses of life suffered by two British destroyers which struck mines October 22 in Corfu channel, the problem would be placed before the United Nations security council.

As a result of the mine explosions, 29 sailors died and 43 were injured. The blasts blew the bows of the destroyers Saumarez and Volage, while they were one and a half miles off the Albanian coast.

Will Lift Ban, GIs May Wed Frauleins

Frankfurt, Germany, Dec. 11—(AP)—A spokesman for Gen. Joseph T. McNarney said today that the prohibition against American soldiers marrying German girls would be lifted within 15 days, with certain reservations.

The surprise decision will allow hundreds, possibly thousands, of Americans to take German girls back home as brides.

Children Injured As School Bus Crashes

Flint, Mich., Dec. 11—(AP)—State police reported that at least 25 children were injured, some seriously, when a crowded bus blew a tire and hurtled into a tree seven miles south of here today.

Corporal Vincent Neering of the state police post said first reports did not list any fatalities. The injured were taken to a Flint hospital.

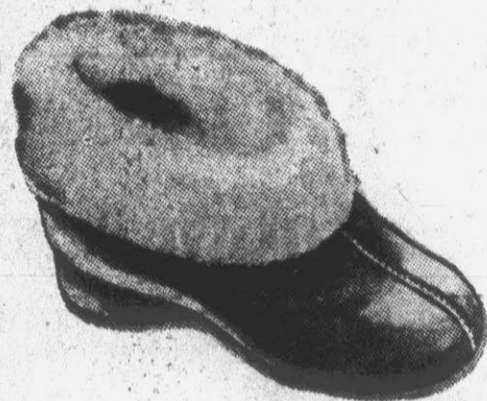

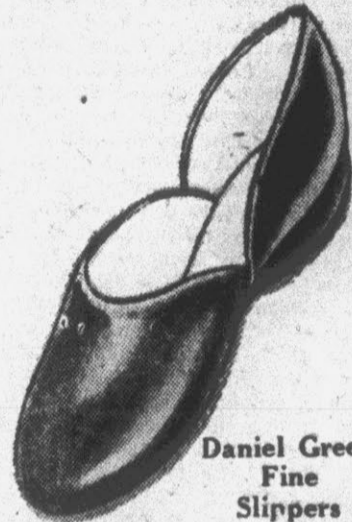

Women IN THE CHURCH

by Mary Fowler

"To discover what is the mind of Christ and the will of God at this hour," two thousand Christian women leaders—representing perhaps 25,000,000 women in seventy Protestant denominations in the United States and in seventeen foreign countries—met in Grand Rapids, Mich., recently. It was the biennial session of the United Council of Church Women, under the presidency of Mrs. Harper Sibley of the Protestant Episcopal Church, New York. The Council urged upon President Truman and his associates the making of concrete proposals for disarmament, the admittance of certain quotas of displaced Europeans into the United States, and continuance of the feeding of starving populations of Europe and Asia. It also urged that issues concerning Palestine be submitted to the United Nations for consideration and action.

Turning to the American scene, the council noted a growing concern throughout the country over the race question and various forms of segregation. Acting on the basis of a nationwide survey among groups of women, it was urged that more Negro women be trained and placed as teachers in the public schools and as nurses in hospitals; that more doors be opened for the employment of Negroes in all fields of endeavor; and that encouragement be given to the plan, already under way in some communities, for "cross-membership" in churches—a group of Negroes in white churches, a group of white members in Negro churches. Many plans were suggested for better interracial relations in local communities; friendliness for Japanese families; local committees on race relations; study of the cause and means of eradicating race prejudice; and programs of race understanding in the public schools and in the churches.

Grove Patterson, editor of the Toledo Blade, urged upon the women continual expression of opinion on matters of public and international welfare. "Public opinion is the strongest man-made thing in the world and the thing against which no man can stand," he declared. "The United Nations will work if public opinion makes it work. Differing ideologies, political and economic systems are not a bar to friendly participation in plans to keep a world in peace." He pointed out that differences between the Russia of the Czars and the United States were greater than between those lands today, yet the two never thought of war in a period of 128 years.

The Pitt County Bar Association held its monthly meeting Tuesday night at Nelson Hopkins' Tavern on Tar River. An interesting and informative discussion on the question of standard measures, particularly as applied to the sale of timber, featured the meeting.

New officers were elected for the coming year as follows: Marvin K. Blount, president; James L. Evans, vice-president; James R. Worsley, secretary; and Eli Bloom, treasurer. Members of the executive committee were named as follows: Julius Brown, Dick Bundy, Hoover Taft, Sam B. Underwood, Jr., and Harry Brown.

Installation of officers will be held at the next regular meeting on Tuesday, January 14.

Proposal Extend Limits Of City

The Board of Aldermen at a recent meeting discussed at length a proposal to extend the city limits. The extension would include Hillsdale, all of the Bama, the north side of Tar river, (the section known as Meadowbrook or Fleming's Cross Roads), and the settlement between Fourth and Fifth streets on the Washington highway.

Mayor Jack Boyd said today the aldermen are anxious to know how the citizens feel about the proposed extension. Interested citizens are invited to attend the Board of Aldermen's meeting at the City Hall

on January 2 to state their views and discuss the matter. The mayor said if there is sufficient interest in the proposed extension by that time he would call a special meeting.

Extension of the city limits would require an act by the General Assembly amending the city's charter.

Dr. W. A. Browne Is Speaker For Club

Dr. Walter A. Browne of the geography department at East Carolina Teachers College spoke at a meeting of the Faculty Lecture Club at East Carolina Teachers College on Monday evening, addressing the group on the subject "Geography and the Geographer's Sphere." Dr. Browne was the second speaker to appear before the club during the 1946-1947 term.

Explaining that changing emphasis in the field of geography and misunderstanding about the material included in the subject makes a clarification of the aims of the geographer desirable, Dr. Browne traced the history of geography for members of the club. He discussed location, environment, and anthropo-geo relations as they concern geography and stressed the usefulness of applied geography, which brings together "into working order the various phases of the geographic realm previously treated."

The conference is composed of the following teams this year: Greenville, Kinston, New Bern, Tarboro, Washington, Roanoke Rapids, and Elizabeth City.

The clinic will cover a detail interpretation of basketball rules which will comprise the afternoon session. A dinner meeting will be held at Respos at 6 p. m. The conference session at night will consist of demonstrations of rules, with the basketball teams of E.C.T.C. and G.H.S. providing the plays.

Some thirty to forty people are expected to attend this meeting, out of which the N.E.A.C. basketball officials association will be formed. Mr. J. Vance Lewis of New Bern is chairman of the officials group. Mr. O. E. Dowd, principal of Greenville High School, is president of the N.E.A.C. and Mr. Joe Talley of High School Roanoke Rapids is secretary of the conference.

Junior Basketballs Also Make Debut In Preliminary Game

The baby phantoms will probably start Murray Cooke, the flashy forward who played varsity ball for Peabody Demonstration School last year, and Joe Allgood, little sharpshooter from last year's team, at forward, Sam Northrop lanky 6-foot reserve from last year's team at center, and Joe Sawyer and John Farley, ball hawking fast dribbling sophomores at guard. The juniors also have four pre-Christmas games.

Will Decide Cup Teams Monday

Meibourne, Australia, Dec. 11—(AP)—Jack Kramer and Ted Schroeder made sure of playing in the Davis Cup doubles match against Australia by trouncing Gardner Mulloy and Billy Talbert 6-3, 6-3, 6-3, in a full-dress cup trial at Kooyoung Stadium today. Although the cup captains will

not name their four-man squad until Monday, it is possible to say now that the American team will consist of Kramer, Schroeder, Frank Parker and Mulloy, Tom Brown's unfortunate illness before the Victoria tournament knocked him out of consideration.

The Australians also held a "crucial" doubles trial before the American match. For the first time they paired Jack Bromwich with Arthur Quist and they came through with a 4-6, 10-8, 6-3 victory over Colin Long and Lionel Brodie after a furious two-hour tussle.

TIDWELL TOPS BOB FENIMORE

Auburn Freshman Is Ground-Gaing King For 1946

New York, Dec. 11—(AP)—Travis Tidwell, Auburn's hard-working freshman, is the ground-gaining king of college football for 1946.

Closing with a terrific burst in his last two games, Tidwell outdistanced his closest pursuers and replaced Bob Fenimore of Oklahoma A. and M., who had reigned for two years as the individual offensive leader of the collegiate grid-irons.

Statistics released today by the National Collegiate Athletic Bureau show Tidwell not only topped the country in combined yardage gained on the ground and in the air but also was the No. 1 passer on the basis of total completions and the seventh best ball carrier.

Tidwell, who threw or carried the ball 339 times to be far and away the workhorse of the country, accounted for a total of 1,715 yards in Auburn's ten games. He completed 79 of 158 forward passes for a total of 943 yards and picked up 772 yards on 181 running plays.

Thus the yearling star personally provided for 61 per cent of his team's total gains of 2,828 yards and was the key man in more than half of the 674 plays which Auburn used in ten games.

"The Big Train" Dies In Hospital

Washington, Dec. 11—(AP)—Two generations of baseball fans were saddened today by the passing of Walter Johnson, the fireball thrower who virtually rewrote the pitching record book during his 21 years with the Washington Senators.

Known as "The Big Train" and a member of the game's official Hall of Fame, the kindly onetime

Kansas farm boy died just before midnight at Georgetown Hospital. He was 59 years old.

For eight months his life had been dimming from a brain tumor which doctors dared not try to relieve by surgery.

In Washington, where he spent his entire big-league pitching career, Johnson was almost as celebrated as Presidents, Cabinet members and Supreme Court justices. During the time he lay dying even schoolboys unborn when he was in his prime called the hospital to ask how he was doing.

Clark Griffith, 76-year-old president of the Senators, summed it up for the lanky Johnson's admirers today when he said: "He was the greatest pitcher of all time."

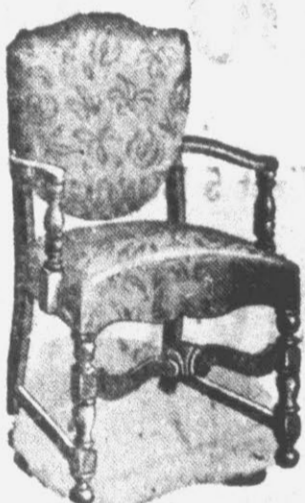
A preliminary game which starts at 7 p. m. will bring together the two B teams of the colleges. The Pirates will meet Fort Bragg here Friday night, December 13.

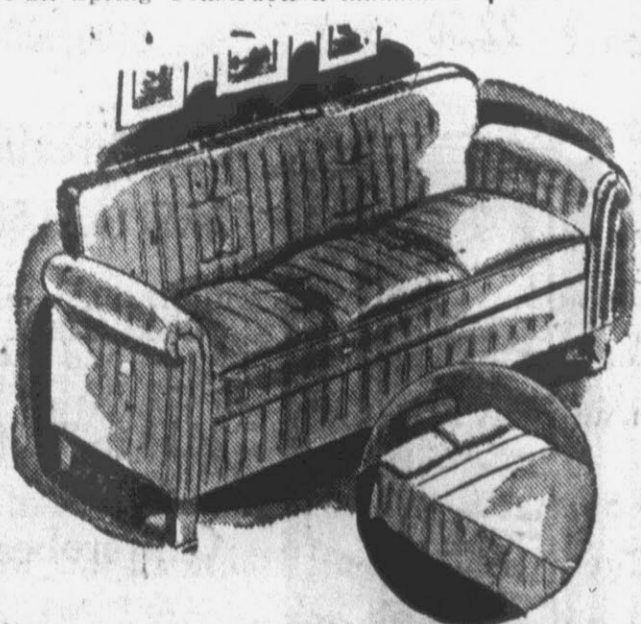

wait hours with indications of the present year exceeding the 1945 figures approximately 3,000,000 kilowatt hours. These facts show the enormous increase in demands on the electric plant which will be further accelerated when materials are available for the construction of residences and business property.
The Chamber of Commerce board of directors realized that an inadequate supply of electric current will hamper the growth of Greenville a situation which no forward looking citizen desires, and for this

reason the board endorses the bond issue for this purpose, as it realizes that industry and business, as well as new citizens locate where they are assured of a dependable supply of electric current to meet their needs.
In urging Greenville citizens to vote for this bond issue on December 16, the chamber's directors call to their attention the fact that the Greenville utilities is a profit-making organization for the community and that a substantial amount each year is turned over to the city which serves to help the municipality to maintain its favorable tax rate.
The bonds to be voted Monday will not increase the city's tax rate as the additional revenue which these improvements will enable the utilities to earn, will pay off the bonds as they become due.

Plane Wreckage Seen By Pilot
Seattle, Dec. 11.—(AP)—A Coast Guard ensign flying a small observation plane radioed today he had sighted wreckage three and a half miles from the Toledo airport, near the western fringe of the Cascade Mountains between here and Portland, which might be a marine transport plane missing since yesterday with 32 men aboard.
The message was relayed here from a Coast Guard mobile communications truck group at Toledo, which is 19 miles south of Ghehalls. The flyer could not determine if anyone was alive.

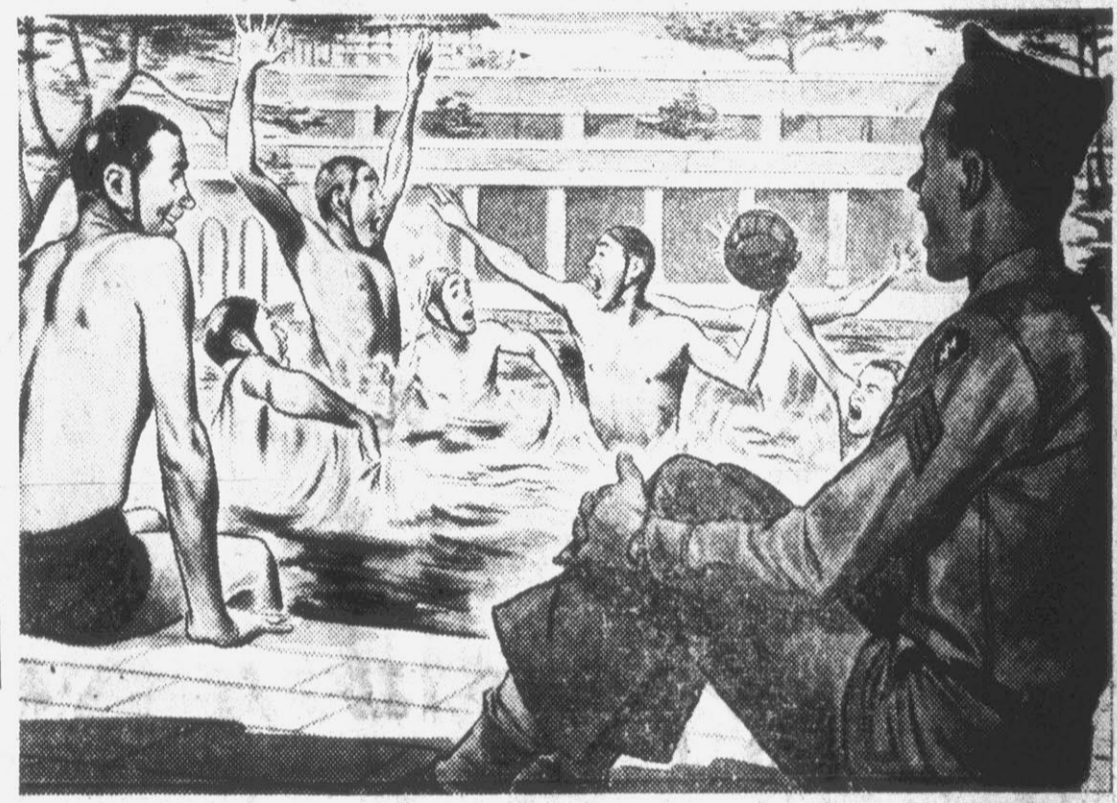
