CIO Filing Suits For Huge Sums

Union Starts Legal Fight To Collect Portal To Portal Pay And Damages That May Reach Into Billions Of Dollars Following Supreme Court Ruling On 1938 Fair Labor Standards Act

By the Associated Press The CIO has started a legal fight in several cities to collect portal to portal pay and damages in excess of \$374,000,000 and a union official in Detroit predicted future suits in that area alone would approach the billion dollar mark.

Filing of the suits followed a favorable decision last June by the U. S. Supreme Court in a suit started by employees of the Mt. Clemens (Mich.) Pottery Company for such pay under the 1938 Fair Labor Standards Act.

In Detroit, Richard T. Leonard, vice president of the CIO, United Auto Workers and the union's national Ford director, predicted the filing of suits asking \$1,250,000,000 from Detroit area employers, including claims of \$270,000,000 against Ford.

UAW attorneys said a suit asking \$60,000,000 from the Briggs Manufacturing Company would be on file in the Detroit Federal Court by Monday at the latest.

Suits seeking a total of \$198,000,000 have been filed in the Cleveland District Court and at Pittsburgh the CIO has started legal action seeking at least \$120,000,000 for 120,000 steel workers.

Suits seeking \$36,000,000 in behalf of 4,500 workers were filed in four Midwest cities Friday.

The suits filed Friday, as in previous petitions, said the wages and damages should be paid by employers under terms of the act for the time employees spent on company premises before their scheduled starting time and after their quitting times.

Of the suits filed Friday the largest amount sought was by the CIO United Steel Workers at Springfield, Ill. on behalf of 3,000 workers. In two separate suits against the General Steel Castings Corp. and the National Enameling and Stamping Co., of Granite City, Ill. the union asked \$30,000,000.

Other suits were filed at St. Louis by the U.S.W. for \$12,000,000 from the Laclede Steel Company on behalf of 1,500 employees; at Chicago by the U.S.W. for \$8,000,000 from the Ford Motor Company on behalf of 2,000 employees; and at South Bend, Ind. by the CIO United Farm Equipment Workers for \$6,000,000 from the Oliver Corporation on behalf of 2,000 employees at plants at South Bend, Shelbyville, Ind., and Charles City, Ia.

New York, Dec. 21.—(AP)—Delegates to the United Nations atomic energy commission disagreed today over whether they had approved a U. S. proposal to eliminate the veto power on punishment for violations of atomic energy control.

This was a major point in the American atomic control plan that was approved in principle yesterday by the commission, and it appeared at first that the controversial issue had been decided finally—although without the approval of Soviet Russia.

BONUS IS GIFT FOR EMPLOYEES

Pottery Plant Owner Gives \$705,686 In Christmas Checks

Chicago, Dec. 21.—(AP)—This village of 1,400 was a potential "boom town" today as \$712,000,000 in Christmas bonus checks from their boss, L. P. Reese, a relief recipient 14 years ago.

The Solo bank was ready for a rush of business, and cashier William Hughes observed happily: "This will play the dickens with the noise at our bank."

The money was handed out at a pre-holiday surprise party last night.

Interviews with many who received the maximum bonus of \$3,500 indicated that much of the money would be used to pay debts, increase savings and buy bonds.

The 33-year-old Reese, who was penniless in 1932 when he began building an abandoned pottery into a \$3,000,000 plant explained his gifts thus: "I've got all the money I need, and my ambition is to keep my employees the highest paid pottery workers in the world."

Divers To Seek Sunken Vessels

Jacksonville, Fla., Dec. 21.—(AP)—The Coast Guard planned to send divers today on an underwater search of two sunken tugs in an effort to find the bodies of five crew members missing since the vessels crashed into a jetty and sank near the mouth of the St. Johns River.

One body, as yet unidentified, was recovered yesterday and a seventh member of the crew was rescued. The sole survivor, Luther Brown, Durham, N. C. remained in the Coast Guard dispensary at Mayport undergoing treatment for exposure and shock.

The one body recovered was found near Mayport, a considerable distance from the scene of the disaster.

Talmadge Of Georgia Dies; Arnall May Remain As Gov.

Governor - Elect Succumbs; Georgia Law Permits Arnall To Stay In Office For Two Years; "Old Gene's" Death Ends Stormy Political Career

Atlanta, Dec. 21.—(AP)—Eugene Talmadge, who four times was elected governor of Georgia, died today less than a month before his scheduled fourth inauguration.

The 62-year-old champion of white supremacy succumbed quietly at Piedmont Hospital where he had lain in a coma since last night.

His death left in doubt the successor to the governorship from which youthful Ellis Arnall ousted him four years ago. Unofficial legal sources said however that Arnall was prevented from seeking a second term under a new state constitution, might remain in office at least until the next general election two years hence.

There is no precedent in the state, but the constitution provides the governor shall remain in office until his successor is qualified and elected. The legislature which meets in January formally elects the governor.

Talmadge's death was announced simply by a physician who stepped from the governor elect's room and announced: "He died at seven o'clock."

Talmadge first was stricken with a stomach hemorrhage in Jacksonville, Fla., Oct. 4, and twice he was pronounced better and dismissed from the hospital. He entered the hospital for the last time Nov. 23 and had been improving until last Sunday when he suffered a relapse.

Two days ago his physicians said he was suffering with an acute inflammation of the liver cells possibly caused by the administration of plasma and pronounced his condition critical. He had received much blood by transfusion since the first hemorrhages.

Members of the Talmadge family, including his wife, son and campaign manager, Herman, and two daughters, Mrs. Bill Kimbrough and Mrs. Charles Smyly, were near his bedside when the governor-elect died.

Talmadge's death ended an up and down political career in Georgia. His first success was in 1927 when he was named State Commissioner of Agriculture. In 1933 he was elected governor, serving two two-year terms until 1937. He lost a bitter battle for the U. S. Senate to Richard B. Russell in 1936, and aged 58, he was in the race against Senator Walter George. That was the race when the late President Roosevelt backed Lawrence Camp in his purge campaign, George won.

Talmadge emerged from political retirement in 1940 again to become governor, but two years later, after a heated campaign, he lost to Ellis Arnall.

When Arnall was prevented under a new state constitution from seeking reelection, Talmadge emerged again under his old banner of white supremacy, and was elected under the state county unit system despite the fact that James V. Carmichael, who had Arnall's backing, took the popular vote.

DEWEY RAPPED FOR ACTIVITY

Told To Keep Hands Off House Leadership Contest

Washington, Dec. 21.—(AP)—The first serious rift in Republican ranks since the party won the congressional elections broke in an open today with a demand that presidential candidates keep hands off the House leadership contest.

Rep. Thomas Jenkins of Ohio objected to a formal statement "attempts to outsiders to dominate the American Congress."

He leveled his remarks primarily at Gov. Thomas E. Dewey's endorsement of Rep. Charles A. Halleck of Indiana for the House floor leadership. But he said they apply as well to "any presidential aspirant—Senator Tatt or Senator Bricker, too, although I don't think they'd try it."

Jenkins is one of three announced candidates for the leadership position to be vacated by Rep. Joseph W. Martin, Jr., of Massachusetts when he becomes Speaker of the House Jan. 3.

The others are Halleck and Rep. Everett M. Dirksen of Illinois neither of whom was in Washington when Jenkins let loose his blast at the New York governor last night.

While capitol observers long had seen the leadership struggle as a jockeying for position for the GOP presidential nomination, Jenkins was the first member of his party to label it openly as such.

ARMY FEEDING GERMAN ZONE

Reserve Stocks Issued; Food Shipments Are Inadequate

Berlin, Dec. 21.—(AP)—Germans in the American zone have been freed from reserve stocks for the last three months as food imports from the United States have run less than half of requirements, but a big increase is counted upon next month to make up deficiencies, Gen. Joseph T. McNarney, American Military Governor, said today.

The theater commander told a news conference that a local crisis in meeting the official 1,550 calories daily ration in Wuertemberg-Baden had been solved by a loan of flour and cereal from Army stocks.

McNarney said he had been informed that 300,000 tons of American food for Germany was on the seas or in process of loading and expected to arrive in the next month.

"Over the last three months," he said, "we have been getting less than half the imports needed to support the 1,550-calory ration, but we expect anticipated shipments to make up the deficiency. Meanwhile, the course of the next month to we have been using reserve stocks."

Discussing quadripartite occupation affairs, McNarney said its four elements are to submit detailed reports on occupation progress and problems from which it will make recommendations to the Foreign Ministers Council meeting in Moscow in March to discuss German peace problems.

SENATORS ASK SUITS AGAINST EDWARD TERRY

Press For Contempt And Perjury Charges; Terry Said Again Ill

Washington, Dec. 21.—(AP)—Attorneys for the Senate War Investigating Committee said today they have asked for authority to file contempt charges against Edward P. Terry, former secretary of Senator Bilbo, (D-Miss.).

The action is based on Terry's refusal to tell the committee what became of \$15,000 which he said a New Yorker gave him to use against Bilbo in the Mississippi election this year.

Committee counsel must obtain permission of Senate President Tom McMillan (D-Tenn.) and then pass the contempt complaint along to the Federal District Attorney here for presentation to a grand jury.

Penalties for contempt of the Senate range up to a year in jail and \$1,000 fine.

Chairman Mead (D-N.Y.) directed George Meader, counsel for the committee, also to push a perjury charge against Terry.

The former secretary testified he got the \$15,000 from Simon G. Silverman of New York to back any opponent who could defeat Bilbo this year.

Unable to find such an opponent, Terry said, he then was told to give the funds to anyone who opposed Bilbo in the run-off primary. But Bilbo mustered a majority over his four opponents in the first primary and there was no run-off. So, Terry said, he handed the cash back to Silverman.

Senator Ferguson declared this was impossible because Silverman died several months before Terry's bank accounts showed the money repaid. Terry said he was "confused" and declined to tell who received the funds.

A woman who identified herself as Mrs. Terry said she is ill in his apartment here, under doctor's orders to talk to no one, and has nothing more to say about the transaction.

Meanwhile the 69-year-old Bilbo, declaring he has cleared himself of all complaints about his dealings with war contractors said he will spend Christmas at his "dream-house" home near Poplarville, Miss.

Clear Weather For Christmas

Berlin, Dec. 21.—(AP)—Soviet-controlled newspapers in Berlin today hailed Prime Minister Josef Stalin on his 67th birthday as an "outstanding statesman, great scientist, philosopher, historian and economist who became the leader of all progressive forces in the historic fight against fascism."

The newspapers gave space freely in their rationed columns for long laudatory articles and numerous pictures of the Russian leader.

The Soviet news bureau reported that Foreign Minister V. M. Molotov and his deputy, Andrei V. Vishinsky, had flown to Moscow to be present for Stalin's birthday, after a brief stop here to confer with Marshal Vasily D. Sokolovsky, Soviet commander in Germany.

Walls Of Water Shatter Houses, Uproot Trees; Yawning Ebb Tide Drags Wreckage To Sea; Dazed Survivors Look For Missing

By RUSSELL BRINES Tokyo, Dec. 21.—(AP)—A great dirty arm of water swung six times at the tiny city of Kainan. When it finally withdrew, there was nothing but whimpering people looking for lost relatives amid smashed houses.

That is the picture sketched in halting telegraph messages from nearly obliterated Kainan on the smashed Wakayama peninsula. Kainan was one of dozens of communities lashed by today's tidal wave, which was felt by coastal towns 376 miles apart.

The tidal wave smashed the Kochi area of western Shikoku at least 370 miles west of Shimoda. Delayed reports may show it reached even beyond that.

"The town boiled with a dirty whirlpool," said the first reports from Kainan, in the center of one of the hardest hit areas.

As the first earth shock hit at 4:20 a. m., residents of Kainan fled, shouting and running in circles as the Japanese are of inexplicable movements of the earth.

Nothing happened for a while, so the people began returning home. Then came a great roaring as the sea. It increased until at 5:30 a. m. the first wave hit the city.

Houses along the coast collapsed and their wreckage was swept to sea.

Kainan calmed. Forty minutes later a second wave crashed upon it. The wave splintered houses, uprooted trees and swallowed all within reach.

People caught in the swirling waters climbed to rooftops. Mothers screamed for their children and children cried for help. Some clung in frozen fear and were washed away.

A boat moored in the harbor broke loose, swept in and smashed a house, then disappeared on the outgoing tide. Furniture floated in the growing waters.

The ebb tide yawned hugely dragging everything with it. Then the sea came back with a snarling roar—again and again until it had pounded the town six times. The last was at 8:20 a. m.—nearly three hours after the initial wave.

Balloonist Plans New Ascension

Washington, Dec. 21.—(AP)—Dr. Jean Piccard and a Navy pilot will try to ride a cluster of 100 balloons nearly 100,000 feet into the stratosphere next June from the naval air station at Ottumwa, Iowa.

The 19-mile ascension would be more than five miles higher than man has ever soared before.

Purpose of the attempt, the Navy said last night, will be to obtain data on the physics and chemistry of the stratosphere. The 100 balloons, each 57 feet in diameter, will carry a 400-pound gondola, the scientific equipment, Dr. Piccard and a Navy man to be named later.

Cataclysm Wreaks Death And Destruction Over 50,000 Square Miles; Early Reports Show Five Hundred Dead; Army Says No Outside Help Needed

Tokyo, Dec. 21.—(AP)—A violent earthquake—possibly the world's heaviest—and the severe tidal wave it erupted off Wakayama peninsula today wreaked death and destruction over 50,000 square miles of southern Japan.

U. S. army and Japanese sources released these preliminary reports: 500 Japanese dead. 42 Japanese and one British occupation soldier missing. 4,500 homes destroyed. 9,041 homes heavily damaged. 14,000 dwellings flooded. 500 fishing vessels destroyed.

An early estimate that probably 1,000 Japanese were killed—based on a report that 203 families in Kochi were "wiped out"—was discarded later as army and Japanese sources compiled their reports of known casualties.

Koshimoto, a fishing town of 10,000 on the southern tip of Wakayama peninsula—at the southeastern tip of Honshu—was reported washed away by seven-foot waves.

Fire destroyed one third of Shingu, on the east coast of Honshu; and U. S. army fliers said flames still were visible there this afternoon.

The temblor was recorded at 4:20 a. m. (2:20 p. m. Friday, EST) slight tremors followed about every half hour.

Damage extended from the northern coast of Kyushu through Shikoku and north to Shizuoka prefecture on Honshu. Kyoto news agency said the wrecked area extended 340 miles at its longest and 60 miles wide.

Osaka, Japan's second-largest city, reported 14 killed, heavy property damage and water three feet deep in some places.

Some famous cities of Kyoto and Nara, both former Japanese capitals near Osaka, appeared to have escaped any but minor damage. Both escaped bomb damage during the war.

The U. S. military government said Osaka has five days' food rations for 50,000 people. Large quantities of imported grain recently were released to Japanese at Kobe. Authorities said they considered the food situation good at both places.

However, U. S. military officials said it may be necessary to supply stricken areas on the Wakayama peninsula by boat because of communication disruptions.

Although concern was expressed over the situation in southern Shikoku island, army officers said no outside help would be needed.

Railroads and communications were marled, electric, telephone, telegraph and railroad lines, particularly on the northern shores of the inland sea, were cut in many places. Numerous communities were isolated.

GIs Unhurt

Tokyo, Dec. 21.—(AP)—U. S. military reports tonight said all American Army personnel in Japan's quake and tidal wave ravaged area are safe.

Only one casualty—a missing soldier—was reported from the British occupation sector, although it is near the center of the area. British headquarters at Kure was damaged.

Two allied military trains which were in the danger zone when the tragedy struck arrived at their destinations late but safely, said an Eighth Army summary.

There was some damage to Army dependent housing in Takamatsu, on the northern coast of Shikoku, where 20 Japanese were known dead.

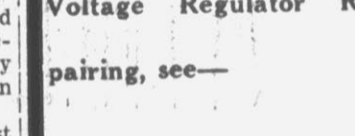

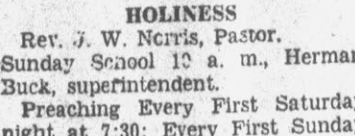

# "Sugar" Robinson Wins Welterweight Crown

New York, Dec. 21—(AP)—At long last they've crowned the uncrowned champion of the welterweights—Sugar Ray Robinson—and it happened just about in time, too, because the Sugar Man isn't nearly so sweet in the sweat department now as he was once.

Those five years of waiting—during which the uptown beanpole had 75 fights, won 73, lost one (to a middleweight) and tied another—apparently took something out of the Sugar Man that he isn't going to get back, like losing the last pot of the night in a seven-card stud game.

He showed against Tommy that some of the fire has gone out. This isn't taking a thing away from Tommy the Thumper, mind you, because the T-shouldered swatter out of Youngstown, Ohio, was a fancy fighting man in there last night, and a crowd of 15,670 customers who chipped in to a pot of \$82,948 liked him. Some even booed the decision, although it was unanimous and the Associated Press score card made it 8 rounds for Ray, 5 for Tommy and 2 even.

Bell laid an assortment of large left hooks on Sugar Ray's whiskers that did the Harlem hammer no good at all. And one of them even dumped Robinson right on his pretty pants for a long, long seven-count in the second round which took years off the lives of the chalk players who liked Ray at 1 to 5 on the board. And after Tommy himself hit the deck in the 11th and had lumps raised on him in the 12th as Robinson tried to put the squeezer over, the Ohio hot-shot came charging right back to take the 13th and 14th.

For five years Ray had been the "uncrowned champion of the welterweights," and, with a bow in

the direction of Joe Louis, a lot of the wise-boy beachcomers along Jacobs Beach have been tabbing him as the greatest fighter, pound for pound and inch for inch, mashing noses today.

## AUSSIES RAP U. S. NETTERS

### Protest Exhibition Games; Pate Backs Players' Actions

Melbourne, Dec. 19—(AP)—Opposition by Australian tennis officials to American Davis Cup squad members playing in exhibitions in this country after the cup matches brought the somewhat heated declaration from Walter L. Pate, non-playing captain, today that he had no intention of trying to dictate to his boys.

"As long as they obey the rules of tennis and don't receive money for playing, they can do anything they please as far as I'm concerned," Pate said.

"Three of them, Billy Talbert, Garciar Mulloy and Tom Brown have agreed to play in the championships at Sydney Jan. 17," he added. "What they do in the meantime is their business."

What threatens to develop into an awkward controversy arose when officials of the Australian Lawn Tennis Association learned the Americans had agreed to play several exhibitions in small "bush" towns. These were arranged by sporting goods firms and no effort was made to obtain approval, either from the Victorian Lawn Tennis Association or the ALTA.

A committee headed by Sir Norman Brooks, president of the ALTA, protested to Pate yesterday but apparently gained no satisfaction from the American captain.

Pate today said he heatedly objected to Brooks' suggestion that Brown should play in the tournament at Adelaide the week of Jan. 4 rather than in a smaller meeting

Government reinforcements rushed into action as two Communist regiments closed within less than a mile of Huangtun, which is 11 miles southeast of Peiping and very near the south airfield. Other Communists closed in on Weishangchung, two miles further southeast.

### Koreans Damage Premier's Home

Tokyo, Dec. 20—(AP)—Twelve Japanese policemen and several Koreans were injured today in a free for all fight at Premier Yoshida's official residence as an estimated 2,000 Koreans forced their way through a police cordon. Loots and windows were smashed. The Koreans, charging discrimination, demanded that the government "protect the livelihood of Koreans." After a mass meeting, the crowd—men, women and children—had marched to Yoshida's home.

### Cage Tournament Is Family "Feud"

Wilson, N. C., Dec. 21—(AP)—Feudin' families will exchange shootin' irons for iron rings and basketballs here next week as mom, pop and the young'uns take to the hardwoods in the national family basketball tournament.

Fourteen clans have promised to be on hand come next Thursday for the postwar renewal of the tournament, billed as the only event of its kind in the country. The show will run for three days and nights at the Atlantic Christian College gym.

All it takes to enter is a bit athletic family willing to pay all its expenses. As long as the players are immediately related neither sex makes any difference. Everybody from grandpa to junior is eligible.

The six Loftis brothers from Durham won the 1941 title and they'll be back to defend it. Their most serious competition—and the competition is the only serious thing about this whole affair—will stem from the Henson brothers of Snow Hill, runners-up in 1941.

serve with the game.

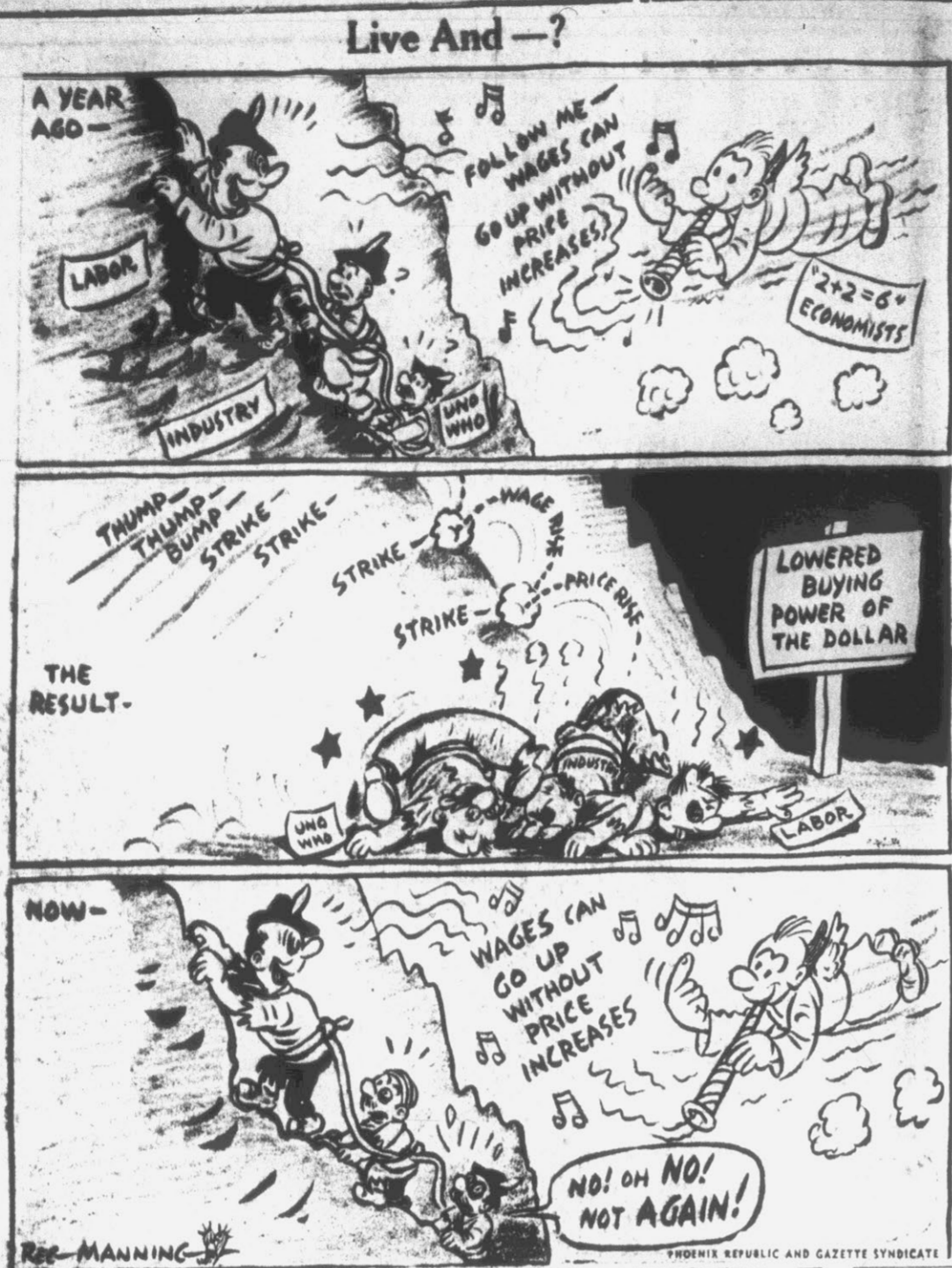
"Chestnut puree is very, very

## TAFT FEARFUL OF RECESSION

Washington, December 20—(AP)—  
Senator Taft (R-Ohio) today called

The children of the second grade are glad to have Jesse Tripp back again. He had to stop school last year because of his eyes and hasn't been able to come but a few days this year.

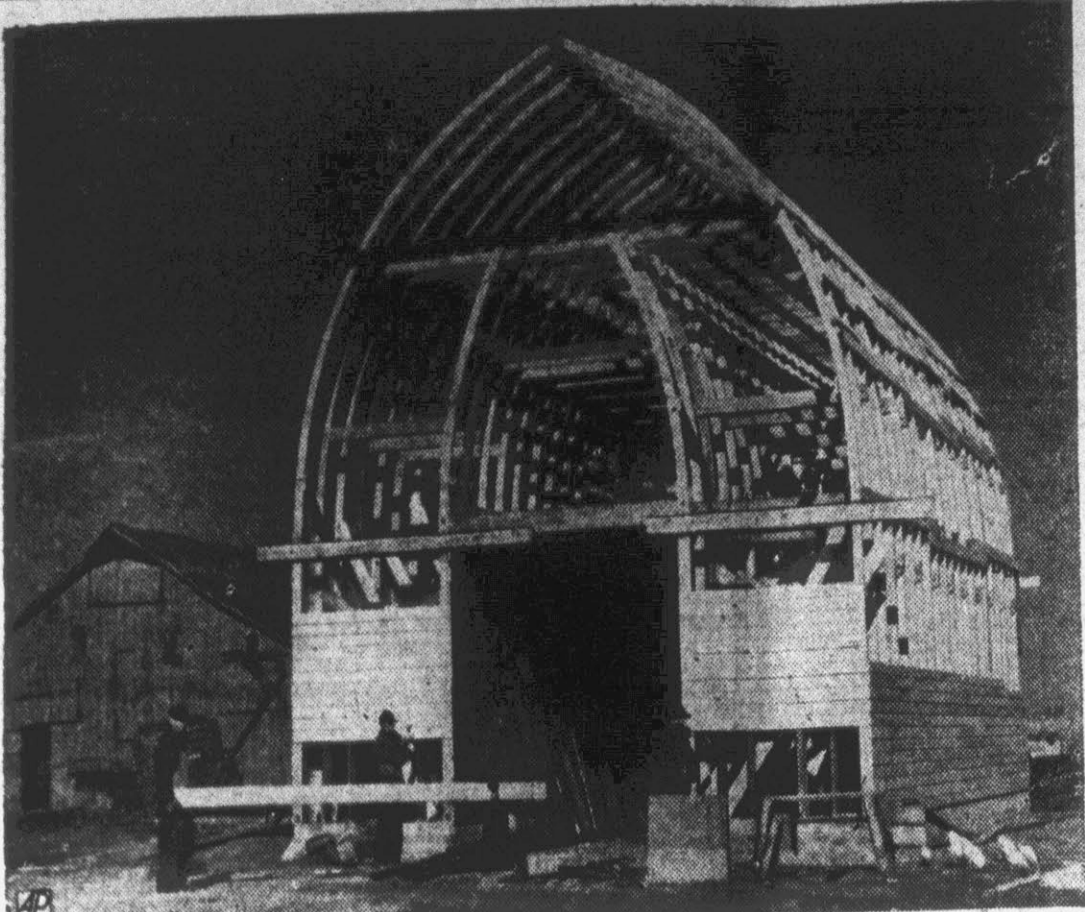
The interests of the children are now about Christmas. They have decorated their rooms and are making presents. The Christmas party to which everyone is looking forward will be Friday morning.
