

## TASS CRITICAL TIES BETWEEN U.S. - BRITAIN

### Official Russian News Agency Questions Attitude On Alliance

London, Jan. 28.—(AP)—Tass, the official Russian news agency, urged Britain today to live up to the spirit of her treaty of alliance with the Soviet Union and at the same time criticized Britain's close ties with the United States.

"One cannot say that British policy towards the U.S.S.R. conforms to the principles and demands of the treaty of alliance," Tass declared a few hours after Soviet Ambassador Georgi Zarubin held a long conference with Foreign Secretary Ernest Bevin, presumably about Prime Minister Stalin's complaints concerning "reservations which weaken" the 20-year friendship pact.

"Actually there are no few occasions when Britain and the United States have come out in a bloc against the Soviet Union," the news agency added.

"Britain has not formally concluded a treaty of alliance with the United States; nevertheless no one can doubt the existence of intimate relations between Britain and the United States, which in fact has assumed the character of a military alliance."

"The time has come to stand by the spirit of the treaty, particularly by that part according to which both countries undertook to work jointly for the organization of the security and economic prosperity of Europe," Tass said.

The Soviet news agency also called attention to a recent article in the Communist Daily Worker of London, which it quoted as saying that British-Soviet relations were in a "most unsatisfactory state" and that the friendship treaty, signed in 1942, "might just as well not exist for all the meaning it has at the present moment."

## Schwollenbach Opposes Most Pending Labor Bill Proposals

Washington, Jan. 28.—(AP)—Secretary of Labor Clegg urged today to approve President Truman's proposal for creation of a commission to study labor laws, but criticized most other pending bills designed to iron out labor-management trouble.

He told the Senate Labor Committee the trouble is that "the art of collective bargaining has been forgotten." Given a reasonable opportunity, management and labor

can "re-learn" the process and work out their problems between themselves, he said.

Schwollenbach struck out directly at one bill introduced by Senator Ball (R-Minn.) to outlaw industry-wide collective bargaining. But the secretary's prepared testimony took no notice of another Ball measure—one that would permit the firing of strikers.

It was introduced only yesterday and drew from Senator Elbert

Thomas (D-Utah) the description "most reactionary."

Both Ball and Thomas are members of the Labor Committee.

Turning to the sheaf of legislation before the group, Schwollenbach in his advance text:

1. Declared that creation of a mediation board, either inside or outside the Department of Labor would "impede industrial peace rather than further it."

2. Opposed abolition of the Labor Department's Conciliation Service.

3. Said it would be "a serious blow" to the Bureau of Labor Statistics to force it to make public all agreements and arbitrations awards which have been obtained through the voluntary cooperation of employers.

4. Opposed elimination of the check-off system of collecting union dues through payroll deductions. ("There is nothing immoral about it," Schwollenbach said.)

5. Declared supervisory employees are entitled to organize and bargain collectively, provided that they do not belong to the same union as production employees, or a union dominated by such production employees.

6. Criticized the language of a proposal to make it easier to sue unions.

7. Urged that a provision to outlaw secondary boycotts be modified in line with President Truman's recommendations to exempt boycotts intended to protect wages and working conditions.)

8. Asked for safeguards in a proposal requiring registration of labor organizations so as not to force creation of a new bureau in the Labor Department to handle them.

9. Declared that a substantial advance in industrial relations would be "destroyed" by enactment of legislation outlawing the closed shop, union shop and maintenance of union membership.

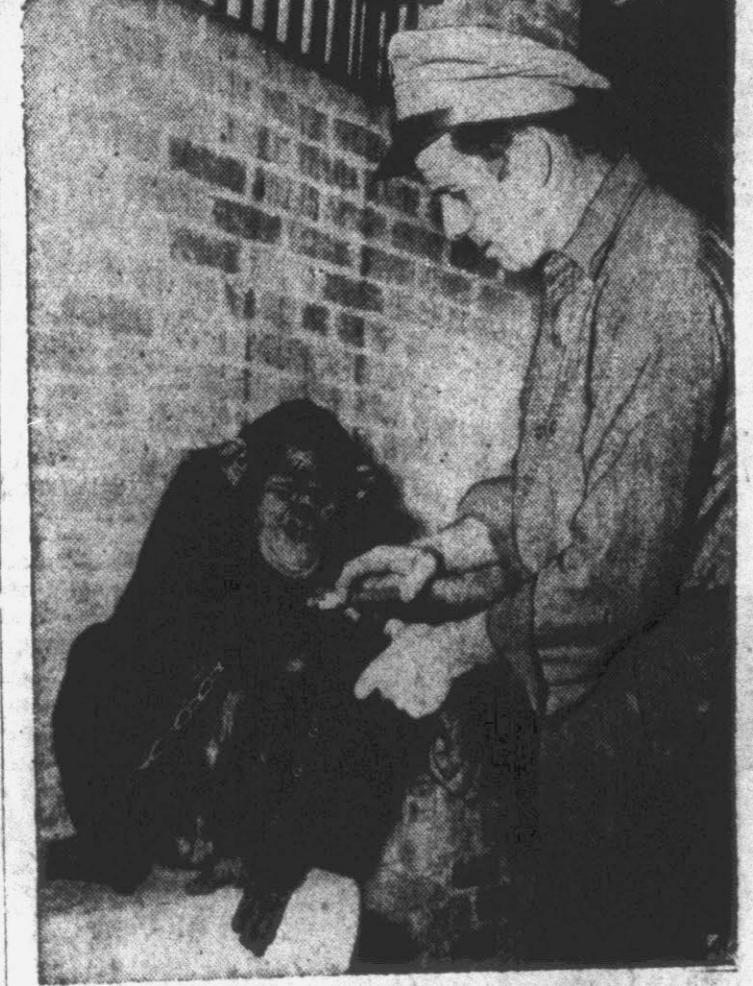
10. Opposed Ball's bill to ban industry-wide collective bargaining.

Schwollenbach said the bill assumes that local unions and local membership would be less anxious to have a strike than the heads of international organizations and that individual employers would be less anxious to have a strike than a group of employers organized together.

"My experience of this last year and a half has convinced me that that simply is not so," Schwollenbach said.

"Despite the difficulties inherent for labor and management in re-learning the free collective bargaining process," he said, "it may be asserted safely that progress is being re-learned and that the number of stoppages in 1947 will be drastically reduced from the number that occurred in 1946."

## Taxicab Bandit Is Under Arrest

Durham, N. C., Jan. 28.—(AP)—A man identified by police as William B. Hilton, 38, of Wake Forest, Route 1, was arrested here shortly after midnight in connection with the robbery and shooting of a Franklin taxicab driver on the Durham-Wake Forest road last night.

Police said that Hilton was arrested after the cab stolen at the time of the robbery, and which he allegedly was driving at a high rate of speed overturned at a street intersection here at 12:01 a. m.

Eyewitnesses were quoted by police as saying that Hilton jumped out of the cab after it turned over on its side in attempting to round the corner, ran to a nearby filling station, where he hid a pistol, and then returned to the scene of the accident. Police later recovered the pistol.

## Engine Trouble Fatal For B-29

Albuquerque, N. M., Jan. 28.—(AP)—Engine trouble was officially advanced today as the likely cause of a B-29 Superfortress crash which carried 11 men to fiery deaths at the Army's Kirkland Field.

Laden with secret equipment, the big ship wavered on the takeoff climbed no more than 200 feet and crashed and burned in a narrow gully yesterday just south of the field's mile and a half-long main runway.

One member of the 12-man crew survived, rescued by a pair of GI firefighters.

Officers said soldier's medal citations were being considered for the crewmen. Risking an explosion, they also pulled another crewman out but he died soon afterward.

## Senate Atom Group Would Define Roles

### Want Clear Definition Of Congressional And Military Rights In Passing On New Atomic Commission

Washington, Jan. 28.—(AP)—The Senate atomic committee sought today to define explicitly the right of Congress and the armed services to know what is going on inside the new atomic control commission.

Chairman Hickenlooper (R-Iowa) told a reporter he expects this definition to be spelled out in no uncertain terms before the committee gets through questioning David E. Lillenthal, Lillenthal named as chairman of the commission, is serving under a recess appointment.

Similarly, Senator Knowland (R-Calif.) said in a separate interview he believes that now is the time to find out whether Congress and the armed forces are going to know at all times what the commission is considering or whether they are going to be told afterward that something is an accomplished fact.

Recalled to the stand today, Lillenthal faced not only questioning on this point but a barrage attack from his long-time political enemy Senator McKellar (D-Tenn.).

McKellar is not a committee member but is commuting between the atomic hearing and inquiries into the nomination of Gordon R. Clapp to be a TVA director, which he also opposes.

McKellar told Lillenthal, former TVA chairman, at yesterday's atom hearing.

## Pay Suits Clarified

### An Analyst Reviews The Argument Over Portal-to-Portal Pay; A Simplified Summary Of Past Events And Current Moves; Actions Being Taken

Washington, Jan. 28.—(AP)—If you're in a fog now over the details of the portal-to-portal pay argument, maybe this will bring you up to date.

It has become one of the great legal problems in American history, and there have been important moves in the past week or so.

First, in order to understand those moves and what may follow, here is a brief history:

About five years ago the workers in a pottery company at Mt. Clemens, Mich., sued the firm in Federal Court for overtime.

Under federal law, since the company was in interstate commerce, the workers were entitled to overtime for all time worked over 40 hours.

They said they worked more than 50 hours a week because they'd been told to be in the plant ahead

## STEEL - UNION ISSUES DRAWN

### U.S. Steel Bids For "Open Shop" In Contract Negotiations

Pittsburgh, Jan. 28.—(AP)—Cards were on the table today with open shop vs. union shop one of the main issues as U.S. Steel and the CIO-Steelworkers Union worked to forge a 1947 wage and hour contract affecting 175,000.

The union, operating under a maintenance of membership agreement, imposed about three years ago in a War Labor Board directive, seeks a union shop. This now means all workers must join the union within a specified time limit.

Big Steel—actually the five subsidiary companies of the U. S. Steel Corp.—has demanded an agreement that permits any employee to decide for himself whether he wants to be a member of the union.

The present or maintenance of membership agreement provides that once an employee has joined the union he must remain a member during the life of the company-union contract. The current pact expires April 30.

Union officials did not comment on the company's demand for what amounts to an open shop.

### Suits May Clarify Which Of Claimants Is State Governor

Atlanta, Jan. 28.—(AP)—Two additional suits have been filed in superior courts to determine which of two claimants is Georgia's governor.

Both suits, petitions for writs of mandamus involving the handling of state funds, have been set for hearings Feb. 6.

In the first of the new suits filed yesterday in Fulton Superior Court, attorneys for Herman Talmadge asked State Treasurer George B. Hamilton to show cause why he should not accept revenue collections from Talmadge-appointed Revenue Commissioner Charles D. Redwine.

The second suit filed in Laurens County Superior Court to compel Attorney General Eugene Cook to show cause why he should not

## Legion's Chief Talks In Durham

Durham, N. C., Jan. 28.—(AP)—A resolution calling for "adequate support for the public school system of the state" was adopted at yesterday's closing sessions of the two-day post officers' conference of the North Carolina Department of the American Legion and Legion Auxiliary.

National Commander Paul H. Griffith, making the same address to four different conference groups during the day, declared that "the American Legion has fought and will continue to fight for the preservation of the American way of life and the only 'ism' it recognizes is Americanism."

Griffith was accompanied by Mrs. Norton H. Pearl, National President of the Legion's Auxiliary, and other high Legion officials.

Griffith, who was introduced by Governor Cherry, reviewed the Legion's activities in attempting to alleviate the housing shortage as it affects veterans.

## UN POSTPONES DEBATING OF ALBANIA CASE

### Give Balkan Nation Time To Send Representative To Deny Charges

Lake Success, N. Y., Jan. 28.—(AP)—The United Nations Security Council today postponed the opening of debate on Great Britain's complaint against Albania after the Balkan nation had asked for time to get a representative here to deny the charges of mining territorial waters.

The British, who accuse Albania of laying mines which damaged two Royal Navy destroyers with a loss of 44 lives last Oct. 22 in Cerin Channel, agreed to the delay on condition that the U.N. ask the Tirana government to set a definite date for arrival of its envoy.

The date of the next meeting was left to Norman I. O. Makin of Australia, council chairman, who was empowered to make immediate inquiries of the Albanian government.

This procedure was adopted after Russia and Poland strongly opposed a meeting next Friday as suggested by Makin.

Albanian Premier Enver Hoxha called the U.S. Secretariat last Friday that he had appointed Hysni Kapp as his representative and that Kapp and his assistants would "soon depart, but owing to great difficulties of communications it is impossible to fix the date of his arrival in New York."

Until receipt of that communication, Sir Alexander Cadogan, the chief British delegate, had intended

## ASK POWER TO STUDY POLICY

### House Committee Would Investigate U.S. Foreign Affairs

Washington, Jan. 28.—(AP)—The House foreign affairs committee today asked for sweeping powers to investigate American diplomatic policies and to study the international organizations in which this country takes part.

In its first action since the republicans took control of Congress, the committee coupled with its formal request a pledge of cooperation "in the formulation and execution of a bi-partisan foreign policy."

A committee resolution asked the House for the right to:

1. Make a detailed study of the State Department, its organization personnel and policies;

2. Review the execution of laws affecting the relations of the U. S. with foreign nations generally;

3. Study the international organizations of which the U. S. is a member;

4. Invite Gen. George Marshall new secretary of state, to cooperate with the committee and to furnish a necessary information as to the organizations and policies of the department and international agreements to which the U. S. is a party.

## Founder of Rotary Clubs Died Monday

Chicago, Jan. 28.—(AP)—Paul P. Harris, who in 1905 organized the first Rotary Club and whose work in the organization which became world-wide won him numerous honors from citizens and governments, died last night after a long illness. Harris, a Chicago lawyer, was 78.

## Jewish Underground Releases One Of Two Britons Held As Hostages

Jerusalem, Jan. 28.—(AP)—The Jewish Agency announced tonight that it had learned that one of the two Britons held as hostages by an underground agency had been released.

The agency said H.A.I. Collins, British banker, had been set free somewhere in the Jerusalem area but that no other details were available. Police were scouring the roads searching for him.

Earlier, advices from Tel Aviv said a note was delivered to Hebrew newspapers, apparently from the underground organization Irgun Zvai Leumi, saying that the two Britons held against the execution of an Irgun member would be freed "within hours."

Police said the kidnapers sought to force a commutation of the death sentence of Dov Bela Gruner, Irgun member condemned for participating in an attack on a police station.

The other Briton is Judge Ralph Wyndham of Tel Aviv's district court.

The Jewish Agency executive earlier today demanded "the release, immediate and unconditional"

of Wyndham and Collins.

The judge was seized in his Tel Aviv courtroom yesterday by armed men officially described as members of the Jewish underground.

British troops were coming Tel Aviv systematically for him. Collins was kidnapped here Sunday.

## Ohioan Proposes Sharp Slash In U.S. Spending

### Will Offer Legislation To Cut Normal Government Function Costs Below 1932 Outlay; Budget Discussion Called

Washington, Jan. 28.—(AP)—Rep. Bender (R-Ohio), proposed today that Congress slash spending for normal government functions 25 per cent below the 1932 outlay.

"I want to do what President Roosevelt promised to do in his first campaign for president," Bender told reporters as he announced that he is preparing legislation to carry out this latest economy suggestion.

Bender did not make clear immediately how much of a saving his proposal might effect if adopted.

Total government spending in 1932 amounted to \$4,948,000,000. But of that amount only \$2,641,000,000 is listed under civil and miscellaneous expenditures—that is exclusive of defense, pensions and interest on the debt.

President Truman's \$37,500,000,000 budget for next year includes only \$1,427,000,000 for general government but some \$13,700,000,000 is allotted for items other than defense, veterans and the debt.

The Ohioan's proposal came in the midst of these fiscal developments on Capitol Hill:

1. The Senate-House budget subcommittee was called to its first business session today with Republicans prepared to launch formally a legislative attack on President Truman's spending program.

Rep. Cannon (D-Mo.), House Democratic leader on fiscal legislation, said he will cooperate in cutting the budget so long as the reductions do not militate against the efficiency of government.

3. Chairman Knutson (R-Minn.) of the House ways and means committee, introduced a bill to prohibit workers from recovering back wages under portal to portal pay suits.

4. Plans were completed for the House to vote tomorrow on the first bill to reach the floor of either chamber this session—a measure freezing excise taxes at their wartime rates.

Engineer N. J. Lamartine, 61, of Richmond, Ind., said of the crash which spread cars the length of this town of 800:

## Burma Promised Own Government

London, Jan. 28.—(AP)—The British government announced today it had reached an agreement with Burma that will permit the Asiatic Crown Colony to attain independence.

Lord Patrick-Lawrence, secretary of state for India and Burma, said that an interim government similar to that established for India would administer affairs during the transitional period for the 262,000-square-mile region had its 17,000,000 inhabitants.

Burma lies just east of India. It was a battleground in the war against Japan.

Lord Patrick-Lawrence announced the accord in the House of Lords. He said a constituent assembly made up entirely of Burmese members would be elected next April.

## SUGAR THEFT EARNS WARREN PRISON TERM

### Virginian And Truck Driver To Appeal To Supreme Court; Bonds Set

In Superior Court today Judge John J. Burney of Wilmington gave sentences in State Prison to Sam Warren of Hickory, Va., and four of his henchmen in a "black market" sugar ring, who were convicted yesterday of conspiracy to rob the Ayden Pickle Factory in Ayden of 10,000 pounds of sugar last October 4.

There were three issues in the bill of indictment: Conspiracy to commit robbery, larceny of the sugar, and receiving stolen goods.

The jury returned the verdicts shortly after it was given the case yesterday afternoon.

Warren was given from five to seven years in State Prison for conspiracy to commit robbery, five to seven years for larceny of the sugar, and three to five years for receiving stolen goods.

Warren gave notice of appeal to the Supreme Court. Bond was fixed at \$5,000. He provided bond and was released from custody.

Johnny C. McLawhorn, truck driver, of near Ayden, was given three to five years for conspiracy and three to five years for larceny. He was not guilty of receiving stolen goods. McLawhorn gave notice of appeal and bond was fixed at \$3,500.

John Goode of Princess Anne County, Va., was given three to five years for conspiracy and three to five years for larceny. He was not guilty of receiving stolen goods.

Warren's, McLawhorn's and Goode's sentences are to run concurrently.

Raymond Jarvis of Princess Anne County, Va., was given four to five years for conspiracy to commit robbery.

N. H. Loftin of Egan, the plant watchman at the Ayden pickle factory, was given from 18 to 24 months.

The sugar robbery trial attracted considerable public interest. Judge Burney in rendering his judgments pointed out that all of the defendants except Loftin had court records.

A dramatic touch was given to the proceedings when sentences were about to be pronounced when Warren's wife stood up among the spectators and asked permission to make a statement. She told the court that she had in her possession a letter written by N. H. Loftin of Ayden to her husband stating that he (Loftin) had "something down here that Warren might want to buy," and that Loftin was the instigator of the robbery.

When the Ayden pickle factory was robbed of one hundred 100-pound bags of sugar, Loftin, night watchman at the plant, reported

## Steelman Orders Controls Lifted

Washington, Jan. 28.—(AP)—Price controls over domestic and imported blackstrap and beet final molasses will be revoked at midnight tonight.

John R. Steelman, presidential assistant, made the announcement. He also announced "all allocation controls over domestically produced blackstrap and beet final molasses will be lifted."

Steelman said that the allocation controls over imported blackstrap molasses will remain in effect through Feb. 28, or "until five tanker loads already scheduled for delivery during that month have been sold."

Two of the five tanker loads have been allocated to producers of cattle feed and the other three to producers of ethyl and butyl alcohol. The White House announcement said.

## Moscow Conference

German And Austrian Peace Treaties More Than Writing Terms For Defeated Nations, But Will Represent Treaties Among Big Four Themselves

The most difficult task which the Big Four foreign ministers have been called upon to handle is that which they will face when they meet in Moscow March 10 to frame the German and Austrian peace treaties.

Those treaties, especially the German, are the documents upon which in the main depends the peace and rehabilitation of Europe. But they are much more than that in effect they will represent treaties among the Big Four themselves—treaties which will bring peace only if they help adjust the differences now existing between Russia and the Western democracies.

So far as concerns the mighty Europe which twice tried to conquer Europe within a generation, she is well and truly smashed—at least physically, though there are

many Germans who aren't beaten mentally yet. War-mongering Prussia, militaristic heart of the old Reich, has ceased to exist as a state. Henry Parkman, chief affairs chief of the American Military Government, recently remarked:

"All we have to do is tell the foreign ministers next March 10 about an accomplished fact. Prussia is more busted up than humpy-dumpy."

This means that Germany (and Austria) will have to take what is laid on the line for them. Still, the matter isn't as simple as all that. As remarked in yesterday's column, these strategically situated countries loom large in the security calculations of both Eastern and Western Europe. Germany and Austria are the no-man's land between East and West, or perhaps it would

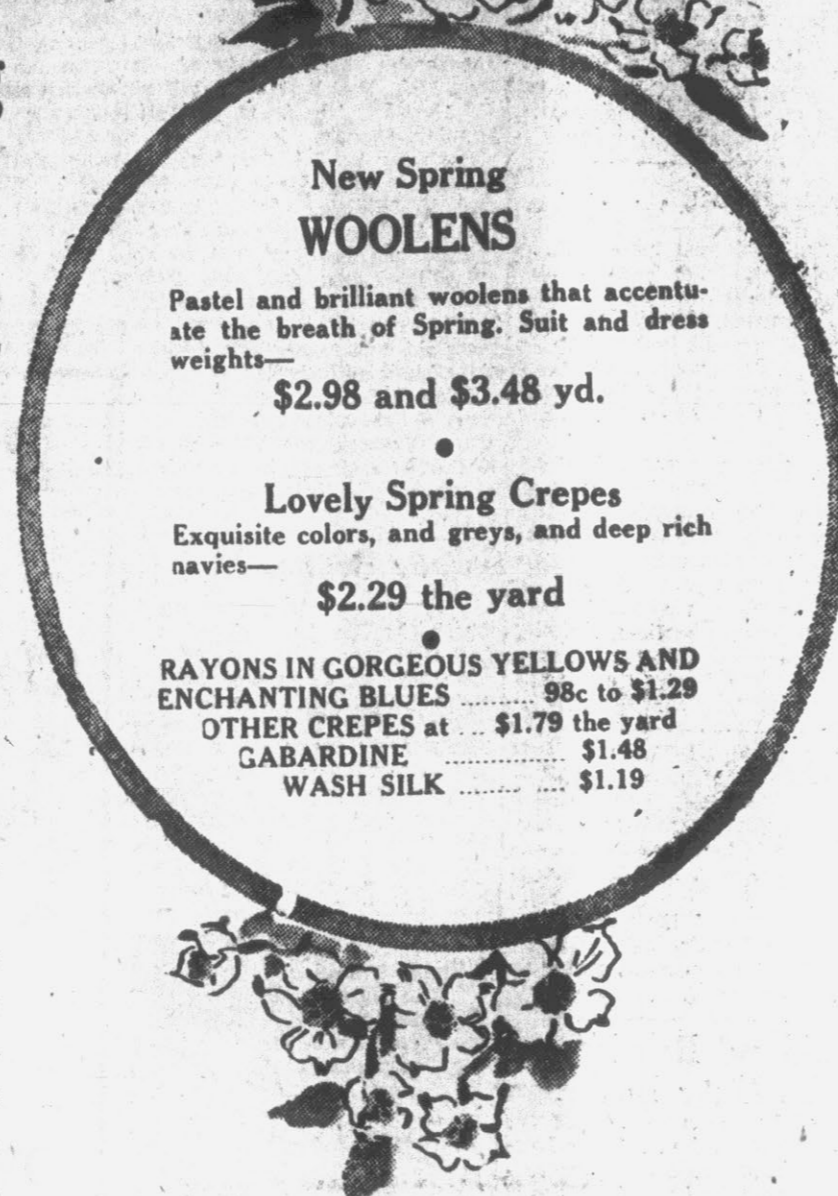

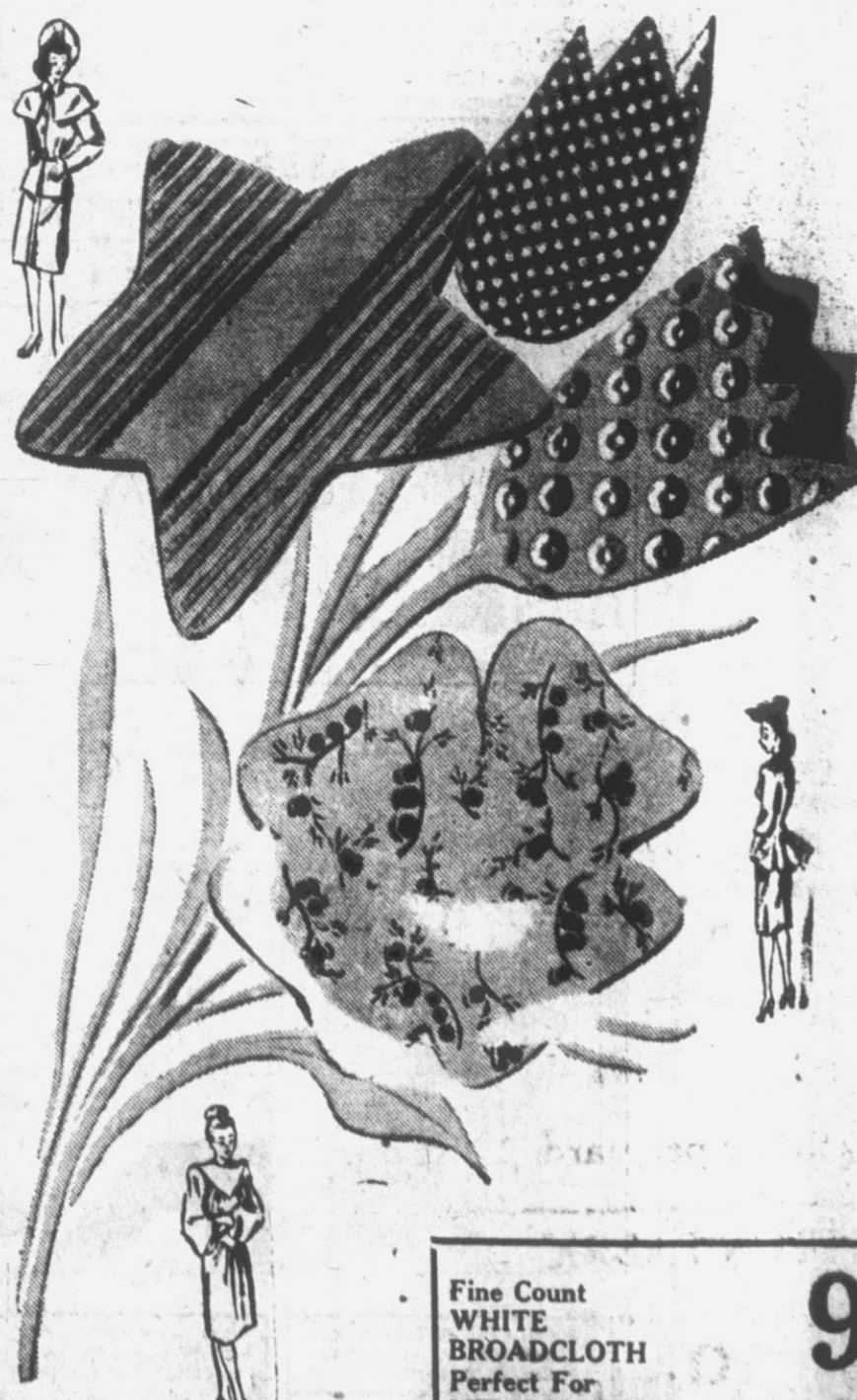

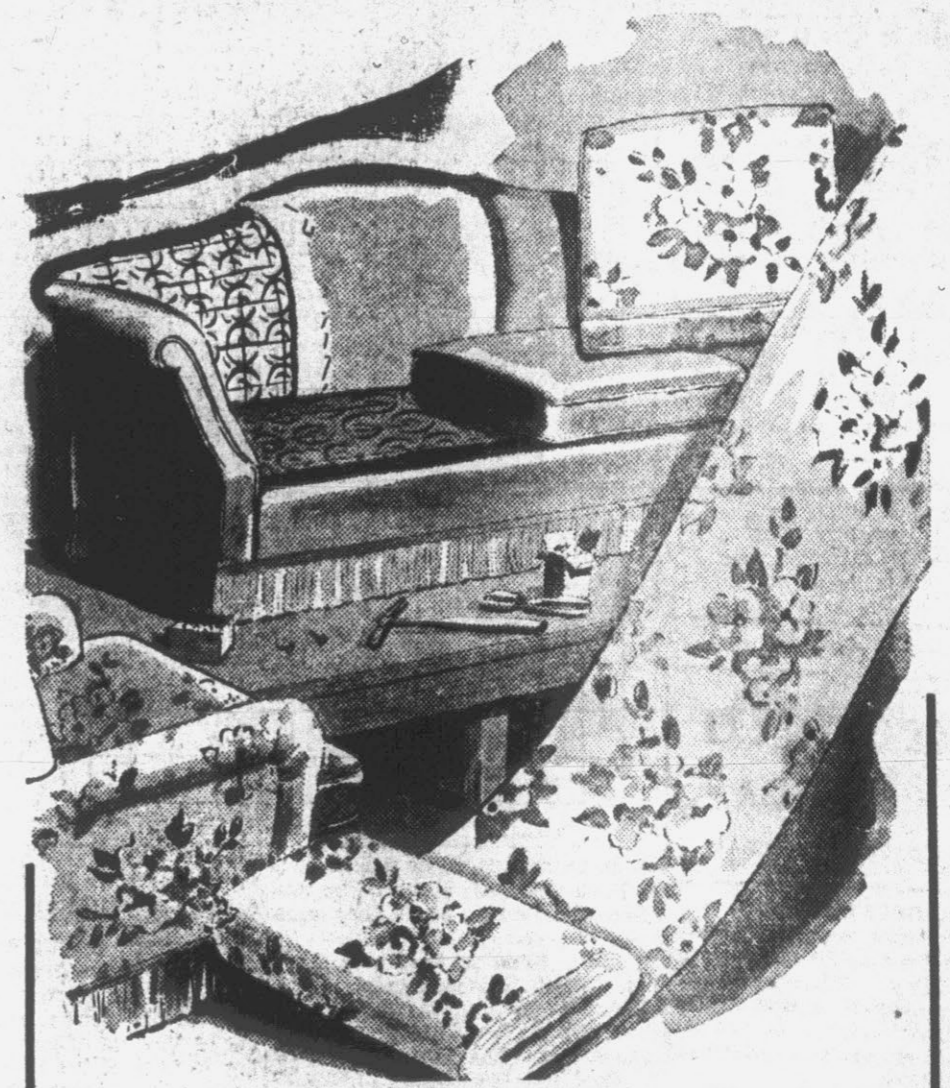

## Strength FOR THE DAY

By EARL L. DOUGLAS

### A GREAT SERMON

Not in many years have I heard  
such a sermon as the one preached  
recently in the Princeton Univer-  
sity chapel by Emil Brunner, the  
great Swiss theologian. It was part  
of the bicentennial celebration of  
the university.

Brunner said in substance: "I  
naturally felt that on an occasion  
such as this I should speak about  
the condition of the world in these  
days, the vista which opens before  
us in the atomic age, about world  
peace, and the place of the Church  
in the affairs of men. Then sud-  
denly St. Paul tapped me on the  
shoulder and said, 'You fool; preach  
the gospel. Nothing can be so ade-  
quate as that.'"

Then Brunner  
went on to speak about the reality  
of eternal life and the necessity for  
the forgiveness of sins. The point  
of his sermon was that better world  
conditions depend upon the spiri-  
tual health of individuals and that  
human destiny is settled at the foot  
of the cross, where sinful and des-  
pairing man meets sovereign God.

The sermon was simplicity itself.  
It was delivered with no oratory and  
was delivered by a man for whom  
English is not his native language.  
But the sermon set forth the gospel  
as human souls need it in every  
generation. And everyone felt that  
the sermon had about it an imme-  
asurable significance because it  
dealt with the most important  
problem in the world.

be more accurate to say everyman's  
land, since neither party is pre-  
pared to give ground to the other  
in this protective belt.

That is due to suspicions which  
exist on both sides of the barrier.  
Those doubts will not be removed  
until the great issues of disarmament  
and control of atomic energy have  
been disposed of and general  
security is assured.

Thus the forthcoming conference  
in Moscow is in reality a peace  
parley among the great powers.  
What happens to Germany is, of  
course, a momentous question—but  
it is secondary to what happens to  
relations among the Big Four upon  
whom the peace of the world large-  
ly depends.

The whole vast problem of the  
rearrangement of power in Europe is  
bound to come up, directly or in-  
directly, at that conference. Com-  
plex political, economic and mili-  
tary questions will have to be dealt  
with. And while the German treaty  
will provide the basis for their dis-  
cussion, still by and large they will  
represent the differences among the  
Big Four themselves.

Because of these extraordinary  
conditions it would seem to be a  
happy circumstance that the new  
American Secretary of State not  
only is a diplomat but is a great  
soldier—one of the notable strate-  
gists of history. General Marshall's  
skill should be most useful in help-  
ing solve the complicated issues in-  
volved.

Clemens workers would stretch  
back over five years. It would be  
overtime back-pay.

The Mt. Clemens workers were  
members of a CIO union.  
A bunch of other CIO unions  
then saw a chance—as a result of  
the Supreme Court decision—to  
get some overtime back-pay on  
portal-to-portal grounds.

So they began suing their em-  
ployers. The total amount of their  
suits now approaches \$5,000,000.  
Employers began to scream and  
some of them said that, if they lost  
these suits, they'd be ruined be-  
cause of the amount of back-pay  
involved.

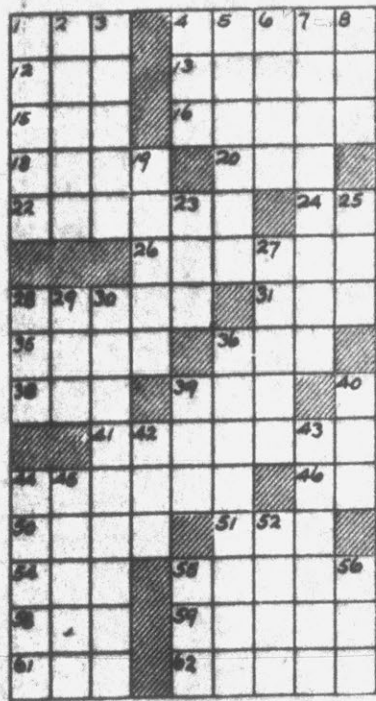
Plenty of congressmen became in-

The new Tass statements seemed to indicate there was to be no relaxing of the pressure on Britain which began when Pravda interpreted a statement by Bevin that Britain "does not tie herself to anyone" as a repudiation of the treaty of alliance.  
Bevin informed Russia that "it certainly is not my view" that the treaty was dead and Prime Minister Stalin concurred, but declared that before it could be extended for 30 more years, as the British have urged, it would have to be amended what he termed "weakening reservations."

unions would get, if the unions won. From the union workers who collected the money—since they were in low income tax brackets—the Treasury could get back only about 17 per cent in income taxes.

Therefore, the Treasury would be out a total of 43 per cent in taxes. Then the Department of Justice stepped in: John P. Sonnett, assistant attorney general, did this:

He asked Judge Picard to throw out the whole Mt. Clemens case unless there was more evidence to show the workers' claims were not trifling.

In this way the Justice Department was using that warning of the Supreme Court to Picard: Not to consider trifles.

If Picard does what Sonnett suggested—throw out the Mt. Clemens case, the claims of all the other unions will suffer a serious blow.

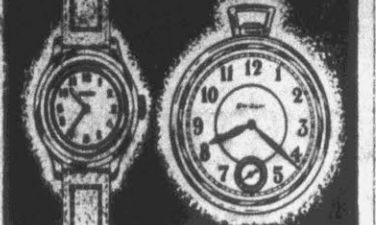
Thursday in Detroit Picard will hear more arguments in the case. Government, company and CIO lawyers all are expected to be there.
