BRIDGES SAYS GERMAN ALLY RUSSIAN GOAL

Senator Asserts Marshall Shall Face Decisive Test At Moscow Parley

Washington, Jan. 31.—(AP)—Senator Bridges (R-NH), charging that Russia's aim is to turn Germany into a "satellite and ally," called upon Secretary of State Marshall today to stand firm at the Moscow Foreign Ministers' Conference.

"If Moscow succeeds in the great design of merging Russian manpower and German technical discipline, the last chance of saving democratic civilization will be lost," Bridges declared in a statement.

"That is why the scheduled big power conference in Moscow (March 10) is so terribly important. It is there that our new Secretary of State will have his first and most decisive test."

Bridges, a member of the Senate Foreign Relations Committee, issued the statement four days after Senator McMahon (D-Conn.) told his colleagues he suspected Russia of building an atomic plant in the Ural Mountains and that this country "may be in mortal danger."

Sharply critical both of America's wartime diplomatic dealings with Russia and of the Soviet Union's postwar activities, Bridges asserted: "Whatever accomplishments we can claim in recent months, we can after we stiffened our policy with an injection of the iron of self-respect."

"Let's not forget," he continued, "that our representatives travelled a hard road, a humiliating road before they reached, at long last a policy of so-called 'patience and firmness.'"

British Royalty To South Africa

London, Jan. 31.—(AP)—England bade farewell for three and one-half months today to the royal family, as they made final preparations to board the battleship Vanguard for a 16-day voyage to South Africa.

The Vanguard—ninth vessel of that name in the British Navy—has been magnificently fitted out for its good-will mission. No stops will be made before Capetown.

South Africa is reported to be planning a huge welcome designed to surpass anything of its kind ever undertaken in that part of the world.

The royal family's first trip of any consequence since the war and the Princess Elizabeth's first close-up of the Empire, the project is considered generally to have too many significant implications to be viewed merely as a holiday.

Ex-Soldier Posed As MP To Rob AT Camp

Fort Dix, N. J., Jan. 31.—(AP)—A former South Carolina soldier, charged by New Jersey FBI Chief S. K. McKee with remaining at Fort Dix four months after his army release for the purpose of posing as a Military Policeman and stealing jewelry and souvenirs from soldiers' barracks bags, was held in custody here today.

McKee identified the prisoner as James Curry, 22, of 710 Church Street, Camden, S. C., whose record, McKee said, includes 15 months of a South Carolina prison gang for burglary and seven months in an army stockade for assaulting his commanding officer in Germany.

Washington, Jan. 31.—(AP)—Gen. Philip H. Frank, OTC boss, told reporters that he would clear up the mystery of the rent rise mix-up when he testifies before a Senate committee.

"Yes, it will cover the whole thing," he replied.

"CAN'T SERVE TWO MASTERS"

Washington, Jan. 31.—(AP)—An auto company and a steel firm asked Congress today to free them from having to deal with unions of foremen.

They appealed to the Senate Labor Committee on the ground that when a foreman joins a union he loses his "loyalty."

Clarence Reichert, president of the DeSoto Motor Corporation, Detroit, said the Foremen's Association of America has lessened efficiency in his plant. He said this union "claims to be independent, but you can't tell its demands from the demands of a rank-and-file union."

H. Parker Sharp, general counsel of the Jones and Laughlin Steel Corp., Pittsburgh, assailed a union of supervisory employees connected with District 50 of the United Mine Workers (AFL). J. and L. is battling in the courts a National Labor Relations Board order recognizing that union as bargaining agent for foremen in the firm's western Pennsylvania mines.

"It is impossible for supervisors to remain loyal to management and at the same time please the miners with whom they are affiliated," he said in a statement prepared for the committee. He added: "No man can serve two masters." (Continued on Page Six)

U.S. Oil Stocks Badly Depleted

Washington, Jan. 31.—(AP)—The Senate Oil Investigating Committee declared today this country couldn't fight another major war if it had to rely on its own oil alone.

It urged "bold steps" to get synthetic fuel production ready.

The committee emphasized in its final report, however, that source materials for synthetic fuels appear to be "capable of meeting all domestic petroleum requirements for many centuries," hence:

"It is folly to be apprehensive that this nation is facing a shortage of liquid fuel."

But the 11-member committee created two years ago to recommend a national petroleum policy—said the military aspect is more serious.

It asserted that in the event of an invasion with all oil imports cut off, known United States reserves could not supply the requirements of a large scale campaign.

Paroled Man Is Held In Slaying

Fayetteville, Jan. 31.—(AP)—Army Private Laurence Simmons, 19, of Asheville, Ala., was stabbed to death early today on the Lumberton-Fayetteville highway. Police are holding Lenward Hair, 29, pending an inquest. Also being held is Mrs. August Pearl Hall Nickels, who is a material witness.

Rural Policeman Earl McLellan said Simmons, Hair, Mrs. Nickels and three other men were occupants of Hair's automobile when it ran into a ditch before dawn. The officer said Hair and the three men left Simmons and Mrs. Nickels to go for assistance, but when they returned they couldn't find the couple. Later, officer McLellan said, they came upon Simmons and the woman walking along a highway, whereupon Hair leaped from the car and stabbed the soldier.

Hair was convicted in 1939 on slaying a Fayetteville policeman, and was sentenced to 99 years to 12 years, but later was paroled.

Increased Teacher Pay Bill Received In House

Raleigh, Jan. 31.—(AP)—Bills providing for highly increased salary schedules for graduate teachers and those holding grade A certificates and for a legislative investigation of enforcement of barber laws by the state board of barber examiners were introduced today in the House.

The House also received a bill designed to bring cooperatives and mutual marketing associations under the states income and franchise tax laws; and heard a brief all by Undersecretary of War Royal, who was introduced as the person most active in Washington in training Camp Butler hospital for a rep. Wilson of Caldwell sent up the teachers' bill, the preamble to which said the public school system is disintegrating because of low salaries, and that young men and women should be encouraged with higher salaries to enter the teaching field.

Soviet Radio Steps Up Propaganda On Policies

London, Jan. 31.—(AP)—The Moscow Radio stepped up its propaganda broadcast against British-American proposals for reorganization of beaten Germany into a federation of small states today as the Big Four deputy foreign ministers plied ahead with their task of drafting German and Austrian peace treaties.

In the sharpest of a series of commentaries this week on the London deputies' sessions, the Soviet radio pushed a Russian plan for "economic and political unity" of Germany and charged that the United States and Britain were seeking "permanent Anglo-American guidance in German political life."

The deputies themselves, meanwhile, were embroiled in an argument over Yugoslav charges that an Austrian delegate appearing before the council to oppose Yugoslav claim for parts of Austrian Carinthia should be banned on the ground he had "Nazi connections."

A Yugoslav note made the charge against Hans Plesch, governor of Carinthia, who appeared with Austrian Chancellor Leopold Figl and other Austrian leaders to plead for easy peace terms on the ground their country was "Nazi's first victim and not a willing axis partner."

Plesch denied at a news conference that he had any influence with the Nazis when he took over as governor of Carinthia in 1945.

The deputies took no action on the Yugoslav charges yesterday but informed sources said Deputy Foreign Minister Fedor T. Gousev of Russia took a serious view of the accusations. American representatives did not immediately commit themselves, but commented that Carinthia was in the British zone of Austria and that Plesch apparently was satisfactory to the British.

The question of Germany's future form of government has not yet been raised formally in the session, but the Moscow Radio for several days past has been stressing Polish, Czech and Yugoslav statements to negotiators favoring a unified Germany.

British and American plans for federalization of Germany, Radio Commentator Lenin said, "conceal plans for establishing complete rule of foreign monopoly and capital in German economy."

British Civilian Families Leaving In View Of Terrorism

Jerusalem, Jan. 31.—(AP)—All British women and children will be evacuated from Palestine by next Tuesday, the Palestine government announced today.

The evacuation results from "recent terrorist acts in Palestine," a government spokesman said. It may involve as many as 3,000 civilian families.

The action will "allow the government and the military to carry out the task of maintaining peace," the spokesman said.

Evacuation of the wives and children of government officials will be compulsory, but certain others may have the option of remaining. In such cases, the spokesman said, the Palestine government would assume no responsibility for their safety.

American diplomats planned to consult with the British regarding United States nationals.

The order did not mention any anticipation of a London conference decision on the future of Palestine. (Continued on Page Four)

Says N.C. Roads Worst In Nation

Chapel Hill, N. C., Jan. 31.—(AP)—The state's chief highway engineer declared here yesterday that North Carolina now has "one of the most obsolete and inadequate highway systems of any state in the nation."

The speaker was W. Vance Baise of Raleigh who with A. H. (Sandy) Graham, chairman of the State Highway and Public Works Commission, urged modernization of the state's highways and improvement of county roads in addresses before the Traffic Engineering Institute, sponsored by the university's Institute of Government and other agencies.

"While this state ranked first in the 1920s, it now has one of the most obsolete and inadequate highway systems of any state in the nation," Baise declared.

Urges Palestine Be Given To U.N.

London, Jan. 31.—(AP)—Winston Churchill urged the British Government today to surrender the United States mandate to the United Nations under the United States joins Britain "on a fifty-fifty basis" in a new policy for the Holy Land.

Almost simultaneously, the Palestine Government ordered the evacuation of British women and children to the United Kingdom.

Churchill, speaking in House of Commons debate, declared: "We have broken our pledges to the Jews. Having found ourselves incapable of carrying out our promises, we have no right to say that we have to stay there for motives of honor."

"If there is no call to honor, then the responsibility of stopping civil war in Palestine between Jew and Arab ought to be borne by UNC (United Nations) and not by this poor, overburdened and heavily injured country."

Unperturbed

Raleigh, Jan. 31.—(AP)—An in-ate school teacher, dissatisfied with the outcome of the teacher salary raise issue, expressed her indignation in a letter to Governor Cherry this week. "I wouldn't vote for you if you were the Angel Gabriel," she wrote. The governor replied briefly. "If I were the Angel Gabriel I couldn't vote for me. You would not even be in my precinct."

REDUCING THE COURT DOCKET Judge John J. Burney Disposes Of Many Cases Here

Islands Have Best Chance To Reach Goal This Year; Hearings In Congress Start Within Few Weeks; Territory's Background; How To Become State

Here is the history which led up to all this:

Hawaii—A group of Pacific islands 2,400 miles from San Francisco—was discovered in 1778 by Captain Cook, an Englishman.

In the following years the representatives of many nations settled there with the natives.

By the middle of the 1800s Hawaii had its own laws and legislature, under a king. The ruling queen was deposed in 1893.

A republic was set up then. Congress in 1898 annexed the islands, and, in 1900, made them a territory, the last step before statehood.

It has a governor, appointed by the U. S. president; two federal judges; a U. S. attorney and marshal, and other officials, and has its own local laws and judges. Its

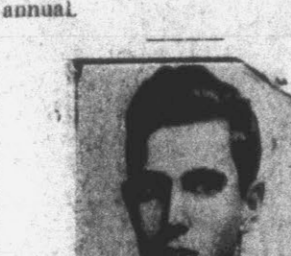

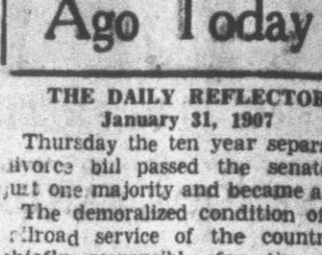

FREE SCHOOL FOR VETERANS

Supt. J. H. Rose Announces Classes For Ex-Servicemen

On next Monday night, February 3, the Greenville City Schools will inaugurate additional classes for veterans at the C. M. Eppes High School. While the first meeting and registration will be at night, after that the classes, will be held in the afternoon and during the evenings from 7 o'clock on. Classes will be given in English, spelling, writing arithmetic, science and building trades.

These classes are for Negro veterans who have not completed high school and who need some training and education in order to become better citizens. All Negro veterans are eligible regardless of the amount of education they may have had.

In order for a veteran to be allowed to attend this school he must go to the Veterans Administration Office in the Armory here in Greenville and obtain his certificate of entitlement and eligibility.

In making the above announcement today, Supt. June H. Rose said that this school is being opened because of the desire on the part of a large group of veterans to secure more education.

He also stated that a combination Accelerated Course and Vocational School would be opened soon at the Greenville Vocational School for white veterans; that this school for white veterans would be opened as soon as the local Veterans Administration Office informed him that a group of 15 or more was ready for school.

Mr. Gardner, however, is well-equipped with cut-aways, striped pants and high hats, according to Mrs. Gardner.

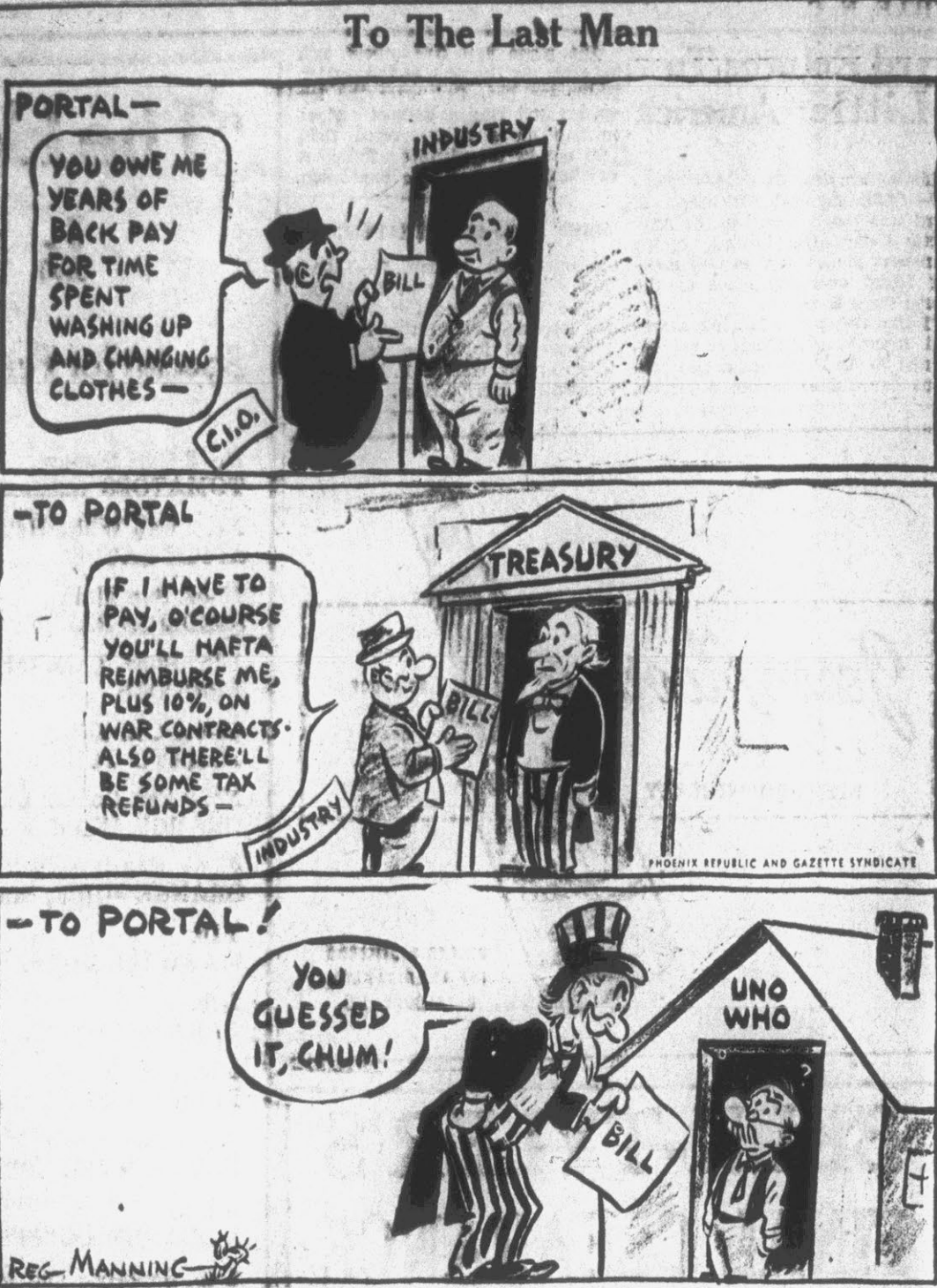
As for our new First Lady to England, she is collecting a wardrobe that will qualify her as one of America's best-dressed women abroad.

own elected legislature, with a 15-man senate and a 30-man house. And every two years it elects to Congress a delegate who can represent Hawaii there and introduce bills but who cannot vote. Delegate Farrington now is serving his third term. The civilian population is about 320,000. Hawaii has 6,000 square miles of land, more than Rhode Island and Connecticut together. Sugar and pineapples are its chief products for export. Since 1900 the Hawaiian legislature has petitioned Congress 14 times to make the territory a state. For Hawaii to become a state, Congress would pass an act telling Hawaiians to draw up a state constitution. When the Hawaiians approved it, by vote, it would come here, and then it would be up to Congress to do the rest.

\$2,400; eight, 2,600; nine, \$2,700; ten, \$2,800; eleven, \$2,900; twelve, \$3,100; thirteen, \$3,300; fourteen, \$3,500; and fifteen and thereafter \$3,600. Rep. 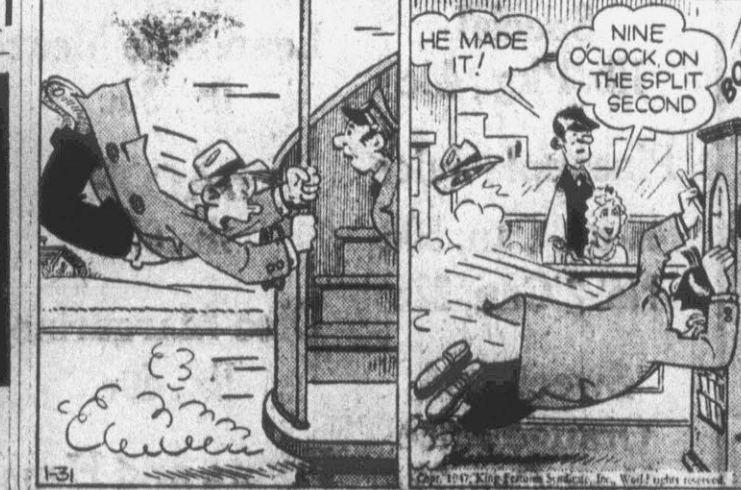

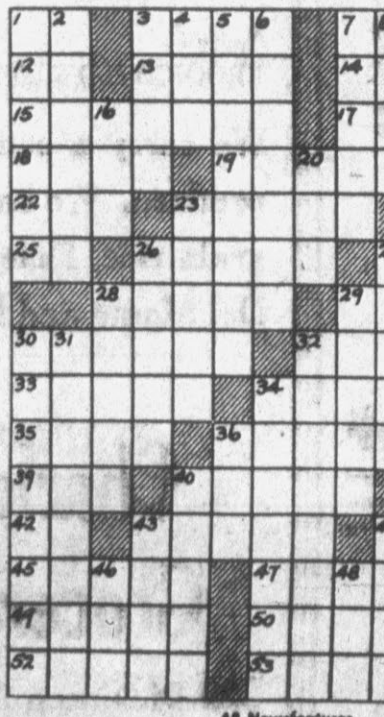
