Thousands Join Roads Leading To Exercises At New Airport

By CHESTER WALSH More than 10,000 people attended the dedication exercises of the Pitt-Greenville Airport here Sunday with 163 civilian and 16 Marine and Navy planes, including a PBY Navy Patrol bomber, participating in the air show.

A two-hour traffic jam resulted at the conclusion of the exercises when nearly 5,000 automobiles were temporarily, bottle-necked on the single highway leading from the field. Highway patrolmen and police did a wonderful job unsnarling the traffic—the largest outpouring of vehicles ever to assemble in Greenville.

The number of planes and spectators exceeded all expectations but the day passed without an accident of any kind, authorities stated.

The Greenville Junior Chamber of Commerce sponsored the exercises. It was a success financially in every other respect, President Vann C. Fleming, Jr. said.

Lieut. Thomas Sellers of Greenville, U.S. Marine Reserves, introduced Maj. Gen. Field Harris of Washington, D.C., director of the Division of Aviation for the Marine Corps.

General Harris, a Kentuckian, who observed his 30th anniversary in the Marine Corps, won the good will of thousands who heard him at the airport and over the Greenville radio, when he paid tribute to Gen. Al Turnage of Farmville, and spoke appreciatively of the fine treatment the Greenville people gave the Marines during World War II.

"The time has come to convert this wartime establishment to something useful to your community and to dedicate it to peacetime service. Implements of war, airfields, are highly convertible to peacetime uses," he said. "The airplane is shrinking distances and saving valuable time. It is being widely adapted to business usages. It takes air mail to your door. The cost of airplanes and their operation is going down and increasing its horizon of service. In the pleasure field it compares with the automobile. All of the airplane's services add up to a real necessity to a live and progressive community. It is here to stay and the community without an airport is living in the horse and buggy days.

"In case of another national emergency, your flying Marines will

want to come back to you, but I hope there will be no national emergency and trust that the peacetime service of your airport will not be interrupted and I hope that its peacetime uses will exceed its wartime service. May it help to make you a better and happier community," General Harris concluded.

Alderman L. M. Buchanan, chairman of the Airport Commission, in a brief speech, accepted the airfield or civilian use in behalf of the Airport Commission for Pitt County and Greenville, Airport Commissioners Jasper Smith, G. H. Pittman, N.C. Brooks and Executive Secretary Willard T. Kyzer were on the platform.

General Harris left for Washington immediately after the ceremony in a Marine plane piloted by Maj. Theodore A. Peras and Staff Sgt. Arthur Brown. Henry Oglesby of Grifton, Congressman Herbert C. Bonner's secretary, accompanied him. While in Greenville, members of the party were luncheon guests of State Highway Commissioner John G. Clark and Mrs. Clark.

The members of the Junior Chamber of Commerce—two-thirds of them were in the armed forces—demonstrated yesterday that they are as efficient as civilians as they were as soldiers, sailors, marines and airmen. They live the motto—"Our Greenville, yours if you come." More than 4,000 persons paid admission.

Marshall Denounces Soviet For Delivering 'Ultimatum'

Secretary Of State Bluntly Criticizes 'Stand Pat' Attitude; Includes France In Caustic Review; Clarifies Conflict; Bevin Bids For Unification Of Germany

Moscow—(AP)—U. S. Secretary of State Marshall, in his bluntest speech of the conference, denounced Soviet Russia today for delivering "an ultimatum" to the Foreign Ministers Council.

"We regret," said Marshall, "that the Soviet delegation found it necessary to state 'the acceptance of reparations from current production' is an absolute condition of the principle of economic unity."

"The Potsdam agreement for economic unity was not conditioned upon the acceptance of reparations from current production. The U. S. categorically rejects the imposition of such a condition. It looks very much to us as though the Soviet Union is trying to sell the same horse twice."

"Unless we can have a real meeting of minds and a real desire to carry out both the spirit and letter of our agreements it would be better if none were reached," the Secretary of State declared.

"We can never reach real agreement in commenting on the Soviet position that unless Russia received reparations from current German production no settlements could be reached."

He spoke just after the British had circulated a proposal by Foreign Secretary Ernest Bevin to the council for the unification of Germany by July 1, this year, a unification which he said should be made effective by abolishing all restrictions on movement of goods between the zones.

This proposal, obviously unacceptable to the Russians, provided that before any reparations could be paid the Germans would have to "pay back" sums advanced for Germany's maintenance by the occupation powers.

Midnight To Signal Shutdown Of Mines

Soft Coal Diggers Enter Pits for Last Time Before Six-Day Stoppage; Industry Has Few Qualms Of Final Results

By The Associated Press The nation's 400,000 soft coal miners entered the pits for the last time today before beginning a six-day work stoppage in memory of the Centralia, Ill., mine explosion victims—but industry generally appeared to face the prospect of curtailed fuel supplies with few qualms.

At regular month-end meetings of AFL United Mine Workers union locals, the coal diggers received orders passed down from the UMW president, John L. Lewis, to stop work at midnight tonight for six days to honor the 111 Centralia dead.

There were ample stock piles of coal at most industrial plants. At the giant U. S. Steel Corp. in Pittsburgh, however, officials said eight

OIL PRICES IN SENATE PROBE

Investigators Question Cost Of Navy's Arabian Oil

Washington—(AP)—Senator Brewster (R-Me.) said today he wants to know whether the navy will have to "pay through the nose" for the next 60 years for Arabian oil bought through American concerns.

The navy has denied the price it paid is out of line. It has purchased oil for \$59,879,954 under contracts with the Arabian-American and California-Texas oil companies.

Brewster, chairman of the Senate War Investigating Committee, estimated this is \$33,460,603 above the quotations in a 1941 contract offer which James E. Moffett testified

Pullman Sale

Washington—(AP)—The Supreme Court today approved sale of the Pullman Company sleeping car business to a group of 43 railroads.

The sale was opposed by the Justice Department on the ground that it would merely substitute a "more powerful monopoly" for one which had been adjudicated illegal under the Sherman Anti-Trust Act.

The same was approved by a 4 to 4 decision. No opinion was written. Justice Jackson took no part in the case.

GERMANS TALK NEW WALKOUT

Coal Strike In Ruhr Considered Over Low Food Rations

Essen, Germany—(AP)—A strike of all German coal miners in the Ruhr in a protest against food shortages will be considered by mine union representatives in Bochum Wednesday. British officials disclosed today.

About 2,000 Geerman miners struck this morning at Dortmund, but 4,000 others returned to four pits that had been closed.

Some 10,000 persons including railway and wagon factory workers marched through the streets of Krefeld, on the west bank of the Rhine, waving banners protesting food shortages. A similar demonstration was planned later today in the coal center of Duisburg.

Official figures compiled by the British-operated North German coal control office showed a significant decrease in Ruhr coal production during the restless period of demonstrations, although most miners so far have obeyed union instructions to remain at work.

The coal output which reached 238,000 tons March 21 dropped to 231,000 tons March 28, or about the average of late February.

The 4,000 strikers who returned to work said they would walk out again tomorrow if their food demands were not met. The miners (Continued on Page Four)

Bombay Riots Take Toll Of Forty-Two

Bombay—(AP)—A communique said today that in rioting between Hindus and Moslems four persons were burned to death yesterday in a horse-drawn Victoria carriage which was set ablaze.

The dead were among the 42 killed and 50 wounded in similar disturbances in Calcutta and Cawnpore.

RACE TO KEEP SUGAR POWERS

House Approves Legislation; Seek Quick Senate Action

Washington—(AP)—Racing to prevent expiration of sugar rationing at midnight, the House today approved compromise legislation continuing sugar allocation and price control until October 31.

Immediate Senate action will be sought to permit the bill to go to the White House before nightfall for the President's signature.

The bill stipulates that each person shall have a ration of at least 20 pounds of sugar in the next seven months. This is at the rate of a 35 pound yearly ration, or 10 pounds more than last year's ration.

Under the compromise, the OPA is stripped of further administration of the controls, and the power transferred to the Department of Agriculture.

The bill also sets aside 30,000 tons of sugar for new industrial users and continues inventory controls except over household consumers until March 31, 1948.

The controls were extended for only seven months over vigorous protests of some lawmakers.

Senator Tobey (R-N.H.), contending the controls should continue for a year, predicted the short extension may bring about a "national scandal" by encouraging sugar hoarding, gambling and profiteering.

Indict Author In Conspiracy Case

Washington—(AP)—A district grand jury today indicted Arthur Howard Fast and 16 others identified as members of the joint anti-Fascist refugee committee's governing body on charges of conspiracy.

The jury accused the group of conspiring to prevent the House Committee on Un-American Activities from gaining access to records of the organization, and failing to produce the records before the committee.

The indictment named Dr. Edward K. Darsky of New York City as chairman of the committee.

Senate Banking Committee Passes Legislation Keeping Rent Controls

Washington—(AP)—The Senate Banking Committee today approved legislation continuing rent controls through February 29, 1948. The controls would be maintained without a blanket increase in rents. The approval of the legislation was unanimous.

The bill provides for: 1. Establishment of five-man local advisory boards in each rental area with authority to recommend decontrol or rent increases on an area basis.

2. Transfer of the rent program from OPA to Housing Expediter Frank Creedon. Unless reversed by Creedon, recommendations submitted by local boards would go into effect automatically after 30 days.

3. Decontrol of new housing, dwellings rented for the first time, houses renting for more than \$225 a month, and hotels and motor courts.

4. Authority for individual states to set up their own rent control

COURT UPHELD TREASON CASE

Conviction Of Saboteur's Father Supported By Tribunal

Washington—(AP)—The Supreme Court today upheld the treason conviction of Hans Max Haupt, father of one of the German saboteurs who was executed here during the war.

Haupt, a Chicago resident, was sentenced to life imprisonment and fined \$10,000. His son, Herbert Haupt, was one of the German agents who landed on the Florida coast from a submarine. Herbert made his way to Chicago where FBI agents later arrested him at his father's house.

Justice Jackson delivered the court's 8-1 opinion. Justice Murphy wrote a dissent.

Counsel for the father protested to the Supreme Court that the verdict of the jury at his trial in U.S. District Court was a result of "passion, prejudice and war hysteria."

The Justice Department replied that the jury after reaching its verdict voluntarily wrote a letter to the trial judge asking that he be "merciful" to Haupt. The department said that the letter impressed the judge so much that he did not sentence Haupt to death "as he otherwise would have done."

Gen. Eisenhower To Inspect Fort Bragg

Fayetteville, N. C.—(AP)—Gen. Dwight D. Eisenhower, army chief of staff, arrived here by automobile from Washington today to begin an inspection of Fort Bragg. He will be here until Thursday, when he will pass through Fayetteville in an open car to acknowledge the cheers of residents of the area.

Truman Removes Kilian From Promotion List

Washington—(AP)—President Truman today deleted the name of Lt. Col. James A. Kilian, former commander of the Litchfield replacement depot, from an Army promotion list.

Kilian's name was included originally in a list of 683 lieutenant colonels, submitted to the White House by the War Department for promotion to the rank of full colonel. The President removed Kilian's name before sending the list to the Senate for action.

Kilian was convicted by court martial of permitting "cruel" punishment of enlisted men detained at Litchfield in England during the war. The sentence was handed down August 19, 1946, and the case is now pending on appeal.

Kilian was sentenced to be reprimanded and to pay a fine of \$500. The Senate previously held up action on a promotion list because Kilian's name was included.

Presidential Secretary Charles G. Ross in announcing the President's action told reporters: "Col. Kilian's name was on the list. It is on there no longer. The President took it off."

Increase In Airline Fares Begin Tonight

Washington—(AP)—A 10 per cent increase in airline fares will go into effect at midnight tonight, returning the tariffs to the 1944 level.

The increase was approved by the Civil Aeronautics Board a week ago at the request of 16 airlines. The lines agreed not change the rates again for 90 days.

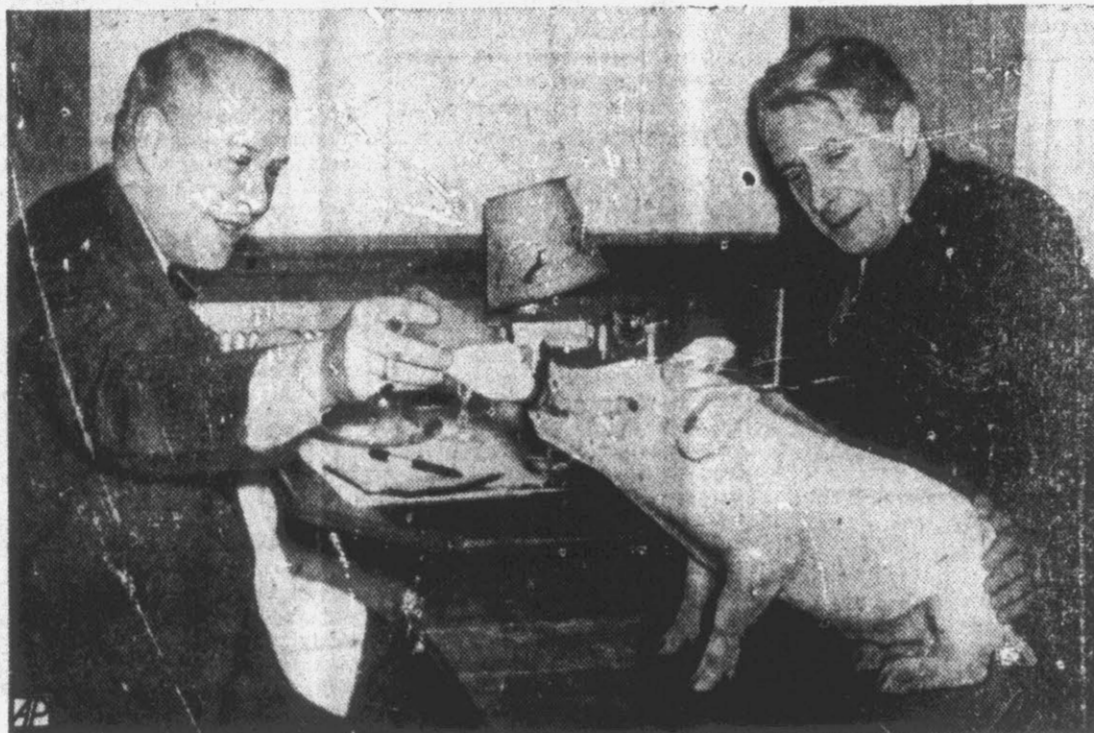

ers tactical political maneuvers. Typical of the latter class are the food demonstrations in the British zone of occupation in Germany. Some 100,000 people in the great Ruhr mining area have been making public protests over the quantity of the food they were receiving and there was an ugly climax Saturday when 4,000 miners refused to resume digging coal, which is the economic life-blood of Europe because of the economic crisis.

Authoritative sources say this trouble has been inspired by the Reds, who exploit every situation which is a potential trouble maker. Such Communist tactics serve a double purpose: The public agitation creates public unrest and tends to break down government, and if the food situation is overcome the Communists will claim that they forced government to act.

Such operations are the indirect action which is used as a softening up process before the direct-action is applied. There are plenty of examples of direct-action - governments established by force and the liquidation of the opposition.

The United States is now in the softening up stage. The governmental drive to clean house of the Communists is calculated to prevent the development of the direct-action stage in America. It will, too, if the public recognizes present dangers and keeps on the alert.

"The Soviet delegation has suggested that it will be possible for the French to have their coal and still leave enough coal in Germany to manufacture the reparations the Soviet government demands."

Clark compared it with the Monroe Doctrine and told a Jackson Day dinner at Des Moines that Mr. Truman measures up as a "great President, a man of mettle." Then Clark, recalling the Democratic defeat in the 1946 elections, said: "And how America has rallied around this stout-hearted, fearless man who dares to do all that is necessary for his people."

"We know that a two-party system works both ways. We know that under that system, what happened in the last election can be reversed in the next." "And we Democrats were never more thankful for that two-party system than we are today as we look forward to the November (elections), of 1948."

Haifa Damages... (Continued from Page One) ment planned to levy a special tax against the Jews in Palestine. The oil fires shot smoke thousands of feet into the air, darkening all of Haifa. Some estimated the fires would burn for several days.

Nearby buildings were damaged severely. The Shell Oil Company alone said its loss was \$1,000,000. The underground Irqun Zval Leumi had claimed responsibility for sabotaging the oil installations earlier.

The fires, blazing along a quarter-mile of the waterfront, were described by British authorities as "the biggest ever in Haifa." Eight storage tanks were demolished and six others were burning out. An official statement said the entire harbor area was "blackened by smoke from a blazing mixture of kerosene and fuel oil and at noon smoke still was rising thousands of feet into the air and darkening the city."

Two miles offshore, the unauthorized Jewish immigrants saved from the 700-ton schooner San Felipe were transferred to the British transports, Empire Rival and Ocean Vigour, and headed to detention camps on Cyprus.

Churchill Backs Attlee On Draft London - (AP) - Winston Churchill threw his support tonight to Prime Minister Attlee, who is fighting a revolt within his own Labor party on the issue of continuing peacetime conscription.

"On this occasion we support the government," declared Churchill, leader of the conservative minority. "We even go so far as to compliment them on the courage they have shown in resisting the subversive and degenerate elements in their majority."

"Of 91 contract items, the union wants only about a dozen changed," Moran told reporters. "None has been agreed on so far." The items include a \$12 per week increase in wages, now \$28 to \$80, would reduce German food consumption to a starvation diet of 1,100 calories a day.

"Does the Soviet government make this proposal seriously?" he asked. "The United States is opposed to policies which will continue Germany as a congested slum or an economic poor house in the center of Europe."

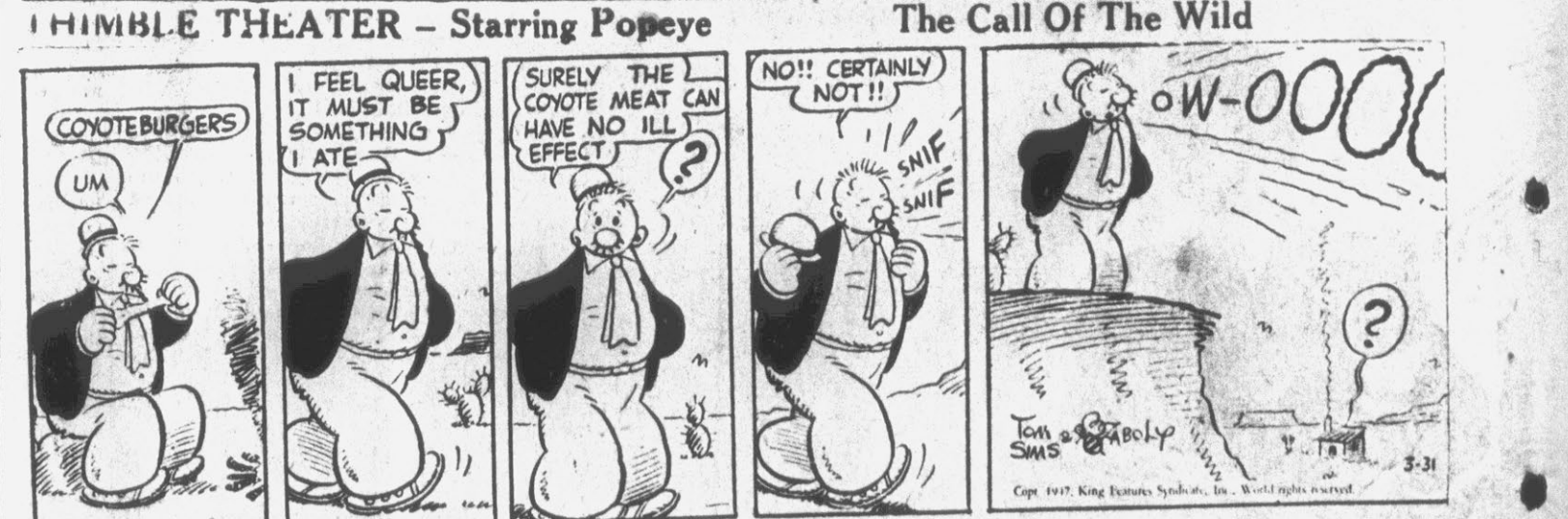

Thirty-Seven Student Teachers Now At Work

East Carolina Teachers college has 37 student teachers working in schools in the eastern section of the state during the spring quarter at the college, according to an announcement from the office of Dr. J. B. Oppelt, director of student teaching and placement. Twenty-seven of the students are women, and ten are men. Thirty-five are North Carolinians, and two are out-of-state students.

In the Greenville high school twenty of the students have assignments in the various departments of instruction. Seven are teaching in grades one through six in the training school located on the college campus. Those working off the campus are located at Lumbago, Saratoga, Walsenburg, Tabor, Ohio, Washington, Bear Grass and Maury.

All student teaching at the college is under the general supervision of Dr. J. B. Oppelt of the college and is directed by supervising teachers or principals in the public schools and by supervisors from the college faculty.

During the three regular quarters this year 128 student teachers in the senior class have received or are now receiving practical training in the public schools as preparation for their work in the future. Of this total, 111 are women and 17 are men.

Guests of the evening were W. G. Gedy and Robert G. Gedy, vice-presidents of the Greenville Blind Center, who were in the European theater.

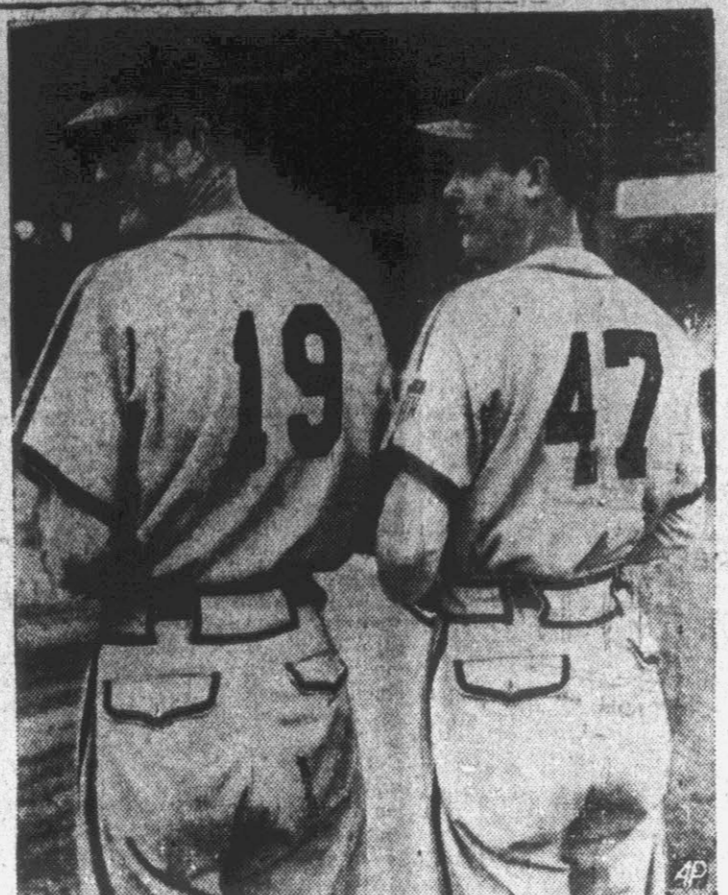
Dragging Body For Missing Negro Youth

Greenville High students were asked yesterday to total up their points for extra-curricular activities on the basis of a system compiled by the point system committee.

The point system was submitted by the special committee that was appointed to handle the matter. It has, however, attracted much unfavorable comment from many students.

One student pointed out that under the system four points would be counted for both a two-day out-of-town convention and one year's membership in a school club. He said that it seemed unwise to consider a two-day convention as requiring the same amount of work as a full year's membership in a club.

Another said that he thought that the points for club membership would cover any conventions the club might attend.

The general opinion among the students seemed to be that GHS was in need of a point system but that the one proposed failed to meet the needs of the school.

At least two petitions are known to be circulating among the students calling for a referendum to decide the issue.

The system, as presented to the student body by the committee, would allow each pupil to carry a total of 15 points. Points would be computed as follows: club membership, 4; club officers, including points for club membership, 5; class officers, 5; sports, varsity team only 4; student council representatives, 4; student council officers, 7; out-of-town trips for conventions or other meetings, 2 for each day out of school. The committee stipulated that points for sports could be dropped at the end of the sports season and the points used for other activities.

Oil Documents In FDR Library

Washington—(AP)—The Senate War Investigating Committee, digging into a 1941 demand from King Ibn Saud for a \$30,000,000 advance payment for Arabian oil, hit a snag today when it learned that documents concerning it are with the late President Roosevelt's private papers.

Chairman Brewster (R-Maine) said the committee will seek President Truman's help in getting them.

Capt. Chester C. Wood of the Navy Judge Advocate General's office reported that the documents are missing from the navy department files. He said that the F. D. Roosevelt Library at Hyde Park informed him they are in the hands of Earle D. Koons, attorney for the executors of Mr. Roosevelt's estate, and that Koons can make them available only upon request of the President of the United States.

Contest Planned Improve Breeds

Pitt county poultrymen will compete with poultry breeders in 12 southeastern states in the 1947 phase of the nationwide Chicken-of-Tomorrow program with more than 5000 poultry raisers from this county eligible to enter the competition, according to D. D. Slade, chairman of the national Chicken-of-Tomorrow contest committee.

"All that is required for Pitt county poultrymen to become a part of this important breeding program is a flock of 50 baby chicks hatched between March 24 and 28," Slade said. "Poultrymen entering the contest are urged to contact C. J. Maupin, Extension Poultryman, North Carolina State College, Raleigh, chairman of the contest committee in this state."

Aimed at developing chickens with improved meat-type characteristics, the contest carries a \$5,000 grand prize in 1948 provided by A & P Food Stores and \$5,000 in regional prizes.

Japs Abolish House Of Peers In Gov't

Tokyo—(AP)—Japan's house of peers formally died tonight after a half-century of aristocratic approval of Japanese imperialism.

Adjournment of the 92nd regular diet session—last under the old 19th century constitution—ended the life of the house of peers. Under the new constitution, effective May 3, it will be replaced by a house of councilors whose 300 members will be elected April 20.

World Airmail Service Starts

Washington—(AP)—The post office department today announced a new 10 cent "air letter service" to all parts of the world, effective April 20.

The service call for the use of air letter sheets, purchasable at most offices. The thin sheets, measuring 12 by 8 1/2 inches, including a gummed flap, may be folded and sealed after the letter is written into the form of a small envelope.

The folded missive will bear a red-printed 10-cent airmail stamp of the same DC-4 design as the new 5 cent air mail stamp.

The price of 10 cents for the stamped letter sheets compares with the present minimum charge of 25 cents for letters mailed abroad.
