Status Of Jews Up For Decision

Fight Over Jewish Representation In United Nations Debate On Palestine Goes To Assembly Floor For Decision; Jews Barred By Committee Vote

New York, May 3—(AP)—The week-long fight over whether there should be Jewish representation in the United Nations debate on Palestine went to the floor of the General Assembly today for decision.

The 55 weary delegates were summoned (11 a.m. EDT) first to hear President Miguel Aleman of Mexico in a ceremonial interlude and then plunge into consideration of the steering committee's recommendation that the Jews be barred from floor debate in the full Assembly but given permission to appear before committees.

The committee vote, coming last night after another torrid session, was 11 to 0 with Russia, Poland and Czechoslovakia abstaining.

The Soviet Union and her two partners sought to invite the Jewish Agency for Palestine to appear before the Assembly but won no support.

Russia, the United States and Britain were agreed that Jewish views should be heard but split on how this should be done.

Should the Assembly uphold the steering committee's recommendation, the question of hearing would be tossed to the 55-nation political committee which expects to begin debate Monday on the sole item on the agenda—the setting up and instructing of a commission of inquiry on Palestine. This commission would report back to the regular September meeting of the Assembly, at which time delegates would attempt to reach a decision on the delicate Holy Land mandate.

Aleman Speaks Before U.N.; Given Ovation

New York, May 3—(AP)—President Miguel Aleman of Mexico told the United Nations Assembly in extraordinary session today that international cooperation was the only way to prevent mankind from falling into another conflict which would wipe out the present form of civilization.

Taking the rostrum after Assembly President Oswaldo Aranha welcomed him as one of the greatest contributors to peace in our generation, Aleman said.

"Only this cooperation can succeed in overcoming the difficulties that have arisen at the close of the war and must, finally, convert into a state of peace—a true peace—the uncertain period in which we have been laboring for several months."

He was given a tremendous ovation as he began to speak.

No Isolation Wanted

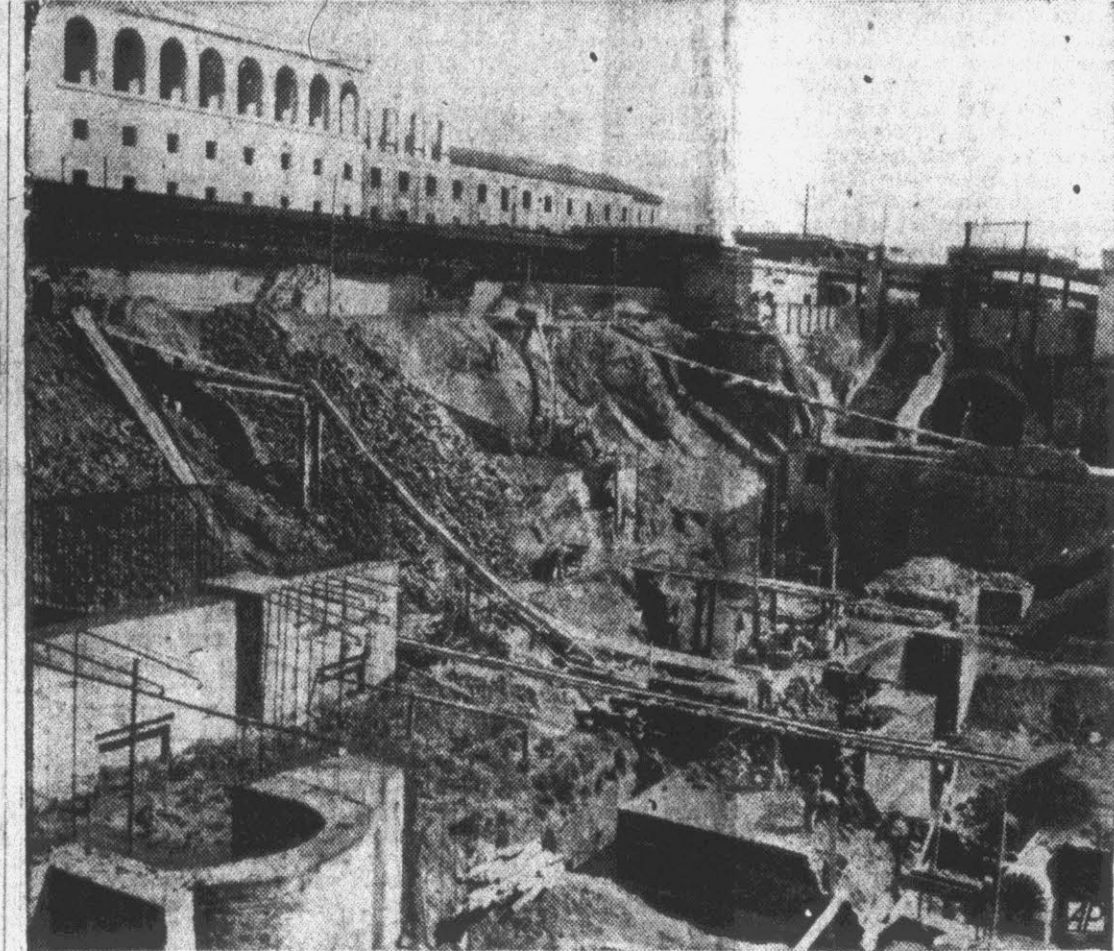

Tentative Settlement By NFTW In Illinois

Chicago Leaders Of Phone Unions Accept Offer Subject To Ratification By Members; AT&T Makes First Pay Proposal

Washington, May 3—(AP)—The first tentative wage settlement between a Bell system company and an affiliate of the National Federation of Telephone Workers hinted a break today in the nationwide telephone strike.

Four sets of negotiations in the Capital were still deadlocked, but there were these two big developments:

1. In Chicago leaders of three NFTW-affiliated unions accepted \$4 from the Illinois Bell Telephone Co. subject to ratification by 16,000 members. It was the first demand for a nationwide boost of \$6 a week.

2. In Washington, the American Telephone and Telegraph Company made its first money offer to its 20,000 long-distance employes.

Though rejected by the American Telephone and Telegraph Company, the offer was \$2, \$3 or \$4, depending partly on the geographical locality. Thus it was not an over the board arrangement.

Atomic Ship

London, May 3—(AP)—The Admiralty broadly hinted today that it may try to develop an atom-propelled battleship.

In a statement saying it planned "a very large amount" of research to maintain the navy's efficiency, it said:

"Many Lines of inquiry present themselves—the atomically propelled battleship, for instance, would have no immediate refueling problems, and the period for which it could stay at sea would be limited only by other and generally less urgent supply problems, a vital factor if the ship proved less vulnerable than the harbor."

GIANT UNIONS PUT AWAY ALL MERGER PLANS

Pool Opposition To Union Curbs; Keep Merger Talk Alive

Washington, May 3—(AP)—The AFL and CIO, laying aside indefinitely any hope of becoming one big organization, went ahead today with plans to pool their opposition to sharp curbs on unions pending in Congress.

This was all they had to show for a two-day peace conference which resulted in unanimous agreement that "organizing unity should be established within the American labor movement"—but rejection of each other's plans for bringing it about.

AFL President William Green and CIO President Philip Murray expressed the concurring view of their peace committees as the conference broke up late yesterday.

"They made it plain that the subject of merger will be kept alive while the tough labor legislation is in the works.

Murray called a meeting of his nine vice presidents for May 15 and of his 51-man executive board for May 16 to hear reports on the unity sessions and work out details of cooperation with the AFL on the campaign against a restrictive labor bill.

The rejected AFL peace plan would have welcomed all the CIO's national unions into membership in the older organization on the same basis as John L. Lewis led back his United Mine Workers last year.

The mergers returned with the understanding that any jurisdictional disputes would be settled by the AFL's executive council as they arose.

Riot, Disorders At Leavenworth

Two Hundred And Fifty Prisoners In Army Disciplinary Barracks Subdued; Over Five Hundred Still Hold Out In Cell Block; One Prisoner Killed, Seven Injured

Fort Leavenworth, Kans., May 3—(AP)—Army authorities reported today they had subdued 250 to 300 prisoners who engaged in a night-long riot at the Fort Leavenworth disciplinary barracks after one prisoner was killed and seven others were injured.

The 250 inmates, of one of two cell blocks involved, surrendered after Col. Graeme Parks, disciplinary barracks commandant issued an ultimatum over the loud speaker system telling the men that the army was in full control, and unless they gave up all would be shut out and the cell blocks would be flooded with tear gas. No word had been received from prisoners in cell block 7, the other affected.

The riot was reported to have been the outgrowth of a recent order that white and Negro prisoners should eat together in the same mess, and was described as a race riot within the prison.

The commanding officer told the men over the address system that white and Negro inmates had been segregated at breakfast this morning and that this practice would be continued.

More than 200 tear gas shells and grenades had been lobbed into the cell blocks before Parks issued the ultimatum.

After Parks' broadcast on the speaker system, the men in cell block 6 sent a spokesman to tell a guard at the doorway that they were ready to surrender.

The men were ordered to come out in groups of five. They were taken into the rotunda, stripped and searched. They then were all herded into another cell block that had been emptied and prepared for isolation of the rioting prisoners.

The rotunda was guarded by 100 troops armed with billy clubs and tear gas. Firemen had two high pressure streams on the men if they showed signs of giving further trouble.

There was no information on whether there may have been more than the eight casualties originally reported.

Phone Strike ABC's

If You've Lost Track Of What's Been Happening, Here Is Outline To Bring You Up To Date; Who Is Involved; The Demands; The Score On Settlements

Washington—(AP)—If you've lost track of the telephone strike, here's an ABC bringing it up to date.

The strike started April 7. More than 300,000 workers walked out or stayed away from work, refusing to cross strikers' picket lines.

Two Hundred And Fifty Prisoners In Army Disciplinary Barracks Subdued; Over Five Hundred Still Hold Out In Cell Block; One Prisoner Killed, Seven Injured

Stalemate In Walkout At R.J. Reynolds Plant

Winston-Salem, N.C., May 3—(AP)—Federal and state efforts to arrange a joint conference of the R. J. Reynolds Tobacco Company management and striking members of the Food, Tobacco and Agricultural Workers (FTA) appeared stalemated as the walkout entered its fourth day today.

D. Yates Heafner of Charlotte, U.S. Department of Labor conciliation service representative, and Frank Crane of Raleigh, State Department of Labor representative, were reported yesterday to have conferred separately with union and company officials.

A company spokesman at the time said there were no plans for further negotiations.

The union has said it is seeking increased wages and has estimated that some 8,000 workers are on strike. The company has estimated that 5,000 employes are idle.

Legal Steps For Moving College Near Completion

Winston-Salem, May 3—(AP)—The legal procedure necessary to effect transfer of Wake Forest College from its present location 17 miles from Raleigh to Winston-Salem is a step closer to completion today.

The trust suit between trustees of the Zachary Smith Reynolds Foundation and Wake Forest trustees has been passed to the North Carolina Supreme Court.

Judge Hubert Olive at yesterday's hearing in Winston-Salem read a 15-page judgement which, in effect, upheld the authority of the foundation trustees to administer funds to the college, and upheld the right of the college to accept them.

Babson Discusses Safe Investment Policy

Eureka, Kansas, May 3—I am writing this column near the exact center of the U. S. In fact, there is a monument on U. S. Route 36 here in Kansas which reads as follows: "San Francisco 1694 miles—West, Boston 1702 miles—East."

Most Take the Risk Everyone who reads the above marker must decide whether he is to go East or West—or stand still. But if one stands too long by this monument he will ultimately collapse. This to me illustrates where America stands in the world today. If we continue with our present cowardly policy of do-nothingism, we will ultimately suffer as selfish isolationists in a starving and angry world.

On the other hand, it is only fair to say that we run some risk in leaving our present position. If we leave, we must go either East or West. Which direction is the best to take no one now knows. One road can lead to war, while the other can lead to Peace; one road can

hasten the great depression, while the other can postpone it; one road may lead to stagnation, while the other to a religious awakening. But I repeat that today no one can see where either East or West will lead us.

Policing the Seas As isolationists—we could enjoy a few more years of good business whatever we do. Embarking, however, on some big world program would postpone depression, unemployment and communistic uprisings. It is even possible that the thought of world power with its promises of "prizes for all" could electrify America and bring about a temporary boom exceeding anything this country has ever witnessed.

1945 by which Korea was to be run for not more than five years under a trusteeship. The effect of the Russian move was to bar virtually all but the pro-Communist parties.

the job because they were too high and installed with home-town labor a 42-inch steel reinforced surface drainage pipe line from the National Biscuit Company's plant on Albemarle Avenue down the Coast Line Railroad to the river. This pipe connects with another and will take care of surface water in the western part of the city. It took off much of the excess load on other surface pipe lines and will prevent flooding of streets during heavy rains.

With City Engineer Henry L. Rivers in charge of the project the city installed the 42-inch surface drainage pipe line and saved the taxpayers \$17,000 of the \$33,000 bond issue. The difference will be spent on similar improvements.
This administration has installed a two-way short wave radio station at the City Hall, equipped two police cars with radio telephones; caused to be similarly equipped the Utilities Commission trucks; gave the County Commissioners authority to connect the sheriff's cars with the police radio, thus providing local police protection here and over the county. The Greenville "police department is as close to the average citizen as his telephone." Incidentally, all of the serious crimes committed here since the radio was installed have been solved, except recent break-ins and the police expect to solve them.

The Board of Aldermen approved the proposal for a special election to levy a tax of 15 cents on the \$100

property valuation to supplement school teachers' salaries; the board also approved the Greenville Utilities' petition for a special election to vote on issuing \$800,000 of bonds for improvements at the electric gas and water works plants. This work is under construction.

Hold Negro For Grand Jury In Shooting Case
At an inquest at the City Hall in Ayden last night, a jury found that John A. Garris, 24-year-old Negro, came to his death as a result of a gunshot wound inflicted by Walter B. Wilson, Negro. Coroner Griffin H. Rouse ordered Wilson held under \$3,000 bond for the grand jury at the April term of Superior Court.

Testimony at the inquest was that Garris and Wilson, at a drinking party at the home of Josh Beaman, Negro, in the Cannon's Cross Roads community, several miles from Ayden, had an argument over a woman, and that Wilson shot Garris with a shotgun, blowing off a part of his face. He died at P. I. General Hospital in Greenville on Monday night.

other points:
"Fortunately in recent times both of us (America and Mexico) have learned a few things. We have learned that isolation is not a good formula for living; that it is not good tactics for security."

It is a striking coincidence that as the Mexican President was delivering his speech, the Chief Executive of another great Latin American country—President Juan Peron of Argentina—was saying the same thing. General Peron told his Congress that isolation no longer was possible and that Argentina must share world problems. He declared that foresight was necessary in the midst of an armed world and announced that he intended to modernize the Argentine Army.

General Peron didn't interpret his remarks, and I think we should be rash to do it for him. It is better to wait and see. However, it's safe to say that the statements of both Peron and Aleman will encourage the hope among Pan Americans that we are coming nearer to a complete implementing of the act of Chapultepec which was concluded in Mexico City two years ago with the aim of securing solidarity.

This act also provided for the creation of a system of hemispheric military defense to which all should contribute, and a subsequent conference was to be held to make this program effective. However, the conference hasn't yet materialized and the plan for unity in defense has been hanging fire. Now one wonders whether we may be approaching the full objective that the act of Chapultepec sought.

Nations. We would agree to drop out of the picture as soon as the U. N. is organized to do the work. We could even ask the U. N. to make a contribution to our U. S. expenses. Russia might "jump the gun" and sweep down and take the Dardanelles; but Russia could not hold the Straits.

Instead of this new U. S. policy "killing the U. N.," as some forecast, it might speed up the U. N. and make it function. Mr. Truman's policy may be the making of the United Nations. Again I say that only the future can tell; but we cannot continue with mere talk, as at present, even though both the American and Russian ideologies are in the test tube and laboratory stages.

Civil Wars May Be Needed
It will take much self-control for us to be content to "rule the waves." Both foreign nations and groups within our own country will constantly urge us to send an army into certain countries. This could be our downfall. We should be content to let nations indulge in some civil wars and learn for themselves the evils of bad government.

Telling nations Communism is a bad doctrine and will end in disaster will do little good. Most people appear to need to try things for themselves and learn the truth by bitter experience. I hate to see Russia take over any more nations. So long, however, as we protect ports, their airfields and broadcasting stations and prevent the killing or deporting of liberals; it may be better by the end to let civil war rage now. Besides, Russia will some day collapse through internal revolution or economic errors.

Investment Policy
In view of the above, I am absolutely convinced that the safest investment policy today is as follows: Have about 50 per cent of one's assets in good bomb-proof common stocks which would benefit in case our nation now takes the right road. (Avoid companies with all assets in big cities.) Then have about 50 per cent in cash or government bonds as a hedge in case our nation should take the wrong road.

Settlements reached in Washington would be important. They might hasten settlements elsewhere, by setting a pattern for the others.

Here's the score on the telephone unions and settlements:
The National Federation of Telephone Workers has 49 unions with a membership of about 336,000. They are not part of the AFL or CIO.

Because 10 of the 49 unions still had contracts in effect, only 39 of the 49 went on strike.
Those 39 have a membership of about 287,000 workers. They struck many of the other 49,000 in the other 10 unions stayed away from work by refusing to cross the strikers' picket lines.

About 60,000 other telephone workers—members of unions not in the federation—also struck, for the same demands as the union workers, or refused to cross picket lines.
The strike occurred in one way or another in every state except Maine, New Hampshire, Vermont, Rhode Island, Connecticut, Virginia, Indiana and Montana.

In Maryland the workers struck but 2,100 have gone back to work, pending a final settlement. Still on strike were 6,400 clerks, equipment workers and others.
About 1,000 workers in Rochester, N. Y., Fort Dodge, Ia., and Sherman, Tex., have settled for an average raise of \$6 a week and returned to work.

In New York one independent union, not connected with the federation, has settled for a raise of \$4 a week and returned to work.
Two other New York unions have reached the same settlement but stayed away from their jobs, refusing to cross the picket line of still another New York union which has not made a settlement.

Last night three unions, affiliated with the federation, agreed to settle with the Illinois Bell Telephone Company for \$4 a week if their rank and file would accept it.

Negro Home Demonstration News
Home Demonstration work is perhaps the world's most far-reaching voluntary or the job education program for women. The program is carried into rural homes and communities by approximately 3,000 home demonstration agents, joint employees of the state land grant colleges and of the U. S. Department of Agriculture. They are assisted by half a million rural women serving as unpaid, volunteer leaders. Home demonstration work, like 4-H Club work and other phases of the co-operation extension program in agriculture and home economics is financed by the county, state and federal government. Since its be-

ginning around the turn of the century, the scope of home demonstration work has been expanded at the request of rural women to embrace every phase of rural family life.

In today's home home demonstration program, rural women continue to study ways and means of forwarding the family's health, comfort and happiness. In foods and nutrition, they work out ever better ways to provide Johnny and Jane with vitamins and to keep dad from getting colds. Buying wisely, making new garments from old, learning the intricacies of tailoring and making a 2-minute patch are some of the ways they keep the entire family modestly clad. They are making further inroads on household drudgery by modernizing homes and by simplifying work-putting heavy loads on wheels or ironing by the easiest method. They beautify their homes by making slip covers, renovating furniture and perfecting handiworks. To help save off that rainy day, homemakers help their husbands in financial planning, using increased incomes to pay off debts and setting aside a nest egg for the children's education and for security in old age.

Greater family unity is promoted by marriage study groups, planned family fun, sharing responsibility for family chores and serious study of the physical and psychological development of infants and adolescents.

But in the course of their participation in the home demonstration program the interest of rural women have advanced far beyond the four walls of their homes. From better homes to better communities has been a logical step.

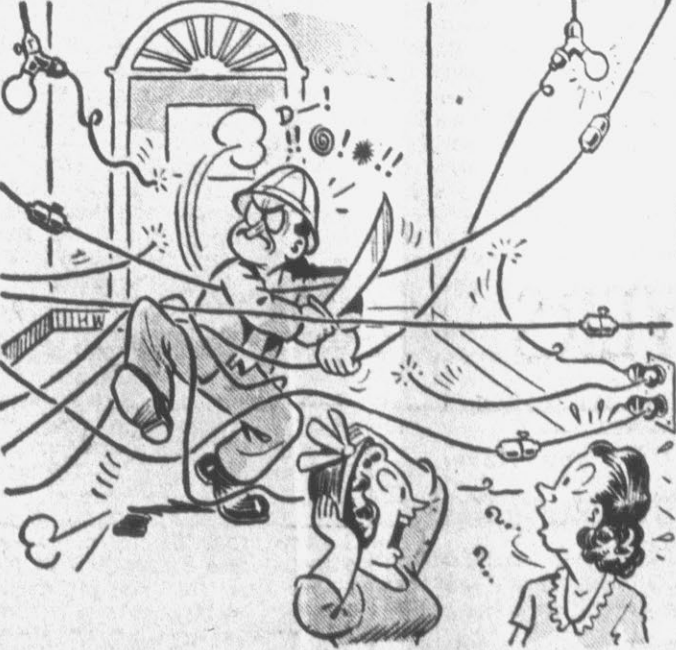
