Dr. Dennis Cooke Resigns His Post

Resignation Of Dr. Dennis Cooke, President of East Carolina Teachers College...

Greenville, May 22.—Dr. Dennis H. Cooke has resigned as president of East Carolina Teachers College...

Dr. Cooke, who became president of East Carolina Teachers College on August 1, 1946, will become head of the department of education at the Woman's College of the University of North Carolina in Greensboro next September.

A committee to recommend a new president to succeed Dr. Cooke was appointed by Dr. Erwin. Serving on it will be T. T. Hamilton of Wilmington, Ralph M. Garrett of Greenville, and Thomas J. Hackney of Wilson.

Dr. Cooke submitted on May 12 the following statement of resignation to Dr. Erwin, chairman of the board:

I am submitting herewith my resignation as President of East Carolina Teachers College effective September 1st, 1947. May I take this occasion to thank you and the Board of Trustees for the one hundred percent cooperation and support which have been given me and my administration. Also, I am offering my full cooperation and assistance to the board in locating a desirable person to take my place.

At a meeting of the college Board of Trustees in Greenville on May 21, Dr. Cooke read the following statement concerning his resignation:

"This resignation has just been read to you by the chairman of the board at its first meeting since the resignation was placed in his hands. I should now like to make a fuller statement.

"On May 12 I submitted in writing to the chairman of the board my resignation as president of the college to become effective on September 1, 1947, and offered my services in helping the board to locate a suitable person to take my place. I should now like to make a fuller statement. First, I should like to thank each member of the board for his one hundred percent cooperation and support. If you support my successor as you have me, as I am sure you will do, his administration should prove effective as I feel my administration has been.

"Entering upon my duties on August 1st of last year, I have given my time and energy without stint toward the solution of the problems of the college. Although some of these problems will still be with us at the conclusion of my tenure of office, a great many of them have been solved. To mention but a few, thanks to the General Assembly that adjourned a few weeks ago, the college will be able to operate for the next biennium on the best financial structure of its entire history in addition to an appropriation of over two million dollars for new buildings and other permanent improvements.

"Three new departments have been authorized for the opening of school in September, a Bureau of Field Services and the addition of a kindergarten and an eighth grade to the training school. Three other departments have been reorganized and greatly strengthened, effective (Continued on Page Five)

Bevin And The Press

Britain's outspoken foreign secretary cites news coverage as handicap to international negotiations; despite his ire, newsmen are welcomed

Britain's outspoken foreign secretary, Ernest Bevin, says one of the greatest handicaps in international negotiations (specifically the recent Big Four Conference in Moscow) is that a chap can't even think out loud without his thoughts being "hurled into headlines in the press."

U.S. Secretary of State Marshall disagrees with this conclusion, and favors full news coverage. One suspects that Mr. Bevin really feels the same but has been tried for the moment by some unwise reporter's persistence and has let the sun get down upon his wrath. Maybe, too, the fiery foreign secretary himself contributes a wee bit to his difficulties by thinking out loud so explosively. At times he launches his thunderbolts with jovian abandon. Anyway, one feels sure that Bevin wouldn't turn back the clock on a freedom of the press to which England has contributed so much during the past generation of progress. ANDERSON IS PAROLE FROM STATE PRISON

Negro Charged With Arson And Murder Of Three; Killed His Brother In 1936

Booker T. Anderson, 29-year-old Negro truck driver, who is being held in jail without privilege of bail on the charge of setting fire to a Negro dwelling house in which a mother and two children burned to death last Thursday night (May 15) will be given a preliminary hearing at an inquest to be held at the City Hall on June 2, at 7:30 p.m. County Coroner Griffin H. Rouse announced today.

The dead are Mrs. Willie Belle Cratch, 27, and her children, Bobby Gene, 7, and Jessie Juanita, 1. Firemen found one child dead on the burned bed, the other dead on the floor, and the mother unconscious in an adjoining room. She died at a hospital several hours later.

Mrs. Annie Belle Spain, the dead woman's mother, suffered serious cuts on an arm when she broke open a window of the burning house to rescue the occupants. Police arrested Anderson on suspicion and then released him. They re-arrested him shortly afterwards when new evidence was found. Chief Tanner said Anderson admitted that he started the fire in the room in which the family was asleep by igniting a pan of kerosene oil under the bed and left. The Negro was taken back to the scene, where he reenacted the crime for police and (Continued on Page 5)

Find Wreckage Of Luxury Plane

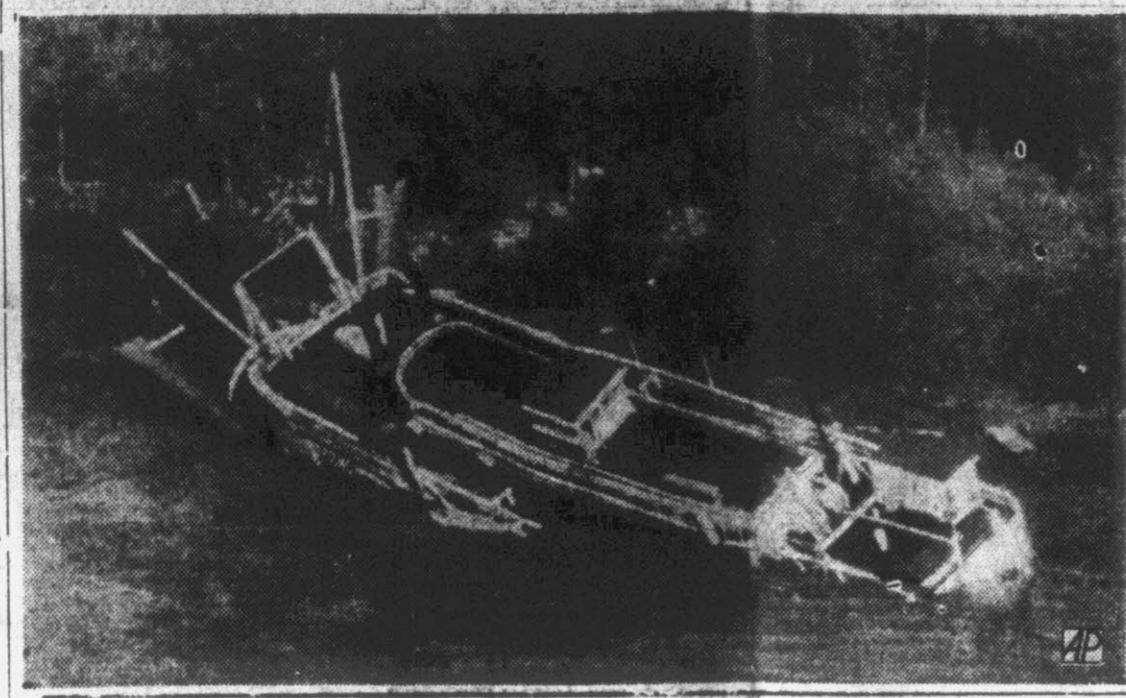

Greece-Turkey Aid Bill Is Signed By President

Proclaims Measure A "Step Toward Peace" By Bolstering Weak Countries Against Outside Aggression

Kansas City, Mo., May 22.—(AP)—President Truman, proclaiming it a step toward peace and a support for the United Nations, signed the \$400,000,000 Greek-Turkish aid bill today before a battery of cameras in a midwestern hotel room.

He told assembled newsmen later that he could not emphasize too strongly this purpose of the bill to set in force a historic foreign policy of bolstering weak countries against outside aggression. He also emphasized, in reading his prepared statement, that the funds called for under the measure will not be used to benefit "any particular group or faction in either country."

The president complimented Congress for its action in supporting his appeal and paid tribute to the press of the country for their big contribution in informing the American people of the issues involved in the legislation.

He issued simultaneously an executive order transferring certain administrative authority under the bill to the secretary of state. His press secretary, Charles G. Ross, said the appointment of an administrator to be direct the program was being worked on in the capital.

Mr. Truman announced that U. S. ambassadors in Greece and Turkey were being instructed to enter into immediate negotiations with the two governments for the expenditure of the funds, which he asked for March 12 to help halt the spread of communism in the near and middle east.

Head Of Trainmen's Union Predicts Walkout Unlikely Before November

Washington, May 22.—(AP)—Five big unions prepared today to bargain out their demands on the railroads under procedure which will delay any strike showdown for perhaps six months. A. F. Whitney, president of the Brotherhood of Railroad Trainmen told reporters: 1. The railroad labor organizations feel they have a legal right to call a "quickie" strike any time after Sunday—but do not plan to do anything of the sort. 2. He believes his union and four others allied with it will agree to start from scratch under the time-consuming railway labor act in their new negotiations for changes in 44 working rules. 3. He thinks this should result in a settlement or a breakdown of negotiations by Nov. 1.

New Ambassador To Philippines

Kansas City, May 22.—(AP)—President Truman announced today he is appointing former Democratic Representative Emmet O'Neal of Kentucky as ambassador to the Philippines.

O'Neal's nomination to succeed Paul V. McNutt, first ambassador to the new republic, probably will go to the senate tomorrow. The announcement was made from the President's temporary headquarters in the hotel Muehlebach here where he has set up operations since the illness of his mother.

British Claim Goal Is To Prevent War

Labor Party Leaders Gird For Showdown With Leftist Bloc On Policies; Deny Choosing Sides For Future Conflict

London, May 22.—(AP)—Labor Party leaders, girding for a showdown with a leftist rebel bloc at next week's annual party conference in Margate, declared today that the aim of British-American understanding is to prevent war.

"The Labor Government," the ruling party's leadership said in a booklet published today, "does not propose to take sides in a lineup for the next world war." The booklet, entitled "Cards on the Table"—a phrase much favored by Foreign Secretary Ernest Bevin—was designed in part to disarm casual left-wing critics of British foreign policy, who contend that Britain is snubbing Russia and aligning herself too closely with the United States.

WILL SETTLE TAX CUTTING ISSUE MONDAY

Senators Will Vote On Motion To Postpone Action Until June 10

Washington, May 22.—(AP)—The Senate agreed today to vote at 3 p. m. (EST) Monday on a motion to postpone action on the \$4,000,000,000 income tax cutting bill until June 10.

The Senate gave unanimous consent to the request made by Senator Millikin (R-Volo), floor manager of the bill.

Senator George (D-Ga.), author of the postponement motion, said he voting time was satisfactory to him.

Democratic senators were wheeling up their heaviest artillery to put the George motion over. Republicans admitted the outcome will be close.

Democratic Senator Byrd of Virginia, who has been waiting 14 years for a balanced budget, was ready to back up the demand of Senator George (D-Ga.) that the legislation be postponed until June 10. Minority leader Barkley (Ky.) and Senator Tydings (D-Md.) were prepared to speak when Byrd concluded.

OPPOSES U. N. BORDER WATCH

Bulgaria Serves Notice, "Will Not Abrogate Rights"

Lake Success, May 22.—(AP)—Bulgaria served notice on the United Nations Security Council today that she would oppose any move to keep a permanent U. N. border watch commission operating in the Balkans.

Such a plan is now being debated in Geneva by an 11-nation temporary investigating group, which still has an interim body posted in northern Greece.

Boyan Athanashev, Bulgarian representative to the council, said he doubted that any nation would agree to any body, no matter what its origin, to remain indefinitely within its border.

"We agreed to cooperate with the commission (the Geneva group) but we have not abrogated our rights," he said. "Bulgaria cannot be expected to permit a commission to remain indefinitely."

He said the interim watchers should get out of the Balkans, where they have been keeping a vigil over the Greek frontiers with Albania, Bulgaria and Yugoslavia, as soon as the council takes up the Geneva report. Secretary-General Trygve Lie estimated earlier that the report would be delivered here June 8 or 9.

Make Progress In Korean Talks

Seoul, May 22.—(AP)—The joint U.S.-Soviet commission seeking agreement on establishing a unified provisional government of Korea was reported to have made "very favorable progress" on administrative matters at its first closed business session today.

"Nationalize"

Oakland, Calif., May 22.—(AP)—Henry A. Wallace last night proposed nationalizing coal, lowering prices and profits and increasing wages as a part of a program to prevent depression.

He addressed an overflow audience in the Oakland auditorium and today prepared to speak in the streets of neighboring Berkeley.

Wallace's proposals to prevent a depression included "an all-out program for world reconstruction" which, he said, "is to be a part of an overall program to abolish war."

Wallace said leadership for such a program must come from the organized trade union members of America, "reinforced by the forward looking people among the scientists, artists and professional people."

MAY APPEALED FOR JUSTICE

Defends Letters To Eisenhower; Gives His Version

Washington, May 22.—(AP)—Former Congressman Andrew J. May told a federal jury today that he had appealed to Gen. Dwight D. Eisenhower to intervene in wartime court martial proceedings against a munitions maker's son because he wanted to see justice done.

Testifying for the fifth day in defense of fraud charges, May related that in 1945 he twice wrote Eisenhower, then allied commander-in-chief in Europe, urging him to review the case of Capt. Joseph Garsson, son of Murray Garsson.

Capt. Garsson was convicted by a court martial on charges of failing to obey a battlefield command. His sentence of dismissal from the army was later suspended and he was placed on the army's inactive list.

May said, too, that he had no idea how his letters got to Eisenhower because he had left that matter to his office force. The jury has received testimony that one letter went to Eisenhower in Europe by plane with an army major (Continued on page seven)

Food Ships Now Arriving In Hungry Germany

Berlin, May 22.—(AP)—Bremen port authorities announced today that 116 ships loaded with nearly 1,000,000 tons of food were arriving from May 1 to July 18 to alleviate the critical shortages in the American and British occupation zones.

While five of the ships were unloading in Bremen and others were discharging food cargoes in Hamburg and Emden, Air Marshal Sir Sholto Douglas, British Military Governor, told the Germans they had no right to demand continued sacrifices from Americans and Britons to feed their conquered land. He advised German politicians to collect and distribute better the available food stuffs.

Judge Withholds Customary Thanks Of Court As Jury Ends Case; Jury Foreman Refuses To Discuss Action; Defendants Jubilant

Greenville, S.C., May 22.—(AP)—Twenty-eight white men were acquitted at their mass murder trial last night of charges they lynched a 23-year-old Negro.

The verdicts were returned last night in Greenville County's stifling courtroom after a nine-day trial unprecedented in Southern history. The state had demanded convictions—but not death—against the alleged murderers of Willie Earle, who was taken from Pickens County jail before dawn Feb. 17 and lynched in reprisal for the stabbing of a white taxi driver.

Agents of the Federal Bureau of Investigation and local state police moved quickly into the case and within 24 hours had incriminating statements from self-acknowledged members of the mob. Eventually, 26 defendants signed unsworn statements, admitting to police they had helped take the Negro to an old slaughter pen where he was bludgeoned, slashed and shot to death.

A county grand jury indicted 31 men for murder, conspiracy to commit murder, and of being accessories both before and after the fact. All were brought to trial in Greenville Criminal Court. Three won directed verdicts of acquittal.

In closing the state's case, Prosecutor Samuel Watt and Robert Ashmore appealed to the jury to act as the public conscience of South Carolina.

The jury, however, heeded the plea of Defense Counsel Thomas Wofford, who criticized Northern "interference" and demanded acquittal to "show them it's no use meddling in Greenville County."

The defense offered no witnesses or testimony and no defendant took the stand.

Circuit Judge J. Robert Martin, Jr. declined comment on the verdict. He withheld the customary thanks of the court when the jury ended the case.

"Gentlemen," he said, "you are free to go. The clerk has your checks and you may pick them up at your pleasure."

The jury had deliberated five hours and 15 minutes. Defense Attorney Wofford hailed the acquittal as "what we expected" (Continued On Page Eight)

Mixed Reaction To Acquittal In Lynching Trial

Greenville, S.C., May 22.—(AP)—Mixed reaction today greeted the acquittal of 28 white men in the lynching of a South Carolina Negro. With outspoken jubilation from many and curtly-spoken disappointment from others.

Greenville, itself, was drowsily quiet. There was no evident surprise for no white man has been convicted in South Carolina for slaying a Negro for nearly a century. One eminent lawyer, whose firm had declined to represent the defendants, said a majority felt satisfaction with the acquittal, but observed: "There are a number of us who feel profound shame."

One significant reaction came from a highly-placed official who declined quotation by name. He said: "You would not have gotten any different verdict anywhere south of the Mason-Dixon Line, except perhaps from a blue-ribbon jury."

A government agency, the food and drug administration (FDA), is trying to stop them.

It can do this because there's a law against selling healing devices that pretend to work cures they can't work.

This week one of the FDA heads, Charles W. Crawford, an associate commissioner, said:

"At present there is an epidemic of serious violations by unscrupulous adventurers in the business of selling cure-all therapeutic devices. During the past year or so we have had to deal with scores of contraptions of this kind."

Some years ago a friend told me

## WASHINGTON LETTER

Washington—A recent report to  
the State Department from Brazil  
tells the latest progress in efforts  
to repudiate Japanese propaganda in  
that country to the effect that Japan  
had won the war.

For a long time some 20,000  
recalcitrant Japanese immigrants in  
Brazil were convinced their country  
had won the war. Japanese language  
newspapers circulated fake pictures  
of Truman bowing to Hirohito and  
of General MacArthur saluting the  
Japanese flag. Accompanying text  
lauded the supposed Japanese victory.

The department's Office of International  
Information and Cultural Affairs  
(OIC) distributed through the  
area 3,815 authentic newspapers  
from Japan telling the true story.  
This, together with visits of an OIC  
sound truck and showings of the  
navy film on the surrender have  
"driven the lesson home," according  
to state department officials.

The Washington Post's columnist,  
Jerry Klutz, tells about the  
librarian of a federal agency seeking  
to subscribe to a Kentucky law  
journal.

The librarian sent along several  
blank vouchers to be filled out in  
detail before the publishing house  
could be paid by the government for  
the subscription. He got this reply:  
"We are glad to enter your subscrip-  
tion to the Bar Journal free of  
charge—if we don't have to make  
out all these forms."

Once a year members of the Congressional  
Club—wives of Senators  
and Representatives—put on their  
very best smiles, straighten their  
husband's ties and whip up their  
finest refreshments. They are  
entertaining the President and First  
Lady of the United States.

This year something extra  
special highlighted the affair. Rare

### Ambassador Dies Before Leaving For Uruguay

Bryan, Tex., May 22—(AP)—William S. Howell, 54, business man, attorney and veteran of the U.S. diplomatic service, died at 5:30 a.m. today, one-half hour before he was to leave for South America to assume his new post as U.S. ambassador to Uruguay.

Howell's death recalled the fatal heart attack suffered Feb. 6 by O. Max Gardner, 64, in New York eight hours before he was to sail for England as U.S. ambassador to the Court of St. James.

At 5:30 a.m., Howell's stepmother, Mrs. W. S. Howell, called to awaken the recently appointed ambassador. Receiving no answer, she went to his bedroom and found him unconscious. He died a few minutes later without regaining consciousness. The cause of death, not immediately announced, was believed to have been heart trouble.

A native of Bryan, Howell served in the diplomatic service from 1916 until 1935.

(Continued on Page Four) In September, music, physical education, and student medical services. Graduate work has been strengthened. Student conduct and discipline have improved greatly. Due largely to the efforts of the Director of Student Affairs, an office created in March, a new and much improved constitution for the student government has been written and adopted.

Both student and faculty morale have improved significantly since August first. It can be truthfully said that the morale among these groups and the alumni of the college is quite high. Every member of the faculty and staff has given me his or her complete cooperation and support. A definite retirement system, a salary schedule, and a system of academic ranks for the faculty have been adopted and put into effect. The athletic program has been expanded significantly. "A competent faculty has been

employed for the greatly enlarged summer school beginning next month. Only a few positions on the faculty remain to be filled for next year, all of which will be filled by September first. A large number of faculty with Ph.D. degrees have been employed for next year. Although much remains to be done on September first I shall leave the college in much better condition in many ways than I found it on August first of last year.

"In view of the opportunity for rendering a greater service in a larger institution, I have decided to accept and have accepted the Headship of the Department of Education (teacher training) at the Woman's College of the University of North Carolina as of September first, 1947."

After the reading of the statement, Dr. Erwin stated that the board discussed the resignation at great length, every member of the board expressing the highest commendation for the splendid work which Dr. Cooke has done at East Carolina Teachers' College during his administration beginning last August. It was the consensus of the board that greater progress had been made during his administration than in many years, the enrollment of the college having reached 422, with a prospective enrollment of more than 1300 for the fall term. Dr. Cooke was urged to reconsider his decision but after stating that he felt that he had an opportunity to render greater serv-

He claimed he did not know the woman and children were asleep on the bed when he started the fire. He said he entered the house through the unlocked front door.

Police looked up Anderson's record and found the following: Under the name of "Booker T. Andrews," 18, he was convicted in Pitt County Superior Court December 28, 1937, after pleading guilty to second degree murder of his brother, Theodore Anderson. Testimony in court at that time was that Anderson shot and killed his brother during a fight about an automobile key in Greenville on Christmas Day, 1936. In Superior Court several days later he was convicted of second degree murder and sentenced to 30 years in State Prison.

While in prison, the record shows Anderson seriously wounded a fellow prisoner in a highway prison camp and caused a disturbance during 1941 and 1942. The governor paroled Anderson in 1944 after serving less than eight years.

Chief Tanner said Anderson will be charged with setting fire to the house here and the murder of the Negro woman and her two children—all capital offenses. Anderson is a son of Wiley Anderson of near Greenville.

### VA Official In State To Resign

Raleigh, May 22—(AP)—Col. Wiley Pickens said today he planned to resign within the next two months as director of the North Carolina Veterans Administration, and would succeed Col. Paul Younts as executive vice commander of the American Legion, Department of North Carolina. Col. Younts plans to enter private business in Charlotte.

Col. Pickens, who has held his present post since August 24, 1943 said he did not know who would succeed him. His post is filled by appointment by the governor, subject to approval of the governor.

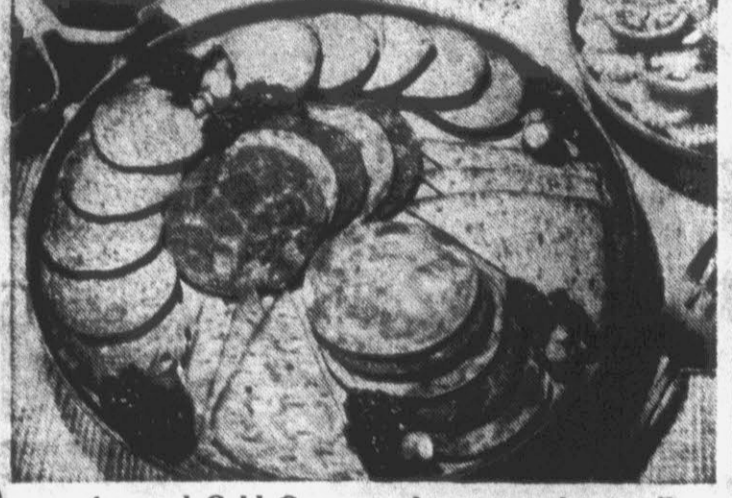
