AIRPORT WILL HAVE MODERN HANGAR SOON

County And City Building 80x100-Foot Structure; Pilots' Training School

By CHESTER WALSH The steel and concrete reinforced hangar at the Greenville Airport now under construction will have a 15-foot clearance between the ceiling and floor. Doors at both ends will open the full width of the building and permit storing large planes. Willard T. Kyzer, executive secretary of the Airport Commission, said today.

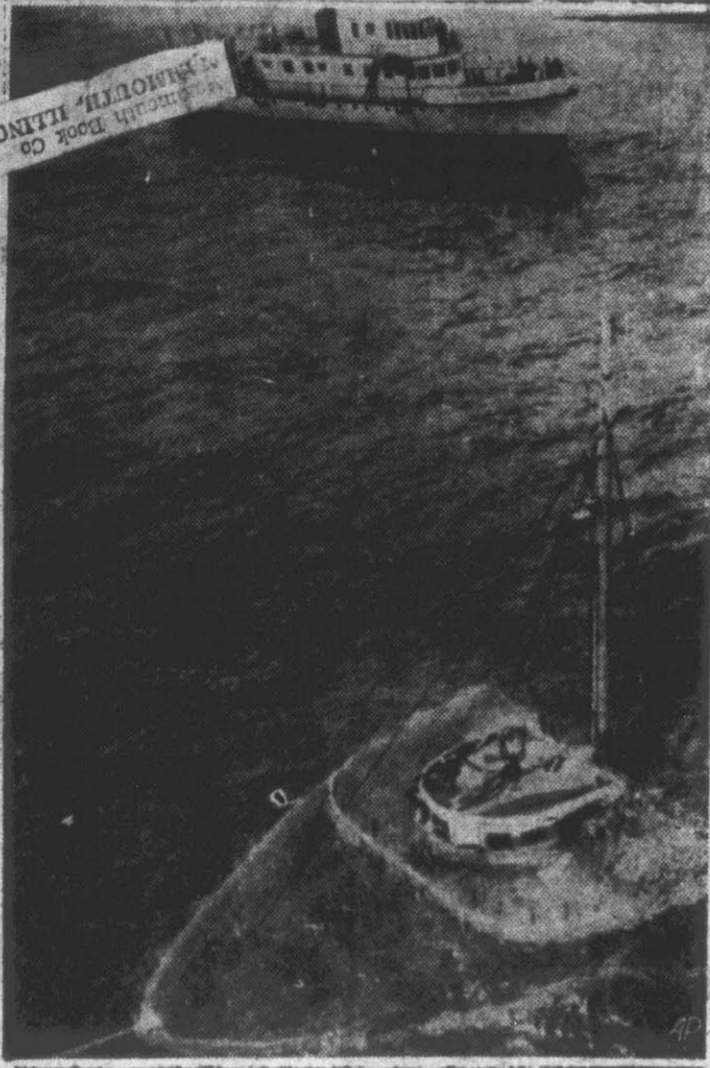
The hangar is 80 by 100 feet, with steel trusses, aluminum covered roof, reinforced concrete floor and concrete block walls. It is located farther back from the field to permit clear vision from the signal tower as a safety feature. A. L. Jarrel & Sons of Salisbury is the contractor.

Barnes Aircraft Services, Inc. operator of the airport, is providing 24-hour service for outgoing and incoming planes. The base operator is providing excellent services for planes, pilots stopping in Greenville. The company's mechanical service department is in charge of a specialist. Planes of all types may be serviced or repaired here.

The Barnes company is conducting an aviation school for GIs and other civilians. Several students have graduated within recent weeks. In addition to trainer planes, the company has available large type ships for charter for long or short trips. In addition short fee may be had at the airport any flights over the city for a nominal day in the week.

Paris, June 12.—(AP)—The French government granted the French railroad workers salary boosts today, thus ending a six-day national rail strike, the worst transportation tieup in the country's history.

The railroad workers union ordered its members back to work after an all night series of conferences at which agreement was reached for settling the work stoppage, and five minutes later Premier Paul Ramadier and Transport Minister Jules Moch signed the accord, making its terms official.

4-H CLUBBERS LEAVE MONDAY

One-Hundred Fifteen Pitt Members To Attend Five-Day Camp

Monday, 115 4-H Club members of Pitt County will leave for Camp Manteo where they will spend five days on Roanoke Island camping under the supervision of the 4-H Club leaders.

In order to be eligible to attend the five-day camp each person must have been a club member since last fall and must have completed his project record book which consists of an acre of some crop cultivation for the boys or a sewing or home-making project for the girls.

Cucumber Growers Told Crop In Danger

County Farm Agent Samuel C. Winchester today warned county cucumber growers to take steps to prevent the cucumber disease which last year took some 30 per cent of the local cucumber crop and damaged about 50 per cent of the cucumber crop of the state.

Winchester said the disease has appeared in Scotland and New Hanover counties and other nearby counties, and is expected to appear in Pitt county within the next two weeks.

A letter is being sent out by the county farm office instructing cucumber growers and advising steps which may be taken to prevent damage by the disease.

Yesterday Was Hottest Day This Summer

By CHESTER WALSH Weather forecasters are having the same troubles which beset baseball umpires during this long and dry spell, it appears. They mention rain, but where is it? Farmers want to know. There's been exactly three one-hundredths of an inch of rainfall here during June and it hit the ground, bounced and evaporated!

Weather report for today: Your guess is as good as ours! Incidentally, yesterday was the hottest day of the year, with the mercury in the Weather Bureau thermometer soaring at 101 degrees in the late afternoon.

It was the hottest day here since June, 1944, when the temperature was 102 degrees for several hours before a torrential five-inch rainfall which flooded city streets and saved growing crops. Farmers had fine tobacco crops that year.

Official readings of the Weather Bureau thermometer here yesterday and today follow: Wednesday—7 a. m., 77 degrees; 1 p. m., 99 degrees, and 101 later in the afternoon.

Today—1 a. m., 73 degrees. At 8 a. m. it was 78, and rising rapidly. Clouds passed over during the forenoon, but they did not stop.

PROBERS PLAN SCRUTINY OF WALLACE TALK

Southern Conference For Human Welfare Checked For "Red" Taint

Washington, June 12.—(AP)—Chairman J. Parnell Thomas (R-NJ) said today the House Committee on Un-American Activities will have "loyal observers" present when Henry A. Wallace speaks here Monday under sponsorship of the Southern Conference for Human Welfare.

The committee, which has been investigating communism, plans to issue a report on the Southern conference over the week-end. In 1944 it listed the organization as a Communist front.

Thomas said the forthcoming report lists Wallace as a "loyal associate of the conference."

Both the conference and Wallace have denied Communist ties or sympathies.

Dr. Clark Forman of Atlanta, conference president, said in a statement yesterday he hopes the report will not be one of "smear-by-impugning in an attempt to discredit Henry Wallace."

Thomas told reporters that is "doubtful."

He said the former vice president's name is mentioned in the report only once, as an advisory associate in a 1947-48 list of conference officers.

The observers at Monday night's program, Thomas said, will take note of who sits on the platform, how the conference conducts meetings and any literature that may be distributed.

Proceeds of ticket sales will go to the conference for its "regular work," a spokesman had said.

Forman said the Southern conference would welcome "an honest, accurate and complete report" because it feels that would "end the slurs and smears to which we have been subjected by the enemies of progress in the South."

But he said he does not see how a complete report could be written when no conference officer ever had been asked to appear before the committee. A thorough investigation, Forman said, should involve public hearings and questioning of organization officials "in the American manner."

MEAT PRICES AGAIN RISING

Chicago, June 12.—(AP)—The jangling steers and the grunting hogs jumped back again into the public spotlight today and there were innumerable charges and counter charges in explanation for the sudden boost in meat prices in livestock markets and in butcher shops.

Average price of steers and yearlings at Chicago yesterday rose to an all-time record high at approximately \$26.00 a hundred pounds according to the Department of Agriculture. This topped the peak of \$25.40 established last October immediately after OPA ceilings were removed. For the first time since March 5 the top reached \$30.

Cattle receipts at Kansas City yesterday, the largest for a June 11 in 25 years, advanced to the best price since January.

Meanwhile, retail meat prices also advanced during the past several weeks and representatives of butchers in the east blamed the meat packers. In Newark, N.J., butchers threatened to close shop unless prices come down.

Large packers in Chicago, discussing talk of heavy foreign exports, said advancing meat prices represented an "amazing" domestic consumer demand, particularly for beef. This, they said, also was reflected in the high price for beef cattle at livestock markets.

United Nations Expected To Ultimately Hear Case

Washington, June 12.—(AP)—Diplomatic authorities freely predicted today that Russia will either reject outright or try to hamstring the American demand for a Big Three inquiry into the Communist grab in Hungary.

In either event, these officials declared, the United States in all probability will carry the case to the United Nations—perhaps in some manner designed to focus the spotlight on Soviet activities all through the Balkans.

This country laid the foundation for such an appeal last night when it made public a blistering protest charging Moscow with "flagrant interference" in Hungarian affairs and demanding a three-power investigation of political conditions in Hungary "as a matter of urgency."

The note was sent to Brig. Gen. George H. Weems, American member of the Allied Control Commission in Budapest, for delivery to Lt. Gen. V. P. Sviridov, ranking Soviet member and acting chairman of the commission.

The document brought out the fact that on two previous occasions, March 5 and March 17, substantially the same request had been turned down by Sviridov. Hence authorities here said they see no reason to believe that it would get a different reception by the Russians this time.

SHAKEUPS IN PITT SCHOOLS CARRIED OUT

Four Changes In Principalships; Conley Spurs Improvement Program

Superintendent of County Schools D. H. Conley today announced four changes in the principalships of the county schools for next year, and also several improvement programs are being carried on in schools throughout the county in preparation for opening next fall.

Conley stated that Sam Bundy of Farmville, former principal of Tarboro schools, has been appointed principal of Farmville schools to replace J. H. Moore who resigned to accept the position of superintendent of Pasquotank county schools.

Leslie E. Murray, principal of Belvoir school for two years, has been appointed principal of the Grimesland school to replace M. L. Basnight who has accepted the principalship of Central School, a large consolidated school in Pasquotank county.

Ola H. Forrest was appointed principal of the Pactivox school to succeed T. M. Grimes. As yet there has not been an appointment to fill the principalship of the 3000s school, vacated by W. E. Knight, who has accepted the position of principal of the Aurora school in Beaufort county.

Conley stated there are only 35 vacancies in the county schools at present as compared with 73 vacancies a year ago. "This indicates," he said, "the situation is much more stable than a year ago."

The transportation program of the county schools, according to Conley, is approximately one year behind schedule because of the shortage of steel with which to make bus bodies. The replacement program for the year '46-47 called for 23 new buses of which only 10 were delivered. The remainder will be delivered before September 1.

Renovation is being carried on at the Fountain school, Bethel elementary school, the Arden colored school and in Grifton a school lunchroom is being constructed.

Zoning Measure Before Aldermen Next Tuesday

By CHESTER WALSH The Board of Aldermen will meet at the City Hall next Tuesday night, June 17, at 8 o'clock to consider the proposed zoning ordinance for the city. Interested citizens will be heard at that time. After thorough consideration, the zoning measure will go before the board for passage.

Mayor Jack Boyd said today. George C. Franklin of Raleigh, attorney consultant for the North Carolina League of Municipalities, who spent two days in Greenville last week, explaining the advantage of the zoning system, made a convincing impression on citizens at a public meeting last week when the matter was discussed at length.

In simple language the zoning law will prohibit the placing of a soap factory, blacksmith shop or some other undesirable line of business, in a strictly residential section. The city has been zoned with fire districts for some time to the mutual advantage of everybody. Zoning of the city into commercial and residential districts will have a beneficial effect as the city grows, it was pointed out.

Lobbying In Congress

Once A Year There's A Protest In Congress Over Professional Lobbyists; Two Kinds — Registered And Undercover Boys; Various Methods Are Used

Washington, June 12.—(AP)—Maybe you're a lobbyist but don't know it. You're one of those who try to influence your congressman, by word or letter, to vote for or against something.

That's your right. Plenty other private citizens do it all the time. That's how congressmen are supposed to know what the people are thinking.

But about once a year there's a cry of pain in the capitol against the professional lobbyist, either out in the open or not out in the open.

Last year Rep. Sabath, Illinois Democrat, raged against them. Now Senator Cain, Washington Republican, complains.

A lobby may be an individual or a group wanting congressmen to do something. Lobbies have swarmed through the capitol for years.

To get some of them on the record as lobbyists, Congress last year passed a law which said:

A person whose main purpose is lobbying, must register. About 700 have registered as professional lobbyists.

But they're being out in the open kind. Being registered, they can walk into a congressman's office and say what their group is for.

But their kind of lobbying is pretty crude compared with the not so out in the open lobbyist.

These are the boys who:

1. Have a regular job somewhere else but come to Washington to do a little lobbying for one special bill, and then go home again.

2. Work here but are too smooth to hang around the capitol. They try to do their lobbying elsewhere.

For example: By throwing a cocktail party for a few friends and a few congressmen; or maybe playing golf with a few congressmen.

Last Ration Books No Longer Required

Sugar Rationing Ends For Home, Restaurant And Hotel Use; Sugar Price Controls Remain; Anderson Beats GOP Schedule

Washington, June 12.—(AP)—The last war-imposed coupon control over the American public vanished today, as sugar rationing for home, restaurant and hotel use ended at midnight.

After five years in which ration stamps meant more than money—when it came to meat, canned goods, shoes, tires, gasoline and a host of other things—individual Americans are free of coupon worries for the first time since April 28, 1942.

The last ration book can be thrown away.

However, sugar price controls remain. So does rationing of industrial sugar. But these two curbs are scheduled to end Oct. 31.

Secretary of Agriculture Anderson ordered the sugar ration end late yesterday, thus beating the Republican-controlled Congress to the draw. The House had set for a vote today a bill calling for an immediate end to household sugar rationing.

SNYDER HINTS TAX ATTITUDE

Latest Statement Indicates Favoring Veto Of Bill

Washington, June 12.—(AP)—A statement by Secretary of Treasury Snyder that "we must know what our expenditures are going to be before we cut our revenues" gave a strong new hint today that he has urged President Truman to veto the income tax reduction bill.

Snyder has made no secret, before congressional committees and elsewhere, of his belief that a reduction in the public debt should take precedence over any tax cuts this year.

But his latest statement at a news conference yesterday, was widely interpreted to mean that he has suggested to the president that he turn down the bill slashing income taxes from 30 per cent in the lowest brackets to 10.5 in the highest.

"I am not against the principle of tax reduction," Snyder said. "I (Continued on Page Six)

China Is Desperate

Border Trouble In Remote Sinkiang Is Chronic; May Be No Ordinary Frontier Incident; American Help Wanted And Needed By Chinese Nationalists

By JAMES D. WHITE The real news about China's border trouble with the Outer Mongolians in the great western province of Sinkiang isn't so much that it has happened, but that we have heard about it.

It would be hard to find anywhere in the world so vast an area (twice as big as Texas) so remote, such a confusion of races and faiths, so habituated to conquest and misrule or no rule at all.

The Chinese empire had Sinkiang for hundreds of years and never got it under full control until the great General Tso Tung-tung, nearly a century ago, subdued it in a campaign which took years because his troops had to plant crops as they went along.

Even today it takes a Chinese official three days by air to reach the border region where the trouble with the Outer Mongolians is reported to be taking place.

In Sinkiang he finds a relative handful of Chinese officials, merchants and settlers ruling as a small minority among one to four millions of polyglot tribesmen, (no one really knows how many) most of whom have racial connections in Outer Mongolia or in Soviet Russia itself.

This means trouble, internally and along borders. Sinkiang has seen many revolts in recent years, and during one three years ago Chinese troops chased some Kazakh tribesmen across the line into Outer Mongolia—and they used planes, too.

But it's all so far off that you just don't hear about Sinkiang unless things get worse than usual or unless somebody has some "other reason" to tell you.

As has been widely noted, Russia's "other reason" for letting her Mongol satellite get involved with Sinkiang would be part of her reaction to the Truman foreign policy.

TRUMAN ASKS CREDIT REINS

Recommends Extension Of Controls On Consumer Credit

Washington, June 12.—(AP)—President Truman recommended today that Congress pass a bill permitting continuance of controls on consumer credit in peacetime.

Unless Congress does this, Mr. Truman said he plans to end the present regulations, based on wartime legislation. These regulations, under executive order, fix the size of down payments and fix the length of time in which the balance due must be paid by installments.

These controls affect purchases of such things as household goods, refrigerators and automobiles.

Mr. Truman's views were stated in a letter to Marriner S. Ecles, chairman of the federal reserve board, which wields the controls on installment buying credit. Ecles read the letter to the House Banking Committee.

Mr. Truman's letter said: "I hope that the Congress will enact the necessary legislation to retain restraints upon excessive expansion which results in excessive contraction of consumer credit and thereby making for economic instability, reduced production and unemployment."

Dry Summer Ahead For Franklinton Despite Election Victory For Wets

Franklinton, N.C., June 12.—(AP) It looks like a dry summer for Franklinton County.

That's no weather forecast. It's a one-sentence picture of a heated fight being waged by the wets and the dries. That picture holds although the wets won a one-sided victory here yesterday in a municipal-option election over Alcoholic Beverage Control stores.

It will be the picture if the wets win in a similar ABC election in Lenoir County July 1.

Court action will block the establishment of Franklinton ABC stores, although the vote yesterday was 267 to 80 in favor of stores.

Dries already have filed a petition in Wake Superior Court questioning the constitutionality of the last General Assembly's legislation which authorized a referendum in Franklinton. Judge Leo Carr of Burlington, promising to rule June 25, told the wets that even if they won yesterday they could not set up stores until his decision was published.

Dry forces anticipating a decision by Carr for the wets plan a Supreme Court appeal. A similar petition and appeal are planned by the dries should the wets win in Lenoir.

However, the Supreme Court has recessed for the summer, and appeals will not be heard until fall. No ABC stores can open until the high court rules.

It's quite possible, as a Chinese spokesman says, that "this is no ordinary frontier incident."

Meanwhile military observers in Nanking are remembering the many incidents in the past, and pointing out that no matter how serious this one is the Chinese are in no position to do anything about it, really.

It is hard to escape the coincidence of the lifting of Chinese silence about Sinking with the growing and desperate need of the Chinese Government for American help—to bolster an economy wrecked by war and re-wrecked by civil war.

This is needed so badly that at least one Chinese, Cheng Tien-fang of the Nationalist Party, tells me that China's currency must be stabilized with American help if China is to go on paying her soldiers who are fighting the Communists.

There is the question, raised by American businessmen in Shanghai, of whether American help in any form could be prevented from finding its way into the Government's civil war chest.

Another Chinese Nationalist, Major Gen. J. L. Huang, who is now touring this country, puts the issue very differently in an address at Vanderbilt University:

China's civil war, he says, "is a war against the communist design of world conquest. . . I dread to think what shall happen to other democracies of the world, if one-fourth of the world's population should turn to be communist; if one-fifth of the world's territory and if the entire amount of China's should be dominated by the Reds; vast hidden resources should be employed by the opposite camp (the Communists) for the massacre of the human race and the destruction of human civilization."

MAY STIFFEN CHINA POLICY

Mongolian Incident Discussed By Nationalist Gov't

Nanking, June 12—(AP)—A short-lived Chinese-Mongolian border foray by a band of cavalrymen from pro-Soviet outer Mongolia brought demands on the government of China today to adopt a stronger policy toward Russia. The incident last week was discussed at a closed meeting of the legislative Yuan, members said, as some sources viewed the fighting as the first open manifestation that China is in danger of losing Sink-

iang province under possibly Soviet-stimulated demands for autonomy. Foreign Minister Wang Shih Chieh told the legislature that he was not sympathetic to their demands for a firmer attitude in relations with the USSR as soon as the government determines its policy, he said. "It will be carried out with fortitude. Meanwhile, a spokesman for the national defense ministry reported that government troops had recaptured Feitashan, Sinkiang City, where the Mongols and Chinese forces clashed.

Labor Disputes Sharply Curtail Auto Production

Detroit, June 12—(AP)—Labor disputes idled about 18,000 Detroit workers today, keeping closed the Hudson Motor Car Company and cutting down production of Ford clutch assemblies and aircraft engines at Continental Motors Corp. A sitdown strike at Continental's Detroit plant, the first such dispute in ten years, began yesterday but apparently affected only 1,200 day workers, since the company reported operations normal after the change of shifts last night.

A walkout of 600 Hudson salaried workers, members of the CIO United Auto Workers, brought about the shutdown there yesterday. The office workers set up picket lines which kept 15,000 UAW-CIO production employees out of the plant. The Continental strikers, also are members of the UAW.

Potato Buying Not All Loss Says Anderson

Washington, June 12—(AP)—Secretary of Agriculture Anderson said today that not all the criticism heaped on him for efforts to support potato prices has been justified.

Sometimes the government makes a profit, he said, when on the surface it appears to have lost money.

He told a Senate appropriations subcommittee he was widely criticized for making \$15,000,000 available to buy and sell potatoes in an effort to keep prices up in the face of a huge surplus.

Congress has told him to do just that, Anderson reminded the senators, and with the original \$15,000,000 he budgeted for the purpose, he said, the government handled 18,000,000 bushels of potatoes, all of which were sold to distillers.

Net results, he said, was that the government collected \$170,000,000 in liquor taxes it wouldn't have received otherwise.

Receives Death Threat Letter

Washington, June 12—(AP)—Rep. J. Parnell Thomas (R-NJ), chairman of the House Un-American Activities Committee, reported today he has received a letter threatening him with death and has turned it over to the FBI. Thomas told a reporter the three-page, hand written letter warned him of death in June and Rep. Rankin (D-Miss.), a committee member, of death in July. Thomas said one part reads: "This is not a threat or warning or bargaining. Can't bargain with a super race. It is simply a death notice."

The letter is signed "finis" in Latin for "end."

Swedish Relief Official Said Shot In Austria

Vienna, June 12—(AP)—A high Austrian Government official reported today that Russian troops had fired on a Swedish relief agency party last night, killing an automobile driver and wounding Torsen Arnaus, chief of the Swedish mission to Austria.

The Swedish legation later said that it had no official confirmation of the report but that the charge d'affaires had left for the scene of the supposed shooting and that it expected to announce his findings this afternoon.

No comment was available from Russian sources.

The Austrian informant said the dead man was named Carlsen and added that he might have been Arnaus' deputy as well as his driver, but of this he was uncertain.

Agree On Terms Of Rent Control Legislation

Washington, June 12—(AP)—House-senate conferees have agreed on a bill extending rent controls through next February 29 but permitting "voluntary" increases up to 15 per cent if landlords and tenants sign leases running through 1948.

Senator Taylor (D-Idaho) told newsmen President Truman should veto the bill to "place responsibility for destroying rent control where it belongs, squarely on the Republican congress."

But Senator Sparkman (D-Ala.) said "it looks like that bill or nothing."

Before it reaches Mr. Truman's desk, the measure still must receive approval of the full house and senate.

Mrs. Roosevelt Declines To Run

Jamestown, N.D., June 12—(AP) Mrs. Eleanor Roosevelt declined today to become a candidate for vice president, saying "nothing could induce me to run for any public office."

North Dakota Democrats, at an April meeting in Fargo, adopted a resolution endorsing her as a running mate for President Truman in 1948. A copy of the resolution was mailed to Mrs. Roosevelt.


