House Rides Roughly Over Labor Bill Veto

Overwhelming Vote Of 331-83 To Override Presidential Opposition; Senate Will Vote Late Today Or Tomorrow; Truman Will Speak On Radio Tonight

Washington, June 20—(AP)—An aroused House swiftly and overwhelmingly passed the Taft-Hartley Labor Bill over President Truman's veto today.

That put it up to the Senate to clinch the decision on whether the bill is to become law over the President's disapproval. It will vote late today or possibly tomorrow.

The Senate is expected generally to override the veto, but both sides concede the vote will be close.

With a two-to-one margin needed to override a veto, the House vote was 331 to 83. That was 85 more "ayes" than necessary.

In his big battle with Congress over the issue, Mr. Truman called in a group of leading Democratic senators for a White House luncheon—presumably to talk over the veto.

He also announced plans to go on the radio tonight and give the people directly his arguments against the bill. He will speak over all networks at 9 p. m. (EST).

Senator Taft (R-Ohio), one of the measure's sponsors and chairman of the Senate Republican Policy Committee, arranged to follow Mr. Truman at 9:45 p. m. with his side. He will speak over MBS.

The House listened while a clerk droned through President Truman's long message. Then came the vote which smothered the veto under a deluge of both Republican and Democratic votes.

That action did this: 1. Propelled the labor issue directly into the 1948 political campaign.

Will Not Permit Delay Says Bevin

Declares Speed In Launching Cooperative Effort For European Recovery Will Be Guiding Principle; Awaits Reply From Russia

London, June 20—(AP)—British Foreign Secretary Ernest Bevin said that in launching a cooperative effort for European economic recovery under the Marshall plan he intends to brook no delays such as those which stymied the recent Foreign Ministers Conference in Moscow.

Urgently awaiting a response from Russia to a joint British-French request that the Soviet Union participate in drafting an aid-to-Europe program, Bevin declared in the House of Commons last night that "the guiding principle I shall follow in any talks I have on this matter will be speed."

"I spent six weeks in Moscow trying to get a settlement," he asserted. "I shall not be a party to holding up the economic recovery of Europe by the mess of procedure, terms of reference or all the paraphernalia which may go with it."

"The reply of the Soviet Government is awaited," he continued, "and the House will understand that until it is received there is nothing I can usefully say on the subject today; I know the great interest of the House in the U. S. proposals and I wish very much it was possible to say more about the position."

The British press gathered from the tone of Bevin's speech that Britain and France definitely intended to go ahead with work under the suggestions made two weeks ago by Secretary of State George C. Marshall—either with or without Russian participation.

Marshall said in a speech at Harvard University that future American dollar aid to Europe should be based on a continental (Continued on Page Six)

Plea For Acquittal In Treason Trial Denied

Boston, June 20—(AP)—Federal Judge Francis J. W. Ford today denied a motion for "judgment of acquittal" of Douglas Chandler, former Baltimore writer, after the government rested its case against the man accused of treasonably broadcasting Nazi propaganda during the war.

Judge Ford issued his decree after a 45-minute conference with opposing counsel, in the absence of the jury.

The government rested after recalling to the stand Karl Schotte, former Nazi director of broadcasts. He was asked to specify Chandler's duties and replied they were to:

HOLD HEARING ON TAR RIVER PORT INACTION

Shipping Line Manager Says Business Does Not Yet Justify Operations

Wednesday night the Greenville Port Terminal Commission, the Pitt County Commissioners and the Board of Aldermen met with L. G. Hogshire of Norfolk, Va., manager of the Norfolk, Baltimore and Carolina Ship Lines, to hear an explanation of the inactivity of the Greenville port on Tar River and to seek information concerning the resumption of operations and use of the port.

Hogshire told the members at the joint meeting that business in Greenville and the surrounding area had not developed to a stage where reopening operations would be justified, but commented that the situation was being checked closely and water freight operations would be resumed as soon as (in business justified) the expense of such activity.

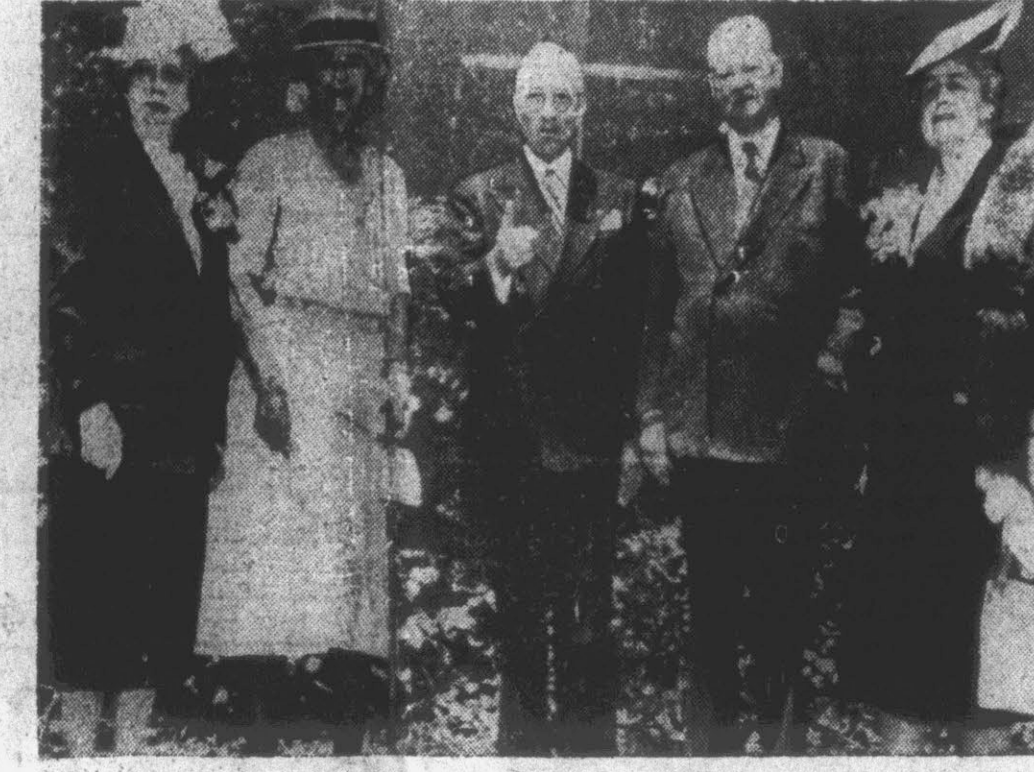
In the explanation of the situation at the port terminal, the ship line manager offered to cancel his lease on the local port if the Port Terminal Commission desired him to do so. In making the offer, Hogshire said his company would not hinder any operations by other shipping lines. He also offered use of one port facilities to any boats which wanted to discharge freight at Greenville. Such boats would pay only the usual wharfage fees.

Hogshire suggested that a committee of one member each from the Board of Aldermen, the County Commission and the Transportation Committee of the Chamber of Commerce be appointed to work with the Port Terminal commission in making a complete investigation of business in the area to bear out his statements, or to recommend cancellation of his lease on the Greenville port.

Labor Union Problems Face Tobacco Industry

Head Of Tobacco Association Describes Obligations And Responsibilities; Lists Other Immediate Problems

Virginia Beach, Va., June 20—(AP)—Clyde B. Austin of Greenville, Tenn., president of the Tobacco Association of the United States told the organization's annual convention today that "we are faced with the problem of increasing labor union pressure on the tobacco industry."

"It is our duty to pay the tobacco workers a wage equal to his productivity," he said, "but it is equally the responsibility of each of us to protect our workers and our industry against the union which does not interest itself in a cooperative and healthy competitive production."

Describing this as one of four "pressing problems" facing the association, Austin listed the others as the expiration of price support legislation with the 1948 crop, the necessity of increasing the proportion of high grade cigarette tobaccos, and methods of developing leaf exports.

"A first consideration for which we must plan now is the expiration of the present price support legislation with the 1948 crop," Austin said. "We must work out a constructive program for our support that will protect growers, warehousemen, dealers, manufacturers and direct consumers. Whether it is by a direct income payment to farmers, a continuation of the parity program, or without reduction of price support, or an entirely new approach, it is our responsibility to work out a program for a healthy tobacco trade through free enterprise methods."

Austin said that if a production control program "is necessary to prevent disastrous overproduction by farmers, the problem of increasing the proportion of high grade cigarette tobaccos being produced arises. In order that our cigarette manufacturers have ample stocks of desirable cigarette tobaccos and to enable them to continue selecting the finest quality of cigarette leaf for their products, it has necessitated production to the point that it leaves undesirable tobaccos in larger quantities than the trade can absorb."

World Speed Record Retained For U. S. By Latest Army Jet Fighter

Muroc, Calif., June 20—(AP)—An Army jet plane, the P80-R, has regained the world speed record for the United States—at 623.8 miles per hour.

Striking but 50 feet above the Mojave Desert near Muroc Army Air Field, Col. Albert Boyd of Asheville, N.C., guided the Lockheed built fighter yesterday on four runs over a 1.86 mile (three kilometer) course. Declares Measure Violates Principles Essential To Public Welfare, By Threatening National Unity; Would Develop Class Basis For Political Action; His Analysis Of Legislation

Washington, June 20—(AP)—President Truman today vetoed the Taft-Hartley Labor Control Bill, saying it violates principles "essential to our public welfare."

Mr. Truman said the legislation is "completely contrary" to basic national policy of "economic freedom."

The message was sent to the House where Republican leaders already had marshaled their forces for a quick vote to override the veto and pass the measure over Mr. Truman's disapproval.

In a 5,900 word message, the President told the Congress members that the legislation is a "clear threat to the successful working of our democratic society."

He declared: "This bill would go far toward weakening our trade union movement, and it would go far toward destroying our national unity."

By raising barriers between labor and management and by injecting political considerations into normal economic decisions, it would invite them to gain their ends through direct political action.

"I think it would be exceedingly dangerous to our country to develop a class basis for political action," the President said there still is a genuine opportunity for enactment of this session "of appropriate labor legislation," and added:

"I still feel that the recommendations which I expressed in the state of the union message constitute an adequate basis for legislation which is moderate in spirit and which relates to known abuses."

He said he was "fairly convinced" the current measure would weaken the economy and weaken the unity of the people.

Disagreeing with the whole philosophy of the labor measure, the President declared it would be "a dangerous stride in the direction of a totally managed economy," said "it contains seeds of discord which would plague this nation for years to come."

In an analysis of the legislation, President declared he had put four tests. He said: "I had considered whether it would result in more or less government intervention in our economic life and concluded it would 'inject the government deeply into the process by which employers and workers reach agreement' and 'superimpose bureaucratic procedures on the free decisions of local employers and employees.'"

Key Provisions

- Washington, June 20—(AP)—Here are the major provisions of the Taft-Hartley Labor Bill: 1. Let the government get court orders to block "national calamity" strikes, as in the coal or steel industries, during 90 days of mediation. 2. Forbid the closed shop, in which the boss can hire only union help. 3. Ban various kinds of special strikes and boycotts. 4. Permit court suits against unions that break contracts. 5. Deny collective bargaining rights to any union having as an officer a communist or sympathizer, or anyone who could "reasonably be regarded as one." 6. Make it an unfair labor practice, which could be stopped by a court order, for a union to keep non-striking workers from their jobs by mass or violent picketing. 7. Forbid "excessive or discriminatory" union dues and initiation fees.

We need more wool than we grow. Last year, we grew 300 million pounds. We imported more than twice that much.

In wartime American woolgrowers had to sell to the government. In return, by law the government had to pay them 40 to 42 cents a pound, a good price.

Soviet Delaying Move Blocked By UN Ballot

Lake Success, June 20—(AP)—The United Nations Security Council today overrode a Russian attempt to block immediate consideration of a governor for Trieste.

The vote was 9 to 1, with France abstaining. Russia was alone in opposing the British proposal to take the Trieste governorship out of the hands of the Big Four powers and placing it on the council's agenda.

Soviet Deputy Foreign Minister Gromyko objected strenuously to the British proposal. He contended the council could not discuss the selection of a governor for the island internationalized territory until the Italian peace treaty was ratified by all the big powers concerned.

British Delegate Sir Alexander Cadogan promptly challenged the Soviet position. He said he was unable to understand the basis for Gromyko's argument.

U.S. SHIPPING AGAIN NORMAL

Interrupted Sailings Return To Schedule After Strike

New York, June 20—(AP)—American shipments returned to normal on all coasts today with the United States liner America scheduled to sail from New York harbor on her interrupted trip to Europe.

The America's scheduled sailing Wednesday, like the voyages of many other passenger and dry cargo vessels, had been stayed by CIO maritime unions which had ordered members not to go to sea after contracts expired Sunday night.

While the unions were ratifying the agreement reached early yesterday with Atlantic and Gulf coast ship operators, the Pacific American Shipowners Association and the CIO cooks and stewards and radio operators agreed late yesterday to permit West Coast sailings while they continued their negotiations.

British Probe Press

Newspapers Investigated By Socialists Raises Uneasy Speculation Of Leftist Trend Of Placing Press Under Strict Regimentation; The Possibilities Involved

Investigation of ownership and control of the British press by England's Socialist regime is giving rise to uneasy speculation abroad as to whether this indicates the development of a further leftist tendency by the government.

Of course there's nothing in an ordinary inquiry into the operation and financial structure of the press which should cause disquietude. An honest press has nothing to conceal.

However, the launching of the present high-powered survey was preceded by much pressure from Communists and fellow travelers who maintained—to quote the view of the London Communist Daily Worker—that "the press today is a menace to democratic methods of government."

Agree To Buy Parking Meters For Greenville

A special committee appointed by Mayor Jack Boyd at a recent meeting of the Board of Aldermen met today to install parking meters on the streets here, after investigation in other towns, has reported favorably.

The meters are to be installed in certain sections of the business district, but not in the tobacco warehouse section.

The number of parking meters to be purchased and the exact streets on which the meters will be installed have not been definitely decided. A survey will be made to determine number of meters which may be used to the best advantage to expedite the handling of traffic in the business section of the city and for the convenience of the public.

The meters will be bought as a part of the administration's city improvement program, according to Mayor Jack Boyd. A person going to a bank to make a deposit may place a penny in a meter and remain parked for five minutes. If he plans to be there longer he may load to park there for an hour, it was explained. Investigation by the aldermanic committee revealed that in towns where parking meters are used the parking problem is not a problem at all, and the movement of traffic is considerably facilitated.

### NOTHING LEFT BUT HONOR AND FAITH.

When Hitler sent Martin Niemöller to a concentration camp, Martin's aged father, Heinrich Niemöller, went forth to take his son's place. The elder Niemöller had been living in retirement for some years. With renewed strength he started across Germany preaching, and because of his unusual ability to express himself in living language, he was everywhere listened to with eagerness. But at last he grew weak and died. As he lay on his deathbed he said: "Yes, it is a terrible thing to have a son in a concentration camp. But there would be something more terrible for us: If God had needed a faithful martyr and our Martin had been unwilling."

Certainly when we come to the end of the road, we can sum up life in a few brief sentences. And certainly one is this: Nothing matters but honor and faith. Fortunately Martin Niemöller was not abused in the concentration camps, but even if he had been tortured and killed, that would have been better in the eyes of his loved ones than to have had him unfaithful to a great trust. The worst thing in the world, and surely the worst thing in the eyes of the Heavenly Father, is to have some great need or challenge arise among men and to have no stalwart soul who will step forth to meet the same.

Everything in life becomes dust and ashes in the last analysis—that is, everything but honor and faith.

ing against workers "by arbitrarily penalizing them for all critical strikes."  
Asserting the bill "would substantially increase strikes," Mr. Truman said it would discourage the growing willingness of unions to include "no strike" provisions in bargaining agreements.  
He contended also the measure would bring on strikes by depriving "significant groups" of the right to organize and bargain by classifying broad groups as "supervisors."  
"The bill would force unions to strike or boycott if they wish to have a jurisdictional dispute settled by the National Labor Relations Board," the President continued. He said this is because the board is given authority to determine jurisdictional disputes over assignment of work "only after such disputes have been converted into strikes or boycotts."  
While he said the bill seemingly preserved the right of employers and employees to agree to the "union shop," the President said "it would place such a multitude of obstacles in the way of such agreement that union security and responsibility would be largely cancelled."
