SAFE ROBBER CAUGHT NEAR HERE MONDAY

Sheriff's Officers Nab Jesse Thomas Varner; Had Burglar Tools In Car

By CHESTER WALSH Jesse Thomas Varner, 27, escaped prisoner from the Norfolk (Va.) Prison Farm, wanted by Goldsboro authorities for the alleged safe-breaking and larceny of about \$2,000 in currency and some odd coins from the Pate Wholesale Company in Goldsboro, was arrested near here yesterday afternoon and turned over to Goldsboro officers last night. Varner also is wanted by Norfolk authorities. He was serving a year there for storebreaking. Varner was arrested at the home of his sister near King's Cross Roads in the Fountain section of Pitt County. Sheriff Ruel W. Tyson and Deputy L. E. Manning and ABC Officers J. M. Ward, Claude Manning and J. L. Taylor surrounded the house about supper time and surprised their man sitting on the back porch. He offered no resistance.

When they searched him the officers found \$405 in bills and a quantity of old silver and copper coins, the gains answering the description sent out by Goldsboro police. Sheriff Tyson said they found a complete kit of burglar tools in Varner's car.

The sheriff said he believes Varner is a member of a gang of safe-breakers who have been operating in Eastern Carolina the past year.

Sheriff Tyson recalled today that a large iron safe, stolen from the Hendrix-Barnhill Equipment Company in Greenville about six months ago was found in the rear of church in the Fountain section, several miles from where Varner has been staying.

Re-Open Inquiry Into Deaths Of Eight Convicts

Atlantic, Aug. 12—(AP)—The case of eight negro convicts, shot to death by guards at a Brunswick, Ga., prison camp last month, has been reopened by the State Board of Corrections and the camp ordered closed.

The board acted yesterday to close the Brunswick camp for negroes and a similar highway work camp for white prisoners at Charton, Ga., thus ending state operation of highway prison camps. Still in operation, however, are 89 county road work camps which are subject to state supervision.

Clear Franchise For Bus Company

Raleigh, N. C., Aug. 12—(AP)—The Sea Shore Transportation Company today had a clear franchise to operate busses from Morehead City to Raleigh, via Beaufort, New Bern, Kinston and Goldsboro.

The State Utilities Commission granted the franchise last month but the Atlantic Greyhound lines asked a writ of prohibition against the commission. The lines contended that the commission had not allowed Greyhound enough time to protest the Sea Shore application. However, the Greyhound Company dropped its action before a scheduled hearing in Smithfield yesterday.

History Being Made

Labor Scene Complicated; A Time of Sparring for Position; NLRB Officials Face Thousands of Problems; Maritime Threat; Impact on Past Laws

Washington, Aug. 12—(AP)—The labor scene today is complicated and bewildering.

History is being made, but what sort of history is hard to say until the situation settles down a bit.

Here are some things of note:

1. Strikes may come in the maritime industry this fall, and possibly on the railroads this winter. All is not yet quiet in the auto industry. CIO rubber workers have asked for more money. The construction industry faces the possibility of wide upheavals.

2. Court battles are beginning under the Taft-Hartley Act. Examples: AFL teamsters in Cincinnati have been sued for \$100,000 for an alleged illegal boycott, and CIO steelworkers in Chicago have been sued for \$75,000 for an alleged breach of contract.

3. The new law has been on the books for seven weeks, and many new provisions go into effect Aug. 22.

The widespread protest strikes and disorders that some people feared have not materialized. But there is great uncertainty over the administration and interpretation of some of the law's provisions.

4. Unions are searching for loopholes and doing everything they can legally to avoid restrictions. Some CIO unions have announced

Heat Wave Hits 1948 Meat Stocks

Still Further Losses Threatened As Corn Forecast Trimmed; Grain Plagued By Late Planting, Heat, Floods And Drought

Washington, Aug. 12—Next year's meat supply hung in the balance today as the midwestern heat wave trimmed official forecast of corn production and threatened to cause still further losses before harvest time.

Plague at planting time by cool weather and floods, corn now has run into hot, dry weather which the Agriculture Department, in its regular monthly crop report, described as a serious threat to all the crops in the Midwest.

A short corn crop this year would affect next year's output of meats and other livestock products.

However, meat supplies for the last three or four months of this year and the early months of 1948 are expected to be large regardless of how this year's corn turns out.

The department forecast the crop as of August at 2,659,959,000 bushels, a decline of about 111,000,000 bushels from its July 15 estimate. The later estimate did not take into account (Continued on Page Three)

Army Ends Investigation Of Missing German Gems

Berlin, Aug. 12—(AP)—Investigators today tabbed the case of the missing royal jewels of Princess Hermine, late widow of Kaiser Wilhelm II, as a "dizzy merry-go-round of family intrigue" and said

the U. S. Army was dropping the matter into the hands of the German police.

"We have definitely determined that no American is involved in the disappearance of the jewels," said O. R. Carlucci head of the Army's Criminal Investigation Division "and therefore we have no responsibility for pursuing the case any further."

American authorities also dropped technical charges under which they were holding Fraulein Vera Herbst 39, attractive friend of Hermine's son, Prince Ferdinand.

Ferdinand touched off the melodramatic investigation when he told authorities that 29 pieces of jewelry were missing from a priceless collection which Fraulein Herbst brought him from Hermine's home in the Soviet occupation zone last June.

A search for the missing gems produced a glittering array of jewelry concealed in the apartments of Ferdinand's friends and family, but failed to unearth any of the missing treasure.

At one point Fraulein Herbst led investigators to the suite above her apartment where a friend, at her request, exhibited a jeweled Tiara of Hermine's and five other valuable pieces.

Later Princess Caroline, sister of Ferdinand, turned over about 30 pieces of royal jewelry which she concealed in her apartment.

The gems which Ferdinand reported stolen were taken from a parcel containing jewelry valued at \$1,000,000 by authorities and at \$5,000,000 by Ferdinand. Investigators said the package was one of three parcels of gems sent by the Prince by his mother, but was the only one he received.

See Black Eye For GOP In Probe Halt

Democrats Claim Sudden Breaking Off Of Hughes Investigation As Doing Political Damage To Republican Party

Washington, Aug. 12—(AP)—The sudden breaking off of the Howard Hughes investigation brought from a Democratic senator today the comment that Republicans got "a political black eye" and from Senator Brewster (R-Maine) the retort, "That's a matter of opinion."

Senator Robertson (D-Va.) professed, with unfeigned pleasure, to detecting bruises on the GOP political optic.

And another Democrat, Senator Murray of Montana, told reporters that what is now needed is an investigation of Senate investigations.

Murray said the two weeks of hearings by the Republican-controlled Senate War Investigating Committee on Hughes' wartime plane contracts represented "just another example of efforts to smear every witness who takes the stand."

Brewster, who is chairman of the

committee, commented in Maine that Murray "is trying to stop the war investigation committee again."

As for Murray's "smear" comment, Brewster said, "That's also a matter of opinion."

Murray said he was serious in suggestion the Senate should investigate its own investigations.

"They didn't have anything to go on and were just depending on sensationalism," the Montana senator declared. "The same thing has been going on before a lot of other committees. The Senate ought to make an investigation of these so-called investigations."

Murray declined to predict his party's course, but there were indications that the Democrats will try again next January to kill off the war investigating group, originally headed by President Truman when he was a senator.

The committee's life was continued in 1946 when it was reauthorized by the Senate. It has since been reauthorized by the House and Senate.

Although Senator Ferguson (R-Mich.) contended that the Hughes inquiry will go on again full blast November 17, Senator Robertson (D-Va.) said he thinks Ferguson's action in abruptly postponing the case yesterday hurt the Republicans politically.

TOBACCO YIELD IS BELOW 1946

Acres Up But Estimated Production Shows Some Decline

Raleigh, N. C., Aug. 12—(AP)—The acreage of flue-cured tobacco in cultivation this season in North Carolina is estimated at 811,000, or one percent above 1946, by the Federal Crop Reporting Service of the State Department of Agriculture.

Growers attempted to plant closer to their allotments this year although quotas are slightly less than last year, the service added.

Other estimates as of Aug. 1: The state's flue-cured tobacco at 881,000,000 pounds, an increase of 18,000,000 pounds over July 1 prospects.

Yield per acre for flue-cured acres was placed at 1,086 pounds as of Aug. 1, compared with 1,138 forecast in the July 1 estimate.

Estimated production in the entire flue-cured belt is now placed at 1,295,865,000 pounds a decline of four percent from 1946. Yield per acre is placed at 1,075 pounds compared with 1,137 last year.

The flue-cured crop improved considerably during July, especially in the border belt and parts of the Eastern Bright Belt. However, prospects in the Old and Middle Belts are not as bright as they were on July 1.

Capture Orders For Attack On Dutch Forces

Batavia, Java, Aug. 12—(AP)—Dutch military authorities reported today that Netherlands troops in Sumatra had captured Indonesian Republican Army orders authorizing an attack on a Dutch camp in direct violation of the truce effective a week ago last midnight.

A Dutch communique asserted that the orders had been captured when Republican forces attempted to infiltrate a Dutch position at Baungin, near Padang on the west coast of Sumatra.

More than 20 members of the Republican regular and irregular forces were captured, the communique said, and orders dated Aug. 8 were found in their possession showing that the attack had been ordered by Indonesian authorities.

The Dutch communique followed the broadcast of a Republican bulletin from Jogjakarta accusing the Netherlands forces of further truce violations.

Farmville Kiwanis Club Interested In Hospital

Members of the Farmville Kiwanis Club showed a great deal of interest last night in the proposed new hospital for Pitt County when the club's executive committee met.

The hospital is to be operated as a non-profit organization and will be eligible to financial aid for charitable purposes from foundations which are dedicated to such purposes, it was explained.

To finance the county's part of the expense of the proposed hospital, a special bond election has been called for September 16 by the Pitt County board of commissioners.

Registration is required for the election, and only those people who register for the election will be permitted to cast a ballot on September 16. The county registration books will be opened on four successive Saturdays beginning August 16.

The speakers at the Farmville meeting, in urging the citizens to register and vote in the bond election, pointed out that anyone registering for the election and then failing to vote on election day will automatically be counted as a voter against the bond issue.

PRICES UNDER GOV'T PROBE

Food, Housing And Clothing Prices To Get Close Scrutiny

Washington, Aug. 12—(AP)—Attorney General Clark today ordered an investigation of food, clothing and housing prices.

He instructed the Justice Department's Anti-Trust Division to determine whether "conspiracies" exist "to maintain or to increase present prices in the food, clothing and housing fields."

Jeal sentences, rather than merely fines, will be sought for any violators, it was announced.

A Justice Department statement announcing Clark's action said: "Such conspiracies will be prosecuted criminally and in those cases the Justice Department will oppose acceptance by the courts of pleas of 'nolo contendere' (no contest), and upon conviction of the defendants the department will recommend jail sentences for the individual defendants and maximum fines against the corporations."

The statement said the investigation follows a three months study of the present price situation by Assistant Attorney General John F. Sonnett who took charge of the Anti-Trust Division in May.

Clark feels, it was added, that "the soaring high prices now continuing in the food, clothing and housing fields, require that a new and more vigorous approach be undertaken in these fields."

Camden, S. C., Aug. 12—(AP)—Sheriff Gib Debruhl said today that a two-day search through the woods and swampland for an 85-year-old blind, deaf and dumb man has been unsuccessful.

No trace has been found of the aged man Debruhl said adding that he did not believe Horton would be found alive.

BRITISH VOTE ATTLEE BILL

Commons Approve "Crisis" Bill By 178-64 After Long Debate

London, Aug. 12—(AP)—After debating the measure throughout the night, the House of Commons today approved the Labor Government's "Economic Crisis" Bill by a vote of 178 to 64 and sent the measure to the House of Lords for final passage in time for Parliament to adjourn tomorrow night.

The debate finally resolved itself into a struggle against time, with the government fighting relentlessly for 2:30 p.m. Continuation of the debate beyond that hour would automatically have cancelled the day's business and made it impossible to get the bill through the House of Lords in time to permit Parliament to take a summer recess beginning tomorrow.

Paraguayan Rebels Near Capital; Morinigo Leaves

Buenos Aires, Aug. 12—(AP)—Argentine sources said today that Paraguay's President, Higinio Morinigo, had pulled out of Asuncion yesterday afternoon for Pilar, near the Argentine border 130 miles south of the rebel-threatened capital.

The Paraguayan Embassy here could not confirm the report, but Argentine informants who have been in frequent contact with the Morinigo government said they had word from the President's departure directly from Asuncion. They said Morinigo was accompanied by his cabinet ministers and diplomats accredited to Paraguay.

An earlier Associated Press dispatch from Asuncion said Morinigo was still in the capital yesterday morning when he made a tour of the city's defenses. Other informed sources here said Air Forces and ground personnel had revolted in Asuncion during the day and had seized both the city's airports. These informants said, however, that all planes previously had been moved.

Morinigo's departure would be a strong indication that the five months old civil war as rapidly heading for another climax, but dispatches from Paraguay and rival communiques did little to clarify the exact military situation.

Get Confession In Torso Murder

Detroit, Aug. 12—(AP)—Authorities said today that Harry Treaski, 50, admitted in unsigned statements that he beat his 20-year-old bride of 11 days with his fists because "she was a no good woman" and later aided in disposing of her dismembered body.

The severed torso of his blonde wife, Jean, was found Sunday in an alley trashcan and her head and legs were located Monday two blocks away.

STEEL UNION OPENS DRIVE ON LABOR LAW

Campaign To Elect "Acceptable Congress" To Repeal Taft-Hartley Act

Pittsburgh, Aug. 12—(AP)—The CIO United Steelworkers Union, which earlier voted to ignore the labor board setup under the Taft-Hartley labor law, now has opened a national drive to elect an "acceptable Congress" to repeal the recent labor act.

Some 520 of the union's district officers and leaders met yesterday to map plans for a mass registration drive and a campaign to collect \$1 voluntary contributions from the 875,000 members.

The Taft-Hartley law specifically forbids use of union funds for political purposes.

However, Philip Murray, president of both the CIO and the steelworkers, said "there is nothing in the Taft-Hartley law which prevents voluntary contributions."

He added the money collected would be kept apart from union funds and "may or may not" be used to make direct contributions to candidates or parties.

Murray in a news conference following the meeting, said the CIO hopes to enlist 1,000,000 members to carry on the "most intensive election campaign in history."

The CIO, the labor leader declared, "would welcome" a test of curb on labor organizations' political activities under the Taft-Hartley labor law. Murray said Attorney General Tom Clark has been advised by the CIO and steelworkers of two instances in which the CIO has engaged in active support of candidates since the law was passed in June.

So far, Murray said, the CIO has not heard from the attorney general, although "we would welcome a test."

Laborite Party Split

Britain's Socialist Party Divided into Right and Left Wings in Vote Over Nationalization of Steel Industry; Their Compromise With Capitalism

The decision by Socialist Prime Minister Attlee and his cabinet to defer Nationalization of Britain's great steel industry, possibly for the duration of the country's economic crisis, is a concession to orthodox means of recovery, which is to say "Capitalistic."

The extent of that concession can be seen from the fact that nationalization of steel was one of the major items in the platform on which Socialism came to power in 1945. So important and controversial is the issue that Attlee took his decision before a private labor (socialist) party caucus yesterday. He received approval by a margin of only four votes—81-77—while it is said that more than 100 members abstained from voting.

This mixed attitude of the caucus makes it clear that the question of steel nationalization is far from settled, and that there is a sizable crack in socialist solidarity. The left-wingers of the party are dead set against any compromise on nationalization, and recently have been attacking Attlee's program as inadequate and his leadership as uninspiring.

Herschel Johnson Says That If Security Council Fails To Solve Balkan Problem U. S. Prepared To Protect Greece; Accuses Soviet Satellites

Lake Success, Aug. 12—(AP)—The American delegation said today that if the United Nations Security Council fails to solve the Balkan problem the United States is prepared to join with other countries to protect Greece within the provisions of the charter.

Herschel V. Johnson, deputy U. S. Delegate, gave this warning to Russia after charging before the Council that communist groups supported by Albania, Yugoslavia and Bulgaria hoped to set up a totalitarian regime in Greece.

"We do not consider that our obligations or the obligations of the United Nations are ended merely because the Soviet Union sees fit to use her veto to block constructive proposals desired by nine out of 11 members of the Security Council," Johnson said.

"It becomes all too clear that the veto is being used in defense of the aggressions of Yugoslavia, Albania and Bulgaria."

At another point, Johnson said: "We are no longer under the necessity of attempting to appease further a threatening veto. Let us now record our honest opinions."

Johnson spoke after Yugoslavia had accused the United States of deliberately misrepresenting conditions in the Balkans to justify the Truman doctrine of aid to Greece.

Johnson said support of the Greek communists by the three Soviet satellites was a peril to peace, but added that the threat can be checked if firmly faced by the United Nations.

Yugoslav representative Dr. Jozef Vilfan blamed much of the Balkan difficulties on the U. S. and on what he called a failure of the United Nations Security Council to examine the problem closely.

He told the council that the 11-nation Balkan investigating commission had not favored creation of the subsidiary inquiry group now in Greece.

"It was proposed by the U. S. delegation," he declared, "in order to justify the increase in the interference in Greece. The United States needed a subsidiary group in order to create the impression that the serious situation in Greece was the consequence of an alleged interference from the outside."

Druggist Freed On Posting Bond

North Wilkesboro, N. C., Aug. 12—(AP)—Hugh West, North Wilkesboro druggist was freed on \$10,000 bond today on a charge of manslaughter and abortion in the death of Pearl Jenkins of Winston-Salem.

Miss Jenkins died on a roadside near here July 31. District Solicitor Avalon Hall said that no trial date had been set for West, but that he probably would not be tried during the current term of court.

West was arrested Saturday in Asheville after a Wilkes County Grand Jury returned an indictment against him.

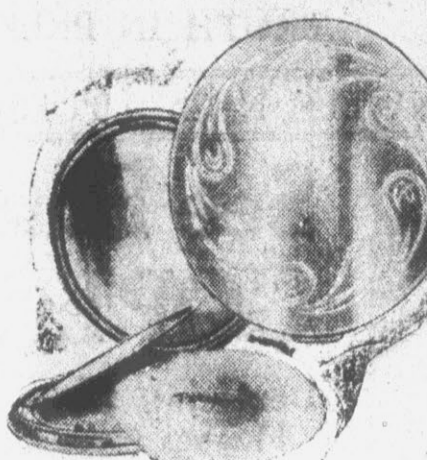

"We charge that the civil rights of local citizens are now being usurped and violated by state and county 'peace' officers," Edelman said in a letter to Turner Smith, chief of the Justice Department's civil rights section.

"Injunctions have been issued by the local courts limiting the number of pickets at the mill to twenty. The union has been strictly living up to the court order and no more than 20 pickets attempt to patrol the plant gates."

The NLRB in the past has had little or nothing to do with the construction industry, but because of the entirely new situation caused by the Taft-Hartley Act, many experts believe the board will change its rules and accept cases in the industry.

And if so, the impact on the time-honored arrangements between unions and contractors may be terrific.

Under the leadership of the United Council of Church Women, thousands of Protestant church women will observe "World Community Day" on Friday, November 7. Some will observe the day in their local churches; in some communities churches of all denominations will unite in services around the theme, "The World Is My Community." The offering will be used to buy milk and food for children overseas, and to continue the work of the churches for the cause of peace. In addition, the women are asked to provide 500,000 bundles of clothing and boxes of shoes and of school supplies for school children overseas ranging in age from six to twelve years. In 1945, at a similar observance, American church women sent a million diapers and thousands of layettes overseas; and in 1946 their gift was 500,000 "kiddie kits." Also at these November 7 meetings the work of UNESCO in providing the needs of children of the United Nations will be studied, and will become the object of prayer. Church World Service will send overseas the donated bundles and boxes. Information concerning contents, packing, etc. may be had from Church World Service Center, New Windsor, Maryland, or from the United Council of Church Women, 156 Fifth Avenue, New York 11, N. Y.

Our Farm Folks

Each year farmers in Pitt County are burdened with the heavy expense of building new tobacco barns to replace barns that have been burned. In 1946 a total of 1,411 tobacco barns were reported to be burned in the state, 78 barns were burned in Pitt County last year.

The North Carolina Agricultural Extension Service is making a survey of tobacco barns lost by fire in 1947. The reason for this survey is to secure information as to the probable cause for different types of barns burning. This information should be of great value to the farmers in the county, in making changes in their respective curing barns as a means to help eliminate the tobacco barn fire hazard.

Every farmer, who has lost or does lose a tobacco barn by fire this season, is urged to report the loss to the County Agent's Office in Greenville. S. J. Weeks, Assistant County Agent.

WHIPS OR ARGUMENTS

When David Livingstone, the African explorer and missionary, was beginning his work, he had some difficulty in making converts among the natives of a certain village. The native chief, who liked him, offered to assist the missionary. "I'll send for my head man, and we'll beat the people with rhinoceros-hide whips until they are all converted."

Naturally Dr. Livingstone declined this chief's offer and continued to teach the people and cure the sick day by day. After he had lived in the village some time, he began to make many converts every week. The natives had learned what a splendid helpful man Livingstone was, and they believed in him—the rest was simple.

HOWARD HUGHES

Let's take a look at the actions of Howard Hughes.

His very obvious obstructionist maneuverings before a subcommittee of the Senate War Investigating Committee have been apparent to all who have read his statements in the press and heard the transcriptions of his more spectacular utterances.

The lack of willing cooperation with the Senate committee which he has displayed is a matter of public record. Every difficulty which was at the disposal of Mr. Hughes has been used with the skill and precision of a surgeon's knife.

In a sense he has shown almost complete lack of respect for an arm of the United States government and his statement that he would "leave the country" if his huge plane is a failure, must reveal to all the degree of affection he has for his own country.

Statements that the press and public have supported him are false. Howard Hughes made headlines because of the news value of the issue with which he was identified, not because of any endorsement by newsmen present at his presumptuous statements. (Stalin, Gromyko and Molotov also rate headlines from time to time, but it can hardly be said that they are generally regarded with any great favor by the American public or supported by the nation's press.)

Charges made by Mr. Hughes regarding the integrity of Senator Brewster have been repeated many times with no evidence of duplicity by that Senator. The presumptuous young millionaire has repeated these statements so often that some individuals may accept them as true with no other corroboration. Other experts

with the use of propaganda in the past have found this gullibility to be a useful tool. Howard Hughes at present enjoys a certain amount of popularity. He would do well however, to modify his peremptory and combative attitude the next time he is called before the Senate War Investigators.

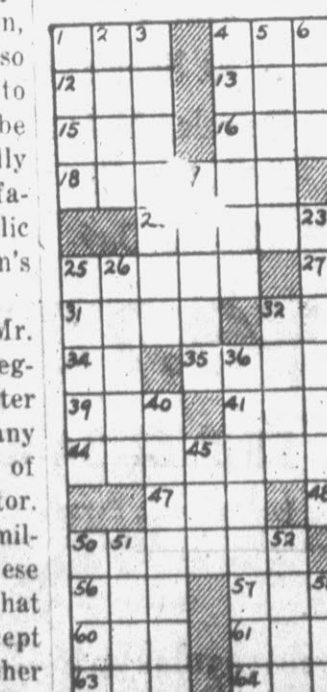

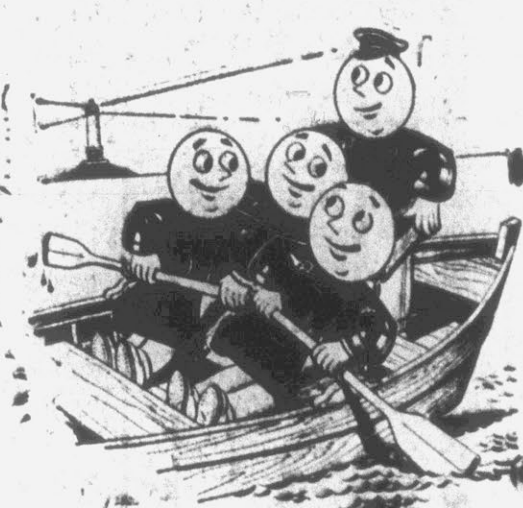

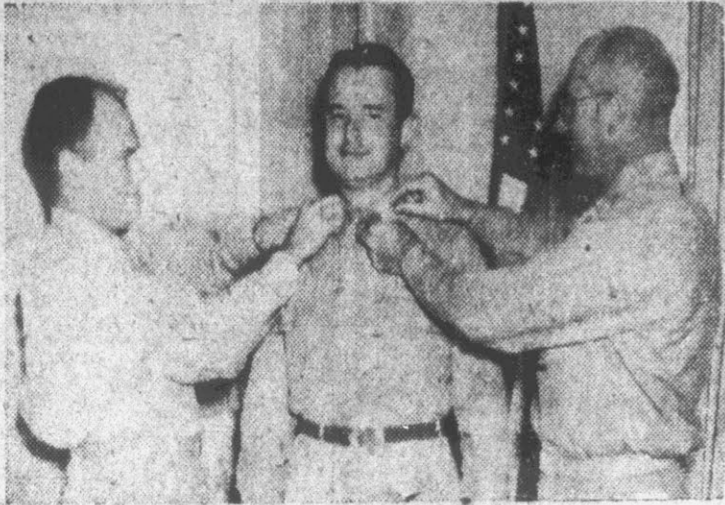

Piedmont Teachers Ask State Board Education To Rescind Fritz Action

Hickory, N.C., Aug. 11—(AP)—Members of the group which started the successful movement for a 30 per cent teacher pay raise which resulted in the unprecedented election of R. L. Fritz, Jr., of Hudson, as president of the North Carolina Education Association have adopted a resolution that his revoked teaching certificate be restored.

The steering committee of the South Piedmont Classroom Teachers Association at a meeting here yesterday called on the State Board of Education to "rescind immediately" its action cancelling his teaching certificate.

Fritz, principal of the Hudson school in Caldwell County, was said by the state board to have been involved in payroll irregularities. He has returned \$1,641 the state board contended had been paid teachers in the Hudson school.

The resolution said in part: "All of the monies involved were used in paying substitute teachers or regular teachers extra hours, because no other teachers were available. The alleged irregularities were caused in large part by the want of regulation prescribing a method of paying teachers of classes having no regular teacher."

"We know that Mr. Fritz was not guilty of an intentional or conscious wrong-doing. In view of the fact that Mr. Fritz has made full restitution and that he acted in good faith in a sincere effort to keep the Hudson schools open under conditions of emergency arising out of

the unprecedented teacher shortage. We feel that the State Board of Education should immediately rescind the resolution whereby it undertook to cancel Mr. Fritz's certificate as a principal and as a teacher."

Navy Sets Aside Conviction In China Rape Case

Washington, Aug. 12—(AP)—The Navy has set aside the conviction of Marine Cpl. William G. Pierson of Sumter, S.C., in a rape case which touched off anti-American demonstrations in North China last winter.

He had been sentenced to 15 years' imprisonment and dishonorable discharge. The Navy announced yesterday that Sec. Forrestal acted on the grounds the evidence was insufficient.

Sen. Olin D. Johnston (D-SC) had disclosed in June that the Navy Judge Advocate General after a review, had concluded the charge was unwarranted and recommended the conviction be set aside. Johnston said at that time that upon Forrestal's approval of the Judge Advocate General's recommendations Pierson will be released from confinement and returned to full-duty status in his previous rank as corporal.

Hobo King Says Convention Is For 'Phoney's'

Chicago, Aug. 12—(AP)—Ben Benson, 64-year-old self-styled king of hoboes, says the annual hobo convention this year is "for phoney's," and that he is boycotting it.

For one thing, he said, Skeets Simmons, elected king of hoboes last year and Jeff Davis, a former king, are not hoboes within his definition of a knight of the road.

"To be a bona fide hobo, you got to be on the bum half the time, absolutely pay no fare, and positively be a single man without a wife," Benson said.

The five-foot, 110-pound Benson

says he has been the "real king since 1940," and is waging a box-car campaign against this year's meeting in Britt, Ia., on August 27. "No bona fide hobo would attend" that session, he said, adding "but those publicity hounds'll be there and I want no part of them."

Now Is Time To Build Schools Despite Cost, Asserts Expert

Chairman Of North Carolina Schoolhouse Commission Says Communities Can Float Bonds At Unusually Low Interest Rates For Such Construction

Raleigh, N.C., Aug. 11—(AP)—High construction costs are delaying new school building in North Carolina but one state expert says now is the time to build.

W. F. Credle, chairman of the North Carolina Schoolhouse Planning Commission, says "I'm not certain but that today is an opportune time for construction. Communities now can float bonds at unheard of low interest rates."

He added "there are many school plants which will not be able to postpone needed repairs. This will have to be done either this summer or in the fall. I look for considerably more school construction during the next few months."

Credle said that it is true that the costs of fire-resistant materials and labor are high now. But he pointed out that cost of fire-resistant construction compares favorably at present with ordinary masonry, which was not true during the so-called "cheap years."

Here is a survey of school building plans in the state, which while incomplete points the trend:

Jesse O. Sanderson, Raleigh school superintendent, says the only work under way there is an \$81,000 addition to a white elementary school. Negro schools in the capital are overcrowded, he explained. An outside agency is making a survey of school needs in Raleigh and a new school for Negroes probably will be one of the first projects when a building program is started.

However, the school board feels that it should plan its building program after costs go down.

Superintendent Randolph Benton of Wake County says that bids will be received Aug. 14 for white elementary school at Fuquay Springs to cost approximately \$150,000. Under construction at Wendell are a vocational building and a teacherage, to cost about \$25,000 each. A large school for Negroes is to be built at Millbrook "as soon as building costs ease up a little."

Benton said a five-year program to cost more than \$1,000,000 is planned. Under the plan consolidation of Wake County Negro schools will be completed.

Greensboro reports that the only project under construction in the city or Guilford County is a rural school for white at Alamance. Begun early in 1946 to replace a burned structure, it should be completed late this year at an estimated cost of \$275,000.

No Negro schools are being built at present.

Plans are being made for these projects in the near future, all for white children, with estimated costs:

Guilford County: Additions and improvements to existing structures at Allen Jay (\$20,000); Jamestown (\$80,000); Guilford (\$20,000).

Proximity Cafeteria (\$26,000); Irving Park classrooms (\$34,500); new stair tower at Central School (\$7,500).

Winston-Salem reports that no new school construction is under way in the city or yet in the planning state. However, \$75,000 has been earmarked for alterations and repairs to existing buildings.

Forsyth County has authorized an outlay of \$1,350,000 for two new schools for white children. One, to cost about \$750,000, will replace the Mineral Springs School No. 2, which burned about five years ago. At that time it was termed the largest consolidated school in the country.

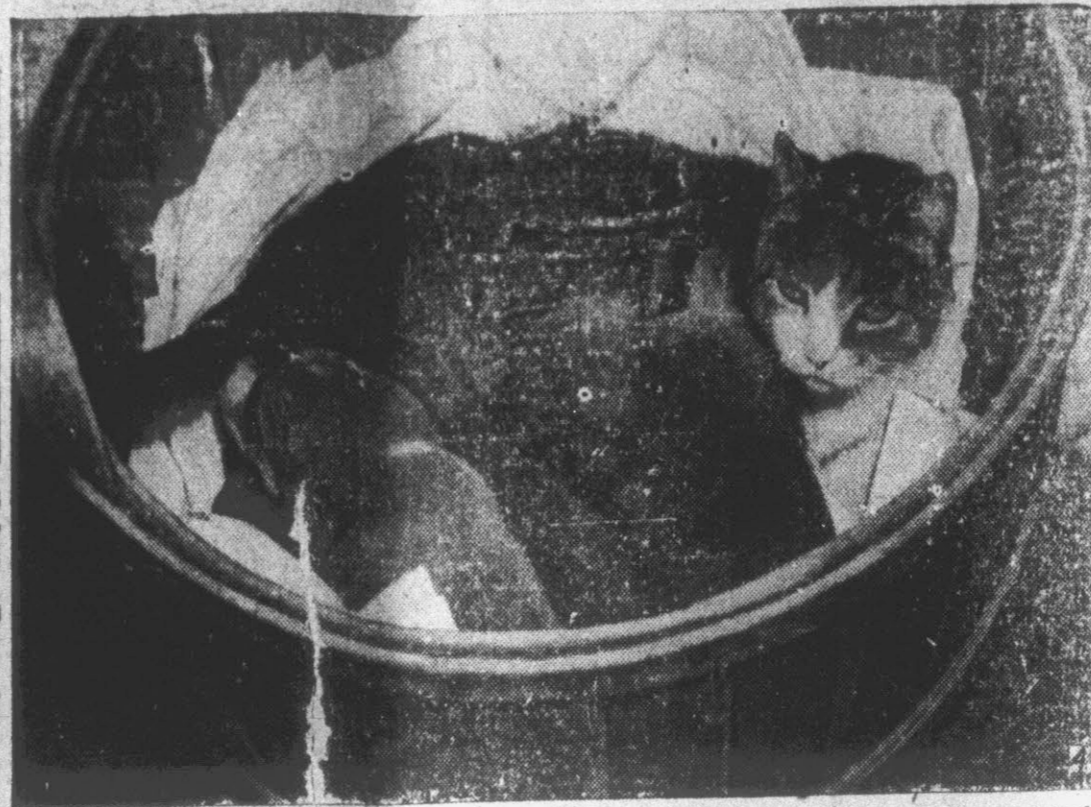
