SIKH RAIDERS COORDINATED IN SLAUGHTER

Well-Planned Task Of Exterminating Moslem Minority In Punjab India

Jullundur, India, Aug. 23—(AP)—The Punjab military is convinced that the Sikh raiders attack Moslem villages in that authorities believe to be a ruthless war of extermination in this little-travelled section every man has his ghoulish task planned and assigned in advance.

In two weeks, the fierce and bearded Sikhs have overrun at least 150 villages and have slaughtered hundreds—no one knows how many. Almost monotonously, I received from Moslem, Hindu, Sikh and British Army officers and from survivors of the raids, the same tale of highly coordinated action in which the raiders used a fantastic assortment of ancient and modern methods but operated as well as a well-drilled military unit might be expected to.

Generally, in the dead of night, while the villagers are sleeping, the raiders strike with a wave of machine guns, rifles, ancient muzzle loaders and muskets fashioned from iron pipes. This shooting stampedes the villagers and the real killers come in, armed with spears having six to eight-inch sheet iron tips, crude broad axes, swords, clubs and small arms.

Their work is done ruthlessly and I have seen evidence of their handiwork at the graveside and in hospitals. After them come the third section—the looters and the arsonists. A raid on the village of Naru Nangal, separated from this military center by dry riverbeds, jungle and farm land, was described to me as typical by both a Sikh and a Moslem army officer who took me to the scene. A foul odor of death greeted us as we spied the village, from some of the buildings of which smoke still curled.

Margaret Truman Calm Before Concert Debut

Hollywood, Aug. 23—(AP)—Margaret Truman, the President's 23-year-old daughter, expressed confidence as she prepared to make her concert debut tonight as soprano soloist before at least 15,000 persons in Hollywood Bowl. "I actually think this performance is going to be harder on my family and friends than on me," said the young, blonde singer. She expressed disappointment that the President and Mrs. Truman will be unable to be in the audience. "I've worked hard preparing for this and I'm confident," Miss Truman explained. "But all mother and dad can do is sit back and wait for the reports."

U.S. Exports In 1947

American Economists Undisturbed By Possibility That Britain, Canada And Australia Will Reduce Purchases From U.S.; Our World Trade Will Not Suffer

Washington, Aug. 23—(AP)—Washington economists are not too disturbed over the possibility that the British, Canadians and Australians may have to cut their buying of American goods. Here are the figures which are important: (1) Canada, Australia and the United Kingdom together bought \$1,767,000,000 worth of American goods the first half of this year. (2) In the same period we exported, all told, goods worth \$7,352,000,000. (3) Our national income is now at the rate of \$193 billions, the Department of Commerce estimates. (4) It is unlikely the three parts of the British Commonwealth would cut their buying by more than half. They sell enough here to cover half of what they are buying. That might mean the U.S. could lose about a billion in exports the next half year. But that would be only a seventh of our exports in terms of the last six months, and a mere drop in the bucket when stacked up against our \$193,000,000,000 national income. The flurry over a cut in Commonwealth buying here stems from the fact that the British and Canadians, particularly, are short of American dollars. Both have been buying here twice as much as they sell. There is no certainty where the possible drop in exports will hit here. But Britain has given an indication that it will be in the luxury field.

Argentina Backs Principle Of Veto

Announces At Inter-American Defense Conference Support Of Unanimity Vote But Intimates At Compromise

Quilinaha, Brazil, Aug. 23—(AP)—Argentina announced at the Inter-American Defense Conference today that she would "defend the position of unanimity" in any joint hemisphere action against aggression. While reaffirming her nation's insistence on the controversial "veto right" in hemispheric defense system, delegation secretary Gen. Enrique V. Corominas added, "We are democratically inclined to go along with the majority decision" of the 20-nation conference. He denied that Argentina had withdrawn her demand for unanimity in favor of the U. S. position for two-third majority rule, which is shared by most of the other American republics.

In an interview, Corominas said the Argentinians would make their position clear in the conference committee on voting procedure. The committee meets today, but the Argentine proposal is not expected to come up for discussion until next week, after organization has been completed. The American foreign ministers here to draft a treaty of mutual defense thus were faced with a second major problem. A special committee already is hard at work on the problem posed by Argentina's objection to the use of armed force against aggression from within the hemisphere.

NINETEEN DIE IN COAL MINE

Blast Is Second British Pit Disaster Within One Week

Annfield Plain, Eng., Aug. 23—(AP)—Nineteen Durham coal miners perished in an explosion in the Mirrison North Mine here today. All the burned and mutilated bodies were brought to the surface.

It was the second mining disaster to hit coal-short England within a week. Only five men survived the blast, and they suffered burns and multiple injuries.

William Welch, National Coal Board area manager, said undertakers and relatives were experiencing difficulty identifying the victims. William Younger, who was working in another section of the mine, gave this description of the blast: "There was no noise but we felt a blast of hot air rush past us. We went in dust was flying through from the top to the bottom. As we entered the explosion area we came upon three men, two alive, one dead. We raised the alarm and started to get the men out. Eventually we got 10 men out to a place where there was some air. Five were alive. The blast occurred shortly after midnight three-fourths of a mile from the bottom of the shaft in which a night crew of 24 men was working."

DEAN SLAY OF ETC RESIGNS

Educator Served Local College For 24 Years

President Dennis H. Cooke today announced the resignation of Dean Ronald J. Slay who has served East Carolina Teachers College for 24 years. Dr. Slay, Dean of ETC, has tendered his resignation effective September 15 as Dean of the College of Education. He has served in the Department of Science at Wagner College, Staten Island, New York. Dr. Slay came to East Carolina Teachers College in September 1923 as director of the Department of Science and served in that capacity until 1945 when he was made Dean of the College. Dr. Slay is a native of Mississippi and received his undergraduate degree at the University of Mississippi. He holds the M.A. degree and Ph.D. degree from Columbia University, the latter being conferred in 1928. Dr. Slay is a member of the following educational organizations: The North Carolina Education Association, the National Education Association, Fellow in the American Association for the Advancement of Science, the National Association for Research in Science Teaching, Phi Delta Kappa, National Science Teachers Association, National Science Teachers Association, the National Council of Elementary Science Teachers, and the North Carolina School Health Coordinating Service. In Greenville his activities have included: Membership on Board of Deacons, of the Immanuel Baptist Church, Chairman of the Board of Trustees of Pitt General Hospital, Secretary of the Greenville Community Chest, and member of the City Planning Board. During the war he was chairman of the Food Panel of the Pitt County ration board. In announcing the resignation, Dr. Cooke complimented Dean Slay for his long, loyal and effective service to the college. Dr. Cooke expressed the opinion that Dean Slay's resignation is a distinct loss to the college.

Eastern Belt To Open On Monday

The 15 markets on Eastern North Carolina's fire-cured tobacco belt will open 1947 sales Monday with prices expected to be in line with those being received on the border belt.

Early placed piles on the warehouse floors were heavy with good to choice-quality leaf. The crop was somewhat light, however, because of fluctuating weather conditions. The crop in the eastern belt was estimated at 450,870,000 pounds, or more than 3,000,000 pounds less than last year. Producers' sales in the belt last year totaled 433,756,724 pounds at an average of 52.68 cents a pound.

The bodies of Martin and Paice, blackened and bloodstained, were found suspended from two eucalyptus trees in a wood south of Natanya on the Palestine coast July 31.

GREEK CABINET FALLS DESPITE AMERICAN AID

Internal Dissension Wrecks Coalition Gov't On Reorganization Issue

Athens, Aug. 23—(AP)—The coalition cabinet headed by Demetrios Maximos, backed by \$300,000,000 in American aid but rent by internal dissension, fell today. The resignation of three ministers who insisted on changes in the cabinet precipitated the government's fall. Foreign Minister Constantin Tsaldaris, just back from Washington conferences, opposed the reshuffling, contending it "would render no service whatever to the country."

Informed quarters said Maximos was drafting his cabinet's resignation for presentation to King Paul this afternoon. Maximos, a leader in the Populist party, formed the coalition cabinet last January, with members from seven of the eight parties represented in Parliament. The left wing EAM parties were not represented. The crisis arose because of a disagreement over reconstitution of the cabinet. Three former premiers who were members of the cabinet—Sophocles Venizelos, George Papandreou and Panayotis Kanelopoulos—insisted on changes. Foreign Minister Constantin Tsaldaris, also a former premier, objected.

Venizelos, Papandreou and Kanelopoulos then resigned. Venizelos, head of the Venizelos Liberal Party, was vice premier and minister of war in the Maximos cabinet; Kanelopoulos, a National Unionist, was minister of navy; and Papandreou, a Social Democrat, was minister of interior.

Winston-Salem, Aug. 23—Reed Johnston, examiner in charge of the North Carolina National Labor Relations Board office here, says that action on some 100 labor union cases filed with the board will be delayed pending filing of union affidavits under the Taft-Hartley law.

Raleigh, Aug. 23—There is a very strong possibility that a four-month strike at the Safe Mill at Rockingham will end today following morning conference in the office of Governor Cherry.

Babson Discusses Labor Conditions

Boston, Mass., Aug. 23—Last night, I spent in Wellesley. Desirous to get to Boston early, I went to the Wellesley Hills railroad station to take the 7:16 a. m. train. This is a very fine stone station of the Boston & Albany (New York Central System) Railroad. To my surprise, I found no ticket agent, no baggage master and no newspapers. The doors were locked and bolted.

Why Railroads Lack Earnings. Upon inquiring the reason, I was told later in Boston that, in view of a recent forced raise in wages, the railroad cut down the working hours of the station employes so the railroad did not have to pay out any more money. This, of course, resulted only in enabling the station employes to be a little longer in the morning. The station did not open until 7:30 a. m. Until then no tickets could be bought, no newspapers were available, no baggage could be checked and the public telephone could not be used. I stood out in the mist awaiting my train; but a neighbor who was also shaking the door said, "Okay, I'm going down to the Square and get a bus into Boston."

Why Living Costs Are High. Now let us forget, for a moment, whether our sympathies are with the railroad or its employes. The fact is that only the bus company wins by such nonsense! The employes have no more money to take home; the railroad loses customers; the newspapers lose sales and the public is much inconvenienced. Of course, this foolishness can't go on forever. More hourly wages, shorter working hours, higher retail prices—all expanding like a balloon—are bound to collapse sometime. I don't blame any special group; but do say that the present system is a losing game to all concerned and the true reason for high prices. The hope of every reader lies with more production which means more work by all of us. What we get in money wages means nothing until we turn it into "goods." What we get for our weekly pay in food, clothing and shelter is our real wages. This can be increased only through increased production which requires longer and better work and more new inventions. In fact, the real reason why wage workers have more goods today is due to inventors and laborers, not to labor leaders and politicians.

What Is The Remedy? Shall we destroy unions? No! Shall we abolish collective bargaining? No! Shall we enact more anti-labor laws? (Continued on page Two.)

By-Passing Of Labor Law Ires Hartley; Asks Probe

Washington, Aug. 23—(AP)—Chairman Hartley (R-NJ) of the House Labor Committee, co-author of the Taft-Hartley Labor Act, called today for a Congressional investigation of "any and all efforts to by-pass the law." Hartley called AFL and CIO proposals to ignore the act "bribe offering."

"When the rank-and-file members understand what this law means to them," he told reporters, "There will be a revolution against the leadership. The leaders then will be looking for every excuse under the sun to conform to its terms."

Turning to reports that several unions have expressed a determination to avoid the Taft-Hartley law by bargaining with the employers independently of the National Labor Relations Board, Hartley declared: "I am going to ask the joint committee to investigate any and all efforts to by-pass the law, whether by unions working alone or in conspiracy with employers. That applies both to violations of the spirit and the letter of the law."

Security Council Given "Last Chance" By Dutch

Virtual Ultimatum To Either Police Cease-Fire Order Or Keep Hands Off In Indonesian Fighting

Lake Success, Aug. 23—(AP)—The United Nations Security Council, in its efforts to halt hostilities in Indonesia, branded a failure by The Netherlands, appeared headed for trouble today in its efforts to reach a decision on the problem.

Dr. Felco N. Van Kleffens, The Netherlands representative, delivered a virtual ultimatum to the council yesterday, demanding that the council either send troops to Indonesia to police its cease-fire order, or keep hands off and let the Dutch handle the situation.

He said that killing had increased in Indonesia since the cease-fire order and implied that further intervention would intensify the conflict.

On the basis of statements made by the various delegates at two sessions yesterday it appeared that the council might find it difficult to work out an acceptable solution of the difficulty.

Soviet Deputy Foreign Minister Gromyko said he was unable to accept proposals which had been submitted by Australia, the U. S. and China. These proposals would call for commissions either of three members or of the consuls in Batavia to supervise the U. N. cease-fire order.

It was believed that delegates may attempt to work out some compromise during the weekend which may be acceptable to Russia.

Convict Out-Ran Bloodhounds But Had No Luck

Atlanta, Aug. 23—(AP)—A young Negro convict, blessed with amazing stamina and no luck, literally outran two packs of bloodhounds for 25 miles across brush and wood country for six and one-half hours.

At the end of the chase late yesterday, Stephen Johnson, 18-year-old trusty at a Fulton County prison camp, scaled a cliff and ran smack into the automobile occupied by Fulton Police Chief Ned Ellis.

Chief Ellis said the youthful Negro had run one pack of hounds until they were winded and his pursuers had to put a fresh pack to work.

The Fulton police had said Johnson appeared over the cliff and leaped in his car, gasping "them dogs is gonna eat me up."

Virginia Hill In Coma; Condition Said Critical

Miami Beach, Fla., Aug. 23—(AP)—Virginia Hill, whose turbulent life has been crowded with lavish parties, three marriages and a gangland killing which snuffed out the life of her boy friend, Benjamin (Bugsy) Siegel, lay unconscious in St. Francis Hospital today, near death from an apparent overdose of a sleeping potion.

At midnight last night she had been in a coma for nearly 60 hours. Her condition was listed as "very critical" and was complicated by pneumonia.

During the night she improved slightly, but an authoritative source said her life still hung in the balance.

"The outcome is in doubt at present," this spokesman said.

Miss Hill was rushed in an unconscious condition yesterday from her spacious home on Sunset Isle No. 1, where she had recently installed an elaborate floodlighting and alarm system as a precaution against a gangland attempt at her life, to the hospital.

U. S. SOLDIERS TO BE FREED BY RUSSIANS

Soviet Authorities Announce Three Enlisted Men To Be Freed Sunday

Seoul, Aug. 23—(AP)—The Russians announced today that three American enlisted men taken into custody just inside the Soviet occupation zone in North Korea Aug. 12 would be released Sunday.

The American liaison officer at Pyongyang, Russian occupation headquarters, was informed by a representative of the Soviet command that the Americans would be released at the point where they crossed the border.

The three are T-5 Tommy P. Pugsley of Renton, Wash.; PFC John D. Hoppe of Seattle and PFC Gerald K. Geffen of Port Chester, N. Y.

An American intelligence officer said they would be interviewed in Seoul Sunday morning.

The intelligence officer expressed some skepticism of the Russian announcement, however. "Our attitude here," he said, "is 'seeing is believing,'" and added that the Russians had promised to release the soldiers once before, the day following their seizure. (The Army had not previously disclosed the earlier Russian promise to release the men.)

Lt. Gen. John R. Hodge, commander of the American (southern) occupation zone in Korea, had lodged two strong protests against the arrest of the Americans, who were on an official mission to inspect telephone lines connecting U. S. headquarters in Seoul with those at Pyongyang.

His protests and demands for an explanation were answered only with a terse statement that "General Korotkov (Russian occupation commander) is handling the case himself."

CONGRESSMAN DIES

Cotuit, Mass., Aug. 23—U. S. Rep. Charles L. Gifford, 78, died early today at his home. Gifford had been a member of Congress since 1921.

Predicts Early Attack On Co-Op "Monopolies"

Washington, Aug. 23—(AP)—Legislation to crack what some cities called "co-op monopolies" operating in government housing projects is virtually certain to be presented to Congress when it returns in January.

This prediction was made today by a high-ranking Republican as a House Small Business Subcommittee delved into the operations of the co-operative at Greenbelt, Md.

Mayor George Bauer of the government-built town of 7,100 population told the committee the community's business is in the hands of a "co-op monopoly" and recommended the introduction there of "free-competitive, private enterprise."

Samuel F. Ashelman, co-op manager, retorted, "we are not a monopoly at all" and said co-ops, too, are free enterprise.

Bauer and numerous other residents of the huge federal housing project said co-ops "are good," but they objected to the exclusion of private business from the community. Some said the "monopoly" encouraged inefficiency and high prices.

The committee was told that private business is prevented from operating at Greenbelt by government leasing of all business facilities to Greenbelt Consumer Services, Inc., a co-op.

Not one of the numerous Greenbelt residents who appeared before the committee in the first day of hearings said the co-op should be removed, but virtually all recommended that private business be allowed to enter the town to put trade there on a competitive basis.

Rattling A Skeleton

Dutch Hope To Convince World That Late Jap Field Marshal Count Terauchi Behind Indonesian Fight; Background; "Operation Scotch"; Terauchi's End

The Netherlands are rattling the skeleton of the late Japanese Field Marshal Count Teruchi Terauchi in the apparent hope of convincing world opinion that the Republic of Indonesia is an illegitimate offspring of Japanese "co-prosperity sphere."

The Dutch appear to be reviving this argument as an offset to the widespread popular inclination to side with the Indonesians as underdogs against the Europeans who have ruled the Indies for three centuries. This inclination, they obviously feel, is placing them at a disadvantage in all discussions of the Indonesian conflict.

Hubertus J. Van Mook, Holland's acting governor general in the Indies, this week revived the theme that Terauchi indoctrinated Indonesian President Soekarno and Vice-President Mohammed Hatta with the independence bug.

This theme was first expounded by Dutch spokesmen to a few of our foreign correspondents who arrived at Batavia on Sept. 15, 1945, in a British cruiser squadron accompanied by the Dutch fleet leader Tromp carrying scars of war and a wistful Dutch hope of an open "welcome home" to the Indies.

We were called a "preoccupation party." There were not enough troops ready for a full-blown allied occupation. That came more than a fortnight later when the trouble began.

We found peace and cheers along the way to the sumptuous hotel Des Indes in Batavia. Then, gradually, the situation soured as the

Social Security

Social Insurance System Makes Provision For Young Widows With Children And For Old People As Well

When the Social Security Act was amended in 1939, provision was made for monthly benefits not only in old age but also in the event of the breadwinner's death. Old-age insurance became old-age and survivors insurance. This insurance might well be called "family insurance" because sixty percent of the monthly beneficiaries are women and children. Preserving the family is a prime objective of the program. To keep families together, to keep families independent, to keep children in school, to give brothers and sisters the chance of growing up together, in normal home surroundings, under the care of their own mothers are the chief advantages of old-age and survivors insurance.

At present the system operates only for wage and salary earners in private industry and business. Even though an industrial or business concern has only one employee it is subject to old-age and sur-

vivors insurance provisions. The number of employees in the firm makes no difference.
Who can get monthly survivors benefits?
Dependents of a deceased worker who was insured under old-age and survivors insurance provisions, listed as follows:
1. Children under 18.
2. Widows with children under 18 in their care, regardless of the widow's age.
3. Widows 65 or over.
4. Aged parents—if the worker leaves neither widow nor an unmarried child under 18, and if he previously supported his parents.
Before anyone can receive payment of Old-Age and Survivors Insurance he or she must file a claim for benefits, with the Social Security Administration.
The claim—or application—for benefits should be filed at the field office of the Social Security Administration. In this area the office is located in Rocky Mount.
