Russian Protest Firmly Rejected

U.S. Refutes Potsdam Agreement in Raising Level of Industry in Occupied Zones of Germany; Soviet Charged With Failures

Washington, Sept. 2.—(AP)—The United States has firmly rejected Russian protest against a British-American decision to step up the level of industry in their occupied zones of Germany.

A note delivered to the Russian embassy in Washington Friday said the United States government "feels justified in pursuing objectives which have been commonly agreed in making arrangements for that purpose with any other occupying power willing to work toward the common end."

The U.S. and Britain announced agreement last week to raise the industrial output of their economically merged zones to approximately the 1936 standard.

Russia had vigorously protested this move, claiming it violated the Potsdam agreement which pledged the Big Four to treat Germany as a single economic unit.

"The Soviet government is certainly aware of the importance of German production to the economic rehabilitation of Europe. This is particularly true in respect of coal from the Ruhr area of Germany," the American note, made public today by the State Department, said.

Refuting the Soviet contention, the United States charged the Russian government with failure to carry out the Potsdam agreement of 1945.

The note said this Russian failure has "placed upon the United States a heavy financial burden in the occupation of Germany."

"The United States government is unable to accept the thesis that nothing can be done to alleviate the financial burden of the United States or to envelop within the framework of the Potsdam agreement the contribution of the western zones of Germany to the economic reconstruction of Europe until the consent of the Soviet government has been obtained."

The note, signed by Undersecretary of State Robert A. Lovett, recalled that the American government has "sought agreements" for two years to reach agreement with Russia and France and Britain to carry out the Potsdam decision.

Palestine Viewpoints

UN Committee Agreed British Mandate Must End But Divided On Methods Of Establishing Jewish And Arab States; Economic Union Wanted Even By Indians

The United Nations Special Committee on Palestine has presented divergent majority and minority recommendations regarding the method of dealing with the establishment of Jewish and Arab states, but among the important points on which the members of the committee are in agreement is that Britain should be relieved of its mandate as soon as practicable.

There is no suggestion that this is in the nature of a reproach to England. The problem is one which would have worried King Solomon himself. However, the committee report obviously is recognition that the mandatory power is unable to deal successfully with the turbulent crisis in the Holy Land.

So far as England is concerned, the establishment of a Jewish national home is no nearer achievement today than it was thirty years ago when it was promised by the Balfour Declaration. Indeed, the position has so deteriorated under the mandate that the very presence of the British in Palestine is a sorry aggravation, affecting relations between English and Jewish people the world over—affecting international relations in some cases, for that matter.

These being so, the probabilities are that the quickest alleviation of the crisis would be for the U.N. to take over the mandate and let John Bull step aside. There should be no difficulty about this, for there is a widespread desire in England to be rid of a stewardship which has

ONE ACCUSED MOB-MEMBER IS IDENTIFIED

"Buddy" Bush Takes Stand As Witness In Hearing Of Accused Lynchers

Jackson, N.C., Sept. 2.—(AP)—Godwin (Buddy) Bush, 22-year-old Negro who was the intended victim of an attempted lynching here last spring, today identified one of the seven accused white men as a member of the mob which whisked him from the Northampton county jail here.

Testifying at a special hearing ordered by Governor R. Gregg Cherry under the state's anti-lynching law, Bush also said that another member of the accused seven had visited the jail in company with a police officer only an hour before Bush was taken from his cell by a band of masked gunmen.

Bush was the first witness called by the prosecution, as the special hearing opened before Judge J. Paul Frizzelle of Snow Hill.

With the seven defendants sitting in a row, only a few feet away in the big rectangular court room, Bush said: "Mister Joe Lee Cunningham" came to his jail cell with two other masked men and said: "Come on down, nigger, and let's go."

Two of the men were armed with pistols, Bush said. Later, on questioning by Solicitor Ernest Tyler, Bush identified Russell Bryant, another of the defendants, as the man who he said accompanied Police Chief Frank Outland of Rich Square to his cell about 1 a. m. on May 23—an hour before the masked men took him from jail.

The defendants listened intently as the Negro testified. The court room was almost filled by a crowd of 250 persons—about 100 of them Negroes.

After the charges were read to them, each defendant answered individually: "Not guilty."

Bush said he noted only five men in the band. Three of them, he said, came and got him from his cell and two others waited outside the jail.

Northampton county jailer, A. W. Edwards, the next witness, said three men had come to the jail in the pre-dawn darkness. To a question from Solicitor Tyler as to why he had released Bush as to them, the elderly, grey-haired jailer replied: "I was scared, that's why."

In questioning by the solicitor who asked the jailer if he had been threatened or if there had been a show of violence, Edwards said there had not been.

The judge asked him if he had attempted to communicate with the sheriff or with police when the men appeared. Edwards replied: "No."

"Why?" Judge Frizzelle asked. "Those men had pistols," the jailer responded.

When asked by Tyler if he could identify any of the men, Edwards replied that he could not.

GANDHI FASTS FOR "SANITY"

Mahatma's Only 'Weapon' Used For Peace In Calcutta

Calcutta, India, Sept. 2.—(AP)—News that Mahatma K. Gandhi has embarked on a new fast to continue "until sanity returns to Calcutta" spread like wildfire today through this great city, where Moslem-Hindu communal hostility erupted in bloodshed again yesterday.

People from non-curve areas began trekking toward Gandhi's residence shouting: "Long live Mahatma Gandhi x x x Victory to the Mahatma." A spokesman in the crowd declared: "These demonstrations are a token of atonement for the violence around Gandhi's residence Sunday night and an expression of hope that he may revoke his determination to fast."

Calcutta police were forced to use tear gas yesterday to break up a howling Hindu mob which besieged the compound where Gandhi is living in Calcutta with the former Moslem premier of Bengal. The crowd became unruly when Gandhi refused to emerge to look at the body of a Hindu allegedly stabbed by Moslems.

Gandhi's announcement of his fast said: "An urgent summons has called me to Punjab. But since the Calcutta bubble seems burst, with what face can I go to Punjab?"

"The weapon which has hitherto proved infallible to me is fasting. What my word in person cannot do, my fast may."

"If my fasting touches the warming elements of Calcutta it will do likewise in the Punjab also."

"I therefore begin fasting from 8:15 p. m. Monday and end only if and when sanity returns to Calcutta."

Convict Claims Beaten By Three Former Troopers

Halifax, N. C., Sept. 2.—(AP)—Claude Gregory, 45, testified today that when he was recaptured the day after escaping from the Halifax county prison camp he was handcuffed to a tree and beaten with saplings and a cartridge belt by three former State Highway patrolmen.

He said the former troopers were C. L. Teague, A. F. Fields and Joan W. Wilson. The convict testified that R. D. Jenkins, acting police chief, looked on during the beating in a woods off the Littleton-Aurelian Springs highway on August 21. Jenkins and the former troopers went on trial before Judge Charles R. Daniel in Halifax county Recorder's Court this morning, charged assault with a deadly weapon on Gregory, inflicting serious bodily injuries.

WILL NOT SUE
Newton, N.C., Sept. 2.—(AP)—An attorney for R. L. Fritz has said that the Hudson school principal has no intention of suing the county or State Board of Education for return of his teaching certificate.

The State Board of Education ordered Fritz' certificate revoked following a hearing in connection with Fritz' handling of teacher salary checks in the Caldwell county school.

Anniversary

Tokyo, Sept. 2.—(AP)—Gen. Douglas MacArthur, observing the second anniversary of Japan's formal surrender, said today his occupation policy of "right, rather than might," had resulted in "a minimum of fear, of confusion, of unrest" in Japan, despite a critically short economy.

He urged that a peace treaty for the Japanese be drawn "in the same tolerant and just atmosphere."

New Patrolmen Are Sworn In

Raleigh, Sept. 2.—(AP)—The State Highway Patrol built its strength up to 320 men today with the swearing in of 107 new patrolmen.

Associate Justice M. V. Barnhill of the State Supreme Court administered the oath to the new patrolmen, all graduates of a patrol school held recently at Chapel Hill. The ceremony was held in the hall of the House in the State Capitol.

Thompson Air Classic Is Wildest In History

Cleveland, Sept. 2.—(AP)—Air racing's newly crowned champions, preparing to go home with more than \$100,000 in prize money, paused today to study the record of the wildest race in sport flying history.

Four planes dug into the wet dirt near Municipal Airport during the running of the Thompson Trophy Classic at the National Air Races yesterday. The toll was one pilot dead, two injured and one able to walk away from a mass of burning wreckage.

The day rich in flying marks, saw Cood's Cleland boost the world's closed course record to 396.1 miles an hour, a jump of 12 miles, and set a new Thompson mark for one lap by turning up 404.4 miles an hour.

The Professional Racing Pilots Association headed by Arthur Chester of Los Angeles was called into meeting this afternoon to discuss steps to increase safety and spectator enjoyment. There were intimations the pilots will ask for stricter regulations for both fliers and planes, and also will seek changes in the race courses.

Cleland's performance in the 20-lap 300-mile race for \$16,000 first prize topped a brilliant three-day exhibition. A second Cleland entry, flown by Richard Becker of suburban Willowoughby, finished second.

The third Cleland plane figured in the day's tragedy Tony Jannazo, popular young flier, crashed with it in the seventh lap and died in the wreckage. All three planes were Corsair Navy fighters powered with the largest and most powerful reciprocating engines ever flown.

Jack Hardwick of Arcadia, Calif., started the crash series by setting his P-51 Mustang down in a field near the race course. It was a rough landing that tore the plane to pieces and started a fire. But Hardwick walked away and within 15 minutes was back in the race stands.

Then Jannazo crashed, and almost immediately Woody Emondson of Lynchburg, Va., made a forced landing that sent him to nearby Berea Hospital. His condition was described as fair.

Jeann L. Ziegler of Kenmore, N. Y., flying an experimental fighter, the Curtiss XP40-Q and apparently in the race without authorization, gave the entire crowd an unlooked-for scare by abandoning his plane and parachuting in full sight of the stands. He broke a leg in landing.

Only six of the 13 planes which took off in the Thompson Classic finished.

THIRTY-FIVE FEARED DEAD IN COLLISION

Vacationers' Special Train Rams Standing Express; Rescuers At Work

Dugald, Man., Sept. 2.—(AP)—At least 35 persons were killed last night in a collision of a vacationers' special train and a standing passenger express at the Dugald station, 20 miles east of Winnipeg.

Rescue crews clawed through the burned, twisted wreckage of the two trains in an effort to extricate the dead and injured. The west-bound vacation train smashed head-on into the express as the latter was discharging passengers.

Rescue workers toiling at the scene said this morning they had recovered 17 bodies from the charred wreckage of the special train, two of which burst into flames immediately after the collision.

How many more bodies might be buried in the charred wreckage of the coaches no one knew, but some of the estimates ran high. All the victims thus far were said to have been aboard the special.

The fifteen injured—all of whom had been aboard the resort train—were taken to the hospital at St. Boniface. With a few exceptions the passengers aboard the transcontinental train bound from Vancouver to Toronto, escaped with nothing more than a shaking up.

The special was said to have been traveling at about 30 miles an hour when it crashed into the standing express shortly before 11 p. m. The second car of the 13 in the special burst into flame at once and fire quickly spread, first to the other coaches and then to a grain elevator standing beside the track at this small flag stop. Later it fanned over to oil storage tanks nearby.

Members of the few families which live in the vicinity of Dugald said the scene was a holocaust when they arrived. Flames were shooting 50 feet in the air, they said, the two locomotives were locked together and the baggage car of the transcontinental train had climbed part way up the tender.

CIO President Philip Murray declared American workers are in a "fighting mood." And AFL President William Green asserted that "labor is rallying its forces to fight against oppression and depression."

Murray, speaking by radio from Kansas City, hammered at the economic consequences he foresees.

"I want to say most emphatically," he declared, "that the nation is heading toward another depression—a depression that could easily make the last one appear to be only a minor economic setback."

"I am not saying that another depression is just around the corner," the CIO chief continued, "I am saying that the present trend of higher profits and smaller and smaller purchasing power must be halted and reversed if we are to avoid economic chaos in the future."

As for the fight he said ahead, Murray pictured American working men and women as "determined that their unions will not be weakened."

Green, addressing a Labor Day rally at Chicago's Soldier Field, pledged that the AFL's fight will be waged "not with ill-considered strikes, but with ballots, in the peaceful, democratic, and American way."

Green laid down this five-point program for 1948 as "worth fighting for":

President Tells Inter-American Defense Conference Strength Necessary To Back Up Policy For Permanent Peace; Lays Down Four-Point American Program

Quintaninha, Brazil, Sept. 2.—(AP)—President Truman said today the United States is "determined to remain strong" to back up a foreign policy based on a desire for permanent peace.

He told the Inter-American Defense Conference that this "is in no way a threat" because "no great nation has been more reluctant than ours to use armed force."

But, he said, "Our aversion to violence must not be misread as a lack of determination on our part to live up to the obligations of the United Nations Charter or as an invitation to others to take liberties with the foundations of international peace."

"Our military strength will be retained as evidence of the seriousness with which we view our obligations."

Nevertheless, Mr. Truman expressed confidence that current international disputes can be settled without armed conflict and gave this pledge:

"The world may depend upon it that we shall continue to go far out of our way to avoid anything that would increase the tensions of international life."

Delegates burst into applause when President Truman asserted the United States "shall not forget our obligations under the (U.N.) Charter, nor shall we permit others to forget theirs."

They applauded again when he declared "without the Western Hemisphere, no world prosperity is possible."

A presidential reference to the United States pledge to assist Latin America in a long-range economic program also was cheered. The delegates broke into loud applause when President Truman declared "the United States seeks world peace—a peace of free men."

Greenville banks were crowded this morning with veterans of World War II to cash their terminal leave bonds. A long line of veterans was at the Guaranty Bank & Trust Company before it opened. Bank officials speeded up cashing of bonds when they provided three special tellers to wait on the veterans and avoid congestion. The bank's two branches on Dickinson Avenue at Pitt Street and Dickinson Avenue at Watauga Avenue were similarly busy.

The State Bank and Trust Company's lobby was jammed when the institution opened for business. The crowds were orderly and patient. Many veterans who had an idea the terminal leave bonds had to be cashed today withdrew from the lines when they were assured that they may be cashed at any time.

One veteran standing in line at the Guaranty Bank with his bond in his hand, awaiting the opening, in some manner lost it, and when he started into the bank he discovered his loss. A frenzied search revealed the valuable paper on the other side of the street and cars had ridden over it. The veteran then held his bond with both hands until he reached the paying teller's desk and received his cash.

The crowds at the banks dwindled as the noon hour approached. The terminal leave bonds were issued to men and women who served in the armed forces in World War II in payment for unused furlough time. Officers and men in the armed forces are entitled to 30 days furlough annually. When they were unable to use the furlough time, the government issued termi-

British Unions Adopt Principle Of Direction

Southport, England, Sept. 2.—(AP)—Britain's trade unions adopted today the principle of government direction of labor, surrendering some of their democratic freedoms in an effort to speed national

economic recovery.

Delegates to the 79th annual meeting of the powerful Trades Union Congress agreed to the measure by a vote of more than five to one. This authorized the government to route workers into undermanned industries essential to recovery.

The vote came after the delegates heard Minister of Labor George Isaacs urge British labor to work a few hours longer a week, so that the government might "secure an immediate increase of output where it matters most, without an increase of manpower."

FIRST THINGS FIRST
At the end of the first world war, the Belgian government placed a large sum of money in the hands of Cardinal Mercier to enable him to rebuild Belgian churches that had been damaged by warfare.

What do you think were the first purchases Cardinal Mercier made with the money? Did he restore altars, build broken walls, repair roofs? Not at all. He bought bells for the churches that had their bells destroyed in the struggle. He said that religion would never again be restored to the hearts of the people until they could hear the bells sounding out over the peaceful Belgian landscape. The more practical-minded might have scoffed at this, but the wise old man who made the decision probably smiled and shook his head and said, "No, the first money will go for bells."

Just ponder this as a good philosophy of life. For what are you spending your time, your energy, your money? For pleasures which quickly pass away, for the so-called practical things which many people said the Cardinal should buy first, or for the things that remind you that God is in the world, that beauty still lives, that right is destined to triumph? These are the things worth spending money for indeed.

THAT TRIP TO RIO
President Truman's visit to Brazil during the closing days of the Mutual Defense Conference is really a diplomatic masterpiece of encouragement to our Good Neighbor Policy.

His flight to Rio de Janeiro is the third such excursion the President has made in the interests of cementing good will among the nations of the western world. All of these trips have met with notable success, and have induced a greater feeling of inter-dependence than we have known in many years.

The bonds which exist between the United States and the nations of Central and South America are more than geographical; they extend deep into the roots of growing peoples. Like ourselves, those Americans to the South were fired with a dream of freedom and rose against the old world and its tyrants. They won through despite reverses that matched the discouragements we knew in our own revolution.

No longer are we the self-appointed guardians of the western hemisphere. And aid, however slight, from our sister republics is the first step in the direction of a common destiny which will be ours. The possibilities resulting from cooperation between the Americas are unlimited; and as we grow more and more accustomed to united endeavors, the common benefits will become more apparent.

The developing of truly mutual friendships with the other American countries has been left too long to the automaton-like formalities of diplomacy and Big Business. Mr. Truman is making a great step towards the neighborliness we've been preaching but have left to our dollars to put into effect. What is needed, is the

more frequent meetings between the heads of the American republics in an atmosphere of cordiality; and the promotion of travel by all Americans so that the bonds of national friendships can be strengthened by personal friendships. If there is one thing we have learned, it should be that you can't buy friends, you have to earn them.

WASHINGTON LETTER

By JANE EADS

Washington—There are about 230,000 blind persons in the United States now, and an estimated 25 percent of them could be rehabilitated into employment. These blind are a part of the army of more than 1,500,000 disabled men and women civilians of working age who are eligible for aid under the Federal Security Agency's vocational rehabilitation program. Michael J. Shortley, director of the Office of Vocational Rehabilitation, estimates that the national wealth could be increased by \$2,000,000 if all of these handicapped people could be made fit for job-holding. The program operates in the various states, with 75 percent of the overall operating expenses carried by the federal government. Shortley says an average of 40,000 disabled civilians a year has been placed in jobs since 1943. Rehabilitated last year were unemployed, and 16 percent of them had never worked before.

Shortley figures that about 250,000 persons become disabled each year, about 20,000 of whom are blind. Right now about 170,000 disabled

are in the process of rehabilitation. Currently, Shortley's office is conducting a training institute in Washington—the first of its kind—to stimulate commercial placement of blind civilians for employment specialists from 18 state vocational rehabilitation agencies. "This is a practical course featuring subjects which a blind person must master in order to engage successfully in a small business enterprise," says Shortley. "On completion of the course, state representatives will return to their home offices equipped with another worthwhile tool for use in preparing eligible blind men and women for employment and placing them in suitable jobs."

A lot of disabled persons don't know of this program, says Shortley. Persons of working force age, say from 16 to 65, can apply to their state offices for aid. After making application they are given a free medical examination, counsel and guidance in arriving at a suitable job future with the individual's own hopes and desires always taken into consideration. Then, if necessary—and this has been found true in only about 20 percent of the cases—the physical restoration program begins. This includes surgery to remove or reduce any disability. In many instances, artificial devices are provided, such as limbs, trusses, hearing aids, glass eyes, and so on.

Psychological and aptitude tests are given, and the applicant is placed on the right job. A post-placement follow-up is made in every instance to determine whether the individual is making the proper adjustment and so on. Before an applicant is ready to take on a job he has to demonstrate he can manage one to five jobs in 20 different industries.

two minutes when he finished speaking.

Mrs. Truman and the Trumans' daughter, Margaret, listened to the Chief Executive from seats in the second tier on the right hand side of the conference hall.

Mr. Truman said the postwar era "has brought us bitter disappointment and deep concern."
"We find," he said, "that a number of nations are still subjected to a type of foreign domination which we fought to overcome. Many of the remaining peoples of Europe and Asia live under the shadow of armed aggression."

And he asserted that European economic recovery has lagged because of "political fear and uncertainty in addition to the devastation caused by war."

He laid down a four point American policy under which he said the United States will pursue the quest for peace with no less persistence and no less determination "than we applied to the quest for military victory." The four points:

1. Under the Marshall Plan, he said, America intends to do its best "to provide economic help to those who are prepared to help themselves and each other." He added that the United States is prepared to do everything it can "within safe limits that will be helpful and effective."
2. Fidelity to the United Nations

"We shall not forget our obligations under the charter, nor shall we per-

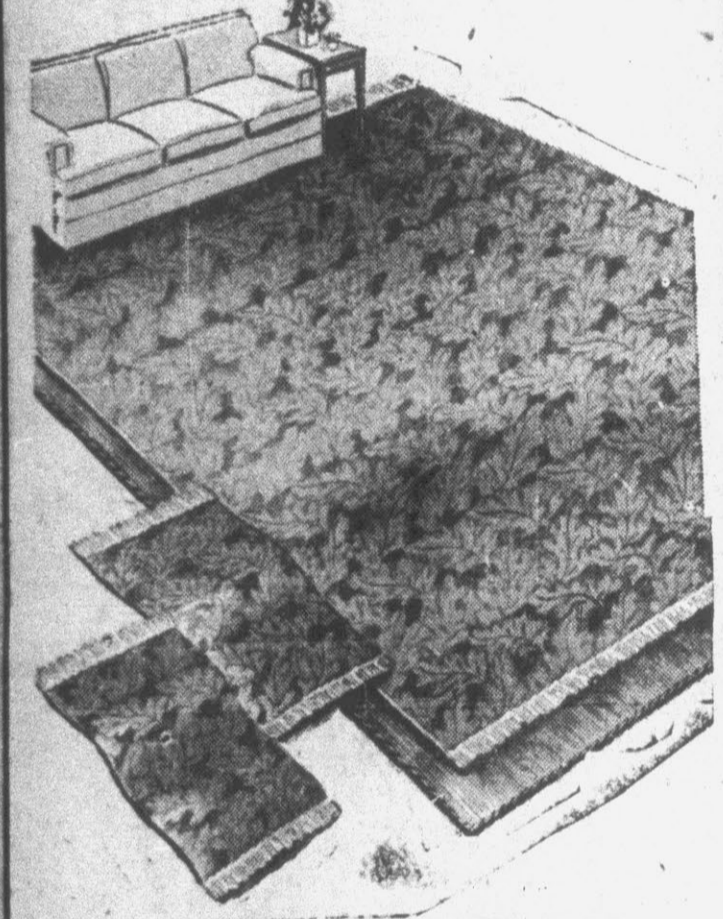

Forest Hills, N.Y., Sept. 2—(AP)—Once more, the Davis Cup belonged to the United States today, saved by California's tennis buddies, stubble-haired Jack Kramer and shoeless Ted Schroder, in a 4-1 triumph over the challengers from Australia.

It may be a long, long time before the tennis world sees another singles battle like the one yesterday in which Schroder outlasted Dimmy Pails to apply the clincher to the five-match series.

It took Jack less than an hour to wrap it up in a straight-set duel that saw him score 30 placements and nine aces against six placements and no aces for Bromwich.

BALLOT FIGHT IS UNSETTLED

Russian Commander Takes Hand In Hungarian Vote Protests

Budapest, Sept. 2—(AP)—Members of the Social Democrat Party said today 17 of their 21 leaders were summoned before the Russian commander in Hungary after several threats to air publicly their protests against methods employed by the Communists in winning Sunday's parliamentary elections.

One informant said he had talked with Minister of Industry Antal Ban, one of the party leaders he said were called by Lt. Gen. V. P. Sviridov, acting chairman of the Allied Control Commission.

The party leaders were quoted as saying that the Social Democratic chief, Deputy Premier Arpad Szakasits, argued violently with Sviridov yesterday over the outcome of the election. Szakasits long has been an advocate of close cooperation with the Communists.

Three ministers in the Communist-dominated coalition government were reported to have quit in protest after the elections.

Figures which the government said could be regarded as sufficiently complete to be regarded as final gave the Communist party 21.6 per cent of the popular vote, which made it the strongest party in the land.
