At that time the Jupiter's crew consisted of 28 men and the boat was being towed by the tug.

However, at 7 a. m. she radioed that the immediate danger appeared over and that unless she went aground, she would be able to hold out until the Coast Guard cutter arrived.

Win Fight Against Poultryless Days

Poultry Men Face Immense Task Of Reducing Flocks Before Jan. 1 In Effort To Effect Promised Grain Savings

Washington, Nov. 8.—(AP)—Victorious poultry men halted the end of poultryless Thursday today with a call for the public to eat more instead of fewer chickens.

Pledged to save 56,000,000 bushels of grain by reducing the size of their flocks, the growers faced the problem of peddling 136,000,000 birds between now and Jan. 1 in the face of huge cold storage supplies already on hand.

In a joint statement with Secretary of Agriculture Anderson, the Citizens Food Committee headed by Charles Luckman last night called an immediate "moratorium" on the poultryless days while retaining the Thursday ban on eggs.

In Los Angeles for ceremonies attending the start of a transcontinental "Friendship Train" with foodstuffs for overseas, Luckman said:

"This committee has been under tremendous pressure for several weeks to remove the ban on poultryless Thursday, but no agreement was reached until the poultry industry came up with a definite program showing where 56,000,000 bushels of grain could be saved."

The committee referred to its action as a suspension "while the new program is given a chance," but the betting around Washington was that poultryless Thursday was as dead as a cold storage duck.

The poultry industry, in its substitute program, pledges to:

1. Reduce the number of broiler chicks one-third below normal seasonal levels by Jan. 31 and baby chick production for all purposes by 7 percent between Feb. 1 and June 30 for a combined savings of 21,000,000 bushels of grain.

2. Cut the turkey hatch 12 percent compared with 1947 levels for a 4,700,000 bushel saving.

3. Reduce duck production 15 percent compared with 1947, saving 350,000 bushels.

4. Call U. S. chicken flocks from 536,000,000 to 400,000,000 birds by Jan. 1, saving 30,000,000 bushels.

Single Body For European Relief Urged On Congress

Washington, Nov. 8.—(AP)—Congressional leaders who will tackle the foreign aid problem at the Nov. 17 special session studied today a recommendation that the whole job be handed over to a single new government corporation.

The suggestion came from a 19-man special House Foreign Economic Committee which toured Europe last summer for the background to work out the broad policies of the stop-communism-in-Europe program.

The committee said the new agency should sift all requests for help in Western Europe, boss the purchase of materials in this country, wield any controls necessary to protect the economy of the U. S. and make sure "that the aid reaches those for whom it is intended."

The committee's recommendations were expected to carry heavy weight, since the group was formed at the insistence of Republican leaders who wanted Congress to obtain its own information to consider along with the Administration's Marshall Plan and stop-gap aid proposals.

Wooster, O., Nov. 8.—(AP)—The life of a social outcast was declared by court order at an end for Andrew J. Yoder today, and the 33-year-old Amish farmer pronounced himself satisfied.

As far as civil authority was concerned, Yoder's quarrel with four Amish church officials over a "mite" or boycott was settled by (1) an award of \$5,000 damages, and (2) a court injunction restraining those officials from imposing social bans upon church members.

"I'm satisfied," said Yoder stolidly after he heard yesterday's verdict by a dual-Amish jury. "I believe the injunction will do more good than the damages."

"I think they (the churchmen) will think some time before they put on any more bans."

Yoder had been "mited" or boycotted for the last five years because he transferred his membership from the Helmsch church to the Bunker Hill district congregation where he would be allowed to purchase an automobile to transport his invalid daughter to a hospital here for treatment.

Big Four Deputies See Old Difficulties Arise

London, Nov. 8.—(AP)—The Big Four deputy foreign ministers bumped into new and old disagreements today over the German peace treaty and an official American observer reported, "If anything, there was a setback."

The deputies failed to reach an accord over just what countries should be given a voice in the treaty making, just as the diplomatic chiefs themselves did seven months ago in Moscow.

It was the second spade-work session of the deputies, preliminary to the meeting of the foreign ministers of the United States, Britain, Russia and France here Nov. 25.

Today's sessions were the first since government sources here reported that Britain and the U. S. have tentatively agreed to unite western Germany politically as well as economically early next year if the ministers fail to settle the peace terms.

These informants said it was "virtually certain" that the French zone would be linked to the combined British-American zones and that occupation officials would appoint local German representatives to a provisional parliament which would have limited lawmaking powers.

The informants said, however, that all plans for the establishment of a German state without the Soviet zone were "subject to Big Four deadlock."
