

Cost Estimate Of ERP Abandoned

Administration Takes Step To Reduce Opposition; Some Republicans Still Want Changes In Original Form Of Marshall Plan

Washington, Jan. 6—(AP)—The Administration took some—but not all—of the opposition heat off the Marshall Plan today by jinking the \$17,000,000,000 cost estimate for long range economic aid to Europe.

Suggested by Chairman Vandenberg (R-Mich.) of the Senate Foreign Relations Committee, the action was generally hailed in Congress as removing one major stumbling block toward approval of a four-year recovery program.

However, Senator Millikin of Colorado, who heads the conference of all Republican senators, made it plain that many in his party want still other changes made.

Speaking on a radio program sponsored by the Republican National Committee last night, Millikin predicted eventual approval of a "sane" foreign assistance project. But he told his listeners:

"A decent regard for what is in the hearts of the American people requires that the aid shall not imperil our own economy and shall be of a nature that will help our friends abroad help themselves.

"Decent regard for these duties of high trust will require among other things, that the Congress shall come up with a plan stripped clean of hysteria, waste, extravagance, over-swollen aims and exorbitant claims. Millikin said it should be "a plan sharply focused on the accomplishment of vital objectives, a plan limited in time so as to assure performance of whatever our promise may be, a plan that will avoid raising false and extravagant hopes, a plan so constructed that the performance can be watched and our aid can be abandoned if the intended purposes are not accomplished.

In announcing the Administration's decision to drop the request for authority to spend up to \$17,000,000,000 toward the recovery of 16 Western European nations outside the Communist orbit, Vandenberg said there is no change in the \$6,800,000,000 estimate for the first 15 months of the Marshall Plan's operation. And he told a news conference this figure may lead to "a hell of a lot of trouble" in Congress.

President Calls Cabinet Meet

Washington, Jan. 6—(AP)—President Truman summoned his cabinet to meet at the White House at 4 p. m. (EST) today.

The President's aides would give no reason for the unusual Tuesday session. But it seemed likely Mr. Truman would go over with the cabinet members some phases of the State-of-the-Union message he will deliver to Congress tomorrow.

Teen-Agers Arrested For 'Thrill-Wrecking' Of Cars

Atlanta, Ga., Jan. 6—(AP)—Four gum-chewing, teen-age youths—all sons of socially prominent Atlanta families—were charged with vandalism and malicious mischief today and Police Chief Herbert Jenkins said they confessed the thrill-wrecking of at least 19 automobiles.

Chief Jenkins said the youths were booked as Danny Payne 19; Leonard Haas Jr., 16; Ed Evans, 17; and Harold Ferst, 17.

Jenkins said Payne was released on \$3,000 bond, pending hearing in Recorder's Court at 4 p. m. He is charged with disorderly conduct, malicious mischief and vandalism, and also is accused of larceny from an auto.

Payne signed a statement recounting the personal wrecking of 17 cars, Jenkins said.

Jenkins reported that Haas, Evans and Ferst were free on \$2,000 bond for similar hearings on charges of disorderly conduct—malicious mischief and vandalism.

Chief Jenkins gave the following account: Haas and Ferst told of releasing the brakes on one car each. Evans accompanied the other three, but did not release any brakes, himself.

The boys signed a joint statement recounting how they wrecked the cars "for the thrill of it" as they raced about the swank, residential section of north Atlanta Saturday night and again on Sunday.

Evans is the son of a clergyman. Payne is a leading Boy Scout, and an assistant Scoutmaster.

The United Nations' "Little Assembly"—the iron lung devised by the democracies to try to keep the breath of life in the veto-paralyzed peace organization—began its permanent sittings at Lake Success yesterday, determined and possibly hopeful.

The "Little Assembly" is the interim committee of the General Assembly, and theoretically it comprises all 57 members of the U.N. Actually, of course, Soviet Russia and five of her satellites—Czechoslovakia, Poland, Yugoslavia, White Russia and the Soviet Ukraine—refused to have anything to do with it, and Russia warned that it might lead to grave consequences.

The democracies established this "Little Assembly" as a backdrop for the all-powerful Security Council which had been rendered impotent through the use of the veto power by the Soviet Union. Each of the Big Five powers—the United States, China, Britain, France and Russia—have the veto right in the council, and when it is invoked it stifles action.

Russia used the veto 22 times on vital issues, after which the United States sponsored the creation of the "Little Assembly" which at least can determine the wishes of the vast majority of the U.N. membership (because the veto is inoperative in the assembly) Russia opposed this project fiercely.

The establishment of the "Little Assembly" was an act of near-desperation. While this body represents all the nations excepting the Russian bloc it can only force late views and has no authority to enforce them. However, it can determine world opinion apart from the Russian bloc which is anti-democracy on virtually everything. That democratic world opinion can be a mighty force.

The Russian bloc was urged to join the "Little Assembly" from the start, but refused. Despite this U.S. Chief Delegate Warren R. Austin said at yesterday's meeting: "It is our hope that the states which are not here today will soon join us."

That's a pious wish, but we can't advise you to bet that it will come true. Still, if the split continues between the Russian bloc and the democracies the "Little Assembly" may be the source of a tremendous development—the formation of a new league of nations which would comprise the democratic nations of the world.

That would be an unhappy solution, but it would be far better than a United Nations which is hopelessly split into two blocs constantly at loggerheads. We should like to see "one world" in operation, but if we must have two worlds, it's better that we recognize the necessity and get the democracies organized so that they won't be shot like sitting ducks by aggressive communism.

So the task of the "Little Assembly" may turn out to be to keep the (Continued on Page Eight)

Economic Signs Mixed

'Good' And 'Bad' Prospects Seen By Agriculture Dept.

Chicago, Jan. 6—(AP)—E. Dodd, undersecretary of agriculture, today asserted that economic signs for the new year "are generally mixed" with three major problems demanding solution.

In an address prepared for the 19th annual convention of the National Council of Farmer Cooperatives, Dodd listed the three problems as "the question of aid to European recovery, the need to stop inflation, and the need for strengthening our agricultural program so that it can best serve our farmers and our consumers in the months ahead.

"It would be clear to us all that the decisions we make on these questions will have far-reaching results. x x x We cannot go back to pre-war conditions even if we wanted to x x x."

Dodd said the "good" signs for the nation's economy are the high level of farm prices and income, high production, and the paying off of "a lot of debts."

He said that among the "bad" signs are the inflationary pressure, the need for more food, and the need for more money.

Kashmir Issue To Security Council

Weigh Indian Complaint Against Pakistan Over Fighting And Status Of Kashmir; Delay As Representative Summoned

Lake Success, Jan. 6—(AP)—The strife and bloodshed touched off by the partitioning of India officially came to the attention of the United Nations today when the Security Council takes up India's complaint against Pakistan, her sister dominion, over fighting in Kashmir.

The issue of Kashmir, a princely state about the size of Kansas in northernmost India, covers only the current focal point of fighting but some observers believed that other problems of splintered India might be aired before the U.N.

British India was carved up along Moslem-Hindu lines last Aug. 15, with most of the Moslems in Pakistan and the Hindus in India. Much of the strife has centered on the two countries some of the princely states with split populations should join. Three-fourths of Kashmir's 4,000,000 are Moslems, but the ruler, Maharajah Sir Hari Singh, is a Hindu, and a tug-of-war has been under way over affiliation. India charges that Pakistan is supporting an invasion of Kashmir.

Indications were that the first council meeting here on the subject would be brief and that full debate would be delayed pending the arrival of experts from the contending parties and from Britain. The U.S. also will have expert representation.

Pakistan asked the council for a delay in discussions to allow Foreign Minister Sir Mohammed Zafullah Khan time to reach Lake Success, and there was no apparent opposition to the appeal.

In New Delhi, the Indian government announced that Gopalaswami Iyengar, minister without portfolio and former premier of princely Kashmir, would hurry here to represent India. Britain summoned Philip Noel-Baker, minister for colonies, to Lake Success and the United States called Ray Thurston, assistant chief of the State Department's Division of South Asia Affairs, from Washington.

The session, the first in 1948 for the 11-nation council, finds Canada, Argentina and the Soviet Ukraine taking seats for the first time, replacing Australia, Brazil and Poland, whose two-year terms have expired.

Meat Ration Machinery

Setting Up Of Program On Stand-By Basis Is Proposed

Washington, Jan. 6—(AP)—Proposals to set up meat rationing machinery on a stand-by basis won the endorsement today of Senators Ives (R-NY) and Murray (D-Mont.).

While the meat issue simmered, President Truman's Cabinet Food Committee decided to eliminate eggless Thursdays after this week but to continue its appeal for meatless Tuesdays.

James A. Stillwell, food conservation director, announced that this step is being taken because of a seasonal increase in the supply of eggs.

Stillwell noted on behalf of the Cabinet Food Committee that the supply of livestock, on the other hand, is diminishing. The committee took the stand that for this reason it is imperative that meatless Tuesdays be continued even though meat "may be offered in non-cooperating restaurants and hotels."

The meatless and eggless days, along with poultryless days, were inaugurated last October to save grain for relief shipments abroad. Poultryless Thursdays were abandoned in November.

The Agriculture Department has predicted a meat shortage will develop in the spring. With this in mind, Senator Flanders (R-Vt.) plans to introduce legislation which would authorize the department to make plans for meat rationing.

Brought Food

Many of 600 repatriated Americans who arrived today from Gdynia, Poland aboard the liner Ernie Pyle brought food with them because Russian agents had told them there was a food shortage in America, a ship's officer said.

Agricultural Department agents confiscated spiced sausage and bologna as passengers filed ashore, but permitted them to keep dried mushrooms. The ship's officer also said there was a widespread rumor in Poland the American dollar would soon be devalued.

Denounce Attack On Arab Hotel In Jerusalem

Jerusalem, Jan. 6—(AP)—A Palestine government spokesman, commenting as Arab and Jewish gunfire sounded almost continuously in Jerusalem, declared today the blasting of the Semiramis Hotel here was a "dastardly and wholesale murder of innocent people."

Twenty persons, 19 of them Arabs, perished in the blast yesterday, which the Jewish underground militia, Hagana, said it set off.

"The government takes a serious view of the publicly made claim by Hagana" that it executed the attack, the spokesman said, and is satisfied so-called Jewish sources were without any foundations whatever in claims the hotel was headquarters for Arab military organization.

"Further," he said, "the government is carefully considering the situation created by the action of Hagana in publicly claiming credit for this dastardly and wholesale murder of innocent people."

Hagana spokesmen said the hotel was wrecked because it was a district headquarters of the Arab military units fighting partition of the Holy Land.

In the old walled city, 1,500 beleaguered Jews kept up a fight with numerically superior Arab riflemen.

Protest Quotas Red Cross Set

Washington, Jan. 6—(AP)—The American Red Cross goal of \$75,000,000 for its 1948 fund-raising campaign brought a protest today from the El Paso, Tex., chapter that quotas set by the national organization are too high.

E. M. Kelley, Red Cross board chairman in El Paso, said that he is flatly rejecting a \$33,000 quota there, adding:

"The war is over. If we can cut down 30 percent locally the national body should be able to reduce 10 percent of its overhead."

FIFTH DAY OF STRIKE

Boston, Jan. 5—(AP)—A strike of AFL truck drivers and helpers in Greater Boston went into its fifth day today with only food, perishables and medicine being moved.

Jail Man Here For Worthless Check, Forgery Charges

The sheriff and police have nearly two-score warrants against Ernest L. Jefferson, 43-year-old dairy worker, who lives at a rural point, charging him with forgery and issuing worthless checks. Two of the checks, very crudely signed, were cashed by Quinn-Miller & Stroud and the Taft Trust Store, police said.

Beaufort County Sheriff Bill Rumley of Washington has a large number of checks allegedly issued by Jefferson in Washington, one of them being dated in 1944. Some of the forged checks were signed with the name "Ernest Jones."

Jefferson will be tried in police court Friday morning on the two local charges. He will be tried later on the other charges.

Three-Part Arab Plan Is Disclosed

Scheme Designed To Make It Impossible For UN To Partition Palestine

Jerusalem, Jan. 6—(AP)—The Supreme Command of the Arab Allied Forces (SCAAF) has a three-phase operations plan to prevent the partition of Palestine and right now is about halfway through phase one, it was learned today from reliable sources.

A military scheme designed to "make it impossible for the United Nations to turn Palestine into Jewish and Arab states" has been devised in these three stages, these sources said:

1. Eviction of the Jews from quarters where the Jews and Arabs have lived as neighbors.

2. Isolation of Jews of the north coastal plain and the southern desert by driving Arab wedges between them.

3. Final drives to exterminate or subjugate Jewish communities such as Tel Aviv, Jerusalem's Rehavia, Haifa's Hadar Hacarmel and hundreds of Jewish villages and settlements.

For two weeks volunteer forces under the unified command, directed from Cairo, have been engaged in phase one, which is about half done, the informants said.

In Jerusalem, for instance, Jews already have fled Upper Bakaa and Katamon, two fashionable residential quarters mainly owned by Arabs but about half rented to Jews.

Still mixed in Talbieh, "and that's the next," the sources said, adding: "If the Jews don't move, we'll chase them out." These evictions, which in effect are partitioning Palestine into Arab and Jewish cities, were described as "security measures."

"If our men want to attack Rehavia, for instance, we want to be sure the Jews can't counterattack from Katamon or Talbieh, which would be at our back," one informant explained.

SCAAF at present is composed of 16 men in six cities. All are veteran warriors and all served in one way or another in the Arab revolt of the late 1930's. At the top is Tahil Fasha Hashimi of Baghdad, one-time minister of Iraq and a relative of the kings of Iraq and Trans-Jordan.

March Of Dimes To Start Soon

The annual March of Dimes, spearhead of the fight against infantile paralysis, will be held throughout the nation January 15 to 30, it was announced here by June H. Rose, Pitt County chairman for the Infantile Paralysis Program. L. S. Murray of Grimsland is March of Dimes chairman.

"The cost of fighting polio has skyrocketed," Mr. Rose said, pointing out that rising prices and mounting polio incidence have placed a tremendous burden on the resources of the National Foundation for Infantile Paralysis, which this year celebrates the Tenth Anniversary of its founding by Franklin D. Roosevelt.

Chairman Murray's March of Dimes Committee is setting up the machinery that will make the 1948 appeal a record demonstration of this area's active interest in helping the stricken children of America along the road to health.

"Every phase of community life will participate in sending a ringing message of hope to the unfortunate victims of this crippling disease, which has stricken 80,000 Americans in the past five years."

"Even the school children will take an active part in helping the less fortunate by participating in March of Dimes school activities."

"When the 1948 March of Dimes goes into action on January 15, more than 500,000 volunteers from every walk of life will be translating American ideals into terms of active assistance. This is the democratic way of fighting a humanitarian war against disease. Every man, woman and child must enlist in the fight by joining the 1948 March of Dimes."

Five Fatalities On Pitt County Roads During Last Year

Only five fatalities from motor vehicle accidents occurred in Pitt County during 1947, compared with 14 during the previous year, State Highway Patrol Capt. John Laws states in his report to headquarters.

However, there more motor vehicle accidents during 1947 than in 1946. "Indicating good luck and good surgery," the report states.

The report for December shows that 35 highway accidents were investigated; 21 persons suffered physical injuries; property damage during the month was about \$10,000, and the patrolmen made 185 arrests.

Ten persons were arrested for driving while drunk, 19 for reckless driving, and 15 for being drunk on highways. Other arrests were for failing to stop at "stop" signs, driving without a driver's license, improper brakes, lights, etc.

The highway patrolmen issued 28 warnings to motorists during the month and ordered lights corrected on 460 vehicles.

Boost Size Greek Army

Britain To Transfer Lend-Lease Equipment To Gov't

Athens, Jan. 6—(AP)—With the consent of the United States, the strength of the Greek army is to be increased by 12,000 men and the manpower of the national guard is to be boosted to 50,000 men, Premier Themistokles Sophoulis announced last night.

The decision, he said, constitutes a reply to the help given Communist rebels by Greece's neighbors and is intended to encourage those who defended and liberated Komfita in the last week of the old year. The announcement was issued after Sophoulis conferred for two hours with Dwight P. Griswold, head of the American Aid Mission to Greece.

The size of the army thus will be swelled from 120,000 men to 132,000. The present strength of the national guard is 20,000 men, making a total increase for the two branches of 42,000 men.

By strengthening the national guard, Sophoulis said, the army will be freed of guard duties and enabled to pursue and attack the guerrillas of Markos Vafiades, the rebel chieftain, who has proclaimed a Communist state in Greece, but who has been unable yet to find a seat for his government.

At the same time, the U.S. State Department announced in Washington that as part of the program to aid Greece in its fight against communism Britain had been given blanket authority to transfer lend-lease military equipment to the Greek government.

The equipment, surplus to British needs, already is in Greece, the department said, but no inventory is available.

The Program Of UMT

An Outline Of The Plan Before Congress For Universal Military Training; May Be Taken Up This Session; How Handled; Army And Legionnaires Endorse It

Washington, Jan. 6—(AP)—Here's the plan now before Congress for compulsory military training of youths 18 to 20.

They'd get six months training in a camp or on a ship. Then they'd have to take more training in school, the National Guard, or some other way.

This plan has the blessing of the Army and the American Legion. Both want compulsory military training started now.

It can't become law unless both Houses of Congress okay it. Neither has acted yet. Perhaps neither will this year.

And, if Congress passes a training plan, it may differ from the one outlined here. But this is the only plan talked about.

If this plan became law, here's how it would work:

Cost—at least \$2,000,000,000 a year.

Number trained—about 900,000 youths yearly.

Organization—these youths would not be part of the armed forces of the Army or Navy. They'd be members of a new organization called the National Security Training Corps.

Start—the program would start within about a year after Congress made it a law. It would take that long to get the whole thing started.

Running it—the policies and standards would be set up by a three-man commission called the National Security Training Commission, ap-

Lull-Before-The-Storm Atmosphere; Only Routine Formalities Occupy Legislators While Awaiting Presidential Message Tomorrow; Weighty Issues To Be Met

Washington, Jan. 6—(AP)—Congress convened at noon today in a lull-before-the-storm atmosphere.

There was no fanfare and only routine formalities in the senate and house. But off the floor the talk was of battles ahead in an election year over weighty domestic and foreign issues.

Traditionally, congress undertakes no business until it receives the President's annual state-of-the-union message. Mr. Truman will deliver that in person at 1:30 p. m. tomorrow.

It is expected to draw clearly the lines between the White House and the Republican-controlled national legislature on many matters. Mr. Truman may give his views—say what he wants—on tax reduction, foreign aid, military training, powers to use against high prices.

Congress' answer will come bit by bit in the debates and the votes of the months ahead while the November elections draw closer.

While almost all congress members were in town for the session, not all attended the opening meeting. There were many vacant seats in both chambers, but the galleries drew the normal crowd of visitors.

Since Congress adjourned December 19, Rep. Patrick Drewry, Virginia Democrat, has died.

Drewry's death and the resignation of Earl Clements, Democrat

CONCERNING MIRACLES
Do you believe in miracles? Did
they ever occur and if so do they
continue to occur today? These are
questions which everyone truly seri-
ous about his religion should at-

LETTER**

Washington—Some \$5,000 meals
a day are served in the 43 restau-
rants and cafeterias in government
buildings here but Uncle Sam never
buys the food, cooks nor serves it.

The cafeterias are operated by Gov-
ernment Services, Inc., a private,
non-profit distributing agency formed
Dec. 28, 1926. The agency, com-
monly known as GSI, also operates
10 or 12 snack bars.

The restaurants and cafeterias
are located in such buildings as
Navy, Munitions, Commerce, Labor,
Justice, Supreme Court, Interior,
Post Office, the National Art Gal-
lery and the residence halls at Ar-
lington Farms for government girls.

The government employee's lunch-
son check averages around 31 cents,
but there are two popular plates for
35 cents and one for 40 cents.
One of the 35-cent plates consists
of a meat substitute, such as a
vegetable, bread and butter and a
beverage. The other is made up of
a choice of three vegetables, also
with bread and butter and a be-
verage.

The 40-cent plate includes meat,
a choice of one of three vegetables,
bread, butter and beverage.

The majority of government work-
ers have a "sweet tooth," says a
GSI official, and most prefer coffee
as a beverage, with milk a close
second choice.

GSI recently reported that though
there had been a slight slump in
patronage this past year, 117,084
dozens (not pieces) of knives, forks,
teaspoons, and dessert spoons had
been "lost" as well as 155,254 dozen
pieces of china.

The loss was due, officials figured,
mostly to breakage, or the stuff
was accidentally thrown out with
the garbage. A large percentage
was snatched by souvenir-hunters.

Last year the loss was even great-
er, with 169,642 dozen pieces of china
and 121,452 dozen pieces of silver
missing.

GSI operates a variety of other
services—six public swimming pools,
bicycle concessions and Pierce Mill
(built in 1821) on Rock Creek Park,
where the agency grinds its own
whole wheat flour and corn meal.

In addition, GSI operates Ft.
Washington, a housing project about
17 miles from the heart of the
capital. The project consists of what
were officers' quarters set up by
the Army and now leased by GSI
from the Interior Department.

GSI leases units here ranging
from three to 11 rooms with rent
from \$35 up to \$85.

A more recent project taken on
by GSI in May, 1946, is the entire
village of Fontana, Tenn., which
the TVA constructed to house em-
ployees building the Fontana Dam.

About 100 TVA permanent em-
ployees still live at Fontana. There
are about 150 GSI people there too,
the year around, but the village is
operated now chiefly as a summer
spot which can take care of 1,200
to 1,500 people.

Veterans Advised Of Time Limits In Using Benefits Under Service Law

The County Veterans Service Office advises that the time limits in which veterans and their survivors and dependents are entitled to exercise rights, benefits and privileges to which they are entitled, as revised August 1, 1947, are as follows:

Ninety days after discharge: Application for reinstatement in permanent job held at time of induction.

Six months after discharge: Veterans may enlist in Enlisted Reserve Corps in same grades held at time of discharge, within six months of discharge.

Until nine months after discharge: Veterans who have not completed USAFI educational courses begun in service are eligible to complete such courses and take end-of-course examinations.

Until July 1, 1948: Reinstatement of term National Service Life Insurance without physical examination.

Michigan, In Landslide

Ballots Give Wolverines Mythical Title Over Notre Dame

New York, Jan. 6—(AP)—The burning sports question of the day—which was the greater college football power of 1947, Michigan or Notre Dame?—never to be settled on the field, was answered today at the ballot box—and it's Michigan almost two to one.

In a special Associated Press poll of sports editors and football writers from coast to coast, Michigan received 226 votes as the superior team to 119 for the Irish, while 12 of the experts suggesting the two mid-west giants should be rated equal.

A total of 357 writers, from each of the 48 states and the District of Columbia, took part in the "post-poll" poll, conducted by popular demand as the result of the New Year's Day game that saw Michigan's unbeaten, untied Wolverines smash Southern California in the Rose Bowl, 49-0.

The new ballot does not supersede the Associated Press' regular final season rating of college football teams released last Dec. 8, which named Notre Dame the mythical national champion with Michigan the runnerup.

The 146 writers who cast ballots in that one gave the Irish 1,410 points to 1,289 for the Wolverines and awarded Notre Dame 107 first place votes, with Michigan getting only 55 and the other 101 tags going elsewhere.

(Continued from Page One) Signs is rising land value. "Farm land values are now within four per cent of the peak reached in 1931 and still slowly going up," he continued.

"Though farm mortgage indebtedness went steadily down all during the war, it has been going up since the beginning of 1946. There is too much land fever in this country. Farm production costs have also been rising rapidly."

"In spite of general good times producers of a number of commodities are in trouble. Average prices of several important farm products are already below parity."

Dodd said this agricultural situation created "important issues" for Congress and the nation in relation to the Marshall Plan, inflation and strengthening of the farm program.

get to work with its head up and its chest out. There seems to be a disposition to confine its labors to non-controversial issues, so not to give offense to the Russian bloc. Maybe that's a good idea, but there are many who would prefer to put it this way:

Let the "Little Assembly" avoid controversial problems where feasible, but let it resolutely face all necessary problems, whether controversial or not.

(Continued from Page One) would have to work out some kind of training for them.

For example: A youth unit for military drill might be able to do clerical work; a conscientious objector might be trained in first-aid work.

Deferments—an 18-year-old who was in high school could get deferred until he had finished or reached 20, whichever was first. And there would be deferments for extreme hardship cases. No youth who was serving, or had served honorably, in the armed forces could be drafted.

Pay—\$30 a month for each trainee. If he had one dependent he'd still get his \$30 and the dependent would get \$50. The government would pay two or more dependents a total of \$65 a month.

Training—each draftee would get six months' military training in a camp or on a ship. But—

After those six months he wouldn't be finished. This is why:

1. He could train another six months. That would mean a total of 12 months' training. Then he would be discharged, with no strings attached.

2. Or, having trained the first six months, he could go back into civilian life provided he joined the National Guard or some other reserve outfit.

If he joined the National Guard (he might have to join for three years) he'd have to drill one night a week and go away to camp for two weeks in the summer.

3. Or, having trained six months, he could go into the Reserve Officers' Training Corps in the college he attended.

This would mean some drilling and military instruction for his four college years. Upon graduation he'd be commissioned an officer in the reserves.

There are other choices a trainee, after six months of training, could make. Those listed here are just some of them.

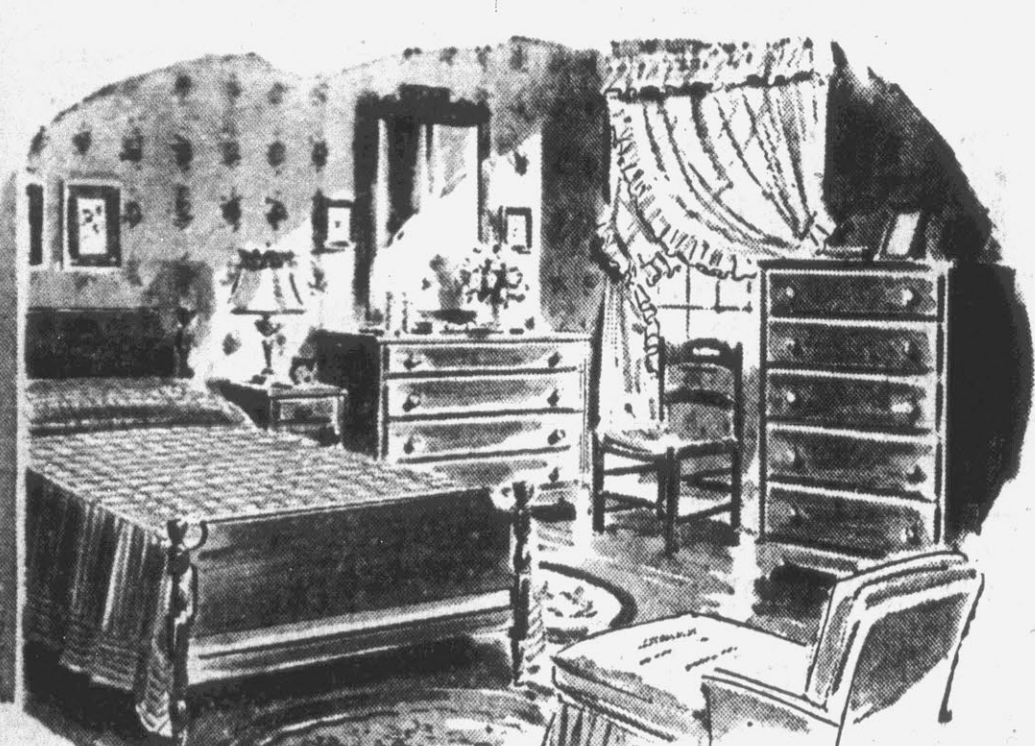

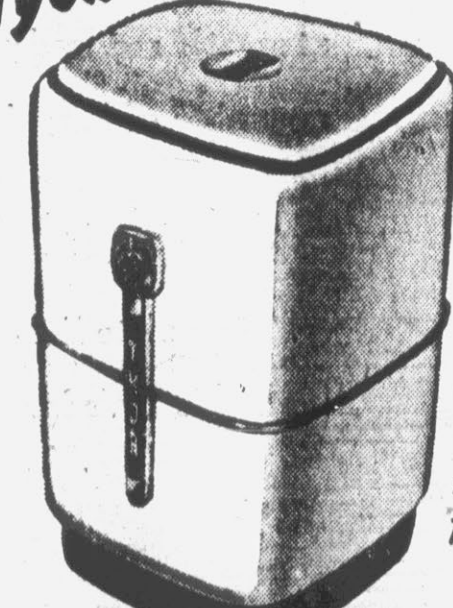
