Army Costs Rise With Price Scale

Witness Says Price Increases Has Cost Army \$250 Million In Nine Months

Washington, Jan. 20—(AP)—Col. Philip Smith, an army purchasing officer, said today that a 30 per cent price increase for supplies during the last nine months has cost the army about \$250,000,000.

Smith told the senate banking committee, studying bills to check inflation, that all pending legislation to stabilize prices, measures to impose price controls at wholesale would be "of most benefit to the armed services."

The army officer emphasized this was his own opinion and that he was not speaking for the army department.

Before the hearings were resumed, Committee Chairman Tobey (R-NH) came out in favor of a "get-ready" meat rationing law. A bill to authorize the Agriculture Department to set up the necessary machinery is before the group.

The committee called Smith to testify on how much of the military is shipping out of the country and where it is going. Smith said he could not help much on this, but that Rear Admiral W. M. Gallagher, scheduled to appear later in the day, probably would know.

Smith did volunteer that most fuel oil for Japan and other Far Eastern areas is shipped from the Persian Gulf region. The committee wants to find out whether exports of fuel oil from the United States in a time of shortage are forcing domestic prices up.

Senator Maybank (D-SC) asked whether the army has noticed any decline in prices in buying supplies for future delivery.

Smith said cotton textiles "are beginning to show a slight decline" in price.

Tobey asked whether Edwin W. Pauley, special assistant to Secretary of the Army, ever has approached Smith on oil matters.

Smith said Pauley has not, but that an industry executive, who figured prominently in a senate committee's investigation of speculation in grain.

Boy Enters U.S. Third Time And Told Must Leave

Charleston, S. C., Jan. 20—(AP)—A persistent 80-pound French youth was scheduled to be deported today for the third time.

Immigration authorities said that 15-year-old Marcel LaFarge and a companion, Jacques Buisson, 16, arrived here Sunday aboard the George Handley, on which they had stowed away.

LaFarge said his father never returned after joining the French army in 1940. His mother, he added, was killed in a 1944 bombardment.

LaFarge related that he adopted American army units and made his first attempt to enter the U.S. at New York. Last November he and Buisson were caught in Philadelphia and deported.

"What's the difference," LaFarge told authorities here, "they send me back now but I'll come back France is no good for me. Here in America I could be free."

Refused To Take Only Two Dollars

North African Base

Mellaha Airport In Itself Of Small Import But Considerable Significance Attached To Reopening Of Base By Americans; Our Frontlines Also Lie In Mediterranean

Washington's decision to reopen the war-time American airfield of Mellaha, near Tripoli in North Africa, has stirred the wrath of the Soviet press which (always inspired) charges that this is further evidence of Uncle Sam's imperialistic ambition to rule the world.

The accusers choose not to recall that Russia has made an open secret of her desire to become a Mediterranean power. Indeed, she wants a mandate over the Italian colony of Tripolitania, and is demanding that Turkey give her a hand in the control of the strategic Dardanelles which provide the Soviet Union access to the Mediterranean from the Black Sea.

Well, America has no imperialistic ambitions, but a couple of world wars, in which she has been compelled to play a leading role, have thrust world wide interests and obligations upon her. She proposes to carry out her obligations to others and to safeguard her personal interests—and it's well that this be recognized by all and sundry.

One of the theatres in which Uncle Sam's obligations and interests are heaviest is the Mediterranean. This vast area, which washes the shores of many countries on three continents, has become one of America's front line defenses—one

Tax-Cutting Plans In Decision Stages

House GOP Steering Committee In Afternoon Session To Shape Party Policy On Issue; General Party-Line Already Fairly Well Decided

Washington, Jan. 20—(AP)—Republican tax cutting plans reached the decision stages today.

Speaker Martin (R-Mass.) called the house GOP steering committee to an afternoon session to shape party policy on the red hot domestic issue.

There was every advance indication the committee would:

1. Ignore the urging of Bernard M. Baruch to put off tax cutting for two years.

2. Reject flatly President Truman's request for a \$40 "cost of living" tax cut for everyone with an offsetting revival of the wartime excess profits levy on corporations.

3. Throw its weight instead behind a trimmed down version of the Knutson bill.

Chairman Knutson (R-Minn.) of the tax-writing ways and means committee told newsmen he would carry into the meeting a demand that his \$500,000,000 bill be adopted as the GOP tax slashing goal for 1948.

But high Republicans who would not allow the use of their names predicted the Knutson plan would be trimmed down—possibly to an overall cut of \$400,000,000—with chief emphasis on lower rates for taxpayers in the low brackets.

There was general agreement among GOP leaders that present exemptions should be boosted from \$500 to \$600 and that the principle of community property taxation—allowing husbands and wives to split the family income for tax purposes—be applied uniformly throughout the nation.

But there was some objection to Knutson's proposal for percentage cuts ranging from 30 per cent at the bottom to 103 for those with high-bracket incomes. The best guess was that these percentages would be trimmed all along the scale.

Republican spokesmen have adopted the view that upping of the personal exemption along with the community tax plan will appeal to the largest number of taxpayers and voters and will soften objections to some reduction for high-bracket individuals.

Pauley Turns On Market Probers

Demands Senators Either Prove He Used Inside Knowledge For Personal Gain, Or Publicly Admit To His Business Ability

Washington, Jan. 20—(AP)—Edwin W. Pauley demanded today that senate investigators either prove he used inside government information for personal gain or acknowledge publicly that he made money in commodities through sheer business ability.

He insisted that the full record of his admittedly profitable market dealings "is a story of profit honestly and honorably made, legally, ethically and in the American tradition."

Pauley, a special assistant to Secretary of the Army, declared "I have never at any time in my life used any government position, or any 'inside information' for my personal financial gain."

He made the assertions in a letter to Chairman Bridges (R-NH) of the senate appropriations committee.

The letter and the full records of Pauley's commodity transactions for the past three years were made public by Senator Ferguson (R-Mich.), chairman of a subcommittee which Bridges named to inquire into speculation by government employes.

He held Bridges in the 2,000-word letter, dated January 3:

"If your committee finds that I have used 'inside information' it will clearly have the duty of seeing to it that I am exposed. Since no such

finding is possible—because no such impropriety ever occurred—I trust that the committee will likewise feel the obligation to see that I am vindicated."

Pauley's letter recalled that he denied under oath last December 12 that he had ever used any such information. He added:

"Despite this, the propriety of my conduct has been held up to question throughout the country, by inference and innuendo."

"Now, denials by me cannot unwarranted headlines or unspeakable radio comments. Therefore, in simple justice—which I am certain is your committee's goal—I respectfully request that your committee make a definite finding as to the question: "Did or did not Edwin Pauley use his government position—or information obtained by virtue of that position—to profit on the commodity markets?"

Referring to lists of heavy traders which the Agriculture Department has given out in connection with the inquiry, Pauley said he has heard it suggested that he was "in some way culpable" because his holdings were larger than those of other traders.

"This appears to hinge on the suggestion that success is a misdemeanor," he said.

Pauley's letter to Bridges said that when Royall asked him to take his present position, they agreed that Pauley was to have nothing to do with any commodity purchases or anything in which he had a financial interest.

"You see, I had been subjected to unfair attack before," Pauley said. "I had no desire to be a candidate for more."

To Relax Law

Boston, Jan. 20—(AP)—It is now up to the Massachusetts Senate to decide whether Rhode Islanders may legally cross the state line into Massachusetts.

After 310 years of technically keeping Rhode Islanders out of the state, the House today approved a resolve to annul the action of the General Court in 1633 which forbade any "inhabitant of providence plantations" to come into Massachusetts in pain of arrest or conviction.

Encouragement For Seekers Of Pirate's Gold

Green Cove Springs, Fla., Jan. 20—(AP)—Eighty-year-old G. F. Mobley and his financial backer, Dr. H. H. Humphries, hoped today workmen will unearth a \$4,000,000 pirate cache which Mobley believed is buried here.

Several chunks of yellow metal brought to the surface yesterday by the huge shovel being used in the excavation on the edge of a downtown street caused considerable excitement. The pieces looked like bits of gold but opinion was divided.

Contractor J. T. Conway who's handling the digging for Mobley said "It's metal and it was 30-feet down." He thinks it's gold.

One jeweler who looked it over wasn't so sure, however. He thought it might be iron pyrite, known as "fool's gold."

As the word spread, a large crowd gathered and police erected a wire fence to keep spectators a safe distance from the hole.

The elderly Mobley has insisted for 18 years there is gold on the spot. He previously tried digging for it but ran out of money. This time, he has secured financial backing and has gone into the treasure digging venture on a big scale.

Nomination Of Army Man To CAB Is Reconsidered

Washington, Jan. 20—(AP)—The Senate Armed Services Committee arranged to take a second look today at President Truman's proposal to let Maj. Gen. Laurence S. Kuter become chairman of the Civil Aeronautics Board with full military status and pay.

The group already has voted unanimously against recommending the necessary special legislation and there was no advance indication of a general change of heart.

The decision to reconsider came after members of the committee talked it over with the President at the White House yesterday. Mr. Truman invited the House Armed Services Committee to a similar discussion today.

Kuter, 42, is one of the younger Air Force generals. The President appointed him CAB chairman last January 8 subject to the passage of legislation permitting him to preserve his rank but exempting him from any control by his military superiors.

At least one member of the Senate committee, Senator Byrd (D-Va.), has announced that he will continue his opposition.

Senator Saltonstall (R-Mass.) told a reporter in advance of the committee meeting that he intended to "express myself strongly—I know which way, but I can't tell you."

Senators Morse (R-Ore.) and Maybank (D-SC) and Chairman Gurney (R-SD) declined to make any advance statement.

Allowance For Elizabeth And Philip Again Studied

London, Jan. 20—(AP)—Parliament returned today from a month's Christmas recess to consider again fixing allowances for Princess Elizabeth and Prince Philip, a question which has split sharply the Labor party's ruling membership in the House of Commons.

Topping the agenda for the opening of Commons was the decisive second reading of a government-sponsored measure to increase Princess Elizabeth's present annual allowance of 15,000 pounds (\$60,000) to 40,000 pounds (\$160,000), and provide 10,000 pounds (\$40,000) a year for Philip.

Dulles Describes Foreign Aid Need

Asks Dixie Demos 'To Get Tough'

Mississippi's Governor Urges Southerners Quit Party If Policy Unchanged

Jackson, Miss., Jan. 20—(AP)—Gov. Fielding L. Wright today called on Southern Democrats to secede from the national party unless its leadership ceases to sponsor "anti-Southern legislation."

Wright made the call in his inaugural address as he began a four-year term to which he was elected last November. He has been governor for the past 14 months, having advanced from lieutenant governor on the death of the late Gov. Thomas L. Bailey.

"I would regret to see the day come when Mississippi or the South should break with the Democratic party in a national election. But vital principles and eternal truths transcend party lines, and the day is now at hand when determined action must be taken," Wright said.

"We have always remained true to the traditions of our party," he said, "and will continue to do so, but when the national leaders attempt to change those principles for which the party stands, we intend to fight for its preservation with all means at our hands."

"We must make our national leaders fully realize we mean precisely what we say, and we must, if necessary, implement our words with positive action."

"We want them now to take heed. "Drastic though our methods may be, and as far-reaching as the results may prove, we are certain that the consequences will justify any temporary setback that may follow our action."

Another Republican viewpoint may come out of conferences by a group of 20 or more GOP senators who have been discussing the Marshall Plan at the invitation of Senator Wigglesworth (R-Meb.), whose "Republican-Liber" leader, disclosed prior to Dulles' appearance before the committee today that the group was seeking agreement on four controversial points in the Marshall Plan.

Dulles said it would be a "fool's paradise," if the United States did "not make honest, substantial efforts to help others to lift themselves out of the morass into which they have fallen." He called an aid program by this nation "enlightened self-interest."

Answering those who would reduce the nearly \$1,000,000,000 which it is proposed that the United States spend in the initial phases of the aid program, Dulles said:

"I am confident that if in the name of economy the European Recovery Program is abandoned, or made inadequate, that will involve our nation in future costs far greater than any present saving."

"We need facts as well as strength" in dealing with the Soviet, she said last night in her first public address since returning from last month's Geneva meeting of the United Nations Commission on Human Rights, of which she is chairman.

Jewish Colony Raided By Arabs

Jerusalem, Jan. 20—(AP)—Arab fighters, apparently striking in reprisal for Jewish raids yesterday, hit today at the Jewish colony of Yehichel, northeast of Acre, and police said fighting was still going on three hours later.

The colony is one of 19 Jewish settlements which are outside the Jewish state proposed under the United Nations' partition plan, approved Nov. 29.

Eight Killed In Baghdad Rioting

Baghdad, Iraq, Jan. 20—(AP)—Eight persons were killed today in six hours of rioting started by youthful foes of the new British-Iraq alliance.

Police with armored cars and machineguns finally restored order around noon. The Iraq army also was alerted.

Hundreds were arrested. About 40 policemen and 100 civilians were injured. The dead were two policemen, two inspectors and four civilians.

Workmen Paid With Blackmarket Fish

Tokyo, Jan. 20—(AP)—Workmen shoveling snow from railroad tracks near Niigata on Japan's west coast worked slyly and complained of poor pay—then suddenly began shoveling quickly and happily. The Tokyo press related today.

They had turned up choice fish, tossed off trains by black marketeers who saw police waiting at the station to search their bundles.

Rent Control Review

Most Congressmen Predict Controls Will Be Continued After Feb. 29; Their Reasons; Politics Also In Picture; Congress Wants To Give Landlords A Break In 1948

Washington, Jan. 20—(AP)—This will bring you up to date on rent control and what may happen to it.

Government rent control ends Feb. 29 unless Congress votes to continue it. Congress now is working on whether to keep the lid on.

Will it? Most Congressmen predict that Congress will continue controls after Feb. 29 in one form or another.

There are a couple of good reasons for thinking so:

1. This is an election year. 2. Rents under the present law, already have gone up. There's bad inflation in this country now. Many landlords are a cinch to boost rents if Congress lets the controls die Feb. 29. That would just kick the cost of living so much higher. Since this is an election year the voters are likely to take it out on the political party they blame for adding to their living costs. President Truman has told the Republican-controlled Congress that rent controls should be continued. Now it's up to the Republicans. If they let controls die and rents shoot up before election day, Mr. Truman then can tell the voters: "I told the Republicans we needed to keep controls but they wouldn't listen to me."

Two Republican senators, Yves of New York and Baldwin of Connecticut, have put a bill in Congress to keep controls until June 30, 1948. Rents already have gone up for a great many people because of the rent control law which Congress passed last summer. This law said that landlords—by letting a tenant sign a lease for a year or more—could boost his rent as much as 15 per cent, if the tenant was willing. Why should he be willing? Two reasons: 1. He might be afraid that Congress would let controls end Feb. 29 and then the landlord could raise his rent any amount. 2. By signing for a 15 per cent boost, he protected himself against a raise of more than that for at least a year if controls did end Feb. 29. (The signing had to be done before Dec. 31, 1947.) Government figures show that, as of last Nov. 28, the tenants of 1,458,115 rented dwellings had signed leases that meant a 15 per cent raise. The same figures—those from the Rent Administrator's office—indicate the tenants of 14,000,000 rentals. (Continued On Page Eight)

WASHINGTON LETTER

By JANE EADS Washington—Super police forces, in hamlet and metropolis alike, are being developed the nation over in "finishing" schools staffed by ace G-men.

In the past year the Federal Bureau of Investigation helped conduct 1,765 programs in which 86,260 officers received general training.

In addition, through its national headquarters and its 51 offices scattered throughout the country the FBI gave specialized training in 157 programs to 8,850 officers.

About a dozen state-wide police administrative schools for ranking officers of departments also had an attendance of approximately 1,500.

Bought voluntarily by local police departments, the FBI programs are tailored to the specific needs of each department, on the theory that the problem at Wichita is not identical with that confronting Boston.

There are departmental schools, some schools (where four or five small towns with forces of one to 25 or 30 send men) and recruit schools for rookies and refresher courses.

Says Gamblers 'Fixed' Some Sporting Events

Albany, N.Y., Jan. 20—(AP)—A broad investigation of professional sports was demanded today by a Buffalo legislator, who said gamblers apparently had "fixed" some events.

Republican Assemblyman William J. Butler, unlike Democrats who called last week for a similar probe, said the State Athletic Commission had "discharged its duties efficiently and courteously."

"Nevertheless," he added in a resolution introduced last night, "a complete, thorough and comprehensive investigation could best be accomplished by a legislative inquiry."

He proposed a seven-member joint legislative committee with "full power to investigate and make a study of professional sports and the manner in which they are conducted."

"Public indignation has been aroused," Butler said, "by disclosure of attempts by organized gamblers to fix sporting events, and it is apparent that some of these attempts have been successful."

Standardization Of Rules Ranks High To Coaches

Movies are being taken of basketball games all over the nation and will be shown to the officials, coaches and players, Hobson said, in an effort to accomplish a uniform interpretation of the rules.

Iba's aides are Ray Oosting of Trinity (Hartford), Alvin Julian of Holy Cross, Lou Alexander of Rochester, Raynor Greene of Cornell, Bernie Carnevale of Navy, Ossie Cowles of Michigan, Harold Foster of Wisconsin, W. M. Stallcup of Missouri, Whitney Bacaus of Southern Methodist, E. F. Shelton of Wyoming, and Sam Barry of Southern California.

The NABC's head says the trend is for more emphasis on scoring, even in the face of improved defenses. The reason, he adds, is that "we're devoting more attention to the shooting average, working on developing accuracy in hitting the target."

Majority On U.S. Olympic Body Approve Boycott

Chicago, Jan. 20—(AP)—Members of the U.S. Olympic committee, in a vote of 80-4, stand strongly behind their chairman, Avery Brundage, now enroute to Switzerland, to withdraw all American winter sports teams from the Olympics if the much-disputed Amateur Hockey Association's entry is permitted to compete.

The overwhelming majority favoring the boycott was revealed yesterday by a committee spokesman, who declined to be identified, following a poll by mail of the 74 committee members.

The six members who cast dissenting votes agreed the committee's stand was justified but thought the American ski, bob-sled and figure and speed skating teams should be allowed to participate since they are already on the scene.

Brundage called for Europe Saturday night and is scheduled to meet the International Olympic committee in St. Moritz Jan. 27 for a "showdown." He will formally disclose the outcome of the poll at that time to back an ultimatum for the I.O.C. to over-ride the Swiss organizing committee's decision to accept the A.H.A. team as the official entry.

The U.S. committee charges that the A.H.A. is "commercially tinged." Tommy Lockhart of the New York Madison Square Garden is president of the A.H.A. league and Walter Brown of the Boston Arena is another league official.

New Record For Clam Eaters On West Coast

Seattle, Jan. 12—(AP)—The Pacific Freestyle Clam Eating Contest Association—a serious minded organization with 193 vice president and no rank and file members—today claimed a new world clam eating record of 120 devoured in 10 minutes flat.

The new champion hailed by the association is Richard Watson, Seattle cab driver, who slammed down a clam every five seconds during the 10 minute contest.

His only rival was a temporary Seattle visitor, J. W. Nichols of St. Augustine, Fla., who claims to have set a world oyster eating mark there of 317 baked "sters" downed in 3 1/2 hours. Nichols finished four behind with 116.

The association, formed at the Washington State Press Club, has granted Nichols a rematch to be held in two weeks.

Judge Gives Long Terms To Robbers

In Superior Court today Judge John W. Burney of Wilmington, presiding over the one-week criminal term, sentenced Macon and Alex Waller, Negroes of Farmville, to long terms in State Prison. They were convicted of highway robbery with firearms in connection with the holdup of James Dall, Farmville taxicab driver, last December 13.

It was testified that the Wallers forced Dall to drive them to a point near Ayden and that they assaulted a passenger in the taxi and forced him to leave the car and shot at him and robbed the driver of \$45.

Judge Burney sentenced Macon Waller to 15 to 20 years in State Prison and Alex Waller to 7 to 10 years. On another charge, five to seven years for Macon and three to five years for Alex.

Calvin Richardson, Negro, convicted of murder in connection with the shotgun slaying of his brother, Eddie, during a family row at their mother's home in Fountain, submitted a second degree murder plea and the court gave him from 15 to 20 years in State Prison.

Quilon Smith, Negro, who pleaded guilty to three charges of breaking, entering and larceny of merchandise, was given three to four years in State Prison on two charges, sentences to run consecutively and three to four years on the third charge; the latter sentence to run concurrently with the first two.

Dennis Williams, Negro, charged with driving drunk and recklessly, was found guilty of reckless driving, but not guilty of driving while drunk. Sentence will be passed later.

Dave Tettion, Negro farm laborer, was arraigned for murder in connection with the pistol slaying of Matthew Dixon, Negro, at a Grimesland store on December 12, and he pleaded not guilty. Tettion's name was spelled "Tetterton" on the warrant.

Russell Bryant of Fountain, charged with carnal knowledge of a female under 18 years of age, pleaded not guilty.

Mitchell Acklin, Negro, former florist's deliveryman, who was convicted Monday of the larceny of floral designs from graves in a cemetery, was given six months on the roads. It was testified that Acklin pilfered the wreaths after funerals and then sold the wire frames to florists.

James Allen Boyd, convicted of breaking, entering and larceny in two cases, was given two to three years on the roads in one case, one to two years in the other case.

Simple Sacrifices Show Gratitude For U.S. Aid

Philadelphia, Jan. 20.—(AP)—Some youngsters in Germany, Austria and Japan are really grateful for American relief food—and show it.

Several thousand children abroad have sacrificed some of their essential materials to say their thanks and make their gratitude known in the United States with gifts of homemade toys.

The American Friends Service Committee said more than 1,000 toys, ranging from complicated mechanical devices to tiny book ends and penknives, were shipped to America by the school children of Darmstadt, Germany, alone.

The toys were sent here in the same wooden crates which carried powdered milk to Europe.

"It's a concrete example of thanks that comes from the heart," said Louise Andrews, committee worker in charge of visual education.

"A small piece of wood can cook a meal but many pieces were used to make these simple toys," Miss Andrews said.

"Cloth, even the tiniest bit, is needed to clothe the ragged population but the Darmstadt children sacrificed enough to make their toys and shipped them, together with Christmas messages, to the U.S."

The toys were set up as exhibits and are being shown throughout the country at schools, churches and libraries.

"Sale of the toys would bring little money," Miss Andrews said, "but the psychological value is very great. It proves that some persons know where aid is coming from and are appreciative of it."
