Paul Porter Sees Need Of Controls

Predicts Country Will Be Forced To Accept Measures With Marshall Plan

By EDWIN B. HAAKINSON Washington, Jan. 24 (AP)—Paul Porter, former price control administrator, predicted today this country will be forced to control wages, prices, credit, meat and essential materials as part of the European recovery program.

He said the price is worth paying because if the Marshall plan is dropped "we forsake the free people of Europe and renounce Europe to Soviet communism or to the throes of civil war."

Multi-billion dollar outlays to get western Europe back on its feet, Porter said, will "aggravate a situation already bad" as far as inflation in the United States is concerned.

He declared new government controls are the only way to forestall an economic collapse "on which the Soviets are basing their expectations and all their hopes."

Porter, a former special presidential ambassador to Greece, said that if a civil war of the kind now going on should break out in one of the larger western European nations "it would point the way almost immediately to world conflagration."

The witness appeared on behalf of Americans for Democratic action, which he identified in his prepared statement as the "national liberal political organization."

In advance of the hearing Senator George (D-Ga) endorsed a plan to remove control of the foreign aid program from the State Department.

"I have come to the very definite conclusion that final authority should be in an independent agency," he told a reporter. "Our contributions and expenditures must rest on the solid judgment of an experienced administrator or board."

Plane Missing In Maryland Storm

Baltimore, Jan. 24 (AP)—State police and Coast Guard stations today were alerted in a search for a two-engine Coast Guard plane believed lost in the winter's worst snow storm in Maryland.

The Baltimore municipal airport reported that it lost contact with the plane—identified as a Lockheed Lodestar used by Secretary of the Treasury Snyder—around 9 a. m.

Snyder was not aboard the ship, which was routed to Baltimore after being unable to land at the National Airport in Washington.

Derides Efforts Of United Demos

Washington, Jan. 24 (AP)—Rep. Knutson (R-Minn) today pooh-poohed a drive by House Democratic leaders to present a united party front against his \$6,300,000 tax-cutting bill.

Renewing his claim that he has no congressional support to override a presidential veto, Knutson told reporters: "We will get a lot of Democratic votes. We are going to surprise a lot of them."

Minority Leader Rayburn of Texas has called a mass meeting of the House Democrats for next Wednesday.

Gen. Eisenhower Exit Starts Talk Of Vandenberg As Dark Horse

Washington, Jan. 24 (AP)—Gen. Eisenhower's abrupt exit from the field of Republican presidential hopefuls started new talk of Senator Vandenberg (R-Mich.) as a potential dark horse nominee today. Senator Sparkman (D-Ala.) told a reporter: "It looks like Eisenhower's withdrawal clears the way for Taft and Dewey to run a head and for some third man to capture the Republican nomination. My guess is that the third man will be Vandenberg, if he will take it."

The Michigan senator has gone a long way toward removing himself from consideration. He has said that he is convinced no man ever is drafted for the nomination without

his connivance and that he won't connive. Vandenberg has observed however that no man could decline the nomination if it actually were thrust upon him. Arthur Summerfield, Michigan national committeeman, said on a visit here this week he believes Vandenberg is "favorite son" at the national convention long as there is any chance that he might be drawn into the contest. The senator smilingly declined comment today on the statement by Eisenhower that "I could not accept the nomination even under the remote circumstances that it were tendered me."

Senator Robert A. Taft of Ohio, former Gov. Harold E. Stassen of Minnesota and Gov. Thomas E. Dewey of New York, announced candidates, were similarly silent. The general's action seemed to leave a "Draft Eisenhower" movement high and dry, but some die-hard backers refused to give up.

Leonard V. Finner, New Hampshire publisher, declared in a radio address last night the nation can still draft the general. "The entire question is still up to the American people," said Finner. "No one can decide for them."

In California Assemblyman G. Delbert Morris told newsmen "unless he expressly repudiates us we still have the right to try to put his name on the California ballot."

White Blanket

By the Associated Press Fuel short North and South Carolinians awoke this morning to find a paralyzing blanket of snow and ice covering most of the two states. Only the Eastern Seaboard escaped one of winter's severest onslaughts as icy conditions disrupted normal transportation in dozens of cities and halted intercity bus travel and airplane flights.

Hurled hit by the new cold wave, which came after sub-freezing temperatures gave way to readings in the high forties Thursday, was wintry Western North Carolina. Asheville, which noted a low temperature reading of 18, had six inches of snow between midnight and daybreak, while at Winston-Salem the mercury tumbled to 12 degrees—equaling the reading atop lofty Mt. Mitchell.

The Piedmont region of both states also was covered with a heavy snowfall, although minimum readings were almost 10 degrees higher than the season's lows established early last week.

Raleigh, which shivered in 18-degree weather, had a trace of snow but along the Eastern Seaboard of both states, temperatures were above the freezing point.

U.S. weather observers at Charlotte saw no change in conditions until mid-afternoon. Cloudy skies and continued cold were in prospect for tomorrow.

Eastern Airlines said all its flights in the Carolinas had been cancelled by icy runways, with flights expected to resume about 6 o'clock tonight. Eastern makes stops in the Carolinas at Raleigh-Durham, Winston-Salem, Greensboro-High Point, Charlotte, Greenville, Spartanburg, Anderson, Charleston and Columbia.

Long distance bus service was curtailed but dispatchers were trying to rearrange schedules to resume service today to both states.

One Soldier Raids Town

Intoxicated GI Puts Citizens In Near-Panic During Chase

Lawton, Okla., Jan. 24 (AP)—An intoxicated Fort Sill soldier ran berserk in a tank-like, self-propelled 155 MM Howitzer here shortly before midnight—leading frantic MPs on a dizzy 12-mile chase through the heart of town before they trapped him with a road-block.

The one-man armored force crashed three cars on his stormy passage and started a near-panic in Lawton, a town of 20,000 where startled citizens jammed the police telephone board with queries and play-by-play reports.

The provost marshal's office at the fort acknowledged the incident, but withheld the man's name and announced tersely "an investigation is going on now."

Frantic Lawton citizens who were forced to seek shelter by the crazy-driven machine, at first reported it to be a tank. Fort Sill is the army's top artillery school.

Desk Sgt. Al Hennessee of the Lawton police said his first report came from an excited man who burst into the police station shouting "an Army tank just smashed my car!"

"I thought he'd flipped his lid," said Hennessee. "Then the phones started."

MPs in jeans tried to stop the driving ahead and slowing down, but thought better of it when the mechanical monster relentlessly bore down on them. Finally, back on the post, they rigged a fake road block of painters' scaffolding and bluffed the driver to a halt. Then they seized him.

"It's a good thing he could drive as well as he did," Hennessee said. "He could have gone right through the bank with that rig."

Williamsburg, Va., Jan. 24 (AP)—David Graves George, 82, author of the famous railroad ballad, "The Wreck of the Old Ninety-Seven," died last night. He was born in Virginia.

Sentenced Six Months For Chaining Daughter

Goshen, Ind., Jan. 24 (AP)—Samuel Hochstetler, 75, a leader in a rural Amish church who had kept his 41-year-old daughter roped and chained in her room for 10 years because she refused to join the religious sect, was sentenced to six months in the Indiana State Penal Farm yesterday.

Sentence was imposed by Circuit Judge Aldo J. Simpson after Hochstetler pleaded guilty to a charge of assault and battery. Later three physicians who examined his daughter, Lucy, and said she is insane, were to submit a report to Judge Simpson. She was examined by two physicians appointed by Judge Simpson and by the family physician.

Dr. H. E. Vander Bogart said they agreed Miss Hochstetler was insane and should be committed to an institution. He and Dr. H. K. Lemon were appointed by the court and Dr. C. M. Hostetler represented the family.

The physicians questioned her at the family home in the presence of about 15 relatives and neighbors, all Amish. Dr. Vander Bogart said. The white-bearded Hochstetler, dressed in a black cap, round-crown hat and the book-and-eye clothing of his sect, told Judge Simpson he had confined his daughter to her bed for seven years by rope and for the past three years by chains.

Sheriff Luther Yoder said Hochstetler had restrained his daughter for 20 years because she "refused to become Amish" at the age of 21. The first 10 years she was locked in her room.

Babson Discusses Inflation

Babson Park, Fla., Jan. 24 (AP)—Most of the talk about "inflation" is bunk. When people have nothing else to lay their troubles to they lay it to inflation. Merchants blame high prices on inflation; politicians blame all losses on inflation; while even farmers are blaming the weather on inflation. Certainly the investigations which are being held to study prices are mostly eyewash or whitewash.

What is Inflation? Inflation is not the fault of farmers, manufacturers, retailers or any other one group. In fact, there is no such thing as "inflation." Our troubles are just a question of supply and demand. When there is more demand for goods than there is supply, prices go up and they call it inflation; but when there are more goods than there is demand, prices go down, and they call it deflation.

This means that the only cure for high prices, or inflation so-called, is to either curtail buying or increase production. This means that the cure is up to all of us. When we spend less, we are helping to reduce prices; while if we increase our buying, we increase prices. The only other cure for high prices is to produce more. This is up to labor.

Soviet Says Bevin Hid 'Real Goal'

Claim Speech Is A Smokescreen For Forming Of Western Bloc In Europe

Washington, Jan. 24 (AP)—The first Soviet pronouncement on the British proposal for a West European alliance is that the apparent aim is to get agreement on a western German state.

The proposal was made by British Foreign Secretary Ernest Bevin in the House of Commons Thursday. It was supported by Winston Churchill, opposition leader, in further debate yesterday.

Tass, official Soviet news agency, said in a Paris dispatch last night the object of the plan "apparently" was to win the support of France, Belgium, The Netherlands and Luxembourg "for the creation of a western German state." Bevin had invited these nations to join the alliance.

Tass said today in London dispatch that Bevin's speech "was meant as a smokescreen for the creation of the so-called Western bloc, the formation of which has already been started by Britain and France through negotiations with Belgium, The Netherlands and Luxembourg." The Moscow radio broadcast this report to Russian listeners in its first mention of the Bevin address.

Reaction in Western Europe to the speeches of Bevin and Churchill was cautious, although generally approving.

Officials in France and Italy expressed a favorable reaction to the program. Government leaders in Belgium, Luxembourg and The Netherlands were wary, yet seemed sympathetic.

Belgium Premier Paul-Henri Spaak said, following a meeting of the cabinet to discuss the proposal, that his country favored political and economic agreements among the Western democracies.

The Dutch foreign minister said the Bevin speech "was received with great sympathy" and was being given "extensive study."

A thorough discussion of Bevin's talk was expected when foreign ministers of Denmark, Sweden and Norway meet in Oslo in a few weeks.

N.C. Highways In Dangerous State

Raleigh, Jan. 24 (AP)—Snow and sleet that fell last night and today has placed highways through the state in an "extremely dangerous" condition, Highway Commission Chairman A. H. Graham reported today.

Graham said that highway maintenance crews had received orders in most cases not to attempt to scrape the highways clear at the present time. The chairman pointed out that most of the highways were coated with a layer of ice beneath the snow and sleet and that scraping would render them "even more hazardous."

Pauley Gets His Chance To Speak Before Probers

Washington, Jan. 24 (AP)—Edwin W. Pauley gets his chance today to answer what he calls "poppycock" charges by Harold E. Stassen that he used inside government information to gamble in commodities.

Wary from a session which ran all day yesterday and on into the night, a Senate appropriations subcommittee called a forenoon hearing to receive Pauley's point-by-point rebuttal.

Stassen said he would be there to hear the California oil man's own version of how he made \$32,700 in three years of speculation with nothing more to guide him than the news in the daily papers.

Yesterday's long session boiled down to a flat assertion by Stassen that Pauley traded on the basis of inside information which he could not have avoided having in view of his government connections.

As the hearing broke up Pauley said all he had heard from the former Minnesota governor, now running for the GOP presidential nomination, was "a bunch of poppycock."

Chairman Ferguson (R-Mich.) asked Stassen whether his study bears out Pauley's assertions that after he became special assistant to the secretary of the Army last Sept. 3 he began liquidating his holdings as rapidly as was possible without suffering heavy losses.

Stassen said the reverse is true. DROVE BACKWARDS Duquoin, Ill., Jan. 24 (AP)—Dr. G. H. Guttridge called a hurry-up call from the hospital and rushed to the garage to get his automobile.

The drive is part of a statewide effort to alleviate sufferings of war devastated people.

Judge Says N.C. 'Marriage Mills' Disgrace State

Norfolk, Va., Jan. 24 (AP)—A juvenile court judge, passing sentence upon two war veterans for contributing to the delinquency of their teen-aged brides, yesterday charged that North Carolina "marriage mills" make a "mockery of marriage."

The judge, Herbert G. Cochran, termed the marriage mills "a public nuisance" and a "disgrace to North Carolina which allows them to operate."

The young veterans, Floyd Swanner, 21, and Milton Tyndall, 25 who married two sisters, Frances Anderson, 16, and Pauline Anderson, 14, at Moyock, N.C., were sentenced to serve six months at the City Farm.

They also were named in bench warrants issued yesterday by Cochran who charged them with contempt of court, saying they had violated his order of Dec. 11 which forbade them from associating with their wives until the hearing yesterday.

The two veterans appealed the sentences and bond of \$1,000 was set for each. Cochran fixed bond for the contempt charge at \$100 pending a hearing Feb. 1.

The two girls were ordered returned to their mother, Mrs. W. A. Anderson who had charged them with incorrigibility and their husbands with contributing to their delinquency.

Took Advice Of Judge: Now Has More Troubles

Kinston, Jan. 24 (AP)—A Leontine county negro who took the advice of a judge and found another wife began rearranging his marital affairs today to avoid a possible prison sentence for bigamy.

Appearing before Judge Henry L. Stevens on a bigamy charge, Wesley Johnson told the court that a LaGrange recorder previously had heard charges of assault against him in connection with difficulties he had with his first wife, Eliza.

"If you can't get along with Eliza," the negro said the recorder instructed him, "go out and find one you can live with."

Johnson did exactly that, courted and marrying one Hattie Parks. Indicating the facts in the case justified Johnson's story, Judge Stevens allowed a prayer for judgment for two years and ordered Johnson to divorce his first wife and re-marry his second.

Halt Shipments

Buenos Aires, Jan. 24 (AP)—Trade sources said today Argentine officials had halted the issuing of permits for shipment of meat to England. They expressed belief the step was due to Argentine fears over the future value of the pound sterling in the light of French efforts to devalue the franc.

New Proposals On Handling Of ERP

Plan Handling Of Foreign Aid Under Single Administrator Of Cabinet Status Free Of State Department Controls

Washington, Jan. 24 (AP)—Senate Department leaders have already asked for the right to control and supervise all operations of the recovery program but suggested a separate administrator.

The new operating plan was handed to senators by Paul Porter, former price control administrator, predicted that the United States will be forced to control wages, and prices, credit, meat and essential materials as part of the European aid plan.

The committee has before it a proposal to authorize \$6,800,000,000 expenditures for the opening about 15 months out of the recovery program.

In outlining the new operating plan prepared by the price research organization, Vandenberg said the proposed new agency "should have a non-corporate form" and the administrator "should have wide latitude of discretion."

He would be advised by a "board composed of eminent citizens" but the administrator would make decisions about how much aid would go to various nations, what products they receive and whether these would be grants or loans.

"Speaking generally the decision of the administrator would be final in economic matters," Vandenberg continued.

"The control and allocation of funds should be the responsibility of the president," he said, and the president would enter into agreements with the foreign nations although he probably would use the secretary of state for these.

The secretary of state would have the right to ask the ERP administrator for information and "to enter objections," but in case of disputes, action would be deferred until a decision by the president.

CIO Backs Rent Reins

Propose Extension Of Controls And For Amending Present Law

Washington, Jan. 24 (AP)—The CIO today proposed a 28-month extension of rent controls and the wiping out of all 15 per cent "voluntary" increases made under the present law.

Donald Montgomery, chief of the Washington office of the CIO Auto Workers, presented the program in a statement prepared for a senate banking subcommittee.

The present federal rent control act expires February 29. Yesterday the AFL presented its program for extending rent controls.

The CIO today asked Congress: 1. To pass a new law continuing existing rent ceilings until June 30, 1950. (The AFL said June 30, 1949).

2. To cut back rents by eliminating the various types of increases permitted by the present law, including the 15 per cent voluntary raises in order to obtain a lease running through 1948. (The AFL proposed that all increases given under the present law be permitted to stand, but asked that there be no more 15 per cent voluntary raises).

3. To provide more protection against evictions and stricter enforcement of rent ceilings, and give the government the authority to initiate court cases against violators. (The AFL recommended these things, too.)

Army Surplus Is Sold To Germans One-Fourth Cost

Frankfurt, Germany, Jan. 24 (AP)—U. S. army surplus stocks which originally cost about one billion dollars were sold today to Germans for approximately \$236,000,000, Bizonal officials announced.

The purchase was officially described as "an important pump primer in getting essential German services and industries back on their feet." It will be paid out for future German exports.

The sale was negotiated between the U. S. office of the foreign liquidation commissioner and the German Bizonal Economic Council. Among articles sold are cargo vehicles and spare parts, small boats, communications equipment, construction machinery, tents, hardware, textiles and kitchen utensils. No iron scrap or food was included.

Aim Disrupt Reich Black Marketing

German Economic Council Spurred To Action By 24-Hour Hunger Strike

Munich, Germany, Jan. 24 (AP)—The German economic council of the British and American zones—spurred by a 24-hour hunger strike by 1,000,000 Bavarians—took steps today to wipe out black marketing and food hoarding and thus increase rations.

The Bavarian state government in the U. S. zone announced it would wage a similar drive and called on trade unions and farmers' associations to help divert food from illegal channels into a common rationing pool.

The Bizonal council, in its severest law in six months, the executive decrees that all farmers and food handlers must report their complete stocks. Food not reported can be confiscated under the new law and fines up to \$3,000 can be levied for false reports.

The lone Communist delegate was the only council member to oppose the measure.

Gen. Lucius D. Clay, American military governor, said in Washington the U. S. Army intends to step up the German basic ration from 1,550 calories a day to 1,800 by July 1. He said food collections from German farmers would comprise about 80 per cent of the ration.

The strike, which gripped 28 major cities and many towns in the American zone yesterday, paralyzed communications, industry and most trade. It ended at midnight.

Marked by mass demonstrations and scattered incidents including angry shouts against "well-fed Americans" the walkout was nevertheless orderly in general.

Communists who supported the strike played a prominent part in the demonstrations with their red banners.

France Decides Devalue Franc Without 'OK'

Paris, Jan. 24 (AP)—France has decided to devalue the franc even without the permission of the international monetary fund, a spokesman for the foreign ministry declared today.

The spokesman said there was a question of France withdrawing from the fund. He added, however, that the French government believes a member of the fund has every right to carry out a money reform without the approval of the international organization.

France, he said, is obliged by her present financial position to create a devalued external franc and a free money market even in the face of an adverse vote by the fund's board of governors.

Earlier Secretary of State Pierre Avelin said the fund in Washington would announce a final decision in the matter today.

Teachers Strike Is Real Threat

Chicago, Jan. 24 (AP)—A city-wide walkout of Chicago public school teachers—already sparked by a sit-down strike in some schools—was threatened today as teachers missed a payday.

Handing out of pay checks totaling \$3,500,000 was postponed yesterday after the City Council Finance Committee failed to approve the Board of Education's record \$96,972,000 tax levy.

Churchill's Support

Endorsement Of Bevin's Foreign Policy Proposals By War-Time Prime Minister Is Follow-Up On Earlier Stand Taken By Churchill; Significant Points In Plan

Winston Churchill, Britain's famous war-time prime minister and leader of her great conservative party, yesterday threw his powerful support behind Socialist Foreign Secretary Bevin's proposal for a consolidation of Western European nations to block Communist expansion westward, thereby increasing hope of averting another world conflict, or at least postponing it.

This project, as I see it, would also complement perfectly the Marshall Plan for economic rehabilitation of Western Europe. To use the language of the independent Paris newspaper, Matin, the countries of this area would be united politically, economically and militarily.

It is of course natural for Churchill to back up Bevin's project, for the former long has advocated a United States of Europe, dream of generations of peace-minded statesmen. The conservative leader spoke bluntly, and in dealing with the dangers of another war declared that the situation had deteriorated, especially in the last six months.

Socialist Prime Minister Attlee, who followed Churchill in debate in the House of Commons, dealt with the proposal of a union of Western European nations rather more conservatively. He counseled a careful

approach to the idea, asserting that it should be done under the larger unity of the United Nations. He said he didn't believe war was imminent, but added that "there is no good shutting our eyes to the possibility." Bevin's proposal thus far has had warm support from both France and Italy, and has been received favorably though cautiously by leaders in Belgium, The Netherlands and Luxembourg—the so-called Benelux customs combine. Government sources in Switzerland, which is traditionally neutral, aren't enthusiastic about joining what is described as a "bloc" Sweden, Norway and Denmark will register their views later, but the Scandinavian countries long have made it clear that they don't wish to antagonize Russia.

In analyzing the significance of the British move we must keep in mind these points, which this column has emphasized repeatedly: If Russia isn't held on the line which she now has reached through Central Europe, war is inevitable, and the only way she can be held is by a physical barrier, since she isn't susceptible to moral influence. The Marshall Plan would give Western Europe the strength to defend itself, and so would provide a material barrier. The union of Western (Continued on Page Five)

## Prominent Educator To Be Speaker At ECTC Inauguration Ceremony

Dr. George Frederick Zook of Washington, D.C., president of the American Council on Education and chairman of President Truman's Commission on Higher Education, has accepted an invitation to speak on the program at which Dr. John D. Messick will be inaugurated on Saturday morning, March 8, as president of East Carolina Teachers College. Announcement of Dr. Zook's acceptance has just been made from the offices of administration at the college.

Dr. Zook has had a long and distinguished career as an educator and is known nationally and internationally for his outstanding work. As president of the National Council on Education, which includes 118 private education groups such as the National Education Association, the American Association of University Professors, and the American Federation of Teachers, he has been influential in shaping many of the educational policies of our country.

A recent report by the President's Commission on Higher Education, which has attracted nationwide attention. Dr. Zook was born in Kansas and was educated at the University of Kansas and at Cornell University, from which he holds the doctor's degree. He has received honorary degrees from a number of American colleges and universities, including the Universities of Boston, Michigan and Southern California.

His career as a teacher includes work at the University of Kansas, Cornell and Pennsylvania State College. For nine years he was president of the University of Akron in Ohio.

During World War I Dr. Zook worked with George Creel on the Committee on Public Information. He has served during his career as specialist and chief of the Division of Higher Education, U. S. Bureau of Education; director of Surveys of Higher Institutions in a number of states; U. S. Commissioner of Education; associate director, Section on Educational Institutions, U. S. Treasury Department; and consultant to the U. S. delegation UN.

In addition to his other work, Dr. Zook is the author of two books and of numerous articles on subjects of educational interest.




**Report Shows Greenville Building Operations Rise**

By CHESTER WALSH

Building operations in Greenville and vicinity in 1948 are expected to exceed those of last year, when commercial buildings, dwellings and alterations and repairs totaled \$1,500,000, a survey of the situation here revealed.

The building inspector's report for 1947 showed that construction was started or completed on 111 dwellings, including six four-unit apartment houses valued at \$701,750, and 47 commercial buildings valued at \$763,100 for a total of \$1,464,850. Repairs and alterations to buildings totaled \$54,000, making the grand total for building operations \$1,518,850, a considerable increase over 1946. These figures do not include buildings erected outside of the city limits.

When the city limits were extended by legislative act last July 1, city officials estimated that the added area contained approximately 2,500 people and that \$2,000,000 of taxable property was included. Many new commercial buildings and dwellings are under construction now or have been planned for the outlying territory.

The Greenville Utilities is enlarging the electric power plant, water reservoir and the gas plant at an estimated outlay of \$850,000. A new 5,000-kilowatt turbine generator is to be installed next fall, and a high pressure boiler is already in operation, and the utilities plants need other additions and machinery.

Extensive alterations and repairs have been made at Proctor Hotel costing a considerable sum of money. The interior of the building has been renovated and a new entrance to the lobby is being provided. Manager Kenneth Phillips said that the entire lower front of the hotel building will be new. The barber shop, now on the corner, will move into the place formerly occupied by Godfrey P. Oakley and Clyde Hollowell, owner of a drug store on Dickinson Avenue, will open a drug store on the hotel corner.

Western Dickinson Avenue is rapidly becoming a business center. Some imposing business buildings have been erected and others are planned. Dwellings have been constructed in large number in Hillsdale, now a part of the city. Two new stores have been built on Dickinson Avenue just beyond the Coast Line Railroad for super-markets for Pender's and the A&P Company.


It is rumored that a national drug store chain will open a store at Fourth and Evans Street now occupied by Pender's grocery store.

Extensive building operations are planned for this year. Greenville is growing.

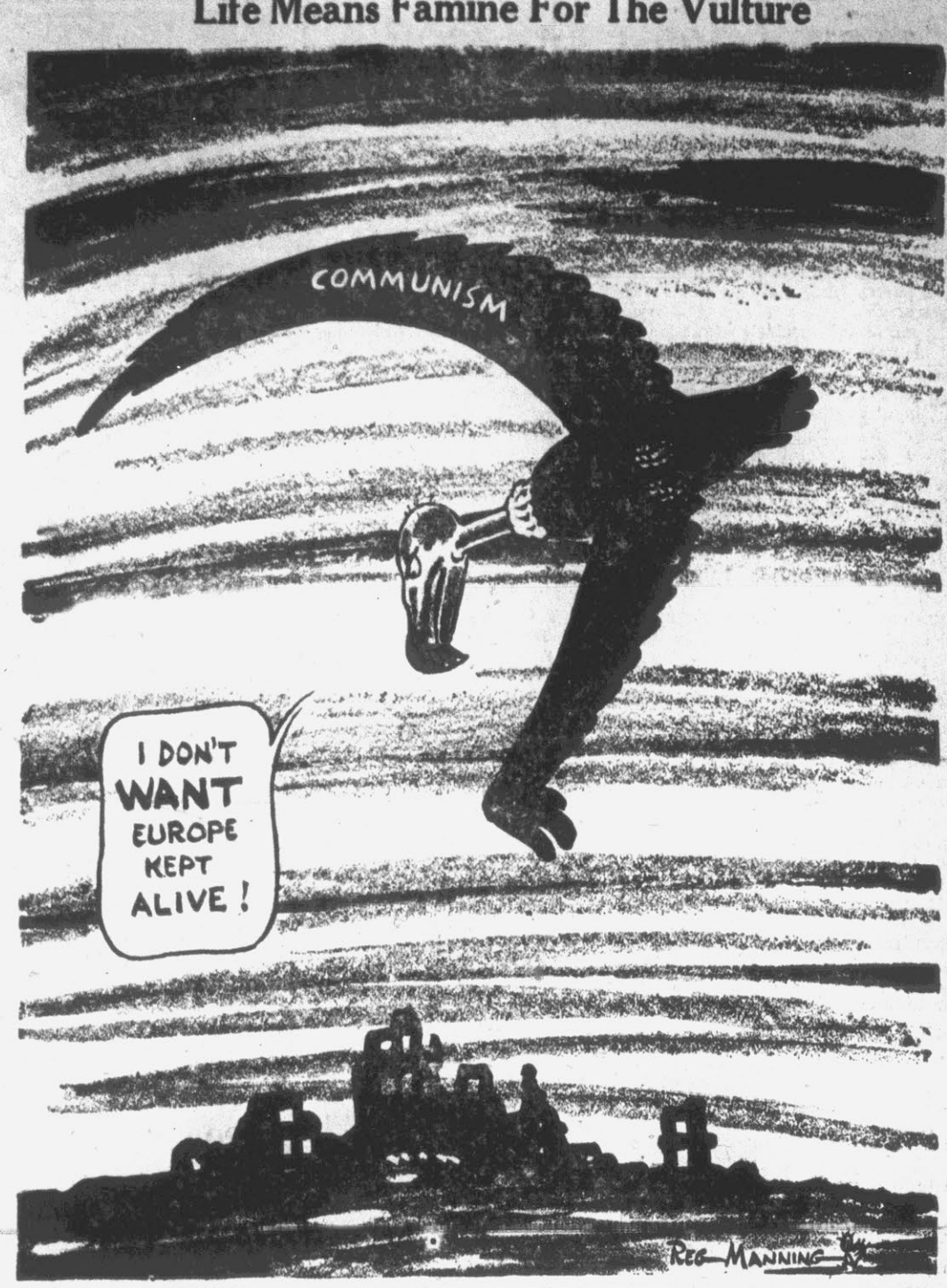

**WASHINGTON LETTER**

By JANE EADS

Washington, Jan. 23.—Tonight the fourth floor of the United Nations Club is a veritable tower of Babel. Classes in Russian, German Italian, Spanish, Greek and French are all going on at the same time.

The classes are held in small rooms and they usually keep the doors open, so Miss Marguerite Sitgreaves, business manager of the club's Academy of Foreign Languages, has difficulty concentrating.

An average of 35 classes are held a week, with no more than six members in a class. Twenty of the classes are for students wishing to learn Spanish, French is the next popular, with 15 classes.

Hindustani is the most recent of the 15 languages to be taught in the Academy, which was established in 1944 in the canteen of the British embassy. There is only one student in this class, however. She is Miss Louise Borsoneuer, an employee of the State Department.

If people come to the Academy to study languages not included in the curriculum, the Academy arranges for special classes on the outside. Someone recently wanted to learn Norwegian. He was sent to the Norwegian Division of the Library of Congress, where a teacher was found for him.

Miss Julia Ramsey of Ohio, who is taking her Ph.D. in political science at Georgetown University and speaks Polish and some Russian, is conducting the classes in English. These, apparently, are the most difficult of all to handle. Miss Sitgreaves says that in a class of six there sometimes may be a Pole, a Greek, a Chinese, a Frenchman and an Arab.

Most of the students of English are members of embassy families or staffs. The United Nations Club is sponsored by the 57 ambassadors and ministers of the United Nations who are represented here.

Some amusing things happen. Two boys from the State Department, one studying Spanish and the other Swedish in preparation for assignments in those countries, were sent to South Africa instead.

Twice a year the Academy stages a general get-together tea. Though most of the students speak English, they all converse in the language they are studying. Bedlam reigns says Miss Sitgreaves.

## Has Treasure Maps For Gold Buried In Florida

West Palm Beach, Fla., Jan. 23 (AP)—The widow of a once-wealthy Tammany Hall leader said today she has two maps showing the location of \$70,000,000 in pirate gold and is seeking a contractor to recover the treasure.

Mrs. Eula Edmondson Croker, 64, widow of Richard C. Croker, said she owns the land where the maps show the gold was buried in the years 1781-1783 about 40 miles from Pensacola.

She said the maps place gold and

other valuables in 25 feet of water in a bayou and she believes the treasure is resting on rock bottom about 38 feet below the surface.

"I've been trying to find someone who is treasure-minded," she said in disclosing she had written J. P. Conway, contractor now digging for gold in Green Cove Springs. "This fellow seems to know his business. I think he can find this gold. He may have to sink a cofferdam to get it."

Conway said he received the letter and planned to contact Mrs. Croker, but his first job is to complete the search for \$4,000,000 in pirate loot believed buried on the main street of Green Cove Springs.

Mrs. Croker said her maps were brought to this country from Madrid by a man named Andrea, who became ill and died in the home of Jacob Faust. She said the maps were handed down to Faust's grandson, Capt. Walter M. Brown, who gave them to her in 1896. One of the maps shows the location of \$4,000,000 and the other \$72,000,000, Mrs. Croker said.

By Marine or Air Force, he takes this oath:

"I . . . do solemnly swear (or affirm) that I will bear true faith and allegiance to the United States of America; that I will serve them honestly and faithfully against all their enemies whomsoever; and that I will obey the orders of the President of the United States and the orders of the officers appointed over me, according to the rules and Articles of War."

What of an alien who becomes a naturalized citizen of the United States?

He must declare an oath in open court that he will support the constitution of the United States and that he absolutely and entirely renounces and abjures all allegiance and fidelity to any foreign prince, potentate, state or sovereignty, of whom or which he used to be a citizen or subject.

And he must swear under oath to support and defend the constitution and laws of the United States against all enemies, foreign and domestic, and bear true faith and allegiance to the United States.

not real wages. Unless wage workers increase production as their wages increase, they are no better off in the end.

What Has Happened to Citrus? What has happened to the market for grapefruit and oranges is a proof of all I have said above. It costs much more to raise citrus fruit today than ever before. Wages are much higher, fertilizer is more expensive, and even the railroad freights are greater. Yet, the prices for citrus fruits today are less than they were when the cost of production was much lower. If all our troubles are due to "inflation," inflation should help the citrus growers with higher prices to overcome these higher costs.

The answer is that there is no such thing as "inflation." It is only a question of supply and demand. Citrus growers do not benefit unless there is more demand for their products. Right here in Florida we see the cattle people very prosperous while the fruit growers are very sad. The reason is that there is an excess demand for meat with a small supply, while there is a big supply of citrus and a small demand. Neither the price of beef nor the price of citrus is due to "inflation."

What Shall Housewives Do? We all shall buy the things which are in surplus supply rather than, through habit, continue to buy the high-priced things. The next time you go shopping ask the clerk to give you a list of the things that haven't gone up, and then change your food customs to using those things. This also applies to shoes, clothing, and household furnishings.

Now that the turn of the year is past and there are "sales" going on, this is the time to do your buying. Wise buyers will stock up with goods during the month of January while these mark-down sales are in progress.

# N.C. State Sets Scoring Record In 'Secret' Tilt

North Carolina basketball teams set a new scoring mark to shoot at today—110 points in a 40 minute contest, just 10 points shy of a three-point-per minute average.

The new record was tossed into the books by the powerful Wolfpack of North Carolina State which blasted High Point, 110 to 50, in a "secret" game in Raleigh last night.

Only a handful of spectators witnessed the terrific offensive battle because State authorities locked the doors to Frank Thompson gymnasium. The building has been condemned as a fire hazard for crowds of more than 1,200.

To add to the secrecy, the game was publicly called off, then rescheduled because the State squad needed practice.

About the only practice they needed last night, however, was at the free throw line. They had 54 charity chances and missed 26. High Point missed 17 of 33 in the extremely rough engagement in which 69 personal fouls were called.

The massive point total was 10 more than State's previous high mark for the year made against the Chatham Blunketeers.

The victory was State's 14th against two losses and upped the points-per-game average to 77.125.
