Broughton Says Tobacco Prices 'Not Too High'

Warehousemen's Meeting Opens; Discuss Marketing And Regulations

Approximately 140 tobaccoists representing the 77 warehouse firms in the huge Eastern North Carolina belt of fine cured tobacco markets met here today to discuss marketing and price support regulations prior to the opening of the market in this area next Thursday.

In charge of the meeting were Fred S. Royster of Henderson, president of the five state Bright Belt warehouse association, and James T. Keel of Greenville, president of the Eastern Carolina association.

Among the principal speakers at the session was Senator-elect J. Melville Broughton, general counsel for the Bright Belt association and the Stabilization corporation who at the beginning of the meeting asserted, "The present price of tobacco is not too high when the cost of production is considered. The theory that we are 'pricing ourselves out of foreign markets' is not justified by past or present statistics or experience. The farmer is entitled to a fair price for his product."

He also stated that farmers this year "will likely receive for reduced acreage substantially as much in aggregate as they received for the 1947 crop."

Other speakers at the meeting included L. T. Weeks of Raleigh manager of the fine cured tobacco cooperative stabilization association, M. A. Morgan of Raleigh, field service for Tobacco Associated Incorporated, Stephen Wraether of Washington, D. C., assistant director of the tobacco branch of the Department of Agriculture and J. Con Lane of Greenville, general counsel for the Tobacco Exporters corporation.

A good portion of the session was consumed with the explanation of the collection of the 14 cent per tobacco acre assessment from farmers and a discussion of the contract between the warehousemen and the Cooperative Stabilization Corporation.

Secretary-Treasurer Bill Whidbee of Greenville reported the attendance at the meeting as follows: 140 of the 77 tobacco warehouse firms in the Eastern belt were represented at the meeting. The Eastern belt is composed of 15 tobacco market towns in this part of North Carolina.

Following the business session a barbecue luncheon was served on the campus of East Carolina Teachers College.

Mounting Unrest At High Prices

Frankfurt, Germany, Aug. 13 — (AP)—Irate German housewives hurried tomatoes at vegetable dealers today as unrest mounted throughout the British-American zones against high prices.

Organizing Spy Ring

Canadian Spy Case Shows How Russians Can Get Employees Of Another Government To Spy For Them; How Ring Was Broken; How Loyalty Was Killed In 'Cells'

Washington, Aug. 13 — (AP)—How could the Russians get employees of another government to spy for them?

The Canadian spy case answers that. The Russians found it easy. It was made easy for them by Canadians in the Communist party.

That case, one of the most amazing in the history of international monkey-business, broke in 1946.

That was when Igor Gouzenko, a Russian army officer working in the Russian Embassy in Ottawa, tipped off the Canadian police to the Soviet spy ring the result:

A number of Canadians were tried. Some were acquitted. But 10 were convicted of being Soviet agents.

All those convicted were Canadian Communist party members or Communist sympathizers. And almost all worked for the Canadian government.

(At this point it's important to remember that, although a number of former American government employees have been accused of taking part in a Soviet spy ring and being Communists or sympathizers, none has been found guilty or even formally charged with any wrongdoing.)

Promise Asylum

Washington, Aug. 13 — (AP)—The State Department today promised asylum for two Soviet school teachers who have figured in current congressional spy they want to remain in this country.

Department spokesman Michael J. McDermott was asked whether Soviet Consul General Yakov Kosenkina or any other officials had the right to demand the return of Mrs. Kosenkina to Russia.

McDermott said Secretary of State Marshall had made clear at a news conference Wednesday "that the right of choice resides in the individual." Broadening his answer to include the Samarines as well as Mrs. Kosenkina, he added: "If they want to stay here, they stay."

Stresses Belief Polio Peak Over

Health Officer Reiterates His Stand; 33 New Cases

Raleigh, N.C., Aug. 13 — (AP)—Dr. Roy Norton, state health officer, reiterated today that the infantile paralysis epidemic probably reached its peak during the week ending July 27.

"Due to the fact that most of the cases now being reported represent illness having onset in August, we feel that the week ending July 23 is probably the peak week of our outbreak," Dr. Norton said in a statement.

"There will be a certain amount of fluctuation in the weekly totals during the decline of the disease; therefore, it will be another week or two before we can definitely establish the fact that the decline has begun and how rapid it will be."

The statement was made as 33 more cases of polio were reported to the State Board of Health, giving a total for the state for the year of 1,440.

Dr. Norton pointed out that there is a lag of from three to 10 days from the time a patient becomes ill with polio until the case is reported to the State Board of Health.

For this reason, he said, the daily totals "are not of great importance in establishing a trend."

"If each case is tabulated by the date of the onset of the illness, a much more accurate picture can be obtained," he added.

He said that in the week ending July 2, 108 persons became ill with polio. In the week ending July 9, 194, the week ending July 16, 210 the week ending July 23, and 154 the week ending July 30.

Reports are still being received for the week ending Aug. 6, Dr. Norton added. The total for the week now stands at 120 cases.

Two U. S. Planes Flying Coal To Berlin In Crash

Berlin, Aug. 13 — (AP)—Two United States four-engine "Flying coalman" planes spanning the Soviet blockade of Berlin crashed while landing in a heavy rainstorm at Tempelhof airfield today.

One smashed through a fence and burned but the crew of two escaped through an emergency hatch without serious injuries.

The other plane, coming down through clouds, landed on a half-completed runway and was heavily damaged. The crew was unhurt.

A few minutes later a C-54 reported by radio that it was near Berlin with two engines out of order. Tempelhof lost contact with the crippled plane, but the Royal Air Force at Gatow airfield contacted it and guided it to a safe landing there.

Berlin's Division More Pronounced

Russians Evacuate Four-Power Kommandatura Building; Haul Down Flag; Germans Told U. S. People Favor Strong Stand

Berlin, Aug. 13 — (AP)—The Russians evacuated the allied four-power Kommandatura building in Berlin today and hauled down their flag.

This action appeared to complete the division of Berlin between the east and west—at least as far as the Russians are concerned.

The Russians withdrew July 1 from the allied Kommandatura, which had provided four-power administration for this city for three years. They pulled out with the comment that "the Kommandatura no longer exists."

They then announced they would return their sentry and flag at the building until their archives have been removed. The Kommandatura is situated in the American sector of the city.

Although they walked out on the allied control council for Germany on March 20, the Russians still fly their colors and maintain sentries at the allied control authority building.

After the Russian withdrawal from the Kommandatura—an act which the U. S., Britain and France refused to recognize legally—the elected German city government alone remained to hold Berlin together.

Since then, however, the anti-Communist administration has been under constant Communist attack and several of its branches have been split between the east and west. This includes the police force and food administration.

A U. S. official last night told Germans in his U. S. sector that polls taken back in the states show the Americans want a strong stand against Russia.

The American military government spokesman, broadcasting on a U. S. zone hookup, declared last night that four out of five Americans said the United States should remain in Berlin even if it meant war.

"The American people believe that peace is not to be found in retreat," he said. "There is, in fact evidence that the American people feel that the government might well have been firmer in its attitude toward the Soviet Union in past negotiations."

In Moscow, U. S., British and French delegates wound up their fifth conference with Soviet Foreign Minister V. M. Molotov yesterday, and there was no indication negotiations were nearing an end.

Asked by newsmen whether there would be further talks, American Ambassador Walter Bedell Smith said "We never know that, but I do think so."

Sees Little Prospect Of Living-Cost Drop

President Takes Issue With Taft Prediction That Prices May Level Off Soon; Expect Signature Anti-Inflation Bill

Washington, Aug. 13 — (AP)—President Truman held out little hope today for a drop in the cost of living as he prepared to get on the Republican anti-inflation bill.

The President took issue at the news conference with a prediction by Senator Taft (R-Ohio) that prices may level off soon.

He hopes that Taft is right, the President said yesterday. But he added he doesn't agree with the Ohioan.

The expectation in Washington was that Mr. Truman would sign the credit-curbing bill passed by the special session of Congress which refused to give him the price-wage controls and rationing authority he asked.

A renewed blast at the GOP Congress for this omission was almost certain, since he already has tabbed it a do-nothing Congress.

The Republicans were ready with their answers. Senator Watkins of Utah disclosed their rebuttal line in advance.

He told a reporter that Congress had approved controls that "go to the root of the matter" of inflation. He said the Republicans had refused to go along with the "unwise steps" of bringing back price controls and rationing.

"What we didn't do was as important as what we did do," Watkins declared.

The Republican bill authorizes the Federal Reserve Board to reinstate wartime controls over time payment buying. The board could fix the down payment required on many articles and the overall time limit for payment in full.

Up to last November, when these controls died, one-third of the purchase price was required first on most articles like washers and radios, with full payment in 15 months.

Longshoremen On East Coast Are Ready To Strike

New York, Aug. 13 — (AP)—East coast longshoremen are prepared to strike Aug. 22, if necessary, says their leader, who warns that a possible illegal strike may be instigated by the Communist party.

Joseph Ryan, president of the AFL International Longshoremen's Association, said yesterday that "we don't want anyone else to pull us out on an illegal strike."

If the strike occurs, he said, the public should find out "whether it is a legitimate ILA strike or a strike instigated by the Communist party."

He said there were "reports around the waterfront" that Harry Bridges, head of the west coast CIO International Longshoremen's and Warehousemen's Union, plans to "take over the east coast after the contract runs out Aug. 21."

Downward Trend On Border Belt

GOP Willing To Make Spy Probe Political Issue

Appear Ready To Accept Truman Challenge; Hit 'Red Herring' Charge

Washington, Aug. 13 — (AP)—Republicans gave every indication today of accepting President Truman's challenge to make a political issue of the congressional hunt for Communists in the government.

Mr. Truman's second declaration that the Senate and House investigators are nothing but a red herring—with the added phrase: of the strongest type you can smell—brought a burst of answering fire from GOP ranks.

Gov. Thomas E. Dewey's campaign manager declared at Albany that he called the President's attitude "in seeming to cover up" information bearing on Communist activities.

Herbert Brownell, Jr., the campaign chief for the Republican nominee, added to reporters that nothing else that has happened in Washington in the last three weeks could match the "intensive" interest shown in the spy investigations.

Rep. Mundt (R-SD), who has been acting chairman for many of the hearings before the House Un-American Activities Committee, shaped his acceptance in the form of a counter-charge.

"I challenge the President," Mundt said, "to authorize the FBI and other government agencies to make available the evidence substantiating or disproving the charges of these espionage activities."

Mr. Truman indicated by his second job at the congressional hearing he expects the Republicans to dwell on testimony that some government officials gave away secrets to Moscow agents.

His vigorous assertion that these hearings are nothing but a red herring left little doubt he will contend in rebuttal that the hearings were stage-managed to take the public mind off his cost of living battle with Congress.

A week ago the President said nothing had been disclosed that was not already known by the FBI. He also looked into the charges.

The question came up at a White House news conference yesterday. One of a smaller-than-usual crowd of reporters noted that Rep. Mundt (R-SD) had said that before the inquiries are over Mr. Truman will have to eat his words.

Gen. Dwight D. Eisenhower didn't seem to think so, the President said. Eisenhower said earlier in the week that the nation's secrets had been very well kept.

The Danubian conference also turned down, seven to three, an alternative American proposal which would have set up an interim commission with seats for the three major Western powers and Austria, as well as the Danubian states.

Under the American plan Germany also would have been admitted when it received a peace treaty. The U. S. delegation offered yesterday to trade away America's claim to a seat on the commission in return for full and equal representation for Austria and Germany.

A similar French amendment also was rejected seven to three. Sir Charles Peake, British ambassador, withdrew another proposal along the same lines.

The action demonstrated anew the complete unity of the Communist bloc on the question of retaining jurisdiction over Central Europe's 1,800-mile waterway.

Cahada To Lift Export Controls On Beef Cattle

Ottawa, August 13 — (AP)—Agriculture Minister J. G. Gardiner announced today the lifting of Canadian export control of beef cattle and calves, effective next Monday.

The relaxation applies to beef and veal, dressed and other edible beef and veal products, canned foods containing meat, and meat pastes, as well as to livestock on the hoof.

It means the United States cattle market, closed to Canadian beef producers for six years, again will be open to their products. It means a greater supply of beef for tables in the United States. It also means that retail beef prices in Canada will shoot up, possibly by as much as 20 to 30 per cent.

The ban on exports was imposed in September, 1942, to maintain supplies of beef for Canadian consumers and to aid in the enforcement of price controls.

Soviet Vice-Consul Is Told 'You Would Not Let Me Go'

Bedell Smith Promises Molotov Investigation

Categorically Denies U. S. Involved In Illegal Action Concerning Russian School Teachers As Russia Charges

Washington, Aug. 13 — (AP)—American Ambassador Walter Bedell Smith has categorically told Soviet Foreign Minister Molotov that the United States is not in any way involved in illegal action in connection with the case of the Soviet school teachers in New York.

The State Department disclosed that Smith issued the denial after Molotov gave him a strong protest at the foreign office Wednesday night. Molotov charged that American authorities connived in "kidnapping" the school teachers.

Smith, the State Department said, promised Molotov there would be a full public investigation of the cases of Michael Ivanovitch Samarin and his wife, and Mrs. Oksana S. Kosenkina, who jumped out of a window at the Soviet consulate in New York yesterday.

The State Department made the announcement after Russian Ambassador Alexander S. Panushkin made—then suddenly cancelled—an appointment today with Undersecretary of State Robert A. Lovett.

The Molotov protest was the third received from the Russian government. The fact that Molotov had personally entered the case by calling Smith to the foreign office threatened to further complicate the already difficult negotiations underway in Moscow between the Soviet Union and the western powers on the Berlin crisis.

Officials said that a new element of irritation had been introduced in the Soviet-American relations which could cause trouble all along the line.

Molotov's declaration to Smith accused American authorities of collusion in "criminal action" centering around Samarin and Mrs. Kosenkina.

This is the exact opposite of the position previously taken by Secretary of State Marshall. He told a news conference Wednesday that Samarin acted of his own free choice.

Evidently the department will now take the same position concerning Mrs. Kosenkina. She has been quoted from her hospital bed in New York as saying that she had to get out of the Soviet consulate.

Roosevelt Aides Deny Accusation

Lauchlin Currie And H. D. White Testify At Hearing

Washington, Aug. 13 — (AP)—Two top government aides of the Roosevelt Administration—Lauchlin Currie and Harry D. White—took the witness chair at Congressional spy hearings today and denied giving secret information or aid to Soviet agents.

Each declared, too, that he was no Communist and had never done anything disloyal to the American government.

Their testimony came as the events stemming directly or indirectly, from the hearings continued to involve the highest diplomatic levels.

The appearance of Currie and White before the house un-American activities committee drew a big crowd to its hearings. They are the biggest names which were mentioned when Elizabeth T. Bentley and Whitaker Chambers, who say they are former spy ring couriers, testified earlier about people they said were in or helpful to the ring. Both Currie and White were listed in the helpful class.

Currie, 46 was in the government 11 years and from 1939 through the war years was an administrative assistant to President Roosevelt. He is now in the export business in New York.

White, 56, is a former Harvard professor. He worked for the government from New Deal days and was assistant secretary of the treasury when he left the government last year. He is now an economic and financial consultant in New York.

U.S. Ambassador To Canada Named

Washington, Aug. 13 — (AP)—President Truman today named Laurence A. Steinhardt to be ambassador to Canada.

Steinhardt, a veteran career diplomat, succeeds Ray Atherton, recently named as alternate delegate to the forthcoming United Nations General Assembly meeting at Paris. The White House announced that the President is giving Steinhardt a recess appointment, subject to confirmation by the Senate at the next session of Congress. Steinhardt's last assignment was as ambassador to Czechoslovakia.

North Africa's Place

Italian Colonial Empire Still Awaits Verdict On Its Future; Libya And It's Importance; Why Russia Would Return Control To Italy; Independence Talk

No. Libya's importance is the same old story. It has great military value as a Mediterranean base.

The country holding Libya would be in a powerful position. If it also controlled the big island of Crete in the north, it could dominate the lifeline through the Mediterranean to the Suez Canal, for the Libyan port of Tobruk and Crete form a saddle over the ship route.

Small wonder that the disposition of Libya is a bone of hot contention between Russia and the Western powers. Neither side wants to see the other get control there.

Not so long ago Russia was asking for a "Mediterranean base. Now, however, she has proclaimed herself in favor of returning all the colonies to Italy for rule under United Nations trusteeship, pending a granting of independence.

Most of the Western Allies, however, want to see Libya split up into its component provinces of Cirenaica, Tripolitania and the Fezzan. Cirenaica, and perhaps Tripolitania, would come under British protection, either as a U. N. trusteeship or as independent states bound to Britain.

Mrs. Kosenkina Spurns Suggestion That She Be Moved To Another Hospital; Says She Was A Prisoner; Heavy Police Guard Stationed At Hospital

New York, Aug. 13 — (AP)—Mrs. Oksana Stepanovna Kosenkina today rejected the suggestion of a Soviet vice-consul that she be moved to another hospital, saying "you kept me a prisoner, you would not let me go."

The suggestion was made by Vice-Consul Zot I. Chepurnykh who visited the police-guarded hospital room of the Russian teacher, seriously injured yesterday when she jumped three stories from the Soviet consulate building.

Detective William Dyzko, a Russian-speaking officer who was in the hospital room during the vice-consul's visit, said Mrs. Kosenkina said, "no" when Chepurnykh advanced his suggestion.

The detective said that after the vice-consul and a secretary arrived at this hospital, and asked for permission to arrange for a visit from the consul general, and Inspector Michael E. J. Ladden went upstairs to the teacher's room.

They told Mrs. Kosenkina there were two persons from the Soviet consulate who wanted to speak to her Dyzko said.

"We told her 'we are going to bring them in and see if you can identify them'."

A few minutes later they escorted Chepurnykh and the secretary into the room.

The injured woman's eyes were open," Dyzko said. The vice consul earlier had said her eyes were closed.

"Do you know this man?" the detective said he asked Mrs. Kosenkina in Russian.

"Yes," he quoted her as answering. "Who is he?" The detective said he asked. The woman identified the vice consul.

The vice-consul, the detective added, then told her to answer that Soviet consul general Yakov Iomanski wanted to see her. Mrs. Kosenkina replied, "I do not want to talk to anyone. I do not want to see anyone."

Then, the detective said, came the vice-consul's suggestion that Mrs. Kosenkina consent to be moved from Roosevelt hospital to another hospital, and her refusal with the accusation that "you kept me a prisoner, you would not let me go."

The interview was terminated then by Inspector Ladden.

A high police official said that the heavy police guard was stationed at the hospital room solely on the department's own initiative. Mrs. Kosenkina, he said, did not request a bodyguard.

When Chupurnykh emerged from the interview he did not tell newsmen of Mrs. Kosenkina's refusal. He did say, however, that it "possible the consul general may have her moved to another hospital so a Russian-trained nurse or observer could be on hand."

The vice-consul then asked a hospital attaché—apparently the institution's administrative officer—for permission to place a Russian trained nurse in Mrs. Kosenkina's room.

"I don't think that's possible," was the reply. "You know we are short of beds."

Chupurnykh left the building and returned to the consulate.

### N. C. Building Program To Require More Funds

Raleigh, N. C., Aug. 13—(AP)—If the State's building program at state institutions is to be completed, the next legislature will have to boost the permanent improvements fund by at least 25 per cent, Governor Cherry said yesterday.

Since the \$60,000,000 building program was approved last year, construction costs have risen by at least 24 per cent—even more for some types of construction—the Governor said.

"We'll be lucky now if we can get out for \$65,000,000," the Governor commented.

If the 1949 session of the legislature does increase the permanent improvements allocations to take care of the building cost spiral, that would top from \$12,500,000 to \$15,000,000 of the general fund surplus, the Governor pointed out. The surplus at the beginning of this fiscal year amounted to more than \$40,000,000.

The Governor also said the medical care commission also found that the \$6,250,000 allocated to it was in-

sufficient for its proposed hospital building program.

"They set up their program expecting the cost to average about \$9,000 a bed, and it's going to be about \$14,000,000," the Governor said.

### See Increase In Schools Budget

Raleigh, Aug. 13—(AP)—The budget for public schools will be increased "about \$30,000,000" if a \$2,400 minimum salary schedule for school teachers goes through, Governor Cherry said yesterday.

The North Carolina Education Association is sponsoring a plan which calls for starting salaries for teachers with "A" certificates of \$2,400 a year and year increments of \$100 each year up to a maximum salary of \$3,800 annually.

W. Kerr Scott, Democratic nominee for governor, endorsed the NCEA plan during his primary campaign. However, he qualified his endorsement by stating that he would make recommendations for the new salary scale "in accordance with available revenues."

A \$30,000,000 addition to the school budget would represent almost a 50 per cent increase in the amount allotted for that purpose during the current fiscal year. This year public school appropriations amount to approximately \$64,500,000.

The \$30,000,000 increase would mean that public school appropriations would go up to about \$94,500,000. The total budget for all state institutions, departments and agencies for this year is about \$96,000,000.

### Opera Prospects Appear Brighter

New York, Aug. 13—(AP)—Prospects for a Metropolitan Opera season this year appeared brighter today.

Following a meeting last night, union and management representatives said in a joint statement they were hopeful of "a basis for agreement" on plans for a 1948-49 season.

The Metropolitan Opera Association last week announced cancellation of the forthcoming season, blaming the decision on financial difficulties and its inability to meet union demands.

Although neither side would reveal what was discussed at last night's session, the joint statement said the Met's board of directors would call a special meeting early next week to consider points discussed.

It said union heads also would meet with their memberships to discuss results of the joint session.

George A. Sloan, chairman of the Met's board, said: "Each group knows the other's point of view now. It won't be necessary for the joint committee of the union leaders to meet with us again. All discussions will be concluded by not later than Monday week—which is Aug. 23."

WASHINGTON LETTER

Washington—After a breakfast of pineapple juice, scrambled eggs and donuts, hot biscuits and coffee, the senators prayed and discussed the scriptures. The topic for the meeting was "Faith." It has been a prayerful custom since 1943—these prayer-meeting breakfasts at the capitol. Members of Congress get together to ponder "ways and means of living amid the world's problems in a manner acceptable to God."

About 35 senators belong to the group, which meets under the leadership of Sen. Alexander Wiley (R-W.V.) in the Vandenberg Room, across the hall from the regular Senate dining room in the capitol building. Members from the House side meet in the same room every Thursday at 8:15 a. m. under the leadership of Rep. Ralph Gwynn (R-N.Y.) Rep. Vaughn Garry (D-Va.) is vice chairman, and Rep. Paul B. Dague (R-Pa.) is secretary-treasurer. There are some 67 members on the House breakfast roll.

There are about 35 of these breakfast clubs in the United States. Three of them—the Senate and House groups and another group for business—are in Washington. The idea started in Seattle, Wash., in 1935 with a group of 18 business executives. The clubs function under the National Council for Christian Leadership.

Abraham Verside, who came to this country in 1906 from Norway, was graduated from Northwestern University and was a minister for some years, is international director. According to members of the congressional clubs, Mr. Verside's idea is that the first step in civic reform is in individual reform. He devoted all his time now to the breakfast clubs and has his office in Washington. The clubs are non-partisan and non-denominational. Members do not pay dues, and there is no big money-raising for the club's work, though members help by private contributions.

Not all members attend every meeting. Sometimes there is only a handful, but on the whole they are pretty faithful. Ralph, head man of the Senate restaurant, who is always an interested spectator, says that during the closing days of the regular session the members spent a couple of weeks discussing housing on the basis of their responsibilities as Christians.

"The members don't seem to care much for any publicity," Ralph told me. "They consider this all a more or less spiritual retreat from the cares of the day. The services are between themselves and their God and are more or less private affairs."

### Growers Finding Tobacco Crop Is Poorer Than '47

Farmers in Pitt county are fast gathering the remaining tobacco from their fields and transferring it to the barns and then to the pack houses and readying the leaf for the market which opens in the bright belt next Thursday.

This year's tobacco in Pitt county will be several million pounds shorter than last year's crop because of the 27.52 per cent decrease in acreage allotments and also the lighter weight per acre of this year's crop. Assistant County Agent Sam Weeks said today the Pitt county crop appears to be approximately 15 percent per acre lighter than last year's record crop.

Although in some localities throughout the county labor was somewhat cheaper this year than last year, more extensive use of insecticides and the increase in the cost of fertilizer have made this year's crop more expensive to produce. Many farmers maintain this is the most expensive tobacco crop ever raised in Pitt county.

Well informed tobacco men of this area report the quality of this year's crop is poorer than was that of last year's crop, and many farmers have reported having trouble in making tobacco cure as well as the tobacco of last year. In some sections of the county one-third to one-half of the tobacco is still in the fields and priming probably will continue into the early days of September.

Early in the season Pitt county received more hail than in many years, and for a time it appeared to be doing extensive damage to the crop, but it now appears that the hail damage was not as heavy as some farmers first thought.

A member of the county agent's staff estimated that the black shank

disease infested about 3,500 acres this season which last year did not show signs of the disease. Losses from Granville wilt were somewhat less this year than last.

Raleigh, Aug. 13 —(AP)—Capus Waynick of Raleigh and High Point is scheduled to be chosen chairman of the State Democratic Executive Committee at a meeting of the committee here tonight.

The committee by custom follows the wishes of the party nominee for governor in selecting the man to lead the party's general election campaign. Kerr Scott, the nominee for governor, has announced that he wants Waynick, who managed his successful primary campaign.

In a move for party harmony, the present chairman, Wilkins P. Horton of Pittsboro, is expected to make the nominating speech for Waynick and State Senator Rivers D. Johnson of Warsaw, a bitter opponent of Scott in the primary campaign, is expected to make a seconding speech. The committee is expected to follow Scott's wishes also in the election of a vice chairman. Scott has recommended Mrs. D. A. McCormick of Robeson County to succeed Mrs. B. B. Everett of Palmyra.

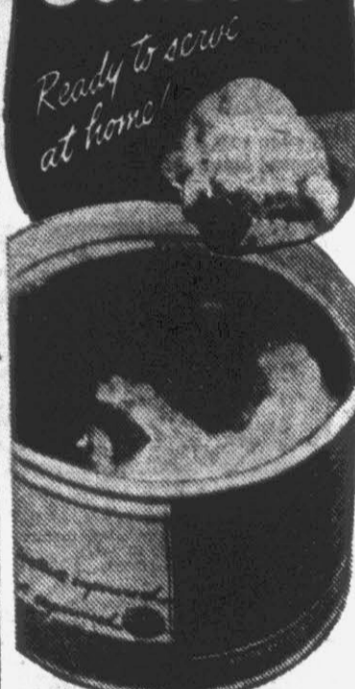

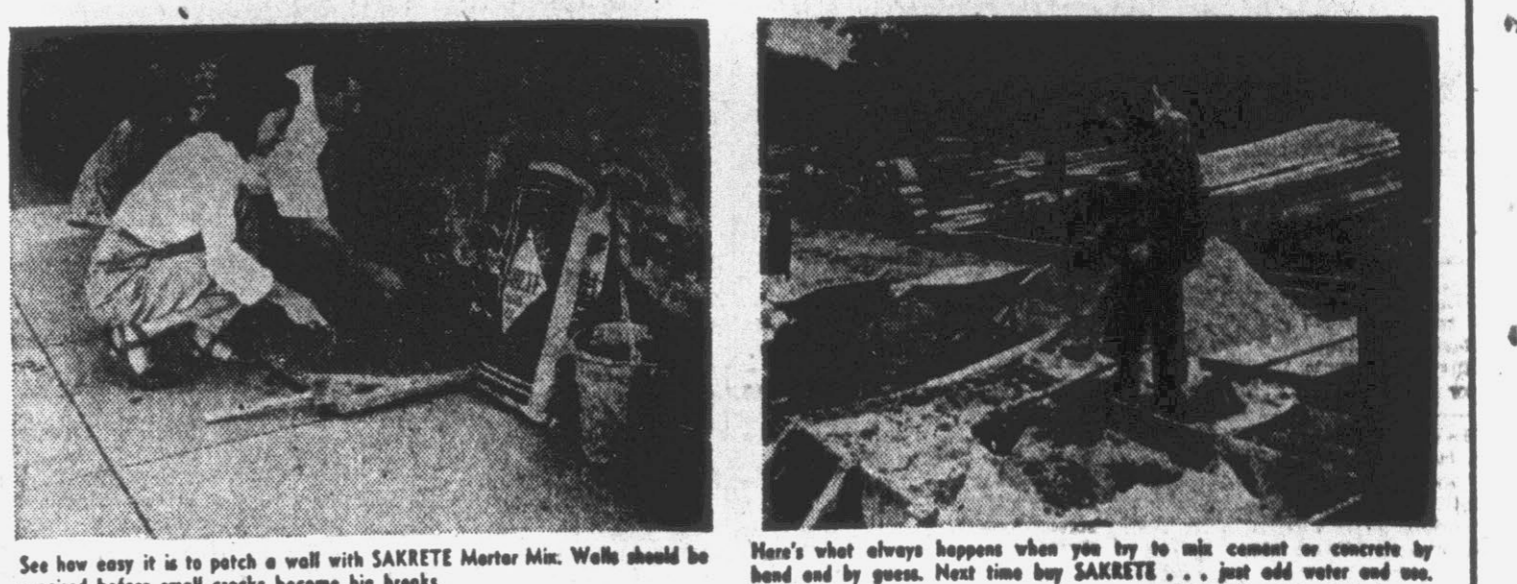

people who already were Communists or who were sucked into them and became Communists or sympathizers.

How did a non-Communist get into one of them? Say his name was Jones. He had no idea of becoming a Communist. But he was unhappy about social, or economic or political conditions in Canada.

A Communist, unknown to Jones as a Communist, would invite him to join a group studying political or economic or social affairs.

By listening to the group discussion and taking part in it, he'd begin to develop a critical attitude toward western democratic society. The discussion was shaped that way, "Oh Jones didn't know it at first."

Actually his loyalty to Canadian society was undermined by the cell.

At last he'd be a Communist, although not a card-carrying member. He'd be a secret member.

(The party wanted certain kinds

of people, like scientists and students and others, to be secret members. They could place other secret members in important government jobs.)

The deeper he got into the party's thinking, the more Jones came to accept, without questioning, orders given by the party leadership.

He didn't know other Communists were making reports on him to party headquarters, particularly psychological reports showing his progress, and his dependability for doing party work, like spying.

When Col. Zabotin needed an agent or spy for a certain kind of job, he'd get in touch with the Canadian Communist party leaders.

If Jones happened to be in or near that job—and if the party leaders thought he had progressed far enough in Communism to be trusted—they'd tell Zabotin about him. Zabotin would contact him, size him up, check on him, and, if Jones was willing, use him in the spy ring.

by military treaty. Fezzan would go to France, which has been administering it since the war.

Russia's abnegation—backed by five Eastern European satellites—is more apparent than real. The idea of turning the colonies back to Italy is a shrewd one from two very important viewpoints:

1. Moscow still hopes to gain control of Italy through the latter's big and militant Communist party, and such an eventually would bring Libya into the Red fold.

2. The very fact that the Soviet Union advocates returning the colonies to Italy is calculated to strengthen the hands of the Italian Communists in their fight for power.

The question of independence looms large with the native Libyans, who long have been working for their liberty. Their paramount leader is the Grand Senussi, the princely personage who is both spiritual and temporal head. I interviewed him in Cairo in 1943, and found him to be a striking personality of much culture.

His highness expressed great hope for the development of his country, and for the education of the masses. I could see that after the war some sort of protectorate likely would be proposed for Libya, and I asked him if he expected this.

"We feel that we should have our freedom first," he replied. "That rest easily can be arranged. We certainly shall need guidance in our new state, and we shall need help in developing it."

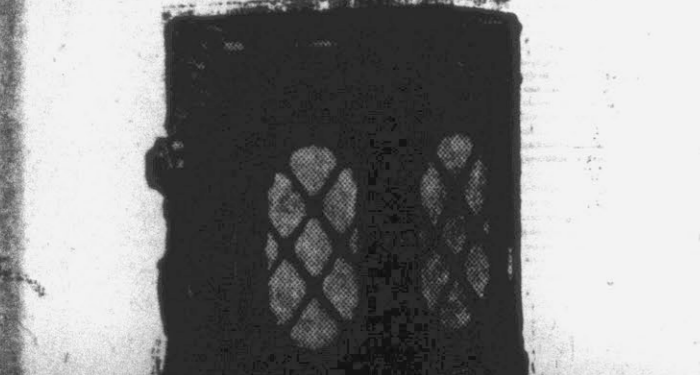
