Chinese Gov't Collapse At Early Date Is Anticipated

Approach Military And Financial Bankruptcy At A Rate Which May Cause Downfall Before Communists Can Attack Nanking; Forecast By Marshall

Nanking, Jan. 13—(AP)—China's National Government is approaching both military and financial bankruptcy at a speed which may cause its collapse without direct Communist attack on the capital.

This situation was accurately forecast three years ago by Gen. George C. Marshall when he told National leaders during his efforts to bring peace that "you must quit fighting and disband your armies or face bankruptcy."

The lack of ready funds is affecting not only attempts to remove officials and property to places of greater safety but is preventing a continuance of the normal processes of government.

Actual governmental functions are rapidly being shifted from Nanking to provincial and hsien (county) leaders whose ability to collect taxes and control territories is growing as the strength of Chiang Kai-shek ebbs.

The loss of Tu Li-ming's well equipped armies in the encirclement near Suchow is considered the final blow to the government's ability to hang on north of the Yangtze River. There are many observers here who say the defense of Nanking itself is impossible in view of the deterioration of the government's unity, strength and power.

The normal system by which the National income is gathered and then distributed has been definitely smashed by civil war developments. Today it was learned from reliable Chinese sources that not even the personal order of Chiang Kai-shek is certain to produce money from the Central Bank because in their words "there just isn't any money."

A dispatch from Peking quoted a source there as saying Chinese Communists have laid down specific conditions for the beginning of National peace talks.

He listed them as: 1. Removal of Chiang Kai-shek and Vice President Li Tsung-jen from office. 2. Scrapping of the Chinese constitution. 3. A mutual cease fire order with both sides holding their present positions. 4. Examination and punishment of "war criminals." Chiang heads the Communists' list.

Establishment of a coalition government with a five, three, four, two, one Communist members, three Kuomintang and four representing all other Chinese political parties.

The Communists, according to this source, apparently did not specify whether the Kuomintang referred to was the present party or the "Kuomintang revolutionaries" as the Reds classify Marshal Li Chi-sen and other Kuomintang dissidents. This naturally would be an important point for Nanking.

Plan Toll Road Along Coastline Virginia Beach, Va., Jan. 13—(AP)—Toll road linking Virginia Beach with Nag's Head, N. C., will be started in April, a spokesman said today. Traffic is expected to roll over it by August.

Engineers estimate that the 56-mile road will cost about \$850,000, said Sidney Banks, President of the Virginia-Carolina Turnpike Corporation. The road, to be built 600 feet inland, will be 22 feet wide.

Washington, Jan. 13—(AP)—One package, or two? That doesn't mean groceries. It means what to do about a new labor law? "Package" is a term for wrapping up two or more ideas in one deal. Congress is getting set to wipe out the Taft-Hartley labor law; to replace it with the old labor law, the Wagner Act; and maybe make a few changes in the Wagner Act.

Should Congress wrap the whole business up in one package by doing all three things at once? Or should it knock out Taft-Hartley and replace it with the Wagner Act in one stroke, and maybe make change later on? That would be a two-package deal.

Labor liked the old Wagner Act which President Roosevelt's New Deal Congress passed in 1935. It had been law until 1947. Employers didn't like it. They said it was loaded in favor of labor.

The Republicans got control of Congress in 1947—for the first time since the Wagner Act was passed 12 years before—and they wiped out that act and replaced it with the Taft-Hartley law.

Labor screamed that the new law put more restrictions on labor than any law in history. Employers said it simply balanced the books.

Came the elections of November, 1948. Backed by labor, President Truman and his Democrats promised, if they won, to wipe out the Taft-Hartley and replace it with a "fair" labor law.

Mr. Truman and his Democrats, having won, now are going to make good on their promise by trying to knock out Taft-Hartley or as much as they can over Republican opposition.

Washington, Jan. 13—(AP)—President Truman stirred thoughts of "what next?" today after a secret flight to North Carolina for a chat with General George C. Marshall.

Mr. Truman slipped out of town without advance announcement to reporters. They learned later he left at 1:13 p. m. EST in an air force Constellation.

But they didn't learn this until 2:30 p. m. when Assistant Press Secretary Eben Ayers summoned them to say "President Truman is just about now arriving at Pinehurst, N. C., to call on Secretary Marshall."

Ayers was asked if the President wanted reporters because he didn't want them along. He replied that Mr. Truman simply made the trip without notifying them, and added: "He frequently goes places without the reporters going along."

To reporters who greeted him upon landing last night at Washington, he explained simply: "I needed to see the Secretary of State, so I went to see him. I'm glad I went because we reshaped a lot of stories to our mutual satisfaction."

There was nothing significant in the visit insofar as Foreign Policy is concerned, he said. It was "just a personal visit, and a pleasant one."

Charles G. Ross, Presidential secretary, who was in the small party that flew with Mr. Truman to North Carolina, said that when the President walked in the Marshall cottage at Pinehurst, the General was "flabbergasted."

Mediation Bid By Western Powers

United States Consults With Britain And France On Chinese Action Aimed At Opening Way To Mediation In Civil War

Washington, Jan. 13—(AP)—The United States was reported today consulting with Britain and France on a Chinese government move aimed at opening the way to mediation by outside powers in China's war.

Under Secretary of State Lovett told a news conference yesterday that a communication had been received from Chiang Kai-shek's government but declined to say what it was about.

However, press dispatches from Nanking have reported that China was raising the question of possible action by one or more of the Big Four nations—Britain, France, America and Russia—to try to end the long conflict between Chinese government and communist forces.

These reports are in line with information from diplomatic sources here. The Chinese evidently have not directly suggested mediation but have opened the way either to suggest it or to have some nation or group of nations volunteer "good offices," by inquiring as to the attitude of each of the Big Four on the possibility of a peaceful settlement in China.

Some answer may be sent to Nanking by the State Department in a few days, but indications are that no step will be taken by Washington without careful checking with London and Paris.

Diplomats consider it a speculative possibility that Moscow's opinion on the China situation is also being sought by the United States; and possibly by the other western powers.

It seems likely that none of the western nations would want to make a move in China which would bring it into direct conflict with any pending Soviet move there.

British Attempt Patch Up Rift With America

Ambassador To See President On Clarification Of Britain's Stand In Palestine Crisis; Hope For Cooperation

London, Jan. 13—(AP)—The Foreign Office announced British Ambassador Sir Oliver Franks will see President Truman this afternoon in a meeting apparently aimed at patching up deepening British-American differences over Palestine.

A Foreign Office spokesman said Franks will seek to "make plain the attitude of His Majesty's government, and to learn further the attitude of the American government, in the hope that the two countries can cooperate" in settling the Holy Land conflict.

An informed diplomatic source said Franks has received instructions from Foreign Secretary Bevin since yesterday's four-hour-long British cabinet session telling him to make these points to President Truman:

1. Britain regards the Jews as the aggressors in the present phase of the Palestine war. 2. Britain feels that unless Jews and Arabs get a settlement of the "security, tranquility, peace" of the Middle East will remain upset, with results that can only benefit Communism.

3. Britain will regard a Jewish attack on the Red Sea port of Aqaba, or any other part of Transjordan, as an attack on itself now that King Abdullah has invoked the British-Transjordan mutual defense treaty. 4. Britain does not intend to suspend the precautionary measures it has taken in the conflict area.

Fireworks Figure in Trial Tuesday in County Court

The following cases were disposed of Tuesday:

Littleton was ordered to pay \$5 now and \$3 a week until he catches up in his payments.

An interesting case on Judge Dink James' docket is that of Jesse Teel, colored, which came up on a Recorder's Court warrant dated September 6, 1948. The case has been continued several times, and when it was called Tuesday, it was continued again. W. W. Speight is counsel for the defendant.

Fireworks, outlawed by an act of the 1947 General Assembly, figured in a case before Judge Dink James in County Court Tuesday. Arthur Council, Willie Meeks and Grant Andrews, all colored, pleaded guilty to exploding fireworks and the court taxed them \$10 each. Sheriff's officers and ABC officers were witnesses against the defendants.

Helen Daniels, colored, pleaded guilty of assault with a deadly weapon and she was given 90 days in jail, suspended on payment of court costs and a medical bill. W. H. Windham, transferred to Superior Court for jury trial.

Molly Cox, colored, was not guilty of larceny.

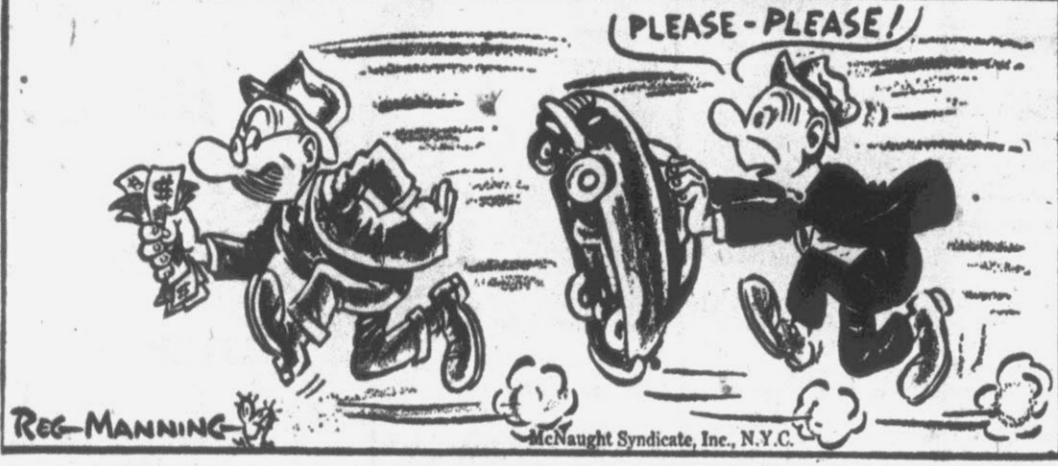
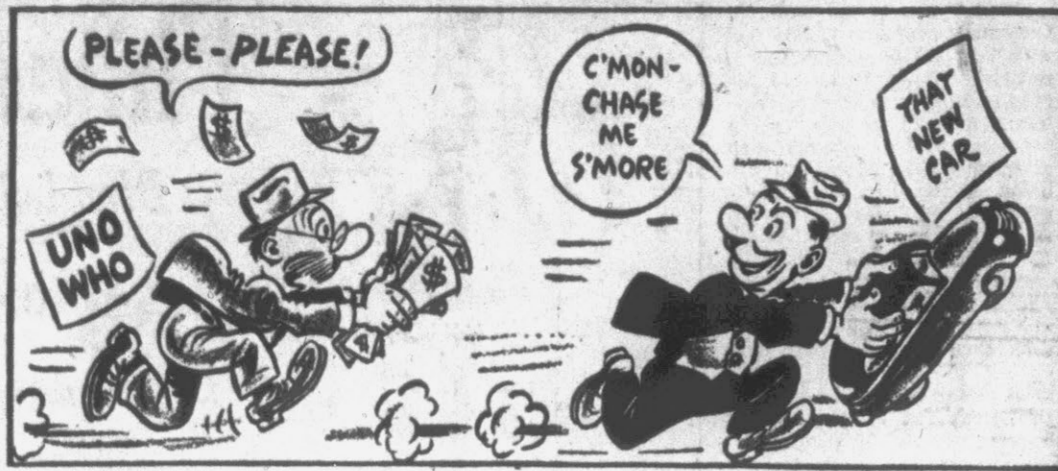

Workers as individuals have fared better under the regulations set by the Taft-Hartley law than under the absolute rule system which labor leaders enjoyed before the Taft-Hartley bill became law.

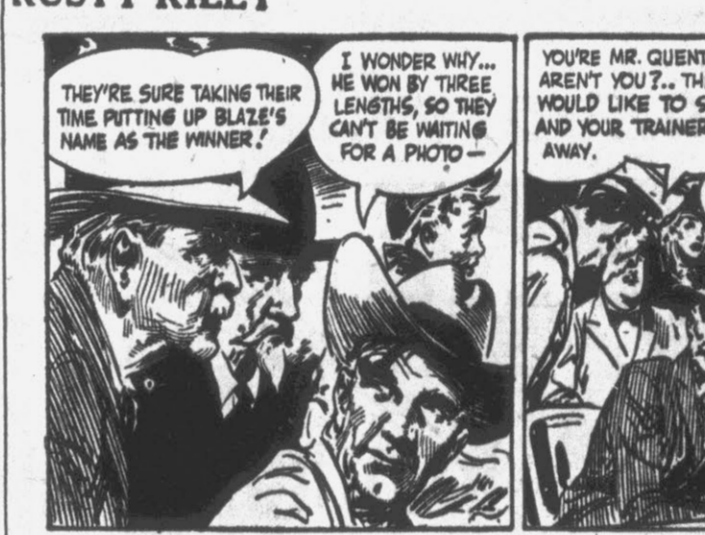

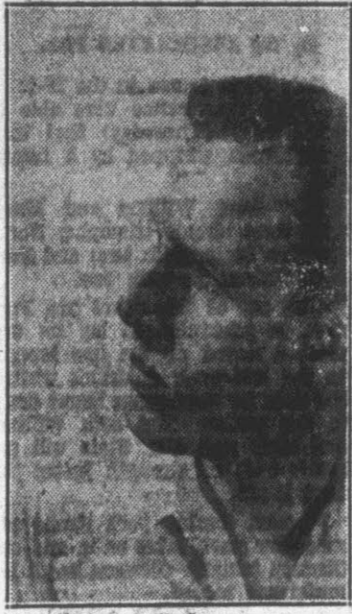

Sam J. Weeks, assistant county agent today released the results of various types of tobacco planted in this section. The results of the variety tests conducted by Weeks show Boston during the 1947 and 1948 seasons to determine the yield and value of special variety the largest producer

In pounds per acre and in total value. Over the two year period the Bottom Special tobacco produced an average yield of 1,843 pounds for a value of \$896.42. Virginia Bright Leaf variety used in the test averaged for the two years 1,626 pounds with a value of \$908.60 and 402 variety averaged 1,608 pounds with a value of \$588.32.

Oxford 1, a black shank resistant variety tobacco used in the tests averaged for the two years a yield of 1,537 pounds with a value of \$855.33. Although the yield and value of the Oxford 1 variety was not as large as that of some non-resistant varieties, Weeks pointed out that in disease infested fields the Oxford 1 variety will produce more tobacco than non-resistant varieties.

The tests were conducted during the past two years at Speight Seed Farm near Winterville, and complete results of the tests will be available to the farmers of this area, Weeks said. Data obtained from the tests will be used in a series of tobacco meetings which will be held throughout the county between January 19 and January 28.

Staff Sgt. Robert W. Burns, 32, of 2824 North Lucy St., Spokane, Wash.

Calvin and Herman are brothers. The three are accused of kidnapping, rape and murder.

Miss Farnsworth, 27, of San Francisco, was seized last Dec. 11 in a Jade shop where she was working part time so she could buy a trousseau for her marriage next April to a Marine. She was knocked unconscious, carried out to a jungle and raped. A searching party of soldiers and marines found her there 12

Sources in Jackson county said that locally-made white lightning is going begging at five cents a pint. "Prove that it came from Tennessee or as far away as lower Polk county and you can sell it," said one officer.

Even in Asheville, the bay rum crowd is said to be leary of what it drinks and arrests for public intoxication are off slightly.

As Generalissimo Stalin once admitted, she couldn't have made the grade but for the help given by Uncle Sam.

So Russia isn't ready for major war now, and it will take her long to prepare herself, if the democracies stand firm. What the western nations have to do is hold their present line.

There is no use in talking "peace" to Russia. She has made it perfectly clear that she doesn't want peace and has no intention of making it. The Bolshevik world revolution is to go on at all costs.
