Senators Express Filibuster Backing

Majority Of Those Willing To Go On Record Say They Will Probably Vote Against Ruling Aimed At Cutting Off Current Talkathon

Washington, March 4—(AP)—Thirty-eight of 55 Senators willing to go on record today they probably will vote against an expected ruling aimed at cutting off a Southern Democratic filibuster in the Senate.

Seventeen Senators told the Associated Press they will support Vice President Barkley if he holds next week that a cloture—or debate limiting—petition can be invoked to halt a Dixie talkathon.

It is being waged against a motion by Democratic leader Lucas of Illinois to bring up a filibuster-killing senate rules change.

A substantial minority remained uncommitted as the Senate headed into its fifth day of debate on Lucas' motion, with Senator Holland (D-Fla.) holding the floor.

A poll of 90 of the Senate's 86 members found 20 Republicans and 15 Democrats unwilling to say at this time how they will vote on a question that may have a far reaching effect not only on President Truman's civil rights program but on his other domestic legislative proposals as well. Six Senators were not reached.

Democrats indicating they would vote against shutting off debate included Hoyer and Broughton of North Carolina, and Maybank and Johnston of South Carolina.

Under present administration plans, the question would come before them this way:

Next week Lucas will circulate a cloture petition. It will be filed and it will then be up to Barkley to rule whether two-thirds of those voting can gag debate on a motion. His ruling will be appealed to the Senate and there is where the vote showdown will come.

Senator Vandenberg (R-Mich.) rules as presiding officer last year that debate limiting cloture can't be applied against a motion such as that made recently by Lucas. Barkley disputed that ruling then and may reverse it now.

But administration lieutenants conceded privately they are not at all sure that such a ruling by Barkley would be sustained by the necessary majority vote.

President Truman made the Southerners angrier and more determined yesterday by coming out at his news conference for a proposal under which a simple majority of those voting could cut off Senate debate at any time. Mr. Truman predicted that the filibuster will run its course soon and permit passage of his legislative program.

Senator Lucas is trying to get up a resolution to change the rules so two-thirds of those voting—not the bare majority the President suggested—could take such action anytime as they now may do when a bill is actually before them.

Mr. Truman's statement brought opposition not only from Senator Taft of Ohio, chairman of the GOP policy committee, but from Lucas himself.

Taft said he is opposed to gagging debate by a majority vote. "I don't think they'll be able to get even a majority of the Democrats to vote for that," he said.

The Red Declarations

Reaffirmed Adherence Of U. S. Communists To Moscow Axis Confirms Attitude To Our Government; Daring And Determination; Main Tenet of Bolshevik Creed

The reaffirmed adherence of American Communist leaders to the Moscow Axis doesn't alter, but here-by confirms, the party's attitude towards the U. S. Government. They've allegiance first to Russia.

There's really only one unusual thing about the statement issued on behalf of William Z. Foster, national committee chairman, and Eugene Dennis, general secretary. This is that both already are under federal charges of conspiracy to advocate forcible overthrow of the U. S. Government.

Their declaration therefore shows daring and vast determination. Here's some typical interpretive comment from Washington.

Senate minority leader Wherry (R-Neb.): "Communist allegiance has been to the Communist party, whether in war or peace."

Senator Pepper (D-Fla.): "If any citizen proves to have given wartime aid and comfort to the enemy, he is guilty of treason under our constitution and should be dealt with accordingly."

Senator Russell (D-Ga.): "Communism and patriotism always have been incompatible."

Auto Inspection By Patrol Given Committee Okay

Highway Patrol Would Be Authorized To Make Spot Checks On Highway

Raleigh, March 4—(AP)—The Senate Roads Committee today favorably reported a measure providing for inspection of motor vehicles by the State Highway patrol.

The measure is intended to replace the inspection law which was killed by the General Assembly last week.

The Senate committee rejected a modified inspection program proposed by Senator L. H. Fountain of Edgecombe which would have provided for annual inspection of all motor vehicles, at least one inspection lane in every county, and a limited list of items to be inspected.

The Fountain measure was recommended by the majority of a Senate roads sub-committee and the patrol inspection plan was proposed by Senator Roy Rowe of Pender and recommended by a minority of the subcommittee.

There would be no inspection lanes under the bill approved by the Senate Committee today.

Instead the State Highway patrol would be authorized to make frequent spot checks of automobiles on

Record Defense Budget Planned

British To Spend \$3 Billions; France Votes Big Sum

London, March 4—(AP)—Britain next year will spend her biggest peacetime defense budget except the years before she had demobilized after World War II.

The House of Commons approved defense estimates of 759,800,000 pounds (3,039,440,000) last night by a vote of 227 to 3.

This was after Defense Minister A. V. Alexander had declared a huge expenditure was necessary "so long as Russia maintains her veto on peace and security."

Alexander defended the budget as common sense in Mexico and the Philippines joined the party leaders of France, Italy, Germany, Britain, the United States, Finland and Denmark in declaring loyalty to Russia in event of an East-West war.

President Truman in Washington said American communist leaders who indicated they would side with Russia were "traitors."

Also alluding to this string of communist declarations, French Premier Henri Queuille declared "Frenchmen must do their duty against all possible invasion."

He spoke in the national assembly which also voted early today the sum of \$9,906,477,000 francs (\$193,211,800) for the army, navy and airforce in March and April.

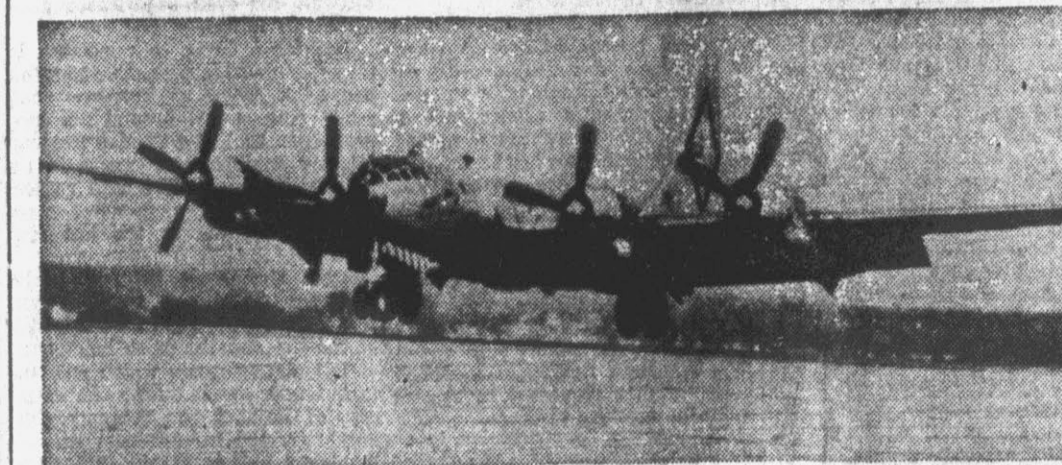

Huge Crowd At School Hearing Asks Program; Disregard Cost

Raleigh, March 4—(AP)—An all-out school improvement program—regardless of cost—was the cry of some 4,500 North Carolinians who came to Raleigh yesterday.

The crowd answered Governor Scott's call to come to Raleigh and tell their legislators what they want in the way of a school program.

The group—the biggest of its nature in the memory of Raleigh—appeared at a public hearing before the joint Appropriations and Education committees.

"The fire that Aycock kindled in the hearts of North Carolinians is burning brightly today," Dr. J. J. Joyner told the committee.

Joyner was state superintendent of public instruction under Governor Aycock, generally known as the father of the state's present school system.

"I favor wholeheartedly the requests for schools that are under consideration," he said. "Cost what it may, it will prove cheap."

Among the other leading spokesmen were Dr. Clyde A. Erwin, state superintendent of public instruction; Charles McCrary, president of McCrary Mills at Asheboro; Dr. Frank Graham, president of the Greater University of North Carolina; and Mrs. Ernest Hunter of Charlotte, president of the State PTA.

Statehood For Alaska Approved

Washington, March 4—(AP)—Statehood for Alaska was approved today by the territories subcommittee of the House Public Lands committee.

A similar measure for Hawaii got the committee's favorable vote yesterday.

Chairman Redden (D-NC) said the vote on Alaska was unanimous. He said the bills will go before the full committee next Tuesday.

Norway Officially Joins In Atlantic Defense Program

Aldermen Favor Substitute Bill

Vote 5-3 On Measure To Be Presented Assembly Calling For Election May 2 On Council-Manager Form Of Gov't

Greenville Aldermen last night voted five to three in favor of a substitute bill to be presented in the General Assembly calling for an election on May 2 on the council-manager form of government for Greenville.

Voting in favor of the measure were Aldermen Waldrop, Collins, Stafford, Tripp and Bowen. Opposed to the measure were Aldermen Morton, Smith and Buchanan.

The bill suggested by Alderman J. Edmund Waldrop calls for the postponement of the regular election of city officials from May until June; for a special election in May either to retain the present form of municipal government in Greenville in its entirety, or the adoption of the council-manager form of government.

The bill would provide the council-manager form of government to go into effect July 1, 1949, if adopted in the election.

According to last night's resolution, the bill will provide in case the council-manager form of government is adopted by the voters of the city, the charter of the Greenville Utilities commission and all amendments thereto be repealed and the city utilities be placed directly under the city government.

Waldrop's proposal calls for a utilities commission which would act in an advisory capacity to direct the operations of the local plant.

City officials will be elected in the June election in accordance with the form of government adopted in the May election, according to the provisions of the resolution.

The bill ordered drawn by the aldermen last night will be presented as a substitute bill to the legislature already begun in the Senate of the General Assembly calling for a city election of the council-manager form of government in Greenville. The bill now in the legislature provides the system, if adopted, to go into effect on July 1, 1951, and in no way affects the city Utilities Commission.

Russians Depart Besieged House

Frankfurt, Germany, March 4—(AP)—Eight angry Russian soldiers ran down the Red flag over the Russian repatriation mission headquarters today and roared off to the Soviet zone of Germany in a motor convoy.

The Russians were grim-faced as they left the building in which they had been blockaded for two days by American military police. One Russian truck driver spat at an American girl bystander as he left the mission grounds.

The siege of the big yellow house finally forced Russian headquarters in Berlin to order the mission to comply with American orders to leave the U.S. occupation zone.

But Russian authorities struck back quickly. They ordered U.S. graves registration men to leave the Soviet zone at once. A grave search unit of four U.S. soldiers last night left under escort of a Russian officer. Two other Americans were in Berlin voluntarily on a holiday when the Russian order was issued.

The graves registration unit which has its headquarters in Berlin, numbers two officers, 11 enlisted men, two American civilians and several interpreters.

The Russian repatriation mission left Frankfurt in three automobiles and two trucks piled high with their belongings. They were escorted by members of the Soviet military mission here.

Diplomat To Supervise German Policy Shakeup

Washington, March 4—(AP)—Ambassador Robert D. Murphy, diplomatic adviser on Germany, is due home from Berlin in a few days to organize a shakeup in the State Department's handling of German affairs. It may have far reaching effects on occupation policy.

At the same time, George F. Kennan, the State Department's long range policy planner, is going to Germany. Kennan will undertake a review of the situation there. His assignment will be at least as important as the Murphy appointment in its impact on the government's German policy.

The exact position of General Lucius D. Clay, American commander in Germany, as a result of these and other recent moves is not yet entirely clear. He has asked for retirement and presumably considers himself on the way out.

Some of the best informed observers here believe the balance of power over American policy on German affairs is passing from General Clay's hands into the hands of Secretary of State Acheson and Under Secretary James Webb.

The shakeup, insofar as it involves departmental machinery and personalities, was announced last night by the State Department. It is another of Acheson's moves to reorganize the American foreign affairs agency to make it a more efficient policy instrument.

For the time being at least the State Department is not taking over direct operation of the American zone of Germany. Some top officials hope it never will. Instead Acheson

and Webb want to see whether closer cooperation with the Army Department—which has direct responsibility for running the military occupation—will solve many problems that previously complicated the operation.

At the same time, George F. Kennan, the State Department's long range policy planner, is going to Germany. Kennan will undertake a review of the situation there. His assignment will be at least as important as the Murphy appointment in its impact on the government's German policy.

Ambassador Scheduled To Visit State Department Today; Formal Acceptance Announced; Further Expansion Of Alliance Seen

Washington, March 4—(AP)—Strategic Norway officially linked its defenses with the North Atlantic democracies today over Russia's vehement objections.

Norwegian Ambassador Wilhelm Munthe De Lorgenstjerne was due at the state department this morning to add his country for the first time to the list of nations drawing up a tight defense alliance against Communist expansion.

The Norwegian government's formal acceptance of an invitation to join in the final stages of the negotiations came yesterday. Simultaneously Norway was reported to have turned down a non-aggression pact which would have tied its future to Russia.

The nation already at work on the North Atlantic treaty are the United States, Canada, Britain, Belgium, France, Holland and Luxembourg.

State department officials welcomed Norway's decision to join up as a "significant cold-war" over Russia, one which is bound to increase the effectiveness of the North Atlantic grouping.

Denmark, following Norway's lead, said last night that it, too, would like to join the treaty talk. That leaves Sweden the only "neutral" among the Scandinavian countries which control the approaches to the Baltic sea.

The Norwegian storting (Parliament) overwhelmingly approved Norway's decision to turn to the west for security in a secret session yesterday. Morgenstjerne said the only opposition came from the 11 Communist members.

Reports of Russian troop concentrations along the Norwegian-Russian border have been reported in dispatches from Helsinki. State Department officials said they had nothing to confirm the reports but added they would not be surprised if they were true.

Norway's entry is expected to speed a decision of whether to try extending the defense ring southward. Both the Italian and Portuguese governments have expressed interest in joining the Alliance.

Some opposition to including Italy in the pact just yet has come from key members of the Senate Foreign Relations committee. Many top State Department officials, however, are convinced quick Italian membership is necessary both from a political and strategic view.

President Finds Taft With Him On Control Issue

Washington, March 4—(AP)—Senator Taft (R-Ohio) and President Truman—for a big change—lined up on the same team today.

They both favor the idea of extending government controls over installment buying beyond June 30. But two Southern Democrats who must help push any authorization through the Senate showed signs of balky. Senators Maybank of South Carolina and Sparkman of Alabama said they would insist upon "extended hearings" before the Senate Banking committee. Maybank is the chairman.

Mr. Truman told his news conference late yesterday that he wants consumer credit regulations extended despite the official loosening of some pay-off requirements this week.

Deductions Explained

Limitations; Charities; Business And Personal Deductions; Tax-Free Income Which Doesn't Have To Be Reported; Items That Cannot Be Called Deductions

Washington, March 4—(AP)—This explains some of the deductions you can, and can't, take in making your 1948 income tax return.

Also listed are some kinds of income which, because they're tax-free, don't have to be reported at all.

Remember, right here, a couple of points:

1. There are various limits on the deductions you can take for medical expenses. They're explained at the end of this story.

2. For charitable contributions you can deduct no more than 15 per cent of your income.

3. But there's no limit on the other kind of personal deductions you can claim, if you can prove you had them and entitled to them.

4. Don't get business deductions mixed up with personal deductions. On your 1948 long-form there are separate places for each kind.

This story deals only with non-business deductions and where they appear to be business deductions they're merely those of an employee. Not employer.

Here's tax-free income which doesn't have to be reported:

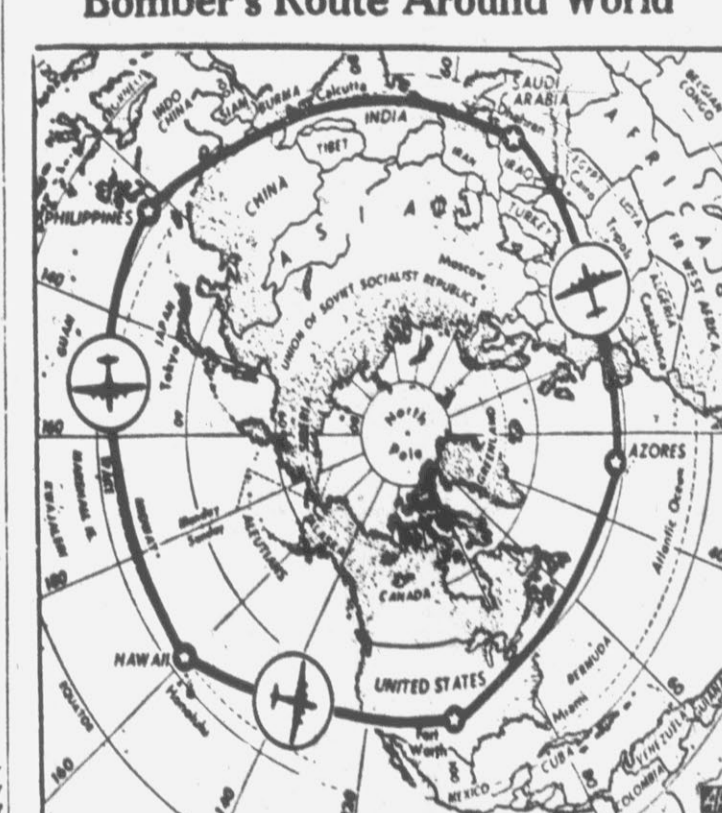
Unemployment compensation; social security benefits; life insurance paid because of the death of the insured; inheritances, gifts or bequests of money or property, although the income from them is taxable; sickness and injury benefits received through accident or health insurance or under workmen's compensation laws. Also—

Monthly government allowances to the families of servicemen; military pay; all benefits under the GI bill of rights, such as for education and subsistence; state bonuses to veterans; disability pay; retirement pay for service-connected disability; allowances for uniforms; subsistence, traveling, quarters; pensions to veterans on their families for war service; all active service pay of enlisted men in the armed forces; and the pay of officers up to \$1,000.

Here are personal expenses which can be deducted:

Contributions (limited to 15 per cent of income) to charitable, religious, scientific, fraternal and veterans organizations, and non-profit

garden problems. Some of them are difficult for even experienced gardeners to solve.

The main thing to remember is that any damage probably is not as bad as it seems at first and that real spring is just around the corner. When we had a week of freezing weather in December many of us thought the camellias were ruined but their blooms have never been lovelier than during the last few weeks.

Roses that were kept in fairly protected places and then set out this spring may have been injured at the top and the same holds true of fall planted roses which put out their tender leaves during the warm days of January and February. Cut back only the injured part leaving the lower half to sprout out again.

Most of the perennials and small plants of larkspur and poppies can stand much cold weather but if any seem very fragile, protect them with a very light covering of straw or evergreen tips.

It is getting late in the season for planting hardy annuals such as ragged robins, larkspur, etc., but they may do fairly well. Zinnias and

marigolds are tender annuals and should not be planted yet. There is still time to plant evergreens and flowering shrubs but the evergreens should be moved with a large ball of earth and will need careful watching this summer. If any bedding plants are to be put out later, have the place pre-

pared now. Fertilizer may be put in to become well incorporated with the soil. Then when the warm days come the plants may go in without delay. Plan for something choice and something new and before we know it our gardens once more will be bright with flowers and birds.

# Sailor Claims Shanghaied By French Foreign Legion

Canton, March 4—(AP)—James Patrick Ryan, 24, U.S. Navy sailor missing for 19 months from his ship in the Mediterranean, today charged he was shanghaied into the French Foreign Legion.

Ryan, who gave his address as Huntington, Penna., said he was brought halfway around the world to fight the Viet-Namense in Indochina before he managed to escape on foot and by river boat to reach Canton. He is being treated at a hospital for malnutrition and jungle ulcers on orders from the American consul.

The American charged in an interview that he was one of several Americans being held against their will in the French Foreign Legion.

Ryan said he was a seaman aboard the U.S. Dickson. He missed the ship at San Remo, Italy, on July 2, 1947, he said. The sailor said he hoped to catch it at Nice, France, and rushed there only to be picked up by French Foreign Legion military police and questioned.

"I spoke no French and they no English," he said. "So we talked in German which I picked up during the war."

"That was my mistake," Ryan continued. "They refused to believe I was an American and threw me in a military jail."

The American said he wrote several letters to the U.S. ambassador in Paris but received no replies.

"I was guarded 24 hours a day," he said.

## Movie Banned

Hamburg, Germany, March 4—(AP)—The British film, "Oliver Twist," has been banned by British military government in Germany, the Eagle-Lion Film Company announced today.

There were riots in Berlin recently when the film was shown there. Polish Jews demonstrated outside the cinema until screening of the film was stopped by the local manager.

The Jews objected that the character of Gai in the Dickens classic was too emphatically portrayed as a Jew.

# Ayden Lions On Mercy Mission For The Blind

By CHESTER WALSH

A review of the good work of the Ayden Lions Club in that enterprising community reveals some outstanding achievements in assisting the blind and visually handicapped. Miss Jennie Manning of Bethel, blind case worker for the County Welfare Department, pointed out today.

The Ayden Lions are paying for glasses and providing transportation of patients to and from hospitals for treatment. The club contributes food, clothing, fuel and medicine in worthy cases. The Ayden Lions donate Christmas baskets every year. The club provides a revolving fund to pay for materials for teaching occupational therapy crafts. It provides material for home industries for the blind and assists in finding a market for hand-made articles.

The Ayden Lions Club is interested in better lighting for schools. Miss Manning recalled that in a recent survey made by the National Society for the Prevention of Blindness, it was found that more than 4,500,000 American school children do not see clearly. To remedy this situation, the society recommends better lighting of class rooms, glare surroundings, coloring of walls and floors to meet modern illumination standards, etc.

The Ayden Lions netted \$180 from the recent minstrel show produced by Eli Bloom of Greenville, and the blind fund benefited substantially. The senior class won the prize for selling the most tickets for the minstrel. They generously donated the money to install better lights in the Ayden High School library. Ben E. Demain, secretary of the Ayden Lions Club, said J. H. Rose is chairman of the Committee on Work for the Blind. Bennett Phillips is president of the Ayden club.

Paris, March 4—(AP)—Ex-Marsh Philippe Petain will no longer have to make his own bed and clean his cell, on the bleak Ile D'Yeu off southwestern France.

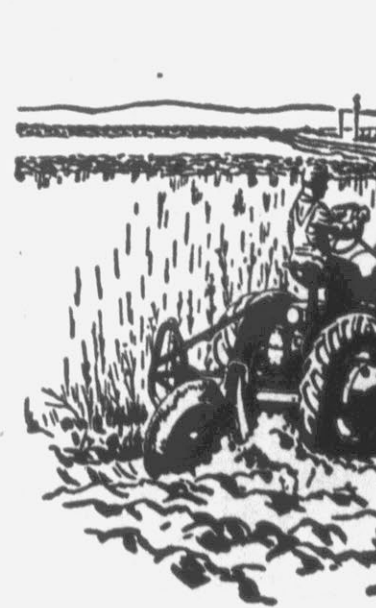

## Strength FOR THE DAY

**GROWTH OF HABIT**  
Some time ago I saw a motion picture of a natural aquarium on one of the islands in the West Indies. Fish, when they are small can get through a certain little aperture which leads from the sea to the aquarium; but after the tourists have fed them for a few weeks, they are so large that they cannot get out through that same opening. Then they have to stay to keep the numbers from increasing too much, the larger fish are scooped out once in a while and hung up in the fish market.  
A generation ago practically every college student was familiar with that famous chapter on habit found in William James' text book of psychology. It gives a vivid picture of how habits grow by feeding until we find ourselves at last prisoners and apparently unable to escape the disadvantage of our ways of life. Habit formation begins quite naturally and innocently. Like the little fish, we go through a small aperture in response to desire, and then after our desires are fed, we find we cannot go out the same place we went in.  
Many a man, like the poor fish has found himself hung up in the fish market because of an easy, indulgent attitude toward life which finally involved him in trouble.

## Around Capitol Square

**By LYNN NISBET**  
**GREEN**—The traffic light for legislative appropriations is green again. When the report on January receipts was released a month ago, showing decline in revenue as compared with the previous year, many legislators regarded it as an orange light calling for caution. Predictions were made then that the February report would turn the light red; instead it is back to green. Net general fund revenue for February was \$111,256.48. For the comparable month last year it was \$9,444,138. This is a boost of nearly 18 per cent for the month. Highway revenue was up three quarters of a million dollars for a 13.16 per cent gain over last February.  
**ANALYSIS**—Legislators have not had time to analyze the report or to appraise its probable influence on legislation. Two items stand out. These being the sources of more than two-thirds of all state general fund money. For the first time in many months the sales tax showed a slight decline; but contrary to many forecasts of declining income taxes this bracket was up nearly a million dollars. March is the big income tax month and pessimists still look for decline in the next monthly report. Drop of slightly more than one percent in the sales tax is regarded as reflecting lower costs for merchandise, which might later also be reflected in less income receipts.  
**FORWARD**—Whether the long range effect of this and subsequent reports may be, immediate reaction was to go forward with even more courage than heretofore in making adequate provision for schools, health and welfare. The February report was published coincidentally with the mass meeting of school supporters and legislative committees on education and appropriations. This timing enhanced the optimistic influence of the figures.  
**PSYCHOLOGIC**—Although the amount of dollar and cent increase in revenue last month over the preceding February was considerable, main effect of the increase is psychologic. It was argued in behalf of the motor vehicle inspection law that a great deal of its influence was on the psychology of the drivers, encouraging them to maintain safe equipment. For many years it has been claimed that one of the chief benefits derived from good roads was the by-product of improved premises along the highways. An upward swing in revenue now, however slight, will give new courage to the "go forward" boys in the general assembly.  
**INSURANCE**—Action of the state board of education in adopting a policy of self-insurance for school buses in logical extension of self-insurance plan for state owned buildings which was put into effect four years ago. Recommendation that the legislature provide method for self insurance of school houses goes into a new field, and is indirectly related to the whole program of state aid to counties for school buildings. Since title to school houses is vested in the state, that matter was simple. Title to school houses vests in local administrative units,



and the problem is more complicated. However, members of the board of education and of the legislative insurance committees have several ideas for working into a plan designed to save a lot of money on insurance premiums.  
**BIG BUSINESS**—The school lunch program has developed into big business—with capital B's. Mrs. Anne Maley, state director of the lunch room operations, gave the board of education some large size figures Thursday morning. Without going into details, she told the undertaking can be illustrated by number of meals served. During the past school year lunchrooms served 36 million meals; this year they will serve slightly more than 50 million. That means almost one-third of the public school pupils of the state get a balanced hot lunch every day.

Washington—At his happy, somewhat boisterous annual "wallow" late this month, the Military Order of the Carabao will welcome Gen. Carl Spaatz, late of the U. S. Air Force, as its new Grand Paramount Carabao.  
Just after the meat course, as the general approaches the platform, members of the herd will sing:  
"Oh, he flew through the air with the greatest of ease,  
"Daring Carl Spaatz without a trap."  
"Oh, he flew and he flew 'til he was, I declare,  
"Naught but a speck in the air...  
"When he retired, they brought our Carl down  
"And found he was mortal like men on the ground.  
"Now, he's had the courage to try to lead us  
"The brave, the foolhardy cuss."  
General Spaatz succeeds General Jonathan M. Wainwright as national commander of the order, founded in 1900 by officers serving in the Philippine Insurrection. The annual wallow, held since 1904, is to naval military "brass" what Gridiron dinners are to the press.  
Assembling mainly to "kid itself" and renew comradeships extending over three wars and a life of military service, the order is now largely composed of liberators of the Philippine Islands.  
Grand Lead and Wheel Carabao, rear Admiral Sara G. Allen, who wrote this year's show for the wallow, and a howl it is, says the order was founded as a joke.

# First Man In North America Probably Lived In N. Carolina

Washington, March 4—(AP)—The first man in North America may have lived in what is now North Carolina or Virginia, after all. At any rate he probably camped in the Roanoke River basin of southern Virginia or northern North Carolina some 10,000 years ago, the Smithsonian Institution said today. It's the Folsom man, apparently discovered again in the Roanoke River basin.

His name comes from the fact that first evidence of him was found at Folsom, N. Mexico.

Carl F. Miller reported the new evidence of the early American in Virginia and North Carolina after surveys were made of the river basin before work was begun on the \$68,800,000 Buggs Island dam on the Roanoke River.

Miller stated: "Makers of (projectile) points came into southern Virginia and northern North Carolina at a time when Folsom points were no longer manufactured and possibly the Folsom man had vacated this section of the country."

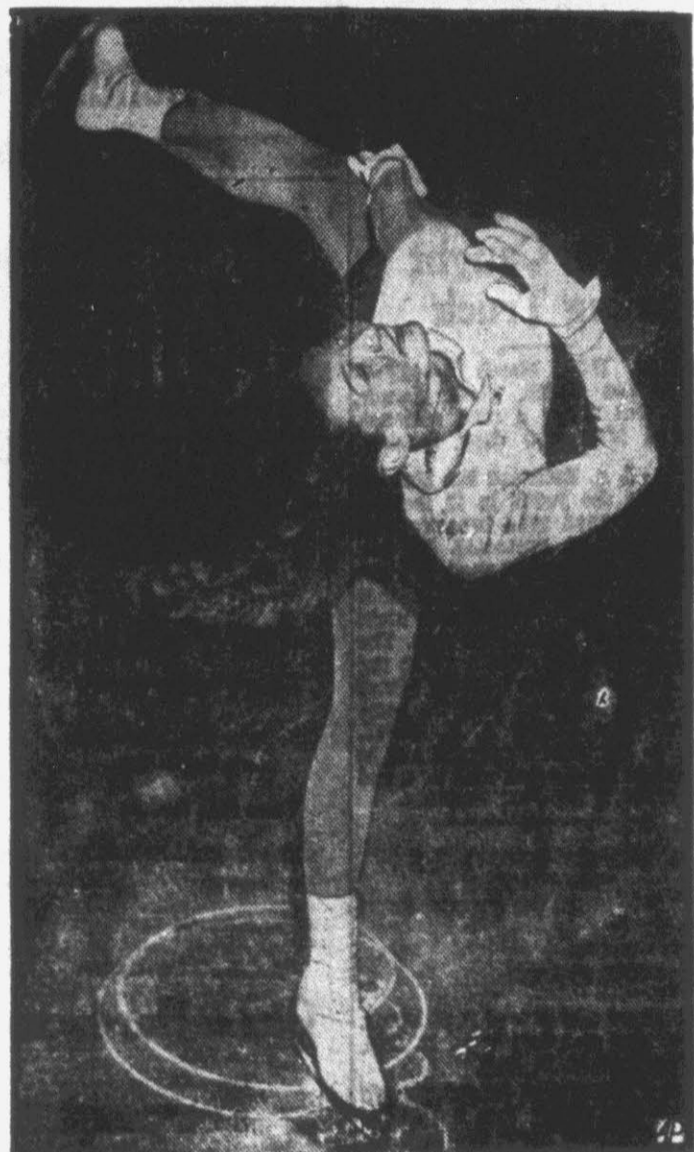
He said pentagonal-shaped projectile points found on the Roanoke River area exhibit a number of Folsom characteristics and bear a close relationship to the eastern variant of Folsom.

Miller also said survey of the Roanoke River basin showed 94 sites where people had lived and worked and included 34 village sites, 17 camp sites, 41 flint workshops and two historic iron-working sites.

Some of the projectile points found in the two southern states resemble those found in the Gypsum cave of Nevada and in the Mammoth mound of New Mexico, the Smithsonian said.

# Archduke Paints Dark Picture Of Russia's Successful Policy

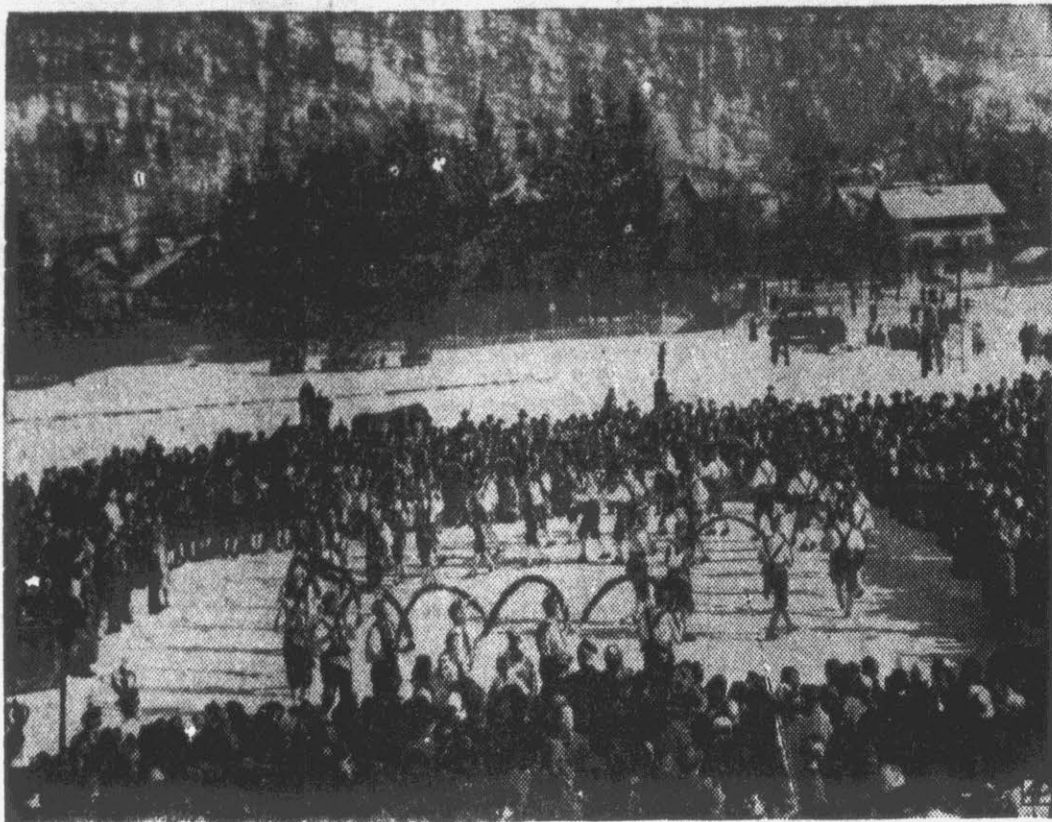

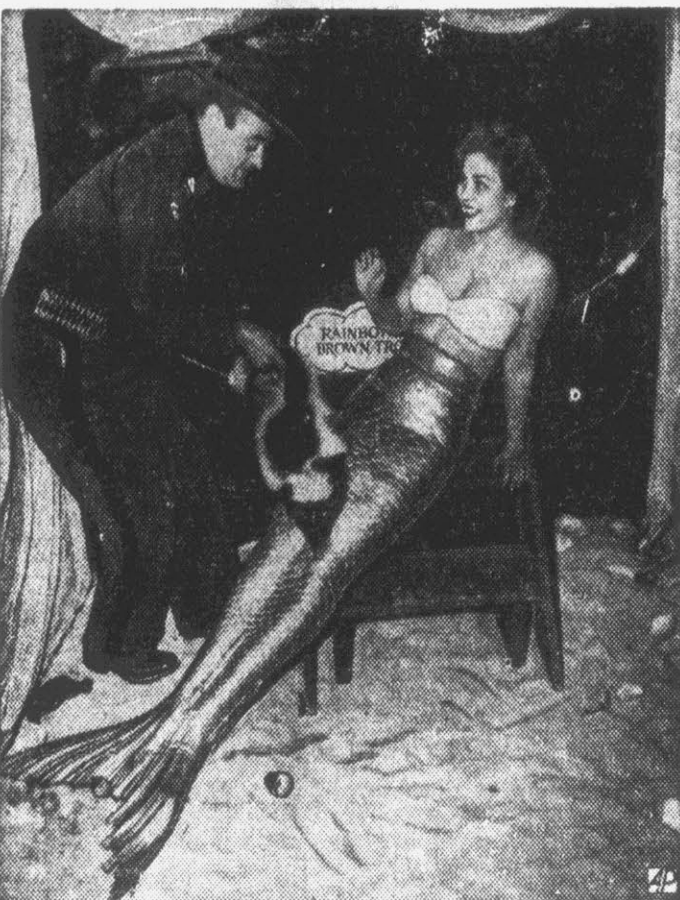
by Robert Lee Humber. The Archduke pictured world events of the past few years and declared that they followed a fixed pattern to carry out the Soviet plans and desires. He said America was the last stronghold of freedom of the world and that all Russian efforts were now directed at the eventual destruction of that freedom.

Quoting figures on Russian production the speaker revealed that great strides industrially have been made by the Soviets since the close of World War II until they are now potentially the strongest force in the world. This fact, he said, places a great responsibility on America and the other freedom-loving people now looking to America for leadership. He said world revolution with actual conflict were in the Russian plan and that the only way to avert it was for America and its allies to become so strong militarily that the Russian leaders would realize that it would be suicide for them to attempt to engage in such a war.

In order to halt the spread of communism, the speaker said, the freedom-loving peoples must join together in a coordinated plan of living that would be evidence to other peoples that freedom had more to offer than did totalitarian dictatorship. Viewing the global situation with special attention to the Far East, he said that so far in the "cold war" America and its allies had lost some important battles. In order to prevent the eventual spread of communism throughout the world America and its allies must become strong enough to recoup their losses and drive communism out of the Far East and out of eastern Europe back into the Russian borders, he said.

## Polio Cases Hit Two-Months High

Washington, March 4—(AP)—Infantile paralysis totals for January and February of this year hit new highs for those two months, the Public Health Service said today.

"This has no significance with respect to forecasting an epidemic in the present year," the agency added, "because it's believed that this excess is due in large part to a carry-over from last year's epidemic." Last year's 27,677 cases made it the second worst "polio" year on record—topped only by 1916 when approximately 29,000 cases were reported. The health service has been keeping exact records on the disease for only 22 years.

The service said that actually the rate of new cases has been declining almost steadily from week to week, as is normal for this time of year but that the number each week was sufficient to give a total of 750 cases for the eight week period which ended February 26. Health service statisticians said it will be May or June before any accurate forecast can be made for the present year.

This year's eight-week total of 750 cases compares with 270 for the same period last year and 500 in the comparable period in 1947—the previous high.

## Yale President Dies Suddenly

New Haven, Conn., March 4—(AP)—James Rowland Angell, president emeritus of Yale University, died at his home here today. He was 79. Angell, who was Yale's 14th president, died at his home in Hamden after a long illness. He retired as Yale's president in 1937 subsequently becoming educational advisor for the National Broadcasting Company.

# Describes Hotel Murder As 'Truth Serum' Is Used

New Orleans, March 4—(AP)—Louis Engene Hoover filled in his blank memory with "truth serum" and told police he beat and strangled millionaire James Mahoney.

Police investigation, however, continued to dig into the case today. They said there "are lot of angles" to be cleared up.

Acting Police Supt. Joseph Scheuering said the statements of Hoover, a 25-year-old Louisville, Ky., parking lot attendant, "are not a confession" and the case is far from closed.

Among angles to be cleared up, he said, is the matter of Mahoney's missing watch.

Hoover said he took it from Mahoney's room after a fight with the wealthy Bristol, Va.,-Tenn., man in his hotel room the night of Feb. 21. It was not in Hoover's luggage when he was arrested Monday after his discharge as a mental patient at the veterans administration hospital here.

Another angle involves Mahoney's emptied wallet which Hoover said he threw into a trash can. It, too, is missing.

Hoover submitted voluntarily to administration of the so-called "truth serum" (pentothal) late yesterday.

Scheuering quoted Hoover as telling of going to Mahoney's (Monteleone) hotel room in the French quarter, taking a shower and engaging in an argument with the millionaire as the two lay nude on a bed. When Mahoney called Hoover's wife a "name," a fight ensued, Scheuering said.

Then he quoted Hoover: "I pasted him and pasted him several times. The only thing I used was my fist. I gave him a rabbit punch with my hand on the back of the head. That might have broken his neck."

# Rector Refuses To Comply With Bishop's Ouster

New York, March 4—(AP)—Defying orders of his bishop, a Protestant Episcopal rector today looked to his congregation to support him in seeking to retain the pulpit he has occupied for 4 years.

The case of the Rev. John Howard Melish, D. D., rector of Holy Trinity Church in Brooklyn, is slated to be the key topic of a meeting of parish members Monday night.

The 74-year-old rector, whose removal was ordered by Bishop James P. De Wolfe of the diocese of Long Island, says he intends to stay at his post "as long as my congregation desires me to stay."

His removal was ordered by the Bishop because Dr. Melish refused to interfere in the non-church activities of his son, the Rev. William Howard Melish, who is the assistant rector.

The son is chairman of the National Council of American-Soviet Friendship, a group called subversive by Attorney General Tom C. Clark.

Dr. Melish yesterday termed the bishop's order a violation of Protestant Episcopal law, and said four Episcopal bishops throughout the country had offered him their support.

There were reports the case may be made an issue before the denomination's general triennial convention, scheduled to open September 26 in San Francisco, if it is not settled before then.

Normal church procedures allow no appeal over the bishop's decision, it was said.

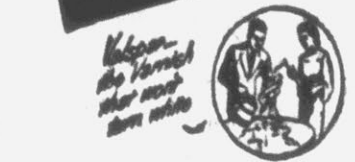

# History Repeats As State And Carolina Meet In Semi-Finals

### Last Year, High-Powered Wolfpack Pressed To Limit In Turning Back Tar Heel Comeback

Durham, N. C., March 4—(AP)—The fates have set up a situation in the Southern Conference Tournament that strikingly parallels that of a year ago.

Action in yesterday's first round produced results:

North Carolina State 64, Wake Forest 42.

William and Mary 54, Davidson 50.

George Washington 62, South Carolina 45.

North Carolina 79, Maryland 61.

Tonight's semi-finals pair N. C. State and North Carolina at 7:30, with George Washington meeting William and Mary at 9.

Here is where history steps front and center in a bid to repeat.

A year ago State was 63 points better than North Carolina in two regular season meetings. This season the high powered Wolfpack was 71 points ahead of the white Phantoms in two engagements.

Last year, as tonight, they met in semi-final contest. In that game North Carolina playing well above the standard of its two early season brushes with the champs, staged a great second half comeback to press State to the limit before bowing, 55-50, in the closing seconds.

Now Everett Case and his two-time champs are wondering what to expect tonight.

They were just as good as they had to be last night in breezing by Wake Forest. Case used 19 players and nine had a hand in the scoring, center Paul Horvath's 14 points topping the parade.

The Deacons had visions of repeating their mid-season upset of the pack, when they stayed with them for nine minutes, but they began to fade and by halftime were behind, 34-19. The 'st half was more of the same. State roiling along to its ninth straight victory.

North Carolina, meanwhile, gains its place in the semis by steam-rolling Maryland, 79-61, before a record afternoon crowd of 7,500. The Phantoms also came up with a record 79 points, three more than Duke made, also against Maryland, four years ago.

A 30-point spree in the first 10 minutes of the second half iced the game for the Chapel Hill team, 31-25 leader at the half.

Sophomore Hugo Kappler's 21 points led the winners, with conference scoring King Coy Carson adding 18.

Davidson gave second-seeded William and Mary a hard time of it in the night finals before 9,000. The Indians blew a 19-10 lead and had to come from behind in the closing minutes to fight off the challenging Wildcats.

Riders in the international bicycle race at the 22nd Regiment Army in New York City voted to use six-ounce tires during the grind instead of the conventional nine-ounce tubes, thereby putting speed ahead of safety. Torchy Peden, winner of 38 six-day races, and holder of many championships, estimates that the lighter tire will not add more than 30 yards in distance for the riders but its use will increase the hazard of blowouts and resulting spills by 200 per cent or more.

"Blowouts and spills are part of the game," says Peden, "but these boys just seem to be asking for trouble by using the lighter tire.

They're willing to risk their necks for a little distance, and they simply shrug off advice. I'd say offhand that the yards they gain will not be as many as the yards of gauze they will use to bandage their injuries.

The riders hit the turns at a terrific pace," Peden continues. "A real fast rider like Cecil Yates or Hugo Koblet will be going 45 to 50 miles per hour. The pressure at that speed is around 600 pounds. It requires the stoutest sort of a tire to withstand the beating the six-day tubes are called upon to take. But the boys are willing to take the chances if they think they can win first money."

## Hogan Undergoes Long Surgery; Said 'Resting'

El Paso, Tex., March 4—(AP)—Plucky little Ben Hogan today was resting well after a two-hour operation designed to prevent blood clots from reaching vital parts of his body.

Clots, approaching his heart last Wednesday, made his condition "very critical." The operation performed last night will prevent further clots, the surgeon said.

However, the nation's foremost golfer will not be "up and around" for several months, the surgeon reported.

He is Dr. Altn Ochener, professor of surgery at Tulane University, New Orleans. He flew here yesterday and almost immediately decided to operate.

He said the clots came from injuries Hogan suffered Feb. 2 in an automobile-bus collision. His pelvis, collar bone and an ankle bone were broken.

An abdominal operation was required. Dr. Ochener said Hogan should be over the effect of the operation in a week, and be "up and about" in a few months.

He explained that the clots which threatened Hogan's life Wednesday had been absorbed by the blood stream. Last night's operation was a precaution against further clots endangering Hogan's life.

The operation took place in Hotel Dieu, a hospital here.

Formation of blood clots had worried Hogan's regular physician almost since the accident.

## Ten Teams Await Tourney Invites

New York, March 4—(AP)—Ten teams remained to be chosen today to fill the brackets of the NCAA and National Invitation post season basketball tournaments.

The invitation indicated it would be ready to release one or more additional entries for its field very soon possibly this afternoon. Four clubs have accepted—Kentucky, St. Louis, Western Kentucky and Bradley.

Yale was added to the NCAA playoffs yesterday. The Blues will represent District One (New England) which produced a national championship in Holy Cross two years ago. Kentucky, which is trying its hand at both of the big tournaments, is the only other school named for the NCAA so far.

Both Kentucky and Yale will enter the Eastern NCAA playoffs in New York starting March 21. Villanova is a likely contender from the New York-New Jersey-Pennsylvania area. The fourth team will be the Big Nine champion—either Illinois or Minnesota.

The invitation which starts March 12 had figured last night's Manhattan-City College game at Madison Square Garden would determine a New York entry, specifically City College. But Manhattan upset the apple cart at least temporarily with a surprising 44-43 victory.

## Veck Heads West After Long Talk With Chandler

Sarasota, Fla., March 4—(AP)—Bill Veck heads for California today to take up his Cleveland hold-out problems after airing his dispute with the New York Yankees' George Weiss before Commissioner A. B. Chandler.

Chandler indicated it would be several days before he completed his investigation and made a decision. Veck's conference with Chandler resulted from counter charges hurled by the two clubs over the signing of two Negro players.

Weiss protested the Indians' signing of Shortstop Artie Wilson, who performed for the Birmingham, Ala., Black Barons of the Negro National League last year. He said Wilson agreed orally to play for the Newark Bears, a Yankee farm club, before he signed with the Indians.

Weiss accused Veck of "unethical practices" and lodged a formal protest with the commissioner's office which was received by Chandler Feb. 28.

Veck answered with a counter charge against the Yankees, protesting their signing of Luis Marquez of the Homestead Grays. Veck said the Indians had obtained a 120-day option on Marquez Nov. 15.

Veck chided Weiss by saying that "like the player who was caught asleep with the hidden ball trick and was trying to save face with his superiors."

Bucky Harris of the Yankees kept the feud smoldering last summer when he accused Bobby Feller, Cleveland's ace righthander, of running out of the All-Star game. The great success of Lefty Gene Bearden with the Indians last year after the Yankees had given up on him without so much as the benefit of a trial did not sit so well with the New York club.

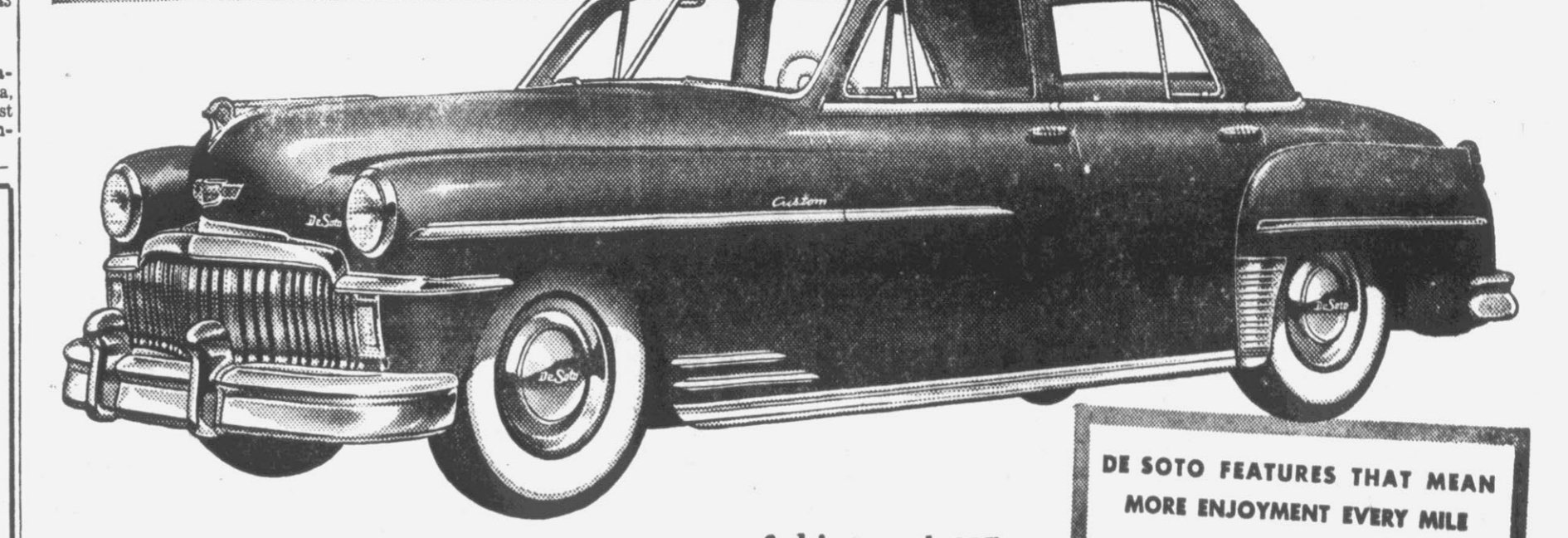

# East N.C. Well-Represented In Hearing On Rural Power Lines

Raleigh, March 4—(AP)—A large Wilson County delegation today appeared before the House Utilities Committee to favor legislation which would put rural power lines operated by municipalities under Utilities Commission regulation.

James Y. Yates of Wilson County presented a petition which he said was signed by 2,200 persons favoring the measure. He asserted that rates charged rural customers by the municipal power plant at Wilson were far higher than rates paid by customers who live in the city.

He said the city of Wilson made \$199,000 on its municipal plant last year and this was sufficient to operate the city government for five months. Rural customers, he said, paid a large portion of this and received no benefits from it.

W. A. Andrews of Wayne County representing the State Grange, said the Grange favored the measure because the municipally-operated plants were discriminating against their rural customers.

Roy Williamson, city manager at Rocky Mount, told the committee he represented his city and the 82 municipalities of the state which operate power systems.

He asserted that there were two "local situations" in the state which prompted introduction of the state-wide measure.

Leslie Elks, mayor of Grimesland told the committee his town had bought its power from the municipal plant at Washington, but Washington had jumped the rate so that it now was buying from Greenville. He said that since the change the

## Many Items Taken Up By Aldermen In Busy Meet

Two bills were authorized to be drawn and sent to the General Assembly by the Greenville Board of Aldermen last night in the regular meeting of the body.

One bill is a substitute for a bill now in the General Assembly and calls for an election of the council-manager form of government for the city. The other bill would authorize the city government to supplement retirement salaries to its employees who are members of the state retirement system so as to bring retirement pay of city employees to 50 per cent of their average pay for the last five years before retirement.

The aldermen approved the recommendation of the city recreation commission that the body be reduced to seven members, and accepted the report of the commission. The aldermen appointed as members of the commission the seven persons recommended by the nominating committee of the commission. Members appointed to the recreation commission and their terms are Mrs. Fred B. Haar, one year; Dr. N. M. Jorgensen, one year; J. H. Rose, one year; Mrs. Wendell Smiley, two years; B. B. Sugg Jr., three years; Ercell Webb, four years; and H. B.

Tripp, two years.

The Charles Gray Morgan post of the Veterans of Foreign Wars was granted waiver of city tax on a dance to be held, and at the request of the Merchants Association Thursday March 10 was declared a holiday for the parking meters. The matter of purchasing property for the extension of certain streets was referred to the street committee which was granted the power to act.

Parker Atkinson, Negro store operator, was cited to the meeting to show cause why his beer and wine license should not be revoked. Police Chief Lester Page reported that Atkinson had been convicted of illegal possession of whiskey for sale twice in the past three months, and recommended to the board that license be revoked. The board accepted Page's recommendation and revoked the license.

Mayor J. H. Boyd read to members of the board a letter of resignation from J. H. Blount of the Utilities Commission, but the aldermen deferred the appointment of a new member of the board for 30 days.

A motion to charge out of town residents 100 per cent more for lots in the city cemetery than charged to residents of the city was passed by the board.

In a letter to the board, Frank M. Wooten Jr. petitioned the city for \$1,500 damages which allegedly were caused by broken water pipes in a house last December when the pipes froze, burst and then thawed out. In his letter to the board, Wooten stated the Utilities office had been notified to turn off the water in the house and the owner was informed that the water would be cut off.

The aldermen heard petitions from several citizens for street lights at various points in the city and referred the request to the Utilities Commission. Reports from city department heads and other routine business was disposed of at the meeting.

An overflow audience attended special services in connection with the "World Day of Prayer" at Emmanuel Baptist Church at 10 o'clock this morning. The Sunday school rooms were opened and the seats were rapidly filled. Chairs were placed about the church to seat the unusually large congregation. Five or six hundred people were in the church, it was estimated.

The "hour of prayer" was sponsored by the Greenville Council of Church Women. Mrs. June H. Rose presided. Ministers and laymen participated in the impressive program. Special music appropriate to the solemn occasion was provided and the congregational singing of hymns could be heard several blocks. Rev. J. A. Nelson is pastor of the host church.

The "World Day of Prayer" was observed in 74 countries last year. There were 10,000 observances of "World Day of Prayer" in the United States. Double that number were scheduled for this year.

## Iran Protests To Soviet Against New Propaganda

Tehran, Iran, Mar. 4—(AP)—Iran announced today she has protested to the Soviet Embassy here against Russian radio and press attacks.

The Iranian note referred specifically to:

1. Russian allegations that the United States military mission had turned Iran into a military base against the Soviet Union.
2. Russian accusations that Iranian authorities are foreign agents.
3. Soviet criticism of recent handling of the left-wing Tudeh (masses) party in Iran, after an attempt on the life of the Shah by a Tudeh member.

educational institutions.

Here are other deductible personal expenses:

Dues to a labor union; state income and personal property and real estate taxes except taxes which, like paying assessments, tend to increase the value of your property. Also—

Interest on your personal note to a bank or individual; a mortgage on your home; a life insurance loan, if you pay the interest in cash; delinquent taxes; interest on installment purchases. Also—

State or local retail sales taxes; Auto license fees; poll taxes; State Gasoline taxes, except in Alabama, California, Florida, Louisiana, North Dakota, Utah, Wyoming, and Hawaii; property losses from fire, theft, storm or auto accidents when you weren't wilfully at fault and you didn't get paid off for the damage; of your car for business, which includes the cost of gasoline, oil, grease, repairs, cleaning; entertainments for business purposes; subscriptions to professional journals; books, papers, and magazines bought for use in your profession; equipment, tools, and instruments used on your job; cost of work clothes and uniforms when not capable of taking the place of ordinary clothing.

You cannot deduct the following federal taxes unless paid for business purposes: telephone, telegraph, or transportation, such as train or bus; admissions to theaters or sporting events, or club dues.

Nor can you deduct the federal tax on jewelry, furs, cosmetics, estates, inheritances or gifts imposed by the government, states or cities.

You can deduct for medical expenses but only that part which exceeds 5 per cent of your income. Example: Jones' income, \$9,000; his actual medical expenses, \$900. But 5 per cent of his income is \$450, which leaves him only \$450 to deduct.

Even then you can't deduct an unlimited amount for medical expenses.

Here are the limits:

Taxpayer claiming only one exemption, his own, \$1,250; taxpayers

"In case war should break out, Socialists have the duty of interfering to end it promptly and to take advantage with all their strength of the economic and political crisis created by war to stir up as many people as possible and bring on the end of capitalist domination."

This, of course, is one of the cardinal tenets of the Bolshevik creed. Wherever there is trouble, Communism is to capitalize it by strong-arm methods. Obviously should Russia, mother of Communism, find herself at war, the Communists of all countries would be expected immediately to adopt the attitude suited to serve Moscow's interests.

In some cases that might mean merely helping to the party line propaganda. In others it might involve actual sabotage and obstruction through strikes to cripple a nation. In extreme circumstances it would mean actual armed rebellion against the government.

What started this avalanche of pledges to Moscow? There are various guesses. One is that it is calculated to counter the proposed North Atlantic Alliance among the Western Nations. In any event it's propaganda which clearly could be directed to two ends:

1. To strike fear in the chancelleries of the Western world.
2. To put the Communist parties of all countries on their toes—to prepare for contingencies.

What contingencies? Well, Moscow keeps saying the western powers, led by America, are preparing to make war. Maybe the Russians believe that, though I doubt it.

## Denmark Joins In Sending Envoy To Study Pact

Oslo, Norway, March 4—(AP)—Two Scandinavian nations braved Russian ire today by indicating a will to join the projected North Atlantic Defense Alliance.

Norway rejected a Soviet offer of a non-aggression pact and decided to join the Atlantic talks in Washington. Denmark is sending Foreign Minister Gustav Rasmussen to Washington Tuesday, evidently to talk over joining the negotiations, a procedure similar to that followed by the Norwegians. Final confirmation of Denmark's decision to join the talks is reported already to have been voted by the Parliamentary Foreign Relations committee. Sweden, for the time being, stands alone in shunning the talks.
