Conservationists Return From Tour Of Alabama Sectors

S. L. Daughtridge, district soil conservationist, W. C. Eagles, county soil conservationist, and B. C. Winchester, county agent, have returned to Pitt county from a trip to Evergreen, Alabama in the coastal plain section of that state.

During the trip the men studied the growth of re-seeding plants used for pasture land in Alabama and the possibilities of using some of the same varieties in eastern North Carolina.

Daughtridge said plans are being made to carry on experiments in Pitt county with the caley pea, button clover which will be used on dairy pasturage, and re-seeding crimson clover.

Accompanying the Pitt county men on the trip were R. B. Bailey of Edgecombe county, and R. Y. Bailey of Spartanburg, S. C., regional agronomist for the department of conservation.

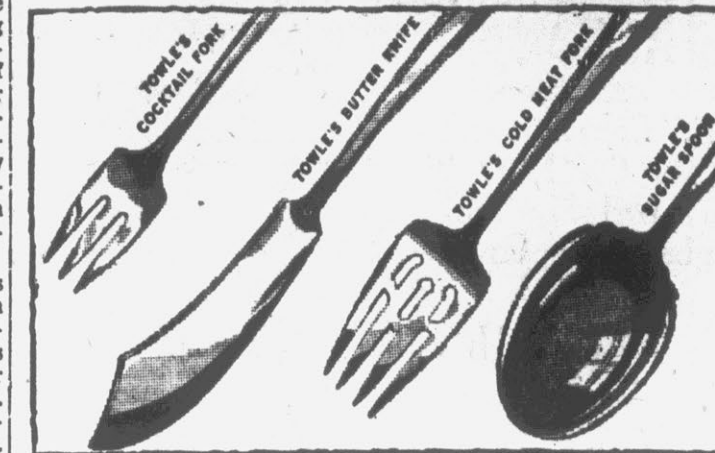

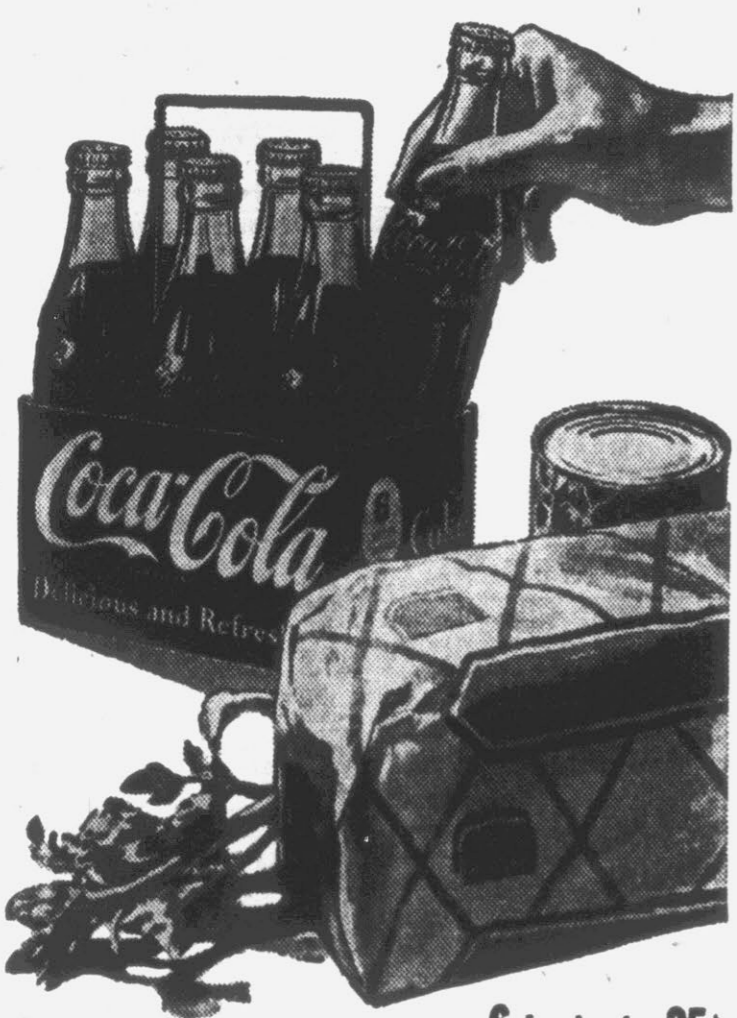

Will Study N. C. Paroles System
Raleigh, N.C., May 4—(AP)—Dr. T. C. Johnson said yesterday the state's "whole parole policy will be reviewed within the next few weeks."
The new paroles commissioner made the statement after he was sworn into office yesterday.
"I am in full agreement with the governor," Johnson declared, "that the policy of paroling prisoners into the charge of state officers and employees be discontinued."
Johnson, who succeeded Hathaway Cross, said "paroles now in force will be re-examined." The state now has 1,460 prisoners on parole.
Under the present policy, prisoners are eligible for parole after serving one-fourth of their sentence. At the end of that time their cases are reviewed by the commissioner.
Johnson said he was unable to say how many prisoners have been released in the past in the custody of state officials or employees. Other commission members said it was "just a handful."

Earning Profits
Raleigh, N.C., May 4—(AP)—North Carolina's idle cash is earning \$4.23 every minute, State Treasurer Brandon Hodges reported yesterday.
Under a law passed by the 1949 General Assembly, the state has invested \$182,315,369.55 in short-term, interest-bearing securities.
The invested money, earmarked for state services, is awaiting spending. Hodges said the invested fund is returning 1.22 per cent in interest for a yearly return of \$2,224,253.61.

Cannon Is Given Road Term, Fine
Asheville, May 4—(AP)—Vaughn J. Cannon, pictured as the good looking bad man of Asheville's racetracks, today faced a long road term and a heavy fine.
The dapper 38-year-old reputed "kingbee of gambling" here was convicted yesterday in police court. Substitute Judge Reed Kitchin adjudged him guilty of conspiracy to violate state gambling laws and violation of gambling laws. Cannon promptly appealed to Superior Court.
Judge Kitchin sentenced him to serve three and one-half years on the roads and assessed a \$5,000 fine. Appeal bond was fixed at \$10,000 which is an addition to the \$15,000 under which he already was at liberty.
The conviction ended the first phase of a nine-month war against alleged gambling and illegal activities in this mountain tourist center.
It began last August 7 with issuance of padlock orders against two dozen reputed gambling and liquor joints, most of them in the heart of town.

Brissie To Help Blood Program
Philadelphia, May 4—(AP)—A baseball star who himself underwent 23 operations and received 40 blood transfusions to save a war-shattered leg, is going to ask others to give their blood.
Lou Brissie, star southpaw of the Philadelphia Athletics, yesterday accepted an appointment as chairman of a recruiting drive among Philadelphia sports fans for donors of a new Red Cross regional blood center.
"Blood saved my life," Brissie said. "That is why I have offered my service to the Red Cross program."

Slays Wife And Shoots Self In Making Getaway
Wilmington, N.C., May 4—(AP)—Fred Q. Allen, 50-year-old carpenter, was in criminal condition at a hospital today after slaying his wife and accidentally shooting himself.
Coroner Gordon A. Doran said Allen shot his estranged wife, Addie, 36, after she refused a reconciliation. In fleeing over a barbed wire fence, Allen accidentally discharged his pistol and the bullet entered his temple.
The coroner said Allen went to the home of some in-laws to try to make up with his wife. She refused to talk with him as he called from a porch window. When Allen's son came on the porch and ordered his father away, Allen pulled out his pistol and shot his wife through the heart.

God bless America, where we have freedom of speech! Last week the guest speaker at the Rotary Club was a dialectics expert by the name of Paul O. Sampson, who outlined what we should and should not eat.

SLOWDOWN—For the ten months period, although revenue has held up, the rate of increase is far below comparable time for the past two years. In 1947 the increase was 30.24 per cent over 1946, while in 1948 it was over 1947. The current report shows increase of 9.05 per cent over last year. Analysis of these figures justifies another warning sign against expectations that revenue will continue to climb at the phenomenal rate during the immediate post war years. There is no cause for alarm, but there is positive reason to recognize that a leveling off process is going on.

ADVANCED—Several friends who came to Raleigh Tuesday to witness the swearing in ceremonies of nine state officials were disappointed. The ceremony was over before they arrived, because the hour had to be moved up. Originally set at 10, 11 and 12 o'clock all the oaths had to be administered before ten. That was due to the fact the supreme court convened at that hour and the justices were not available to administer the oaths. Somebody else could have done it, but the incoming officials had pride enough in their jobs to request that supreme court justices officiate. The constitution requires that the oath of office shall be administered to the governor either personally or in presence of any other officials authorized to administer general oaths. (It is recalled that Calvin Coolidge took the oath as president before his father, who was a Vermont justice of the peace.)

COMELY—Just after the swearing in of nine top flight officials, some of whom wouldn't take prizes at a beauty show, Governor Scott announced addition of two comely young ladies to his office staff. Mrs. Frances Reesman, former secretary to Dave Coltrane in the department of agriculture, will be the governor's personal secretary, succeeding Miss Myrtle Fleming, who moves over to the chief clerkship of the utilities commission. Mrs. Margaret Jackson, former secretary to Lawrence H. Fountain at Tarboro takes over the typist duties in the governor's office performed by Mrs. Gertrude Newman during the Broughton and Cherry administrations. Mrs. Newman also is moving over to utilities as secretary to Joshua James, one of the new commissioners. Prevailing sports capital square are the two old fashioned games of "fruit basket" and shuffleboard.

Around Capitol Square

UP AND DOWN—April revenue receipts were again ahead of totals for last April, but were not as much up as were expenditures by the state. General fund collections amounted to \$9,094,223, which was \$114,949 more than in April 1947. But—the extra 20 per cent for all state employee salaries, including teachers, means the state spent last month about a million and a quarter dollars more. It was estimated at the time the salary supplement was enacted that it would take about fifteen millions, of which something more than ten millions would come from the general fund, to cover the increase for the last nine months of the current fiscal year. So while collections were up, their ratio to spending was down.

NOT BROKE—This doesn't mean, however, that the state is broke or is currently running in the red. For the ten months of the fiscal year general fund receipts were up \$10,314,174 over the comparable period in 1948. The warning signals are out, however, in view of the drop in income, sales and beverage schedules. Income collections were off \$71,000 and sales tax, accepted as the best criterion for business trends, was off \$327,000 for the month. However, for the ten months since last July

It even imitates the mental quality called understanding, says Dr. H. M. Johnson, Tulane University psychologist.

More startling, water seems to have a very long memory.

The experiments to support this were made by Dr. N. E. Dorsey of the national bureau of standards. For 20 years Dorsey alternately froze and thawed samples of water enclosed in glass tubes. The water was pure and the tubes very clean, also sealed hermetically.

After a few freezings these water samples no longer froze until their temperatures dropped close to zero, fahrenheit.

In some cases one sample of water preferred a different temperature for freezing than the other samples. The largest difference between these preferences was nearly 20 degrees, fahrenheit.

Dr. Johnson says that scientists have known for a long time that non-living systems, such as water, can learn, remember and forget. But because this is usually slight and doesn't last long, psychologists have assumed that only living beings have memories.

He explains that the water samples did something very like learning when they lowered their freezing temperatures.

Their long memories were indicated by the fact that once the water samples had "learned" a low temperature, the lapse of time between freezing did not make them forget. Even a lapse of months failed to make a difference in the lower temperature.

"I have no objection," said Dr. Johnson, "to saying that the sample of water had come to understand its task. Those who do not like to say so, should recognize from Dorsey's experiments that non-living as well as living physical systems behave according to their past experiences, and thus should no longer assume that changes in learning behavior necessarily mean 'understanding.'"

Dr. Johnson made his report to the Southern Society of Philosophy and psychology.

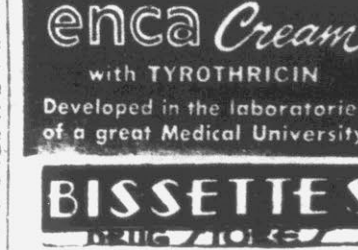

Faith And Hope Keep Father's Search For Son Going Strong

New York, May 4—What would you do if you were Harry Lepseiter?
Your only boy, Nathan, 21 went down with an American bomber in France in 1944. Officially, he has not been heard from since. By all the odds of war he is dead.
But you can't picture the boy dead. You feel he is alive. You figure he has amnesia or was badly hurt. Maybe he can't find his way

home to Brooklyn, where he was born.
So you decide to go to him. Your friends try to be kind. But in their eyes they seem to be telling you:
"Harry, the war's over. Your boy is dead. It's too bad. But lots of other boys died, too, you know."
Sure, you know lots of other boys died. But they weren't your boy. They weren't the kid you watched grow up to five feet, 10 inches of

rugged young manhood. Your friends probably are right, but you go to the newspapers. They try to help. But newspapers can't print the same story over and over again. They tell you they need "a new angle" to keep your story alive. But the only angle you know about is the sharp one inside you. It has been there ever since that falling bomber carried a piece of your heart down with it. So you keep on looking. You go

to France and talk to people there. Some of them think they saw your boy alive after his plane went down. But you can't be sure they aren't just telling you what you want to hear. They have no proof.
You write to Washington, letter after letter. But they have done everything they are supposed to do. And the War Department reminds you again that it was a big war. Lots of boys killed or missing.
You work a few days a week in a Broadway restaurant where you are a waiter. You lie awake nights at home in Brooklyn. You spend every cent you can get to keep the search going, mailing letters and your boy's picture here and abroad. You neglect your health. Your hair grows whiter. Your body gets thinner and a little more bent. Your 55 years get heavier.

Your wife, Dora, shares your faith. You picket together during an A.V. Forces Association convention in New York. It gets you publicity and pictures. Maybe it will get your story some place where it hasn't been before. Maybe Nathan will see it and remember.

You know you should give up. But you can't. The years are running out on you.
Then this week, a solid, dark-haired lad of 25, H. H. Tucker of (2344 Pennsylvania) Charleston, W. Va., shows up. He says he knew Nathan overseas. He claims to have seen him alive in a Belgian hospital two months after his plane went down.

There, you say to yourself, I knew he was alive. I knew it. But that was more than four years ago.
Tucker says his story has led the War Department to reopen its investigation into your boy's disappearance.

So you go back to your work in the Broadway restaurant. And back at night to your home in Brooklyn. And you keep on writing letters, asking questions, hoping... hoping... hoping.
What else would you do, if you were Harry Lepseiter?

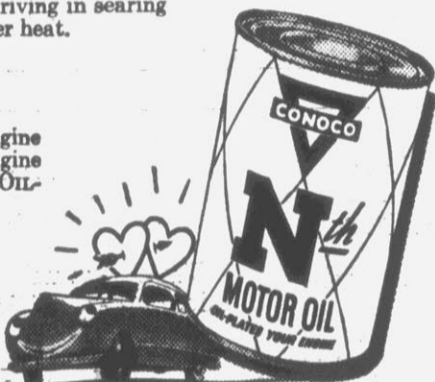

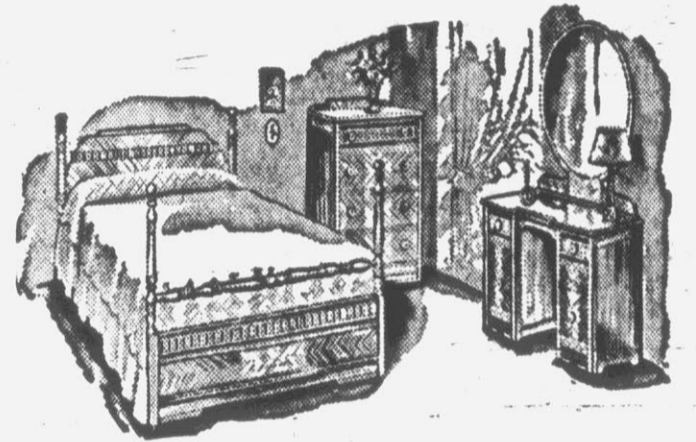

Bobby Harrison started on the mound for the Greenies and was relieved at the end of four and two-third innings after yielding six hits and six runs, and five walks. Jimmy Lewey pitched the next one and one-third frames allowing one hit and no runs, and Jim Pollard pitched the remainder of the game allowing three hits and two runs.

John Hanley with a homer and a double, Bob Johnson with a homer and a single and Walt McJunkin with a double and a single, led the 30-hit attack of the three Greenville hurlers.

Hal Rose went the entire dote for the Leafs giving up a total of nine hits. Bob Cohen with three singles in four trips to the plate led the Greenies attack.

Olympia Easily Captures One-Mile Derby Trial Run

Louisville, Ky., May 4—(AP)—A field of 12 shaped up today for Saturday's 75th running of the Kentucky Derby, with Olympia still the horse to beat.

The ease with which F. W. Hooper's colt won the one-mile Derby trial over six other contenders yesterday boded his Derby stock considerably.

Jockey Eddie Arcaro, who will ride Olympia in the \$100,000 added, mile and a quarter "run for the roses," brought his under the wire only a length and a quarter ahead of Calumet Farm's one-rushing Ponder, but had slowed him to almost a walk at the finish.

Arcaro wouldn't compare Olympia with his four Derby winners—Lawrin (1899), Whirlaway (1941), Hoop, Jr. (1945) and Citation (1948)—but said last night, "I wouldn't trade my chances with anyone" in Saturday's classic.

Eddie admitted that Olympia's race yesterday made him sure of one thing. "He certainly didn't run as if he was going back any," he grinned in the showers. After his narrow victory over Palestinian in the Wood Memorial, Eddie said he was worried that Olympia might be tapering off.

Noe pushed at any stage, Olympia ran the mile in 1:37 3-5, the same time hung up by Citation last year in winning the trial with the same ease. Citation is the only horse ever to win the trial ANP the Derby.

Greentree stable's Capot finished third in yesterday's trial, followed by Hooper's Ocean Drive, Mrs. H. J. Damm's Roundleer, Arthur P. Cotter's Pety Cotter and Calumet Farm's Deluxe. From the first to the last there was a 14-length gap.

Court Action Is Still Facing Leo

New York, May 4—(AP)—Leo Durocher, off baseball's griddle, resumed his role as manager of the New York Giants today but still faced court action charging him with striking a Brooklyn fan.

The tempestuous Giant pilot, after sweating out four days of an indefinite suspension, was cleared and reinstated yesterday in less than two hours before Commissioner A. B. Chandler at Cincinnati.

Chandler held there wasn't sufficient evidence to show that Durocher had "deliberately assaulted" Fred Boyen, a vociferous Dodger roofer, after the wild game at the Polo Grounds last Thursday.

"I am very happy about it all," Durocher said upon his return to New York. "I am very anxious to get back to work."

Durocher picks up the Giants' reins today from Frankie Frisch, who has been acting manager. The Giants play Pittsburgh in an afternoon game.

Durocher showed no concern over the simple-assault summons which Boyen's attorney promised would be served as quickly as possible. The summons is returnable in upper Manhattan court Monday.



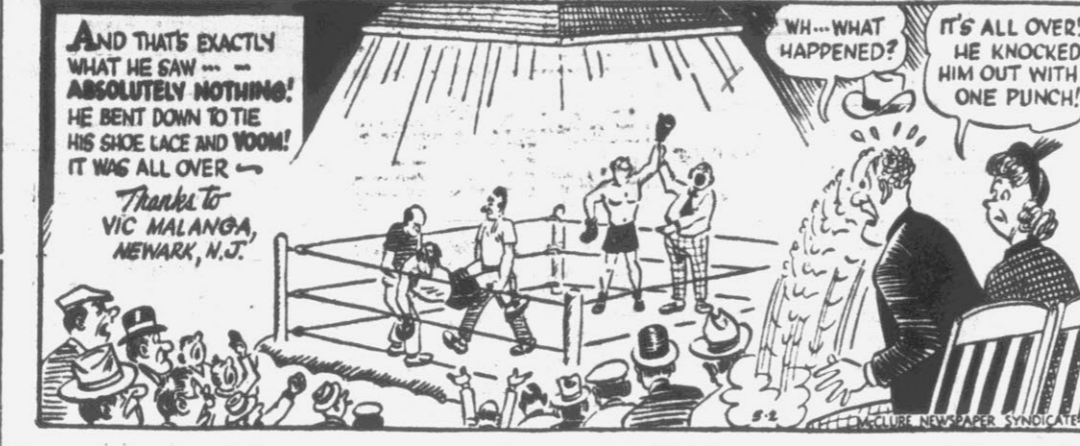

Mrs. Geneva Willoughby, assault with a deadly weapon, was given six months in the women's division of State Prison.

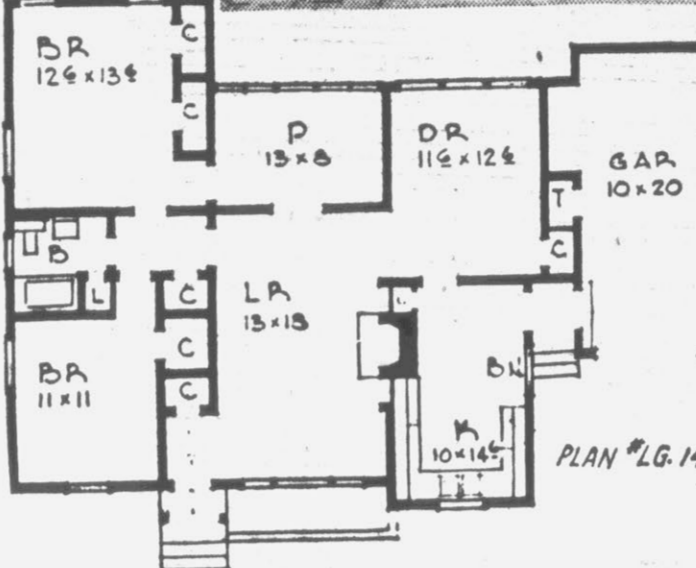
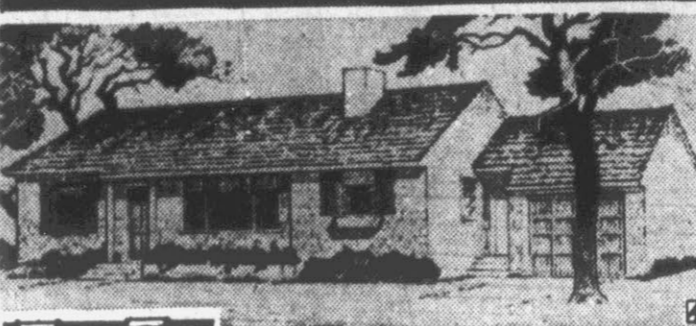

and Dr. Skala told the Overseas writers Club in Washington that the government's foreign exchange resources have dropped from about \$400,000,000 to some \$28,000,000. He predicted that the situation would become serious unless the country gets help soon.

So the Moscow controlled Prague government sends its envoys to Washington to ask for help. The significance of America's attitude is clear enough. She has no intention of weakening her position, or that of her allies, by strengthening a communist bloc which is making war on all non-communist countries.

Indications are that the answer "No" will apply not only to Czechoslovakia but to other communist satellites. Yugoslavia, which is at loggerheads with Moscow, apparently is no longer regarded as in the same category. Diplomatic authorities in Washington state that the Export-Import Bank is giving active consideration to a plea from Belgrade for a \$50,000,000 credit.

Seeing they were losing out, the Trumanites yesterday tried to get through a compromise bill, a little stronger than their first one. It got knocked aside in a hurry.

Then the House, with Republicans and Southern Democrats joining forces, voted for the Wood bill.

This was a temporary vote. The final vote was expected today. The vote for the bill yesterday was 217 to 203.

It's possible that overnight the Trumanites could get some of the opposition to swing over to their side today, but that seemed unlikely.

So by nightfall the final and deciding vote on the Wood bill was expected. This doesn't finish the labor bill.

If the House passes it, it doesn't become law unless the Senate also approves it. The Senate isn't ready to vote on a labor bill yet.

What it finally will vote for is anybody's guess. But it probably will be a lot tougher than the Trumanites or labor wanted.
