Vandenberg Asks Close Check On Atomic Exports

Would Have Military Approval On Shipments Of Isotopes And Material

Washington, June 10—(AP)—Senator Vandenberg (R-Mich) called today for a close military check before atomic materials are sent abroad, "even to the friendliest of countries."

The Michigan senator said he wants to be sure that the military liaison committee approves in advance Atomic Energy Commission decisions such as that which sent radioactive isotopes to a research division of the Norwegian military government.

"The point is not whether a country is friendly to us," he told a reporter.

The liaison committee is composed of two high ranking officers from each of the Army, Navy and Air Force.

Chairman David E. Lilienthal of the Atomic Energy Commission insisted during an exchange with Vandenberg yesterday that the fact Norway is a friendly country had some bearing in the commission's decision to send it the isotopes.

Lilienthal was appearing before the Senate-Atomic Energy Committee as it continued its hearings on charges by Senator Hickenlooper (R-Iowa) of "incredible mismanagement" by the commission chairman.

The congressional group met behind closed doors again today to decide how to carry out the inquiry. Hickenlooper wants to present evidence that certain key AEC employees—whom he doesn't want to name publicly—have been questioned about their loyalty, associations and character.

The committee has failed twice to decide how the Iowan can go about this, since Lilienthal has protested that any such method identifies the person concerned to his co-workers.

Chairman McMahon (D - Conn) said the worker named in Hickenlooper's "Case A" of this type—an official on whom the FBI made a 50-page report after an investigation—has asked to be heard publicly.

Meanwhile, Lilienthal had renewed assurances that President Truman thinks the atomic program is in good hands.

Mr. Truman told his news conference yesterday that the testimony brought out before the Senate-Atomic Energy group hasn't changed his high opinion of Lilienthal.

In response to questions, Mr. Truman added that some of the recent investigations into disloyal and subversive activities are motivated by a natural desire for headlines.

Atomic Worker Says Scientist Red Recruiter

Washington, June 10—(AP)—Robert Davis, a wartime employee of a West atomic laboratory testified today he was recruited into the Communist party by an atomic scientist, Giovanni Rossi Lomanitz.

Davis, now of New York, was a witness before the House un-American Activities committee. He said he attended perhaps two or three Communist meetings while he worked at the Radiation Laboratory at the University of California at Berkeley. He said Lomanitz attended meetings with him.

Lomanitz himself, who was also called as a witness, had refused, on grounds he might incriminate himself, to say whether he ever was a Communist or ever tried to get anyone into the Communist party.

Aldermen Increase Tax Rate On City Property

Agree To Fix Tentative Tax Rate Of \$1.50, An Increase Of Twenty-Five Cents On \$100 Property Valuation For Fiscal Year

At a preliminary meeting of the hold-over members of the Board of Aldermen and the new aldermen and Mayor-elect W. S. Stafford at the City Hall last night it was agreed to fix a tentative tax rate of \$1.50 for the city of Greenville, an increase of 25 cents on the \$100 property valuation over the fiscal year 1948-49. Mayor Pro-Tem L. M. Buchanan presided.

W. S. Stafford, mayor-elect of Greenville, in an interview today said the proposed 20 per cent increase in the city's tax rate is justified by necessity. Increased revenue will provide funds to purchase new equipment and to take care of numerous improvements on buildings and to procure things not available during the war. Stafford said the washout on East Second Street needs to be repaired; the fire station and city hall need repairs inside and outside; fire alarm boxes are needed in Hillsdale, across the river and in the eastern section of the city; and additional equipment for garbage disposal is needed. "It is my hope to give the city a progressive and economical business administration," the mayor-elect added.

It was stated that the tentative tax rate was fixed so that prepayment of city taxes could be made this month. The law provides a two per cent discount for taxes prepaid during June.

The opinion of the aldermanic body is that after a survey of last year's property valuation and bud-

Peak In Excitement

Week Has Seen Hunt For Communists, Spies, Fellow Travellers, Etc., Build Up To New Crescendo; Innocents Will Be Hurt; Concern Over Communism Is Mounting

Washington, June 10—(AP)—This country has reached a post-war peak in the excitement over the hunt for Communists, spies, fellow travelers, Russian sympathizers, subversives and security risks.

At least half a dozen things have been happening this week around the country in connection with Communism, spying, fellow-traveling, or subversion of one kind or another.

This peak has been slowly building up over the past few years, ever since the war ended and relations with Russia, friendly during the war, fell to pieces.

The excitement is being fanned by events in Congress and court trials as more names are brought, rightly or wrongly, into the present crusade against Communism.

A number of innocent people will be hurt in this spreading search, but the concern over Communism is so great the end is not in sight.

Here are just six of the things that have been happening:

1. In New York 11 Communist party big-shots, all admitted Communists, are on trial on a charge of teaching conspiracy to overthrow this government by violence. This

has been going on for months.

2. In California the state senate un-American Activities committee this week listed a number of prominent people, including movie stars and writers, as having "followed or appeared some of the Communist party line program over a long period of time."

3. In Washington Congress' House committee on un-American Activities has been investigating alleged Communist spying and activities in general, with more names being made public every day.

4. Here in Washington, too, a Congressional committee is holding an open hearing on charges by Senator Hickenlooper, Iowa Republican that David E. Lilienthal, chairman of the atomic energy commission, has been guilty of "incredible mismanagement."

Lilienthal's management is under fire but Hickenlooper keeps raising questions that spread the odor of Communism over the AEC's atomic program in one way or another.

5. So-and-so who worked on the program a good security risk? How

One Of Escaped Convicts Caught In Roanoke, Va.

Fred Martin, Fugitive From Pitt Road Gang, Captured; More Escapees

Raleigh, N. C., June 10—(AP)—The State Highway Patrol reported today that one of two convicts who escaped from a Pitt county road gang Wednesday had been recaptured.

Freddie Martin, 26, was arrested today in Roanoke, Va., Major J. R. Smith, patrol executive officer, reporter.

Ed Smith, 49, who joined with Martin in overpowering a prison guard, has not yet been taken. Smith added, Martin was arrested in a 1942 model automobile which was stolen from an Oxford used car lot, Smith said.

Another search was underway in the Lee county area after two other convicts made their getaway from a Chatham county gang yesterday. Prison officials said they overpowered a truck driver and took his pistol.

The Chatham fugitives were listed by prison inspector Kyle Matthews as Ralph Johnson, 26, of Wake county and Hubert Watts, 26, of Columbus county.

Matthews said they were armed with a pistol and called them "right tough boys." He added that Watts has had to be disciplined frequently for breaking prison rules.

The two stole a car at Bonlee, Matthews said, and were seen last near Lemon Springs church in Lee county.

The Pitt escapees, overpowering a guard, took his shotgun and acquired two pistols, and held up a rural mail carrier and took his car Wednesday, had stolen two more automobiles.

The mail carrier's car was found abandoned near Kingston Wednesday night. Another car they stole at Kingston was found yesterday at Oxford, where it was thought they took another car.

Sees Extension Of Crop Control

Raleigh, N. C., June 10—(AP)—Possibility of an extension of crop controls to farm products other than tobacco and peanuts was seen by a Production and Marketing Administration official here yesterday.

Horace Godfrey, PMA state program director, told the Farm Hands Club that large surpluses of cotton and wheat are in prospect this year and that production control measures may be necessary next year. He also foresaw the possibility of reducing peanut acreage and quota restrictions on commercial Irish potatoes.

Name-Calling By Sen. Eastland

Washington, June 10—(AP)—In an angry scene, Senator Eastland (D-Miss) dismissed C. B. Baldwin, who was Henry Wallace's campaign manager, from the witness chair of the Senate hearing today and called him an S. O. B. in the full version.

Baldwin had refused to answer a question whether or not he is or has been a member of the Communist party, and had accused Eastland of "fighting against Negro rights."

Senate-House Politeness Strained Over Privileges

Washington, June 10—(AP)—The traditionally polite relations between the Senate and the House were strained today by House criticism of such senatorial privileges as free mineral water.

Resentment over Senate "miscellaneous" expenses including free shaves, haircuts and daily miner water rations broke into the open yesterday during House debate on the annual bill for financing congressional activity.

The \$62,200,000 measure cleared the House without alterations but not before the criticism was raised. And not until the House had voted an additional clerk and an extra \$500 expense fund for each of its members.

Not in years have House members spoken so critically of their colleagues at the other end of the Capitol.

"It's about time that we began to ask some questions and lay the cards on the table," he shouted.

Nobody asked any questions though and the bill sailed through the House by a voice vote and sent to the Senate.

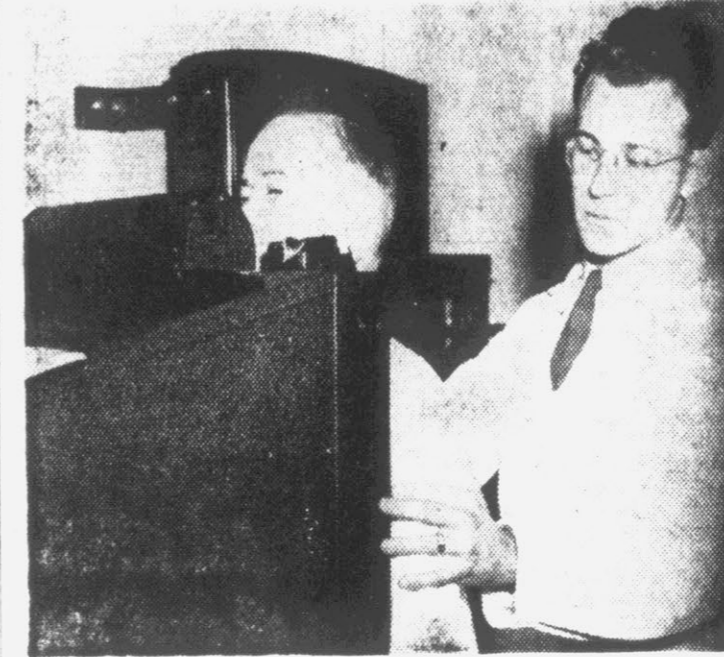
Will Push Cut For ECA Funds In Face Of Hint

Layoffs Start

New York, June 10—(AP)—A series of railroad layoffs developed today with the approach of John L. Lewis' one-week coal mine shutdown due to start Monday.

A spot check of railroads showed well over 10,000 layoffs definitely scheduled and others likely, with indications the number would soar if the United Mine Workers should be out longer than a week.

Tucker Indicted On Fraud Count

Chicago, June 10—(AP)—Preston T. Tucker, promoter of a novel automobile that never got into mass production, today was indicted on charges of mail fraud. Seven associates were indicted with him.

A 31-count indictment was returned before federal judge John P. Barnes by a grand jury which spent 12 weeks since Feb. 12 investigating affairs of Tucker and his corporation.

Maximum possible penalties for conviction under the indictment would amount to 155 years imprisonment and \$60,000 in fines for each of the eight defendants.

The counts are 25 of mail fraud, five of violating regulations of the securities and exchange commission and one of conspiracy.

Other defendants with the 46-year-old president and director of the Tucker corporation are:

Harold A. Karsten, 58, alias Abraham Karatz, North Hollywood, Calif., former Minneapolis lawyer.

Floyd D. Carl, 60 Chicago, former investment banker, who floated the public issue of stock in the corporation.

Robert Pierce, 50 Detroit, formerly associated with Briggs Manufacturing company of Detroit, and former director and treasurer of Tucker.

Government Near End Of Its Case Against Hiss

New York, June 10—(AP)—The government, nearing the end of its case against Alger Hiss, called more witnesses today in an effort to bolster its second charge of perjury against the former State Department official.

This second and last charge is based on Hiss' denial before a federal grand jury that he saw Whitaker Chambers after Jan. 1, 1937, until the current espionage probe started.

Chambers, self-styled former courier for a prewar Soviet spy ring, ended seven days on the witness stand in federal court yesterday and the government then called 17 witnesses to support some major points in his accusations against Hiss.

Most of their testimony concerned the first count in the perjury indictment—based on Hiss' denial to the grand jury that he gave Chambers secret government data to be passed on to the alleged spy ring.

Mystery Plane Over Shanghai

Senate Warms Up For Labor Fight

More Denials To FBI Report In Coplon Spy Trial

Soviet Embassy Silent, But Protests Come From Barber And Editor

Washington, June 10—(AP)—Reports from the Coplon espionage trial that the FBI checked on (1) the Russian embassy, (2) a barber at a rocket testing range and (3) a Russian language newspaper produced protests today from the barber and the paper's editor, and silence from the Embassy.

The defense in the Judith Coplon case meanwhile served notice that reading of 12 FBI reports that have come into the trial will continue. These are the dozen that the government tried particularly to keep out.

Already parts of the reports have stirred up sensations aside from the question of whether Miss Coplon pilfered government secrets while working in the Justice department.

One of the reports read to the jury yesterday mentioned 19 confidential informants, all described as reliable, as watching over Communist activities in Washington, including what went on in the Soviet Embassy.

"T-19," one of the informants, was identified in the report as a member of the Communist party and a member of the Southern conference on human welfare. ("T-19" called the conference "a transmission belt to reach the masses," and told the FBI "all officers are controlled by the Communist party.")

Another report quoted a "reliable" informer as saying a barber at the White Sands proving grounds in New Mexico, where guided missiles are tested, was expected to be able "to get photographs and other information" for transmission to the Russian Embassy in Mexico. Barber was identified as Eugenio Chavez, also known as Eufenio Garcia.

In El Paso, Chavez said that "I never spied on anybody or tried to be a spy." He described himself as a patriotic American who had no idea how his name got into the papers. He said he has left Wing sympathies and subscribes to the Communist newspaper, the Daily Worker.

Still another report read to the jury discussed the San Francisco Russian language newspaper Novaya Zarya, published by Gregory T. Soohoff. This report said the FBI had received "numerous unsubstantiated allegations" that the newspaper was subsidized by the Soviet government.

Soohoff commented at San Francisco that this was "a great injustice." He said his paper has not been biased in its presentation of news and declared that it has not received "a single cent" in subsidy from anyone.

The report dealing with Washington Communist Activities mentioned that the FBI was able to obtain a copy of a Communist party member's application for employment at the Soviet Embassy. One informant said Communists here receive instructions from attaches of the Soviet Embassy and the Bulgarian legation.

The Crown Is A Bond

Socialist England Clings To Traditional Ceremony Of Homage To King-Emperor; A Conflicting Picture; A Bond Of Loyalty In The Commonwealth; Significance

This is an odd though likeable old world of ours.

Socialist governed England paid homage to its king-emperor yesterday amidst the splendor and pomp of by-gone days.

The occasion was the celebration of His Majesty's 53rd birthday—an event observed throughout the commonwealth and empire.

King George, uniformed in scarlet and escorted by household cavalry, rode through cheering lines of his subjects to the parade ground for the ceremony. There he took the salute of the royal guards in their scarlet and blue uniforms and tall bearskin headdress. A charming touch was added to the picture by Princess Elizabeth, robed apparent to the throne, who rode a spirited horse side-saddle.

Well now, just how does all this imperial display fit in with socialism—or does it? Do we have an anomaly here, or don't we? Why this reverence of the king? I put the question to an Englishman in New York, and for a minute had him stopped.

"Why," he said, "I never thought of it like that before. I guess it's because the king is the same to us

General Debate On Changing Of Taft-Hartley Law Nears End; Consideration Of Amendments To Truman Administration's Bill For Taft-Hartley Repeal

Washington, June 10—(AP)—The Senate warmed up today for its hottest labor fight—over how to handle strikes that could cause national emergencies.

General debate on changing the Taft-Hartley Act neared an end, to come after speeches by Senators Humphrey (D-Minn.), Murray (D-Mont.), and Neely (D-W.Va.). Next will come the one-by-one consideration of amendments to the Truman Administration's bill for Taft-Hartley repeal.

"National emergency" amendments may be taken up Tuesday and some senators say this battle may continue the rest of next week.

That also happens to be the week John L. Lewis has set aside for a coal strike. With coal supplies high, a one-week stoppage isn't considered a national emergency. But it brings sharply to the attention of Congress the possibility of a longer strike beginning in July.

President Truman was asked yesterday at his news conference about the work stoppage. Lewis has called for the United Mine Workers.

The President catalogued Lewis as a headline hunter, and said also that this is not supposed to be a strike but a sort of special sitdown. He said he understood that its object was to use up coal and put the miners in a better bargaining position.

On one thing, the President and Lewis are agreed: They want an end to the Taft-Hartley provision for court orders to stop national emergency strikes. Lewis has been heavily fined under this provision in the past. Mr. Truman has expressed the view that the President already has inherent powers to deal with an emergency.

As much as Lewis hates the whole Taft-Hartley law, however, his strategy is calling a "sitdown" during debate on the law's repeal has dismayed some of the lawmakers who are for repeal. Likewise, it has encouraged T-H friends who say that the timing is bound to help their effort to preserve much of the law.

The Administration repealer, for which Mr. Truman expressed continued support, does not authorize either injunctions or government seizure of plants to delay strikes in vital industries.

Senator Taft (R-Ohio) told reporters today that he is still just as strong for injunctions as he ever was, although he doesn't know what whether the Senate authorizes plant seizure.

A group of Democrats and Republicans who have introduced a series of compromise amendments to the Administration bill seemed divided and uncertain over the wording of their emergency provision. Senator Morse (R-Ore.), chosen to introduce the final version of this amendment on behalf of the group, still deferred action.

AMA Boosts Voluntary Health Insurance Plans

Atlantic City, June 10 —(AP)—The American Medical Association's fight against enactment of compulsory health insurance legislation crystallized today in a program designed to encourage the expansion of lay-sponsored medical care plans.

The program was unfolded yesterday when the AMA's house of delegates — policy-making body of the organization — adopted a set of 20 principles for lay-sponsored plans seeking AMA approval.

Dr. James R. McVay of Kansas City, chairman of the AMA's council on medical service, said the action was "a positive, decisive, progressive step" toward the expansion of voluntary health insurance.

Heretofore the AMA has recognized only those medical care plans sponsored by its federated county and state groups. It has been indifferent to numerous plans operated by labor, farmer, consumer cooperative and other groups—including city governments.

Medical care plans cover doctors' fees for stipulated services but do not cover hospital expenses. Hospitalization plans, such as the AMA-sanctioned Blue Cross, do not cover doctors' fees.

McVay said there are 171 voluntary health plans now operating in 43 states, exclusive of 92 sponsored by medical societies. He said his council has met with leaders of lay groups in the past two years in an effort to formulate a work agreement between the AMA and the existing voluntary health plans.

From these meetings, McVay said developed the 20 principles adopted here yesterday. These specify that medical care plans must be non-profit making, comply with AMA's principles of medical ethics be adequately financed, be devoted exclusively to health service, have high quality personnel and employ only licensed physicians.

McVay emphasized the AMA itself would not sanction medical care plans without prior approval by county or state medical societies.

He said the 20 principles will be guides for the state and county societies in recommending approval or disapproval by the AMA of medical care plans in their areas.

Air Force Plans Medical Branch

Pope Air Force Base, N.C., June 10—(AP)—General Hoyt S. Vandenberg, chief of staff of the United States Air Force, announced today the organization of a United States Air Force medical service.

Its establishment within the department of the Air Force follows directives issued May 13 by Secretary of Defense Louis Johnson to provide the Air Force with its own medical service and to establish a medical service division within the office of the Secretary of Defense.

The new Air Force medical service was planned to provide better flexibility and control for Air Force medical services and requirements. No duplication is expected under the new organization since the Air Force previously had a medical service, which, however, was under Army control.

Major General Malcolm C. Grow, surgeon general of the U.S. Air Force, has been elevated to an organizational and functional position directly under the Air Force chief of staff.

General Vandenberg said Air Force plans are designed to correct the major objections of professional people to a career in the armed forces.

WASHINGTON LETTER

By JANE EADS

Washington—Record millions of Americans will hie themselves on vacation jaunts to their national parks and forests this year.

The National Park System estimates that more than 30,000,000 visits will be paid to its 174 areas, which cover 20,817,000 acres throughout the country. The Forest Service estimated that the recreational areas and facilities in the 151 national forests will receive more than 27,000,000 visits.

If one of the more widely known national parks is your destination, the National Park Service suggests you would be smart to make reservations for lodging well in advance or you may have to sleep in your car.

In most of the national parks hotel, lodge, housekeeping cabins, cafeterias, bus transportation, saddle horses and similar services are provided by concessionaires operating under contract with the government and under supervision of the park service.

Rates for accommodations in the national parks compare favorably with those charged at other resorts or in the vicinity. This year the National Park Service says motor transportation, saddle horse and lodging rates will not be much more than last year, with the main cost increase in meals.

In addition, free public camp grounds are operated by most parks. Visitors may bring their own equipment and camp there. Each camp ground has fireplaces, table and benches on individual campsites.

However, if you are unconditioned to roughing it, hotel rooms are as low as \$5.50 a day American plan or as high as \$14.

As for the national forests, it has been a tradition to provide public

One-Time Army Commander Is At Work Bench, Happy In U. S.

Culver City, Calif., June 10—(AP)—A one-time commander in chief of the Lithuanian army goes to work today assembling airplane hydraulic valves in a little back shop here.

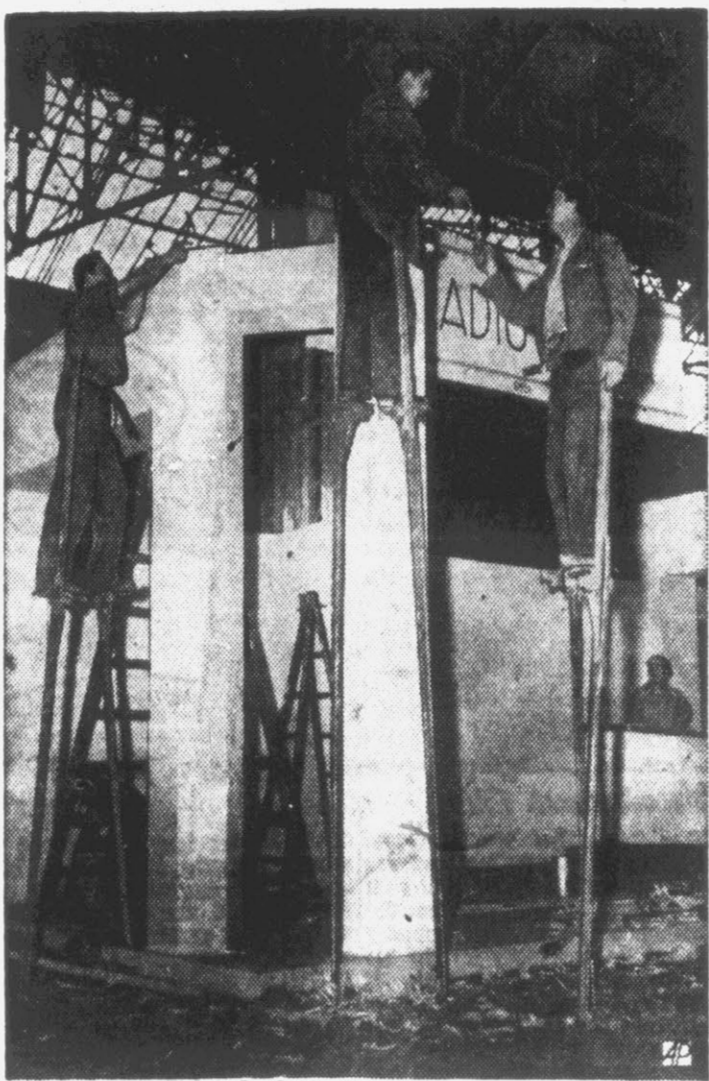
But Gen. Stays Rastikis says he is "happy as a bird" behind a work bench at the Hartwell Aviation Co. The 53-year-old general starts work at the bottom less than a month after he and his wife, Helen Marie, 46, arrived in New York as displaced persons. They were sick and exhausted after nine years of fighting, hiding, running and imprisonment at the hands of the Russians and Germans.

Underground reports say that one of their three daughters is dead. From the other two, also whisked away to Siberia, has come no word. Mrs. Rastikis, arrested with the girls, was imprisoned but eventually released to rejoin her husband in the Lithuanian underground.

How the general came to work here is a story in itself. Clark Hartwell, the aviation company owner met the Rev. Joseph Concius, president of the United Lithuanian Relief in America, at Lake Arrowhead Calif. Father Concius asked Hartwell if he could use a good man Hartwell said "sure" and the "good man" turned out to be Gen. Rastikis.

Through an interpreter the general says he is pleasantly impressed with America except for the automobiles—"there are so many of them it is frightening."

The general, who hopes some day to write about his plight as a displaced person in Germany, began his military career as a rear rank private in the Czarist army. He was a line lieutenant when the Russian revolution developed in 1917. The Czarists were demobilized. He returned to his native Lithuania to join its army. Trained in Germany, he fought with the Lithuanian army against Russia in 1918.

Federal-State Drive Against Syphilis Planned

New York, June 10—(AP)—A coordinated federal-state drive against syphilis will take place July and August in 27 states and the District of Columbia.

Charge Breaking Of Sanitary Code

Chicago, June 10—(AP)—No names have been mentioned but the National Collegiate Athletic Association has accused 16 of its member schools as not acting in compliance with the group's much publicized "sanitary code."

Prof. Clarence P. Houston of Tufts College, chairman of the constitution compliance committee, said that the schools will have until July 1 to signify whether they intend to comply by Sept. 1.

He said if the offenders did not comply with the sanitary code they face expulsion at the annual meeting in New York next January. He added there also were 11 institutions on the "doubtful list" and they will be investigated further before action is taken.

The violation against the schools affected is giving aid to athletes over the rigid limits prescribed in the N.C.A.A.'s sanitary code which went into effect Jan. 10, 1948. A two-thirds vote of the 270 members of the N.C.A.A. would be necessary for suspension.

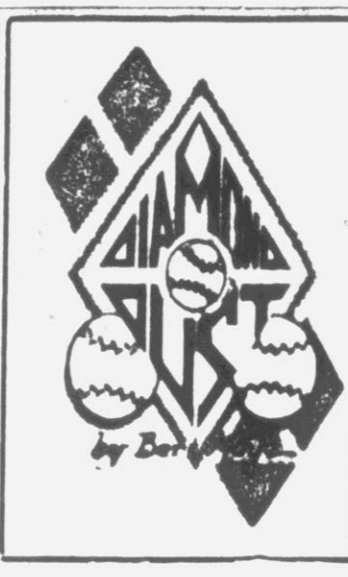

With fan attention focused on the St. Louis Cards' sizzling spurt in the National, the hustling Tigers have been giving Casey Stengel a rough time.

Stengel's Yanks took a 6-game lead into Detroit after Sunday's split in St. Louis. Now the margin is 3 1/2 and sinking fast. Red Rolfe's Tigers have won eight of their last 10 games.

Art Houtteman, a young man who nearly lost his life in a serious auto crash in Lakeland, Fla. in spring training time, did the latest job on the Yanks—a six-hit, 9-5 Tiger triumph. It was the Yanks' fourth straight loss, three to Detroit.

Last year Houtteman, the tough luck kid, won only two and lost 16. He dropped his first eight starts. Already he has a 3-1 record for '49 with prospects of a fine season.

With Houtteman, Virgil Trucks (8-3), Hal Newhouser (6-5) and Freddie Hutchinson (3-2) taking a regular turn, the Tigers rate as real pennant contenders.

Hoosier Evers, who was shoved over from center field to left to make room for Rookie Johnny Groth, was a one-man team yesterday. He batted out a triple, double and three singles for five hits, scored three runs and drove in two more.

Connie Mack's Philadelphia A's also closed in on the Yanks, securing third place, five games out of first, by edging the Chicago White Sox, 1-0, in 12 innings. Dick Fowler won a tight duel with Bill Wright on a walk, Luke Appling's two-base error and an infield grounder.

Dick Starr, a non-winner who has lost seven, finally made the victory column, 11-0, as the St. Louis Browns made merry with Ellis Kinder, Chuck Stobbs and Frank Quinn. It was the first shutout thrown by a Brownie pitcher this season and the Red Sox's seventh defeat in their last nine games.

Brooklyn clung to that half game lead in the National by subduing Chicago, 9-5, while both St. Louis and Boston won to remain right on the Dodgers' heels.

Ralph Branca was unable to stand the prosperity of a 9-0 lead. He was knocked out in the eighth when the Cubs scored five times. The Dodgers wrapped it up early with a six-run blast in the second that routed their old jinx, Lefty Johnny Schmitz.

Howie Pollet, back in his 1946 form, whipped the slumping New York Giants with six hits, 4-1, as the Cardinals made it six straight wins and 15 out of 17. Pollet, with five straight victories, might have hurled the third St. Louis shutout of the series sweep but for an unearned run in the sixth following Eddie Kazak's error.

Bob Hall, a Johnny-come-lately in Billy Southworth's starting rotation, turned back Cincinnati with seven hits as Boston romped home with a 10-2 decision. It was Hall's second start and first since May 20. Bill Salkeld hit the only homer of the game, in fact the only one of the day in the National.

The Phillies squeaked past Pittsburgh, 4-3, in 188 innings, the longest game in the majors since 1946. Del Ennis' single, a double by Andy Seminick and Jack Mayo's fly ball broke it up in the 18th, after Murry Dickson had hurled 11 scoreless relief innings.

Dickson, who has trouble hitting the winner's circle since he was purchased for \$125,000 from St. Louis, suffered his ninth loss despite the fine effort. Jim Konstanty shut out the Pirates in the last nine innings to earn his first victory of the year.

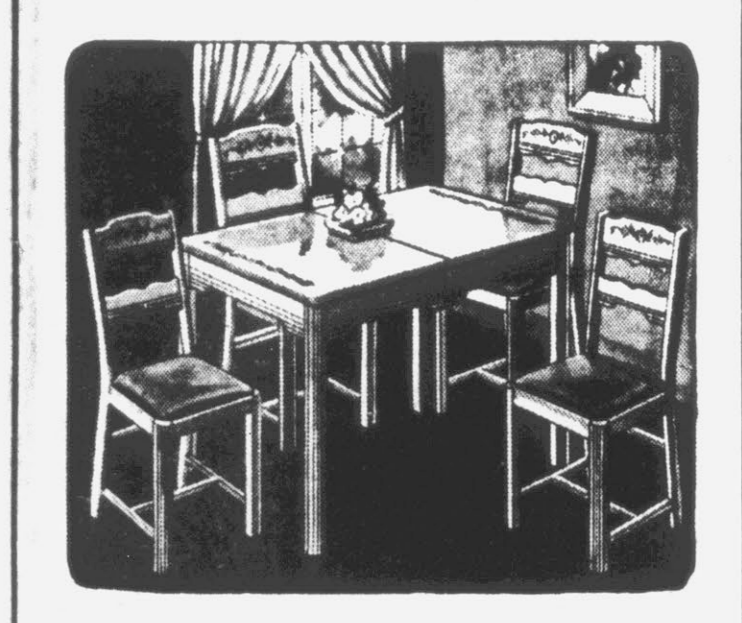

5 In New York Alger Hiss, one-time state department official, is on trial on a charge of perjury, the result of his denial of charges made against him before a grand jury by Whittaker Chambers, who admits he was once a Communist-Russian spy.

Chambers accused Hiss of handing over state department secret papers to him, Chambers, himself, on the stand during the trial has admitted he has committed perjury seven times.

But as the case drags on, other names besides those of Chambers and Hiss are brought into it, as links of a spy ring here back in the 1930's.

6. And in Washington one of the biggest explosions has come out of the trial of Judith Coplon, former justice department employee, being tried on a charge of giving government secrets.

A flock of Hollywood stars and others, people Miss Coplon probably never met, have been dragged into the case not as spies, but as people unidentified informants of the FBI accused of being Communists or fellow-travelers.

This extraordinary thing—public exposure of secret FBI files—happened because the FBI said Miss Coplon had information about those files in her pocketbook when she was arrested for spying.

This was all secret information, the FBI said. The trial judge said it had to be made public to Miss Coplon could have a fair trial.

(Continued from page one) get expenses and an anticipation of extra demands to be made on the Board of Aldermen for the coming year, it was wise to fix the rate at \$1.50 for the fiscal year 1949-50.

During the discussions it was stated that if the tentative tax rate is too high, it will be better to make refunds to those who prepay their taxes and to have to collect the difference.

A summary of the \$1.50 tax rate for the coming year is: General fund, 93c; city debt service, 18c; school debt service, 14c (an increase of 1c over last year); school maintenance (voted by the people), 25c.

A summary of last year's \$1.25 tax rate is: General fund, 87c; school debt service, 13c; school maintenance, 25c.

The tax valuation of property in the city in the fiscal year 1948-49 was \$16,655,524. The valuation for the fiscal year 1949-50 is \$17,745,428 an increase of \$1,089,904, a city official stated.

Mayor-elect W. S. Stafford and the recently elected aldermen will be sworn in at the City Hall at noon on July 1. Stafford succeeds J. H. Boyd, Jr., who has been mayor four years.

Hold-over aldermen are Heber Tripp, C. B. Mayo, L. M. Buchanan, James E. Collins and J. Ed Waldrop. New aldermen are R. E. Rogers, W. M. Pollard, Dal Cox and "Yank" Howell.

(Continued from page one) kings. However, in the commonwealth conference in London at the end of April someone had a brain-wave, and India agreed to accept the crown as "the symbol of the free association" of the independent commonwealth and, as such, the head of the commonwealth.

Thus the crown still continues to be the bond that holds the commonwealth together.

Two Referendums

On July 23 farmers of Pitt county who have an interest in a tobacco crop will go to the polls to vote in two referendums which will affect their crop next year.

Wyatt Highsmith of the local production marketing office said today farmers in the state will decide in the referendum whether there will be tobacco acreage control for the coming season, or the next three years. Farmers will have three choices on the ballots: marketing quotas for tobacco in 1950, 1951 and 1952; marketing quotas for 1950 only; or no marketing quotas for tobacco.

The last tobacco quota referendum was held in 1946 when farmers of the state adopted the quota system for 1947, 1948, and 1949.

On the same day the Tobacco Associates, Inc. will have a referendum for the farmers to decide whether or not they will extend a levy of 10 cents per acre on tobacco to furnish money to be used to expand the sale of American leaf in foreign markets.

New Date Fixed For Institute On Communism

An institute on "Communism as a Threat to American Democracy" sponsored by the social-studies department at East Carolina Teachers College and originally announced for June 15, will take place on Thursday afternoon and evening June 16, according to an announcement by Dr. A. D. Frank, director of the department.

The afternoon meeting on Thursday will begin at 3:30 and the evening program and dinner meeting will take place at 6:30 in the college dining hall. Speakers will be Dr. Clyde A. Erwin, state superintendent of public instruction in North Carolina; the Rev. Maurice Tew of St. Gabriel's Catholic Church Greenville; and Dr. Frank. Discussion will deal with the menace of Communism to democratic government, to religion and the church, and to education.

Potato Worms In Tobacco Plants

Assistant County Agent Sam J. Weeks yesterday reported finding potato tubular worms eating tobacco plants in a small portion of a field on Walter Alres farm in the Bethel section of the county.

Weeks said the potato worms usually are found in potato storage bins, and yesterday was the first time he had ever heard of such worms attacking tobacco plants. He stated that the damage to the tobacco plants on the Alres farm was negligible.

The worms had eaten portion of the stems and part of the web of the leaves of the damaged tobacco plants, Weeks stated.

The long-awaited Greenville high school annuals have arrived and will be given out tomorrow morning at 10 o'clock on the steps in front of the high school building. Students who want annuals should bring their receipts with them.

The annuals which were scheduled to be in Greenville a week before the closing of school were delayed by publication trouble.
