Dramatic Action By Russia Seen After 'Day Off'

Western Officials Speculate That Vishinsky May Change Course Of Talks

Paris, June 11—(AP)—Western officials look for a new dramatic move by Russia when the council of foreign ministers reconvenes tomorrow.

Soviet Foreign Minister Andrei Vishinsky had asked before adjournment yesterday that no meeting be held today. His Western colleagues agreed to the Russian diplomat's cryptic request.

A Russian press officer was asked why Vishinsky wanted an adjournment until Sunday afternoon. "He wanted the day off, that is all," was the answer.

Western officials speculated that Vishinsky, after consulting with the Kremlin, might make a move that could change the course of the Paris conference.

They noted these aspects of Vishinsky's call for a one-day recess: It came soon after Secretary of State Acheson warned that the days of the conference were numbered unless Russia gives ground.

"We are here to deal with realities, the blunt facts of a situation and not to engage in some form of diplomatic minuet," said Acheson.

Secondly, Vishinsky's request was made immediately after the conference had reached a near deadlock on three German issues before the council. These were four-power control in a politically and economically reunited Germany; Berlin and the currency question and preparation of a German peace treaty.

Vishinsky explained his request yesterday merely by saying he was going to be "busy." Western officials suggested he could "busy" himself by seeing some Russian emissary in Paris, or awaiting word from some top level policy conference taking place in the Kremlin on the basis of reports he may have sent to Moscow last night.

The United States has insisted that the foreign ministers meeting adjourn at the end of next week.

A senior East European diplomat, however, told a reporter: "I don't think the conference will end next week." He said he had lunched with Vishinsky three days ago.

Coal Walkout Is Called Violation Of Pact Terms

Scranton, Pa., June 11—(AP)—Next week's walkout of the miners is "a distinct violation" of the contract with anthracite operators says Ralph E. Tager, operators spokesman and president of the Philadelphia and Reading Coal and Iron Company.

Tager said in a statement issued yesterday: "We consider the shutdown of all anthracite mines for one week by the order of the officers of the United Mine Workers of America to be a distinct violation of our wage agreement with the union."

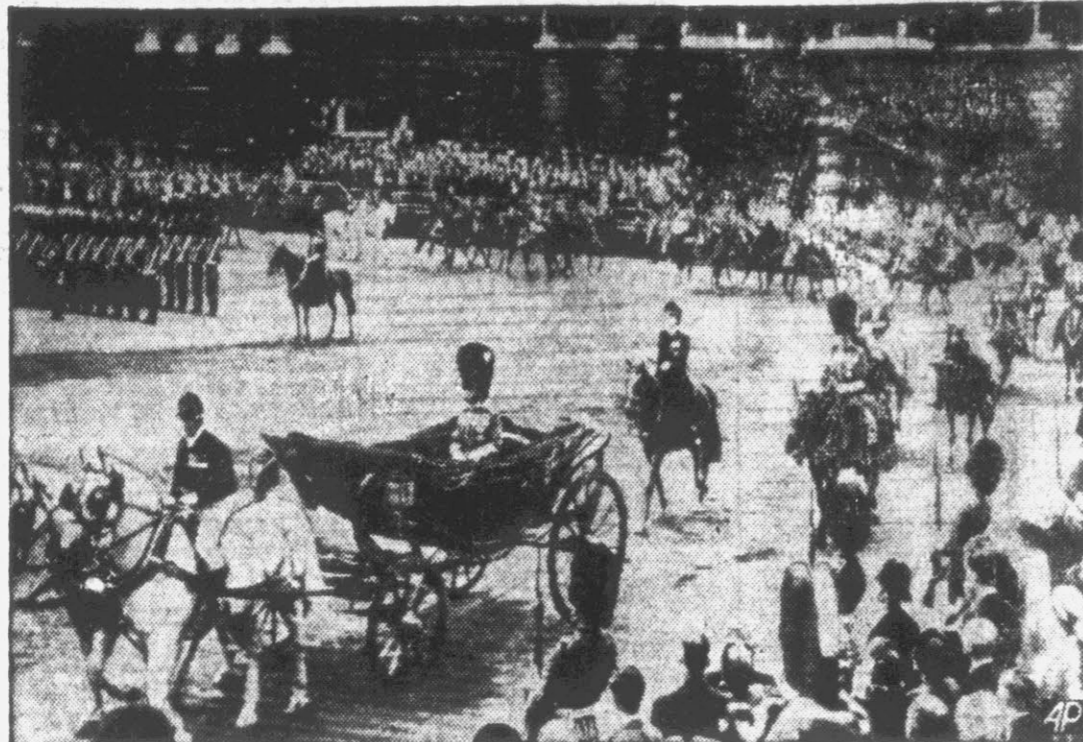
"The production of anthracite to meet market demands is authorized by a committee operating under Pennsylvania statutes on which the UMW and the anthracite operators have equal voice."

Appeal By Scott In Mill Walkout

Raleigh, N.C., June 11—(AP)—An appeal to both sides to accept arbitration in a Tarboro mill strike has been made by Governor Scott.

The strike, called after the failure of negotiations for a new contract between the Hart Cotton Mill and Local 316, Textile Union Workers of America, CIO, has kept 500 workers idle since May 12.

Hooded Mobsters Smash Into Home

Beat Birmingham Woman And Threaten Burning At Stake; Second Gang Raids Cafe, Threaten Owner As Policeman Looks On

Birmingham, Ala., June 11—(AP)—Hooded and robed men last night beat a Birmingham white woman and threatened to burn her at the stake. Another group of 16 carloads of hooded men took charge of a cafe in a nearby town and threatened the proprietor.

About 20, some of them armed, smashed their way into the home of a 42-year-old woman. She said they struck her and threatened to lash her and burn her. They left a fiery cross burning in the yard of her home.

Mrs. Hugh McDanel, who lives on the Jasper highway about five miles from the Birmingham city limits, said the robed men invaded her home about 10 p.m. The woman, who recently underwent an operation for a brain hemorrhage, said she was struck twice on the head. Her husband was away from home at the time.

Mrs. McDanel said she was talking to a friend on the telephone when she heard a knock at the door. She said she looked out and two men armed with pistols told her: "We want you."

She ran back to the phone and told the friend to call police, then grabbed a shotgun in a back bedroom. She said she dropped the shells as she was trying to load it.

Meanwhile, the men broke a pane of glass in the door and unlighted it. She said one hit her on the head and another grabbed the shotgun.

At that point, she jumped from one man to the next and lifted the hoods of four of them. "We could kill you for that," she quoted them as saying.

She said she thought the incident "may have been the result of a grudge by one neighbor." She did not elaborate.

She was dragged out of the house onto the lawn, where a six foot cross was burning. The men asked for her husband, who was at work on his delivery route for a bakery company.

"We're after him, too," they told her. The men said the neighbors had complained that her home was being used to "bring men and women together, and also to sell whiskey."

Solons Push For Big Cut In ECA

Washington, June 11—(AP)—Senators called today for cuts of up to \$780,000,000 in the European Recovery Program.

Senator Taft (R-Ohio) told reporters the Economic Cooperation Administration can stand a 10 per cent cut in the \$3,586,470,000 fund voted by the House. He said he will back such a cut.

But Senator McCarran (D-Nev.), a member of the Senate Appropriations Committee, said he will urge a flat \$780,000,000 slash.

McCarran said he is basing his recommendation on a study made by the staff of the Senate-House "watchdog" committee. This group was set up to keep a check on ECA spending.

The committee has authorized McCarran to use this material, but not as a committee recommendation.

"There are some places in the program," McCarran said, "where we can make a direct cut. The rest of it should be done by the ECA administrator."

McCarran said ECA Chief Paul Hoffman has "done as good a job as any one man could do."

"But the project is too big," he added, "and in many places it has gotten away from him."

Chairman McKellar (D-Tenn.) of the appropriations committee angrily told Hoffman yesterday that his resignation "would be a very good thing."

Raleigh, June 11—(AP)—The Atlantic Fisheries compact has been completed with North Carolina's formal entry.

Governor Scott yesterday signed the compact, which makes this state a member of the Atlantic Marine Fisheries Commission.

There already were 14 members of the commission, whose aim is to promote and protect marine fisheries along the Atlantic coast. The 1949 legislature authorized this state to join the group.

Governor Scott said he has named Conservation Director George Ross and Tony Seamon of Morehead City as two of the state's representatives on the commission. The third will be chosen by the Committee on Interstate Cooperation.

Roanoke Police Give Up Martin

Roanoke, Va., June 11—(AP)—Roanoke police yesterday surrendered to North Carolina authorities an escaped convict arrested earlier in the day driving a stolen automobile.

The convict, identified by city detectives as Freddie Martin, was quoted as saying he had escaped from a prison camp near Greenville with another prisoner after overpowering a guard and taking his gun.

Commission Will Assist Graham

Washington, June 11—(AP)—Senator Graham (D-NC) will let the Civil Service Commission help him pick West Point and Annapolis students.

The senator announced yesterday that competitive examinations for his appointments will be given by the civil service July 11. The examinations will be held at post offices near homes of applicants who apply to Senator Graham by June 24.

Harlan, Ky., June 11—(AP)—Seven times a bride, 50-year-old Mrs. Lucy Jane Johnson looked at spectators outside County Judge W. J. E. Howard's chambers where she was married yesterday, and asked: "Why shouldn't I get married if I want to?"

Mrs. Johnson's newest husband, Isaac, is 75 and he has been married three times. They both reside at Hulien, near the Bell-Harlan county line. He listed his occupation as a laborer.

Court records showed Mrs. Johnson's sixth husband, the late John Blevins, was 95 at the time of their marriage in September, 1948.

Many To Attend June 14 Meeting

Eastern N. C. Businessmen Said Making Reservations

Businessmen from Wilson, Tarboro, Rocky Mount, Kinston and Washington already have made reservations for the national affairs panel discussion to be held in the Greenville Woman's Club Tuesday evening, W. T. Kyzer, manager of the Greenville Chamber of Commerce, announced today.

Kyzer said reservations from 16 Tarboro businessmen have been received along with 16 reservations from Wilson, 15 from Rocky Mount, 10 from Kinston, and six from Washington. The manager of the local Chamber of Commerce said 100 or more out-of-town people are expected to attend the meeting here and approximately 50 Greenville businessmen are expected to attend.

The program is one of 400 being held currently throughout the United States to emphasize the importance of local businessmen participating more actively in national affairs.

Principal speakers at the meeting will be John Whittiesey, top labor relations expert from Washington, D. C.; William J. Bird of Washington, D. C., national affairs advisor of the Chamber of Commerce of the United States; and E. H. Cherry of Atlanta, assistant manager of the Southeastern Division of the National Chamber of Commerce.

Babson Sounds Danger Signal

New York City, June 10—During the twenty-eight years that I have been writing this weekly column, I have seldom suggested to my five million readers that they write their Congressmen. I am doing so now, however, because of the indifference which I found as to Government finances on my recent annual trip about the country.

Deficit Financing For the first time in many peace years the Government has reached the "parting of the ways" in connection with balancing the budget. Of course, during the war it was impossible to balance the budget and no one asked that it be done; but today the situation is very different. The country is now at peace; business is fairly good; and employment continues to be high. On the other hand, due to the demands from abroad and the possibility of smaller income tax receipts, one of two things is necessary. Either taxes must be increased, or Government expenses must be correspondingly reduced. The Hoover Commission recommends an annual reduction of three billion.

I believe that President Truman is an honest man, but I fear some of his advisors are either misleading him or else are ignorant of economic truths. He wants a balanced budget, but he seems unwilling to balance this budget in the obvious and sensible way—namely by reducing Government expenses. This would be the natural way for any business to balance its budget; in fact this policy of economy would have saved Mr. Truman from undeserved financial trouble which, through no fault of his, came upon his former haberdashery store which I visited a few weeks ago when in Kansas City.

The Present Danger The present danger is that Congress, to satisfy those who are opposed to increased taxes and also those who want to hold jobs for their friends, may cause the country to fall into the terrible and dangerous habit of deficit financing—that is, to run the government at a loss and borrow money to make up the difference. Such a borrowing policy is like a prohibitionist starting to drink, or like a bank clerk starting to gamble.

Truman Turns To 'Plain Talk' On Foreign Program

Important Address Supporting European Aid Funds Promised For Today

Little Rock, Ark., June 11—(AP)—President Truman, disturbed by congressional economy bloc efforts to slash funds for European aid decided to resort to what his associates said should be "plain talk" today to save his program.

Meanwhile, he and the boys of the 35th Division whooped it up in another reunion.

His address, which he said would be a "very important" foreign policy speech, was scheduled for delivery at 3:30 p.m. (Eastern Standard Time).

Gov. Sid McMath, his official host, said the President told him the address would be of major importance in the international field and that it would be broadcast by all the major radio networks and beamed overseas.

And the President gave the speech another build-up at a ball in his honor last night.

Addressing the dancers, he said he could not join them on the floor because his dancing education had been neglected.

"I'm a Baptist but not a 'light-foot' one," he said.

Then he went on to say: "If you want to hear the President of the United States, come out to the stadium tomorrow."

"I'll tell you something that will be good for your souls."

But, as he awaited the time for his talk dedicating a park as a memorial to the dead of two World Wars, the President joined in the convention revelry.

As "Captain Harry" of Battery D he summoned World War One comrades of the 129th Field Artillery to a 7 o'clock breakfast and said he would walk with them in their annual parade.

The breakfast and parade, like yesterday's appearances, sounded a light note.

City Bus Service Needs Are Polled

Line To Be Sold; Utilities May Be Asked To Step In

A poll of the merchants of Greenville to determine the need and desire for city bus service is being conducted by the Chamber of Commerce and the Merchants Association in cooperation with a committee from the Board of Aldermen.

The Greenville Transit Company, which operates the city bus line, is scheduled to be sold for mortgages next Thursday. One of the company stockholders who has worked closely with the company management said today the company would like for some individuals or company to buy in the bus company and continue to operate the city lines.

Reliable sources in the city government this morning stated that the Greenville Utilities Commission may be asked to consider taking over the bus line to operate as a utility of the city if the poll of merchants indicates a need and desire for the service. The matter of the city purchasing the bus line to operate under the Utilities Commission may be presented to the members of the Utilities Commission at their regular meeting next week, it was indicated today.

W. T. Kyzer, manager of the Greenville Chamber of Commerce, said replies received from the poll of merchants regarding the bus line show an overwhelming majority of the merchants favor the continued operation of a bus line within the city.

Boiling Point

Washington, June 11—(AP)—Police said today that one of the men mentioned in the Judith Coplon trial yesterday had committed suicide here last week.

He was Morton E. Keni, 48, of Chevy Chase, Md., whose throat-slashed body was found floating in the Potomac River last Saturday. District Coroner MacDonald pronounced the cause a suicide.

Keni was a Russian-born former State Department aide. Top-secret FBI documents read at the Coplon espionage trial yesterday said he had been in contact with Soviet secret police.

Keni was a Harvard graduate and spoke nine languages. He joined a private firm here five years ago after working for both the State and Labor departments and for the Board of Economic Warfare.

Detectives who investigated his case said they were positive his death was a suicide. He had rented a boat, and several persons saw him canoeing near the Three Sisters Islands.

Two hours later his body was found. A cheap kitchen paring knife was found at the water's edge the next day.

The FBI data listed George Dimitrov Sotirov, a Bulgarian now employed as a clerk by the United Nations secretariat, as the agent for the Russian intelligence service Kent contacted.

The report went on to say that in an effort to contact Sotirov, Kent got in touch with Mrs. Emily Condon, wife of Dr. Edward U. Condon, director of the National Bureau of Standards. It said this was in October, 1948.

Maneuvering In China

Diplomatic Efforts Partly Taking Place Of Gunfire During Pause In Civil War; Look To West; Nationalists Plan Defense And Reds Lay Down New Conditions

Both the harassed Chinese Nationalist government in Canton and the triumphant Communist leadership in the north are maneuvering energetically for position in the forthcoming fresh phase of their bloody civil war.

Diplomatic efforts directed toward the western world are in part taking the place of gunfire during a pause in the victorious Red drive. From Nanking comes word that Communist officials there are urging western powers to withdraw recognition of the Nationalist government. Meantime the Nationalist have appealed again to Uncle Sam for aid, this bid having been made in Washington by Dr. Kan Chieh-Hou, Special Ambassador from China's acting President, Li Tsung-Jen.

So far as Congress any withdrawal of recognition from the Nationalists, Washington has taken the position that it will not recognize any Communist regime so long as a responsible Nationalist government exists. While the military prospects of the Nationalists seem dim, this country isn't going to do anything to contribute to their collapse. The other western powers have been playing along with America in this policy.

In the matter of the Nationalist bid for further aid, there is no sign that Washington intends to shift its policy of not giving further military help. American aid at present is limited to providing economic help out of a fund of some \$54,000,000 which is handled by the economic co-operation administration. This assistance is mainly for food in the sections not captured by the Reds.

Dr. Kan has stated in Washington that the Nationalists have a "definite plan" for defense of territory still in their hands. He didn't say what that plan might be. However, the Nationalist government in Canton is said to be preparing to move to the old wartime capital of Chungking, leaving an army behind to defend Canton against the Reds. Meantime former president Chiang Kai-Shek has organized the defense of the Great Island of Formosa off the east coast.

Of course the Communists aren't rushing into establishing a "government" of their own at this juncture. They aren't expected to make this move until autumn, and so (Continued on page eight)

Decision Made By 9-8 Vote Of Committee; Hickenlooper's Case Against Lilienthal Goes Into Closed Session Against His Wishes

Washington, June 11—(AP)—Congress will get a look at the loyalty records of key Atomic Energy Commission employes, but behind the closed doors of the Senate-House Atomic Committee.

That decision, made by a 9 to 8 vote on the committee yesterday, apparently pulled out of public hearings a major portion of the "incredible mismanagement" case of Senator Hickenlooper (R-Iowa) against AEC Chairman David E. Lilienthal.

Senator McMahon (D-Conn.), who made the move for closed sessions on the loyalty question, promised a report of the committee's conclusions when the inquiry ends.

Hickenlooper, who didn't vote on the issue that kept the committee split for a week, called the decision "a remarkable action."

He said that he doesn't know what course he will pursue "now that they have blocked me on the security phase."

Later, in a radio interview on Mutual's "Meet the Press" program, Hickenlooper said the committee's decision had forced him to "reorient my approach" because "a very vital part of my presentation has been taken out from under me."

He said he had expected the security files would be gone into privately, anyway, but he wanted to make a public presentation on procedure "leading up to clearance and nonclearance of individuals."

Hickenlooper said he thought this was the "public's business."

McMahon said that the committee's public hearings will be resumed Monday if Hickenlooper is ready to proceed with other phases of his case.

The committee's decision grew out of Hickenlooper's presentation of what he called "Case A." He said that an AEC employe whose loyalty or associations had been questioned in a 50-page FBI report had aided in obtaining top secret AEC reports.

The Iowa said he didn't want to name any of the employes involved in such cases, but intended to show the commission was lax on loyalty issues.

Lilienthal contended that Hickenlooper had identified the individual, at least in his coworkers. He said such methods were "unfair."

The employe has asked for a hearing and Chairman McMahon indicated it probably will be given to him in public.

Hickenlooper's failure to vote kept the committee from a tie ballot, under which McMahon's move to close the doors on loyalty cases would have lost.

As it was, Senator Edwin C. Johnson of Colorado was the only Democrat to join seven committee Republicans in voting against the closed hearings.

McMahon said Hickenlooper's proposed procedure was "one-eighth of a hearing" and called it an "unworkable" and "fantastic" arrangement.

Consider Selling Guns To Arabs

Lake Success, June 11—(P)—Britain is considering resumption of small arms shipments to Arab states, informed sources here and in London said yesterday.

United Nations officials said British representative Sir Alexander Cadogan called on U. N. Palestine Mediator Ralph J. Bunche to ask his opinion. Cadogan is understood to have told Bunche his government feels the recent armistices Israel signed with trans-Jordan and Iraq opened the way for the lifting of the U. N. embargo.

Communist Teachers

A Running Argument Over Allowing Communist Party Members To Teach In American Schools; Party Line Denies Impartial Thought; What Educators Think

Washington, June 11—(AP)—There's been a running argument for several months this question: Should a Communist party member be allowed to teach in American schools?

Those on the "yes" side, putting their emphasis on the importance of academic freedom, argue this way: A teacher should not be interfered with unless he's caught trying to twist his teaching to fix the party line.

But catching him at it, say those on the "no" side, is difficult. To do that, they say, would require spying and once spying started in a school the faculty would be paralyzed or ruined.

They argue that once a man is a Communist party member he is no longer free to teach what he may truly think because:

He is a disciplined party member and must follow the party line, no matter how it shifts or changes.

Professor Sidney Hook of New York University, one of those on the "No" side, had a long analysis of the problem last February in the New York Times Magazine section.

He said teachers who want to stay in the Communist party "must believe and teach what the party line decrees." And he added: "A party line is laid down for every area of thought from art to zoology."

As proof of his statement, a very interesting job, Hook quoted from the Communist official party organ of May, 1937, in part: "Communist teachers must take advantage of their positions without exposing themselves, to give their students to the best of their ability a working class education."

Arthur M. Schlesinger, Jr., author of the "Age of Jackson," reached an astonishing conclusion on May 14 in the Saturday Review of Literature when he said:

No University in the "senses would knowingly hire a Communist," but once such a man was hired he shouldn't be fired for his beliefs alone unless having him around was a real danger.

Those who say a Communist should not be hired to teach received their strongest support this week from 20 educators, including General Eisenhower, President of Columbia University, and James B. Conant, President of Harvard.

Pitt Court Sees Precedents In Trial Of Daniels' Boys

Grim Plight Of Victim's Family Eased Through Drive

First Pitt Trial In 43 Years Wherein 2 Tried For Killing

Unless the Supreme Court should find some error and order a new trial, the O'Neal murder case is officially ended so far as Pitt County courts are concerned, and the hundreds of persons who lost many hours from work to attend the trial are back on their jobs. Except for occasional conversations about the trial things are back to normal in Pitt County.

Meanwhile citizens of the community have gone ahead with their plans for aid to the family of the murdered man through the O'Neal Foundation formed here immediately following the crime in February.

Trial Sets Precedents
The trial in which Bennie Daniels and Lloyd Ray Daniels, Negro youths, were both sentenced to

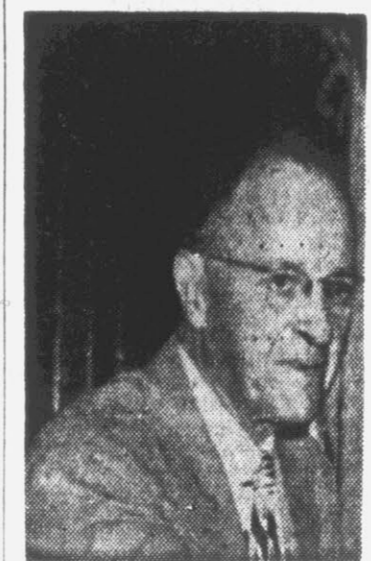
death for the murder of William Benjamin O'Neal, local taxi driver, on February 5, set many precedents for the Pitt County court records. The trial was the first in 43 years in which two persons have jointly been charged and tried for first degree murder in a single slaying, and was the first in which both defendants were convicted in the first degree. In the former case one of the defendants was convicted in the first degree and the other in the second degree.

The trial of the Daniels boys also combined many elements, heretofore appearing separately in Pitt County court procedure, but never before combined in one trial. On previous occasions Negro attorneys have appeared in cases in the court

and Negroes have done jury duty. On previous occasions since the constitutional change permitted women to do jury duty, women have served in Pitt County. The Daniels trial was the only one in Pitt County history in which a jury has included both white men and women and a Negro man, and was also the only murder trial in the county in which a woman has been a member of the jury. But for the fact that a Negro woman, drawn from the special venire, disqualified herself on the grounds of conscientious scruples against capital punishment, she too might have been a member of the jury, causing it to consist of all possible elements under the law.

Trial Cost \$3,500
Not counting the salaries of regular officers and court officials, the investigation and the trial is estimated to have cost Pitt County more than \$3,500. The volume of testimony together with arguments on various motions and subsequent orders and judgments by the court together with the judge's charge to the jury furnished enough wordage for two or more complete full length novels.

A Parallel Case
The parallel case, mentioned above, occurred in Pitt County in January, 1906, when Sylvester Barrett and Jerry Cobb, Negroes, were tried for first degree murder for the slaying of Constable J. W. Lovitt, who was endeavoring to arrest them for breaking another man's arm with a shovel earlier in the day. The jury returned a verdict of first degree murder against Barrett and he was sentenced to die by hanging in February. The jury found Cobb guilty in the second degree and he was sentenced to 25 years in prison. The Barrett-Cobb case continues

in similarity to the Daniels case in that notices of appeal were given on the grounds of error of the court in permitting incompetent testimony and rejecting testimony believed by the defense to be competent. (The same grounds of the appeals in the Daniels case.) Likewise Barrett and Cobb took pauper's oaths and were permitted to file their appeals as such, the same as was granted the Daniels cousins here on Monday night. The Barrett-Cobb sentences were confirmed by the September, 1906, term of North Carolina Supreme Court and in due course of time that included an additional 30 days reprieve, Barrett was hung in the Pitt County jail yard by Sheriff L. W. Tucker. That was the last hanging to occur in Pitt County before the state adopted the electric chair for executions.

The Testimony
The state in its testimony revealed the finding of O'Neal's battered and slashed body at a lonely spot several miles from Greenville on Sunday, February 5, and of information that the two Negroes were seen to ride away with O'Neal in his taxi on the night before. Officers told of procuring bloody clothes later identified as those worn by the Daniels boys on the night of the murder. The two Negroes subsequently were arrested and later allegedly confessed the crime, telling of how they had robbed O'Neal and beaten and cut him to death. A large number of state witnesses gave substantiating testimony.

Efforts of the defense to provide alibis for the defendants or to lead the jury to believe that some other unknown person or persons had committed the crime were to no avail and the jury on its first ballot returned first degree murder verdicts against both defendants.

First Four Days
The first two days of the trial, which began Monday of last week, were taken up in the arguments on a motion to quash indictments because of absence of Negroes on the grand jury. The following two days were taken in the selection of a jury from the regular panel and two special venires. Actual testimony was begun on Friday morning and by holding court sessions at night the testimony was finally concluded and two lawyers spoke before the jury on Saturday night.

Final arguments were made before the jury on Monday morning and Judge Clawson L. Williams, after a review of the evidence and charge to the jury that consumed more than three hours, gave the case to the jury just before seven o'clock Monday night.

Following return of the verdict, Judge Williams sentenced each of the youths to death in the gas chamber on Friday, July 15, and notices of appeal were immediately filed by the defense. Judge Williams granted the defendants 60 days in which to affect their appeal and

granted the state 45 days thereafter to prepare its case. The matter will come before the North Carolina Supreme Court when it begins hearings of cases from this district on October 12.

Large Crowds At Court House

Throughout the trial hundreds of persons jammed the courtroom while additional hundreds could not gain admission and remained outside the building. Despite the great interest in the trial there was no outward appearance of any racial feeling and the entire trial was without incidents or disturbances of any kind.

As a precautionary measure, however, about 4 o'clock Monday afternoon, highway patrol cars from various sections of Eastern North Carolina converged on Greenville and remained on the outskirts of town subject to immediate call should any emergency arise as the prisoners left the court house following the verdict.

Judge Williams, immediately prior to adjourning the term of court, publicly praised the jury for its services to the county and state and commended officials and attorneys on both sides for the manner in which the trial was carried out and thanked law enforcement officers for their cooperation.

The case was prosecuted by Solicitor William J. Bundy, aided by J. H. Harrell, and the defense was

represented by C. J. Gates, of Durham, and Herman L. Taylor, of Raleigh.

The O'Neal Foundation

When news of the death of O'Neal, World War II veteran, who had spent time in a German prison camp, was revealed here on that Sunday in February, a wave of sympathy spread throughout the community for his destitute family.

Superintendent of City Schools J. H. Rose, through a letter in the open forum of the Reflector, issued an appeal for help for the dead man's mother, his wife and his unborn child. Immediately the matter was taken up by various organizations in the city. Negro church and civic organizations in the city adopted resolutions condemning the crime and they joined with other citizens of the community in contributing to the fund for the bereaved family. The aid was placed in the hands of a special foundation headed by Mayor J. H. Boyd.

The O'Neal family's immediate needs were taken care of. Provisions have been made to cover necessary medical and hospital expenses for the birth and care of the unborn child, and plans for the building of a home for the family have been formulated. Contributions for the fund have come from within and outside the state.

Construction to Begin Next Week

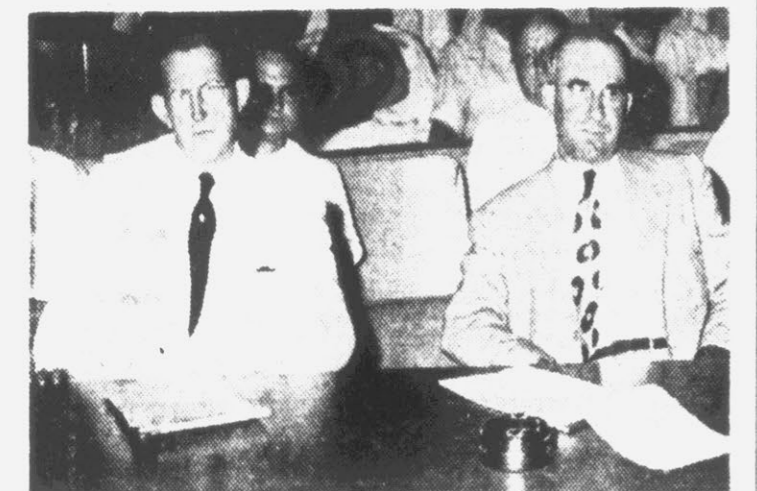
At a meeting of the O'Neal Foundation held Wednesday night it was announced that the foundation is ready to begin construction of the proposed home next week.

During the campaign for funds the heads of the American Legion and Veterans of Foreign Wars, together with their auxiliaries and the Junior Woman's Club, have acted as a steering committee. At a meeting of the foundation Thursday night an executive committee to oversee the construction of the home was named.

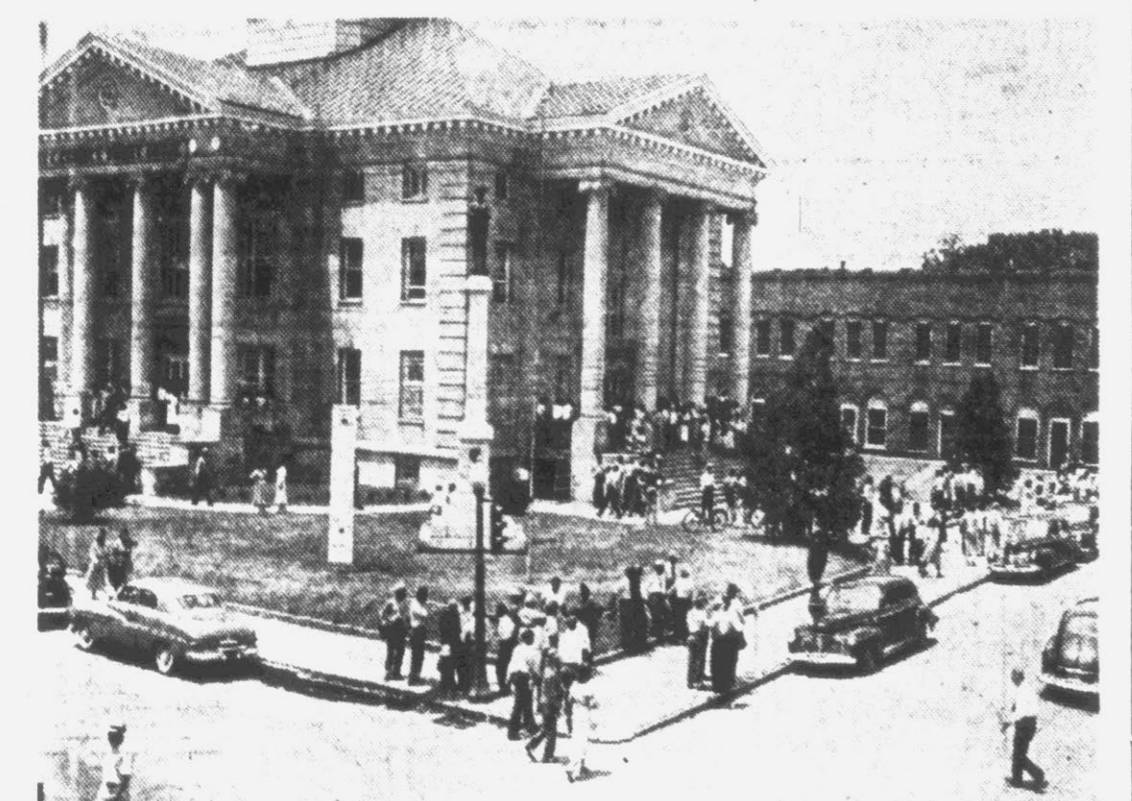
Financial reports of the foundation revealed a total of \$3,437.32 on hand for the project. Much material

for the proposed home has been promised by various concerns, and carpenters and workmen as far as 30 miles from Greenville have offered a day or more each of free labor on the project.

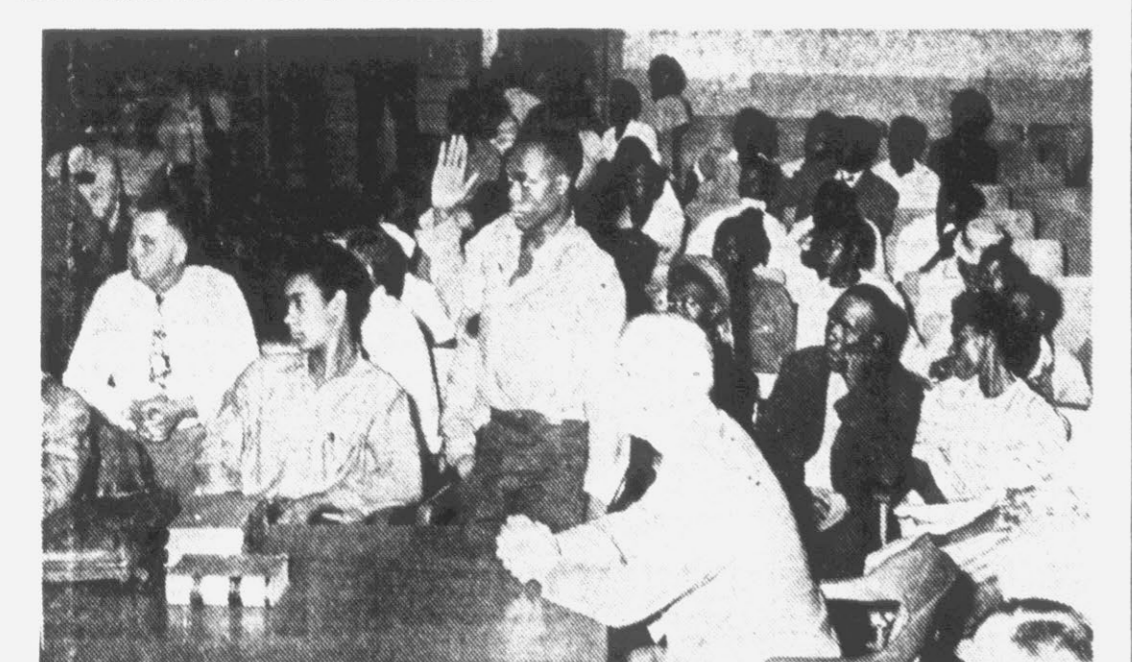
The home will be the property of the widow and mother of O'Neal so long as either of them survive, and at the death of both of them it will be the property of O'Neal's yet unborn child. Should the child not reach the age of 21 years, the property will belong to the O'Neal Foundation and be used for the purpose of aiding and helping other World War II widows and orphans as the foundation found worthy and could help.

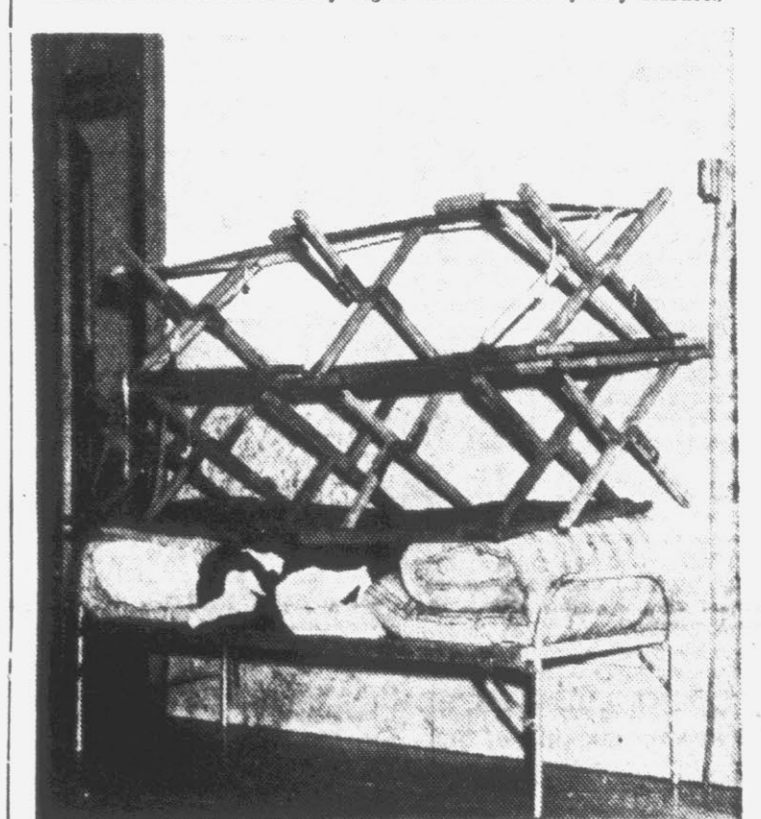

Hamm, Luxembourg, June 11—(AP)—There is a grave here big enough for a man, but too small to hold a Legend.

In the grave lies Gen. George S. Patton, Jr. and it holds him securely. But his Legend reaches across the miles and years to all those who aspired to what he lived by and that was leadership.

They didn't bury "George" here, they just put him underground. But nobody shoveled earth on what he stood for nor can anyone as long as men put their faith in valor.

Perhaps the word is glory. George used that word often. He liked the sound of it and he believed in it. He didn't fight the system under which mankind has dwelled in worry and wonder since Cain killed Abel.

He took it as it has been. He said it would probably continue and he believed and lived and died in that belief—that man is born to warfare and that since his heritage is struggle, those who struggle with the firmest courage are the people who face life in the finest way.

There is probably a wisdom about war called peace—the World's unknown adventure. Whether peace is good or bad for the human race has never been fully determined because always since the Garden of Eden this race, facing life with more vanity than the insects but with four fewer legs, has expressed its frustrations in a sterile pattern of weary violence.

In individual cases these outbreaks are classified as homicide. A kind of crime. In the cases of nation against nation there is the softer word, war, a kind of polite and collective murder. Under this surprising moral order you can be hanged for killing a man you have a personal grievance against or can be rewarded with a medal for killing 25 strangers you don't know.

George Patton took mankind as it is and as it always has been. His real monument was a ruthless, personal honesty. He believed that people, being what they are, made war inevitable, not just once but over and over.

Because his courage came out of his mouth as well as his heart, because he spoke as bravely and straightly as he acted, he was sometimes in hot water with the American people. He was more honest with them than they were with him. They compromised and quibbled. He acted. He did what they wanted done.

They wanted victory and he gave it to them. There are diplomats in military as well as civilian life. Diplomats want success without the attrition and risk of gambling.

George was smart enough to know that a bold General spends men's lives to save other men's lives. He hated foxholes because he really believed that digging in was wasteful energy, that in attacking again and again lay success and few losses.

And when the army needed a tough man to do a tough job, there was George, tough enough to order one man to his death to keep two other men alive. And that was the courage he had—a courage above military politics.

Well, to him, to die in battle for your country was the supreme glory. George didn't create the system, it created him.

And until men think of glory in other terms, General Patton will remain an American landmark.

Today he lies at the head of his troops, a silent roster of some 5,200 men. There are four gold stars on the simple white cross above him.

No General who died in Europe in the second world war wears this rank over his grave but him. They had to set George apart in death, as he set himself apart in life, because so many people come to see him. Here he is our strong Ambassador, a real symbol that Americans are here to stay.

The grave holds George Patton but his legend is world wide—the story of courage in our time and bravery as he honored it.

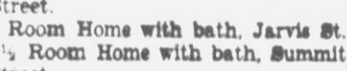

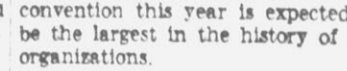

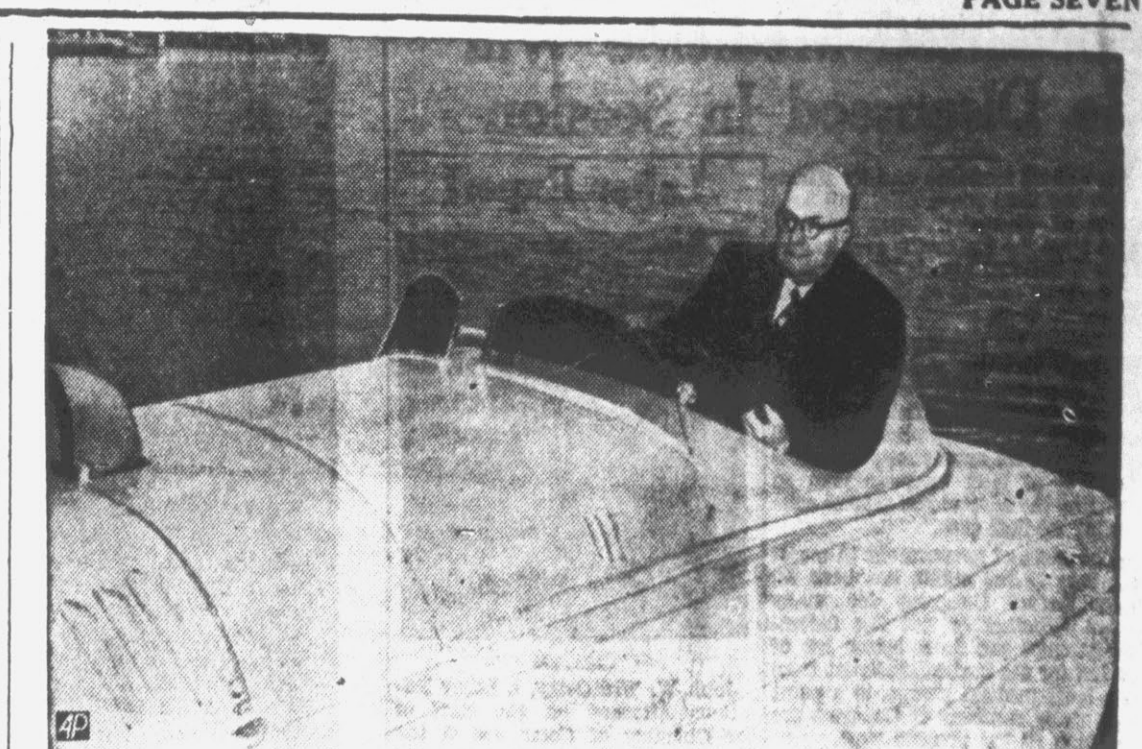

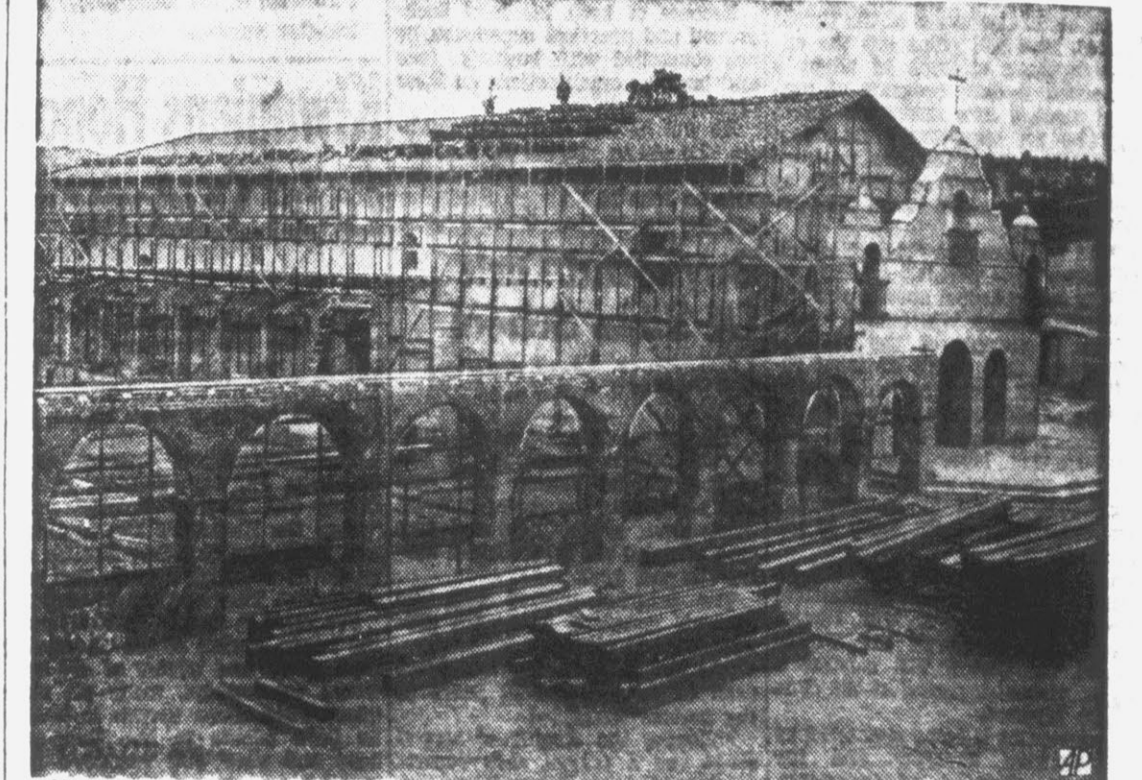

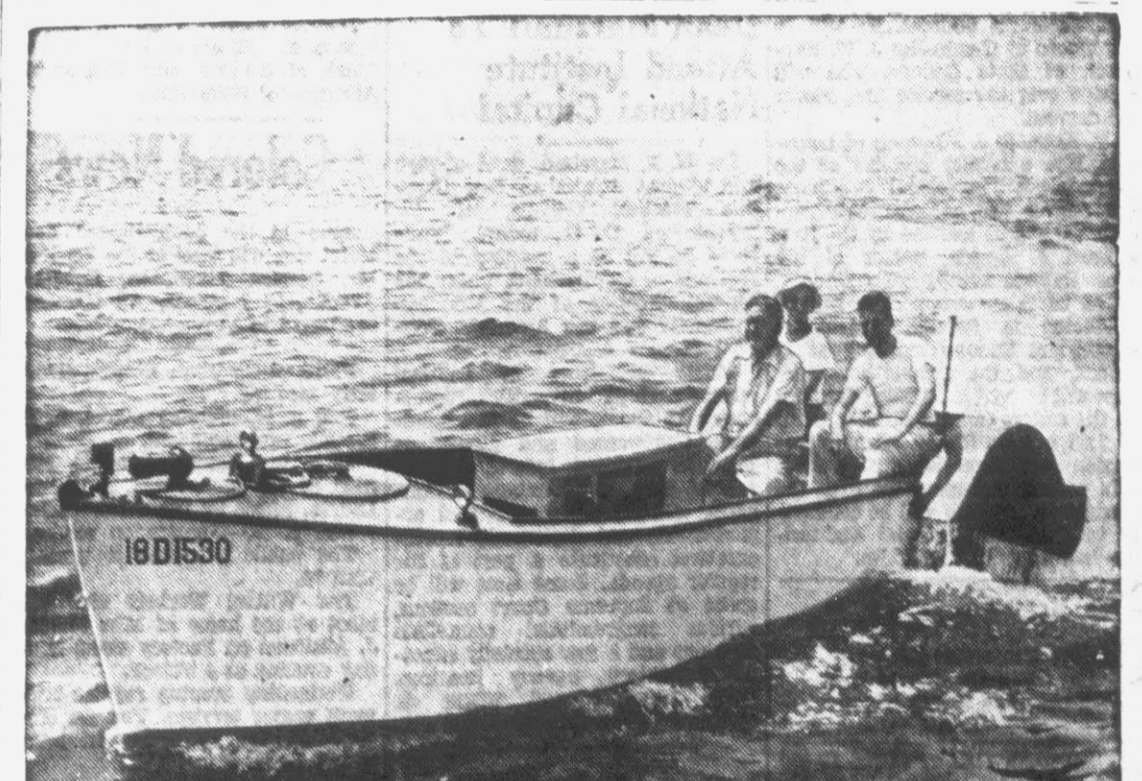

Socialized medicine and its effects upon the local community will be a point of discussion when business men from the Greenville area gather to talk national affairs at a regional conference June 14 at the Greenville Woman's Club.

Chances for passing the administration's plan for socializing medicine, according to Greenville Chamber of Commerce officials, will be discussed, and local physicians will get their first opportunity to enlist the aid of local business men in fighting the adoption of federal controlled medical care.

Whether or not the federal government can do a better job of caring for the medical indigent than can local medical groups, is a point that many members of Congress are debating at the present time.

To talk against socialized medicine at the June 14th meeting will be William J. Bird, Washington, D. C. National Affairs Advisor of the Chamber of Commerce of the United States. Bird will point out the administration's attempt to adopt socialized medical program of pre-paid medical care insurance. There will be an opportunity during a roundtable period for local business men to have their say on this as well as other major issues now before Congress.

Bird will speak on "Help Yourself to Better Government," and will be one of two principal speakers at the conference. John Whittlesey, Washington, a member of the national Chamber's department on labor relations, will highlight the session with an inside story of the administration's attempt to repeal the Taft-Hartley labor law, together with a summary of what the administration's bill to increase the minimum wage would mean to the local retailer.

Also on the program will be E. H. Cherry, Atlanta, assistant manager of the southeastern division, Chamber of Commerce of the United States. Mr. Cherry will conduct a forum discussion period at the close of the program.

The meeting is being sponsored by the national chamber and the Greenville Chamber of Commerce.

Labor Expert



John W. Whittlesey, a Labor Relations Attorney on the staff of the Chamber of Commerce of the United States, is an expert on labor legislation, especially that which deals with the Taft-Hartley act and the Wage-Hour law.

Because of both his legal background and practical experience, he has counseled with business men and business organizations on labor problems.

He will be one of several speakers who will be present for the National Affairs conference in Greenville on June 14.

In a 54-page booklet made public by the National Education Association, they said:

"Members of the Communist party of the United States should not be employed as teachers. They said party members are not 'free to think for themselves,' and added: 'It is because members of the party are required to surrender this right, as a consequence of becoming part of a movement characterized by conspiracy and calculated deceit, that they should be excluded from employment as teachers.'

They said Communists 'surrender intellectual integrity' and therefore are rendered 'unfit to discharge the duties of a teacher in this country.'

The 20 educators offered no proof but plainly said their statement was their opinion.

London, June 11—(AP)—Railway strikers defied today a government demand to end their "Sunday only" work stoppages on Britain's state-owned rail lines.

Meanwhile, 49,000 London trainmen were called to a mass meeting Monday to decide whether to bring all London's surface and underground lines to a standstill. Rail union officials said any action taken would be unofficial and without union sanction.

In addition to the schedule changes demanded by engineers the nation's railwaymen are seeking a general ten shilling (2) a week pay raise.

The Labor government sent a stern demand to the strikers last night to quit the "Sunday only" walkouts so negotiations can be resumed.

meantime they aren't eligible for international recognition. Naturally their position would be strengthened if they could persuade the western powers to withdraw recognition of the Nationalists. The Communists already have laid down the conditions under which they will be prepared to enter diplomatic relations with foreign powers. The conditions are these:

1. Foreign armed forces must be withdrawn from China.
2. Relations must be based on "equality, mutual benefit and mutual respect for each other's independence and territorial integrity."
3. Recognition must be withdrawn from the Nationalist government.

Obviously America will recognize the Communists if and when they establish a responsible government for China. However, the signs seem to read that even then the western powers aren't likely to abandon any Chinese elements which are friendly to the west, no matter what their political complexion.

China is going to present a strange and complex picture for a long time.
