Secrecy Shrouding Mysterious Talks

President Truman Meets With Top Military, Atomic, Diplomatic And Congressional Leaders Behind Closed Doors; No Comments By Those Attending

Washington, July 15—(AP)—A White House shield of secrecy today threw a tight cover over a super-mysterious conference which brought President Truman together with top military, atomic, diplomatic and congressional leaders.

For two hours and 33 minutes these men—the list was impressive—were together behind closed doors last night in historic Blair House, the President's temporary home.

There was no announcement whatever of what went on. However, the identity of the participants pointed strongly toward some development in the atomic weapons field on an international level.

The 16 men who were closeted with Mr. Truman were singularly close-mouthed as they left. What little they did reply to reporters' questions could be summed up: "If anything is going to be said, the President will say it."

Mr. Truman wasn't talking. There was no sign that he would later.

The conference, staged against the dual backdrops of (a) the sharp Senate debate on the Atlantic Pact and arms-for-Europe and (b) a congressional hearing into charges of mismanagement of the atomic energy program, threw open the doors to wide areas of speculation.

This was true because of the secrecy that surrounded everything, even though it could be that nothing sensational was involved.

Here's the list of those at the conference with the President: Vice President Barkley, Secretary of State Acheson, Secretary of Defense Johnson, General Dwight D. Eisenhower, who has been presiding as chairman of the joint military chiefs of staff, House Speaker Rayburn of Texas; Chairman Connelly (D-Tex.) of the Senate Foreign Relations Committee; Chairman Tydings (D-Md.) of the Senate Armed Services Committee; Chairman McMahon (D-Conn.) of the joint Senate-Atomic Energy Commission.

Also Senator Vandenberg (R-Mich.), Republican foreign policy spokesman and member of both the foreign relations and joint atomic committees; Senator Hickenlooper (R-Iowa), a member of both groups and author of the "incredible mismanagement" charges against the Atomic Energy Commission (AEC); Rep. Durham (D-NC), vice chairman of the joint committee; and Rep. Cole (R-NY), ranking GOP House member on the committee.

Chairman David E. Lillenthal of the AEC; Joseph Volpe, Jr., AEC general counsel, and two unidentified men.

Mr. Truman walked to the door with the last two to leave—Secretaries Johnson and Acheson.

He was smiling as he chatted with them briefly in the anteroom, in sharp contrast to Barkley's stern features and the sharp tone with which the Vice President told questions:

"Not a damn thing," which he later withdrew and changed to "I've got no statement. There will be no statement from anybody except the President, if he makes one."

Senator McMahon followed this with the remark that "any statement will come from the President," and Lillenthal sounded the same note: "If there is anything to say, the President will say it."

General Eisenhower was asked what he made of the affair. "It's

Monroe Doctrine Extension Meets Cool Reception

Democratic Leaders Disapprove GOP Plan As Atlantic Pact Substitute

Washington, July 15—(AP)—Democratic leaders today looked with flat disapproval at a Republican plan to extend the Monroe Doctrine to Western Europe as a substitute for the North Atlantic pact.

They said they were confident the proposal—offered by Senators Taft of Ohio and Flanders of Vermont—will be put into cold storage in this session of Congress.

President Truman was asked about it at his news conference yesterday. He said he had no comment on anything Senator Taft had to say on the subject. Mr. Truman did say the Atlantic pact should be approved without reservations.

The Taft-Flanders resolution was referred to the Senate Foreign Relations Committee. And there was considerable chill in the reception given to it by Chairman Connelly (D-Tex.).

"They're trying to do just what the treaty does," Connelly said, "but they want the United States to go on alone—without the help of our European friends."

The resolution would urge President Truman to extend the Monroe Doctrine to Western Europe "on such terms and subject to such limitations and definitions as will best meet the present emergency and likewise serve as a continuing support for the objectives of the United States."

The effect of such a move would be to make the United States protector of Western Europe.

Flanders said an extension of the Doctrine would give Western Europe the assurance of protection it needs—but would not bind the United States to the "obligations of details."

Bragged Of Post Office Thefts, Placed In Jail

Cleveland, July 15—(AP)—A Tulsa, Okla., man who bragged to police about committing 32 post office burglaries in several states, was held in jail today.

Postal Inspector Martyn S. Thomas identified him as Clarence Maness, 33. He was charged specifically with robbing the Columbus, Ky., post office in 1947.

The inspector said Maness talked of knowing the late "Pretty Boy" Floyd, a midwestern bandit, and confessed to taking part in robberies that netted \$100,000.

Police began an investigation of his stories after he was arrested Saturday in a stolen car.

Spiritual Crossroads

Millions Of Europeans Caught Between Two Systems Of Supreme Authority As Vatican And Moscow Step Up A War Of No Compromise; Something Must Give

Suppose a Polish Catholic peasant has a pig for sale.

Suppose he takes this pig to market, and while there happens to read some notice or pamphlet issued by the Polish government.

Where does this peasant stand under the Vatican's order of major excommunication?

According to the translated text, it looks as if the peasant is not subject to excommunication. That is reserved for Catholics who persist in being or supporting Communists.

But it does look as if he might be denied the Holy Sacrament of his church if somebody should get technical enough to decide that he had read something that "set forth the doctrine of activity of Communists."

In a country like Poland, with a Communist government and a population that is mostly Catholic, it seems this sort of thing could happen on a large scale.

On the other hand, if the peasant does not read the government notice, he could just as easily get into trouble with the authorities.

This imaginary peasant suggests the plight of millions of Catholics since the Vatican's order was published Wednesday. They are caught squarely between two systems of supreme authority and neither system admits there is any higher than itself in its claimed province of human affairs.

The conflict arises because communism sets itself to govern all human affairs, and the

church holds itself supreme in spiritual matters.

Our peasant, by the millions, must now choose between obeying his church or his government in certain things. Just what these are still is not clear. What about his children, for example? In a country like Czechoslovakia these days, if they go to school, they go to Communist schools. Are their souls doomed because they learn from Communist teachers, or teachers using Communist textbooks?

To good Catholics, this can be a matter of spiritual life or death. To citizens of Communist countries, it can be life or death, period.

The Vatican has unhesitatingly its supreme weapon—and the Communists have asked for it. They have attacked the church in all the countries of Eastern Europe, and even in Northern Korea.

The Communists have had a lot of experience at this. The Russian Orthodox church exists today, partly because the Soviets found they could not wipe out religion without wiping out the people who follow it—and partly because the Orthodox church in Russia adjusted itself to Soviet rule.

This is not to say the Roman Catholic Church of today is like the Russian Orthodox church that bowed to the Soviets, except that both are churches and churches that are

Senate Receives Anti-Slump Bill

Prospects For Action Appear Slim During This Session

Washington, July 15—(AP)—The Senate today got a bill aimed at President Truman's target of boosting the nation's output of goods and services to \$300,000,000,000 annually.

The far-reaching "anti-depression" measure was introduced by 15 Democratic senators and two Republicans. But prospects appeared slim for action on it at this session of Congress.

Senator Murray (D-Mont.), the chief sponsor, said the bill "is designed to reverse the present trend toward contraction in business activity."

He said also that it is intended to:

"Promote a steady and stable expansion of our national economy at a rate that, over the next four or five years, will raise the total output of goods and services in America from its present level of \$250 billion to the President's goal of \$300 billion."

Mr. Truman is not waiting for Congress to get the ball rolling on the new program, which still is drawing heavy fire from some lawmakers.

At his news conference yesterday the President announced plans to step up federal buying and construction in areas hardest hit by the business slump.

Mr. Truman announced he had instructed John R. Steelman, presidential assistant, assume full responsibility for the program in these areas. Mr. Truman asked members of the cabinet and the heads of various government agencies to work with Steelman.

Mr. Truman said the program will not require public works funds beyond those already approved or proposed.

X-Ray Unit Will Start Special Work Saturday

Officials of the Pitt County health department announced today that the X-ray unit located at Five Points in Greenville will start taking X-rays Saturday morning at 11 o'clock and the unit will work only with people who have to have new X-rays made because their first ones were not found to be good. The unit will make no pictures of people who have not had an X-ray previously.

The X-ray unit at Five Points will be open only on Saturday and the plans are for the unit to work this Saturday and the next, said Pitt County health department officials today.

If a person receives a card from the department stating that his X-ray was found to be bad they should go to the unit at Five Points to have a new X-ray taken. The person who is having the X-ray made should take his card along, but this is not required. Results of the findings of the X-rays are usually known in a week or two.

House In House Leave No Doubt On Farm Stand

Washington, July 15—(AP)—The House leadership minced no words today in rallying GOP forces against the Brannan Farm bill.

The bill will be debated next week by the House.

In a special notice to the 171 Republicans in the House, Rep. Andrews of Illinois, the GOP whip whose job it is to get out the party vote, said:

"Every Republican who is on his feet and breathing, or shows any signs of life and is free from doctor's orders, must be accounted for x x x and be ready to vote on this all-important and far-reaching legislative proposal.

"We must defeat the Brannan Farm bill. It can be done if all Republicans are on the job."

Treaty Vote

Washington, July 15—(AP)—The Senate agreed today to vote at 4 p. m. (EST) next Thursday on the North Atlantic Security treaty.

Senator Lucas of Illinois, the Democratic leader, obtained the agreement. Senator Donnell, representing opponents, objected when Lucas sought a "y" vote.

Senate leaders are confident the treaty will be approved, though the problem has been to get the debate shut off and take a ballot.

Churchmen Face Treason Charge

Archbishop Beran Accused By Czech Justice Minister

Prague, Czechoslovakia, July 15—(AP)—Justice Minister Alexi Canicka today accused Roman Catholic Archbishop Josef Beran and members of the Preiate's Hierarchy of treason against the state. The Archbishop now is a virtual prisoner in his palace.

The minister made the charge in a long review of the church-state fight in Communist-ruled Czechoslovakia. He spoke before the central action committee of the National front here.

Canicka claimed that Beran maintained "treacherous connections with foreign enemies" and that, with Vatican emissaries, the Archbishop plotted "treacherous and anti-state riots."

The Justice Minister termed this a terrible indictment.

Earlier another official of the government directly attacked Pope Pius XII, accusing the Pontiff of blessing and supporting Fascism.

Although the controlled press has not yet informed the Czechoslovak people—75 per cent of them Catholics—of the Vatican decree excommunicating Communists, Minister of Information Vlastislav Kopecky reflected the Communist anger at the church's action.

Execution Marks End Of Jake Bird's Wanderings

Walla Walla, Wash., July 15—(AP)—Death on the gallows early today ended the bloody wanderings of Jake Bird.

The 48-year-old Negro transient had confessed committing or having knowledge of 44 murders during his cross country roaming.

He was hanged specifically for the ax murder of Mrs. Bertha Kludt in Tacoma, Wash., on Oct. 30, 1947.

Mrs. Kludt and her daughter, Beverly, were slain when they caught Bird prowling around their home.

Bird was born "somewhere out in Louisiana where they ain't no post office" on Dec. 14, 1901. He began his travels when he was about 19. At one time he was listed as being from North Carolina.

During his last days, Bird spent much of his time writing his memoirs, which were turned over to his

attorney for release after the execution.

Although he received little formal education, Bird's legal knowledge enabled him to carry his case through numerous courts and postpone his execution for a year and a half.

He died with an apparent personal fortune of \$6.15, which he willed to his attorney, Murray Taggart of Walla Walla. But during his final days, Bird talked of a "little black box" containing the loot from his burglaries. He said it was in the possession of a friend in Los Angeles, but the identity of the friend was not disclosed.

Shortly after his conviction, Bird startled law enforcement officials by confessing he knew about or took part in 44 killings. Subsequent investigation of leads which he furnished solved at least 11 murders in Iowa, Colorado, Utah, Indiana, Illinois, Nebraska and Washington.

House Writes New Law Defining Animal Furs

Washington, July 15—(AP)—The fur-buying public, in the opinion of the House of Representatives, ought to be acquainted by law with the facts of animal life.

Simply stated, says the House, a rabbit is a rabbit, a muskrat is a muskrat, and a skunk is a skunk, and you can't convert them into a sable, a beaver, an ermine, a marten or even a civet cat.

The House said so, in legislative terms, in a bill passed and sent to the Senate without opposition late yesterday.

Known as the "fur labeling" bill the measure is intended, so its sponsors claimed, to protect not only legitimate fur dealers but the more gullible fur-buying public.

Average Teacher To Receive \$549 Salary Increase

Salary Scales Set By Education Board Provide Average Of \$2,494

Raleigh, N. C., July 15—(AP)—The average North Carolina teacher's pay will be an estimated \$549 higher next year.

Salary scales set yesterday by the State Board of Education in approving next year's budget will provide an estimated average salary of \$2,494, controller Paul A. Reid said.

The average under the old schedules was \$1,945.

For 1950-51, Reid added, the average will rise to an estimated \$2,511.

An overall increase of 28.17 per cent in teachers' salaries for next year was approved.

For A-certificate teachers, the Board fixed a scale of \$2,061 for beginners up to \$2,745 for those with 11 years' experience. Graduate-certificate teachers' pay will range from \$2,322 for those with two years' experience.

The Board approved an overall increase of 23.38 per cent in principals' pay for next year.

Reid estimated the average principal's salary will be \$4,021, compared with \$3,259 the past year.

The Board voted to employ 37,224 teachers in the coming year, compared with 25,640 for 1948-49.

A health program grant of 50 cents per pupil, based on average daily attendance, was voted for each county. In addition, each county will receive a \$1,000 donation.

Unification Bill Gets New Chance

Passage Regarded As 'Cinch' After Reversal In Committee

Washington, July 15—(AP)—Quick passage by Congress of a military unification bill now looks like a cinch.

The House Armed Services Committee nimbly reversed itself on the issue yesterday, and approved a bill to reorganize the armed forces' business-finances affairs. One member said instructions from Minority Leader Joseph W. Martin Jr. (R-Mass.) were partly responsible for the reversal.

Majority Leader McCormack (D-Mass.) announced shortly after the committee vote that the bill is on the House calendar for debate Monday. It is expected to pass without much opposition.

Adding to the pressure was a reminder of Senate interest in unification, expressed by Senator Tydings (D-Md.). He announced that the military pay bill passed by the House will stay on ice in the Senate Armed Services Committee until the House passes the finances bill.

When the House passes it, House and Senate conferees can get together on a compromise bill containing all essential features of the unification bill originally passed by the Senate. That bill bears Tydings' name.

The House committee voted the finances bill out unanimously yesterday after Chairman Vinson (D-Ga.) notified it that President Truman has a military reorganization plan on his desk ready to send to Congress. Vinson said the plan is almost an exact duplicate of the Tydings bill, blocked 13 to 12 by the House committee Tuesday, except for the section on military business management.

Senators Agree To Economies In Military Budget

Washington, July 15—(AP)—Senators agreed tentatively today to slash \$125,000,000 from proposed military spending this fiscal year.

A member of the Senate Appropriations committee, who would not permit use of his name, said cuts of about \$50,000,000 were voted early today at a closed-door session. Another session, at which additional cuts are planned, was scheduled for later today.

The House on April 13 passed a bill providing \$15,900,000,000 cash and contract authority for the army, navy and air force.

Senators who hope to balance the budget during the next 12 months have been concentrating economy efforts on this biggest of all appropriations.

New Record For Auto Production

Detroit, July 15—(AP)—Automotive production in the United States and Canada reached an all-time record output of 155,350 cars and trucks this week, Ward's automotive reports estimated today.

The estimate compares with a previous weekly high of 153,647 vehicles turned out in the week ending May 4, 1929.

U. S. production for this week, estimated at 148,320 units, also is a record, the statistical report said, surpassing the highest weekly volume in 1929.

Steel's Big Three Bow To President

Pitt's Tobacco Crop Considered Best In 20 Years

Crop Yield Estimates Hit Average Of 1,265 Pounds Per Acre In County

Washington, July 15—(AP)—The steel industry's giants bowed to President Truman's insistence today and accepted his plan for dealing with their labor dispute.

Since the million-member CIO United Steelworkers already had accepted it, the action of the "big three" producers headed off for at least 60 days a strike scheduled to begin in some plants at midnight.

Most of the smaller companies already had agreed to Mr. Truman's proposal—that he appoint a three-member board to investigate the wage-pension dispute and make recommendations for a settlement while, meantime, work continues for 60 days.

The big three—U. S. Steel, Bethlehem and Republic—rejected this idea when Mr. Truman advanced it Tuesday. This stand was that he should act under the Taft-Hartley law. That law provides for fact-finding boards but says the boards shall not make recommendations.

In the face of White House pressure, they gave up today—first Bethlehem, No. 3 producer; then Republic, No. 2; and finally, "Big Steel" itself, the U. S. corporation.

All emphasized that they were not to be bound by the board's recommendations. Mr. Truman had not asked that they, or the union, bind themselves to take the board's proposals.

Union locals had their strike orders from CIO President Philip Murray. One major instruction was to not capitulate to the strike.

Already furnaces had been banked in many steel centers, anticipating the walkout.

Last night's success to Mr. Truman from President Benjamin F. Fairless of U. S. Steel seemed to leave the door slightly ajar for more maneuvering before a strike occurred.

Fairless insisted that Mr. Truman was bypassing the Taft-Hartley Act by giving a fact-finding board the right to suggest a settlement. He argued that so long as that law is on the books, Mr. Truman is bound to use it. Inquiry boards under Taft-Hartley are barred from recommending settlement terms.

But Mr. Truman told his news conference yesterday a steel strike would not immediately threaten the national health and safety, and therefore Taft-Hartley emergency powers could not be invoked for some time after a total shutdown.

Mr. Truman, in proposing his own sort of panel, said its recommendations would not bind any of the parties. However, public opinion would be an influence in support of any finding by an impartial agency, in view of the dire threat to the economy from a strike.

Fast Strike Of New York Buses Affects Million

New York, July 15—(AP)—More than a million New Yorkers hurried alternate transportation today after a lightning strike immobilized buses on 30 routes.

Riders who could do so handsily switched to subways, which were put on stepped-up schedules to handle the extra crush. Others hailed taxicabs, if they could find empty ones. Some walked.

The stoppage, touched off yesterday by the lay-off of four New York City Omnibus Corp. mechanics, spread early today to the Fifth Avenue Coach Co., affecting a total of 3,300 workers.

A city-sponsored peace meeting last night failed to bring any agreement between the companies and the CIO Transport Workers Union.

City councilman Michael J. Quill, TWU president, said the union is "digging in for a long strike."

Weapon Of A Church

Excommunication And Its Terrible Significance To A Catholic; Greatest Weapon Is Invoked In War Against Communism; A Theologian Explains What It Means

Washington, July 15—(AP)—A Roman Catholic believes that if he follows his church's teaching and is truly sorry for what he has done, after his death on earth, he will live forever in Heaven.

He is also taught that if he disobeys the church and dies without repentance, he not only loses all hope of Heaven forever but will suffer eternal damnation, or eternal torment.

That is why there is such terrible significance, in the mind of a Catholic, in the order of the Catholic church this week excommunicating any Catholic who helps Communism in any way whatever.

Excommunication cuts a Catholic off from the church entirely and, if, while still excommunicated, he dies without true repentance, he will suffer eternal damnation. That's the Catholic belief.

This was the explanation of the order as given here by a Catholic theologian:

The help a Catholic henceforth is forbidden to give Communism, under pain of excommunication, covers a number of things:

Belonging to a Communist party anywhere in the world, helping Communism in any way, such as voting for party members or contributing to party funds; or even reading Communist literature or newspapers. But the excommunication covers the future, not the past. A Catholic who has been a Communist party member for years—say in Poland or

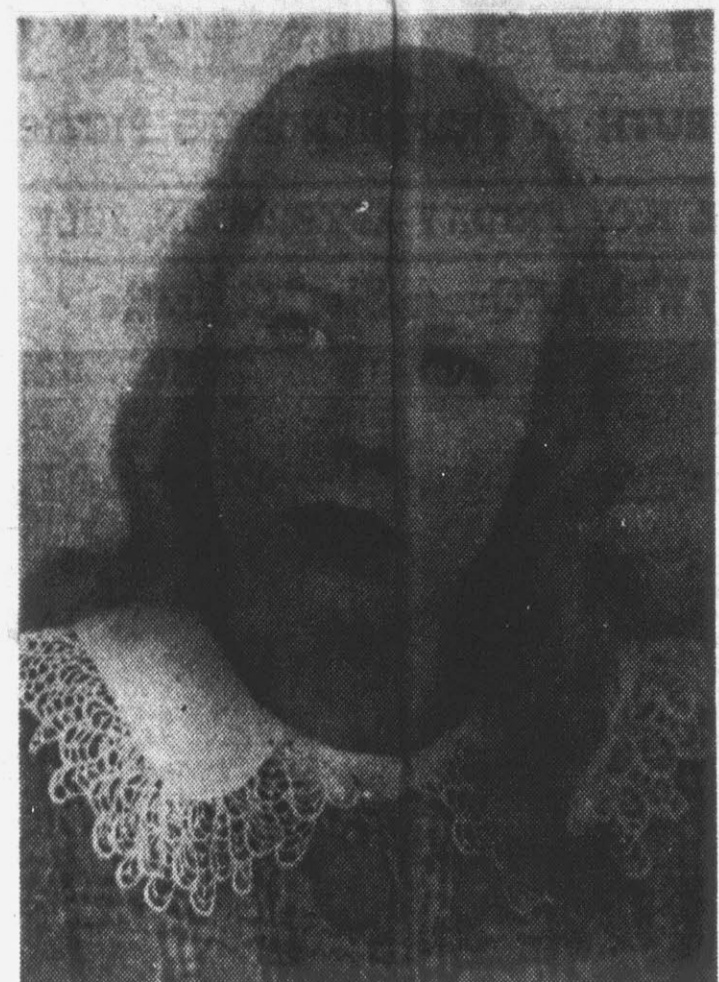

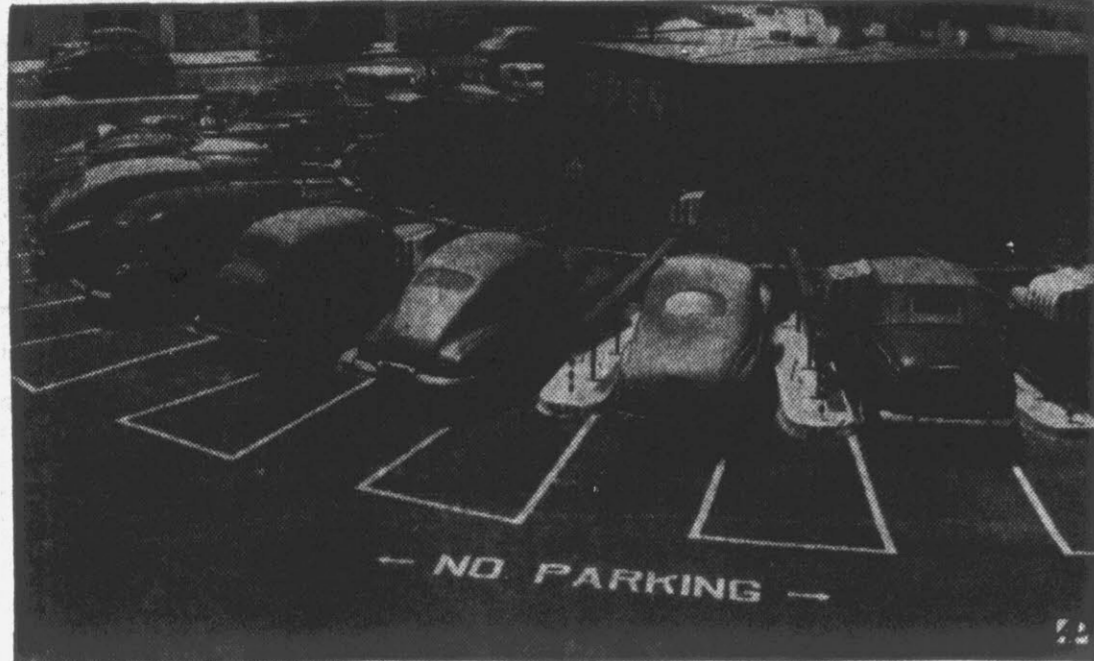
The President's broadcast Wednesday night was carried on all major radio and television networks.

## Gov't Calls For Wheat Reduction

Washington, July 15 — (AP) — A 1950 production program calling for less wheat but more meat animals and dairy products was laid before the nation's wheat farmers by the government today.

A declining foreign market for wheat makes it advisable, Secretary of Agriculture Brannan said, that farmers plant 14,000,000 fewer acres to wheat for 1950 harvest than the nearly 83,000,000 seeded for this year's crop.

The acres taken out of wheat should be put to grass and pasture for grazing of beef and dairy cattle, sheep and lambs, he said, because consumers need more of the latter products.

Under the 1950 program, each farmer will be given a share of a national wheat planting allotment of 68,900,000 acres. His share will be based upon his past production history. Areas which greatly expanded their acreages since the war will take a larger cut than others.

Compliance with an allotment is not required by law. However, those who do comply will be eligible for support aid on their 1950 wheat. The price support program is expected to assure complying farmers an average of about \$1.25 a bushel.

Failure of farmers to comply, Brannan said, might well bring on a glutted wheat market, disastrous price breaks and an undue burden on the price support program.

West, a cafe owner, is charged with assault with a pistol on Hatlie Cooke, a High Point Negro.

The case, scheduled for trial in municipal court yesterday, was postponed because the woman is still in a hospital.

# N. C. Puts Into Effect School Health Program

By LYNN NISBET  
Raleigh, July 15.—Adoption by the state board of education of a plan for spending \$876,211 appropriated by the recent legislature for public health work in the schools assures major control on local level.

The general assembly provided for the state board of health \$326,211 to be allocated to county health departments for use in public schools. The board of health has already set up rules governing distribution and use of that sum. The legislature also, for first time in history, appropriated \$550,000 for use by the state board of education in public school health work. It was that item the board dealt with Thursday.

The plan adopted calls for allocation of something more than \$400,000 on basis of fifty cents per school child enrolled. Another \$100,000 will be distributed at rate of a flat \$1,000 to each county, regardless of size or school enrollment. It was explained that under this plan the smaller counties would have a lot more per child to meet what is generally conceded greater need. Two illustrations were given: Camden, with school enrollment just above 1,000, get \$500 on state allocation and \$1,000 on county basis, approximately \$3.00 per child. Johnston county, with some 18,000 school children, will get \$9,000 on state allocation and \$1,000 on county basis, or about 55c per pupil enrolled. State

Superintendent Clyde Erwin said there would be a few thousand dollars to be used as an adjustment or equalization fund in unusual cases. While some public health work has been carried on in connection with the public schools, this is the first time there has been enough money to do anything like a decent job. While the state boards will exercise considerable supervision, administration of the program is primarily in hands of local agencies.

# Five Young Imps Are Six Today

Buenos Aires, July 15.—(AP)—The Dilliganti's "five young imps," as their father calls the quintuplets, are six today—that is six years old.

Their household will realize it better tomorrow because they are in school today. Franco Dilliganti, parental boss of the two boys and three girls, postponed their sixth anniversary party so the hilarity would not interfere with their education. Franco Jr., Carlos Albert, Maria Fernanda, Maria Ester and Maria Christina Dilliganti—the precocious and peppy youngsters—are expected to keep a large staff of servants on the go, when they celebrate tomorrow. Papa Dilliganti says they really tear the house apart when they get started.

They all speak English and French and their mother's native tongue, Italian, in addition to Spanish. But they are not bookworms. They will be separated for schooling next year—the boys attending one school and the girls another.

"I couldn't inflict those five young imps on one boarding school," says Dilliganti, wealthy textile manufacturer. "They all would be packed home within a couple of days."

# Membership Of U. S. Churches At Record Level

New York, July 15.—(AP)—Church membership today includes one out of every two Americans—the largest proportion in the nation's history. The figures were disclosed in the foreword of the 1948 issue of the yearbook of American Churches, made public yesterday by the Federal Council of the Churches of Christ in America. About 76,000,000 Americans now are church members, out of an estimated 148,000,000 population. Only one American in 15 was listed on church rolls 150 years ago. In round numbers, here is the count given for some faiths: Protestants, 45,000,000; Roman Catholics 25,000,000; Jews 5,000,000; Eastern Orthodox, 1,000,000.

The additional inspectors will go to markets which are already established and want additional sales. They also will be sent to centers where efforts are being made to establish markets.

Volume of sales will determine whether the individual center will retain the additional inspection service, a department spokesman said. North Carolina cities receiving the temporary service include: Winston, Goldsboro, Wilson, Rocky Mount, Smithfield, Windsor, Farmville, Greenville, Whiteville, Lumberton, Durham, Ellerbe, Winston-Salem and Greensboro.

# Scott Tries New Tactics On His Political Foes

Raleigh, N. C., July 15.—(AP)—Governor Scott has taken a new attack in trying to fire J. Harris Sample from his \$7,920 a year state job.

Sample, director of the state probation commission, was anti-Scott in last summer's red-hot gubernatorial fight. Since assuming office, and even before, Scott let it be known that he did not want Sample in his administration. But through technicalities, Sample has hung on.

Scott's latest method of discouraging Sample from keeping his job came to light yesterday. Under repeated questioning, state auditor Henry Bridges admitted he had received during the day a letter from the Governor concerning Sample.

It ordered him, Bridges said, to stop Sample's pay effective July 26, the day after state employees receive their monthly pay.

The story was broken yesterday by the Asheville Times, which publishes in Samples' home town. The Times reported that the above letter had been sent to Bridges by the Governor.

Efforts to reach the Governor were parried by his staff, which said the Governor was "unreachable by telephone" and unavailable. Later it became known that Scott had flown to Missouri to look over a purchase of cattle the Governor made on his recent trip to the National Governors conference in Colorado. He wanted to inspect the cattle before they were shipped to his Haw River farm.

He was expected to return today. Technically, the director of the probation commission is named by the commission with the approval of the Governor.

However, the commission, friendly to Sample, has taken the attitude that no vacancy exists in the office. The law providing for the director's job does not specify the length of his office.

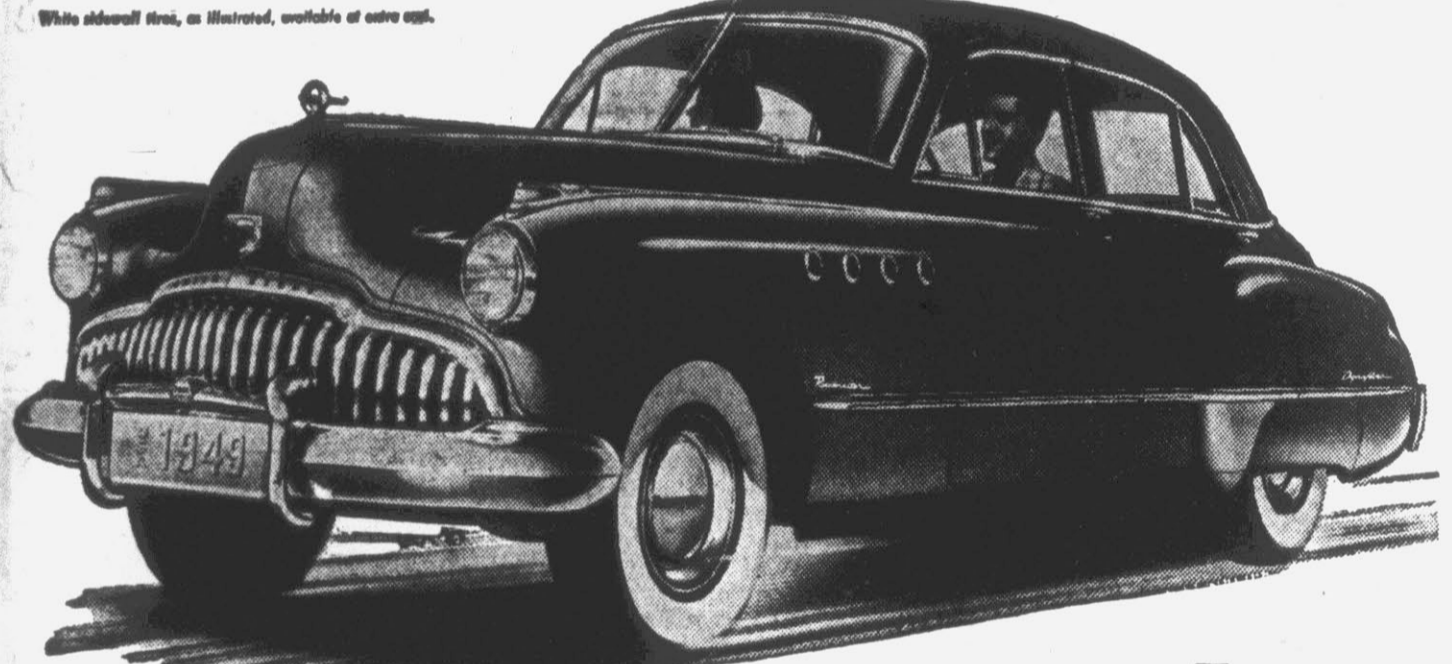

"Ken," she confided, as they walked toward Betsy, "I'm afraid this is going to be the worst job of all. I wish it were over."

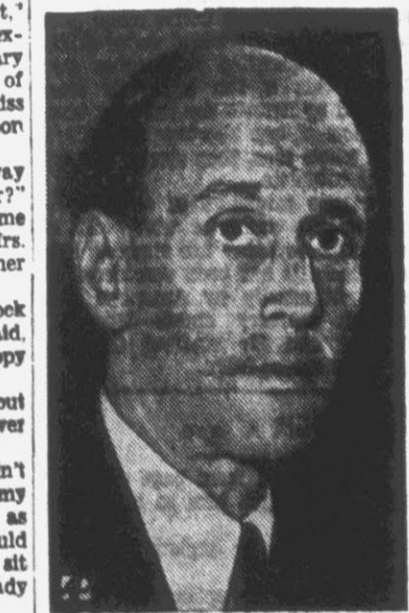
Her conscience smote her when she thought of her father, still weak from his illness. At least I could have told him ahead of time what I was going to do, she thought.

# Demented Slayer Climbs Down From Watertower

Lima, O., July 15—(AP)—Raymond Jutla, the demented slayer, was tired and sunburned after his 20 hours atop the state hospital's 130-foot water tower.

He also was happy—and remorseful.

"Doc, I'm awful sorry for all the trouble I've caused you," he told Dr. R. E. Bushong, hospital superintendent.

The 35-year-old insane killer came down yesterday from his perch on top of the watertower at Lima state hospital for the criminal insane. He was happy after being assured "released convicts" would not harm his family.

The family had not been threat-

ened, Dr. Bushong said; Jutla's fear was just a mental delusion.

The Warren, O., man had scampered up the tower Wednesday morning. He refused to come down until protection against "some released convicts" was furnished his family.

To assure the "protection," Jutla demanded that Police Chief William Johnson of Warren, send him a telegram. The message, he insisted, had to be delivered by a uniformed Western Union messenger.

When the telegram was delivered, Jutla kept his word. He climbed down the ladder.

The message from Chief Johnson read:

"I have seen your father, mother, sister and wife. They are all O.K. They want you to come down from the tower immediately."

When he reached the ground, Jutla posed silently while news photographers snapped pictures. Then he walked to the hospital.

As a reward, the insane killer was to be permitted today a visit with his mother, Mrs. John Jutla, and a sister, Mrs. Marie Dawson, both of Warren.

## Growers Discuss Tobacco, Corn

Tobacco and corn growers from various sections of Pitt county gathered at the Speight seed farm near Winterville yesterday afternoon for field meeting on the production of hybrid corn and tobacco.

Dr. R. B. Moore, director of the North Carolina crop improvement association, discussed with the farmers in detail hybrid seed corn production and explained to the farmers how the various strains and varieties of hybrid corn are developed.

During the tour of the farm, the farmers observed feed corn planted from last year's hybrid seed growing in the fields, and also observed corn variety tests which compared N.C. 27, Dixie 17, N.C. 1032 and Jarvis and Latham-double varieties of corn. A spokesman for the farm said the yields from these tests will be taken to compare the production qualities of the individual varieties.

## Britain May Ask U. S. To Join In Huge Trade Pact

London, July 15—(AP)—Britain and her dominions may ask the United States to join them in a two-way multi-million dollar trade pact to help solve the world dollar crisis.

Highly qualified informants said today this is the approach most offered by Britain for the long term solution of her shortage of dollars. The whole idea, they stressed, is far from complete.

Finance ministers of eight commonwealth countries who were in session here today are studying this approach. It has been considered at least informally by American and British treasury chiefs—John W. Snyder and Sir Stafford Cripps—at their recent talks.

## "Nobody Knows What Trouble Policemen See"

"Nobody knows what trouble I see," a policeman said yesterday, when he was called to lasso or capture a mule wandering around the territory of Library street.

Another policeman, called to the Bama section of Greenville, that's in the south, to capture some hogs that had strayed from their pens, recalled some of the duties he had to perform while in the armed forces.

Another Greenville policeman, and he was on the police radio cruising car, talked out loud when he answered three different calls to neighborhoods where stray dogs were a nuisance. An officer on duty from midnight to dawn, chirped some interesting opinions when he said he had settled two family arguments near midnight, when the waning moon was still shining.

This job of policing is a hard task. This reporter knows its technique, because he rides around as an observer in police and state highway patrol cars at night. Out on the circuit of patrolling the "beats," as police and other officers say, one gets a convincing impression that law enforcement officers, sheriff police, ABC officers, township constables and others, do a lot more toward preventing law violations than they do in serving warrants for somebody's arrest.

Incidentally, the Pitt county sheriff's cars and the Greenville police cars are "in tune" on the radio. When they get a message that there's trouble somewhere, they work together, communicate with police headquarters, inform the state highway patrolmen, and then there's action. "It is this cooperation among law enforcement officers that contributes so much to the good order which generally prevails in Pitt county," State Highway Patrol Lieut. Lester Jones said today.

## 'Big Inch' Pipe Line Explodes, One Youth Slain

West Chester, Pa., July 15—(AP)—An explosion on the Big Inch pipe line today killed one youth and injured two others.

Dead was Lewis (Pete) Keller, 21-year-old triple-threat athlete from West Chester who planned to enter Duke University this fall.

The Texas Eastland Transmission Corporation, which operates the natural gas-carrying pipe line, shoored reporters off the scene of the blast at nearby Eagle, Pa., and declined to make public the cause of the blast.

News men were told, before they were ordered from the scene, that the victims were working in a small building cleaning equipment when the blast occurred this morning.
