Economy Drive Is Worrying Solons

Senators Concerned Over Threatened Reduction In Foreign Arms Program; Lucas Sees Close Vote Late Today; Connally Cautious; Critics Hit Program

Washington, Sept. 22—(AP)—Senate leaders showed concern today at a fast-gaining economy drive which threatened to make a \$500,000,000 cut in the Foreign Arms program.

Democratic leader Lucas of Illinois conceded the vote would be close on amendments by Senator George (D-Ga.) to slice in half the \$1,000,000,000 earmarked in the program for North Atlantic pact nations.

"But I think we have the votes to beat them," Lucas told reporters.

By agreement, the Senate was to begin voting at 5 p. m. EST. on the \$1,000,000,000 plan to re-arm friendly nations in the fight against Communism.

Chairman Connally cautiously avoided predicting defeat for the George amendment. He was obviously not as confident as he had been earlier in the week when he opened the debate on the bill.

Critics hammered hard at the spending program yesterday. George and Senator Byrd (D-Va.) led the assault with other Senators joining in during the day.

The George-Byrd attack centered on government spending which they said threatened to undermine the strength of the United States. If the United States is weakened, they argued, then all hope for peace will be lost.

George favors an arms program—but thinks the present plan is too big. Byrd is opposed to any arms program.

Senator Gillette (D-Iowa) joined the opposition today by declaring the arms program will commit this country for years to a policy of militarism and force. Gillette said in a statement:

"It is a down-payment on a policy limitless in the sums which it can consume and in the length of its duration. We are not voting the question of a billion or two billion—the dimensions of the military assistance program are infinity and eternity."

As the bill now stands, it would authorize \$500,000,000 in cash and \$500,000,000 in contract authority for the Atlantic pact nations. The remaining \$3,400,000,000 would be divided among Greece, Turkey, Korea, Iran, the Philippines, and the China area.

The George amendments would cut the cash spending to \$300,000,000 and reduce the contract authority to \$200,000,000 and give Congress equal power with the President to review any Atlantic defense plans.

If George fails to cut \$200,000,000 in cash from the total, then Senator Knowland (R-Calif.) will try to mount the program by the same amount—but half in cash and half in contract authority.

Farm Land Value Drop Reported

Washington, Sept. 22—(AP)—Farm land values declined in all southern states by Maryland during the four months ending June 30. The declines, an Agriculture Department report says, ranged from one percent in North Carolina, Kentucky and Tennessee to six percent in Virginia.

China's First Lady

Madame Chiang Kai-Shek Certain That Nationalist China Can Ultimately Cope With Communistic Crisis; Will Return To China Soon; Going Back Into War Duties

Madame Chiang Kai-Shek still has faith in Nationalist China's ability to cope with the life and death crisis created by the southward sweep of the victorious Communist war machine.

The first lady of China made this statement to me in the course of a long conversation I had with her in New York. While this meeting wasn't a newspaper interview in the accepted sense of the term, it is permitted to give my impressions.

Madame Chiang has no doubt that the Nationalist forces will reclaim the territories lost in the north. How long will this great operation require? She doesn't know; she is only sure that it will be achieved. In support of this belief she recalled that during the war with Japan the Chinese armies were forced back to approximately the same line they now hold—and flung the invaders back.

She feels certain that the people of China as a whole do not believe in Communism or trust it, though many are submissive to it now because of circumstances over which they have no control.

Believe Arrests Prevented Flood Of Fake Stamps

Trio Allegedly Plotted To Print Ten Million Counterfeit Stamps

New York, Sept. 22—(AP)—Three printing executives were under arrest today in an alleged plot to put 10,000,000 fake 3-cent stamps into circulation through a national counterfeiting ring.

The three, described by federal authorities as "former reputable businessmen," are:

Saul Schackman, 35, of (86 West 33rd St.), Bayonne, N.J., operator of a printing shop at 120 Monticello Avenue, Jersey City, N.J.

Philip Schwartz, 31, and Nicholas Frasca, 45, both of the Bronx, co-partners in the Manhattan Photo-Plates, Inc., at 19 Warren Street in Lower Manhattan.

The latter firm, whose authorities said part of the counterfeiting operation was carried on, is situated only a few steps from U. S. Secret Service headquarters.

The three men, after their arrests yesterday at their homes, were arraigned before U. S. Commissioner Edward W. McDonald and held in bail of \$50,000 each.

Assistant U. S. Attorney Roy M. Cohn said the three were linked with a national counterfeit ring allegedly run by Michael Malone and the Barra brothers, Joseph and Morris.

At Schackman's Jersey City plant, federal agents said, they seized a big press, counterfeit engraving plates and a half-ton of prepared paper that would have yielded 4,000,000 stamps.

Other material was seized at the New York plant that with the arrest of the trio the counterfeit ring is smashed—smashed before any on the millions of stamps could be sold.

Says Remains Of St. Peter Found Buried In Crypt

Southampton, England, Sept. 22—(AP)—The Roman Catholic Archbishop of New Orleans said today the remains of St. Peter have "definitely" been found in a tomb in the St. Peter's Basilica in Rome.

The most Rev. Joseph P. Rummell spoke to reporters just before he boarded the Queen Mary for New York after a pilgrimage to the Vatican.

Pope Pius has long entertained the theory that St. Peter's remains were buried in a crypt in St. Peter's church.

In preparation for Holy Year, 1950, he is reported to have ordered an effort to prove the theory. "There are very significant circumstances about the crypt in St. Peter's church," Archbishop Rummell said.

Three Eastern Tobacco Marts Halt Rump Sale

Raleigh, N. C., Sept. 22—(AP)—In accordance with a Superior court injunction, three Eastern North Carolina tobacco markets have discontinued rump tobacco sales.

Rocky Mount, Kinston, and Smithfield stopped their rump sales yesterday, one day after the injunction was issued by Judge J. Paul Frizzelle.

The injunction had been requested by the Bright Belt Warehouse Association. Rump sales occur when an inadequate set of buyers is present at a tobacco warehouse auction.

The Association defined an adequate set of buyers as buyers from each of the three major buying companies and buyers from at least three other recognized companies.

Judge Frizzelle adopted the definition in his injunction order. The injunction barred the Rocky Mount warehouses—there are 14 warehouses there—to walk out of the Association. They were scheduled to meet today to decide whether to appeal the injunction.

The three markets had been attempting to expand their operations by increasing the number of sales they wanted. Rocky Mount and Kinston wanted to increase their sales from four to five and the Smithfield market its sales from two to three.

The extra sales, however, did not attract enough buyers to conform with the Bright Belt Association's definition of an adequate set of buyers.

Electricity Cut Off Briefly By Short Circuit

Several sections of Greenville were without power for a brief time last night when a transformer section located on Fourth Street in the up-town business section was put out of service due to a fire resulting from the short circuit.

Power was off in section of the business district and on Dickinson Avenue for about 33 minutes before crews from the Greenville Utilities plant could restore service.

Greenville firemen who answered a telephone call to the burning power unit quickly put the blaze out. The power went out shortly after 7:00 o'clock but all sections had power within a four hour period.

China Asks UN Act Quickly To Halt Communism

Warn Far East May Be Engulfed; Charge Russia Directing Chinese Reds

New York, Sept. 22—(AP)—China called on the United Nations Assembly today to act quickly to prevent communism from engulfing China and the entire Far East. For the first time, China also charged that Russia was directing the Chinese Communists.

China's chief delegate, Dr. T. F. Tsiang, told the 59 national delegations that the North Atlantic pact had halted the flow of communism across Europe, but there was no such barrier in the East.

"The Chinese Communist party," he said, "is an integral part of the international Communist movement. It is as fanatical as Communists elsewhere. Its propaganda is always in tune with Moscow propaganda. Its action is always in step with Moscow's action."

Tsiang spoke less than 24 hours after the Chinese Communists proclaimed at Peiping the establishment of a Communist Peoples Republic of China.

He devoted almost his entire speech to an attack on communism. Then he made his appeal for help.

"I ask the General Assembly," he said, "to ponder over the present situation in the Far East and the grave dangers to world peace and security."

"I appeal to the General Assembly to be brave enough to embrace the vision of an indivisible world and not to retreat to the false illusory security of half a world."

He asserted the Soviet Union already had obtained more in Manchuria than Czarist Russia ever tried to seize. He added:

"In addition, the Soviet Union, through the Chinese Communist party, has an instrument and a lever with which to undermine the independence and integrity of China and the peace of the Far East."

'Richest Bride' To Wed Again

London, Sept. 22—(AP)—Cornelia Mary Vanderbilt, once called the world's richest bride, plans to be a bride again.

The great-granddaughter of old Commodore Cornelius Vanderbilt is to marry a 58-year-old London banker, Vivian Francis Bulkeley-Johnson.

In a formal notice of intention too wed, filed at Kensington registry office, her age is given as 43. Newspaper morgues indicate she is 49.

Fell Victim To Own Good Deed

Columbus, Ga., Sept. 22—(AP)—For two years tall grass had obscured a fire hydrant. Motorists parked by the hydrant plug with never a protest from police.

Civic-minded Horace Gordon, who worked nearby saw his duty and chopped the grass.

Then in an unguarded moment Gordon parked his own car by the hydrant. He was the traffic court's first customer from the newly exposed plug. He paid a \$6 fine.

Business Hopes Grew In August

New York, Sept. 22—(AP)—Business optimism over prospects for the rest of 1949 took an upward turn in August, a Dun & Bradstreet survey reported today.

Opinions of 1,154 business executives were polled in the fifth such "business expectations" survey conducted by the business reporting agency. Previous surveys in June and July had indicated a leveling off of sentiment or a more optimistic trend from the May low point.

Charge Doctor In Drug Smuggling

Junction City, Kas., Sept. 22—(AP)—A Kansas Board of Health member was accused today of supplying narcotics smuggled into the Colorado state penitentiary.

The Board of Health member is Dr. Hugh A. Pope. Federal agents arrested him yesterday at his drug store in Hunter, Kas.

No-Drink Pledge Candidate Wins

Atlanta, Sept. 22—(AP)—Councilman Joe Allen, who has pledged himself not to drink again in public, has the Democratic nomination for another four years.

Allen yesterday defeated W. C. Campbell by approximately 3,000 votes for the second ward council seat.

'Fast Time' Ends

New York, Sept. 22—(AP)—Daylight saving, the summer dividend of an extra hour of evening recreation for some 50,000 Americans, ends this Sunday.

The official time for turning back the clock an hour is nearly a "fast time" zone is 2 a. m. Sunday.

Thus the hour of sleep lost April 24 will be regained this Saturday night.

Daylight saving was observed in most of the Northeastern sector of the country this year and in several large cities of the middle East. It was shunned in the South, and in most of the middle west and far west.

Cannon Testifies At Trial Today

Claims Police Court Solicitor Was About 'Half Tight'

Asheville, Sept. 22—(AP)—Handsome, well dressed Vaughan Cannon, accused gambler, testified today that the solicitor of police court was "about half tight" when, he said, they had a fight last Aug. 14.

Cannon testified at his trial in Superior Court on assault charges. He is accused of beating and kicking Police Court Solicitor Will Hampton. Hampton assisted several weeks ago in prosecuting Cannon on gambling law charges. Subsequently Cannon pleaded guilty in Superior Court to possession of pin ball machines and was fined \$5,000 and given a one-year sentence, suspended two years on good behavior.

Cannon said he went to Ches Paul, north side night spot, to collect \$700 from Ralph Overton, one of Hampton's companions. He said that Hampton, Overton and the establishment's proprietor, Paul Houelle, all "had a pretty good load on."

Cannon said Hampton and Houelle "kidded" him about his police trial. He said he left temporarily and that upon his return Houelle struck him with his fist from the rear and dazed him. That, he said, set off a general fist fight.

J. Walter Haynes, the special prosecutor in Cannon's previous trial, in cross-examination questioned the tall, erect defendant about the gambling trial. Cannon said he pleaded guilty in Superior Court after a police trial that had lasted more than 30 days.

Sam Wood, Top Hollywood Film Director, Dies

Hollywood, Sept. 22—(AP)—Sam Wood, 68, one of the movie's best-known directors, died today of a heart attack.

His death was the third among movie notables in less than a week. Comedian Frank Morgan and Actor Richard Dix were the others. Wood directed Morgan recently in "The Stratton Story."

Wood's studio disclosed that he lived less than two hours after an early-morning heart attack. He succumbed in a hospital.

Wood, a native of Philadelphia, spanned the era from silent pictures into sound. In the old days, he megaphoned such notables as the late Wallace Reid, Jackie Coogan and Gloria Swanson. In recent years, probably his most notable achievement was directing "For Whom the Bell Tolls."

Wam Two Hurricanes In Caribbean And Gulf

Miami, Fla., Sept. 22—(AP)—Two potentially dangerous tropical storms—one a full fledged hurricane, both weakening in strength—churned near land in widely separated sections today.

The entire Texas coast remained on the alert as a still undeveloped storm walked through the Gulf of Mexico about 170 miles south of Galveston.

Residents of the southern and eastern sides of Hispaniola—the Dominican Republic and Haiti—and the southwest tip of Puerto Rico watched anxiously as a larger and stronger disturbance moved west northwestward along a path about 35 miles east of San Pedro.

The Caribbean storm, about a thousand miles southeast of Florida, showed evidences of weakening. The Weather Bureau at San Juan reported at 5 a. m. (EST).

All interests in the Dominican Republic and surrounding waters were warned, however, to take extreme precautions "as this may continue to be a dangerous storm."

It was moving at about 12 to 15 miles an hour. Its location was a matter of guesswork early today but the San Juan weather station believed its estimate position to be within one-half of one degree accuracy.

Hurricane winds (75 miles an hour or more) were over only a small area near the center, and further weakening was expected as the storm moved inland.

No FEPC Moves Predicted This Year By Thomas

Signs Develop Demo Leadership To Shelve Controversial Programs

Washington, Sept. 22—(AP)—Chairman Elbert Thomas (D-Utah) said today he has told the Senate Labor committee there will be no action at this session on controversial legislation to create a fair employment commission.

Thomas talked to reporters about the matter while signs developed that the Democratic leadership might decide to let all of President Truman's hotly disputed civil rights program stay on the shelf until next year.

Senator Lucas (D-M) the majority chief, is standing by his statement that there still is a chance one of the civil rights measures will be called up for action before adjournment.

The party leaders, however, reportedly are only lukewarm about forcing a test which they feel inevitably would touch off a Southern filibuster and prolong adjournment.

Some members of the Democratic high command are known to feel also that a session-end attempt to put a bill through might fail because absenteeism usually runs high as adjournment nears. Under a new Senate rule, limitation of debate to end a filibuster requires a constitutional majority of 64 Senators.

A week ago a Senate Labor subcommittee approved, 2 to 2, an administration bill to set up a fair employment practices commission.

The bill states that the right to employment without discrimination because of race, creed or color "is a right of all persons within the jurisdiction of the United States, and that it is the national policy to protect the right of the individual to be free from such discrimination."

The measure is perhaps the most controversial of Mr. Truman's civil rights program, which calls also for such things as anti-poll tax and anti-lynch legislation.

Labor Law Plans Go Into Discard

No New Labor Legislation Seen For House Through 1950

Washington, Sept. 22—(AP)—House leaders appear to have written off chances for getting a new labor law through Congress—not only for this year, but for 1950 as well.

Chairman Lesinski (D-Mich) of the House Labor Committee said today his committee will take no further action on Taft-Hartley repeal—now, or at the next session starting in January.

With demands for some new legislation almost certain if the nation's strike picture worsens, Lesinski told reporters:

"Unless the attitude of the House changes, we don't intend to try to report out another labor bill."

And with the 1950 election campaign already warming up, Lesinski said he doesn't look for any immediate change in attitude.

Early in the session the House rejected the administration's labor bill and sent a substitute measure back to committee, leaving it with no labor legislation pending.

The Senate passed a bill containing many of the features of the union-hated Taft-Hartley law. The House hasn't acted on the Senate bill and leaders have indicated no intention of doing so.

President Truman, who campaigned for Taft-Hartley repeal in the 1948 presidential election, said recently that the administration will fight to the bitter end to wipe that measure off the books.

Ingrid's Lawyer To See Husband

Hollywood, Sept. 22—(AP)—Ingrid Bergman's Rome lawyer is in town today apparently for divorce talks with the actress' husband, Dr. Peter Lindstrom.

Monroe E. McDonald, an American citizen who practices law in Rome, Italy, and calls himself an "international counselor," said this about his visit:

"I am here to handle a number of personal matters for Miss Bergman. You can draw your own conclusions."

Steelworkers Again Delay Nationwide Steel Walkout

Peace Prospects In Coal Dispute Fading

Northern And Western Operators Vain For Time, Watching Steel Dispute; Details Of Negotiations Not Revealed

White Sulphur Springs, W. Va., Sept. 22—(AP)—Chances for an early settlement of the coal strike faded today even though Southern mine owners hinted they were getting ready to make up the back payments to the United Mine Workers welfare fund.

It was the refusal of some Southern operators to pay up that touched off the walkout of 480,000 coal diggers last Monday.

Northern and Western coal operators meeting here with John L. Lewis sparred for time, watching developments in the steel dispute. Union sources said the mine owners virtually announced they would do no business until there was more clarification of the steel controversy.

The steel industry is opposing the type of pension proposed by a presidential fact-finding board financed by employers alone. The future of Lewis' pension system built on employer royalties currently at 20 cents a ton may rest on the ultimate settlement in steel.

Neither Lewis nor the operators would discuss details of their negotiations here yesterday beyond the union declaration that the operators were trying to delay the talks.

The Lewis camp gave some signs that the mine leader would use that as the basis for a blast at the operators before a week end recess.

A prominent West Virginia operator beat the UMW leader to the punch. President D. W. Martin of the Kanawha Coal Operators Association declared that Lewis, "seemingly afraid of public sentiment," had dodged responsibility for calling the strike.

Martin contended the miners were financially unprepared for the walkout. He predicted that "before the first week of the strike ends garnishments of earned wages by the miners will be floating through the mining districts thicker than flying saucers."

At Bluefield, W. Va., where Southern Coal Producers Association members are negotiating with a union team, the issue of paying the 20-cent royalty was at the top of the agenda.

Decision Looms On Recognition

U. S. Must Decide Soon On Policy For Red China Gov't

Washington, Sept. 22—(AP)—Formation of a Communist government in China brought a bit closer today the time when the United States must decide whether to recognize such a regime.

At the moment, however, American officials say that the issue of recognition is not raised by the announcement of the new government made in Peiping yesterday by Communist leader Mao Tse-Tung.

What is expected is that when the Communists have completed their government's organization they will make a bid to establish formal diplomatic relations and Russia or one of its satellite countries will be the first to accept and agree to open embassies at the Communist capital.

The recognition issue is understood to have been discussed here last week by Secretary of State Acheson, British Foreign Minister Bevin and French Foreign Minister Schuman during their review of the whole Far Eastern situation.

They agreed then that they would discuss the possibility of taking parallel actions when the Chinese Communists assert their claim to be recognized. They agreed not to act hastily in the matter.

Acheson is thus committed to consult with the other western powers before making any decision. He has also promised the Senate Foreign relations committee that he will consult with Congressional leaders before a policy decision is made.

He bequeathed 10 per cent to his sister, Mrs. Zoila W. Cook, Santa Barbara, Calif. Morgan died last Sunday at the age of 59.

The will provided no specific amount for the actor's son, George, 33, but specified that trustees could give the son up to 25 per cent of the trust estate to enable him to start a business.

Union's Policy Making Committee Joins In Accepting President Truman's Plea For Extension Of Strike Truce Until Saturday

Pittsburgh, Sept. 22—(AP)—Philip Murray's CIO United Steelworkers today put off for another week the nationwide steel strike set for Saturday midnight.

The million-member union's policy making committee joined industry in accepting President Truman's plea for extension of the strike truce until 12:01 a. m. Saturday, Oct. 1 to permit renewed contract talks.

The action came as wildcat walkouts shut down two Pittsburgh steel plants and idled 2400 workers. Picketers carried signs demanding "strike—no more extension," and "strike—free pensions."

Murray and the industry deadlocked on acceptance of a Presidential board's peace recommendations that the steelworkers get company financed insurance and pensions. The Union accepted. Industry objected to footing the bill and refused to be bound by the report without bargaining. They've been feuding since.

Mr. Truman intervened to stave off the week-end strike. In addition to truce extension, he called for direct bargaining and early settlement.

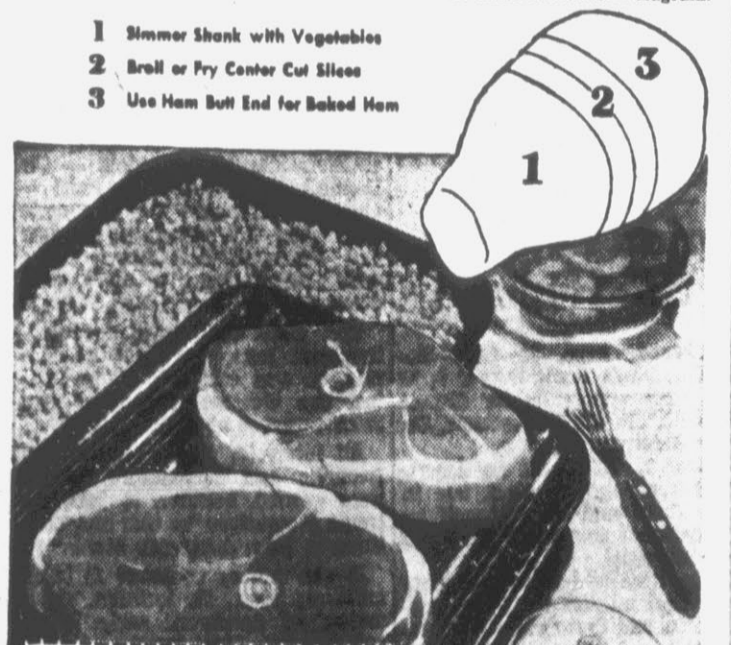

In the indictments handed down yesterday by a county grand jury, in 1949.

Lillie was charged with hurling a stone through a window. The technical count is malicious mischief, a misdemeanor.

Four others, charged with overturning a parked car, were accused of felonious malicious mischief.

The indictments came as Westchester district attorney George M. Fanelli announced a full-scale grand jury investigation into the violence will begin Oct. 3.

India Will Ignore Travel In Space

New Delhi, India—(AP)—A suggestion that the Indian constitution provide the government with powers to regulate inter-planetary travel died like a damp rocket in the Constituent Assembly here.

Most members kept their feet on the ground as H. V. Kamath argued that interplanetary travel was a scientific possibility. He was supported only by Naziruddin Ahmed, who thought the government ought to have powers over travel between planets and their satellites as well.

Law Minister B. B. Ambedkar, who drafted the constitution now under discussion ended the debate by remarking that if the proposed related to matters unknown, the assembly was wasting its time in discussing it. None of the members was prepared to explain how inter-planetary travel might be achieved.

China Reds Move On City Of Amoy

Canton, Sept. 22—(AP)—Chinese communist forces moved on the big southeastern seaport of Amoy today.

The Nationalists yielded ground in the mainland area northeast of the island where the former treaty port is situated 330 miles east-northeast of Canton.

Dispatches said the Nationalists blew up a bridge spanning the Chiling River 20 miles northwest of Amoy, which is mainland headquarters for the Nationalist south-east China command.

In nearby Kwangtung province, a mixed Red force of 3,000 regulars and irregulars was reported entrenching in the mountains near Yungyun, 105 miles north-northeast of Canton.

Reports from the northern front in Hunan province claimed 700 Red irregulars surrendered to the Nationalists who recaptured Jucheng Tuesday. Jucheng is 170 miles north of Canton.

In Canton, the dismissal of two important Nationalist commanders was expected shortly on charges of corruption and inefficiency.

Cordova, Alaska, Sept. 22—(AP)—Civilization has come to Cordova. The newly organized Klwanis Club will receive its charter Friday night—putting an end to Cordovans' claim that this is probably the only city under the American flag without a luncheon club.

"Leave her till I die. It won't be long."

Instead of waiting wearily for release, he is eager to be back on the job tomorrow. What is dull and tedious to others is interesting, engrossing, perhaps even romantic to him.

If you are imprisoned by your work, look again. In your own attitude towards it lies the key that can free you.

DO YOU STILL WANT RENT CONTROL?

The Greenville Board of Aldermen has called a public hearing for next Tuesday evening in the recorder's courtroom of the Municipal building. The purpose: To determine whether there is now a housing shortage in Greenville and to discuss the advisability of ending rent control in the city.

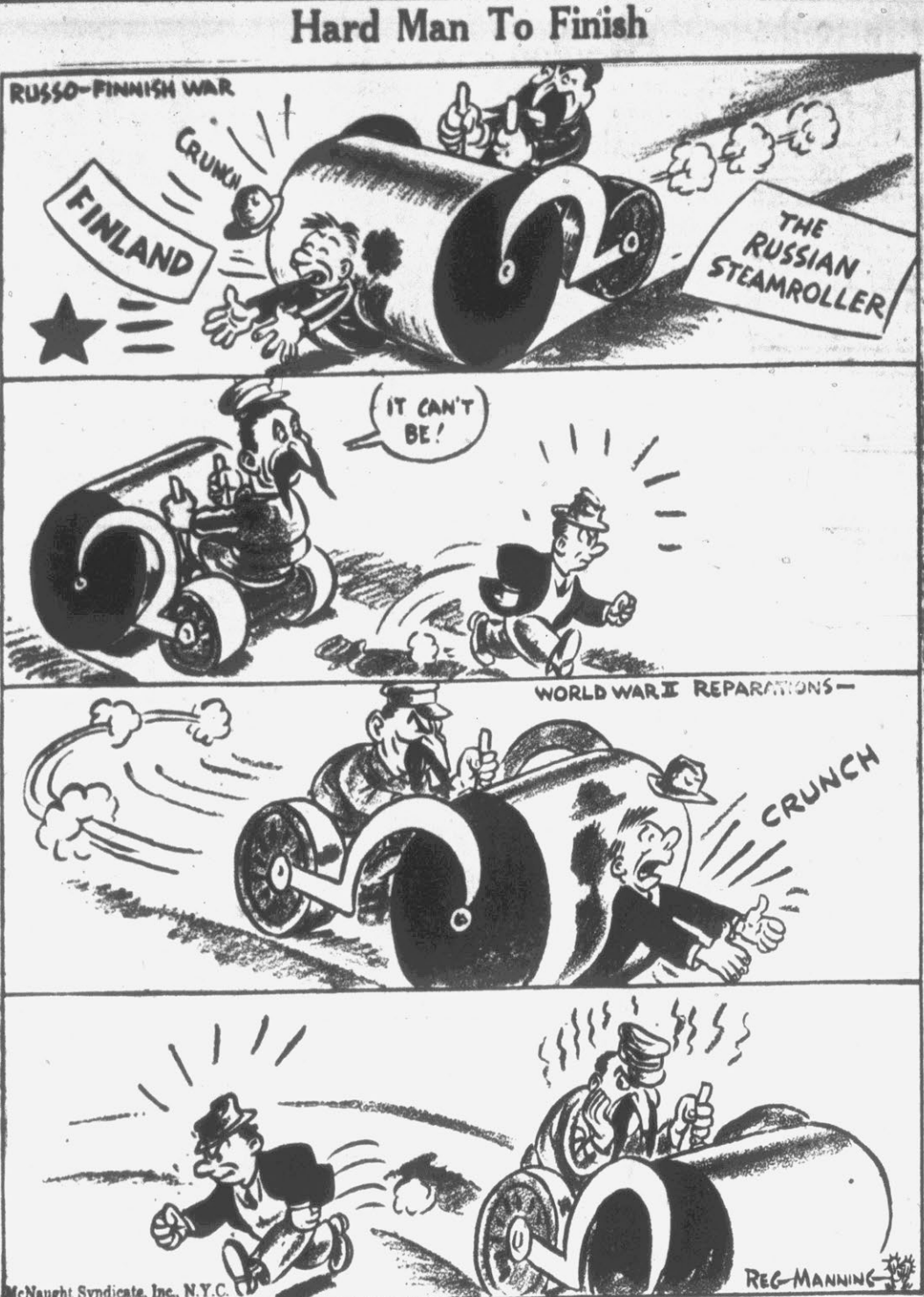
Action to be taken on this particular subject is going to vitally affect two large groups of people; the individuals and families who live in rented rooms, apartments and houses, and the people who act as landlords. 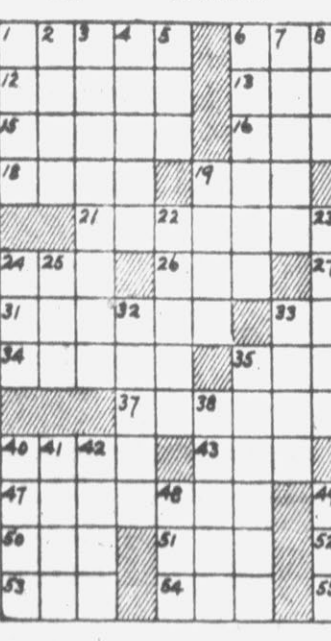

WASHINGTON LETTER

Washington — In Japan a baby is considered to be one year old when he is born. On the first day of the following January another year is added to his age, thus a baby born Dec. 31 would be two years old the next day. It's an old Japanese custom but some changes will be made, says Frederick G. Vosburgh, National Geographic Society writer assigned to Japan.

"With the end of this year every man, woman and child in Japan will become from one to two years younger," he said on a visit home. This will happen when a new law discarding "Kazoe-doshi," the age-old way of computing ages, and substituting the Western method, as suggested by Allied occupation forces goes into effect.

Mr. Vosburgh reports that some Japanese believe the practice of counting a baby as one year old at birth is based in the idea that life begins at conception and thus the infant is really three-fourths of a year old when it is born. Another explanation, according to Mr. Vosburgh, is that the Japanese count the number of years a person has seen. A baby "sees" one year at birth and another at the beginning of the next year.

On the other hand, a Japanese sociologist told him that his personal idea was that "the Japanese respect older people so much that they want to be as old as possible." Whatever the basis for the custom, it is deeply rooted. A law establishing the Western system of computing ages from the date of birth has been on the statute books of Japan for 47 years but has failed to be put in use by the population in general.

Text of the new law says that "on and after the date of enforcement of this law, it shall be obligatory on a person to discard the old usage of counting his or her age by "Kazoe-doshi" and to compute it by

years (or the months as to the length less than one year) in accordance with the law concerning the Computation of age.
Under present conditions census report, many Japanese—particularly the older ones—do not know their own birthday and have to get the date from family or official records. All that they know offhand is their Japanese-system age, from which a year or more must be subtracted, says Mr. Vosburgh.
Wish there were some way we could knock off a year or two from our ages and be legal about it!

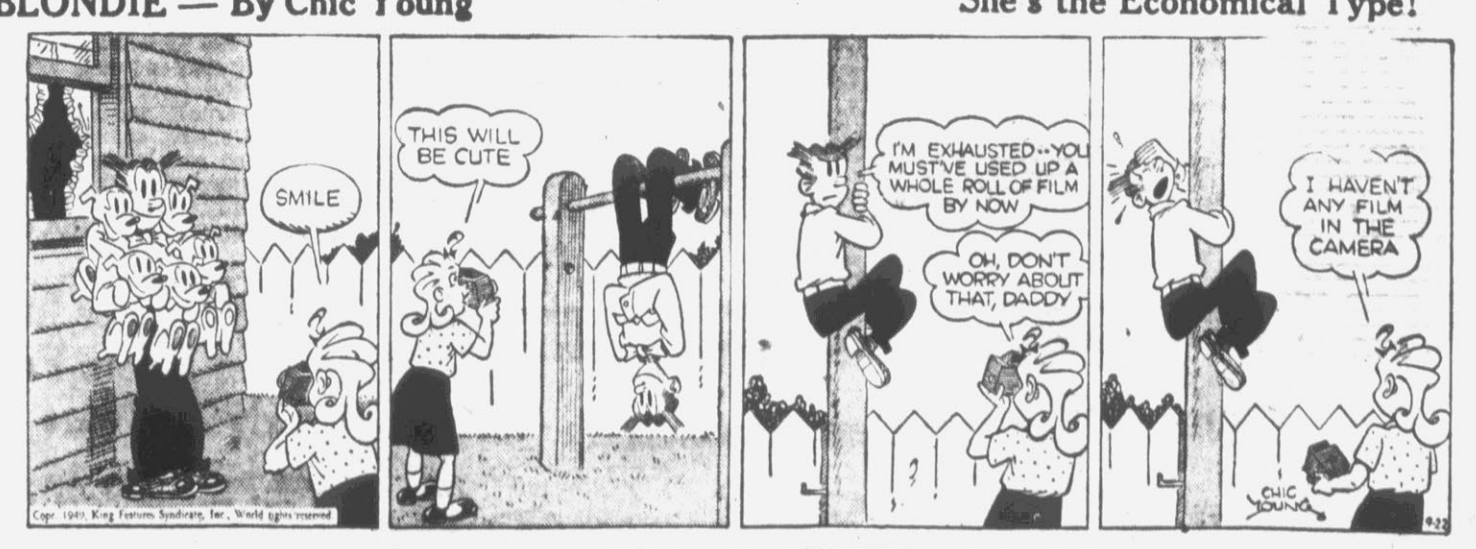

Reduce Demand By Dock Workers

New York, Sept. 22—(AP)—The AFL International Longshoremen's Association, representing 65,000 East Coast dock workers, has trimmed its wage demands to a 12-cent hourly increase.

Previously, the union had demanded a 22-cent boost to the present basic wage of \$1.38 hourly.

The reduced demand was submitted yesterday to employers, whose top offer so far has been in continue existing rates. Originally, the shippers called for a 12-cent hourly wage cut.

The union has threatened to strike Sept. 30 if its terms are not met. Current contracts expire then.

The New York Shipping Association, the employer group, reacted coolly to the union's new wage demands.

An employer spokesman said the reduced demand was the union's "only important concession" in a dispute that involves work hours, welfare benefits and other items.

(Continued from Page One) a pound to \$2.80. Other overvalued currencies around the world fell like a row of dominoes. Now, Britain still had some choice. Instead of saying "the pound is now worth \$2.80," Cripps could have said "we'll let the pound seek its real value, the value in world markets."

Some English newspapers thought he should have done that. They feel the cut was needlessly deep. To which Cripps' answer would be: When a money starts falling, you can't foresee the end. France is letting her money "float" to whatever rate the Paris free markets set. But France knows that the franc already is close to the free market rate.

Britain, on the other hand, is in trouble. People would tend to wait till the pound hit bottom. The longer they waited, the farther down would go the pound.

The pound now seems low enough

to insure that money-value won't be an obstacle to Britons selling goods abroad, whatever other obstacles may remain. If the rate does prove too low, sterling can be re-valued upward.

Summer Weather

Indian Summer continued to prevail here today. The highest temperature yesterday was 84 degrees. The highest yesterday a year ago was 96.

Incidentally, a year ago today, the highest temperature was 71 degrees. The lowest temperature in the Greenville area last night was 58, and at 8 a.m. today it was 66 degrees.

According to the local U. S. Weather Bureau records, the first killing frost occurred here last year on the night of October 19. The coldest weather last winter was the day after Christmas, when the temperature dropped to 13 degrees above zero. That winter was exceptionally mild. Only a few snow flurries were reported, the first in January, Mrs. Carl E. Malden, observe here, reported.

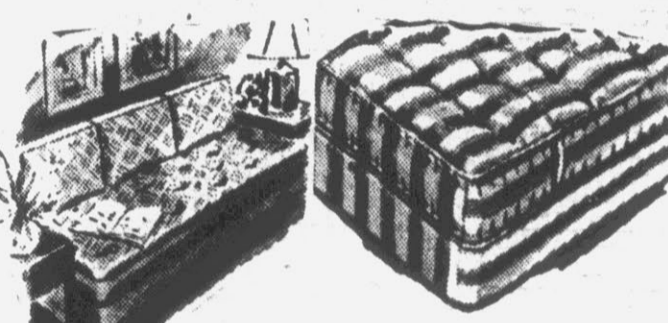

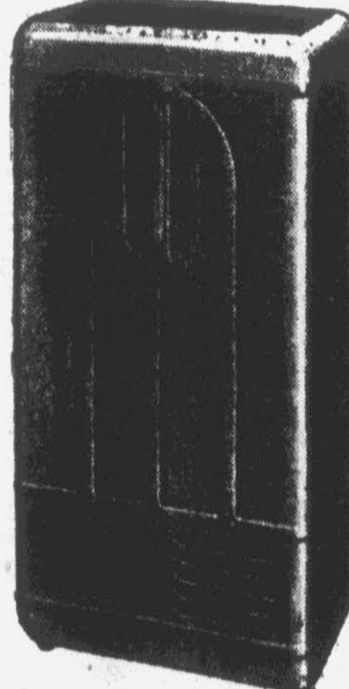
