

Big Recovery In Strikeless Week

Business And Industry Rebound After Two Months Of Crippling Tie-Ups; Stock Market Shakes Off Decline, Regains Ground

New York, Nov. 19.—(AP)—Free of crippling strikes for the first time in two months, business and industry made a strong recovery this week.

Almost all important indicators of activity pointed higher, with the rebound most pronounced in the steel mills and coal mines.

Retail trade recovery sharply in areas that had been hard hit by the lack of purchasing power of strikers and registered a modest increase over the preceding week in other areas.

The stock market shook off a two-week decline and went into a sustained advance that more than regained all the ground lost during the repeated retreats in the closing stages of the labor troubles.

Investment rated issues made a good showing in the bond department and the few new money issues that were brought out for investor appraisal received an approving nod.

One of the most significant events of the week occurred late Thursday. A buying drive of size and force developed suddenly in the New York textile markets.

Economists saw in this development a vote of confidence in business trends in the first half of next year on the part of highly trained experts who keep close check on conditions in the so-called consumer industries.

Print cloths were reported sold for delivery through next June and sales of sheetings were reported for delivery through next April.

The idea of good business the balance of this year and well into the new one apparently gained new recruits this week.

Bolshevism Stopped

Western Powers Have Temporarily Contained Communist Threat In Europe, Though Asia Remains Sore Spot; Eastern Planning; Who Is Boss In Peiping? Problems

The Western powers having at least temporarily contained the Bolshevik drive in Europe, America is making energetic moves to strengthen her position in the Far East where communism's mounting success threatens to turn that part of the globe into the political Armageddon of the isms.

With this in view Uncle Sam's head diplomats in eastern Asia have been ordered to hold a regional conference in Bangkok, Thailand, in January to consider the general situation. Meantime the Washington Administration's top diplomatic trouble-shooter, Ambassador Philip C. Jessup, also will make a survey of the situation and then meet with his colleagues in the Siamese capital.

This whole vast area fairly bristles with problems. Foremost among these are the question of a Japanese peace treaty; the position of strategically located Korea, which is a land divided against itself—Communist in the north and democratic in the south; the complex Chinese situation where Generalissimo Chiang Kai-shek's Nationalist Government has all but been knocked out in the military sense.

Solon Confident Truman To Again Be Demo Choice

Anderson, Former Agriculture Secretary, Opines He Will Be Nominee

Washington, Nov. 19.—(AP)—Senator Anderson (D-N.M.) expressed confidence today that the Democratic party will re-nominate President Truman in 1952 and that he will win another four-year term.

Anderson, formerly Mr. Truman's secretary of agriculture, is now chairman of the Democratic senatorial campaign committee. He recently returned to the Capitol from the west to map a campaign for retaining Democratic control of the Senate in next year's election, when 36 seats will be at stake.

Talking to a reporter, Anderson said he is optimistic about Democratic chances in both the 1950 and 1952 elections. As for Mr. Truman, he commented:

"I think he'll be the nominee and will be elected." He added: "I also am confident that the party will retain its majority in the Senate and increase it. I have been talking with a lot of farmers and businessmen in California, Arizona, New Mexico, Texas, Oklahoma and Colorado and I'm very much encouraged."

Anderson has been among those mentioned as possible Democratic presidential timber in 1952 if Mr. Truman is not nominated. The President has declined to say what his plans are for 1952.

Senator Millikin (R-Colo.), a top GOP leader in the Senate, sharply disputed Anderson's claims for next year's congressional elections.

Millikin didn't go so far as to predict that Republicans would take over control of Congress from the Democrats. But he said GOP chances of making substantial gains are excellent.

Keeping Eyes On Deadlock In Coal

Gov't Labor Advisers Still Hope For Possible Break

Washington, Nov. 19.—(AP)—Government Labor Advisers kept a close watch on John L. Lewis and coal operators today in hope of a possible break in the deadlock coal dispute.

The last word from both the UMW chief and the mine owners made clear that each side was waiting for the other to make the first move.

Government officials, keeping hands off the situation for the time being, hoped that the possibility of a new strike at the end of this month would force either the mine leader or the operators to offer a new proposal for negotiations.

While they expressed belief that the break might come soon, there was no sign of action from Lewis or the operators.

The United Mine Workers president said Sunday that he was ready to talk contact at the "convenience" of the owners, and indicated that the next move was up to them.

A spokesman for northern, western and commercial coal companies said, however, that the operators are waiting for Lewis to act. At the same time, he indicated that mine owners are feeling the pressure of the 52-day miners' walkout which ended with a truce last week.

The spokesman, Frank Amos of Pittsburgh, said that means Lewis is less likely to get the terms he is seeking. Lewis has never said just what they are.

Uniform System Of Bus Check-Up Now Organized

Crommelin Again Puts Navy 'On Spot' With New Charges

Washington, Nov. 19.—(AP)—Capt. John C. Crommelin, put the Navy on the spot today with new charges that Pentagon "zealots" with a "lust for power" have clamped Nazi-type controls on the defense establishment.

His latest blast against Pentagon policy raised this ticklish question for naval officials: Will the Navy start pat on a stiff rebuke already handed Crommelin for his part in a scrap among the armed services—or will it let the whole bitter row over vital defense

Washington, Nov. 19.—(AP)—Admiral Forrest Sherman, chief of naval operations, said today that the case of Capt. John Crommelin is "closed."

Washington, Nov. 19.—(AP)—The 48-year-old war hero insisted yesterday that either the reprimand should be erased from his otherwise sparkling record or he should be allowed to explain his actions in a court martial.

That was in a letter to Admiral Forrest P. Sherman the new chief of Naval operations, who gave Crommelin a public spanking Nov. 10.

While Sherman had no comment for the time being, some other navy authorities said they couldn't picture the Admiral backing down on his preplan in any way.

But Crommelin isn't backing down, either, from his stance that top army and air force Generals are ruining the navy's fighting power and endangering the nation's safety.

A pair of freshmen in Congress, Senator McCarthy (R Wis.) and Rep. Sutton (D-Tenn.) have jumped to his side with offers of any help they can give. That included legal advice should there be a court martial.

McCarthy was a Marine Captain in the war. Sutton a wounded much-decorated member of a navy underwater demolition outfit.

"I think Crommelin had no choice whatsoever," McCarthy told reporters, "but to demand a court martial so as to present the entire picture to the American people."

"He feels that our chiefs of staff are going the old German high command one better in attempting to obtain complete control of the economy of the nation and that that is dangerous not only in peace time but would be disastrous if another war should come."

In his letter to Sherman, Crommelin took a clout at a "small group of men" who, he said, have "complete and full control" of the defense establishment and a "carefully prepared plan" to take over its civilian operations.

And to reporters, the veteran navy flyer explained he means the top officers now running the army and air force.

Russians Demand Yugoslav Recall

Top Tito Diplomat Not Wanted; Soviet Envoys Expelled

Moscow, Nov. 19.—(AP)—The Soviet government for the second time in three weeks has demanded the formal recall of Yugoslavia's top diplomat in the Russian capital.

A Soviet note said the presence in Moscow of Charge D'Affaires Lazo Latinovic, the acting head of his country's embassy staff, was "impossible."

Last month the Russians told Premier Marshal Tito's government the same thing about Yugoslav Ambassador Karl Mrazovic, whom they accused of subversive activities.

In London the Soviet news agency Tass said Latinovic had been expelled from Russia for spying and subversive activities. Tass also disclosed that three Russian representatives had been ordered out of Yugoslavia.

Neither Mrazovic nor Latinovic were in Moscow when the notes were delivered. The ambassador returned to Yugoslavia last August. Latinovic, who took charge of the embassy when his chief departed, left Moscow Oct. 30 and now is in Yugoslavia, a spokesman at the Yugoslav embassy said.

The Tass dispatch distributed in London said the Russian consul at Zagreb, Vladimir, and Zdenko, Soviet second military attaché in Belgrade, had been ordered out of Yugoslavia "recently" for "engaging in anti-Yugoslav activities."

Off To A Slow Start

Gov't Housing Program Has Only Reached The Planning Stage, But It Is Under Way; Its Three Aims; The Cost, And Who Will Get The Money; Loans, Grants

Washington, Nov. 19.—(AP)—The government's public housing program is slowly getting a start. At this point, though, it has only reached the beginning of the planning stage.

Because more than 25,000,000 low income people live in slums and run-down-city or farm homes, this program—passed by Congress and signed into law by President Truman last July 15—has three aims:

1. To wipe out slums, although this program won't wipe out all of them.

2. Build houses where low-income families who can afford only low rent can get decent homes.

3. Aid poor farmers in putting needed repairs on their homes or building new ones.

The cost to the government is between \$7 billion and \$12 billion spread over 40 years in grants, or outright gifts of money; plus about \$3 billion or so in loans, which the government will get back.

Most of the money will go to cities and communities. They'll hire private contractors to clear the slums and build public housing.

The government will help when the cities and communities can't pay the bill themselves.

The only individuals who'll get money are poor farmers, if they're approved by the government.

And they can't get it unless they can get money any other way. They'll get two kinds of help: Loans and grants.

The public, low-cost housing program calls for \$10,000 units to be built in the next six years.

Not a nail has been driven into a single yet under this program. The program is getting under way, but only to this extent:

The government this week approved loans of \$79,575,400 to 108 cities to make surveys and plans for a total of 134,000 low-rent homes.

Since they're only at the start of the planning stage no building of homes can start before next year.

When the plans and surveys are finished, the 108 cities and communities can come back and ask the government for help in building the homes.

The government can make loans to the communities up to 90 per cent of the total cost of the projects. The loans to be repaid in 40 years, at interest.

The other two parts of the program—help to poor farmers and slum-clearance—haven't started yet.

Search Spurred

Hamilton, Bermuda, Nov. 19.—(AP)—Planes and ships narrowed their search today for a missing U. S. bomber on an area 290 miles northeast of Bermuda. An air force pilot said he spotted what might be the floating wreckage there of a B-29 which disappeared last Wednesday with 26 men aboard.

It was the third report to spur on the huge search party seeking the bomber crew who last messaged they were going to crash land in the sea.

Red flares had been seen Thursday night about 40 miles northeast of the area where first Lt. Richard Mullin, of the 52nd Bombardment Squadron of the 301st Bombardment group, said he saw what appeared to be debris.

Returning from his search mission, Mullin said he picked up a faint radio signal giving a group of call letters for the 52nd Bombardment group, to which the lost plane belonged. Later he heard an S. O. S.

Arms Embargo Is Approved By UN In Balkan Action

New York, Nov. 19.—(AP)—The United Nations General Assembly beat down Russian opposition once again yesterday and approved an arms embargo against Greece's Communist neighbors.

The assembly also voted down the Russian group in their motion to discontinue the special U. N. committee watching Greece's borders and the civil war that has raged across them.

The arms embargo was directed at Albania and Bulgaria. The assembly has only a kind of moral force with which to enforce the ban, but none of the countries in the western ranks of nations are known to be sending arms to Albania and Bulgaria now.

By a vote of 50 to 6, with two abstentions, the assembly approved an American-supported proposal to impose the arms embargo until such countries as Albania and Bulgaria stop aiding Greek guerrillas fighting the Athens government.

Yugoslavia, once on the committee's list, has been dropped from this accusation since Marshal Tito split with the Communist more than a year ago. The U. N. committee has reported that Yugoslavia has ceased helping the Greek rebels.

But Yugoslavia yesterday joined the Soviet bloc in opposing the resolution finally adopted. To most observers, this seemed to dash hopes that Marshal Tito's government might patch up its differences with Greece. Yugoslav Delegate Dr. Alex Bebler accused the Athens government of engaging in terrorism, atrocities and brutality especially in Macedonia.

The Soviet proposal rejected by the assembly, paragraph by paragraph, called for withdrawal of all foreign troops from Greece, dissolution of the U. N. committee and creation of a Big Four border commission to supervise the frontier between Greece and her northern neighbor. The action as adopted extends the life of the U. N. commission for another year.

Today the General Assembly takes up the disposal of Italy's pre-war colonies in Africa.

Damage to the station wagon was estimated at \$400. The truck was not damaged. The truck was operated by Wooten Holloway, Greenville, and was owned by the Norfolk Tallow company.

Cold Virus Lost As Science Gets Another Setback

Washington, Nov. 19.—(AP)—National scientists have suffered a setback in their study of the common cold.

Dr. Leon T. Atlas, U.S. Public Health Service scientist, disclosed yesterday that a pesky little virus called MR-1 has disappeared at the National Institutes of Health.

MR-1, isolated for the first time in 1947, was being incubated in a batch of fertile hen's eggs. Dr. Atlas explained, and now it can't be found.

Dr. Atlas helped isolate the virus from the nasal discharge of a fellow scientist who came down with a cold. The quest, begun within 24 hours after the scientist gave his first sneeze, led to the discovery of MR-1, just 11 months later.

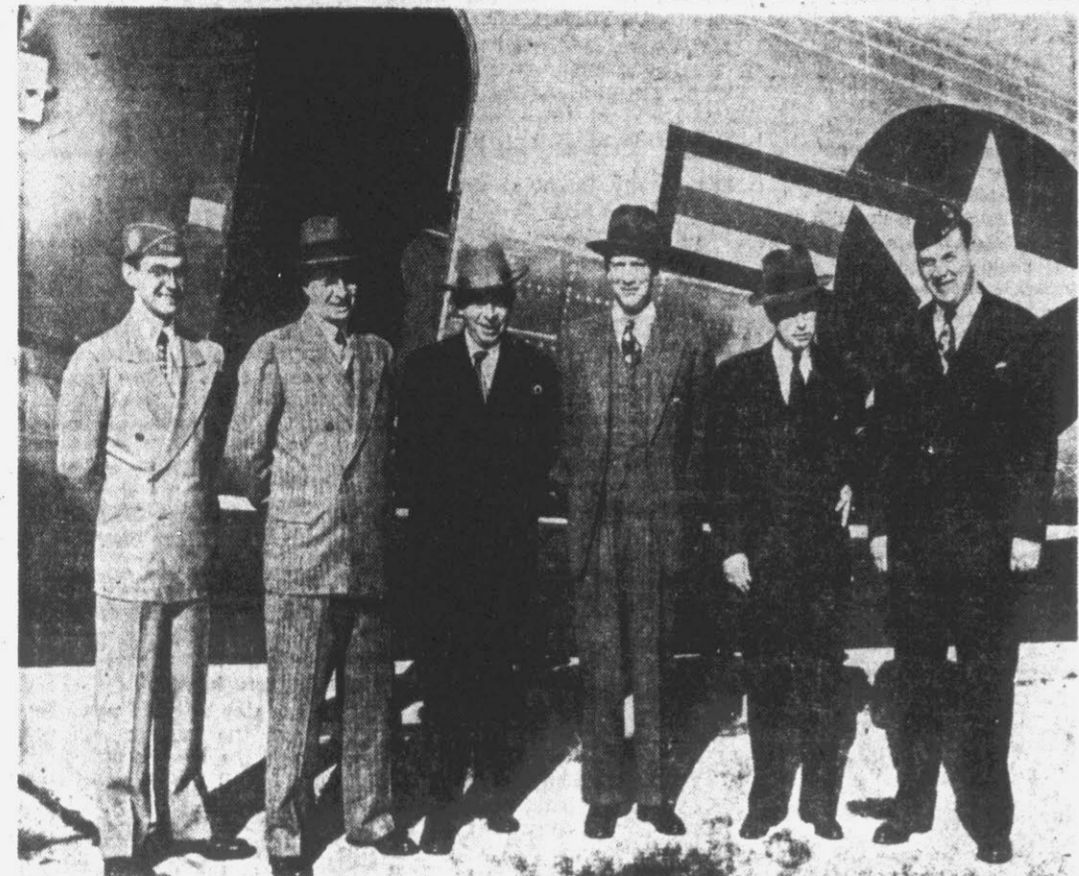

Greenville Armistice Celebration Was National News

Spectacular Parade Filled Streets; Crowd Heard Gray

Greenville's Armistice Day celebration last Friday was given national prominence by the big press associations and New York newspapers gave it special mention.

North Carolina newspapers played up the story in a big way, and some of the radio stations "spotted" it conspicuously in their news broadcasts.

Newspaper reporters flew down here from Washington to write the story for their papers.

Armistice Day 1949, was a great day in Greenville and Pitt county. Twenty thousand persons lined the streets to witness the spectacular parade, headed by the 82nd Airborne Division band, Company C, Composite Group, 505 Regiment, and Battery A, 456 Airborne Group, from Fort Bragg.

Sherman Parks was chief parade marshal. Thousands cheered as the Fort Bragg soldiers marched smartly by, and lusty cheers were given to the Greenville Battery of the National Guard and the Air Reserve Officers' Training Corps unit from East Carolina Teachers College.

Distinguished Guests
Secretary of the Army Gordon Gray and Congressman Herbert C. Bonner and other distinguished guests in the parade received an ovation all along the line of march to the college football stadium.

Four thousand persons assembled at the stadium to hear the War Secretary deliver his Armistice Day address, and to witness the review

of the participants in the Armistice Day parade.

The exercises at the college stadium clicked with clockwork precision, with J. Con Lanier as master of ceremonies.

Dr. John D. Messick, ECTC president, and others participating in the memorial exercises said Armistice Day in Greenville showed that the people of Pitt County are united in spirit for all occasions for the advancement, progress and prosperity of the community.

No serious accident occurred during the day while thousands of people milled about the streets. No traffic accident was reported. No arrest was made.

Mayor W. S. Stafford lauded the police, State Highway Patrol and sheriff's officers for their good work in handling traffic and controlling the exceptionally orderly crowds.

Feeds A Multitude
The climax of the day's festivities was the barbecue feast at the Farmers' Warehouse, across the river, on the Bethel highway, when Respass brothers served a barbecue dinner to more than 800 persons.

Other guests included the newspaper correspondents from the National Capital, Margaret Kernode,

from the Associated Press, Washington, D. C., James Free, News and Observer, and Bruce Jolly, Greensboro Daily News, were given special recognition at the luncheon.

The celebration was sponsored by the American Legion and Veterans of Foreign Wars posts. Ty Wagner, American Legion, and Earl Alder, Veterans of Foreign Wars commanders, respectively, reminiscing after the Armistice Day celebration ended, said with emphasis: "We are going to start right away on next year's Armistice Day celebration and we shall plan it on more elaborate scale."

Photographs Tell Story
Photographs of the Armistice Day parade and exercises tell a better story than any newspaper reporter could write. They were snapped by Roy Hardee, Daily Reflector staff photographer.

They will recall the splendor of this Armistice Day pageant and cavalcade. They will be a record in history of the fine way the people of Greenville and Pitt county do things for the public good. Many who read this story and see the pictures will find something personally interesting to them. "Maybe 'spot' some one dear to them in the parade or in the 'crowds along the parade's line of march."

Incidentally, this Daily Reflector reporter saw the Armistice Day parade from several vantage points, taking advantage of opportunities to move about in a police car. He landed finally at the traffic light at Five Points when the cavalcade swung eastward into Fifth street toward the college stadium. It was an impressive sight, spotlighted by those great 82nd Airborne military units from Fort Bragg, the Greenville battery of the N. C. National Guard and the Air Reserve Officers' Corps unit from ECTC.

Honor Gold Star Mothers
The crowds at Five Points and other places gave profound applause when the cars with the Gold Star Mothers passed. Not the lusty applause inspired by joy, but that solemn and sacred recognition which attests the appreciation of the people for the mothers whose sons made the supreme sacrifice during the wars. Mrs. Frank Taylor was chairman of the Gold Star Mothers committee.

Members of the American Legion and Auxiliary and the Veterans of Foreign Wars and Auxiliary in the parade were given special recognition.

Fine School Bands
The bands, in addition to the Fort Bragg outfit, were distinct features of the parade. The Greenville High School band, in its soldierly bearing, and the Farmville High School band, with the sparkling drum majorettes, and the ECTC band were distinct hits of the parade.

Boy and Girl Scouts—white and Negro—had prominent places in the Armistice Day parade. A feature of the celebration and parade was the appearance of the Negro American Legion, C. M. Eppe High School band, members uniformed Elks and others. The Ayden and Farmville Negro high school bands made a wonderful showing.

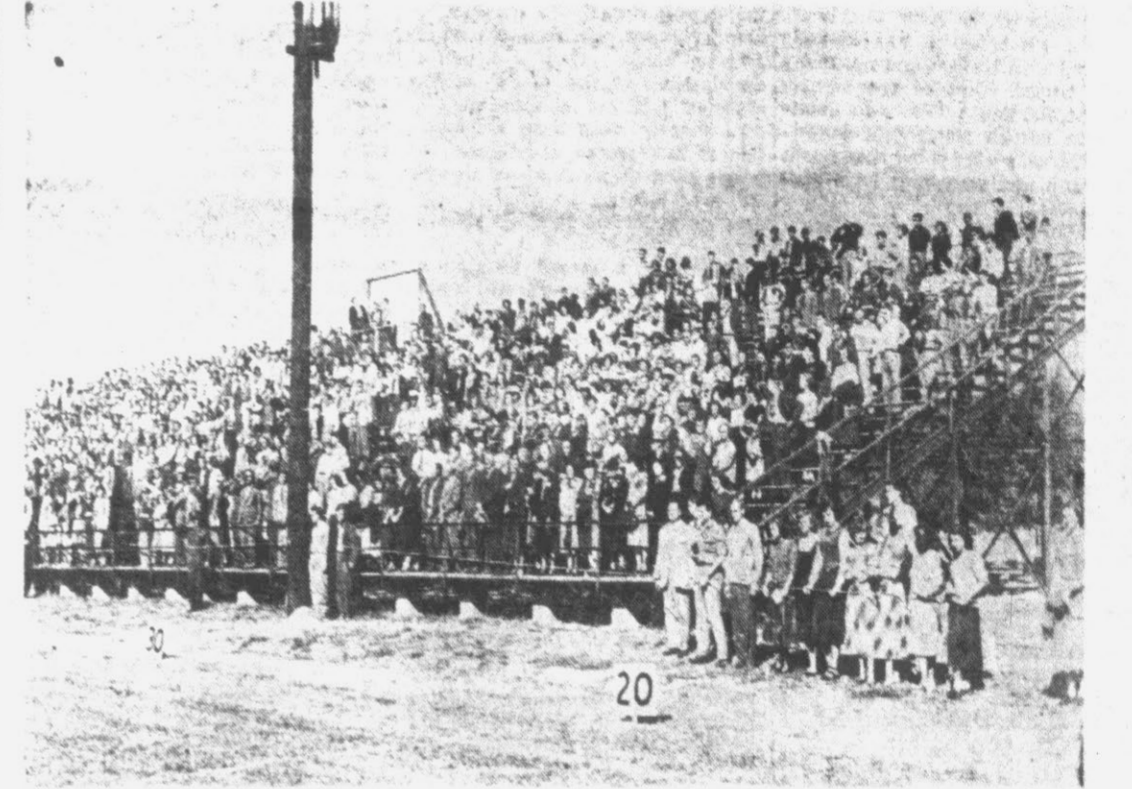

Vet Enrollments Sharply Reduced

Washington, Nov. 19—(AP)—College enrollments by World War II veterans are tapering off sharply. The Office of Education said only 856,000 veterans enrolled for higher education this fall—16 per cent fewer than the 1,022,000 enrollment of a year ago. The peak of 1,158,000 was reached in December, 1947.

Of the nation's 15,000,000 World War II vets, the Veterans Administration said, about 6,840,000 have taken education or training under the GI Bill.

In the field of higher education, only one state, Connecticut, reported increased veteran enrollment this fall. And while almost half the nation's college students in 1947 were war veterans, this year only 35 per cent of them are.

College enrollment of veterans by states, with the amount of decline from a year ago given in parentheses included: Georgia 13,312 (2,390); North Carolina 13,736 (4,027); South Carolina 7,240 (1,963); Virginia 11,173 (3,550).

With this veneration of the automobile growing as it is, a man would be a fool to want to come back to America in some afterlife and waste his career as a mouse, an elk or a high-flying duck. No, the thing to aim for—if you get a second chance—is to be an automobile. That's my goal, and I've given the matter considerable thought.

I don't care a honk whether I'm a sport coupe, a limousine or a four-door sedan. Just don't make me a doctor's car, as cabbies tell me physicians are the world's worst drivers. Otherwise it is a matter of indifference to me whether I'm a rich man's plaything or a poor man's pride. I'm no snob about it.

For I know that in either case if I don't get what I want I'll just break down and sit there until the owner does give me what I crave. And that's a luxury I haven't been able to afford in this life.

The telephone classified directly fills 11 columns with listings under associations, starting with AAA (the American Automobile Association) and ending with Zionist Organizations of America.

The Chamber of Commerce of the United States of America, whose staff of 250 probably is the largest among the groups listed, reports 364 trade association headquarters in Washington. There is even an Association for Trade Association Executives.

Industry associations fall in another group, representing broad fields such as railroads, airlines, ship owners, manufacturers, bakers, truckers and cannery. And there are associations representing elements within an industry such as the shortline railroads, glass container makers, independent air carriers, waterways operators. There is a National Apple Institute and American Ladder Institute and an American Tree Association; but no formal body of apple polishers, people who avoid ladders, or

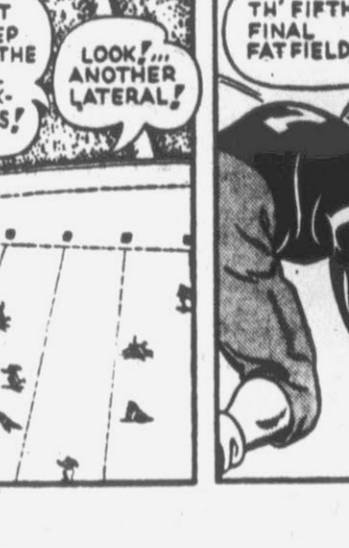

Locals' Offensive Effort Contained

Visitors Reveal Surprise Attack Led By Quarterback Asby; GHS Eleven Scores Lone Tally In Last Of Third

Led by Quarterback Asby who scored three touchdowns and passed to a fourth, Washington's Pam Pack humbled Greenville high school's Phantoms 33-7 before a sizeable homecoming crowd here last night.

Washington's highly touted defensive team bottled up Greenville's offensive efforts until the closing minutes of the third period in a performance highlighted by their goal line stand in the opening of the fourth.

But it was the Pam Pack offensive, which had failed to create any great concern among Northwestern teams until last night, which came through to deal the Phantoms one of their most staggering losses of the year.

The Pack scored the first time it got the ball when Asby took a punt on the 50 and raced to a touchdown.

The Phantom defense showed its determination and strength in the second period when the locals held the Pack on downs after they moved to the nine for a first and goal.

A few minutes later, however, after Greenville punted out, Asby skirted end, hit the sidelines and raced 30 yards to pay territory to give the Pack a 14-0 halftime lead.

A 53-yard run by Halfback Dixon set up Washington's third score early in the third period. He was caught by Greenville's speed merchant halfback Walt Gooch on the Phantom 18. Asby bulled down to the six on the first play and then Dixon went over for the score. The kick was good and Washington was out in front 20-0.

A 40-yard pass from Dixon to Asby gave the Pack its fourth tally. Vainright, Moore and Brady broke through to roll the Pam Pack back from the 31 to the 45. But two plays later Dixon rifled one in the coffin corner to Asby for a touchdown.

Trailing 26-0, the Phantoms of Greenville High came to offensive life in the closing minutes of the third. Cox passed to Gooch for a first on the Washington 30. A few minutes later, a penalty put the Phantoms on the six with a first and

goal. But the Pack line held on the one foot line.

Early in the fourth, a 15 yard penalty put the Phantoms down on the 10 of Washington. It was Greenville's all-conference candidates Jimmy Cox and Leon Moore who were credited with the locals' lone touchdown. Cox passed 10 yards to the sophomore end for the tally.

A pass to Cox was good for the point.

Asby took to the air to score Washington's final touchdown. He hit Smith in the end zone for the score which made it 32-7.

In the closing minutes of the game the Phantoms threatened again but a pass interception on the 25 ended the game as far as the Phantoms were concerned.

Ahoskie Winning Streak Is Broken

Ahoskie high school's 24-game winning streak was snapped last night when Coach Honey Johnson's Elizabeth City Yellow Jackets bowled over the 1948 Class B state champions 19-0.

The highly touted Ahoskie team never threatened.

Elizabeth City scored twice in the second period and again in the third to blast any hopes the Ahoskie boys had of going undefeated.

The Yellow Jackets, who barely asked out a 9-6 win over Greenville, blocked a kick on the 18 in the second period and Quarterback Bobby Askew scored on a sneak to put the winners in front.

Askew scored again on a sneak two seconds before the half after Clay Foreman ran 35 yards to set up the score.

Foreman galloped 36 yards in the third to put the ball on the Ahoskie two from where Askew bulled off tackle for the tally.

As always, he missed the trapeze and started to fall. And as always, he had a rope tied to his ankle to check his plunge.

But last night the rope broke. He fell to the floor as more than 9,000 persons in the audience gasped.

Attendees quickly rushed him from the arena. Municipal Auditorium and the show went on. Many persons in the crowd thought the fall was part of the act.

Vogel died shortly afterward in a hospital.

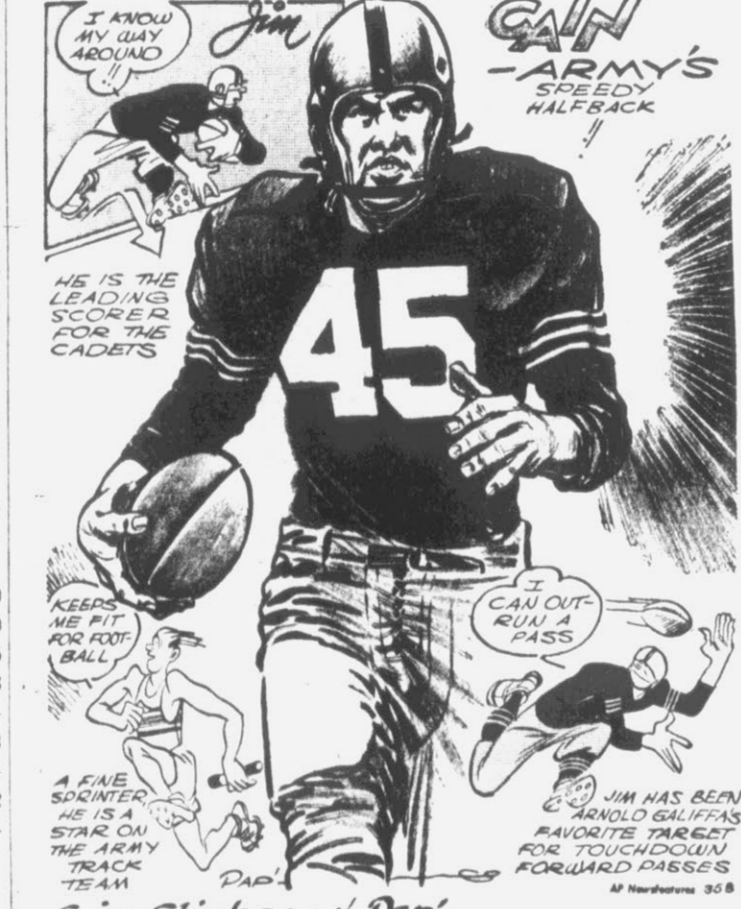
Dodd Considers Coaching Offer

The blanket of cold was widespread. Rome, Ga., for example, reported a low of 22. Birmingham, Ala., 28, Knoxville, Tenn., 29, and Atlanta 32.

Rising temperatures were promised the frigid zone for today and tomorrow.

There were some snow flurries in the northern and eastern Great Lakes region, eastward to the North Atlantic states. Most of the northern part of the country had cloudy weather.

Warmer air moved across the central states from the great plains but a mass of colder weather was on the way from central Canada. Warm weather continued in California. The mercury yesterday reached 87 at Los Angeles and 86 at San Diego, the latter mark an all-time November high.

Bishop Manning Dies In New York

New York, Nov. 19—(AP)—Bishop William T. Manning, one of the leading figures of the Protestant Episcopal Church in the United States, died yesterday at the age of 83.

He was Episcopal Bishop of New York for 26 years, retiring less than two years ago.

He was a strict churchman throughout his life, and an uncompromising enemy of divorce. He once preached a sermon criticizing King Edward VIII for abdicating the British throne to marry a divorcee, and barred Elliott Roosevelt, twice-divorced, as vestryman of St. James Church at Hyde Park, N. Y.

As bishop, he was the driving force behind continued construction here of the huge Cathedral of St. John the Divine, the world's largest cathedral in Gothic style.

His body will lie in state in the cathedral from 6 p.m. (EST) tomorrow until Tuesday noon, when the burial office and a requiem will be offered. Burial will take place at a later time in the cathedral itself.

Bishop Manning returned from a vacation in Maine on Nov. 4 and entered St. Luke's Hospital for his annual examination. He was found to be suffering from a kidney and bladder involvement, complicated by age, and was kept in the hospital for treatment.

Bishop Manning was born in Northampton, England, and came to the United States with his parents when he was 16.

Gettysburg Has Anniversary Day

Gettysburg, Pa., Nov. 19—(AP)—The residents of this historically famous community today were joined by hundreds of visitors to commemorate the 86th anniversary of Abraham Lincoln's Gettysburg address.

Highlight of the all-day program was the reading of the immortal address on the ground where more than 50,000 Union and Confederate soldiers were killed or wounded in the decisive battle of the Civil War.

The "Voice of America" program representatives were on hand to record the activities for broadcast overseas.

Marine Flier Is Crack-Up Victim

Cumberland, Md., Nov. 19—(AP)—A Marine Corps flier was killed last night when his navy fighter plane cracked up on a snow-blanketed mountainside in nearby Pennsylvania.

Officials at the Quantico, Va., Marine Corps base identified the pilot as First Lieut. Max B. Rosecrans, 28 formerly of McDougal, Pa.

He also says the extra point tends to take away from the thrills of the game. "If a team gets ahead by one point it often sits back to protect that lead," Bell says. 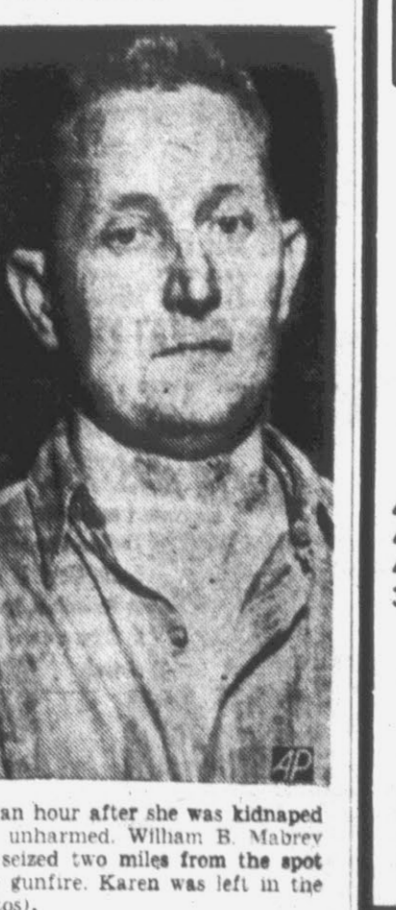

'Thrill Slaying' Confessed By Teen-Age High School Athlete

Twin Falls, Idaho, Nov. 19—(AP)—Neil (Butterfingers) Butterfield, 16-year-old high school athlete, confessed last night to the thrill slaying of seven-year-old Glenda Joyce Brisbois.

The youth, who was arrested as he fled west in a stripped-down "hot rod," told officers he killed the child "just to see someone die."

Sheriff Saul Clark of Cassia County said the youth admitted he had first graded from Burley, Idaho, with a tire jack before throwing her body into a canal.

But the sheriff said he denied that he raped the girl.

Glenda, fully clothed, was found in the canal yesterday. She had three wounds on her head. She was last seen Wednesday evening when she entered an automobile driven by a man. Officers announced following an autopsy last night that the girl had been sexually assaulted.

Shortly after Butterfield made his confession, he was taken under heavy guard 27 miles east of Twin

Falls just inside the Cassia County line. There, in a field of sagebrush beside the highway he was arraigned before Probate Judge Henry W. Tucker of Cassia County on a first degree murder charge.

The open air courtroom was within the legal limits of the county where the crime was committed. Officers feared to take him into Burley because of high feelings among citizens of the town of 3,500.

Butterfield, a handsome, six-foot, 175-pound youth, was recently

released from the Idaho State Industrial School at St. Anthony, where he was sent as a delinquent after a case involving forgery. He was nabbed yesterday by state police 110 miles west of Burley.

Sheriff Clark said Butterfield admitted that he slugged the little girl three times with a tire jack, threw her body into the canal, pushed her from the bank with the jack, then drove away—after wiping blood from the jack with his fingers.

Longer Life Expectancy Reflects Health Progress

New York, N.Y.—A century's progress in American health conditions is reflected in an increase in expectation of life at birth from less than 40 years in 1850 to about 67 years today, according to Dr. Louis I. Dublin, chief of statisticians of the Metropolitan Life Insurance Company.

"Every branch of the medical and sanitary sciences has shared in the unparalleled progress of the past century," he declared, "with the result that the death rate has been greatly reduced and many diseases which once were rampant are now either under control or well on their way to control. We now enjoy a vastly higher standard of living—more abundant and better food, shelter, clothing, educational and recreational facilities."

The gain in longevity was at a much more rapid rate during the second half of the century than during the first half. For example, the gain of 27 years for white males is made up of a 10-year gain from 1850 to 1900 and a 17-year gain since then, and the 30-year gain in the case of white females divides into a 10½-year increase up to 1900 and 19½ years since that time.

Dr. Dublin is optimistic as to further gains in length of life.

"The medical and sanitary sciences are advancing at a fast pace, our standards of living are still improving rapidly, and our people have become alert to their stake in sound public health and medical care," he points out. "With the expectation of life of the American people now near the Biblical three-score-and-ten, there is good reason to expect a life expectancy of 75 years within the next generation."

New Brunswick, N. J., Nov. 19—(AP)—A strange new adventure in life has begun for a 33-year-old woman—she has become a man.

Dr. Charles F. Church said yesterday that the former Edna Geneck of nearby South River has been changed into Ed Geneck—at "her" own request—by an operation at an out-of-state hospital.

Geneck lived his first 33 years of life as a girl and woman. He graduated from Rutgers University and later became a junior executive at Johnson and Johnson company here—all as a woman.

But "Edna"—though considered a

good-looking coed by Rutgers classmates—had deep doubts as to her rightful place in nature's scheme, Dr. Church said.

She found she had to shave every day, and she had unusually strong hands and arms for a woman.

Finally, Dr. Church said, she came to him for advice.

Dr. Church sent the troubled woman to leading medical authorities. They agreed that she was predominantly male and with her full cooperation suggested an operation to complete the transformation to a normal man.

The new Ed Geneck will be coming home next week. He'll take up his old job where he left it and take a new place in the community as a man.

Neighbors and co-workers have been told of his change.

They all want to help Ed lead the normal life that was denied to Edna.

Medical authorities explain that cases like Ed Geneck's occur about once in every 150 births. In most similar cases, however, one sex overcomes the other tendency, and the dominant sex is established naturally.

certain whether Mao has full freedom of action. Russia is suspected of having special influence with the Communists in Mukden and elsewhere in Manchuria.

For this reason one possible move by the State Department is to ask Russia to intervene with the Red Chinese government.

Chinese Nationalist fortunes continue to fall. Enemy forces draw in on the provisional capital of Chungking, and the American embassy and consular personnel are scheduled to leave for Hong Kong tomorrow. It's said this won't affect diplomatic relations between the Nationalists and Washington.

So goes the story, and this whole complicated situation in east Asia forms a jig-saw puzzle which the American conference of diplomats at Bangkok presumably will endeavor to piece together. That is to say, their job will be to evaluate the various complications and give them the proper place in the defense against Bolshevism.

The Unions scale their 'take' so that an employer will pay in proportion to his volume of business, number employed, or some other differential. This is what this small operator is asking. It sounds sensible to me.

Another report and recommendation comes from a small manufacturer of metal specialties. He writes that government contractors tend to place with the smaller shop only a variety of trifling shop orders. But for efficient handling any concern needs a reasonably long run. To make a profit, after adequate tooling

up and devising new methods, takes time. Many of the smaller shops, I am informed, lack the immensely diversified equipment and experience necessary to take care of an endless hodgepodge of experimental knick-knacks.

Less Surveys And More Service
In political speeches, our governmental bigwigs are loud in applause for small business. In actual practice, the government confronts the little businessman with a mass of bureaucratic entanglements. The government not only bleeds him with extortionate requirements, but applies these with lepastic red tape that is all but unintelligible to anybody but a Philadelphia lawyer.

Ostensibly to serve small business, the government has encouraged the setting up of commissions, committees, councils, authorities, advisers, administrators, offices agencies. It has exasperated both the alphabet and the patience of the businessman who is compelled to pay the bills for this costly nonsense. Small business in America today is not seeking a hand-out, but a hand-up. It is tired of filing blanks instead of filled firm and profitable orders. Speaking as one who got his own basic training in the small business field, I urge the government to let up on the question for a spell and instead to give small business a few sorely needed answers.
