Tornadoes Leave 47 Dead In 4 States Over Weekend

Another 200 Or More Injured; Death Toll Expected To Rise; Twisters Strike Hard And Fast, Travelling Northeast, After Inception In Texas

Shreveport, La., Feb. 12—(AP)—Tornadoes whirled through four states over the weekend leaving at least 47 persons dead.

Another 200 or more were injured in East Texas, Northwest Louisiana, Southern Arkansas and Tennessee.

The sheriff's office at Ripley reported that still others, probably Negro tenants of the stricken Woodard farm, were believed killed.

Three houses also were damaged by a twister at Rosemark, near Memphis. No one was reported injured at Rosemark.

As the tornadoes continued a northeastward course, the death toll mounted in Louisiana and Texas.

The Red Cross reported 29 killed in Louisiana. This total did not include one fatality reported by the Shreveport Times in Shreveport.

The death of 9-year-old Shirley Windson in a Lurken Hospital early today raised the death toll in Texas to nine.

The tornadoes spawned Saturday when a mass of cold air collided with a mass of warm, moist air struck at least 20 times in less than 24 hours.

The number of dead in Texas and Louisiana had been reported as high as 42 at one time last night. But Louisiana state police at Bossier City checked this figure down with a report that caught some duplications.

First to feel the twister was lower East Texas. A tornado smashed Lupton, Tex., and Alvin, Tex., Saturday afternoon. Another twister hit after that day at Shapel Hill, Freedom and Baileyville. At midnight the tempo increased and with machine gun rapidity the twisters struck at Corley, Jericho, Gill, Salem and Hughes Springs, all in Texas; at Roytown, near Castor, Silo, Shreveport, and Grand Cane, in Louisiana.

Arkansas reported less damage and no injuries from a single tornado.

Texas bore the brunt of the storms Saturday and early yesterday, but then they whip-lashed into Louisiana and wrecked greater havoc.

Louisiana's dead were still only partially identified.

Thinks Handling Of Coal Strike Will Cost Votes

Washington, Feb. 13—(AP)—Senator Ellender (D-La) contended today that President Truman's handling of the coal strike will cost the Democrats thousands of votes in the congressional elections next fall.

Senator Humphrey (D-Minn) commented: "I doubt it, but the important issue is the welfare of the American people, not votes. The President has tried to protect that welfare by every means at his command."

Ellender, who helped draft the Taft-Hartley law in 1947, told a reporter it was inexcusable for Mr. Truman to have waited as long as he did to invoke the law in the mine dispute.

March 15 Deadline

This Is The First Of Twelve Stories Explaining Who Must Do What And How About His 1949 Income Tax Return; Highlights To Be Kept In Mind In Filing

Washington, Feb. 13—(AP)—Midnight of March 15 is the deadline for setting up on your 1949 income tax.

If your 1949 income was \$600 or more, you must file a return, whether or not you owe any tax. If you owe any, you must pay it in full.

This applies to every man, woman and child, married or single, who had \$600 or more income in 1949.

Under \$600 income is free of tax. If your less than \$600 income in 1949 had some tax withheld from it, the government will return it—but only if you file a return. It is the only way you can get a refund.

The internal revenue collector has sent most people income tax blanks. If you don't have yours, you can get it at the nearest collector's office or at most banks and postoffices. A number of points will be explained separately and in detail in the other 11 stories of this series, such as:

Who uses what form for filing his return; the problem of husband-wife filing and their filing of joint returns; exemptions, deductions, dependents, and how to fill out various forms.

Keep these highlights in mind. In every case where the wife has no income, a couple can't lose money by filing a joint return. Joint returns will save money even in most cases where husband and wife both had income.

That's because under present law husbands and wives are allowed to split their income, each claiming half, thus throwing each half into a lower tax bracket and making the total tax less.

New Look At Cold War Score Taken By Govm't

Administration Takes New Over-All Look At U. S. Foreign Policy To Determine Just Where U. S. Now Stands

Washington, Feb. 13—(AP)—The Truman administration was reported today to be taking a new, over-all look at American foreign policy to determine just where the United States now stands in the conflict with Russia.

The study is being made by the National Security Council. This agency embraces the State Department, the Defense Department and other government agencies.

Responsible officials said that the aim of the present review, which is the latest in a series of such studies to keep President Truman and the cabinet currently informed of "where we stand," is not expected to produce any new turn in the direction of major foreign policy.

Open questions are said to include whether the United States is more powerful in relation to Russia as the result of the H-bomb possibilities, how long it may be expected to hold any edge it has, what affect the possible new weapon will have on this nation's strategic planning and how the bomb should be used.

Informed authorities regard the question of use as one of the most difficult. It involves the determination—that actually may not be firmly settled for a long time—of whether as a matter of high policy the United States should reserve so devastating a weapon for use in retaliation only or whether it should use the H-bomb like any other weapon as soon as that becomes strategically desirable following the start of a war.

Three Accidents Over Weekend In Greenville Area

Three Persons Injured And Five Cars Damaged In Series Of Mishaps

Three week-end accidents in the Greenville area, caused considerable damage to five cars and injured three persons, state highway patrolmen reported today.

The first accident occurred on 14th Street Extension about one-half mile from Greenville, at 6:30 Saturday night.

A car driven by James C. Crisp, of Route 3, Greenville, struck the front end of a parked car on the highway.

The car, owned by Sam O. Worthington, of Greenville, was parked on the left side of the highway with the headlights on at the time of the accident, Patrolman R. H. Chadwick investigating officer stated.

Crisp was taken to Pitt General hospital for treatment of a severe laceration of the forehead.

Both of the cars suffered considerable damage.

Chadwick stated that investigation of the accident is not complete yet.

About 8:30 Saturday night, a car driven by Lenwood Newton, 22, of Route 1, Farmville, was rounding a curve on the Roundtree road some seven miles from Ayden, when his lights went out, and his car went off the left side of the road, into a six-foot canal.

The driver suffered lacerations about the forehead and was treated for his injuries at Dr. Williams office in Farmville. A passenger in the car, Harvey May, received minor bruises about the face when the car nose-dived into the canal.

Patrolman R. C. Holt, charged Newton with driving without a driver's license.

The third accident near Greenville occurred last night about 1:30 a mile and one-half from Winterville.

A car driven by Mrs. Minnie Nobles Hines of Winterville, started to make a left turn when it was struck by a car attempting to pass it.

Patrolman R. C. Holt said that drivers of the two cars explained the accident this way. Mrs. Hines' car was the lead car of a string of three cars. The middle car, whose driver was not known, was moving along at a moderate speed when the third car operated by William Jessie Taylor, of 1129 W. 23 Street, New Port News, Virginia, started to pass and was along side the Hines car when she attempted to make a left turn. Taylor told Holt that he cut to the left and applied brakes in an effort to avoid a collision but could not.

Both cars suffered minor damage to the fenders of the cars.

No one was injured in the accident and no charges were brought against the drivers of the cars.

Rafael Sabatini Succumbs Today

Adelboden, Switzerland, Feb. 13—(AP)—Rafael Sabatini, the Anglo-Italian writer whose swashbuckling Captain Blood thrilled millions of readers, died at his hotel here early today. He was 75.

The author of more than 40 historical novels published since 1904, Sabatini had suffered for years from stomach ulcers. His last book, "Turbulent Tales," was published in 1946.

Einstein Warns Mankind On Path To Destruction

New York, Feb. 13—(AP)—Dr. Albert Einstein warns mankind to stop fighting—or disappear from the face of the earth.

Development and use of the hydrogen bomb, he says, possibly could cause "annihilation of any life on earth" through radioactive poisoning of the atmosphere.

The man who gave science the theoretical knowledge needed to make the H-bomb presented a general two-point formula yesterday for saving the peoples of the world from "general annihilation":

1. Ban on violence among nations, not only with respect to means of mass destruction.

2. Creation of a supra-national judicial and executive body superior to any country to decide questions of immediate concern to the security of the nations.

Einstein's views were given in the first of a series of television shows conducted by Mrs. Franklin D. Roosevelt over the National Broadcasting Company network.

The scientist, who is a leader in the Institute for advanced study at Princeton, N. J., did not appear on the program in person. His statement was given by transcription in a discussion on the H-bomb.

Calling for peace moves to "do away with mutual fear and distrust," Einstein said the present arms race between the United States and Russia has developed a "hysterical character."

"Every step," he said "appears as the unavoidable consequence of the preceding one. In the end, there beckons more and more clearly general annihilation."

Coroner Rules Suicide In Sunday Poison Death

Pitt County Coroner Griffin H. Rouse ruled that the death Sunday afternoon of Mrs. Louise Howard, 33, wife of Charlie K. Howard, was suicide. There will be no inquest.

The coroner quoted the woman as stating that her married life was unhappy and that she decided to end it all.

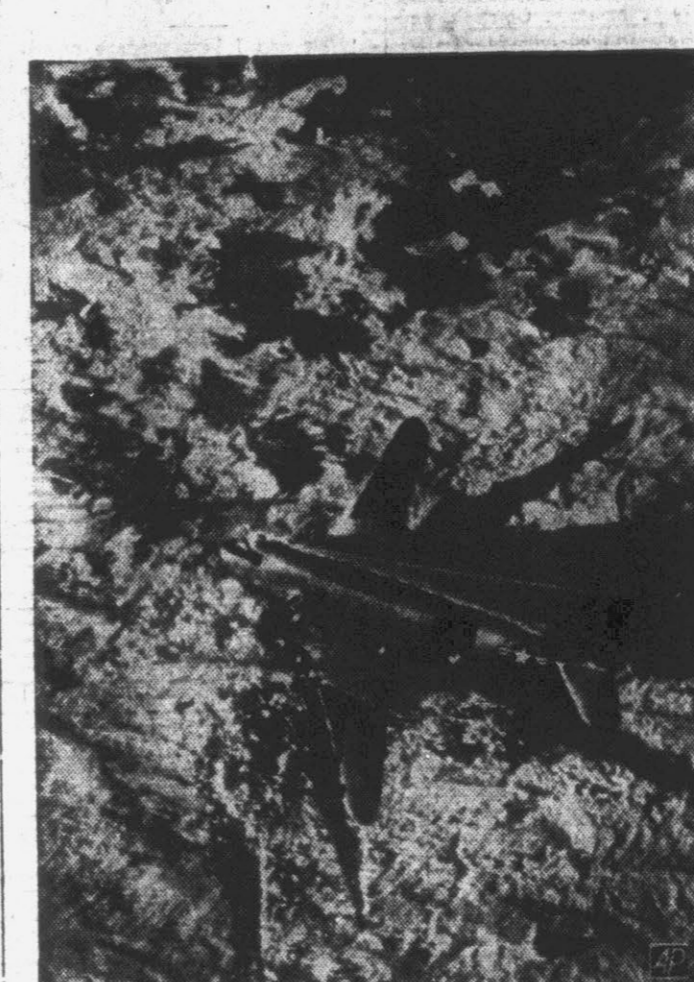
One of her children, Charlie K. Howard, Jr., was quoted as saying that he and his brother were on a bed; that his mother came into the room, kissed them and said goodbye. She told physicians in the presence of authorities at Pitt General Hospital that she and her husband had trouble.

It is believed that Mrs. Howard took the poison—rat poison—between 2 and 3 p.m. She was admitted to the hospital at 8 o'clock and died at 4.

Police who investigated the case said they had information that Mrs. Howard had previously attempted to end her life.

Funeral services and burial will be in Elberton, Ga.

Miners Ignore Lewis And Court; Strike Is Continued

Operators Consider Coal Talks' Renewal

May Complete Arrangements For Resumption Of Contract Negotiations With Lewis; Welfare Fund Hearing Today

Washington, Feb. 13—(AP)—John L. Lewis and coal operators may complete arrangements shortly for resuming contract talks as directed by a federal court. However, nothing was definite.

Judge Richmond B. Keach directed renewed bargaining "in good faith" at the same time on Saturday that he ordered Lewis and 370,000 United Mine Workers to call off their strike.

Leaders of the Southern Coal Producers Association, convening in their annual meeting today, were to decide whether to accept Lewis' bid for renewed bargaining on Wednesday.

Also on the day's schedule was another court hearing involving Lewis. This one was brought on by a former coal miner, George Livengood, with a demand for a court accounting of the now-poor miners' welfare fund.

Livengood contended the onetime \$100,000,000 fund had been unlawfully dissipated. He asked the court to oust the trustees—Lewis, representing the union, and Senator Bridges (R-NH), representing the public. The third trustee, Ezra Van Horn, quit with a blast at Lewis and Bridges for "improper expenditures" from the fund.

Bridges has filed a cross-claim in the Livengood suit asking to be relieved of any responsibility and to be replaced as trustee.

Today's hearing before Judge Burnita Matthews was on several motions. Livengood is asking access to welfare fund records. Lewis has demanded outright dismissal of Livengood's suit.

Livengood, 54, is a former beneficiary of the welfare fund. He was ousted from the U. M. W. after he filed the suit, and the union now claims that since Livengood is no longer a union member or beneficiary, he has no right to sue.

Represented At Scout Jamboree

At least three Boy Scout troops in the Pitt district have indicated they will have a representative at the national jamboree at Valley Forge, Pa., this summer, District Chairman Wyatt Brown has announced.

Brown said reservations have been made for one Scout at the jamboree by troop 15 of Bethel, troop 36 of Greenville, and troop 200 of Winterville. The regulations governing the national gathering of Boy Scouts allotted each troop in the nation one representative to the jamboree provided registration was made February 11.

Officials say more than 40,000 Boy Scouts from the 48 states are expected to be present at the eight-day camping event which will begin on June 30 and last through July 6. A complete list of the Scouts from the Pitt district who will attend the jamboree will be announced at a later date, Brown said.

Glissen To Head Demonstration In Rat Campaign

The City of Greenville this morning hired Henry C. Glissen, local mercantile, as head of the rat extermination demonstration in town.

Glissen will be assisted by State Health Department authorities in his new duties which begin February 15. The demonstration runs on through June 30.

As announced last week the extermination of rats in Greenville is a demonstration to see if present methods are effective. If so, there is expected to be a permanent campaign will be staged in the county for control of the disease-carrying rodents.

A truck with all equipment will be furnished by the State department for duty in Greenville during the four-and-a-half month demonstration.

No salary was announced in connection with the job.

'Hate Campaign' In East Germany By Red Leaders

Point To Destruction Of Dresden By Allied Bombers; Raid Helped Russia

Berlin, Feb. 13—(AP)—Communist leaders whipped up a bitter hate campaign against the United States and Britain in Soviet-occupied east Germany today.

It was the fifth anniversary of the destructive bombing of Dresden, ancient center of German culture, by fleets of American and British planes.

Royal Air Force records of the Feb. 13-15 air raids were not made public, but news accounts indicated then that the raids were intended to assist the army of Soviet Marshal Georgi Zhukov, advancing from the east.

In the ruins of the old Saxon capital today, all street traffic was ordered stopped for one minute of silence at noon.

Communist organizations in all other towns and villages of the Russian zone sponsored "Remember Dresden" observances.

The Soviet army's official newspaper, Taegliche Rudschnau, told the 20,000,000 East Germans "destroyed Dresden reminds you—fight against the imperialistic robber."

Dresden's mayor wrote in the chief Communist party organ, Neues Deutschland, that the Anglo-American raids killed 35,000 civilians but had "not been a military necessity."

London, Feb. 13—(AP)—The foreign office said today British and American planes bombed Dresden five years ago to give support to advancing Russian troops.

A spokesman was commenting on the campaign of hate against the United States and Britain in the "Remember Dresden" observances being sponsored throughout the Russian zone of eastern Germany.

"At the Yalta conference, it was decided that the western allies would give all possible tactical support to the advancing Russian forces," the spokesman said. "Dresden was the main communications center for the defending German armies."

"When speaking of bombing, the German people should remember the German bombing of Warsaw on Sept. 1, 1939, which started the whole chain of events."

Deputies On Way To Get Pelley For Old Charge

Asheville, N. C. Feb. 13—(AP)—Two Buncombe county deputies were on their way to Terre Haute, Ind., today with papers asking extradition of William Dudley Pelley to North Carolina.

The former leader of the Silver Shirts of America will be released here tomorrow from a Federal Prison where he was sent in 1942 after conviction of sedition.

Pelley still faces a two to four-year prison sentence in North Carolina. It seems from a Buncombe county judgment that he violated terms of a suspended sentence given him in 1935 for violating the state's laws on securities dealings. The judgment was affirmed by the state Supreme court, June 24, 1942, but no effort was made then to invoke the sentence because of the federal indictment.

Gen. MacArthur Gets Emergency Navy Authority

Washington, Feb. 13—(AP)—The military high command announced today it has given Gen. Douglas MacArthur authority to assume control of American naval forces in Japanese waters in event of emergency.

This unification move was made known at a news conference held by the joint chiefs of staff who have just returned from a 10-day tour of Pacific bases.

It was also announced that they have submitted a "top secret" paper to President Truman on the effects on American security of the Communist advance in Asia.

Famine Plays A Hand

Millions In East China Face Starvation; Importance Of Food Centers In Burma And Indo-China To Communists; Rulers Get Blame When Disasters Descend

The dread hand of famine again has spun the wheel of fortune in China and until it stops no man—either Nationalist or Communist—can say what fate has in store for that war-torn country.

Communist occupied East China north of the mighty Yangtze river, is being swept by the scourge of hunger. At least 16,000,000 people are reported by the Communist news agency to be feeling the pinch, and some 2,700,000 are said to be facing starvation.

Spring, which isn't so far away, is expected to bring worsening conditions in this area. Should the famine develop into a major disaster, as so often has happened in the past, it could have far-reaching effects on the status of the Communist offensive in the Far East, for China is essential to Red success.

Small wonder that the Chinese Communists, who now dominate most of China, are straining every nerve to reach the crops of Burma, Indo-China and other food centers of the Far East.

Rice kernels are more potent than bullets these days. China has been afflicted with in-

numerable disastrous famines through the centuries. People have died in untold millions. Now with her population of 500,000,000—more than a fifth of all the people in the world—there are hosts of folk who, quite apart from famine, always are hungry. There just isn't enough food for all, and that's a condition which exists in most parts of the Far East.

China's position now is particularly bad because for more than thirty-eight years the republic has known little peace. The ravages of war have left a terrible mark on the life of the country, and agriculture has been particularly hard hit. Armies have surged back and forth across the tilled fields, killing what crops the locusts hadn't got. And of course in many cases armies have appropriated the grain of farming communities, leaving the people to suffer.

So China now is very weak as this new plague of hunger descends on her. Famine means that people peel bark from elm and willow and scorch trees and eat it. They mix bitter roots of weeds with dried

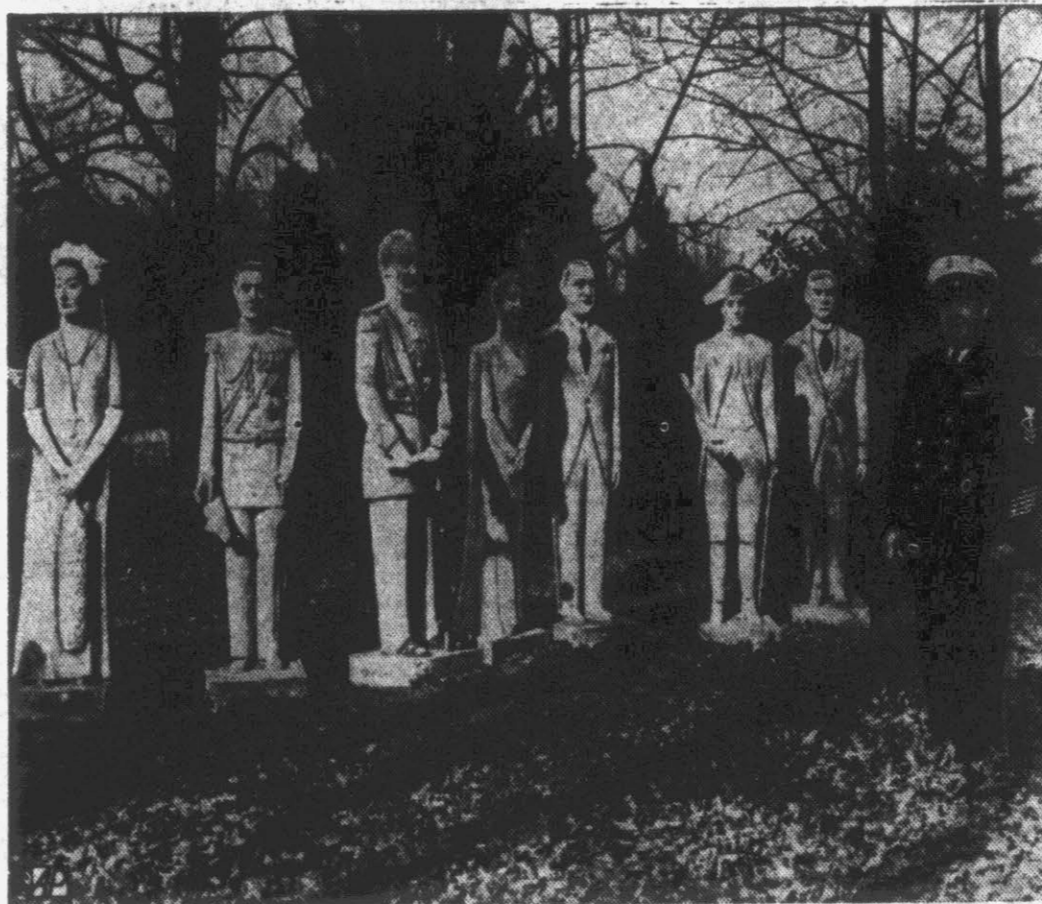
Iva Kitchell In Dance Recital Here February 16

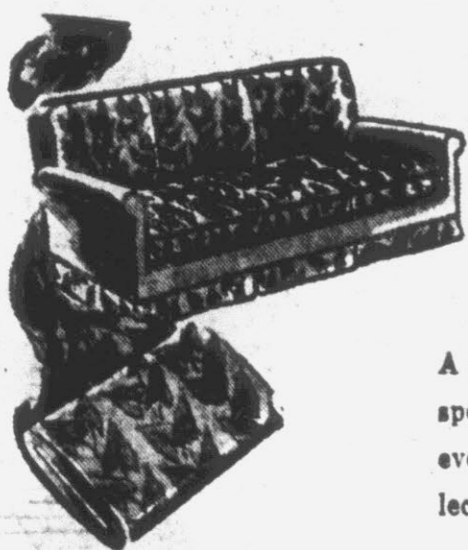

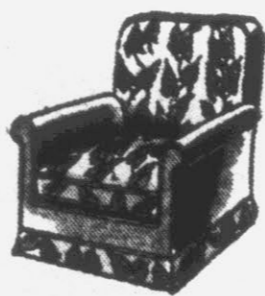

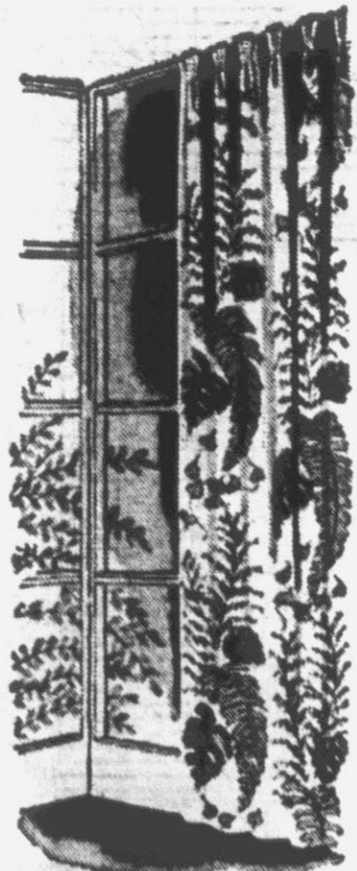

THE WATER OF LIFE IS BOUND ABOUT US

So many people waste their time asking God to do for them what He has already done. The opportunity to achieve their deepest desires stands right before them. The means lie at hand, yet they continue to implore God to give them the opportunity and the power to use it.

RATS

Officials from the state health department estimate Greenville has approximately 17,500 large rats—one for every person living within the city limits—and that these pests destroy something like \$385,000 worth of food and other property each year.

In addition to the property destroyed, rats are carriers of typhus fever and other diseases which are a constant threat to the people of the community. During 1948 Pitt county had only one case of typhus, and last year the county had two cases of typhus; but even so, the county average still remains high above the average for the counties of North Carolina.

City officials in cooperation with the county health department and the state board of health are seeking the cooperation of the people of Greenville in a program designed to rid the city of its rat population. A rat poisoning program is scheduled to get under way here within the next few weeks, but the success of the program will depend largely upon the cooperation which is received from the people in Greenville.

Citizens are being urged to comply with the city ordinance which specifies the use of metal containers for garbage in order that food for the rats may become scarce. When food is no longer plentiful, the rates will more readily take the poison bait which will be set for them. Greenville has a great deal to gain from a successful rat destruction campaign, but whether the majority of the city's rat population is destroyed hinges on how well

Around Capitol Square

THREE-WAY—There were really three Democratic meetings in Greensboro last Saturday, although all were embraced in the Young Democratic Clubs rally for the central part of the state. While the YDC executive committee was planning campaign strategy in one room the women of the party were holding a work-shop conference of their own under leadership of Mrs. D. A. McCormick, vice chairman of the state Democratic committee, and Mrs. C. W. Tillet, vice chairman of the national committee. Late in the afternoon both these groups with about a thousand other Democrats from all parts of the state repaired to armory for a barbecue feed and two hours of speech-making with Senator Estes Kefauver as the main attraction. Roll call of districts at the women's meeting showed attendants from all except the twelfth—and several were in Greensboro from that area but tied up in other sessions. YOUNGER—The battery of big shots among party leaders was impressive, but to greater degree than has been the case in recent years the youngsters ran the show. Governor Kerr Scott, State Chairman Everett Jordan, National Committee Chairman Jonathan Daniels, Senator Frank Graham, Congressman Carl Durham and Hamilton Jones, along with a dozen top-rank state officials were in evidence. Most of them were given opportunity to say a few words. They were obviously under strict management of State President Terry Sanford and his committee of Young Democrats. Several oldtimers were heard to express gratification over this trend toward younger control of the YDC activities—instead of it being a pawn in the hands of shrewd elderly politicians. CAROLINA—It was obvious that alumni and students of the University of North Carolina dominated the situation. If there had been a sound meter in the armory it would have shown most applause for Senator Graham, with second honors going to Gordon Gray, newly elected president of the university. GRAHAM—It had been charged

beforehand that the affair was being planned as a Graham rally. It was hardly that, although the Graham folks were in great majority. Senator Hoyed wired his regrets at being unable to attend. Bob Reynolds, announced candidate against Graham, was not present either in person or by proxy. Only two congressmen were present—Durham and Jones—and one other—Deane—was represented by his office staff. Senator Graham was much in evidence, and among his most effective campaigners was Assistant John McConnell, two of his secretaries, Dick Queen and Bill Staton, and his newly named campaign manager, Judge Jeff Johnson. Ribbons in Carolina colors with lapel cards proclaiming Graham for senator were distributed at the armory. Occasional criticism was heard of such use of the university colors, but most of the young folks saw nothing wrong with the idea. In fact, they liked it. REPUBLICAN—Attendants from counties where the Republican vote is heavy were concerned about local tickets that can win next fall. Majority of the crowd took Democratic victory in November as a fact already accomplished and were more interested in primary candidates. These attitudes were illustrated by two earliest arrivals was Robey Lewis of Avery, where Republicans are in control. Throughout the day he was seen in serious conference with folks from Watauga and other marginal counties. Then there was the instance of Miss Edith Marsh of Congressman Deane's office pinning a YDC badge on her fellow-countywoman, Miss Emily Hasty of Monroe. The Republican vote doesn't worry Union county Democrats much, but Miss Hasty's family is responsible for most of what worry there is. Miss Marsh was happy to have her friend with her; Mr. Lewis would have looked askance at any Republican from Avery who tried to get in on the Democratic meeting.

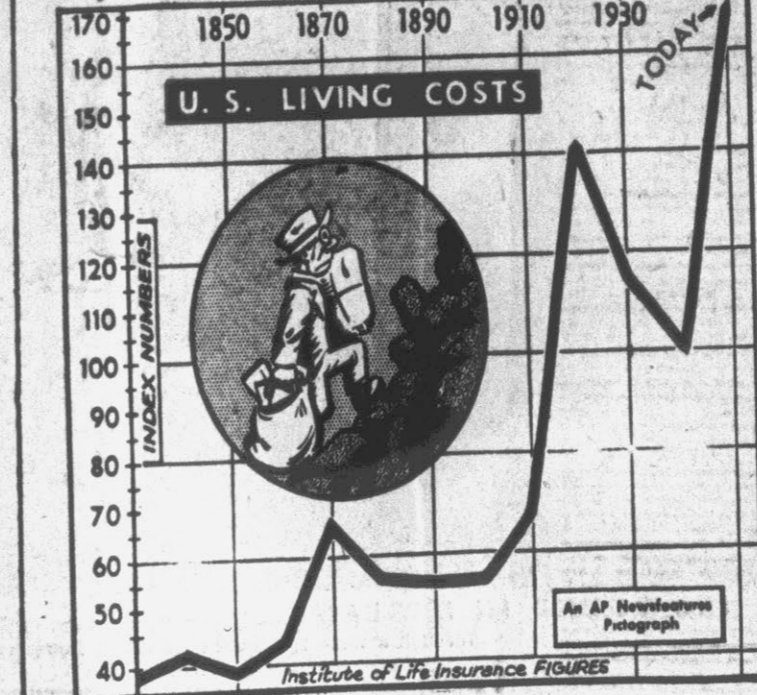

Washington Letter

WASHINGTON—Thirty years ago the 19th amendment to the Constitution was ratified. The women of the United States had won the right to vote. Do enough of them take advantage of this and actually go to the polls and vote? The president of the General Federation of Women's Clubs, Mrs. J. L. Blair Buck, thinks not. Writing in the current issue of the Federation's publication, "Clubwoman," Mrs. Buck urges women to take their political responsibilities more seriously. "One of the things that has disturbed students of political science in this country for a long time is the fact that almost half the people who could vote just don't bother to do it. Appeals to 'get out and vote' are not new. Both political

When they won the right to vote, Mrs. Buck said, most women regarded it as a right and a privilege, but she added: "Not many regarded it as a responsibility." "We would like to think that the events of the past 30 years would have followed a better pattern if more women had taken their political rights seriously," Mrs. Buck wrote. Prospects Of Opposition For Senator Hoey Fading

(From the Reflector's Washington Bureau)

Washington, Feb. 12.—There was a growing belief on Capitol Hill today that Governor W. Kerr Scott will not seek to throw opposition into the field against Sen. Clyde R. Hoey, and that Hoey will escape opposition unless a candidate against him appears within ten days.

It had been generally reported—and there was no denial from Scott—that if opposition appeared to Senator Frank P. Graham, Scott's sponsor, this year, Scott would prevent Graham's being exposed to a flank attack by an unopposed Hoey.

But the consensus of Capitol Hill opinion this week appears to be that Hoey under no circumstances would form an alliance with former Sen. Robert R. Reynolds, Graham's recently announced opponent, and that for this reason, Scott will not seek to persuade an opponent to enter the race against Hoey.

With the party primary in May little more than 90 days off, there was growing opinion that Hoey would escape opposition of any formidable type. Veteran politicians pointed out the near-impossibility of a candidate achieving success in a state-wide race if he waited until he had less than 90 days in which

to establish his political fences throughout the length and breadth of the state.

Similarly, there was a growing feeling that most of the state's members of the House would get by this year without opposition, unless opposing candidates get their hats into the ring within the next couple of weeks.

Exceptions to this belief were Reps. Carl T. Durham of Chapel Hill, who can always count on opposition from a jealous Guilford County, which believes that as the sixth district's largest, it deserves the congressman; F. Eriel Carlyle of Lumberton, believed by some factions in his district to be a vulnerable target for a strong opponent; and, possibly, Rep. John H. Kerr, of Warrenton, who faces a possible opponent in the person of State Senator Julian Allsbrook, who long has had the desire.

For the rest, with the exception of the bare possibility that Sanford Editor Bill Horner may get in the race against Rep. C. B. Deane of Rockingham, it appeared that the delegation might get through this year without significant opposition.

Some months ago, it was thought in some circles that Scott would throw candidates into the race against most of the current members of the House, as a corollary to Graham's race for the Senate. But Scott has mellowed in his attitude toward the delegation, and now says he gets along with all of them except possibly Rep. Thurmond Chatham of Elkin.

And nobody believes the farmer-politician is ready to tackle the blanket-manufacturing lawmaker this session, in view of the fact Chatham would appear to have won the support of the powerful Folger machine in the district.

Big Shrimp Beds Said 'Permanent'

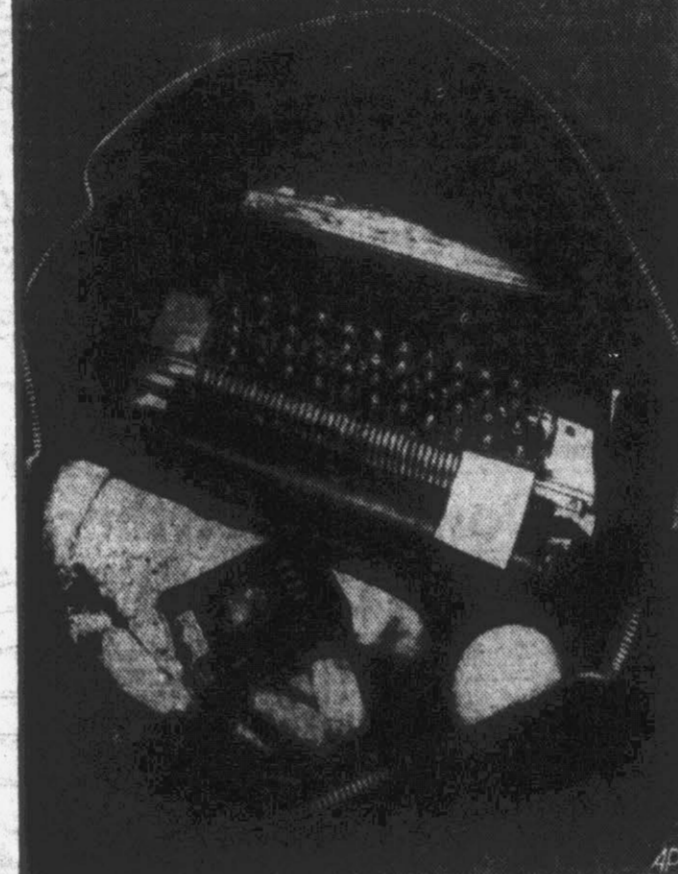

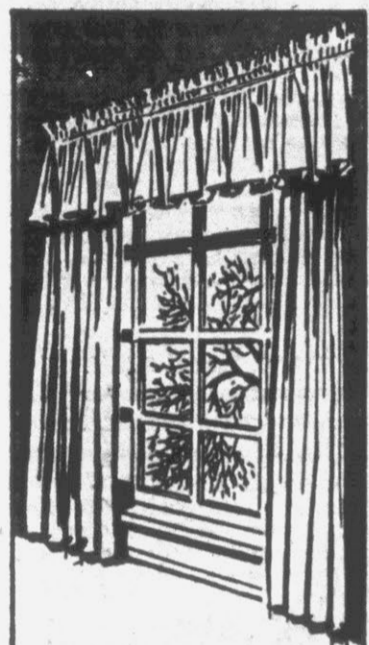

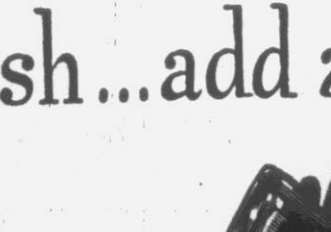
Conference Still In Market For A Commissioner

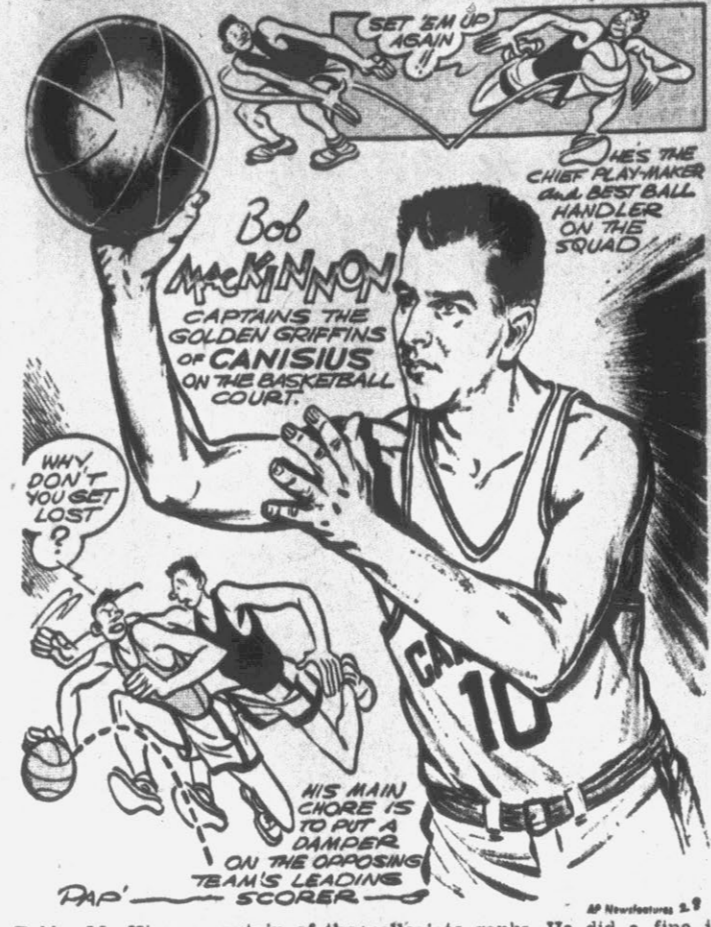

Bonded Debts Of Local Govm't Now Total Nearly \$300 Million

 Raleigh, Feb. 12.—As of December 31, the counties, municipalities and special districts in North Carolina had outstanding bonded indebtedness of \$280,826,887. This was about twenty-six millions less than on June 30, 1949, but more than forty millions above the amount outstanding on June 30, 1946. In addition to the bonds issued these local units of government had authorized but not yet issued bonds in the amount of \$34,737,000. These figures are embodied in a

compilation prepared by W. E. Easterling, secretary of the local government commission. Further breakdown shows that municipalities issued since June 30, 1946, bonds in the amount of \$52,328,000; counties in the amount of \$31,279,000, and special districts in the amount of \$1,901,600. More than half the municipal bonds were for water and sewerage systems; most of the rest for electric light plants and streets. Nearly all the county bonds were for school buildings, with only a million and a quarter for hospitals, courthouses and other purposes. About three and a half millions in bonds were authorized for refunding old debts, which adds nothing to total indebtedness but is in effort postponing payment.

Outstanding bonds at close of 1949 were distributed among the local units as follows: Municipalities, \$158,790,247; counties, \$108,932,740; districts, \$13,103,900; total, \$280,826,887. In concluding a statement accompanying the tabulated report, Secretary Easterling had a word of counsel for local government officials. He said: "Conservation of borrowing capacity for contingent needs is good insurance for continuing progress and development in our local communities."

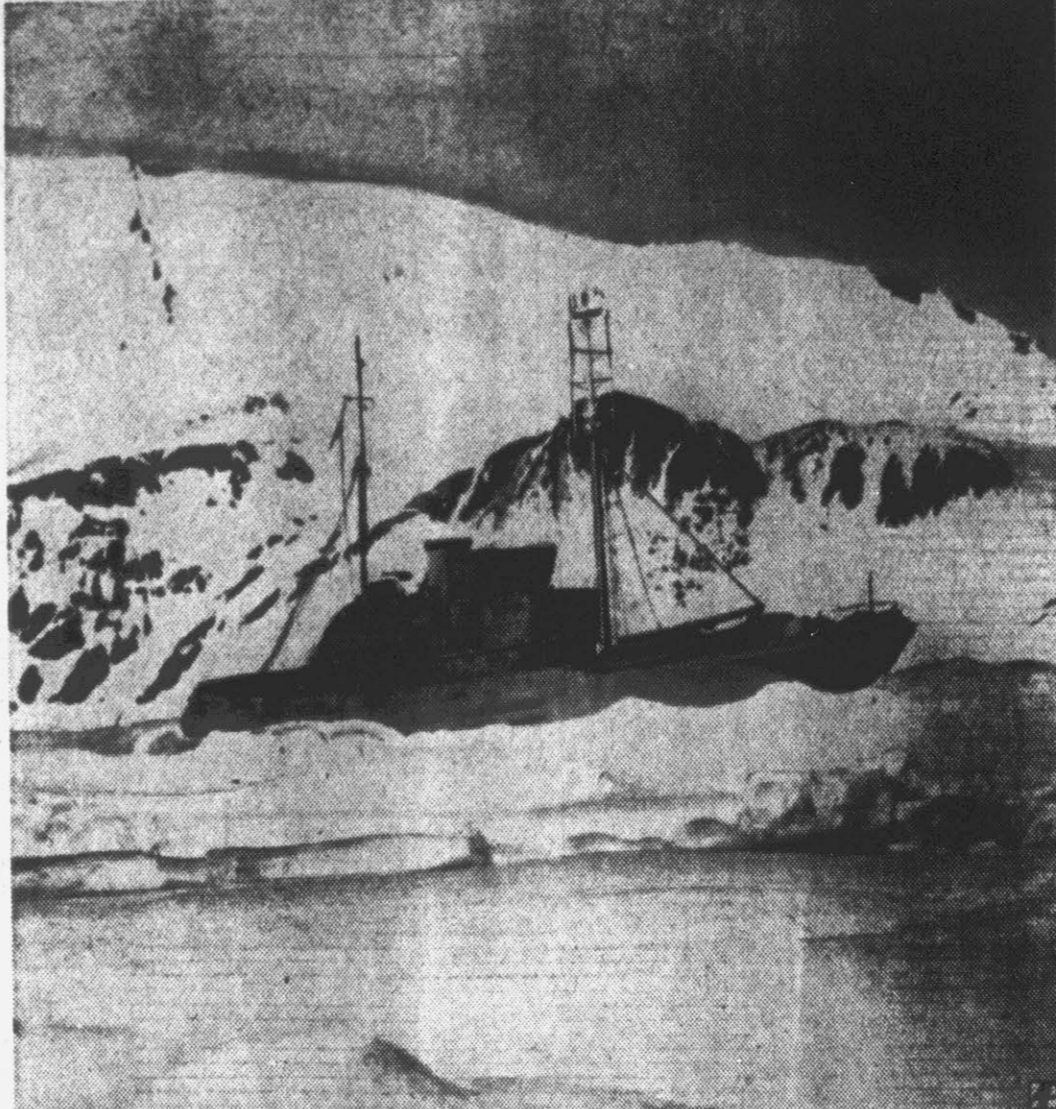

 sweet potatoes, vine, millet husks and peanut shells and eat them. The gaunt eyed children develop bloated bellies. Their elders grow more and more emaciated. And finally one by one they give up the fight and just lie down to die, either from actual starvation or allied diseases like dysentery. It is a characteristic of many Oriental people that they blame the government when disaster overtakes them, even though it be an act of nature. The Chinese are that way, and the advent of famine, on top of all their other troubles, could easily cause an adverse reaction to the Red regime.

Apropos of this it is interesting to note that the Chinese New Year begins on February 17. That ordinarily is a time of great celebration—a time of settling accounts—a time of looking into the future. If conditions

aren't good during this period, which lasts about a fortnight, then that is a bad omen for the ensuing year.
