Miss Reeves Forney, city clerk of Shelby and second vice-president of the North Carolina Business and Professional Women's Clubs, guest speaker at the Greenville club's annual "bosses' night" banquet at the Woman's Club last night, made an eloquent after-dinner speech.

She prefaced her interesting talk with the reminder: "The clock of life is wound but once, and no one has the power to tell just when the hands will stop—late or early hour. Now is the time we own, live, love, toil with a will. Place no faith in tomorrow, for the clock will then be still."

The distinguished Shelby woman reviewed the history of the Business and Professional Women's Clubs in this country. The organization, established in 1919, now has 58 clubs and 2,079 members. It is the largest national organization created to serve business and professional women. "The federation is unique in that it approaches the specific problems for women, recognizing their inevitable relationship to all social, political and economic progress," the speaker declared.

Miss Forney made a distinct impression when she recited the BPWC creed of a good citizen. "My town is a vital part of me," she stated. "It is more than stores and houses and a responsibility to the city fathers. It is my shelter and my refuge. It gives me strength with which to face my destiny.

"My town is my inspiration — it stands for the loyalty of friends, the sympathetic understanding of neighbors and the affection of my family. It gives me a pride of possession, the ideals of a free people, Christian humility, promise and fulfillment. My ambitions, pleasures, suffering and triumphs—all have their beginning and end in my town. Here I find protection, trade, friends, schools and churches. My town deserves to share the fruit of my labors. It supports me and I should support it."

In concluding, Miss Forney said: "I stand on the edge of the lily pool at night. It is as dark as I have ever seen it. I have come out for a last breath of air before the day is snatched from me forever. Overhead the gleam of the stars remind me of a line, I know not who uttered it: 'The darkest night the world has ever known did not put out the stars.'

"There is a tremendous philosophy packed into that single sentence," she said. "In it is the essence of all the progress which mankind has made—and it is a brave line. It speaks the faith and the hope of those souls who stumble and fall and get up again—and go on and lead the world forward."

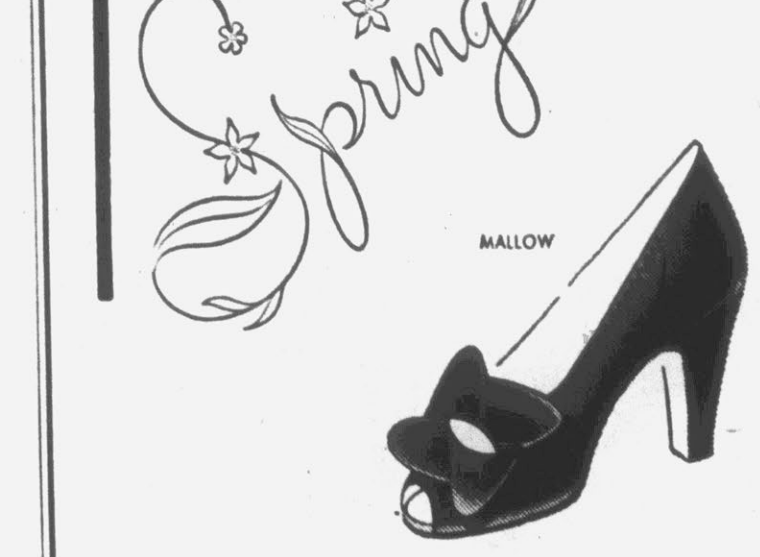

Strength FOR THE DAY

DO WE HAVE FREEDOM OF CHOICE?
We live in an age that talks a great deal about liberty. We must have freedom to do what we want to do; otherwise our lives are confined, our natural impulses suppressed.

Reflect for a moment on how little liberty and freedom of choice there is in life anyway. Did you choose the family into which you were born, or the age in which you live? Did you choose your sex, or the color of your skin, or your native land? Ninety-five per cent of the situations of our lives are fixed and established quite apart from any choice on our part.

We are like children who sit at their father's knee as he drives the automobile, and, because they have their hands on the steering wheel, they think they are running the car. If we had a real sense of humor, we would take a good look at ourselves and indulge in a hearty laugh every time we are tempted to use the word "liberty" and to plead for freedom of choice.

Yet the child who sits on the father's knee is not a slave on an automaton, but a personality. And we are personalities, even though 95 per cent of our lives, and most of the issues of our lives, are settled before we start to live. But the 5 per cent which is ours is so important, requires so much ingenuity and character to bring to full development, that we may well congratulate ourselves on the opportunities we have.

CITY TAXES

Yesterday's report from the city clerk showing the Greenville tax collections at exactly the same percentage on March 1, 1950, as on the corresponding date a year ago is an indication of the people's cooperation with the city government and efficiency in the tax department of the city.

Although the percentage on collections is the same for this year and last year, it is significant to consider the fact that this year's collections have been more than \$51,500 over the collections for the same period last year because of the 16.7 per cent increase in the tax rate.

And even with less money in circulation than 12 months ago, the people are meeting their tax obligations to the city, and from evidence throughout Greenville, the citizens in turn are receiving better services from the city departments even though they are paying higher prices for the service.

On every hand there are complaints of the high cost of government operation from the local level through the national level. But when the return the people get from their tax money is on a dollar's value received for a dollar paid basis, there is more willingness on the part of the people to pay taxes.

All the tax increase which the city has been levied for the current year has not been reflected entirely in increased services, however, for some of the revenue from the increase has gone to pay the deficit which increased services cost the city before the tax rate was hiked. On an over-all basis, we feel the townspeople of Greenville are receiving more services for their taxes than several years ago, and at the same

time are still receiving a good dollar's value for each dollar paid to the city in taxes.

Around Capitol Square

LOCAL—The slogan of the newspaper advertising group that "all business is local" applies with equal truth to all politics. Several dozen politically minded visitors to Raleigh during the past few days have testified that there is more interest in contests for sheriff and other local offices than in the statewide senatorial campaign. There is noted increasing interest in the type of men sent to the general assembly. And, even more gratifying to those concerned with good government, is the greater attention being given to county commissioners.

SCHOOLS—This attitude is especially noticeable among county school superintendents attending the North Carolina Education Association meeting here. They are interested in congressional action on federal aid to schools, but they recognize that action taken in the capitol at Raleigh and in the several courthouses will determine whether education is to advance or recede in this state. Whatever course the federal congress may make will have only incidental effect. Classroom teachers, who have little direct dealings with the courthouses, show more general interest in the senatorial race than do the superintendents whose relations with county commissioners and the state board of education are chiefly in the realm of business administration.

SOUND—Interest of the administrators in competent legislators and commissioners is based on recognition that a sound fiscal policy for state or county is more vital to continued school progress than a few extra salary dollars for a year or two. One superintendent very frankly admitted he is more concerned with holding the line where it is than in attempting to move it forward too fast. He said he could hardly hope for the same ratio of gains during the next few years as has been made in the past three or four legislatures.

GENERAL—Very similar attitude was expressed by lawyers here on legal business with supreme court or state departments, as well as

Somebody Told Me...

Right now I can't remember whether it's three or four columns that I've written about Charlie Justice, the football All-American from the University of North Carolina. You can't keep a good man out of the news, so Charlie has popped up again.

You realize, of course, that the Educational Foundation is the group of UNC football fans who contribute to a fund that provides scholarships for football players. Members are not necessarily graduates of the University. It takes money, and plenty of it, to build a top-ranking football team, so the Foundation provides the funds. As a reward, members of the Foundation get top priority (even over UNC graduates who are not members) on football tickets.

Monday night Charlie Justice was in Tarboro at a meeting similar to the one here Tuesday night. One of the Foundation members present was Dail Holderness, an official of the Carolina Telephone and Telegraph Co. in Tarboro. During his college days Dail was captain of the UNC boxing team and southern conference champion in his weight division. He has

members of the state Democratic executive committee here for the regular pre-convention session of that body. Because their interests were more general in approach than the school people. One lawyer-business man expressed it this way: "We can't afford to slip back, we must keep moving forward; but sometimes the surest way to progress is to make sure we do not slip backward. It's like the mountain climber who finds it necessary every once in awhile to dig in and get a firm foothold before trying to take another step."

OPTOMETRIST — Dr. Felix W. Jackson is opening offices for the practice of optometry in Winston-Salem. He was licensed by the state board of examiners last summer, the first Negro to take the examina-

tion in North Carolina and the first of his race to open an office for practice of that profession in this state. Four other Negroes were among the group taking the examination before the state board last week. Results of that test have not been announced.

COMPLIANCE—Dr. Jackson is a native of Mississippi, understands relations between the races and appreciates progress being made. Two of the Negroes here for the examinations last week displayed no such sympathetic understanding. They occasioned some embarrassment by sitting in the lobby of the Sir Walter Hotel, where the tests were being given. One of them was heard to say that when he came to North Carolina to practice he would do something about conditions prevailing here. Evidently he was talking about the segregation laws for hotels and quasi-public places.

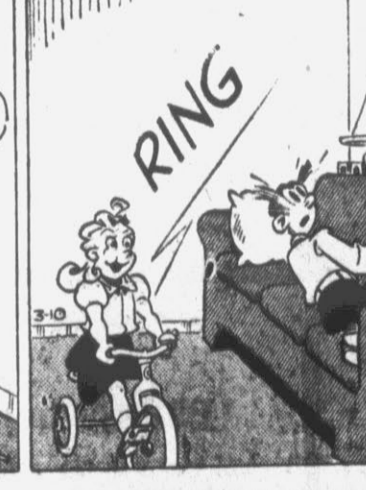

ILLUSTRATED SUNDAY SCHOOL LESSON

Scripture—Acts 6:1-6; 20:17-21-6; I Corinthians 12; I Timothy 2.



In the early church all things were shared equally among members. The Greeks claimed that their widows were not given their fair share, so the elders asked the congregation to choose seven good men to remedy this situation.

Paul called the elders of the Ephesian church to him at Miletus and told them he was leaving them. He told them they might never see his face again. Paul prayed with them, and weeping, they bade him goodbye.

At Tyre, where Paul landed, he sought out disciples, who warned him not to go to Jerusalem. All the men, women and children, took him to the shore, where, kneeling on the beach, they prayed before he sailed away.

PAUL LEAVES EPHEBUS

CHURCH ELDERS WEEP AS HE DEPARTS

Scripture—Acts 6:1-6; 20:17-21-6; I Corinthians 12; I Timothy 2.

By NEWMAN CAMPBELL "PARTING is such sweet sorrow," William Shakespeare says of lovers' partings. Partings are far from being always sweet, even when those who are parted expect to meet again. To many million people in the world today it has been and is tragedy and grief.

So many sons, husbands, brothers, sweethearts marched away to war, never to return or came back crippled. Families have been driven from their homes and put to death; or separated never to be reunited. God comfort those who have so suffered!

St. Paul had endeared himself to the disciples at Ephesus. As we were told in our last lesson, he had set his heart on going to Jerusalem for the Pentecost—the great feast time. He knew that he might be arrested and thrown into prison, or even killed, but he felt God wanted him to go.

From Miletus, further down the coast from Ephesus, where he had gone first, Paul sent to Ephesus and called the church elders to him. When they were assembled, he reminded them of his coming to them, and how he had

the shore to see him sail. All knelt on the beach while Paul prayed, "And we went on board the ship, but they returned home." This was the close of Paul's third missionary journey. In fact, it was his last missionary journey, because most of the time after this he was in custody—"protective custody," as it is called now, although he did have a brief period of liberty.

The first reference in our lesson concerns the church in Jerusalem before Paul became a convert and started his great work. You remember that the Christian members shared and shared alike in all things, the richer casting in their belongings with the poorer.

Certain Greeks among them complained that their widows were not receiving their share. The 12 apostles called a meeting and said they felt they could not leave their preaching, praying and "ministry of the word" to attend to these things. They asked that the congregation choose seven good men—outstanding men—to take care of the matter.

The whole multitude—in democratic manner—chose seven—Stephen first of all, he who was

preached to and taught both Jews and Gentiles.

"And now, behold, I go bound, in spirit unto Jerusalem, not knowing the things that shall befall me there," he said. "And now, behold, I know that ye all, among whom I have gone preaching the kingdom of God, shall see my face no more."

He warned them that after he had gone "grievous wolves" would enter the church, false teachers who would try to lure the people away from Christ, and some within the church itself who "will fall away from the truth, and draw disciples after them."

The address (too long to repeat here), was dramatic, filled with deep feeling and warnings of what this church should look for and forestall. And then Paul knelt down and prayed with them all, and they fell on his neck and kissed him goodbye.

At Tyre he looked up disciples, and stayed seven days. These disciples told him he should not go to Jerusalem. When he was leaving Tyre all the disciples, with their wives and children, went to

afterwards stoned to death—the first Christian martyr.

When they had chosen seven and the men were standing before the apostles—Stephen, Philip, Prochorus, Nicanor, Timon, Parmenas and Nicolas (all Greeks), the apostles "laid their hands on them and prayed," dedicating them to the work.

So carefully and democratically the founders of the Christian church chose their ministers in the very beginning.

Paul, writing to Timothy, who was at Ephesus, in after years, advised him of the necessity of selecting men of good moral character—not drunkards, nor polygamists, nor money lovers—to serve as bishops and deacons in the organizing of their churches. He even mentioned the wives of these officers of the church: "Even so must their wives be grave, not slanderers, sober, faithful in all things."

Such, according to St. Paul, was the type of man and wife to become leaders of the church of God. The advice is as pertinent today as it was then.

Rent Control Extension Question Still Undecided

Washington, March 10—(AP)—The question of extending rent controls another year was still up in the air today.

The Senate late yesterday voted until June 30, when the present \$1,400,000 to administer rent ceilings until June 30, when the present rent law expires.

At the same time, they voted him \$2,600,000 and told him to use it in preparation for closing up shop on that date.

Between now and then, they said, Congress can reach a decision on whether to continue controls.

The two provisions were included in a \$758,729,000 money bill to keep various government agencies in funds for the rest of the 1950 fiscal year ending June 30. That amount

was \$26,244,000 more than approved by the House—despite the efforts of Senate economy advocates to trim the total.

A threat to rent control was written into the House bill by the Senate Appropriations Committee. Instead of granting Woods the \$3,600,000 he had asked to continue operations this year, the committee recommended giving him \$1,000,000 less with orders to use the money for "terminal leave" payments—in other words, to pay off and let go the 4,000 rent control workers.

The Senate action on the bill sent it back to the House. The Senate increases probably will be compromised later by a Senate-House conference committee.

Boxing Bucs Edge Virginia Athletic Club Team By 3-2 In 'Rubber Match'

Torrans, Edwards And Williamson Carry Honors For East Carolina; Creef Floored After Spectacular Showing; Three Exhibition Bouts

Coach Johnny Long's East Carolina pugs won their rubber match with the Virginia Athletic Club last night by a close margin, 3 to 2. A near capacity crowd saw plenty of action in the five team fights and three exhibition bouts staged in Wright auditorium, with blood spurting in nearly every fight, topped off with five knockdowns and two knockouts.

In the night's feature bout, big Bill Torrans, East Carolina's spectacular light heavyweight, came out fast in the first round to stun VAC's Charlie Weeks. Continuing his onslaught on the Virginia 160 pounder in the second round, Torrans used heady right crosses to the body and left hooks to the head, which saw Weeks go down for the count of eight in the closing minutes of the round. Only the bell saved Weeks from a worse beating in the final round, as Torrans showed aggressiveness all the way to gain his decisions by a wide margin.

Another main attraction saw unheralded Charlie Edwards, the Pirates' 145 pound slugger, make a terrific comeback in the last two rounds against Al Robbins, to gain a very close decision over the gangly Virginia glover. In the first round, Robbins, weaving and connecting with fast body blows, carried the fight to Edwards, as the East Carolina pounder hit the mat for the second time. Edwards turned the tables on the VAC puncher with hard blows to the head, gaining momentum in the final round. Edwards became the complete aggressor, taking Referee Elder Craft's nod by a very close decision.

In the deciding match of the evening, smooth-working Crowell Williamson, East Carolina's outstanding middleweight, staved off the attack by Virginia's Clarence Winger, to gain his decision in the sixth round. Williamson, previously matched with VAC's Tommy Soboleska, mastered the scientific tactics of boxing in gaining his match-winning margin.

Most outstanding fight in last night's battles from the spectators' standpoint came in the heavy division class, as East Carolina's H. A. Creef and Virginia's Bill Walker brought the crowd to its feet with terrific fighting.

Creef stalked his southpaw opponent in the first round, and landed jarring head and body blows, which sent Walker reeling against the ropes continuously during the first round. In the second round, which brought the fans to an uproar, Walker regained his effectiveness and landed a hard left to the body of Creef that sent the purple and gold pounder to the mat. However, Creef came back fast in the waning minutes of the second round and had Walker against the ropes as the bell sounded the end of the second round. In the final round, with both boys tiring considerably, Walker connected with hard left jab to the pit of the stomach of Creef, that floored the East Carolina boxer in one minute and 15 seconds of the last round.

Frankie Rollins gained the second VAC victory of the night as he de-

feated EC's Cleon Smith in the featherweight division. After feeling out each other in the first round, Rollins brought a flow of crimson to Smith's nose in the second on a hard right to the head. With Smith showing fatigue in the final round, Rollins became more aggressive as he floored the Pirates' little scrapper as the bell sounded, ending the match.

In the three exhibition matches, little Jackie O'Neill, the New England Golden Glove champ and semi-finalist in the national Golden Gloves in Madison Square Garden, received a great ovation from the crowd as he defeated Ray Shaw by a TKO in one minute and 50 seconds of the second round. O'Neill, who wishes to join Coach Long's boxing forces next year, showed plenty of polished form and aggressiveness in the opening round as he rocked the tall and lanky Virginian against the ropes continuously in the first round and floored Shaw during the opening seconds of the second round before landing his final TKO punch.

Two outstanding members of the East Carolina boxing team, Ken Stargardt and Cecil Phillips, drew great approval from the crowd as they put on a brilliant performance of boxing in a non-decision bout. Both fighters, who were unable to be matched in last night's bouts, will represent East Carolina in the Southern Conference Invitational Tournament which is to be held at Columbia, S.C., March 16, 17, 18. In the third exhibition match Tom Rollins and Bruce "Boo Boo" Jones, two East Carolina students, helped get the eight-bout card underway, with Rollins gaining a very close decision over Jones.

After the final matches, Coach Johnny Long was approached on the chances of his fighters in the SIBA tournament, to which Long answered, "Win or lose, I think we will make a good showing. The boys are looking forward to the tournament. They have really been training hard for the fights, and are in good spirits after beating VAC here tonight."

Duda, pro at the host Camden Country Club, shot a one-under-par 70 to match his opening 70 for a two-day total of 140.

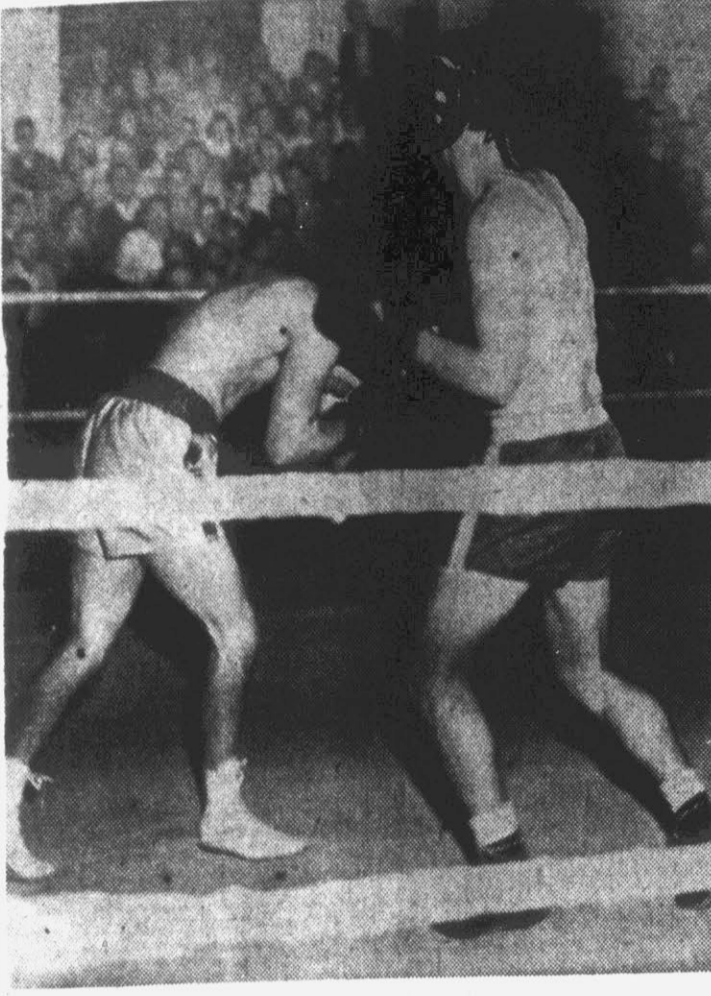

had been tricked, adding that he had offered to have the wife flown back to London, with full medical attention.

"Will not the minister consider," asked Churchill, "that Seretse has a right to go back to that very place and meet her at that very place before the government take any further action?"

Gordon-Walker replied that he couldn't do so, whereupon Churchill retorted:

"A very discreditable transaction. In all this exchange nobody put his finger on the apparent underlying cause of the government's action. That was left for the British press to do. The London Times refers to the government being under 'the urgent pressure of an embarrassing political situation,' and adds:

"The decision has been reached without any attempt by the Union to influence it. It is of South Africa to influence it. It is common knowledge, however, that the nationalists now in power are not only committed to the doctrine of the separation of the races but dislike sharing their continent with other communities in which it is not applied. x x x

"The truth is that British Africa is divided between one great independent state, which believes in the color bar, and a number of smaller states in which the color bar is repudiated. The conflict is tragic for the commonwealth but it cannot forever be evaded."

again Tydings has interrupted McCarthy to see what proof he had for the charges he made.

So far McCarthy has named by name only three people. These, he said, had been members of or contributed to organizations which the government later declared to be subversive. But he has offered no proof to show that any of the three was a Communist.

This brings out one of the main points in the hearing: The vast difference between deliberately doing wrong and being an innocent party in wrongdoing. For instance:

Many loyal Americans in times past joined, without knowing the true but concealed nature and purpose of them, organizations which the government later announced were Communist-front outfits.

But a person isn't necessarily a Communist or sympathizer just because, without knowing it, he got mixed up in a Communist outfit or one that was set up to serve a Communist purpose. To say he is, is to say an innocent person is guilty of a sin committed by his associates. This is the old "guilt by association."
