Economists Concerned Over Halting Of Unemployment

Jobless Count Inching Toward Five Million Mark; U. S. Will Have To Provide Jobs For Extra Ten Million In 1960; Labor Force Growing

Washington, March 16 (AP)—Government economists showed concern today over how to clamp a lid on unemployment, now inching toward the five million mark.

By 1960, they said, the nation will have to provide jobs for some 70,000,000 workers, instead of the 60,000,000 considered the top goal for the immediate postwar era.

But the increase in the labor force apparently has brought no corresponding rise in job openings in recent months.

Census takers counted 4,700,000 jobless in Feb. 11. Statisticians say the number may pass the 5,000,000 point this year, for the first time since 1941.

Already a dozen areas have been stricken with unemployment described as equal to that of 1933. While most of these are small, scattered places with special problems, 43 areas are classed as having "substantial" surpluses in manpower—meaning that more than 12 per cent of their workers are walking the streets.

The 12 areas listed as hardest hit are Washington County, Me., Lawrence, Mass., Pottsville and Greensburg, Pa., Jasper, Ala., Clinton, Ind., Cairo, Crab Orchard, and Mount Vernon, Ill., Sheboygan and Muskegon Mich., and Park City, Utah.

Over the nation, 71 per cent of all workers covered by jobless insurance were listed as out of work in mid-February. That compares with the national average of 25 per cent unemployed in the worst year of the depression, 1933.

Another 1,750,000 college and high school graduates are expected to join the labor force this spring and summer. It will be a record influx, representing the biggest wave yet of war veterans whose entrance into the work force was put off for a four-year GI education.

To help relieve the pressure, the federal government is conducting a campaign to encourage private business to make more jobs. President Truman has told Congress that 2,000,000 more jobs in private industry will solve the immediate problem.

A "shell" of public works projects is being assembled, but most of the projects are in the field of construction, which has not been nearly so hard-pressed by unemployment as certain others, like textiles.

More than 300 persons were out of work by last night's spectacular, wind-driven blaze at the Moosehead Mills.

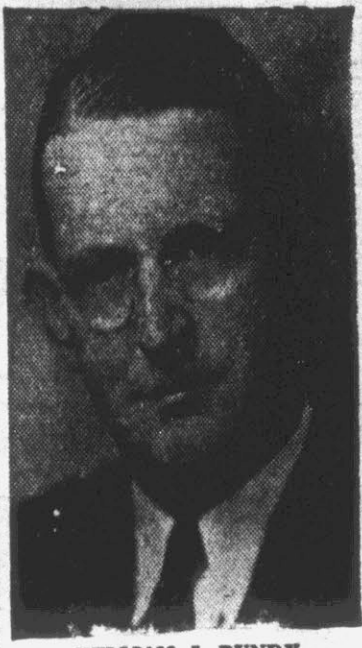
Firemen of four towns, hampered by the wind and lack of water, battled the blaze in a snowstorm.

Two File For Pitt Commission; Bundy To Run; Constable Is Candidate

Pitt county's political field broadened today as four new candidates tossed their hats into the ring.

W. J. Bundy of Greenville, solicitor of the fifth judicial district, posted his filing fee in Raleigh yesterday as a candidate for reelection to the office he has held since February, 1948, when he was appointed to fill the interim period between the death of Solicitor D. M. Clark and the next regular election.

Bundy is well known in masonic circles having served as grand master of the grand lodge of North Carolina and as potentate of the Masonic Temple in New Bern.

Three other Pitt countians made known their candidacies late yesterday and this morning as two filed with Elections Board Chairman Harrell, and another announced his candidacy, although he had not posted the filing fee this morning.

County Commissioner Marvin Smith of Chocowoc announced he will seek reelection to the county's governing body from the fourth district which includes Winterville and Chocowoc townships.

C. C. Harris of Ballard's Cross Roads filed with Harrell as a candidate for commissioner from the third district which includes Falkland, Fountain, Farrville and Beavertown townships.

He will oppose Commissioner G. H. Pittman who last week filed for reelection and announced he will seek another term in office.

Constable H. E. Hill of Pactolus this morning filed with Harrell as a candidate for reelection to the office of constable of Pactolus township.

He was appointed to the office by the county commission in June, 1948, following his nomination in the May democratic primary. He took office in December, 1948.

Commissioner Smith who is so far unopposed in his bid for reelection was elected to the county board of commissioners in 1946, and was again elected in 1948. He had previously served as a justice of the peace and a tax collector in the county and is active in the church work in his community.

The first race for a commissioner's office will be held in May.

Signs Oleo Bill

Key West, Fla., March 16 (AP)—President Truman today signed the bill to repeal the federal tax on oleomargarine.

It was Mr. Truman's first action after his arrival here for a vacation after a sea voyage from Washington.

Charles G. Ross, presidential secretary, said the signing of the bill was done at the "Winter White House." The measure was flown here by courier plane from Washington yesterday.

Under the new law all federal taxes on margarine are wiped out. But it does not interfere in any way with taxes or restrictions placed on oleomargarine by any state government.

The law does say that any restaurant selling yellow margarine must sell it in triangular packets, and the restaurant must post a notice saying margarine is sold there.

Suspect Russia Prompted Poles

Washington, March 16 (AP)—Poland's sudden withdrawal from the "World Bank and Fund is considered by some American officials as a Moscow-directed move to strengthen the Russian ruble in eastern Europe.

Poland walked out of both 48-nation institutions yesterday, terminating instruments of "imperialist" United States policy.

Informed government officials said the real reason for the Polish action probably is this:

1. Moscow has decided to build up a ruble "trading bloc" among the satellite countries as part of its campaign to tighten Russia's grip on their economies.

2. Before this can be done, satellite governments would have to value their money in terms of what it is worth in rubles alone instead of dollars, as is the case now.

3. A necessary preliminary would be for satellite countries to pull out of the international monetary fund, which pegs all member currencies to the dollar.

The fund was created in 1945 to spur world trade by maintaining realistic rates for the money of member countries. Russia refused to join but Poland, Czechoslovakia and Yugoslavia did.

American officials see a possibility that Russia eventually may force satellite governments to scrap their individual currencies altogether and substitute the ruble. The ruble has no international value at present and could be spent only for Russian goods.

Secret Military Outlays Come Under New Study

Washington, March 16 (AP)—Requests for about \$70,000,000 worth of highly secret military installations—described by the armed forces as imperatively needed—came under new study on Capitol Hill today.

Military witnesses have told the House Armed Services Committee that these projects should have "high priority." They are part of a \$187,142,000 amendment to the Defense Department's \$477,974,000 public works bill which the committee previously had under consideration.

In addition, Chairman Vinson (D-Ga.) instructed the Marines to submit two amendments for \$27,478,000, bringing the grand total in requests for public works to \$692,592,000.

No More Acting For 9-Year-Old

Los Angeles, March 16 (AP)—Lora Lee Michel, the nine-year-old who ran away from her life as a \$90 a day actress, is through with the movies—by a judge's order.

Juvenile Judge A. A. Scott said yesterday that Lora Lee will be made a ward of the court and "will be kept in Juvenile Hall and studied for awhile, then she will be placed in another foster home where she can have fun—like any other child."

Critic Punished

Washington, March 16 (AP)—The Navy has decided to punish Capt. John G. Crommelin, persistent critic of Pentagon policies, by furloughing him indefinitely at half-pay instead of trying him in a court martial.

The action amounts to his involuntary retirement at the age of 47, and Crommelin blamed it on the Army and Air Force general staffs. He has been blaming them all along for what he called a serious weakening of the Navy in the Army-Air Force-Navy unification setup.

Secretary of the Navy Matthews announced the punishment last night, effective April 1. A Navy spokesman said it was for "continued actions prejudicial to the service."

Three Missouri Officers Facing Court's Martial

Commander, Operations Officer And Navigator Ordered To Be Tried

Norfolk, Va., March 16 (AP)—General courts martial were ordered today for the commanding officer, the operations officer and the navigator of the battleship Missouri as a result of the vessel's grounding in Chesapeake Bay January 17.

The officers to be tried are Capt. William D. Brown, of Frostproof, Fla., the big Mo's skipper; Comdr. John R. Millett, operations officer, and Lt. Comdr. Frank G. Morris, of New York, navigator.

The courts martial will be convened March 27 at the Norfolk Naval Base. The trials will begin at that time, naval spokesman said. If the defendants are ready to proceed, all proceedings will be open to the public and the press.

The courts martial were ordered by Rear Adm. Allan E. Smith, commander of the cruiser force of the Atlantic Fleet, after a review of the proceedings of the naval court of inquiry which investigated the grounding.

Smith's action was announced by Adm. William M. Fecteler, commander-in-chief of the Atlantic Fleet.

Fecteler said "the formal charges and specifications to be served upon these officers and upon which they will be tried, will not be made public prior to the convening of the respective courts. The individual officers concerned, however, may release the charges and specifications in their respective cases at their own discretion."

Fecteler said Smith did not consider the evidence against Lt. John E. Carr, of Norfolk, Va., combat operations officer of the Missouri, of sufficient gravity to warrant trial by court martial.

However, Smith has addressed a letter of reprimand to Carr.

Brown, Millett, Morris and Carr were defendants before the court of inquiry, which heard a half hour of testimony during 18 days of sessions between February 3 and February 25.

Fecteler said no serious blame was "considered as attached to Carr, Edwin R. Harris, of Norfolk, Va., the Missouri's assistant navigator, and therefore no disciplinary action was taken in his case."

Search Pacific For Naval Ship Long Overdue

Pearl Harbor, March 16 (AP)—Search centered today 400 miles north of Kwajalein Island for a missing Navy tender bearing 83 men enroute to Eniwetok Island.

The craft, the Elder, commanded by Lt. William F. Adams of San Diego, was due in Eniwetok Monday with a cargo of navigational buoys for the atomic proving grounds. She was last sighted 700 miles from Eniwetok by the transport A. W. Brewster. The tender was in no apparent trouble then.

A spokesman for the Hawaiian Sea Frontier said it was possible the tender might have struck a floating mine and been sunk.

Secretary Of State's Seven-Point Program Calls For End To Soviet Aggressive Diplomacy And For New Moves To Conclude Peace; Predicts Russian Refusal

Berkeley, Calif., March 16 (AP)—Secretary of State Acheson challenged Russia today to demonstrate her desire for peace by accepting a new seven-point program to free the world from "destructive tensions and anxieties."

Bolled down, the seven steps Acheson proposed call for an end to Russia's aggressive diplomacy, both in her dealings with satellites and with the Western world, and for new moves to conclude peace treaties and to find some solution to the problem of atomic controls.

Bluntly, he predicted Russian refusal of any attempt to settle these points of "greatest difference" between the East and the West.

But he insisted that they "must be identified and sooner or later reconciled if the two systems are to live together, if not with mutual respect, at least in mutual security."

Otherwise, he said, the United States can only continue to resist aggression where it finds it, and to "press ahead with the building of a 'free world' as we see it."

"We are always ready to discuss, to negotiate, to agree," Acheson declared, "but we are understandably loath to play the role of international sucker."

Acheson's address—a major statement of American policy said to have taken three months to draft—was prepared for delivery at the University of California, in connection with the conference on international cooperation for world economic development.

Declaring that "We want peace, but not at any price," Acheson said Russia must do several things "which, while leaving much yet to do, would give the world new confidence in the possibility of peaceful change." These are the points he listed:

1. Join with the West in defining peace terms for Germany, Japan and Austria—without trying to make them satellites—meanwhile refraining from any interference with the new states of the Far East.

2. Withdraw military and police forces from the Soviet satellites and refrain from using the shadow of that force to keep in power persons or regimes which do not command popular confidence.

3. Drop the present "policy of obstruction" in the United Nations and help make the U.N. a serious instrument for building international peace and security.

4. Join in seeking "realistic and effective arrangements for the control of atomic weapons and limitation of armaments in general."

5. Stop using Communist party apparatus to overthrow by subversion means "established governments with which the Soviet government stands in an outward state of friendship and respect."

6. Quit harboring American diplomatic representatives, who are now being "treated as criminals," and branded as "sinister people" with whom all contact is "pregnant with danger."

7. Stop "systematically distorting to their own peoples the picture of the world outside their borders, and

Not Well-Informed

A Good Democracy Rests Largely On Keeping Everyone Informed As To Every Issue; Too Many Americans Aren't Keeping Up; Congressmen Can't Do It All

Washington, March 16 (AP)—Evidence keeps bobbing up to show that a lot of Americans don't keep themselves informed.

This is a weight around the necks of the rest of the people who want a better democracy. It plays into the hands of those who don't.

In a speech last night Gordon Dean, a member of the Atomic Energy Commission, spoke of a survey made by expert public-pollsters. He said the survey, made in December, three months after President Truman announced an atomic explosion in Russia, showed 26 per cent of the polled people hadn't heard of it.

This brings up the old question: How do you get a good democracy? The ideal democracy is one in which everyone is completely informed on every issue and everyone is voting age votes directly on every issue and on every law that's proposed.

In such an ideal democracy there'd be no Congress. A Congress like ours would be unnecessary if everyone could vote directly on every issue.

But our society is not the ideal democracy. It can't be. It's too complex, with all the different groups dependent on one another for production of clothes, food, light, housing and so on.

Producing those different things and earning a living keep most people too busy to be completely informed on every issue and to vote on every one. So we elect a Congress to represent us and act for us. This doesn't mean we give the 531 members of Congress a blank check to do anything they please for us, or to us. It doesn't mean that, having elected a Congress, we ourselves stop thinking and yield up all control over us to Congress to tell us Congressmen what we feel on the issues that arise; to put pressure on them to vote the way we think they should, and to change our congressmen when we no longer believe he represents our views.

But to do those things intelligently, so that we will have a Congress acting most responsibly to the will of the people, means we have a responsibility and obligation to be informed on as many issues as possible.

Desire Tax Day

While Billions Pour In, GOP Hits Financial Policies

Washington, March 16 (AP)—The federal government jingled several billion dollars in fresh spending money today as late check-laden returns trickled in from taxpayers across the nation.

Nothing that even though billions richer, the government still is in the red, Republicans in congress grasped at the chance to belabor the Truman administration and its financial policies. Democrats replied with reminiscences of the depression years.

In Detroit, what may have been the day's biggest tax payment—a \$114,373,394 quarterly installment from General Motors Corp.—showed up in the same mail with what certainly was one of the smallest: two cents.

And in a long list of cities the day marked the last chance the government had to catch up with 1943 tax fraud cases involving an estimated \$15,000,000. At midnight last night, the seven-year statute of limitations went into effect, closing the books on any new action against those who evaded taxes during that war year of high profits.

Although income taxes had the spotlight everywhere else, on Capitol Hill the emphasis was on excise

Rain Slows Pitt Red Cross Drive

Returns Slowed By Weather; Canvassing Is Postponed

Rain over practically all of Pitt county today put a damper on the county-wide Red Cross drive campaign.

County Chairman Lester Turnage said money was slow coming into the county office today because inclement weather kept most of the 200 volunteer workers throughout the county indoors. The house to house canvass in Greenville which was scheduled for today by members of the Service League and other women of the city has been postponed until tomorrow, Turnage said.

Although on a county-wide basis the collections for this year have fallen behind the anticipated day to day goals, the county chairman expressed the belief the \$11,280 goal would be reached. He added however, "The campaign in some communities will have to go over into next week before the goals are reached." He said the quota for Greenville probably will be reached by Saturday.

Although no official report from the other communities of the county have been compiled, Turnage said preliminary reports received last night indicate most of the workers in the individual communities have contacted about half the people and have about half their quota. He pointed out that in past years the county has reached its goal by virtue of Greenville, Farmville, Ayden and Bethel going over their assigned quotas, and aiding in making up for communities in which the quota was not reached.

He added, however, that this year all the communities "are struggling to meet their quotas. The smaller sections are doing a splendid job of trying to raise enough money to make their communities go over the top."

Raise Estimates Of Rioting Toll

New Delhi, India, March 16 (AP)—Official Indian sources said today additional information on the recent East Bengal communal riots indicate the death toll is "much higher" than the 3,500 lives estimated earlier.

These sources did not announce their latest figures, but said new information showed 600 Hindus were killed during the peak of the disturbances on one section of a rail line near the West Bengal border.

Takes Control

Taipei, Formosa, March 16 (AP)—Pres. Chiang Kai-shek took direct control of Nationalist Chinese armed forces today.

The office of Southeast Asia commander, formerly in command of Formosa armed services, was abolished. Premier Chen Cheng held the post until he took the premiership this week.

The move was part of an effort to streamline the government and step up the war machine to prevent another defeat—which might cost Nationalist leaders their heads.

'Grass Roots' Talk

Acheson's Major Foreign Policy Speech Promising Limited Aid To Non-Communist Asiatic Nations Was Addressed To Peoples, Not To Governments

Secretary of State Acheson's major foreign policy speech before the Commonwealth Club in San Francisco yesterday, promising non-communist Asiatic countries limited aid in their fight against "Soviet-communist imperialism," took the unusual form of being directed to the grass roots.

Acheson was speaking not only to the American people but apparently was reaching out in an effort to contact the rank and file of Asia's millions rather than restricting his remarks to governments. And President Truman en route to Florida on vacation, let it be known that he had read Acheson's address in advance and thought it a "fine speech."

America's assistance would cover military, financial and technical aid. It could be used only to "reinforce the efforts which others are prepared to make on their own behalf." That's a blunt way of saying that Uncle Sam can only help those who help themselves.

Then Mr. Acheson gave a fillip of hope to the thousands of Americans who have been struggling with their income tax reports—and wondering where the money was coming from to meet the bills. He declared that U. S. aid "must be with the prudent capabilities of our own resources."

The secretary stressed that the greatest threat to Asiatic progress and freedom is the attempted penetration "by Soviet-communist imperialism and by the colonialism which it contains." He emphasized this thrust by declaring that communism is a "tool of Soviet imperialism" and perverts the real democratic revolution. The American people are the real leaders of a "revolution by the common people."

China naturally occupied a prominent part in the address. Acheson declared that the U. S. will support the Chinese who are fighting the Japanese. He said that the U. 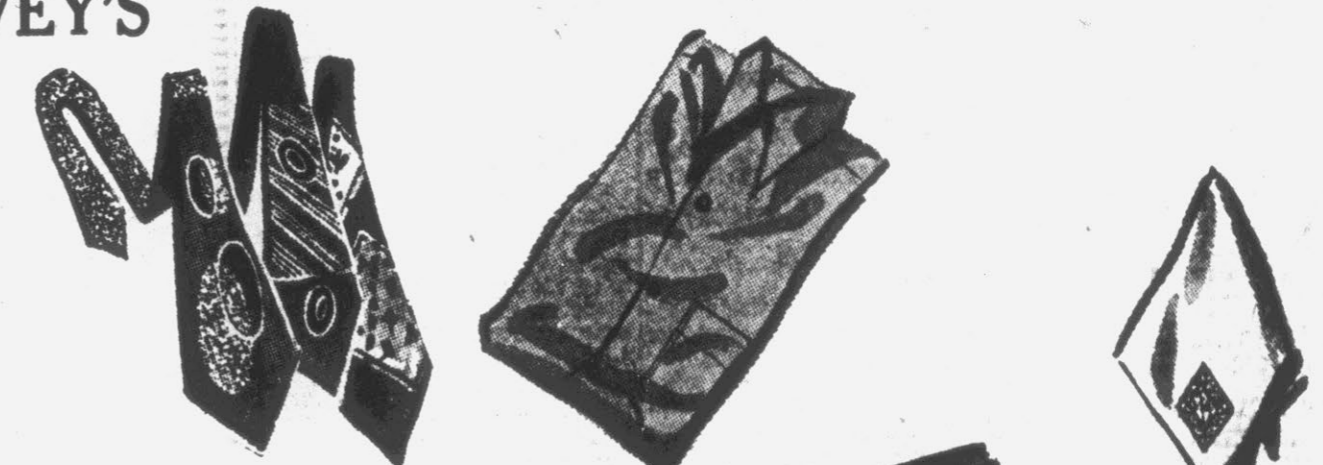

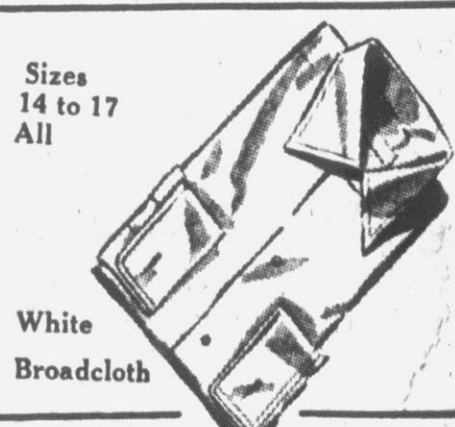

Dangerous Dust Is Blown From Atomic Workers

Minneapolis—(AP)—A breath of air so slight you could hardly detect it even by holding up a wet finger wafts radioactive dust particles away from workers in atomic-energy laboratories.

The controlled air movement over the special desks of such workers must be "marvelously precise," explained James S. Locke of Minneapolis-Honeywell Regulator company. "It must be strong enough to draw off fumes and dust, but not strong enough to draw into the exhaust mechanism any of the material being tested." An electronic instrument achieves this balance through super-sensitive thermostats that control dampers in the ventilating system. The thermostats create and control a breeze that is about as strong as the upward curling of smoke from a cigarette in an ash tray.

IT CAN BE DONE
About one hundred years ago a young man by the name of George Williams went to work as a clerk in a London store. Moral conditions in England at that time were so bad and the dissolute character of most of the employees of this firm so notorious that everyone declared that young Williams would lose his Christian ideals amid such an environment.

Within a few years this particular store which had been notorious for the dissolute character of the people connected with it, became equally well known throughout London for its high moral tone. Young Williams had started an organization which he called the Young Men's Christian Association. Later he was knighted for his efforts, and his little group grew into a world-wide army of consecrated men attempting to bring wholesome environment and the inspiration of high ideals to young men all over the world.

RESPONSIBILITY AND AUTHORITY

Captain John G. Crommelin, naval war hero, expert in matters pertaining to naval aviation and foremost critic of Defense Department naval policies, has been suspended for his criticisms. The disciplinary action was prompted by either the nature of his criticisms or the fact that he persisted in them after having been ordered to desist. Unquestionably, Captain Crommelin's case is going to raise a furor rivaling that occasioned by the abrupt dismissal of the Naval Chief of Staff Admiral Louis Denfeld.

There is a natural abhorrence in the public mind to the dismissal and punishment of an honored public figure for expressing his honest convictions, particularly when his apparent goal is the national welfare. The immediate reaction is that Defense Secretary Louis Johnson is demanding that his office be surrounded by "yes men," and is forcibly concentrating all military authority in his high office.

The objectors point to the weaknesses of the "yes man" system in any business and its inherent dangers in government... particularly in a government based on the principals of democracy. As a general rule, Americans just aren't accustomed to, and are opposed to any system of procedure that obliterates the hearing of opposite views, debate and either compromise or proceed on the basis of majority approval.

But that is not military procedure, and the Department of Defense is definitely a military establishment. Matters of policy are established therein, and all subordinates are required to

carry out those policies to the best of their ability.

It is logical that Democratic procedure must be omitted in the military set-up. Its nature necessitates the placing of authority and responsibility, which now rests on Secretary Johnson. That's quite a load. No individual could carry that responsibility, the security of the United States, without the authority to enforce compliance with his long-range plans. Half-hearted compliance or schisms among personnel who have positions of trust only weakens the approach to the end.

Unification of the armed services has been long-sought, and accomplishment in the past left much to be desired. Whatever his methods, Secretary Johnson is bringing about a degree of unification which was previously lacking. There are bound to be critics as to his handling the difficult task, but even they will admit his system has been effective.

Whether his defense policies are sufficient and adequate is something else again. The only sure answer is when they are put to the ultimate test. Not many men would want to find themselves in such a position.

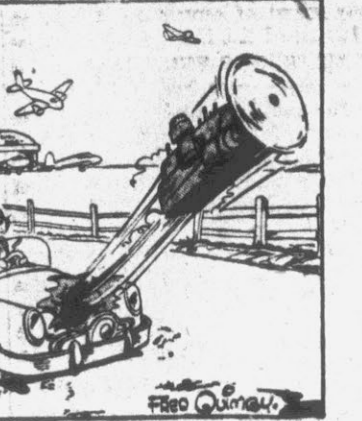

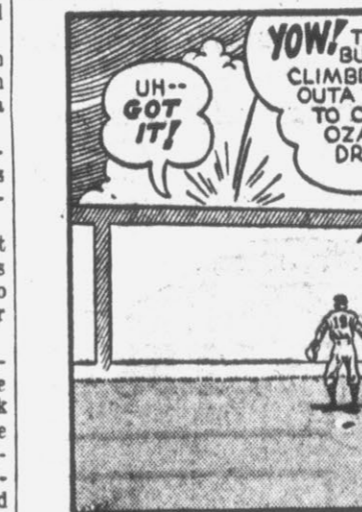

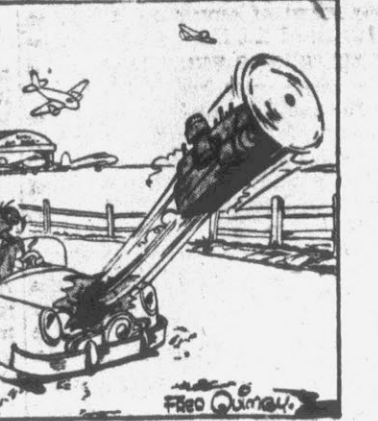
Designs Luxury Home For Dogs

Movies Ask High Court To Ban Local Censorship

Washington, March 16—(AP)—The movies have appealed to the Supreme Court to ban state and local film censorship but Rep. Angell (E-Ore.) sees a need for "supervision" to protect the morals of youth.

Angell took space in the Congressional Record today to voice belief that the movies, along with radio, television and comic books, increase juvenile delinquency and are "one cause of crimes of sex and violence."

United Artists Corp. and Hal Roach Studios, Inc., appealed to the high court yesterday in a Tennessee case. The appeal said the Memphis city board of censors had forbidden showing of the film "Curley" because Negro children were included in the cast along with white children.

The studios asked the court to declare the censorship of movies unconstitutional, holding that such restriction violates freedom of speech and freedom of the press, in the broad sense of those constitutional guarantees.

The proposal came close on the heels of a bitter attack by Senator Edwin C. Johnson (D-Colo.) on the morals of some Hollywood notables.

Johnson let it be known yesterday that he is planning to call spokes-

men for the film industry before his commerce committee next month for a frank discussion of the off-screen antics of movie folk.

Two of the people he has in mind are Actress Ingrid Bergman and Director Roberto Rossellini, principals in a widely-publicized romance in Italy.

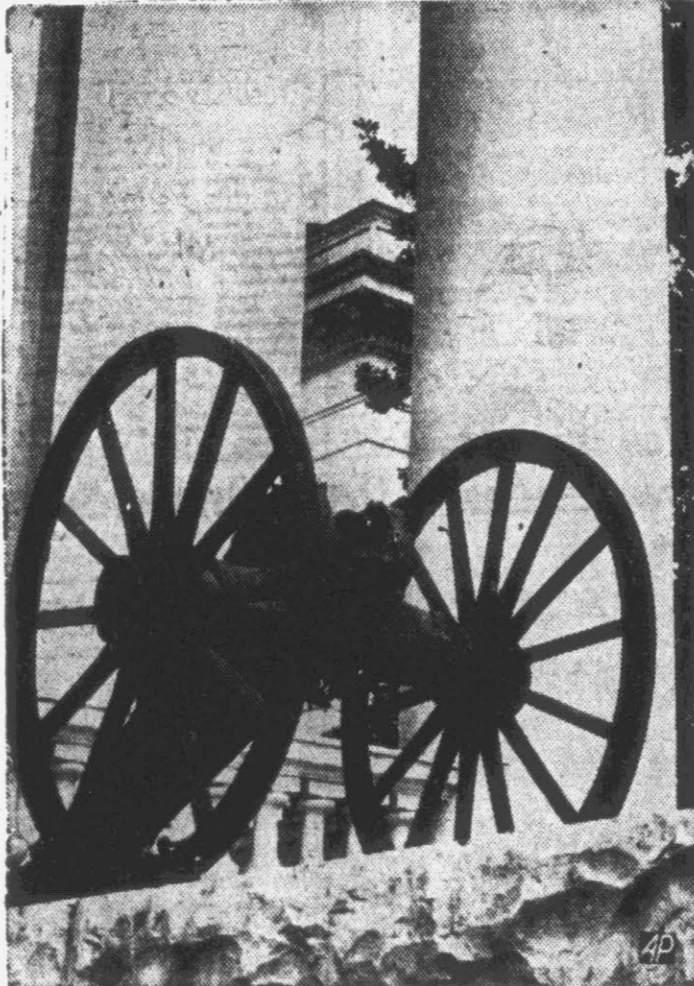

Rounding out the backfield for the Gold team will be four returning lettermen and three rookies. The four monogram winners are Bill Derby, Frank Maennie, Billy Smith, and Bob Grady.

Derby came into his own in the running department last year, and is expected to handle the punting chores for the Gold team. Maennie will be slated for the power-driving fullback spot, with Smith and Grady, two Pirate scabbacks, taking over the offense from the halfback positions.

Newcomers are Clark, Jim Cushing, and Pistrak. Cushing, a well built line plunger from Wilmington, N.C., will see plenty of action in tomorrow's game, and will be counted on heavily next fall.

Farmville Mites Eliminated By Winterville Five

The first annual Midget tourney got underway with a bang last night when the untested Winterville cagers knocked favored Farmville out of the running with a stunning sudden-death victory, 34-24, to open first-round of play.

The team which had never played a game except among themselves led all the way by virtue of their tremendous height, considering their ages.

Paced by two starters who towered over their opponents, Dick Hoogood and Ed Evans, the midget Wolves marginated a first-quarter lead of 9-3 and again at the half, 19-11. Hoogood and Evans, a guard and center respectively, controlled the ball and the backboards all night and both emerged high scorers with 11 points apiece.

For Frank Cerruzzi's Farmville club, Jack Allen and Bobby Hathaway were the leading scorers and defensive guns. Allen connected for nine points while Hathaway was following with eight. Both played the best defensive games for their team.

The win was a definite upset for Rommie Mallison's quint, one which will throw a scare into their possible opponents during the rest of the tourney.

In the four games tonight, formerly the first round of play, probably the toughest drawing of the entire eight teams matches Raleigh against New Bern. Raleigh hasn't lost a game in 18 outings and is definitely pointing for the championship of this tourney.

They are paced by Fred Deberry, a 12-year-old lad who has led the Red Wings in scoring. He has a hook shot from either side and can also score on a push shot from his center position. The forward posts are held by Bobby Caviness and Van Colton. Both have a variety of shots. At the guards will be four alternates—Neil Birch, Julian Peebles, Bobby Crew and Pete Bougades. Any two of these four are slated to start tonight.

On the other hand, New Bern is the only team which has won from Greenville, that loss being avenged last Monday night. The Bear midgets are led by Gene Suttlemire, a forward who has scored 72 points in nine games this season. Buzzy Boyd ran next to Suttlemire in scoring 42 points this year.

Coached by George Fasolo, the New Bern five holds victories over Kinston and Ayden, two of the tournament teams this year, in addition to the Greenville win.

In the second game tonight, Kinston vs. Winterville, the fans will probably see one of the smallest players of any season. He is Kinston's Darwin Williams, a guard, who is 4'10" tall but has had an outstanding record from his ball-hawking position.

Goldsboro meets Ayden in the third game, the latter team coming out in second place in the midget conference this year. Goldsboro has never been in the conference until now and is rated slightly lower than Ayden in tonight's game.

Ayden is coached by an East Carolina student, Raz Autry, who brought the youngsters from the cellar to the runnerup spot this year and are able to give any team a run for the laurels.

Greenville's midgets, leaders in the conference this season, meet the Scotland Neck five in the nightcap and the locals are favored. Led by Smith Worthington, who has averaged 14 points per game this year, Bill Kittrell's cagers are an aggregation to be reckoned with in the final analysis.

Little information is known about the ability of the Scotland Neck squad but if past records prove anything, they should have a strong team on the basis of last year's record.

Wandering Six' Are Unaccepted

Corpus Christi, Tex., March 16.—(AP)—Tulsa University's six football players who switched allegiance to the University of Corpus Christi in the midst of spring training return to Oklahoma today.

UCC authorities said they could not enroll here—much to the sorrow of UCC Coach Will Walls.

Two of the roaming gridmen are starting defensive tackles—James Prewitt, 235, of Smackover, Ark., and Floyd Harrawood, 255, of Harlan, Ky. The others are Eddie Ware, 200-pound end from Carthage, Miss.; George Coldiron, 185-pound halfback from Harlan, Ky.; Tom Hamm, 220-pound guard from Corinth, Miss., and Bob Miles, 220-pound tackle from Missoula, Mont.

"We're all going back and give Tulsa a whirl for the rest of the semester," Coldiron, spokesman for the group, said after UCC authorities told Walls the players could not enroll under any conditions.

The sextet say they left Tulsa because the school "had not fulfilled its promises."

Ware said he had been promised, among other things, some new clothes.

"I didn't get anything but three suits of underwear and they are about worn out," he said.

Errors Plaguing Cleveland Nine

Tucson, Ariz., March 16.—(AP)—Cleveland's Indians, who sparked a defense last season, are having a bad case of fumble-itis in their exhibition contests.

The Tribesmen have made 14 errors in six exhibition games, including two against the Oakland Oaks yesterday—one by Milt Nielsen and one by Mickey Vernon.

Says Future Now Hinges On Soviet

Durham, March 16—(AP)—On the shoulders of the Kremlin may lie the decision as to whether U. S. atomic energy will be channeled for peace or war.

That's the warning of atomic energy commissioner Gordon Dean who spoke here last night. Dean addressed a Phi Beta Kappa initiation at Duke University, where he once served on the law faculty.

"The tragedy of our present predicament is that our power to control the future of the atomic energy program depends upon people hostile to us and far beyond our shores," Dean said.

The AEC's greatest task, Dean declared, is to perform its task with balance in the midst of extremes of pessimism and optimism.

"There are too many people today who are quite happy to assure us that God's in his heaven and all's right with the world," Dean said. "There are those at the opposite pole who are equally positive that an atomic blitz is inevitable and imminent."

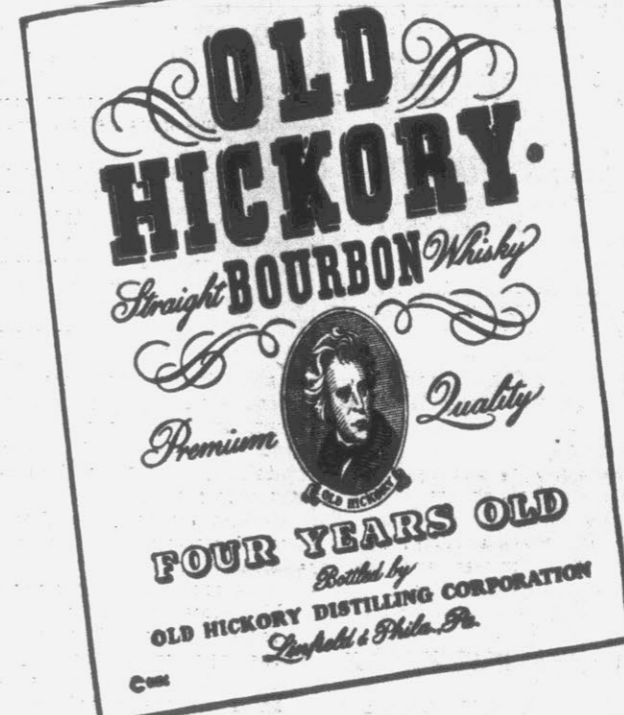

Engineer Throws Cold Water On Idea Of N. C. Toll Turnpike

Raleigh, March 16.—(AP)—Cold water had been drenched on the idea of a toll turnpike reaching from South Carolina to the Virginia border.

James E. Burch, state highway commission engineer, suggested yesterday that Tar Heel traffic might not be heavy enough to make the road pay.

Burch spoke before a special committee named by Governor Scott to study the turnpike idea. The committee heard Charles P. Jones, president of the First Securities Corporation of Durham, declare his firm would finance a survey of such a project at no expense to the state.

Jones estimated the cost of the survey at upwards of \$30,000. He declared the findings would be made available to both the committee and the State Legislature without obligation.

Burch said that in his knowledge "the only successfully privately financed toll roads have been in areas of great population with large cities at each end, generating great

traffic pressures; accompanied by serious congestion and or terrain delays on existing roads.

"Many free highways in these areas often carry 30,000 to 80,000 vehicles per day. North Carolina figures are in the order of about 10 per cent of such volumes."

The proposed turnpike would run from near Charlotte to above Durham. It would not cost the state anything financially. The cost, estimated at about \$100,000,000, would be raised by a private bond issue and it would be paid off by tolls. When the bonds were paid, said Jones, the road would revert to the state.

The special committee agreed to meet again when Jones is ready to submit additional information and the results of the survey.

NCEA Election Results Still In Doubt; Protests

Raleigh, March 16.—(AP)—The problem of deciding who won the North Carolina Education Association's presidential election is still in doubt.

A special committee of the organization's board of directors heard protests from four of its state units yesterday. But it recessed without taking action and set its next session for Saturday.

Last Sunday night the NCEA's canvassing committee announced that C. M. Abernethy of Lenoir had been elected president by 18 votes over Mrs. Margaret McDermott of Winston-Salem. The ballot count was Abernethy 8,830, Mrs. McDermott 8,812.

However, it was officially revealed that Abernethy was declared winner by the canvassing committee after a recount, and that in the first count Mrs. McDermott led by 14 ballots.

Protests to the special committee centered the fact that ballots with erasures were ruled void by the canvassing committee in the second count.

H. B. Marrow, Johnston county superintendent of schools, declared he had "positive knowledge" that returns from the Johnston NCEA unit in the mail balloting had been incorrectly reported and that no ballots had been defaced or marked in any irregular way.

L. P. Miller of Asheville, chairman of the canvassing group, asked Marrow if he were "implying" that the canvassing committee had tampered with the votes.

"I'm implying that someone did," Marrow replied.

Miss Sara Olive Smith of Winston-Salem, Mrs. McDermott's campaign manager and a member of the canvassing committee, said that as far as she knew, there was no tampering with ballots by the committee.

"I think the crux of the question is—what is a defaced ballot?" she declared.

Units protesting the naming of Abernethy and the method of ballot counting, in addition to Marrow's, were Wake, Pitt, and Winston-Salem.

It appeared likely that whatever decision the special committee might take on Saturday another statewide meeting of the association will be held.

Term Suspended In Road Accident

Beaufort, March 16.—(AP)—Beaufort, a highway patrolman chasing him crashed to his death, a Raleigh youth may not drive for five more years.

The judgment, plus a two-year suspended prison term, was imposed on Charles Henry Stephenson III of Raleigh in Carteret Superior Court yesterday by Judge Walter J. Bone.

Stephenson, 18, is the son of a prominent Raleigh merchant. He pleaded guilty to reckless driving charges in the death of patrolman Richard Warren Jackson of Durham.

Evidence was that the patrolman, who leaves a widow and two chil-

dren, was chasing Stephenson's car late last summer. The patrolman veered around another car while going about 75 miles an hour, side-swiped it, and lost control of his vehicle. He cracked into a tree, was thrown from his car and broke his neck.

Manslaughter and hit-and-run charges were brought against Stephenson. However, the solicitor told the judge there were no grounds to prosecute these charges against Stephenson. The youth's family has agreed to pay \$4,000 to the patrolman's family, the court was told.

Beer Strike Is Very Effective

Perth—(AP)—Residents of Marvel Loch declared a beer strike because the beer was too hot. For nearly a week, they boycotted the local pub and flocked to soft

drink shops. The pub keeper installed a new cold storage room.

Young Wife Breaks Down When Insanity Is Pleaded

Frankfurt, Germany, March 16. (AP)—(AP)—Wildly crying "hang me, hang me," pretty Brooklyn born Mrs. Yvette Madsen today sought to silence a psychiatrist who testified she believed her insane when she shot her husband.

"Hang me if you want. Hang me. I don't care. But make him stop," cried Mrs. Madsen, on trial here on a murder charge in connection with the fatal shooting of her husband, Air Force Lt. Andrew Madsen of Oakland, Calif.

The 22-year-old mother of two children repeatedly disrupted her trial today with emotional outbursts as Dr. Karl Kleist, Frankfurt University professor of psychiatry who examined Mrs. Madsen for two weeks, testified he believed she was suffering from an insane delusion at the time of the shooting after a party last October.

"Oh, don't say any more," she cried once.

"They didn't tell me they were going to do this to me," she cried from her counsel table. "I would never have let them examine me."

"They want my heart, too—he wants to cut my heart out," she burst forth still later.

At another outburst her father, Alfred Noack of Brooklyn, sitting by her side, turned to her and said in a voice audible to the packed court room:

"Shut up."

With 47 members of the council attending, they moved to call off a trip to New Bern and the garden festival in April because it will conflict with the district meeting of the clubs of three counties, held in Snow Hill April 13.

Other proposals made concerned: urging the club members to write newspaper articles about how home demonstrations have helped them individually; entrance of members into a state contest for papers written on "12 reasons why I belong to a Home Demonstration Club."

The council voted to accept an invitation from the Arts Festival June 1 to enter dresses made at home for awarding of prizes.

Mrs. J.H.B. Moore spoke on the history of the art movement in Pitt County, begun in 1935 by the W.P.A., the present gallery is located in the library. Mrs. Moore asked the council members to urge their club members to help in running the gallery to enhance the appreciation of art in the county.

Secretary Acheson said the United States was ready to trade with China on a fair basis. However, America wouldn't sell to the Chinese goods which could be used to harm her.

All these facts are useful for America to know. They will be treble useful if they can have any considerable distribution in China and neighboring countries. So far as China is concerned, the Chinese communist regime, which controls most of the country, does everything possible to block distribution of such information.

intelligently-run democracy. How well these sources of information do their job will vary, of course, from paper to paper and from radio to radio. But—no matter how well the information is pumped out, there'd still be people, and probably plenty of them, who wouldn't read or listen.

Since they can't be forced to be informed they'll remain a gap and drawback in any efforts the rest of the population makes toward shaping the best possible democracy in our time.

"They are not things that go to the depths of the moral conflict. They are not things that promise the kingdom of heaven."

"They have been formulated by us, not as moralists but as servants of government, anxious to get on with the practical problems that lie before us, and to get on with them in a manner consistent with mankind's deep longing for a respite from fear and uncertainty."

(Continued from page one) This is simple common sense and to the selfish interest of everyone since, in the end, a Congress most responsive to the will of the people can produce the kind of laws most near to everyone's desire.

And it is not unselfish in another way: An informed public opinion, acting on Congress, is the best safeguard against a special selfish interest working against the general welfare.

Granted this, then everyone—if for no other reason than his own self-interest—has an obligation to be as well-informed as possible in as wide a field as possible, because Congress cuts across many fields.

How do they get well-informed? By reading newspapers, magazines, books, listening to the radio, watching television, discussing events.

In turn that imposes, say, on newspapers and radios an obligation of doing a good job of informing their readers and listeners. This is so, since it's to their own self-interest, or should be, to help create an

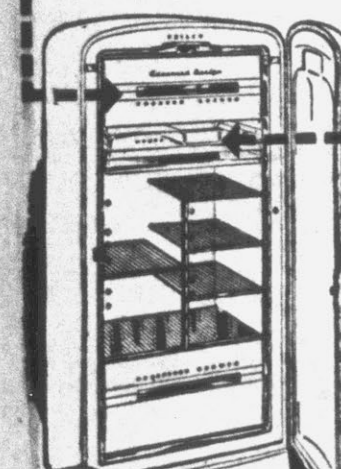
