Ambassador Jessup Plans Strong Reply To McCarthy

Washington, March 18—(AP)—U.S. Ambassador Philip C. Jessup was reported today to be drafting a fighting reply to Senator McCarthy's charge that Communists have infiltrated the State Department.

The Wisconsin Republican yesterday couped that general accusation with a new specific one? He contended the department has issued a mandate for a "complete and thorough whitewash" of Diplomat John S. Service, whom McCarthy has called pro-Communist.

Envoy-at-large Jessup has been accused by McCarthy of having "an unusual affinity for Communist clauses," and of having sponsored a subversive organization.

2-Day District Music Festival Reaches Climax

Concert By Six Bands Is Highlight; Event Will Reach End Late Today

Six massed bands from eastern North Carolina high schools climaxed a parade early this afternoon with a concert on the steps of the Courthouse as one of the highlights of the music contest held here.

The two-day District Music Contest-Festival held on the campus of East Carolina Teachers College March 17 and 18 will end late today with approximately one thousand students having participated according to a statement by Dr. Rudolph R. Willmann, director of the college music department and chairman of the Contest-Festival.

Today's contest was devoted entirely to instrumental music, including bands, instrumental solos, instrumental ensembles and piano solos on the junior and senior high school levels. The parade and performance of massed band music took place at noon and was followed by instrumental solo and instrumental ensemble events in the afternoon.

A feature of this year's contest which has caused much interest musically has been the marked increase in the number of instrumental soloists and instrumental ensembles. Assisting the chairman in conducting instrumental events was Herbert L. Carter, director of the East Carolina Teachers College band.

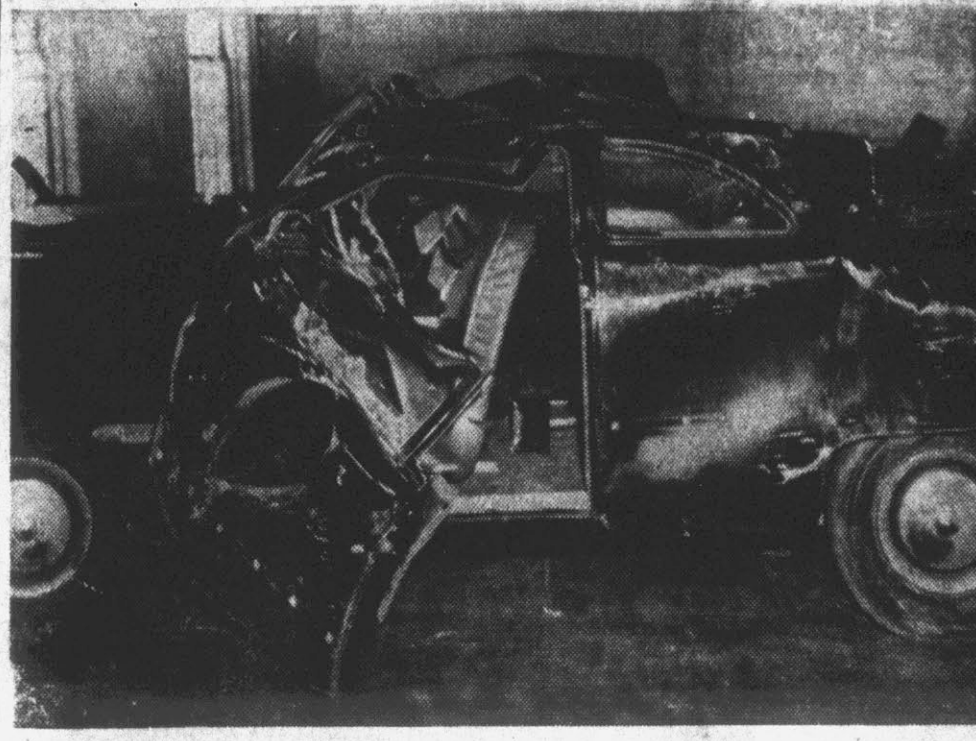

All Crewmen Of Missing Vessel Rescued Friday

Seamen Tell Story Of Fire And Explosion; Fourteen Stayed On Ship

Pearl Harbor, March 18—(AP)—All 40 crewmen of the net tender Elder, blackened by fire and blasted by explosion, were rescued yesterday near the Navy's mid-Pacific atomic testing area.

The destroyer tender Piedmont reached the stricken net tender herself at 11 p.m. (4 a.m. EST Saturday) and reported the other 14 crewmen were aboard and "all in good shape." They had stayed aboard to continue fighting the blaze.

The twin rescue ended in an intensive air and sea search for the Elder—six days overdue at Eniwetok scene of forthcoming atomic experiments.

What had happened to her was a mystery until the 26 men were picked up from the rafts in the central Pacific.

After they climbed aboard the Comstock, the sailors called for water, then told their story. Fire broke out in the engine room of the net tender March 10. A series of explosions followed.

The crew fought the spreading flames and jettisoned the ammunition board. All morning and all afternoon they struggled against the fire.

Then the Elder's commander, Lt. William F. Adams of San Diego, Calif., ordered 26 of the crew to abandon ship. They put out in a life boat and rafts.

The other 14—eleven enlisted men and her three commissioned officers—remained aboard to continue the fire-fighting. They were still tossing ammunition overboard as the 26 pulled away.

"They couldn't go into the engine room," one said. "It was too hot." "There was a lot of three-inch cased ammunition floating around," another said.

Those 14 conquered the fire. They were still manning the flame and explosion scared Elder when aid came a week later.

Six N.C. Congressmen Unopposed In Primary

Filing For State Offices Closed At Noon Today; Bonner Among Those Automatically Certified As Demo Party Nominees

Raleigh, March 18—(AP)—Six of North Carolina's Democratic congressmen were unopposed for the Democratic nomination when filing for state offices closed at noon today.

The six will be certified as Democratic party nominees which is tantamount to reelection.

The last day of filing brought a contest in the Eighth congressional district when W. E. Horner of Sanford filed for the Democratic nomination in opposition to Rep. C. B. Deane of Rockingham.

Congressmen who won the Democratic nomination without opposition were: Reps. Herbert C. Bonner, Washington, N.C. First district; John H. Kerr, Warrenton, Second; Graham A. Barden, New Bern, Third; Harold D. Cooley, Nashville, Fourth; Robert L. Daughton, Laurel Springs, Ninth; and Monroe R. Redden, Hendersonville, 12th.

Horner, who paid his \$125 filing fee personally, was the last candidate to get under the wire before the filing closed. Horner, publisher of the Sanford Herald, lost by 354 votes to Deane in 1946 in one of the state's tightest congressional races that year. He did not run in 1948.

No Immigration Bars For Invid Says Official

Scouts To Help Anti-Rat Drive

Canvass Of Homes To Point Up Sanitation Factors Set

A canvass of Greenville homes to Health Department in its current drive to the breeding of rats will begin, tentatively, April 1, county sanitarian Charles Morgan stated this morning.

The canvass is to be conducted by the Boy Scout troops of Greenville and is under the direction of the Health Department in its current rat control demonstration.

Before the canvass is begun, Morgan will show the participating Scouts a movie on how rats destroy property and breed disease. In order to educate them in the demonstration and how the canvass should be organized.

Morgan said the Scouts will come to every home in town, asking the residents such questions as whether there are proper garbage and rubbish disposal cans, if there is litter in the yards or in the basements, and others pertaining to better information concerning the possibility of controlling the rodents.

As of March 17, Morgan reported the Health Department had inspected 322 residences and mercantile establishments for rats. Among those 322, 249 places were treated with squill, the chemical used in the demonstration to kill the rats, and 20 treatments of cyano "A" dust which is also effective.

The Street Department, which is cooperating with health authorities in the demonstration, has equipped three more establishments in town with adequate rubbish boxes at the merchants' expense, Morgan

Three New Candidates Plan Entry Into Pitt Primary

Politics continued to stir in Pitt County today as three new candidates indicated they will seek nominations in the May primary, and another made official his previous announcement by filing.

Sheriff Ruel W. Tyson today announced he will seek reelection to the post he has held since 1943. J. Vance Perkins, vice chairman of the county board of commissioners, filed for reelection from the first district this morning, and Clerk of the Court D. T. House, who announced his candidacy two weeks ago, filed officially today.

Willie Bell, constable of Belvoir township, filed for reelection yesterday afternoon.

Sheriff Tyson, who announced his candidacy today, will seek election to the office for the second time. He became a deputy sheriff in Pitt County in 1938, and was appointed sheriff of the county on November 1, 1943 to fill the unexpired term of J. Knott Proctor who resigned the position to become Greenville postmaster.

Tyson ran for the office of sheriff in 1946 and was elected for a four year term. He was born in Ayden and has lived in Pitt County all his life. Before moving to Greenville in 1938 he lived near Renston where he was engaged in farming.

J. Vance Perkins, who filed today for reelection to the county board of commissioners, is seeking reelection for his third term in office. Perkins became commissioner from the first district after his election to the office in 1946. He was reelected to the office in 1948.

Perkins is a native of Pitt County and before seeking election to the board of commissioners he worked for a period of time in the county treasurer's office. He was appointed county treasurer by the board of commissioners in 1934, and served in that capacity until 1942.

Soldier Killed As Auto Overturns On Black Jack-Grimesland Highway Early This Morning; One Passenger Seriously Hurt, Minor Injuries For Third

Pitt County suffered its seventh highway fatality of 1950 about 1 o'clock this morning when Cpl. James Alton Rosser, 20, was killed instantly as the automobile he was driving overturned on the Black Jack-Grimesland highway.

Heber Sutton of Shelmerdine, a passenger in the automobile, received scalp and pelvic injuries and is confined to Pitt General Hospital. Sgt. Conley Snowden of Shaw Air Force Base, South Carolina, owner of the automobile, received only minor bruises and abrasions.

Sen. Humphrey Continues Drive End Byrd Group

Washington, March 18—(AP)—A unanimous vote of confidence for Chairman Byrd (D-Va) by the Senate-House committee on reduction in federal expenditures failed to halt a drive by Senator Humphrey (D-Minn) to abolish the group.

Humphrey told a reporter Chairman Hayden (D-Ariz) of the rules committee has agreed to hold hearings on the Humphrey bill. It would wipe out the 14-member economy group which Byrd has headed since it was formed in 1941.

Raleigh, March 18.—Three hurdles are yet to be overcome before the contest for speakership of the next house of representatives can be decided.

First is the deadline for filing candidacy for the legislature, which falls on April 15. Next is the primary on May 27, with possible runoff on June 24. Then there is the general election on November 7.

The November election will not seriously bother prospective candidates for speaker, since they all come from counties where Democratic nomination is equivalent to election. The May and June dates may be other, though chances are slight that either of the present leaders in the speakership race will have serious trouble in the primary.

Fred Royster of Vance, who is presently unopposed for a fourth term in the house, and Frank Taylor of Wayne, also unopposed for a seventh term, are recognized as leading contenders for the presiding officer's place. Arch Allen of Wake,

Some weeks ago there was evidence that Scott and anti-Scott forces would draw the lines of battle for the speakership. There is less probability of such division now and more likelihood the issue will be on basis of individual popularity. At the same time, legislative leaders are not forgetting that the speaker names committee chairmen, including two members of the advisory budget commission, and therefore the office is more important than personal friendships. That is why effort is being made to get the "right kind of folks" to run for the legislature so the "right kind of speaker" can be elected.

'Romeo' Waiting In Vain For His Wives Pay Bail

Cambridge, Mass., Mar. 18.—(AP) A strapping "lonely hearts" Romeo waited in vain today in a dingy jail cell for one of his six—possibly nine—former wives to put up \$20,000.

That was the sum fixed for release of Clarence W. Buchanan, 49, when arraigned yesterday on charges of polygamy and fraudulently obtaining a signature.

Police quoted Buchanan as saying he wasn't quite sure whether he had picked up six or nine wives in his cross-country mail campaign in the past 26 years.

The 206 pound, six-foot Casanova described himself as a St. Louis rooming house operator. He could recall marrying two women in that city and four elsewhere.

French Carrier Leaves Norfolk With Warplanes

Norfolk, Va., March 18.—(AP)—The French aircraft carrier Dixmude sailed today with the first units of a billion dollar program of military aid for western Europe.

At 7:55 a. m. the little escort carrier, her flight deck covered with 48 planes—former U. S. navy fighters and bombers—departed her pier at the Norfolk naval base.

Capt. Louis Felix Mornu, skipper of the Dixmude, said the carrier will unload her cargo of war planes at Bizerte, North Africa. She then will proceed to Toulon, France, "for a short stay," Mornu said, before returning to Norfolk for another load of aircraft.

The Dixmude arrived here March 7 and began loading planes and spare parts the next day.

To Talk Changes In Sanity Code

Chicago, March 18.—(AP)—Representatives of 28 conferences have been invited to Chicago next month to begin spadework in revising the NCAA's controversial sanity code.

In a three-day session starting April 4, athletic chiefs will be asked to outline conditions in their areas regarding scholarships, jobs, recruiting and other items in the conduct of intercollegiate sports.

Recommendations for making the sanity code more pliable and thus agreeable to all members will be made by the chiefs working jointly with the NCAA executive committee. Their views will be funneled to the three-man study group for screening and presentation to the policy-making council which is scheduled for a Chicago meeting in August.

Final action on possible changes will come at the 1951 annual NCAA convention in Dallas, Tex., next January.

Summoning of athletic chiefs is a development of the amendment presented by H. C. Byrd, University of Maryland president, and adopted in New York last January. It proposed a complete survey of athletic policies throughout the nation.

Dramatic Productions Play Important Role In High Schools

G.H.S. Dramateers Have Garnered Many Honors; Bid For New Success

Across the high school stages throughout these United States for years on end have tripped the future Hamlets, Barrymores, Ziegfelds and Berlins as they have begun with youthful merriment the path which one day would lead them to the Great Way Way. And along with these are the everyday school boys and girls who are seeking diversion and self-expression in a single activity by becoming a member of a dramatic group. Greenville high school has been no exception to the trend, for dramatics here has always ranked high among the curricula and extra curricula choices of the students.

Next week the high school Dramateers are joining in the celebration of International Theatre Month which for the first time this year is being observed in nations on both sides of the Atlantic and the broad Pacific. The part the Greenville high school students will play in the world-wide celebration will be a small one it's true, but theirs will be a vital part as they carry out the theme "The Theatre Serves International Understanding."

"More Perfect Union" The highlight of the week's celebration will be the presentation of the play "More Perfect Union" by Harold Weiss which will be given in the high school auditorium Tuesday evening at 8 o'clock with no admission being charged. The plot of Weiss' creation is built around a high school girl who received the cold shoulder from her classmates because she is a foreigner and cannot afford the luxury of an evening dress to wear in a school concert.

The More Perfect Union comes with the better understanding of the American school lasses and their schoolmates from across the sea.

Peggy Bland will portray the role of the foreign girl with the supporting roles being played by Betty Sue Harris, Carolyn Clapp, Janet Waters, Barbara Tilley, Sue Lassiter, Jackie Sears, Joyce Stokes and Betty Jean Allen. The production is being rehearsed under the watchful eyes of Student Director, Virginius Haymes, Miss Kathryn Van Nortwick, student teacher from East Carolina Teachers College, and Mrs. Howard W. Mims, director of dramatics at Greenville high school.

What Goes Into The Play As for the play itself, there first of all must be a reason for giving it. A suitable play must be found for the reason, and when this is done begins the tedious process of rehearsals and rehearsals until the final performance.

The play selected is reviewed by the class and then try-outs for the roles are held. Each member of the Dramateers is allowed to try for any part in the play. The most coveted of all jobs in any production, however, is the position of student director.

The rehearsals begin with readings of the play and getting the feel of the play and the interpretation which the author meant for the production. By the end of the second week the members of the cast are expected to know their lines, and a failure in this phase of acting is considered unexcusable by the Dramateers. The third week of rehearsals begins the polishing of the play to give it the detailed touch which usually means the difference between a success and a flop. Dress rehearsals come two nights before the public performance, and keen critics watch for flaws which may be corrected before official curtain time.

when it can be viewed from the distance of a few days, the Dramateers set about the task of evaluating each phase of the effort in classroom discussions.

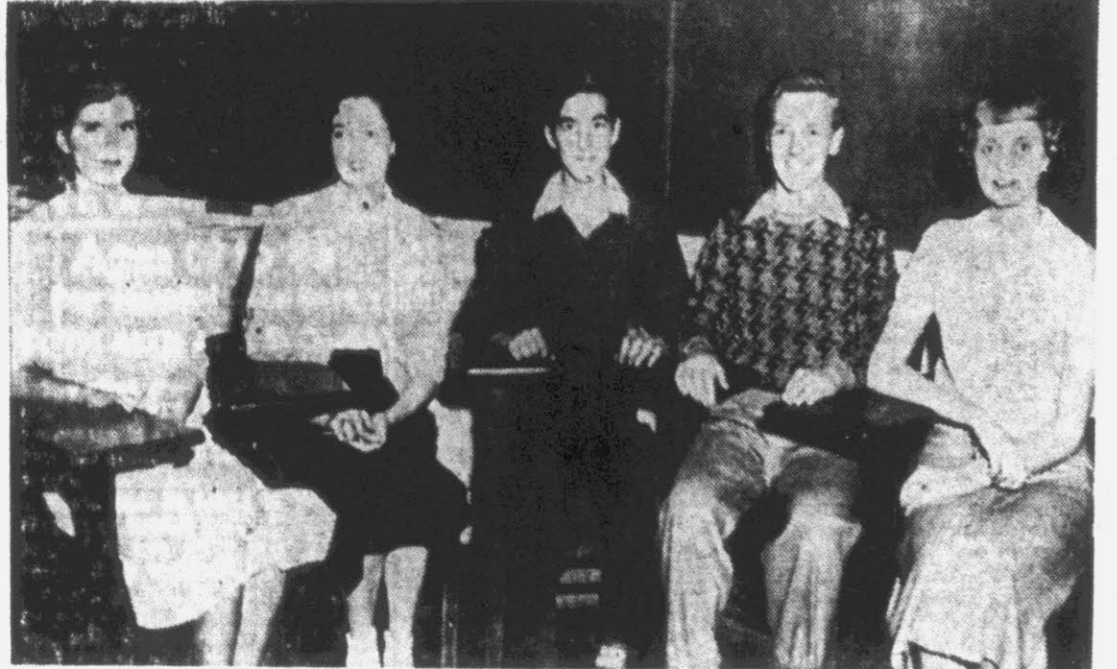

"The Dramateers" The Dramateers, as the dramatics class has suavely named itself, adheres to a peculiar combination of curricula and extra curricula activities which is termed by Mrs. Mims as more of a club than a class in the strict sense of the word; but the students avow, membership in the group comprises much more work than it does play. The activities of the group are under the direction of Mrs. Mims who majored in French and Spanish during her college days, and became enthused about dramatics as a hobby. "And now a hobby has become work," she quips, but readily admits her genuine interest in the work of the Dramateers.

The enthusiasm which is shown by the director is reflected in the constant clamor of high school students to have dramatics class as a part of their individual curriculum. This year for example more than 50 students requested assignment to the class as a part of daily high school work, but limited facilities at the high school restricted the number in the class to 27.

Since becoming part of regular high school work under the leadership of Richard Waiser 12 years ago, the dramatics class has succeeded with commendable success except for one year when the war and the teachers forced the director's time from dramatics to the more basic subjects of a formal education.

During the current school year the Dramateers have presented three full length productions, are working on "More Perfect Union" at the present time, and expect to present two more plays plus a group of workshop productions before the end of the school year.

This Year's Productions The first production last fall was the presentation of Donald Payton's "Say Uncle," and presented Billy Woolfolk in the leading role, which oddly enough was the first speaking part he ever had in a high school production. The play was given to a packed house of high school students, but was not given as a public performance.

The high school glee club and the Dramateers combined their talents during the Christmas season to present the Yuletide program "Spreading the Light" which attracted a full house at the high school auditorium plus hundreds of other people who were turned away because of lack of seats and standing room.

Early in January the Dramateers presented the family comedy "Wilbur Faces Facts" in conjunction with the drama conference which was held under the auspices of the Teachers Playhouse and the English department of East Carolina Teachers College. Joel Bunch took the lead in the production which is one of the many examples of the cooperation between the drama group at the high school and the drama group at East Carolina under the direction of Dr. Lucile Charles.

During the winter quarter, the Dramateers turned their attention to writing their own plays as well as producing plays which had been written by "outside" authors, and each member of the group wrote an original piece. Four of the writings by Sue Lassiter, Janet Waters, Betty Sue Harris and Anne Sutton have been chosen for radio production in the near future. Three more written by Leonard Ippock, Sue Barrow and Charlie Anne Sutton have been selected for workshop productions which are to be presented to an invited audience within the next two weeks.

Workshop Productions This Spring After the staging of "More Perfect Union" Tuesday night, and the workshop productions, the Dramateers will turn their attention to the preparation of two one-act plays which will be presented as an evening's performance later in the spring.

Next month for the first time in three years, the Greenville high dramatics group will not compete for honors with other high schools of the state in the annual Drama Festival held in Chapel Hill. The high school will be represented by a group which will attend the festival, but no production has been prepared for this year's competition. The lack of an entry from Greenville high, however, is no reflection on the local group; but indeed a relief to other high school groups of the state who have watched the Greenville Dramateers walk off with festival distinctions each year since re-entering competition in 1947.

Three Years Of State Honors In 1947 when the Dramateers re-entered the festival competition after the war-time lull, the group won highest rating honors among the high schools of the state with the presentation of "Happy Journey" which had Billy Sutton and the former Betty Jo Wilson cast in the leading roles. Supporting roles in the production were played by Janice Owens, Dan Reid and Willie J. Lewis, Jr.

"High rating" is the grade bestowed on the two or three plays at the festival which the judges feel is done in the most creditable manner.

Returning to the festival again in the spring of 1948, the Dramateers presented "Manikin and Minikin" by Kreyborg, which also won highest rating honors and kept for the Greenville drama group its high rank among the high schools of North Carolina. Janice Owens and Ken Owens were the principals in the production.

In 1949 competition, although the Dramateers did not bring home a highest rating award for the production of "Gray Bread," Joanna Bunch who played the lead in the production was chosen the best senior girl actress at the festival. She was awarded a summer scholarship to Burnsville School of Fine Arts which is an extension of the University of North Carolina. While at the school Joanna took her dramatics seriously and also her instructors, and last September became the bride of Claude H. Rayburn, business manager of the school and director of the Charleston Little Theatre.

To delve deeper into the history of dramatics at Greenville high, information reveals that prior to 1938 such activities were confined principally to the presentation of a Senior play and a school play which were produced under the direction of Miss Ona Shindler and Mrs. P. W. Picklesimer.

Dramatics Organized In 1938 With the organization of the dramatics class in the high school in 1938 under the direction of Richard Waiser the school began its bid for state recognition in dramatic circles.

During the first year the members of the class wrote and made a movie entitled "How to Scramble," and a play by the same name was presented by the class in numerous eastern North Carolina towns and at the Chapel Hill festival. During the same year the members of the class wrote and produced several other original plays, and a play written by Herbert White Lee, a member of the class, was recognized at the state festival as one of the best original plays entered in the festival competition.

In 1940 the group's production was chosen as the second best in the state at the annual festival; and in 1941 the Greenville high dramatics were declared the best high school dramatics group in North Carolina with their presentation of "Waiting for Lefty."

After 1941 the manner of rating plays in state competition was changed, and at the festival the following year, the local group received highest rating honors for "The Devil Was a Good Man."

After the close of the school year in 1942, Director Waiser entered military service, and in the fall of 1942 Mrs. Mims began her duties as head of the dramatics work in the high school.

During the war years the annual festival at Chapel Hill was discontinued, and most of the local high school productions were presented to stimulate the sale of war bonds. It was not until 1947 that the Dramateers returned to state competition.

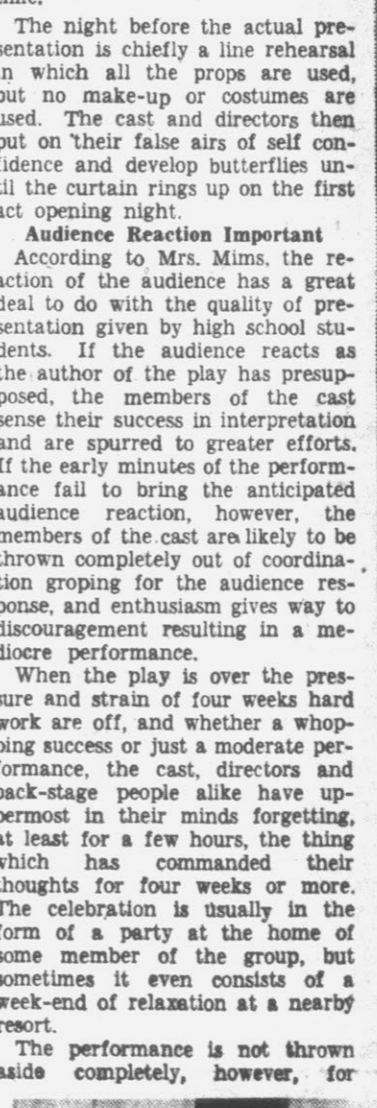
Four Weeks Of Rehearsals Although a high school presentation of a play may seem to a casual spectator a relatively simple undertaking, few one-act plays ever reach the curtain call without at least four weeks of daily rehearsals and an unnumbered quantity of man-hours of effort by students and directors. The staging of a play even on the high school level has many ramifications which individually are vital to the success of the production.

In addition to the actual drill by the members of the cast, there is a vast amount of detail work which must be carried out beforehand by the costume committee, the scenery committee, the house committee, the props committee, the publicity committee, the make-up committee and the lighting committee. Each group plays an intricate part in the success of each production, and the failure of any one of the groups may reflect in the presentation of the play itself.

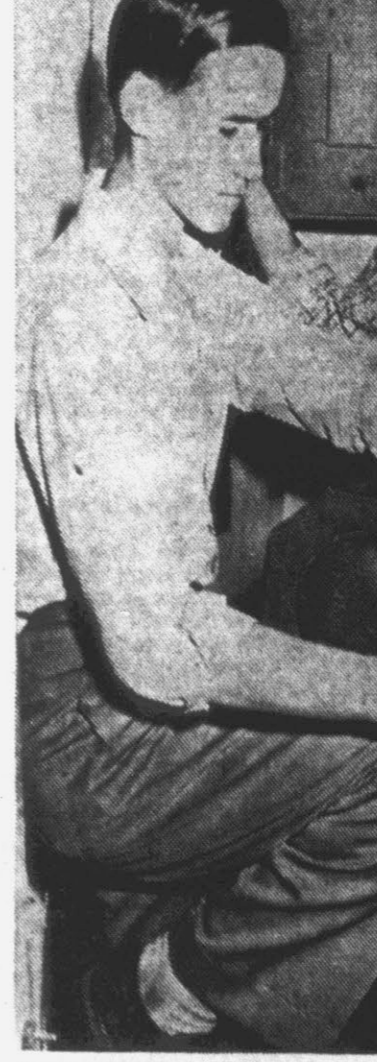
The whole complicated process of producing a play is done by the students with the adult directors acting only in advisory capacity. The students do their own hammering and sawing, nailing and painting for the scenery, and carry out the details from start to finish by their ingenuity and the sweat of their brows.

If you are complaining about the spiritual diet you get every Sunday, switch to a little exercise for a change and see if you don't feel better.

INFORMED CITIZEN A GOOD CITIZEN

Associated Press national affairs analyst James Marlow has been recently writing some enlightening columns with reference to the need for a better understanding of current affairs by the public at large.

On Thursday of this week he pointed to recurring evidence that a lot of Americans don't keep themselves informed; and because of this, democratic processes are set back.

In that column he mentioned a survey by expert public pulse-takers who found 26 percent of the persons polled did not know Russia had exploded an atomic bomb three months after the President had announced the fact. This, on a news item which was "streamered" on the front pages of every daily newspaper in the United States... echoed, analyzed and discussed for days over the radio; and which provided material for "follow-up" news-writers for weeks.

The inference as to the lack of public knowledge on less spectacular happenings is something to marvel at. How can individuals insulate themselves against events which so vitally affect domestic and international affairs? How can such persons conceive themselves qualified to intelligently participate in a democratic society... to vote, speak for, and advocate legislation or political candidates?

Their passive ignorance not only affects others, but themselves.

In Marlow's Friday column, he discussed and described Secretary of State Dean Acheson's review on current Russian relations and the requirements for peace. Acheson's momentous speech was to the American

public. An explanation of the problems confronting us and our position in the cold war. He clarified the issues for the benefit of the people whom he was serving so they would understand what they were up against.

How many now have a clear concept of the difficulties and the stakes... seventy-four percent? Seventy percent? Sixty percent?

The basic course of our government lies with the people. Only an informed citizen can fulfill the responsibilities of a good citizen, whether in town, a city, a county, a state, or in the complicated affairs of national government. It is not only patriotism, but self-interest which should prompt close attention to the chapters of history we are now writing.

SUPPORTERS—Both camps are announcing names of party leaders who have pledged support. Some surprise has been voiced because several big industrialists have declared their support for Graham, while many leading farmers have come out strongly for Smith. Also there has been surprise that organized labor has not been more openly active for Graham. Most observers are not disturbed about these conditions. They insist that North Carolinians always have and for a long time will cast their votes as individuals, not as members of a class group. That calls to mind predictions that Charles M. Johnson, former state treasurer and runner up for governor last time, will take public stand in favor of one or another of the senatorial candidates. Latest information is Johnson will say he expects to vote for his personal choice and support the nominee in November—and hopes everybody else will take the same course.

Boyle's Column

New York—(AP)—There is a great and growing religious revival in America.

Significantly, it is spreading widely among the youth of our post-war generation, the generation that is usually a prey to doubt, disillusion and cynicism.

Recently I received a letter from one of these young people—Miss Josephine Owens of West Helena, Ark.—that told of the happiness her awakened faith had brought her.

Her letter was simply written, artlessly sincere, fervent with a desire to help others. She said I could give her letter a wider audience if I wanted to, "because it is so important that people wake up."

And so I will. Here is one girl's Lenten sermon—an old message from a young and zealous heart: "Oh, if I could get everyone to become a Christian, what a blessing it would be—for them! "I used to worry continually about

money matters, the hydrogen bomb, etc. Now those things aren't important at all. Only God is important in my life. I only want to live so that I can serve Him. He will keep me from harm—and also anyone else who will believe in Him and trust and have faith.

"God has made me a 'fisher of men.' My purpose now is to win others for Him. But people are hard. They don't want to know about God. But once they do, then they see what they have been missing. "God does many things for men which they take for granted. Think of the air, the sun and rain, the clothes we wear, the food we eat—and so many, many other things. God makes all these possible, but people take them for granted. If they don't get them they raise all kinds of Cain about the senators, the President and the governors—when, if it weren't for God's good hand, these things would never even be.

"Think how wonderful He has been to America! We don't have a warring country like Europe and Asia. We have just about every possible comfort and joy, and yet we turn our backs on the Saviour. "You say it is difficult to be a Christian? Well, dear people, once the loving Saviour has truly touched your hearts, you won't want to do wrong. You will only want to do the Lord's will.

"The other day I asked a poor, crippled Negro man who was begging on the street, 'Are you a Christian?' and he replied, 'Yes, for 40 years.' Just think, that poor soul, crippled and having to beg for a living, giving 40 years to Christ!

"Once people know Christ they never want to leave Him. There is so much He can do for you—if you will only let Him. He is more important than anything or anybody. And the sooner people find this out, the better off they will be.

"Oh, dear people, wake up! Know and accept Christ as your Saviour. Give your heart to Him. Serve Him and He will truly bless you. Repent of your sins. Confess your sins, believe in Him, obey His will, and you will receive a greater joy than any you have ever known."

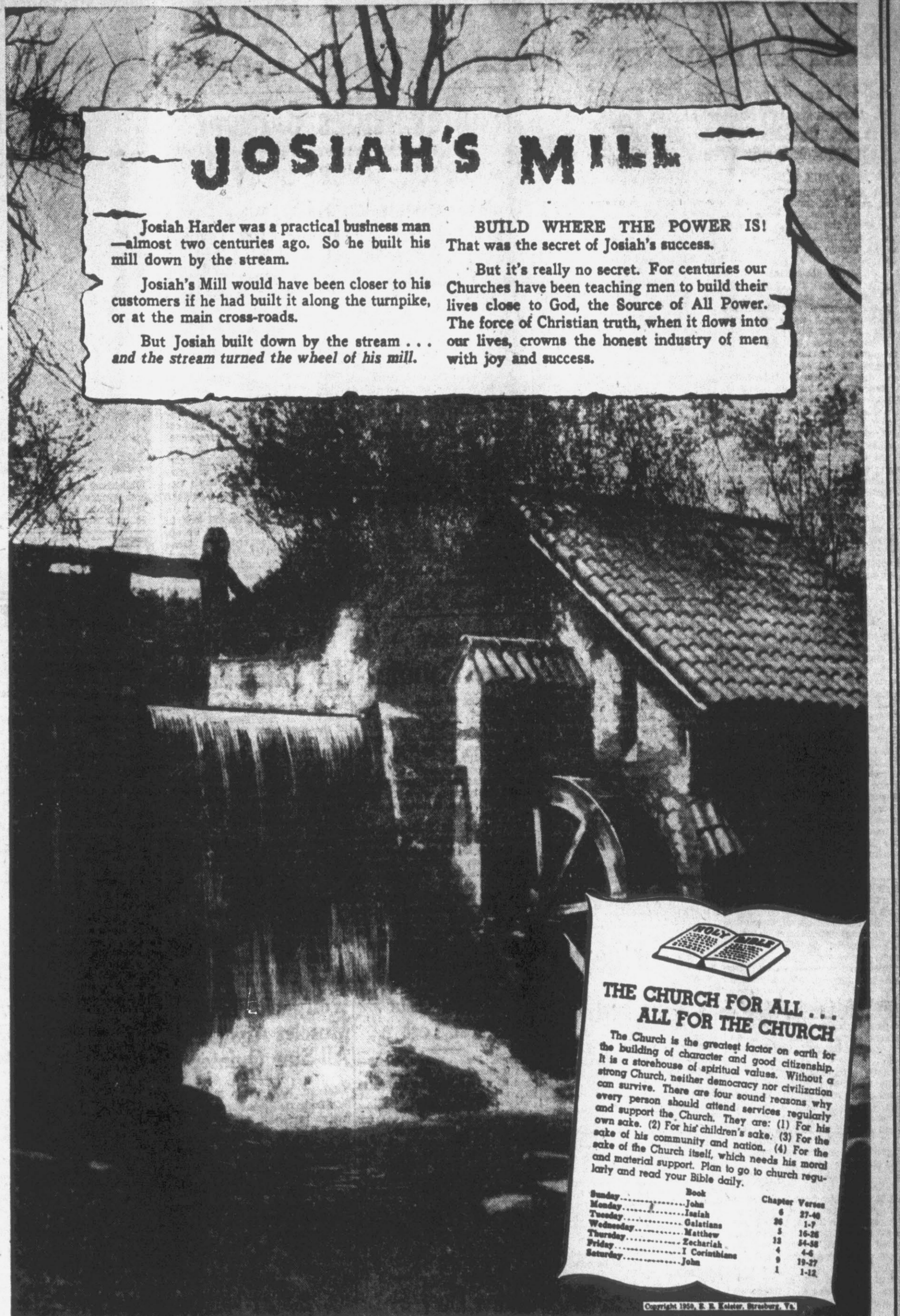

Pirate Squads Show Scoring Punch And Offensive Power In Close Game

Gold Team Edges Purples By 32-31 In Final Quarter Rally; Roger Thrift Again Demonstrates Passing Ability; Intra-Squad Contest Closes Eight Weeks Of Winter Drills

Nearly 1,000 frozen football fans weathered cold winds last night to watch the Gold team come from behind in the final quarter to defeat the Purples, 32 to 31, by virtue of Ed Tanner's second extra-point kick.

Last night's tilt, sponsored by the college Varsity Club, was East Carolina's first annual Purple and Gold intra-squad grid battle, and concluded eight weeks of winter drills for Coach Bill Dole's eleven.

Trailing 31-25 in the waning minutes of the final quarter, the Gold team, led by All-Conference quarterback Roger Thrift, scored their game-winning touchdown as Thrift hit Halfback Bill Darcy in the end zone for the tying score. Ed Tanner made good on the all-important place kick to give the Golds their game-winning point.

The Golds winning score was set-up after Thrift had completed two consecutive passes to Tanner and Darcy which covered a distance of 83 yards.

Getting off to a fast start in the opening quarter, the Purples scored quickly, as Quarterback Sandy Siler passed to Halfback John Daughtry down to the one-foot line, with hard-driving Tom Swain, Purple fullback, going over on the next play. Siler's pass covered a distance of 30 yards, to give the Gold team a 6-0 lead.

In the second stanza, the purple squad continued its rampage over the Gold team, as they scored again in the early moments of the period on another pass from Siler to Daughtry covering 14 yards, with Swain's placement was blocked, and the Purple led, 12-0.

The Purple increased their lead, 18-0, two minutes later, as defensive Halfback Howie Carmichael intercepted Thrift's pass on his own 48, and ran it back to the Gold 33. Daughtry, showing much running power in his new position, carried the ball down to the 21. On the next play Siler hit Ed Dwight Shoe on then-yard stripe, and the elusive Shoe scampered the remaining distance to score his first of two touchdowns, and gave the Purple their 18-0 lead.

At this point in the game, big Frank Maenne, power-driving fullback for the Gold eleven, took over the running duties, and in two plays advanced the ball from his own 37 to the Purple 46.

Thrift then passed to Darcy down to the 28, which was good for a first down. After three passes failed, Thrift faded back on fourth down, then hit Halfback Billy Smith on the four, with the little Portsmouth seatback going over for the Gold's first score, making the margin read, 18-6.

Shortly after the kickoff, defensive guard Barry Bateman intercepted Siler's short pass on the Purple 37 and ran it back to the 25 to set-up the Gold's second tally. On second down, newcomer at end, Ott Alford, made a diving catch of Thrift's pass in the end zone, to bring the score up to 18-12.

With the clock showing time for only two more plays in the first half, Ed Dwight Shoe gathered in another Siler toss on his own 47, and completely out-distanced the Gold team secondary on a play that covered 53 yards, which gave the Purple a lead at halftime, 24-12.

Third quarter of the game went without a score, but in the final stanza, Frank Maenne, increasing his running momentum, combined with Thrift's aerials, to help the Gold team come from behind.

Opening up the final period with plenty of offensive play, that took part of the chill off the on-looking spectators, the Golds scored their third TD of the night, as Maenne power-driven his way down to the one-foot line on three consecutive plays. At this point, the Purple defensive line rose up to the cause.

led by rookie tackles Wally Robinson and Buck Hardee, to hold the Gold team for three straight plays. However, on fourth down, Roger Thrift went across on a quarterback sneak, making the score 24-18. Tanner kicked his first placement for a 24-19 count.

The Gold eleven took a temporary lead when defensive linebacker Bob Ellis intercepted another Siler pass and ran it back to the 40.

Darcy went off guard for six yards, then Thrift tossed to Tanner down to the 19 for a first down. Maenne skirted the end for 17 more yards to place the ball on the 2-yard stripe. On the next play Billy Smith again hit pay dirt to give the Gold team their first lead in the grid battle, 25-24.

Never to be outdone, the Purples came roaring back, as Siler passed to Daughtry on the 23, the up and coming halfback picked up steam to tally the score, 30-25. Buck Hardee came in to kick the extra point, making it 31-25.

However; at this point in the game, the Gold squad rallied back to score their game-winning margin on Tanner's extra point kick.

Statistics revealed the closeness of Coach Dole's intrasquad game as the Gold team gained 149 yards rushing while the Purples picked up 127 yards. In the passing department, Thrift completed 11 out of 21 attempts while Siler made good on 9 out of 22. First downs were in favor of the Gold team, 14 to 10.

Outstanding defensive players during the night's game were Guard Leon Ellis and center Buck Wilson for the Gold, and End Dennis Smith, and newcomers Buck Hardee and Wally Robinson for the Purples. Jesse Aldridge also played a terrific line-backing game for the Purples before going out because of injuries.

Yale has won four of the seven championships awarded so far: relay, backstroke, 220-yard free style, and low-board diving.

Brawner gave Princeton its only title so far. Cadet John Irwin of Hawaii won the 50-yard free style championship for Army in 23.5 seconds. Alvin Malthaner copped the 1500-meter race for Springfield college when the meet opened Thursday.

On tap for tonight are final races in seven more events: 100-yard backstroke, 100-yard breaststroke, 100-yard free style, 440-yard free style, 150-yard individual medley, three-meter high board diving and 300-yard medley relay race.

Belgium Gov't Collapses Over Leopold's Return

Coalition Cabinet Quits After Liberals Refuse Move To Recall King

By ALFRED CHEVAL

Brussels, March 18.—(AP)—Belgium's coalition government collapsed today in a dramatic demonstration of how badly this nation is split over whether exiled King Leopold III should be returned to his throne.

Premier Gaston Eyskens' cabinet—made of eight liberals and nine members of his own social Christian (Catholic) Party—quit after the liberal members refused to support a move to recall the monarch from Switzerland and resigned.

A spokesman for Eyskens, who has been premier since last August, immediately announced that, because of this, the government's resignation would be presented to Prince Charles, the ruling regent.

Charles is a brother of Leopold and the next step in the crisis is up to him. He will have to try to find a new premier to form a cabinet for the purpose of handling the

question of Leopold's future, which can only be settled by parliament.

Parliament's legal responsibility arises out of a law of July, 1945, which says the king can be returned only by a majority vote of that body. The king himself won 57.68 per cent of the vote in an advisory referendum last Sunday and Thursday he said he thought it was up to Parliament to act without further delay.

In Switzerland today there was no immediate comment from the king concerning the cabinet's fall.

The difficulty is that, while the Flemings of Belgium want Leopold back and voted heavily for that solution last Sunday, the French-speaking Walloons gave him only 40.3 per cent of their vote. This, many politicians here declare, is a demonstration that Leopold does not represent the unity of his people, as a king should.

The controversy dates back to King Leopold's surrender to the Germans after only 18 days of fighting in 1940 and to his marriage to a commoner, a Fleming. His first wife, Queen Astrid, died in an automobile accident in 1935.

The Socialists, who were not represented in the Eyskens' cabinet, bitterly oppose the king's return. Strikes of 100,000 workers yesterday were attributed to Socialist inspiration as a means of expressing their opposition to the king.

These workers returned to their jobs today but labor leaders warned that this was only the beginning of widespread demonstrations.

Will Not Require Money For Drive

J. Frank Parker, Jr., chairman of the Red Cross drive in Falkland township, said today people in his township don't need money to make a contribution to the Red Cross.

"Our solicitors will accept chickens, eggs, corn, model T Fords, or what have you that may be converted into cash."

Parker said bad weather this week has slowed down the drive in his township, but the drive will be continued into next week until the quota is reached.

He said Mr. Edith Fleming of Greenville route one has turned in \$33.15 in contributions from her small segment of the township, and is the only solicitor of the township to complete her assignment so far. He added, however, that the other solicitors will complete their work by Wednesday night.

Convict Wife In Husband's Killing

Frankfurt, Germany, March 18.—(AP)—Mrs. Yvette Madsen of Brooklyn was convicted today of murdering her Air Force husband and was sentenced to 15 years imprisonment.

The beautiful, 22-year-old mother of two stood pale but erect as a three-judge American occupation court handed down its verdict, finding her guilty of the deliberate "treacherous" murder of Lt. Andrew E. Madsen of Oakland, Calif., after a gay party last Oct. 20.

The court rejected a defense plea that Mrs. Madsen was temporarily insane at the time.

And once a police agency can arrest and judge a man, no man is safe.

But now comes a bill, passed by House and Senate, to set up a government agency—to be called the National Science Foundation—which will give scholarships, paid for by the government, to scientists.

The House—but not the Senate—put a tail on the bill, an amendment, before passing it. This is what it would do:

It would require the FBI to check on everyone getting such a scholarship and make a definite finding on his loyalty or disloyalty.

In other words, this would give the FBI the right to investigate and pass judgment. The investigated person wouldn't have a chance to clear himself or demand proof that he could try to refute.

J. Edgar Hoover, head of the FBI, wants no part of that. Neither does the Justice Department. The department's views were expressed in a letter to House members by Peyton Ford, assistant attorney general.

He said that if the bill became law with that provision in it, it would: "Effect an extremely radical and undesirable change in the basic re-

ed whole fish to run through a chocolate-sealing machine—including the cooler. The result to my taste was very good—no odor and no bitterness. But according to the newspapers not even the cats of Lakeland would come near the factory for days!

Chocolate A Preservative

But the above is not the whole story. In addition to killing the odor and bitterness, of the whole fish, the chocolate also sealed this cooked ground whole fish. The chocolate sealing acts as a preservative for the fish as it does for the cream in chocolate covered candy. The fish so sealed and unfrozen kept fresh for some weeks in our refrigerator.

Well, the above is my story. Surely my chocolate-sealed fish has no friends at present; but I close the sad story with this forecast—Some day every family for health's sake will be eating ground whole fish chocolate sealed. Whether it will be eaten as a main dish or as a dessert, I leave to the imagination of my patient readers.
