Lucas Seeks More Bi-Partisan Work

Proposes President And Congress Work Together On Foreign Policy Decisions To Reduce Friction And Misunderstanding In Field

Washington, April 15 (AP)—Senate Democratic Leader Lucas of Illinois proposed today that the President and Congress establish a "working agreement" to keep lawmakers abreast of foreign policy decisions.

Lucas told a reporter he will back any constructive move to revive two-party cooperation on international questions and to reduce the "friction and misunderstanding" which he said seems to have grown up between Republicans and Democrats in this field.

"I think it is vital that the executive and the legislative branches of the government establish a close working agreement so that no Democrat or Republican can say that he is in the dark on basic foreign policy," the Illinois senator said.

"I am not suggesting that the power given the President by the constitution in the foreign field be taken away from him, but Congress must implement these policies and it seems to me good business to remove every possible cause for misunderstanding between the legislative and the executive."

Lucas said, in this connection, that if Senate Republicans want to name one or more of their members as official representatives to sit in on the formation of foreign policy decisions, he believes some arrangement of the kind could be made.

Senator Ives (R-NY) has suggested this action. But Senator Wherry of Nebraska, the GOP floor leader, said he doesn't think the plan would work unless several Republicans were named, representing a cross-section of GOP thinking.

Wherry said it's his idea that a non-partisan foreign policy can be developed by debating the issues in Congress before final decisions are made.

"We don't know what's going on until the Administration brings its decision to Congress and asks for bipartisan support of them," Wherry said.

"Look at Western Germany right now," he continued. "Things are going on in Western Germany that Congress doesn't know anything about. We Republicans have tried to get the Administration to stop the plant-dismantling program until Congress can survey it for itself, but our proposals have been pigeon-holed."

Four Narrowly Escape Injury In Car Collision

Farmville, April 15.—Four people narrowly escaped injury on highway 43 about 300 yards north of the intersection at Bruce last night when two automobiles collided and one of the cars overturned.

Patrolman R. C. Holt reported today a 1940 Plymouth driven by Alton Ray Heath, 18, of Greenville Rte. 3, and a 1946 Buick driven by James Byron Brow, a 19-year-old marine of Cherry Point, were involved in the accident about 11 o'clock last night.

Holt said both automobiles were going south on highway 43, and as Brow attempted to pass Heath, he (Heath) made a left turn in front of Brow's car without giving a hand signal.

The patrolman said Brow's car struck the left rear fender of Heath's car, turning Heath's car over on the shoulder.

The two occupants in each of the cars escaped without injury, Holt said.

He reported Heath was indicted for failing to give a proper turn signal.

Ferguson Wants Budenz' List Of 400 Communists

Says Witness Should Turn Over Names At Closed Meeting Of Probers

Washington, April 15.—(AP)—Senator Ferguson (R-Mich) said today former Communist Louis Budenz ought to hand Senate investigators the names of the 400 Communists he says are concealed in this country.

Ferguson suggested that Budenz turn over the names at a closed meeting of the Senate Foreign Relations sub-committee which is investigating charges by Senator McCarthy (R-Wis) that the state department has hired Communists and fellow travelers.

Budenz, one-time managing editor of the Daily Worker, renounced Communism in 1945 and rejoined the Catholic church. He now is on the faculty at Fordham University in New York.

He is scheduled to testify next Thursday at a public hearing arranged by the inquiry committee. McCarthy has said Budenz will swear that he knew Owen Lattimore, far eastern affairs expert to be a member of the Communist party.

Lattimore already has testified under oath that he never has been a Communist and that he never knowingly promoted the principles of Communism.

Budenz told a Michigan audience last Tuesday that he could name 400 concealed Communists in the United States, but would not do it because "I can't afford libel suits."

Ferguson noted that Budenz is coming before the senate committee under subpoena and will have immunity from any libel action. He added that Budenz therefore ought to feel free to name the "concealed" Communists at a behind closed doors meeting after the public hearing.

The Michigan Senator told reporters Budenz should do that because his information may "greatly affect our foreign policy" and the nation's security. Ferguson added that he is against having Budenz name names in public because he wants to make sure no innocent person is smeared.

Filing Deadline Is Tonight For New Candidates

Raleigh, N. C., April 15.—(AP)—The deadline for filing for local offices comes at 6 p. m. today. The deadline may provide the answers to a lot of questions for a lot of people.

At that time, many candidates for the state legislature and local posts such as sheriff, coroner and county commissioner will be able to find a sign of relief as they find themselves without opposition in the May 27 primary.

Others, at least, will know the worst, because all the candidates will be out in the open. Mr. Candidate can quit asking himself "will John Jones run against me?" After the deadline, he'll know the answer.

Tragedy Fails To Stop Production

Actor Fonda Plays Role Scant Hours After Wife's Suicide

Beacon, N. Y., April 15.—(AP)—Henry Fonda went back to Broadway last night after his wife's hastily-arranged funeral and played "Mr. Roberts" to an audience that whispered the first news of her suicide from seat to seat.

Thirteen hours before—shortly after dawn yesterday—the actor's beautiful society wife had cut her throat from ear to ear with a razor blade.

She was in a private sanitarium here, 40 miles north of New York city, and was believed to be recovering from a nervous breakdown that followed her consent to a divorce. She was 42.

Her death note ended: "I am sorry, but this is the best way out."

A doctor and nurse found her dying on the floor of the bathroom in her suite at 6:50 a. m.

Her death came just as Broadway heard rumors that romance had cooled between the 44-year-old Fonda and Susan Blanchard, 22-year-old stepdaughter of Oscar Hammerstein II, the librettist and producer.

Fonda disclosed plans for a divorce last December, amid reports of a romance with Miss Blanchard.

Federation Plan Said Impossible At Present Time

Biloxi, Miss., April 15.—(AP)—A North Carolina researcher said here today that under present conditions a world federation is impossible, but that regionalism is "a dynamic functioning reality."

In a paper prepared for the Southern Sociological Association, in session here, Sydney Lester, senior research analyst at the University of North Carolina, said that the one world theorists and the world federalists are aware that the practical implementation of their plans is veritably impossible.

Lester said the Arab League, the South Pacific commission and the Caribbean commission—all made up of groups of members of the United Nations—were carrying out important functions in international cooperation.

City Rat Control Demonstration Is Said Successful

All Inspected Buildings Found Infested, Treated; Poison Is Effective

The current rat demonstration in Greenville has been termed by sanitarians of the health department "highly successful" during the two months it has been underway.

At the end of the two-week period, April 3-14, at which time the sanitarians make a report on extermination operations during the period, 227 mercantile establishments and residences were inspected and 227 were reported with infestation.

All were treated with red squill and cyanide dust to exterminate the rodents and the treatments were termed effective by the sanitarians.

They reported eating places and other food handling establishments are cooperating with them in an effort to rid their places of the typhus-bearing rodents. The department is getting results from the proprietors in that their inspection scores are becoming higher.

Local authorities have said that only 25 percent of the dead rats are actually seen, once the poison is set out. But for every one dead rat, there are four or five more dead ones inside the burrows where the dust and squill have penetrated.

There is a concrete indication the poisons are taking effect on the rat population hereabouts by the appearance of the burrows. Sanitarians said the "slides," which the rats use to get down into their burrows, are becoming dull looking, indicating the rats are not coming out again.

In one area of Greenville, where there are three stores, one restaurant and three food-handling places, the sanitarians spent three days exterminating the rodents. In one place, they reported rats had gnawed through one-and-a-half inches of concrete and got inside the store.

Extra efforts have been put on the jobs in food handling places. The street department has been building rubbish and garbage disposal boxes for the proprietors at their own expense. There has been a drop in requests for such service during the past two weeks, but the street department is still undertaking the work.

China Air Force Announces New Shipping Raids

Taipei, Formosa, April 15.—(AP)—Nationalist China's air force today announced new raids on the Communists' South China invasion springboard—the Luichow peninsula.

The air headquarters report was issued as the top Nationalist military chiefs conferred here, presumably on how to checkmate expected Red attempts to make large-scale amphibious landings on Hainan and Chusan Islands.

Nationalist planes carried out day-long attacks yesterday on Red shipping along the southern coast of Luichow opposite Hainan, air headquarters said. Military installations ashore were heavily damaged and several anti-aircraft positions destroyed, it claimed.

Tolar Is Out

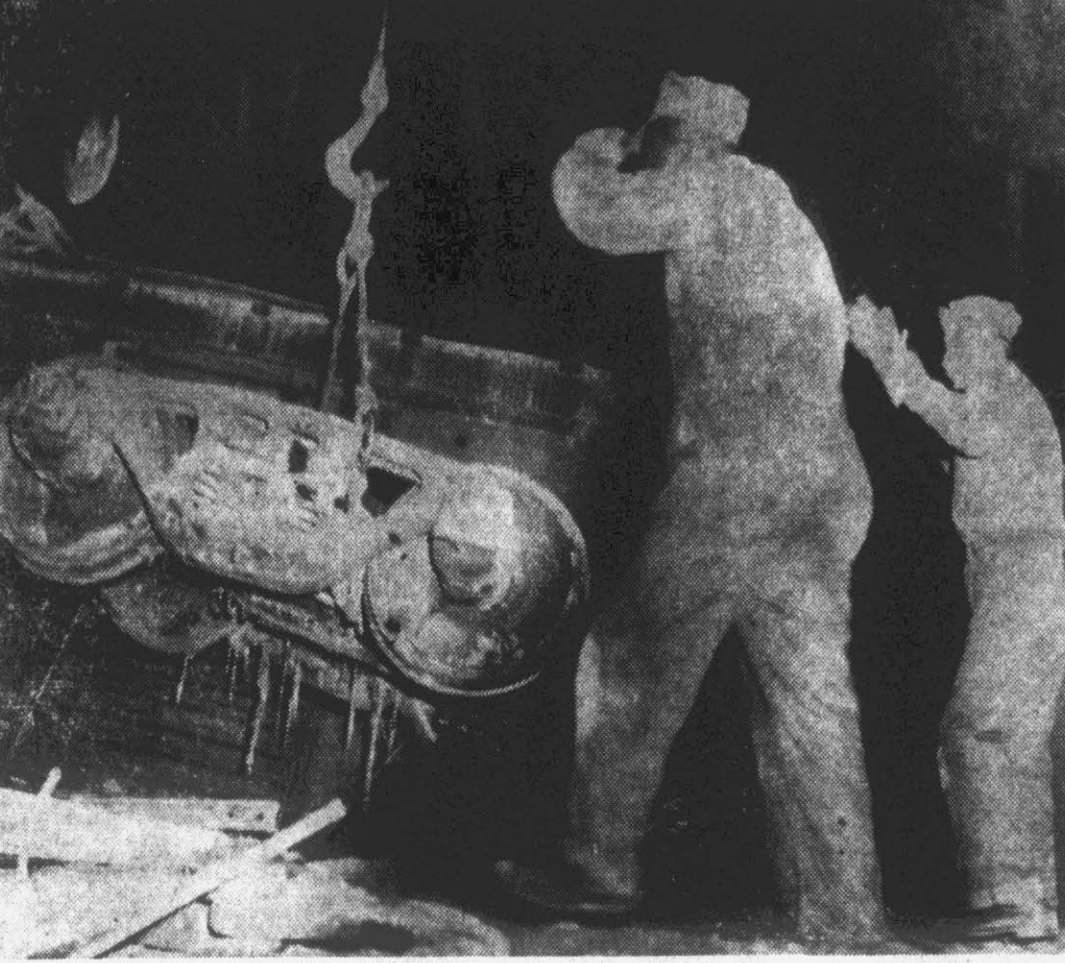
Raleigh, April 15.—(AP)—Governor Scott today accepted the resignation of Highway Patrol Commander C. R. Tolar effective immediately.

At a specially called meeting the governor announced that he was accepting Tolar's resignation "for the best interest of the state."

Motor Vehicles Commissioner Landon C. Rosser said after the governor's announcement that Maj. J. R. Smith, patrol executive officer, has been named to succeed Tolar effective May 1. Smith's appointment is permanent.

Capt. D. T. Lambert, commander of Patrol Troop A, at Greenville, will be elevated to the executive officer post effective May 1, Rosser said.

Hoist Removes Set Of Wheels From Train Wreckage

Crews Working Steadily At Removal Of Train Wreckage

Work Through Night At Site Of Norfolk Southern Freight Accident; Track Cleared Of Wreckage; Broken Flange Said Cause

Farmville, April 15.—(AP)—Double wrecking crews worked steadily through last night and were still at work today at the site of a Norfolk and Southern freight train about four miles from here.

O. G. Spell, Farmville agent for the railroad, said the track was cleared of wreckage and opened for traffic about three o'clock this morning, but crews still are working at the scene of the wreck to clear the wreckage and salvage all the cargo and equipment possible from the wreck.

J. C. Poe, assistant general superintendent for the Norfolk and Southern, said last night a broken flange on a wheel of one of the cars was the cause of the accident which piled up the twenty cars on the straight stretch of track between Farmville and Bell Arthur about 3:25 yesterday morning.

A flange is the raised or projecting rim on a wheel which is designed to prevent it from leaving the track.

Poe said the broken flange which caused one of the worst wrecks in the railroad's history was on a wheel on the first car in the north end of the wreck. The car, he said, was the second freight car behind the diesel engine in the 49-car train.

Parts of the broken flange, Poe said, were found for "eight or 10 miles" up the track where it had broken off progressively while the train was in operation.

Double wrecking crews were called to the scene of the accident yesterday morning and track laying continued until about three o'clock this morning when the track was again opened to traffic. The smashed cars and other debris of the wreck still flank the railroad right-of-way, and officials said it will probably be "two or three days" until all the wreckage is removed from the scene.

Spell said the crews had to rebuild approximately 150 yards of the track which was ripped up in the wreck.

Although no estimate of the damage has yet been given by the railroad, Spell said the damage to the cargo alone will "run well over \$100,000," and in addition to the cargo, he said, "18 cars were almost a total loss."

The Farmville agent said he understood from the other officials that there was no insurance on the equipment which was involved in the accident, and that a blanket policy on the cargo will cover all the losses over \$5,000. The railroad, he said, will have to absorb all the cargo damage up to \$5,000.

Two of the freight cars involved in the wreck were pulled back onto the tracks yesterday morning and taken to Farmville, but the other 18 cars which were entangled in the wreckage were dragged off the right-of-way by the wrecking crews to enable them to open the track to passage.

Candidate Voices Racial Platform

Handful Hear Olla Ray Boyd Talk For 'White Supremacy'

A handful of Greenville citizens got their first look at a senatorial candidate last night as Olla Ray Boyd, Pinetown native, outlined his white supremacy platform to them in the courthouse.

Running in opposition to Senator Frank Graham and Willis Smith for senatorial representative for the east, Boyd described North Carolina as "the battleground between the North and the South. And we all know it," he said.

He discounted the ability of Willis Smith, the Raleigh attorney, to make a race of the coming campaign, but hopped upon Graham as the go-between of whites and colored. He said:

"If Frank Graham goes back to the Senate, the Negroes and whites will be sitting beside each other in our public schools."

And he scored Governor Kerr Scott for appointing Dr. H. L. Trigg, president of St. Augustine's College in Raleigh, to the State Board of Education.

Trigg, a Negro, was one of the first appointive offices to be filled by Scott when he came into office last year. Boyd said, "I wonder how many of our 100 county school superintendents are insulted that Scott put a Negro over them in their school work."

Besides carrying the banners of white supremacy, Boyd stated he would favor federal housing and further aids to agriculture if elected to the Senate. He stated the houses now being built in towns and cities under the Federal Housing Administration are inadequate for the needs of the people. He favored the construction of enough homes so middle and lower income bracket persons may buy.

He said he will push any congressional bills which will allow North Carolina farmers to grow more tobacco. He stated Pitt County had as well-balanced an income as any average agricultural county and

While in Greenville Thursday night on a speaking engagement, the Young Democrats' chief executive described the proposed meeting as the "first annual North Carolina Young Democrats' Roosevelt Day dinner."

Mrs. Barkley will accompany her husband to Greenville for the rally and "Roosevelt Day" dinner, which will be held in Wright auditorium at East Carolina Teachers' College.

The "Roosevelt Day" dinner, Sanford said, will be similar to the "Jefferson Day" dinner held annually by the North Carolina Democrats. The purpose is to raise funds needed to carry on party activities. Tickets will be \$5.

Embarrassing Moment

Dealing With The Impingement On The Dignity Of One Of The World's Most Dignified Gentlemen, Charles Evans Hughes; The Occasion And His Gesture

This being reminiscence Saturday (by request), your columnist offers for your delectation the tale of that moment which was at once the most embarrassing and astonishing of his far from humdrum career.

It had to do with my impingement (by proxy, so to speak) on the dignity of one of the world's most dignified men. I refer to the late Charles Evans Hughes, internationally famed statesman and jurist who, among many other distinctions, was Secretary of State and Chief Justice of the U.S. Here is my story:

It was a summer's day in Oswego, N.Y., back in 1908. (Never mind counting to estimate my age, madam. It was 42 years ago and I was a mere stripling, or words to that effect.) Mr. Hughes, who then was governor of New York and was campaigning for a second term, came to Oswego to address the politically powerful State Volunteer Firemen's Association, in annual convention.

Bad Traffic Snarls Often Due To Minor Violations

\$8 Million Blaze Began With Bet

Tokyo, April 15—(AP)—Police today said a bet on whether a lighted cigarette could ignite gasoline led to the \$8,000,000 fire that razed a major part of the resort of Atami Thursday night.

This is the way investigators said the fire began:

A workman was filling a gasoline container in a waterfront building. A second workman bet that a cigarette dropped into the gasoline wouldn't start a fire.

The first workman took the bet and a lighted cigarette was dropped into the container with the following results:

More than 200 persons injured, 19 critically, 1,500 houses destroyed with 6,000 homeless, and most of the business district of the city of 15,000 wiped out.

The first workman is in a hospital for treatment of burns and the second is in jail charged with responsibility for the fire.

Truman Pardons James M. Curley

Washington, April 14—(AP)—President Truman has granted a pardon to former Mayor James M. Curley of Boston, convicted of mail fraud.

White House officials announced his action today.

In 1947, Mr. Truman commuted Curley's six to 188 months sentence, releasing him from the federal prison at Danbury, Conn. Curley had served five months.

The pardon serves to restore all civil rights to Curley, a former Democratic congress member as well as mayor of Boston.

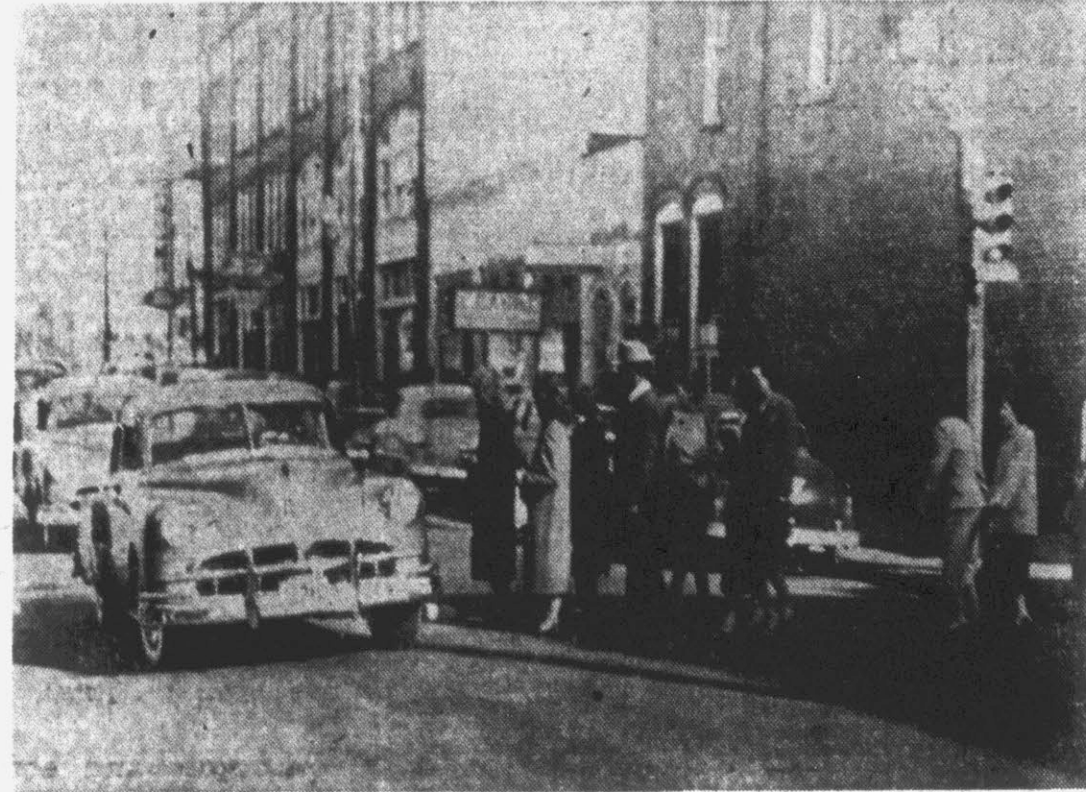

Double parking by cars and trucks offers a serious threat to the safe flow of traffic along the city streets. As can be seen in the above photo, a truck has double parked, blocking the street and the cars which are parked correctly.



Not only does slow moving traffic cause traffic snarls, but persons on foot often times cross against the light, causing cars to have to stop and wait for them to pass before clearing the lanes. Here a group of people cross the street at the same time the traffic starts to move.



Many streets in the city should be made into one-way drives in an effort to avoid traffic tie-ups. In the picture, a string of parked trucks and cars line one side of a small street. On this street when the traffic is the heaviest both sides of the streets are lined with room for only one row of traffic to move safely.



Not all of Greenville's traffic hazards are amply taken care of by traffic lights. In the top picture is shown a typical intersection in which four lanes of traffic travel. The vision of the drivers coming on the streets located next to the building is completely blocked until they enter the intersection. The building is located right on the sidewalk leaving only the sidewalk between the drivers and the intersection. Several serious wrecks have occurred at this intersection.

Small Infractions Frequently Help To Slow Traffic

One of the main topics in Greenville on busy week-ends is that of the traffic situation on some of the city streets.

While everyone agrees that the more traffic on the streets means more people swarming into the stores of the town, most people think that something should be done to help clear up the congested area in certain sections of the city.

At the height of the traffic on Dickinson Avenue and Evans Street, for instance, long lines of slow moving traffic snarl the streets for blocks.

At some of the traffic signals, only three or four cars make each light when it changes, piling up more lines of cars behind it.

It is generally believed that the traffic situation in Greenville at its worst is not all together the fault of improper handling of the traffic by the police traffic department, or the traffic lights, but the people themselves. The minor things which most people do, not thinking, result in blocking traffic for blocks and blocks.

To cite a few of the many causes for the man-made traffic tie-ups in Greenville: A person stops his car to discharge a person, while traffic cannot move around it; or a slowly moving car, creeping along looking for someone or something.

The marked walking lanes across the streets at the intersections are for the use of the persons on foot to cross with the lights. Often times cars and trucks come to a stop over the walking lanes, forcing the persons walking to either go behind the car or out in the streets in the traffic to cross. Now in some cases the walking traffic which crosses against the lights force the cars to stop in the middle of the streets, completely blocking the area.

One of the major problems on the city streets is that trucks of all kinds are allowed to stop on the street and discharge their cargo despite the safety of the other travelers which they may be endangering.

Often times these trucks park out in the street when parking space is available nearby.

On some of the streets in Greenville, one way traffic rules would greatly speed up traffic and avoid the danger of accidents. Some streets, at the peak of the traffic, are lined on both sides with either trucks or cars, allowing room for only one car to pass safely. This condition exists on both dirt and paved streets.

Also in certain sections of Greenville, the vision of the drivers are blocked by blind corners which allows the driver no vision at all, until he is out into an intersection. The pictures accompanying this article show a clear example of a four street intersection and a typical blind corner. Presumably the buildings were built before a building law was passed governing the location of buildings or the law has not been enforced. These corners are the frequent scenes of accidents, some of them serious.

"Stop" signs governing the flow of traffic into some city streets are needed in an effort to help clarify who has the right of way. A great number of the intersections have the signs while others still need them.

Other minor parking violations are noted in the city, such as parking in loading zones, parking beside fire hydrants, double parking and jay walking.

From a general viewpoint the traffic situation is one which could be greatly helped if the drivers and walking traffic would just take stock of how many of the violations they are guilty of doing every now and then. The flow of traffic would be speeded up if these small infractions of the traffic laws were obeyed by the people behind the steering wheels and the persons crossing the street.



One of the most frequent causes for traffic tie-ups on the streets of Greenville is that of trucks parking on the streets, forcing traffic either to move around it or to stall waiting for the trucks to unload their cargo. Often times the trucks park in the streets when parking space is available nearby.



Most people would not think that a car or truck parked across the walking lanes offers much of a traffic problem but it does. As shown in the above photograph the truck is across the walking lane, forcing any traffic or persons on foot to have to go way out in the street. The car making the turn is having to make a narrower turn in an attempt to avoid striking the car.



Such traffic lines as the above picture shows is not an uncommon thing in Greenville on Dickinson Avenue and other streets of the city. The string of cars shown moved across the green light at the rate of some three to four cars each time the light changed, taking quite a long time for the entire line of traffic to move through. National Whirligig News Behind The News By RAY TUCKER

WASHINGTON, April 15—"What is behind Philip Murray's and William Green's sudden yearning for a united labor movement?" inquires F. R. P. of Cincinnati. "As I recall, both of them have repeatedly rejected invitations to organize all labor organizations into one big union when they were made by John L. Lewis. Are Phil and Bill slipping?"

Answer: There are several amusing and interesting factors behind the Murray-Green proposals for a merger that would result in a nationwide union with more than fifteen million members. Incidentally, if ever effected, such an organization would be the most powerful and cohesive group, politically, in the United States.

With relatives and friends, it would have first claim on approximately twenty million voters, or almost forty per cent of the number of people who usually vote in a presidential election. Even if all did not vote the same way, and they don't as a rule, they could be a dominant influence at the polls.

MISTAKE—Messrs. Murray and Green now realize and regret the mistake they made in relying on a single political party to win victories for them. For instance, they were largely responsible for President Truman's reelection, and they felt confident that he would be able to repeal the Taft-Hartley Act, and obtain other benefits for them, as Franklin D. Roosevelt paid them off.

But they have discovered that Mr. Truman is powerless in the face of bipartisan opposition in Congress. He cannot deliver. Therefore, they must win control of the legislative branch. And they do not believe they can do this except by re-organizing all the scrapping labor groups into a single organization with a common policy and strategy. In short, they plan to bypass the White House.

UPROAR—But there are several serious obstacles, personal and political, in the way of a merger. A general pooling of labor interests would mean that the big bosses—Messrs. Murray, Green, Lewis etc.—would have to surrender some of their present power. They might even have to be content with smaller salaries and expense accounts, which now run from \$25,000 to \$50,000 a year. I doubt if the hierarchies would deliberately destroy themselves.

It would be almost impossible to solve the jurisdictional disputes among the uniting unions, as they were the reason for the splitoffs of the machine and the coal miners from the A. F. of L. in the first instance. Their throat-cutting squabbles would mean constant internal uproar if they were assembled under one big tent.

TIPOFF—President Truman and his political faction do not want a merger, and they will try to block it, as F. D. R. succeeded in doing several times. The politicians realize that it will be easier to control labor votes, if they are split up. It is also easier to play one group against another, and to take advantage of the personal jealousies among the top leaders.

Specifically, H. S. T. wants no overall labor movement in which such an enemy as John L. Lewis would wield great influence. Mr. Truman's close friend, George Harrison of the Railroad Brotherhoods, opposes unification. That's the tipoff.

SECURITY—Scores of readers—too many to list individually—ask about the prospect for enactment of the expanded Social Security Bill. The pathetic letters come from Maine to California, usually written in shaky handwriting, pointing out that an individual or a couple cannot exist on the present scale of payments.

The measure has passed the House, and is now before the Senate Finance Committee. A majority of the committee members canvassed tell me that the bill should be reported favorably within three weeks. As the leadership on both sides of the aisle favor it, its enactment into law seems certain.

It is impossible to list here the detailed changes. But the present average payment of \$26 a month to an individual will be increased to about \$45. In general, that will be the proportion of increase for all beneficiaries. Couples now receiving approximately \$50 should get about \$85 or \$90.

Old age and survivors benefits will be extended to include eleven million additional people, mostly non-farm self-employed. Pensioners will be permitted to earn up to \$50 a month without disqualifying themselves for federal payments. The current maximum on outside earnings is \$14.90.

WAGES—"Moscow propagandists constantly tell us how much Communism has done for the workers and ordinary people of Russia," writes M. P. of Springfield, Mass. "Can you tell me what prices and wages are in that country today? What does a worker get for his money?"

Answer: In the first place, a working man cannot get much for his money because only the barest necessities are available. It must also be remembered that they have no forty-hour week in the Soviet. It averages between sixty and seventy hours, sometimes more.

The latest official figures, based on a 25-cent value for the ruble, show the following current Moscow prices: Beer, 70 cents a pint; cheese \$5.32 a pound; oranges, 55 cents each; toilet soap, 75 cents a bar; milk, 52 cents a pint; beef, \$4.34 a pound; ham, \$5.60 a pound; cheap men's shoes, \$117 a pair; women's medium quality dresses, \$101.

Again giving a 25-cent value to the ruble, unskilled workers in Moscow are paid from \$64 to \$128 a month, while skilled workers get from \$125 to \$378. Prices are much higher and wages are much lower in the provinces.

Around Capitol Square

BUSINESS AID—The division of commerce and industry, in the department of conservation and development, has received out-look of a plan for aid to small business recently put into effect by the State of Maine.

The scheme was authorized by the 1949 general assembly and is not designed to cost the taxpayers anything. Proposal is to sell \$50,000 worth of stock and then to solicit investments by banks and insurance companies to provide a million and a half dollars capital. This money would be available for loans to finance establishment or expansion of small business enterprises. It would be frankly regarded as "venture capital" for backing reasonable propositions which still did not have bank credit rating.

N. C. CORPORATION—Several years ago Charles S. Allen, Durham business man and member of the state board of conservation and development, conceived a similar plan for this state. A charter was obtained for "The North Carolina Corporation," and through activity of J. V. Whitfield, Pender county legislator, several thousand dollars stock subscriptions were obtained. Press of other business matters on time of Allen and Whitfield diverted interest from this project. Allen said this week he has personally kept the state taxes necessary to keep the corporation alive, and he hopes the original aims may yet be carried out.

SMALLER—The North Carolina scheme did not contemplate a large block of beginning capital. Plan was to start operations with \$50,000. However, the stock was to be issued in several classes of common and preferred. A and B shares, so that there would be opportunity for various types of investment. Meanwhile, a number of cities and towns have

moved forward with local organizations patterned on the same idea and these have already proven their high value in community development.

LOCAL—List of communities having investment corporation of this character is not available. Goldsboro is known to have a working unit. Hickory, Shelby, Siler City and other piedmont towns began in early days of the war to lay by funds for post war development, not only for promotion of industry but for hospitals, recreational centers, libraries and similar community-building projects. Numerous local areas are becoming more interested in small home-financed industries. There is growing belief that since North Carolina is essentially a state of small towns, with no very large cities, its industrial development can more appropriately follow along lines of many small plants instead of a few enormous industries.

FACILITIES—Governor Scott has long contended that the rural road improvement program, coupled with extension of power and phone lines into more remote country areas, will rapidly further this type of progress. Long before Scott became governor the big power companies and REA units had recognized and were working on the same idea. All such activities have been speeded up since the war, and especially under the impetus given by the governor during the past eighteen months. North Carolina promoters are watching the experiment in Maine, and whether or not it proves successful there is likelihood "The North Carolina Corporation" idea will be revitalized and activated to cooperate with and supplement funds provided by the local promotional units.

ISSUES—Since many of the

business ventures supported will be admittedly "risk investment" some loss of money is expected. Belief back of the idea is that good accomplished through successful industries will far more than offset such losses. However, in no case would the money invested be regarded as a donation. In every case repayment with legal rate of interest would be expected.

MISSING—Another veteran will be missing from the 1951 general assembly. Arch T. Allen of Wake, who had also been a tentative candidate for speaker, has announced he will not seek re-election to the house. Member of every legislature since the special session in 1936 except while on active duty with the Navy in the South Pacific while the 1945 assembly met, Allen has headed many of the most important committees in the house.

SPEAKERSHIP—His withdrawal leaves only two avowed candidates in the 1951 speakership race. They are Fred Rysler of Vance and Frank Taylor of Wayne. Generally accepted classification rates Rysler as having support of the Scott administration, Taylor that of the more conservative element. The men themselves are reluctant to accept that rating, each claiming that he is standing upon his own feet. There are a number of students of legislation who doubt the speakership race will be limited to these two. Almost always, say these long time observers, the post is practically conceded to one man, or there are more than two contestants at this stage. It will not surprise this group if a third member whose name has not been suggested to date moves in and complicates the voting before time for the assembly to organize next January.

Business Today

There has been a big shift of consumer buying to durable goods—furniture, appliances, autos, etc. It has become a critical problem for merchants of soft goods, such as wearing apparel.

Samuel L. Deitch, president, told the annual meeting of the Industrial Council of Cloak, Suit and Shirt Manufacturers this week that in 1945 the public spent 12.6 per cent of disposable income for apparel and 15.6 per cent for durables. By 1948 it was spending only 11.4 per cent for soft goods and 31.8 per cent for durables. The trend appears to have been accelerated since 1948.

Federal Reserve figures on department store credit show that installment sales in February were 40 per cent higher than a year ago, while charge sales were 4 per cent less. Since department store installment sales are largely of durables, and charge sales are largely of soft goods, this indicates a tremendous swing from soft goods to durables among credit customers. The trend is probably not as pronounced among cash customers.

There are several reasons for the shift:

- 1. Great construction of new housing is creating demands for furniture and appliances.
2. Demand for television sets has risen.
3. Softer credit terms are available for durables. A survey by A. L. Trotter, chief expert of the National Retail Dry Goods Association, shows far easier terms for hard goods. The survey showed 54 per cent of responding stores require down payments of 10 per cent on durables, while only 29 per cent will sell soft goods for 10 per cent down.

Fashion trends have reduced soft goods sales. Dr. Paul H. Nystrom, Columbia University professor of marketing, told a meeting of ready-to-wear retailers, "It seems safe to assume a good many of your customers already have well-stocked wardrobes of suits, coats, suits, dresses and similar goods. They may not feel the urge to buy new goods until they have used up what they have. During recent years the fashion trends for women's apparel have been for suits rather than for dresses. The fashion cycles for suits are ordinarily longer than those for dresses. It has been the experience over many years that after two or three years of good suit-selling, there almost invariably follows a similar number of years of lower sales." Dr. Nystrom told retailers the situation offered a challenge to their merchandising skill.

"If it is your desire to get some of the dollars for your departments that are now going to automobiles, building materials, and television sets," he said, "the job is to have goods and sales promotion to back the goods that will make them at least equally attractive."

ONE BIG VACATION IN RAYON WEAVING

"All vacations at once" will be the rule in the rayon weaving industry this year. The National Federation of Textiles checked and found that 78 mills will close from July 1 to 10, and that 14 would close from July 1 to 17, with practically all saying vacation pay would be granted.

DISPLAYS DEVICES MOVE AND TALK

Displays that flash light, move and speak to customers featured the Point of Purchasing Advertising Institute's show in New York this week. There was large interest in devices which play a recorded sales talk after consumers pass in front of electric eyes. Many new devices that go through long series of motions, light up messages at customers' approach, and flash sales messages on viewers were also on display.

Institute officials estimated that from \$500,000,000 to \$700,000,000 is now being spent a year on point-of-sale displays.

OLD PROMOTER'S PLAN COMING TRUE

The Old Promoter had a self-satisfied grin when he walked in today. "You will recall," he said, "that several months ago I gave you an item suggesting that if the British wanted to increase sales here, they ought to outfit a ship into a floating fair and tour the sea ports of the country." We nodded in recollection. "Well," said the O.P., "did you notice that the British are now going to send a floating fair to Mediterranean ports, and that if it pays off it will probably be sent to America?" "Yes," we said, "have a cigar as a token of appreciation for your item, Old Promoter." "Old SIR Promoter," he said. There was a dreamy look in his eye.

CHICKEN: Lower poultry prices have resulted in new canned products. There's a new line of turkey breasts and chicken breasts packed in jars (for Hi-Hat, 37 Bronx Terminal Market, New York) and chicken croquets and chicken dumplings in cans (by Meeting House Brands, Wrightsville, Pa.).

Hal Boyle's Column

New York — (AP) — National Doughnut Week begins today. And, naturally, millions of thoughtful Americans are going around saying to one another: "Good old National Doughnut Week. It's rolled around again. My, isn't it good to have it back?"

But only a handful of these grateful citizens are aware of the deep historical significance behind National Doughnut Week—or just how it came about.

Well, it was born 13 years ago in the agile brain of Bert Nevins, a balding, cruller-shaped publicity man.

"It was the first of the food weeks," Bert recalled modestly. "Before that there were just things like Mother's Day, Arbor Day, the Fourth of July and National Baby Week."

Now, of course, there are weeks for all sorts of goodies—such as National Hot Tea Week and National Cold Tea Week, National Kraut and Frankfurter Week, National Pickle Week, National Honey Week and also National Honey for Breakfast Week.

The pioneering idea of setting a week apart for the nation to pause and ponder the blessings of the doughnut grew out of a stern reality in the industry—sales hit a peak at Halloween, slumped in the spring.

"Picking the right time was very important," said Nevins. "You don't want to have a food week during a period when there are other holidays, as people have other things on their mind."

"We couldn't take the week before Easter because bakers are pushing hot cross buns then. So we settled for a week in April after Easter."

And in the baker's dozen years since the doughnut mused itself a place in the calendar sales have quadrupled. The \$200,000,000 a year industry expects to sell 12,000,000 doughnuts in 1950.

"We don't think that National Doughnut Week alone is responsible for this increase," said Nevins, who has built himself a \$100,000 annual business glamorizing doughnuts, diapers, pretzels and cranberries. "But we do know that spring sales, which used to be small, now are almost equal to fall sales."

Some groups name a week for their product, say "National Frozen Dogood Week" and let it go at that. Nevins uses every possible device to thrust doughnuts into the public mind.

This week, for example, his gimmicks include a new doughnut-shaped hair-do, doughnut straw hats for the ladies, pajamas decorated with doughnuts, and a recording of "The Doughnut Song," by Folk Singer Burl Ives. He even persuaded Emily Post to endorse the custom of dunking "provided the doughnut is first broken in half."

Like all frontiersmen of the intellect, Nevins feels he has been copied. "Now there are too many weeks of all kinds overlapping each other," he objected. "This whole idea of special weeks may kill itself if we get many more. It is getting promiscuous."

He is mulling over a plan to call all interested parties together and get them to divide up the year on a sensible basis.

"After all there are only 82

weeks," he said regretfully. "So, a happy Doughnut Week to you! It is also National Coin Week, National Want Ad Week and National Noise Abatement Week."

WASHINGTON — Three things Mrs. Pandora Tsaldaris of Athens, Greece, wanted most to see on her first visit to this country—the Empire State building in New York, the Broadway show "South Pacific"—and juke boxes. The beautiful, dark-haired young woman, daughter-in-law of Constantine Tsaldaris, former premier of Greece, is in Washington for the opening of a "Cavalcade" of Greek fashions. She has seen and heard the juke boxes. She finds them "fascinating."

The Cavalcade of fashions, which features a number of national Greek costumes from the provinces as well as modern creations made by leading designers of the country, will go from here to New York. The chic Mrs. Tsaldaris will go with it. "I will see the Empire State from floor to floor then," she says. She hopes to see "South Pacific" too.

After the showing in New York, the fashion collection will be taken to San Francisco, Berkeley, Calif., and Dallas, Tex. In June it will be viewed in Paris and later that month in London. Proceeds from the showings will go to Queen Frederika's orphan fund. The Cavalcade originally opened at the Royal Theater in Athens under the auspices of the King and Queen. Mrs. Henry Grady, ambassador of the United States, instrumental in getting the fashions to this country. She expects to be in Washington for the opening here.

(Continued from Page One) Failures On The Increase Every month my statistical experts compile for me comparative figures on over thirty business barometers. In my forty years of studying business conditions I have always said the most significant figure is that for Business Failures. Heretofore, a very low failure figure has indicated excellent present business conditions; but such figures usually forecast that business troubles are coming. With double the national income failures have during the past ten

years actually been less than before 1940. But at last we see a change for the worse. The greatest increase in bankruptcies is in the retail store field where there has been an increase in failures of 12 per cent. In the case of manufacturing this figure is 9.4 per cent; while in mining, farming, etc., there are 5.4 per cent more failures. Although the failures in the retail field show the greatest increase, yet enough new firms come into being so that the total is now only 2 per cent less than at the peak.

What Statistics Show As a result of all the above 45 per cent fewer new concerns were incorporated in 1949 than in 1946. The number of independent concerns are now about 3,900,000 compared with nearly 4,000,000 in 1949. Yet, there now remain about 18 per cent more concerns in business than in 1939. The present failures average about 200 a week—compared with 100 a week in 1948. Further details will be sent freely on request by the world famous authorities, Dun & Bradstreet in New York City.

There is one cheering feature to these figures. The bankruptcies were not all among young G. I.'s. In fact, 7 per cent of them were of old concerns which had been dying of dry rot for many years. With age comes poor health and a loss of energy. Young men have this energy which we older ones lack. This is worth more than capital or customers. Hence, no young people should be discouraged by the above figures on failures. But I do say that if you now have a good job, hold it and make the most of the opportunity it gives you to learn. This is not the time to start in business for yourself.

Cool Weather To Extend A Month

Washington, April 15—(AP)—The weather probably will continue chilly in the eastern part of the nation for at least another month—but not as frigid as it has been. But the west will be warmer

than usual. That was the gist of the latest experimental 30-day forecast issued yesterday by Jerome Namias, chief of the weather bureau's extended forecast section.

Air Search For Missing Plane Will End Today

Wiesbaden, Germany, April 15—(AP)—Lt. Gen. John K. Cannon, chief of the U. S. Air Force in Europe, announced today search for a navy privateer plane missing for a week will be abandoned at sundown tomorrow.

U. S. planes roved over the Baltic for the seventh day today with scant hope they still may find the plane and its crew of ten.

Sixteen U. S. Air Force search planes based at Copenhagen reported the weather was better over the Baltic than any day since the navy privateer patrol plane vanished a week ago today on a flight from Frankfurt, Germany, to the Danish capital.
