Czechoslovakia Is Ordered To Close Consulate In N.Y.

Drastic Retaliatory Action Taken As State Department Accedes To Prague Demands; Will Hamper Czech Trade Relations

Washington, May 27—(AP)—The United States today ordered Communist Czechoslovakia to close its New York consulate.

At the same time, the State Department announced that the American consulate in Bratislava is being closed. The U. S. said it is yielding to a demand by the Prague government to reduce total U. S. diplomatic staff in Czechoslovakia from 26 to 12 Americans by June 6.

The Department said the American action was taken in a note presented by Ambassador Ellis Briggs to Czech Foreign Minister Vilém Štoky at Prague today.

The American note was in answer to a Czech note of May 23 saying that the United States should cut its official personnel to 12 persons—the number of Czech diplomats now officially permitted in this country.

The Czech demand had angered State Department officials since this country has for several years maintained a larger staff in Prague than the Czechs have maintained in Washington.

The decision therefore was made to force the closing of the Czech consulate general, including the office of the commercial counselor, in New York. While the American note used such terms as "requests," the message amounted to an order to the Czechs to close the consulate.

The action came within 24 hours after the United States had restricted Romanian diplomats to an area of 35 miles around the city of Washington. That move was in retaliation for Romanian restrictions on U. S. officials in that country.

The main result of the closing of the consulates appears likely to make it more difficult for the Czechs to carry on trade with the United States. Officials said the Czechs had a favorable balance last year—their imports of American goods totaling \$21,300,000 against their estimated sales to the United States off \$22,000,000.

The travel ban against the Romanians was announced yesterday by Undersecretary of State Webb.

While he indicated there might be still further reprisals in the making against the Soviet bloc, Webb said there is no present plan to limit the movements of Russian Ambassador Alexander S. Panuskin and his staff.

One of the largest in the country the Soviet embassy numbers nearly two-score officials, aside from dependents.

All of these persons remain free to travel whenever they wish in the United States.

The Romanians were ordered not to stray more than 35 miles beyond the capital boundary, except with specific permission from the State Department.

Bretton Woods Story

About The Gentle, Blue-Eyed Men And Women Who Made Up The Icelandic Delegation When The World Bank And Fund Was Set Up; Admiration For U. S.

Today I want to tell you a little "one world" story from the Bretton Woods conference of July, 1944.

It's about the gentle, blue-eyed men and women who made up the Icelandic delegation to the meeting in New Hampshire where the World Bank and Fund were set up. Two Pitt Prison Camp Escapees Recaptured

One Caught Soon After Break By ABC Officer Claude Manning In Woods Near Road Gang; Second Nabbed Early Today

Two white convicts who escaped from a Pitt County road gang in the Sheppard's Mill Pond section near Stokes yesterday are back behind bars today following a speedy recapture of the pair by prison officers.

The prisoners escaped from a road gang working near the Mobley bridge between Stokes and Bear Grass around 1:30 p.m. yesterday. The pair later stated that they made their break at the time a large tree was being felled. When the tree crashed to the ground they ran for the woods.

Guards at the site discovered the escape almost at once and a search was organized.

The two prisoners, one a long termer and the other described as a short termer, walked into the arms of the law a short time later.

The two escaped men, William F. Shoaf, 26, and Wilbert Wooten, 26, were making their way through a swampy woods at the same time Pitt County ABC Officers J. M. Ward and Claude Manning were in the locale.

Manning and Ward separated at the time the men made their appearance.

Prosecutor Raps Handling Of Case

Says Evidence In Amerasia Suit Obtained Illegally

Washington, May 27—(AP)—A striking new development involving the 1945 Amerasia case brought a fresh dispute today between Senator McCarthy (R-Wis.) and the Senate group investigating his charges of communism in the government.

The new development came in the form of a statement by a former government prosecutor that the Justice Department case against the Amerasia defendants all but fell apart when some of them learned that the major evidence against them had been obtained illegally.

The defendants were charged with unlawful removal of hundreds of secret government documents, some of which were found in the offices of Amerasia magazine, a now-defunct publication which dealt with Far Eastern affairs.

The government prosecutor in the case was Robert M. Hitchcock, who read his statement behind closed doors yesterday to the Senate foreign relations subcommittee studying McCarthy's charges.

In releasing the statement later, Chairman Tydings (D-Md.) said additional testimony by Hitchcock was not being made available because there was no time to prepare it.

That prompted a sharp comment from McCarthy, who has called the Amerasia case a key part of his charges that the State Department harbors Communists and Communist sympathizers.

"The new practice of hearing a witness in secret session and carefully selecting the parts of his testimony which will be made public and the parts which will be kept secret is fantastic beyond belief," McCarthy declared.

McCarthy and others in Congress have claimed that there was an Administration "cover up" of the Amerasia case.

Blockade Base Abandoned Today By Nationalists

Hong Kong, May 27—(AP)—The Chinese Nationalists handed the Wanshan (Ladrone) Island to the Communists today, the Royal British Navy reported.

A spokesman said evacuation of the blockade base 40 miles southwest of Hong Kong was completed by Nationalist warships at 8 a.m.

In giving up the Wanshan the Nationalists left the trade-starved Communist metropolis of Canton open to foreign sea commerce for the first time in more than eight months.

The Royal Navy report came only a day after the Nationalists had announced a whopping victory over Communist invasion forces.

The Nationalists claimed yesterday that 4,000 Red troops had been "annihilated" in their second attempt to take the islands by amphibious operations.

Minor Incidents Mark Gathering Of German Reds

West German Kidnapped; Fourteen Demonstrators Desert Red Event

Berlin, May 27—(AP)—With pomp and fanfare reminiscent of the Hitler era, East Germany's Communist youth brigades paid homage today to Russia's war dead. Western troops and West German police patrolled the Western sectors on watchful alert as the long-heralded Whitenside rallies steamed into high gear.

There were a few minor incidents here and there, but mainly the city was calm and orderly. Three East German police, armed with old German army carbines, abducted a German from the American sector during the noon hour and fled on Western police when they attempted pursuit.

That was the second such incident in 24 hours. The first was forestalled last night when British sector police seized two alleged Communist agents as they were pushing a political refugee into an east-bound elevated train.

But all the Eastern police were not happy. Eight young conscripts fled to the Western sector, Allied officials reported, making a total of 14 such deserters so far.

More than 3,000 blue-shirted youngsters of the Free German Youth—Freie Deutsche Jugend (FDJ)—stood stiffly while wreaths were laid at the foot of a Soviet memorial made largely of marble wrenched from Hitler's former chancellery.

The ceremony was a highlight in the three-day Free German Youth demonstration which will be climaxed here tomorrow with a monster parade.

Today's tribute to the war dead of a country which was once Germany's bitterest foe called out only a portion of the estimated 377,000 youths of East Germany who have already gathered here.

The wreath-laying ceremony, which also was used to attack the Western Allies was strictly a German affair. Only two Soviet officers were on hand. They stayed discreetly in the background.

Officers encountered some trouble in tracking the man as the area is muddy and swampy.

U. S. Production Rivaling Records Output May Equal Or Top 1848's Postwar Boom Levels

Washington, May 27—(AP)—The production of America's mines and factories this month may rival the records set in the postwar boom year of 1948.

Reporting this last night, the Federal Reserve Board said industrial output had hit a 13-month high in April and was continuing the upswing this month.

April output was indexed by the board at 189 per cent of (89 per cent above) the 1935-39 average against 187 in March and 179 in April, 1949, when an economic downturn was underway.

This month, the board said, "apparently" will produce another two point rise to 191—closing in on the historic top of 195 registered in October and November, 1948, at the crest of the postwar boom.

Along with the upsurge in production the board noted price advances since mid-April in many industrial materials, farm products and consumer goods.

Sales of autos, television sets, home furnishings, and other durable goods were reported continuing strong—with autos setting new records.

In contrast to this trend, however, department stores found clothing sales moving slower than a year ago. The Commerce Department reported that manufacturers' business also slackened somewhat from the hot March pace, with some trimming down of the backlog of unfilled orders. Nevertheless, it still was ahead of 1950's first two months and far above a year ago.

Babson Discusses Jobs For Grads

Babson Park, Mass., May 26—One and three-quarters million boys and girls will graduate from our schools and colleges this May and June. Their outlook is bleak. Nearly half their number will graduate into unemployment!

Reasons For Scarcity

There is already a pool of unemployed estimated roughly at 5,000,000. In addition, 500,000 college graduates will come onto the job market late this spring. Another 1,200,000 high school graduates will receive their diplomas by late June.

Of these high school graduates, 240,000 will go on to college. About 300,000 of the girls will marry. The balance 760,000 will seek employment. School officials say that another 600,000 drop out of school and college each year for one reason or another. They, too, become job hunters.

There are six reasons for the gloomy outlook: (1) The war-time and post-war shortages have now been mostly filled. (2) Industries have been making a few efficiency studies to cut mounting labor costs. (3) Since most industries are no longer expanding, much hiring is on only a replacement basis. (4) Individuals are graduating from

Defense Factor Given Big Role

Post-Marshall Plan Program Shaping Up In Washington

Washington, May 27—(AP)—American military interests will play a vital part in White House development of a new global economic program to succeed the Marshall Plan.

Officials said today this fact is reflected in the appointment of Tracy Voorhess, former Undersecretary of the Army and now a consultant to Army Secretary Frank Pace, as a member of the staff of Presidential Assistant Gordon Gray of Winston-Salem, N.C.

Gray, himself a former Army Secretary, was named by the President earlier this year to direct a government-wide study of what the United States should do to keep an adequate supply of dollars in the hands of friendly nations when the multi-billion-dollar European recovery program ends in 1952.

Involved in this project are three matters having an important bearing on national defense:

(a) The necessity of insuring imports for the nation's stockpile of strategic materials; (b) the effect of U. S. economic planning on the occupation of Germany and Japan; and (c) the need to protect vital American defense industries from the possible harmful effects of European competition.

Gray has now substantially completed the organization of a staff whose principal members include top-flight experts on this country's defense needs, as well as some of the nation's leading economic authorities.

Fire Sweeps Big Chemical Plant

Cincinnati, May 27—(AP)—Fire, fed by chemical and tobacco dust, roared through the Virginia-Carolina Chemical Corp. plant here early today and destroyed four buildings with a loss estimated unofficially at \$300,000.

The fire spread so rapidly that the four buildings were wrecked in slightly less than two hours. Fire men succeeded in saving a nearby building which contained explosives.

Officials Await Holidays' End In Oak Ridge Strike

Oak Ridge, Tenn., May 27—(AP)—Officials looked today to the end of the four-day holiday weekend for the next step in a walkout which has idled \$250,000,000 of government construction projects here.

Local and international union officials denounced the three-day-old strike and urged members of 18 AFL organizations to return to their jobs. But they said they had little hope of marked success before next Wednesday following Memorial Day, although Monday is a regular work day.

"A lot of the men have taken the entire long weekend for trips and such, expecting the strike to continue," said George A. Hines, president of the AFL Knoxville Building Trades union, parent organization of the 18 craft unions involved.

Six Probes Open In Chicago Crash Fatal For 32

Chicago, May 27—(AP)—A half dozen separate investigations were being made today in connection with the street car-gasoline truck crash in which 32 persons were killed Thursday.

Some of the points the investigators are attempting to clear appeared to be the rate of speed the crowded trolley was moving and the discrepancy in passengers' accounts on the operation of the car's rear doors.

Thirty-one of the estimated 48 persons in the trolley—including the motorman—perished minutes after the car crashed into the big gasoline truck. The driver of the double trailer truck, which contained some 8,000 gallons of gasoline, also was killed. Thirty others were hurt.

Throughout County, Voters Turning Out In Large Numbers; Observers Revise Earlier Predictions Upward; City Boxes Off To Fast Start

Pitt County appeared to be headed toward its predicted record vote today as citizens all over the county ventured to the polls under sunny skies to join the half million Democrats throughout North Carolina who are expected to cast ballots today.

With the sunny skies came what apparently will be one of the largest Democratic primary votes in the county's history even if it falls short of the 11,000 vote record set in 1940. Throughout the county, however, candidates and campaign managers alike were predicting as many as 12,000 votes would be cast in Pitt County's 20 precincts today.

Some political observers who earlier this week predicted an 8,000 to 10,000 vote in the county, this morning were revising their estimates toward the 11,500 or 12,000 marks.

Throughout most of North Carolina today fair weather was forecast, but scattered showers had been reported in a few areas. Today's primary in the state centered around the senatorial race in which Frank Graham and Willis Smith are considered the principal contenders. Observers predicted a vote close to 500,000 which would be near the record of 516,000 votes which was set in 1936.

Voting was relatively slow in most of the boxes in Pitt County during the first hour after the polls opened at 8:30, but soon after 9 o'clock this morning the balloting became unusually heavy, especially in three of Greenville's four boxes.

At the Greenville precinct number four (city hall box), which is the largest box in Pitt County, 700 people had cast ballots at noon today. In the same precinct a total of only 915 votes were cast in the 1948 second primary which drew more people to the polls than the first primary of that year.

At the court house (Greenville No. 27) votes had been cast at 11:35 today. The morning voting at that precinct indicated the box would go far over the 786 votes cast in that precinct in the 1948 primary; and perhaps over its record of 1,108 votes cast in 1940.

At Greenville No. 1 (Third Street school) 543 votes had been cast at noon, and there was little doubt that today's balloting would go far over the precinct's record of 584 votes which was set in 1940.

Greenville precinct No. three reported only 200 ballots cast at 12 o'clock, and appeared to be the only precinct in the Greenville township which was lagging.

A compilation of the figures from Greenville's four precincts at noon showed 2,118 votes already had been cast in the township, compared with the total of 2,651 votes which were cast in the senatorial race during the 1948 primary.

Early heavy balloting at the Greenville precincts was a surprise to most observers, as it did not follow the usual election day pattern which sees the precincts throughout the county have slow balloting during the morning and increasingly heavy voting during the afternoon.

Lines already had begun to form at the city hall and the court house before 8:30 this morning, and from time to time during the morning as many as 50 or 75 people waited in line for their turns to vote.

Balloting in the boxes throughout the county for the most part reported a slow start this morning with voting becoming increasingly heavy toward noon. Most of the poll holders contacted said they expected afternoon balloting to be the heaviest on record for their respective precincts.

Farmville reported 264 votes cast at 11 o'clock this morning, but

The Anti-Gambling Bill

A Pretty Good Bet This Legislation Won't Be Passed This Year; Kefauver Report Awaited; Measure Aimed At Transmitting Information On Races

Washington, May 27—(AP)—If you have to bet, it looks like a pretty good bet the Senate's anti-gambling bill won't pass this year.

The bill was offered to the Senate yesterday by its Interstate Commerce Committee. Its purpose:

To wipe out gambling on horse and dog races by making it unlawful to transmit—by wire or radio—information useful in betting before a race is run. Under the bill, the information could be sent after a race.

The Senate has a special group—the Kefauver committee—making a nationwide investigation of crime. Its work won't end before next year.

The head of this group, Senator Kefauver, Tennessee Democrat, is to report to the full Senate by February, 1951. And, based on what his investigation uncovers, he'll probably make recommendations on crime.

So until it has had a chance to see the results of Kefauver's investigation, the Senate seems unlikely to act on anything so major as this anti-gambling bill introduced yesterday.

It was put together and approved by the commerce committee which held hearings this spring. Some big-shot gamblers were called before the committee, including

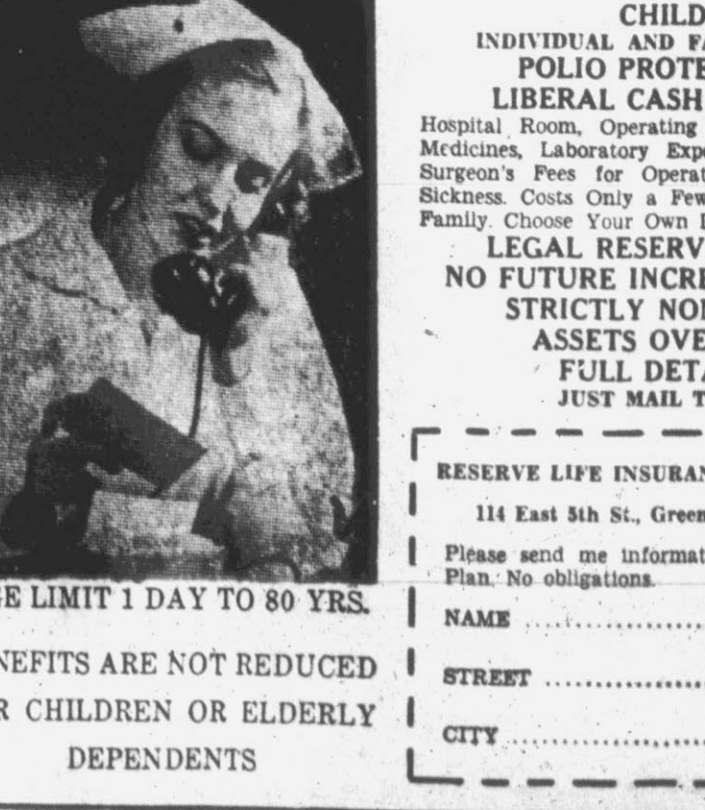

A Hindoo who unpacked the box was even more interested in the paper wrapping and packing than he was in the art object. Forthwith he began to read the Bible, and was converted.

This is not an isolated experience. Religious literature is full of accounts of how Bibles and religious tracts have fallen apparently by accident into the hands of certain persons and have produced astonishing spiritual results. The Bible teaches that the Holy Spirit can lead every one of us to that supreme truth which will give us peace and happiness, if only we will resign ourselves to the Spirit's influence.

Times without number some verse of Scripture has been unveiled in all its glory to the waiting and needy heart of someone who was walking in darkness. The Bible is the message of God to man, and it is as cogent today as it ever was.

## Lower The Death List By Staying Off It

We stand on the eve of a long Memorial Day weekend; a period in which the National Safety Council says will mark the last days of life for some 290 persons whom they predict will be killed in traffic accidents. No mention was made of the number of maimed and crippled victims that will be added to the grisly total.

The tribute we pay our war dead is almost obliterated by the unprecedented extent of bloodshed conducted on America's highways during that brief period.

Greenville and Pitt County have been peculiarly plagued by an unusual number of automobile accidents and fatalities during the early months of this year. It is to be expected that the Memorial Day period will be marked locally by more than usual travel, and the Reflector urges that extra care be exerted by our people.

Keep it a "safe and sane" Memorial Day. Keep down the expected toll by keeping your name off the list.

## Our Nomination For The Cleanest Campaign

With all the mud slinging and gnashing of teeth in the senatorial campaign, one thing stands out above all. Bob Reynolds surprisingly enough has conducted the cleanest campaign of all.

When Bob gave up his job of baby sitter a few months ago and announced he would enter the political campaign, the people of North Carolina thought they were in for a campaign marked by a red carpet, T-model Ford and all the invective language the dictionary could muster—with a few new expressions thrown in.

Although the 1950 senatorial campaign sank to the lowest ebb the state has witnessed in a long time, Reynolds did a good job of keeping his skirts clean. Neither the Smith camp nor the Graham camp can make claim to the same type of vote-getting publicity program.

Reynolds probably will not make a good showing politically in today's primary; but he at least has indicated that his years in the Senate, and his life since that time have endowed him with a great deal more uprightness in his campaigning than his opponents in the 1950 race have shown.

## The Fuse Grows Shorter On Berlin Powder Keg

Time is growing shorter as is the fuse on the Berlin powder keg. There are reportedly 500,000 Communist youths who are preparing for a mass demonstration in the German capital on May 28th—tomorrow.

The Allied forces in West Berlin have taken their positions to repulse any attempt by the Communist youths to over-run the western portion of Berlin. And apparently the Russians are attempting to avoid letting an incident grow out of the demonstration which would cause an international crisis. At least on the surface the Russians

have backed down on any original plans of forcing the allies to withdraw from Berlin with the mass youth demonstration.

Orders have been issued to the Communist youths by their leaders that "under no circumstances overstep the (Russian) sector boundary." The order also admonishes the youths not to "let yourselves be provoked and drawn into thoughtless actions."

Those warnings are good advice; but when a half million young people gather together anywhere, a radical idea can spread like wildfire. The youths just do not bear the sense of responsibility which is found in older people.

While the Berlin situation looks much brighter than it did a few weeks ago, it by no means has ceased to be a powder keg. A few people scattered through the 500,000 Communist youths in Berlin tomorrow could turn the peaceful demonstration into a mass riot which may be the spark to touch off another world conflict.

The world is watching and waiting.

## National Whirligig

News Behind The News

WASHINGTON, MAY 27—"Am I mistaken," asks M. T. of Troy, N.Y., "or is the Republican Party finally awakening from its long sleep and becoming more progressive than it has been for the last thirty years, ever since Harding? Is there a faint chance that they will give us a presidential candidate in 1952 who will not want to return to McKinley, Harding or Hoover days?"

Answer: That is a difficult question, and it covers a lot of territory. But I do think that the GOP, largely as a result of its exile from power at the White House and at the other end of Pennsylvania Avenue, will present a modified "new look" in the next national election. Otherwise, it won't have any face at all.

A major political party is like an individual, being a collection of them. It cannot remain forever immune or unresponsive to the stirring of new forces, new needs and new viewpoints, especially when it realizes that the opposition owes its success to its contrary reaction.

RETREATING—It strikes many Washington observers that the Old Guard is retreating or being driven back on many fronts. Recent primary results seem to indicate that the Republican rank-and-file are more ready for certain social and economic changes than their leaders.

Governor Duff's victory over the admittedly reactionary Grundy machine in Pennsylvania was the most recent and notable example. Across the border in New Jersey, Governor Alfred E. Driscoll has given an economic and relatively liberal administration, resulting in his mention as a possible vice-presidential nominee.

LOST—Don't forget that the Republican Governors of two of our most important commonwealths—Dewey of New York and Warren of California, both of whom will probably run again—campaign on such a progressive platform in 1948 that many leading party conservatives were hostile.

They lost, not so much because of their break with party traditions, as because they refused to discuss such basic issues as centralization, regimentation, political spending and using public funds for vote-getting purposes. They shadow-boxed.

In another great state, Illinois, the Republican senatorial nominee was never regarded as "the back" when he served with distinction in the House. He is Everett P. Dirksen, who is conceded a 50-50 chance to defeat Senate Majority Leader Scott Lucas.

QUESTION—Other men coming to the fore are "The Eisenhower, Senator Edge of Massachusetts, Representative Lodge of Connecticut. Across the continent, the sometimes Fair Dealish Wayne Morse won an overwhelming triumph over an old-fashioned conservative in the primary.

The great question of 1952 will be whether these men can translate their nomination of a presidential platform and in the nomination of a presidential ticket. Or will they, under the pressure of expediency, nominate a couple of harmless political hacks and adopt a set of plattitudinous principles on the theory that the Democrats can't go on winning forever?

If they do, they ought to be licked again, although a change of Administration might be advantageous to all Americans, regardless of party affiliations.

POWER—"Our group of women," writes C. B. of Los Angeles, "have been seriously interested in politics, and we have been discussing the hold of the Americans for Democratic Action on the Democratic Party. You have intimated that there is not close cooperation between the two.

It is our understanding that the ADA has on its executive committee Walter Reuther and David Dubinsky, and that this ADA group is really trying to put over socialism here as did the Fabian Society in Great Britain. Now you intimate that Mr. Truman and his man Boyle are against the ADA. We have felt that the ADA, and not Mr. Truman, was the real power in the Democratic Party."

RESENT—Answer: The Truman-Boyle faction is not openly hostile to the ADA, and did not mean to suggest that they are willing to accept political support from almost any group, and they recognize ADA's appeal to many people who have no great affection or admiration for the Democratic organization. But they do resent ADA leaders' attempts to grab control of the party machinery and to assert leadership in their own right.

CHAGRINED—For instance, the inner circle fears and opposes the pretensions to high office—that is, the presidency—of the Roosevelt boys, although quite willing to use their names for partisan purposes. They were chagrined when Senator Humphrey of Minnesota, former ADA head, forced the 1948 convention to adopt a stronger Civil Rights plank than the White House wanted.

SCOURGERS—They were upset when Senator Paul Douglas of Illinois blasted the Kerr Natural Gas Bill, for Mr. Truman had promised his friends that he would sign it. In both instances these ADA-ers behaved as scourgers in the temple rather than servant politicians. The Reuther-Dubinsky wing is far more insistent on FEPC legislation than the party regulars.

In brief, the White House coterie welcomes ADA's backing for the votes they harvest. But the Trumanites wish that ADA's brain trusters would be less ambitious, less aggressive, less noisy and more puppy-like.

## Around Capitol Square

IT'S OVER—The campaign to influence opinion of voters in the 1950 primary is over. And some three million Tar Heels breathe a fervent "Thank God." Strenuous activity will be continued until the curtains are pulled over the voting booths at 6:30 tonight, but this activity will be directed toward getting citizens to the polls to express their choice already made in their own minds. Governor Scott said at his latest conference that few souls are converted in the last hour.

COMPARISON—The senatorial race ending today follows closely the pattern of the gubernatorial primary two years ago. Then Charles M. Johnson and Kerr Scott were recognized leaders, with Wayne Albright figuring prominently on the sidelines. It was almost universally conceded that Johnson would run high, Scott a good second and Albright an uncertain third. Speculation centered around the Johnson-Scott differential and the size of the Albright factor as these factors would effect a run-off. The current race is recognized as between incumbent Frank Graham and Willis Smith, with Bob Reynolds an uncertain third. Almost everybody except Smith himself and his high rank campaigners agree that Graham will lead. Few expect Graham and his twilight supporters think he will get a clear majority of all votes. So again speculation is on the spread between the two, with size of Reynolds' vote being a big factor on influencing a run-off.

DIFFERENCE—There is further similarity. Two years ago the Johnson folks had most of the state administration and the election machinery; this year Graham has most of the state administration and the election machinery. PROPERTY—Almost every primary election brings out proposal of some of the candidates where more than two are running to let the high man have the nomination. That raises the question of property rights in the office, and whether title is vested in the candidates or in the whole people. Statutes provide for a clear majority in the primary, but awards office to winner of high vote in the general election. This week Reynolds made the high-man proposal and it was accepted by Graham. Smith declined to enter such agreement.

STRATEGY—That sort of thing is a part of campaign strategy. The fellow who makes or accedes to the proposition is thus staking his conviction he will be high man; at the same time it is confessed he does not expect to get a majority. Failure to accept is generally interpreted as acknowledgment the candidate can't win the first time. The statements are phrased to make it appear the proposer is interested in saving time, worry and money during a run-off; the refusals are allegedly based on the right of the people to a final choice. It all sounds good, but in fact it is just practical

politics in action, with all parties seeking advantages out of the way they handle it. The chief factor is one of timing. The second high man must still decide whether to call a run-off, and the high man has privilege of withdrawing if he desires. Unless a second primary is requested in writing within five days after the returns have been officially certified, the high man takes the nomination.

CANVASSING—County boards of election will canvass returns at the respective courthouses on Tuesday, May 30. The state board will meet in the capitol the following Tuesday to declare results on state and district candidates. A second primary must be called or before June 12, and if ordered will be held on June 24.

MODEL—North Carolina's department of agriculture will be used as partial model for a department in New Mexico if Judge David Chavez Jr. wins his fight for governorship of the far southwestern state. Judge Chavez telegraphed Commissioner L. Y. Ballentine asking for information on the "Sunshine State" is the only one in the union without a department of agriculture although it has enjoyed statehood since 1912. One of the planks in his campaign platform is to provide the farmers of New Mexico comparable services supplied by agriculture departments in other states. Blackburn Johnson, chief of the publication division, sent the New Mexican the requested structure and several biennial reports of the North Carolina department, accompanied by a cordial invitation to pay a personal visit to look over the departmental activities.

The outstanding feature of the contract just entered into between General Motors Corporation and the CIO United Auto Workers is that it seems to have been a mutual agreement without the elements of bitterness which have characterized negotiations of the larger unions with their employers recently.

employees of General Motors will get the full benefit of the additional pay without losing ground because of lay-off.

President of General Motors, C. E. Wilson expressed the opinion that the new agreement "is expected to have a stabilizing influence not only on our business but on the economy of the whole country."

Whether other industries can go as far in pay hikes and pensions as the General Motors contract calls for, of course, is a matter that will have to be determined.

The Free Press hopes that the friendly settlement is an indication that a better spirit of mutual understanding is now being manifested. Unless employers and employees realize that they must work together and in mutual interest neither side will be able to get the best results.

## Business Today

The way the projected revisions in the Social Security law now pending before Congress shape up, most small businessmen will come under the pension plan, but apparently a number of professional groups, such as doctors, dentists, lawyers and farmers, are to be excluded. Insurance agents will come under the plan.

How to collect the tax from such self-employed persons as the corner grocer had been the big problem. The Commerce Clearing House points out. It's been overcome by providing that they'll pay 1 1/2 times the regular rate withheld from wage-earners. Probably along with their income tax returns.

Since wage-earners now pay 1 1/2 per cent (the employer pays an additional 1.5), self-employed persons will pay 2.25 per cent of their earnings, if present rates are continued next year when the pending revisions will probably go into effect.

Some 4 1/2 million small businessmen and other self-employed individuals will thus secure old-age benefits when Congress finally approves the changes.

Among the 3 1/2 million additional persons who will be brought into the pension formula will be employees of state and local governments (if the states choose), domestic workers, employees of religious, charitable and other non-profit organizations, and some 200,000 workers on those farms which are essentially commercial and industrial (rather than the family-type farm).

Incidentally, local printers and stationers can get ready to do a flourishing business with specialized records for these new groups. Housewives, or example will have to keep track of how many hours the maid works each week, and how much she gets paid.

WORLD TRADE WEEK SHOWS EXPORT-IMPORT DILEMMA  
What observance of World Trade Week this past week really underscored was the problem of balancing foreign trade without disrupting the U. S. economy. The plain fact is that during 1949 we exported almost twice as much as we imported; we shipped out 4.9 per cent of our gross national

product, and bought goods amounting to 2.8 per cent. Our customers abroad are squawking, and of course don't have the dollars to keep up such unbalanced trade, unless we continue the various types of lending and subsidy operations that are making for a national deficit at home.

Yet, as imports design to correct the imbalance increase, specific industries here suffer, as reported in this column recently. The way it is, the effort to balance trade is a laudable national program, but hard to swallow on a local scale.

One hope for correcting the imbalance stressed in talks during the week, is the possibility for increasing trade between dollar-long nations like Brazil, Persia, Malaya, and dollar-short nations like England and Japan.

BUILT FROZEN FOOD BUSINESS BY WAREHOUSE PHONE  
One department store (Moorehouse-Martens, Columbus, O.) has a home delivery service for frozen foods entirely by phone. The department is located in the store's warehouse; deliveries are made by refrigerated trucks. The store sets a minimum of \$2.50 on orders, and finds the average weekly order runs \$5-\$6. Prospects are dug up through sales and rentals of freezing units by the store's appliance department. The store sends out a monthly price list, and also a mid-monthly list of specials. Phone operators then call each customer weekly, on the day before deliveries are scheduled for that neighborhood.

## Hal Boyle's Column

New York —(AP)— Shall we have 'mapes' in the world? A "mape," presumably, is what you would get if you cross-bred a man and an ape.

Creation of this hybrid by artificial mating between humans and apes recently was proposed by Dr. Sydney William Britton, University of Virginia physiologist.

He said it was scientifically possible and might help our hairy forest cousins speed up their evolution—bring them out of the woods and onto civilized sidewalks.

This proposal drew howls of indignation from some critics. They said it was immoral, impossible, unthinkable, and the mere suggestion of such a thing made them nervous.

I'm against the idea, too, but on ethical grounds; I don't think it would be fair to the apes. And not because of a point that Dr. Britton himself raised—that men might cruelly turn the mapes into a new race of slaves. I just can't believe that a mape—half-man, half-ape— would be happy in our culture, physically, mentally or morally.

As it is now, apes in the jungles live a more naturally moral life than human beings; they are less confused of mind and they are bodily stronger. They are more polite to each other than people; they require no police force to keep them in order. Divorce is rare among them. Without benefit of child psychologists they rear their babies into fine healthy apes instead of juvenile delinquents.

While men scramble dustily with each other for power and more powers, the apes enjoy peace in their time. They don't start wars. And who can say they don't enjoy a lovely sunset just as much as we? Would it be justice to marry this fine clean race to the troubles of mankind? If by doing so, human beings might gain the elemental common sense virtues of the apes it would be a worthwhile project—for our own sakes. But the chances are we merely raise the apes higher—we'd merely educate them to our vices, rather than ourselves acquire their merits.

But let us suppose they do cross-breed a human being and an ape. By the time he is in kindergarten, before he has learned to pledge allegiance to the American flag, he is hired by a professional football team to play fullback.

He quickly becomes a star. He goes for touchdowns after touchdowns. Nothing can stop him. He can do everything except sign an autograph. In mid-season romance blossoms and he marries a girl from Brooklyn. The happy fans give him a new motor car for a wedding present—and a suit from Brooks Brothers.

The mape never had it so good. But in the last game of the season, he gets tired of acting like a human being. It bores him. So he breaks the neck of the opposing tackle, throws the football over his own goal posts, takes off his shoes and runs into the stands and begins swinging hand-over-hand among the girders. Ah, he feels better. This is really living. It makes sense!

So he's fired from his job. The cops let him off—what cares what happens in a pro football game—but no other team will hire him.  
And three nights later his weeping wife phones her mama: "I can't do a thing with Mapey. He just hangs out all day at the corner fruit stand—smoking cigars, drinking gin, and throwing oranges at the neighbors."

"Come back to me, baby," says mama. "Your father never acted quite that bad."

So the mape is homeless. And he winds up at the Bowery, a bum, asking every passerby for the price of a banana.

No, let's don't push ourselves off on the apes. They deserve something better—to be left alone. That's all they ask. If people are going to marry apes, they should go into the jungle with them and live a simple, normal life—again.

## Washington Letter

WASHINGTON — Pretty Lydia Newbuck, 25, isn't exactly a cave woman, but she spends most of her time in caves. Lydia, who wears her dark brown hair, tied with ribbons in two swatches down her back, is a "spelunker." That means she is a member of the National Speleological Society, which makes a scientific study of caves and caverns. The society is affiliated with the American Association for the Advancement of Science.

Here recently for the "spelunkers'" seventh annual convention, the vivacious little brunette told me she began guiding people through the Natural Stone Bridge and Caves near her home at Pottersville, N.Y., when she was 4 1/2 years old. Six years ago her aging great-uncle Jim Van Benthuyzen, who owned the caves, turned them over to her. About three years ago, while she was a student at the New York State School of Home Economics and Agriculture, she visited the nearby commercially-operated Howe Caverns. She decided to make a paying career of taking tourists through her caves.

She studied business through correspondence courses; visited commercial caves all over the country, one year took a night course in geology. During the winter months she earned money to carry out her venture by various means as a governess for a wealthy New York family, working in the New York Public Library, selling magazines from door-to-door. In 1945 she worked for the late Hollywood character actress, Mme. Maria Ouspenskaya as a receptionist. She's gotten around quite a bit since the days she used to walk five miles to school and back, and baked doughnuts to sell the neighbors to help her through high school. She has just gotten back from a trip to Florida which she financed by lecturing on caves and showing color slides.

She looks more like a glamorous cover girl who might be at home in night clubs than the barefoot miss who lives most of the time in a cabin without electric lights, running water, or telephone.

Lydia intends to keep her caves natural, disdains cement walks and elevators such as many commercial caves boast. She charges her visitors 75 cents for an hour's trip. She put picnic tables and outdoor fireplaces on her 30-acre place and made a swimming hole, 60 feet long, 12 feet deep. She has no professional guides. Her 13-year-old sister Jenny, also a "spelunker," her cousin, and a nephew all help. When her brothers, David and Donald, whom she's helping through college, are home they pitch in with building projects. They built her a souvenir shop. Her Latvian-born mother keeps up the flower gardens.

# 'Most Unorganized' Annual Outing Staged Wednesday

## Men Get Away From It All In Pierce Fellowship Event At Moccasin River Camp

They had an all-day, all-male meeting on Moccasin River near Grifton this past Wednesday.

With no other qualification than that the majority of Pitt County residents will know what was going on in the southern end of the county, who was there and why. But for those who may not be informed—

The members of the John B. Pierce Fellowship were at it again. Just exactly what "it" was that they were "at" was not determined and, more, hasn't precisely been determined during the more than 25 years the organization has been having its meetings. And it isn't exactly an organization for it is probably the most unorganized group of its kind in this country. But the amazing thing about it is that this unorganized, integrated

group continues to meet once each year at the same place on the strength of a single notice sent the member through the mail. A post card inclosed in an envelope with the member's name bearing the words "(I will) (I won't) attend the John B. Pierce Fellowship this year" is all the person receives prior to the meeting.

It all began in the early twenties—original members think it was in 1924—when John B. Pierce of Ayden took a few friends with him to Peele's Seine Beach below Washington for an outing best described by the remaining old timers as "getting away from business." Twenty men made that first trip, little thinking it would be an annual affair. But the next year they went again for a day of relaxation and the event became a regular happening each year in May—at least

far enough along in the year for the weather to assure the group of a warm day.

Besides Pierce, the other 19 were Levi Pierce, John Harvey, Ben Manning, J. C. Gaskins, W. J. Boyd, Dr. G. Grady Dixon, Fred Worthington, Ed Matthews, Congressman Lindsay C. Warren, Henry Pierce, Blaney Sur-reil, Dr. W. W. Dawson, J. F. Harrington, C. R. Tyndall, George W. Prescott, George Worthington, J. H. Coward, J. R. Turnage and Herbert C. Bonner. They were the original business men who took a day off from their work for a little fun and relaxation. Only seven of the original 20 remain. Pierce died about 10 years ago. Those remaining are Dr. Dixon, Worthington, Matthews, Warren, Sumrell, Prescott and Bonner.

Through the years the few members were usually asked by their

wives and friends "Where are you going," and the only answer was "Off." And when the curious got too inquisitive, the members didn't see the percentage in making a secret of where they were going. The result, of course, was an increasing membership taking off from their homes once each year, only to return in the evening tired, a little sleepy, just a little worse for wear after the day's activities, yet just as certain they'd had a good time and would again next year.

Soon, Peele's Beach was closed and the fellowship group was wanting for a place to hold the annual meeting. Then it was that Raymond Turnage donated his camp on Big Contentnea Creek to the group and its goings-on. Happily enough, Turnage had named his place "Camp Contentment," certainly no misnomer for what happened there the first year the members initiated it and in the years following through Wednesday of this week. For what began as a small group of businessmen and friends, "getting away from it all," has now grown into a 150-odd roster of names representing every part of Pitt County and its fringes, still getting away from it all—and into a full day of eating, talking, card playing and general down-East laissez faire.

It's supposedly a non-political organization. That is the way it began 26 years ago. But it is non-political only insofar as the group does not actively support any particular candidate. However, it doesn't follow that politics are not talked up down and sideways at the meetings. There are groups talking politics under each tree, regardless of who the candidate is or what the issues are. And a candidate for any political office in Pitt County had best come along to the meeting each year. He may not pull down any more votes by attending, but his presence is at least made known, and it won't hurt him to have members of this representative group report to their neighbors at home that such-and-such a candidate was there.

During this past meeting, coming on the eve of the Democratic Primary, there were more politics discussed by the 150-odd persons present than one could shake a used-ballot at. And the present hot county race for commissioners and sheriff didn't hold sway over the Senatorial race, either. One group was off to one side listening to one of the prospective Senator's interview with a Raleigh commentator over the car radio. But, as one spokesman for the group stated, regardless of how many candidates are present and how much talking and back-slapping they do, there is not much gained by it. For most of the group have already made up their minds for whom they'll vote.

Perhaps the "political" atmosphere of the organization came about because of the location of Camp Contentment. The stream which fronts the cabin is known as either Big Contentnea Creek or Moccasin river—either one will get you there when asking directions. The Moccasin River tag came about some years ago when a proposed government project for the creek was talked about. Washington, it seems, couldn't put federal funds into any project for a creek. So the name was changed to include the word river and the project was carried out. Political in its aspect or not, Contentnea Creek-Moccasin River has had its effect on the gathered fellowship group in its annual meeting.

### Just Follow the Dust

Two brick pillars flank the entrance to a dirt road which leads to the camp about a mile off the Ayden-Grifton road. If there is any doubt in a newcomer's mind just where the camp is, he can follow the dust. Where it settles is proof enough. There in a clearing of hardwood and pine is a white cabin just large enough to include two small rooms and a screened-in porch. The river flows in front and between it and the cabin are enough automobiles to haul half of the county's tobacco crop to market

And on three long tables on the bank above the water is enough barbecue, slaw, pickles and bread to give the United Nations' food division a shot in the arm. When the dinner bell is rung, all talk of things politic ceases and the meat eaters are at it as though they hadn't seen since the last meeting. It's a rare thing when some of the food is left over and, on the other hand, rarer still when the members don't come back asking for more.

There is refreshment too, of a diversified nature—lemonade for dinner and something a wee stronger before. There isn't too much of the latter in evidence. Some of the group embrace the bowl during the morning proceedings, but there usually isn't enough to continue in the afternoon. That may have been the practice during the years of low membership but the group has become unwieldy of late and the expense of supplying the grapes has mounted.

Who pays for all this? The members do now but such was not the case a few years ago. When the membership numbered less than 100, the different communities in Pitt took on the burden of buying all the food and other miscellaneous items. During the early forties the meetings became the talk of the county, so much so that friends of the members wanted to attend, too. So at 1948's meeting the group decided each person should share in the expense, at least to the extent of buying his own meal. As it is handled now each member, if he wants to come for the following year, contributes \$1.50 for his next year's meal and that is the only invitation he needs. From the slips of paper which designate which ones paid for the following year is drawn up a list of names by the secretary to be sent to the members in good standing. That is the only way the group knows which ones are in good standing and who will be there next year.

When this method of financing the fellowship was incorporated, officers were elected for the first time. Prior to that time the group had no organization, as was stated before. It just met once each year, more or less haphazardly, and a program of event during the day was mapped out when the first ones arrived on the scene. Now things are different, at least as far as the executive department is concerned. Matt Long, of Greenville, was elected in 1948 to become the fellowship's first president. Greenville had been host at that year's gathering and it was decided to re-arrange the finance method. There was no talk that a pay-as-you-go method was better than deficit financing—they just decided cash on the barrelhead was the easiest way out.

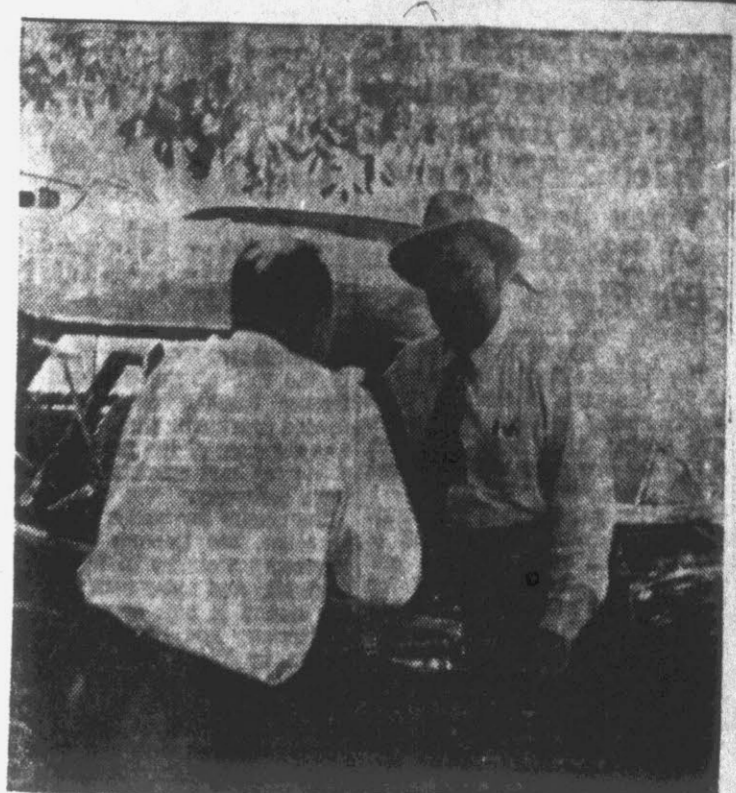
This year's officers, as elected at 1949's meeting were Harry Stillman, of Ayden, president; Dr. E. V. Tucker, of Grifton, vice president; and A. F. Rowe, of Ayden, secretary. George Prescott, of Ayden, one of the original members to attend the gatherings at Peele's Beach, has been unofficial historian for the group and will take time out to relate the various occurrences at meetings in past years. Although he has kept no record of what happened at each year's meeting, he can remember the general trend of events during the years. And that's what makes the gatherings unique—nobody knows exactly what has happened each year, or who attended (prior to the election of a secretary), or how many will be there next year. All they know is that there will certainly be a meeting and who will come depends on who pays this year. Unorganized and rather helter-skelter in its proceedings, still it is strongly banded together under the cloth of fellowship.

Officers for the 1951 meeting—and there will surely be one—are: Dr. Tucker, president; Z. Vance Bunting, Bethel, vice president; and Rowe, secretary. The election of officers this year came off quietly, which belied the hotly-contested political races extant in the county. There were three nominations and all were elected by acclamation.

The wives of members of this peripatetic group probably wonder just what their men do "down on the river." Suffice it to say that while their men are down at Camp Contentment, all is serene and all are in good hands and company. For one day they manage to blow off the accumulated steam stored up by business and jobs since their last vacation period. They meet their friends, and others not so familiar, and manage to get in enough whimsy to last them until the next year.

The wives may very well say to their estranged-for-a-day husbands, "If you have so much fun down there, why don't you take me along?" Well, ladies, don't ask that too often. Chances are you won't be asked to go along; but you just might be. Camp Contentment is no den of iniquity. Rather, it resembles a combination of civic and men's club. And, conversely, the only overhead, in addition to the cost of dinner, is the wide open sky above.

But it just isn't the place for ladies. You have your college class reunions, your book clubs, your strictly feminine gatherings, where a man would feel himself in alien surroundings. Let 'em go for one day to see what it's like. After that, however, there is just one rub. Once your husband attends his first meeting of the John B. Pierce Fellowship he's full-fledged member from then on. Keeping him away thereafter is next to impossible.

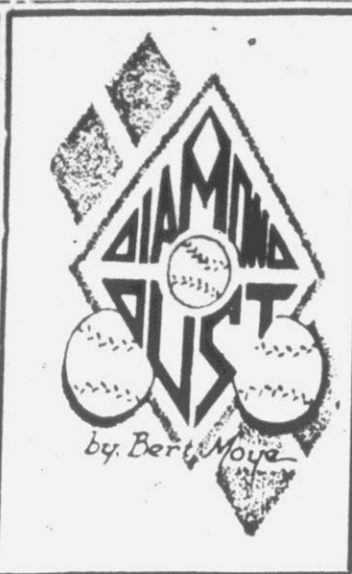

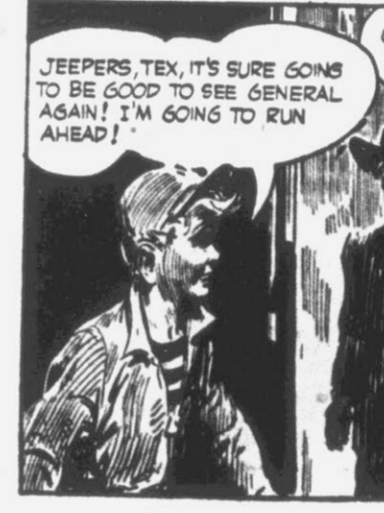

"We have warned them through the newspaper for years, but it's a regular thing for us to receive complaints from Negroes about somebody finding money on the street, offering to divide with a sucker, and then escaping with the loot," he added.

Chief Page said M. Coward, local Negro, reported to police that two Negro men approached him on the

street Thursday, stated that they had found \$500, and then suggested that he pool what money he had with them and the \$500, and agreed to allow Coward to hold the handkerchief containing the money until they could divide it equally. Coward told police that they were to meet later. In the meantime he went to a laundry to get some clothing, and that when he opened the handkerchief it contained a wad of paper.

Coward "chipped in" \$40, he said. He was unable to describe the filmmakers to the police.

### Violence Eases At Enka Plant

Morristown, Tenn., May 27—(AP)—Most of the 35 State Highway patrolmen assigned to maintain order at the strikebound American Enka Corp. plant were withdrawn today as the plant closed for the week end.

A dwelling near the plant was stoned last night, capping two days of stoning and egging, highway patrolmen reported. But strife in the strike shifted to the courts.

Five members of the striking CIO Textile Workers were accused by police yesterday of violating an anti-violence injunction.

And the union sought \$500,000 damages from Enka Corporation and public officials, claiming violations of civil rights through injunctions and law enforcement.

A house near the plant, and owned by the company, was stoned, Patrol Sgt. Carl Gilbert reported. The stoning occurred after electrical wires leading from the dwelling's lines to a strikers' tent near the plant entrance were cut, he said. The strikers were using the current to operate a public address system to "pep up" strikers and pickets, Gilbert explained. No one was hurt in the incident, he said.

### Over 100 Attend Demonstrations

Over 100 Pitt sweet potato farmers witnessed two transplanting demonstrations on county farms yesterday morning and afternoon. Conducted by Jesse Sumner, sweet potato specialist for Pitt, Martin and Edgecombe Counties, with equipment of three Greenville companies, the demonstrations sought to prove to the farmers that planting on high ridges was beneficial financially when marketing the product.

Three types of transplanters were used in the demonstrations held on A. D. McArthur's farm, Bell Arthur, in the morning, and Andrew Taylor's farm, Bethel, in the afternoon. Thirty-two farmers were present in the morning and 75 in the afternoon.

Sumner pointed out the advantages of the three types of transplanters. The purpose of each one should be considered by the farmer, he said, as to how he can best adapt the transplanter to his particular planting conditions.

Yams should be transplanted in high ridges, Sumner said, rather than on level ground so that they can grow in a tight bunch rather than spread out. In this way, digging is effected easier and the potatoes are not bruised in the digging process, thus bringing a higher price on the market.

Persons at the scene of the crash reported the car occupied by the two Negroes got in front of Payne's patrol car as he was chasing someone toward Greensboro.

Payne was found partially under the dashboard of his wrecked vehicle.
