U.S. Ready To Take Part In Five-Power Peace Meeting

Dulles Announces Willingness, But Warns Of Complexities And That America Will Insist On Agreements Based On Justice

Lake Success, Oct. 20—(AP)—The United States announced today it was prepared to take part in a five-power meeting on problems threatening world peace.

This announcement was made in the U. N. assembly's political committee by John Foster Dulles, Republican policy advisor to the State Department. He warned, however, against underestimating the complexities of the problems involved and said the United States would insist on agreements based on justice.

Dulles backed the objectives of a Syrian-Iraqi resolution calling for big power consultations. The five major nations would report back to the current session of the General Assembly any progress achieved.

One stumbling block to the whole proposal revolves around whether the Chinese Communists or the Nationalists would represent China in such big five talks.

Russia has insisted that the Chinese Nationalists have no right in the U. N. and their place should be given to the representatives of the Red Peking regime. The United States has resisted any change in China's representation. The whole issue still is pending before this General Assembly session.

Yugoslavia asked whether Iraq and Syria would accept an amendment specifying that the Chinese Communists would participate in the big five talks.

Originally the Syrian-Iraqi proposal called for meetings between representatives of the United States, Britain, France and Russia leaving out any mention of China. China was included in a revised draft brought in by the sponsors shortly before the committee convened this morning. The reference was to the five permanent members of the Security Council, however, and not to a specific Chinese regime.

Dulles pointed out that in the years since the war the major powers have held thousands of meetings and often have had difficulty even in reaching agreement on an agenda. He declared:

"We do not despair, and we accept the principles of this resolution. Whenever there are possibilities of agreement we are prepared to explore them to the utmost."

He said the door was open but added: "I can't say I entertain great hopes from the conversations, but one can never tell."

Inquest Set For Tuesday Night In Crash Death

An inquest into the highway death of a young Edgemoor county man who was killed on the Falkland highway in a highway accident recently will be held Tuesday night in the Pitt County Court House, Coroner Griffin H. Rouse reported today.

The man, Billy Forbes, age 24 of Crisp, died of injuries early Saturday morning, Oct. 7, sustained in a collision several hours earlier. He died of head injuries.

Forbes was a passenger in a car operated by William Waters, age 37 of Pinetops which collided with a truck driven by James Robert Garris of Greenville.

Postponement of the inquest, which was set for the following Tuesday, came about when one of the drivers was stricken with illness and was unable to attend the inquest.

Time of the inquest has been set at seven-thirty, October 24.

M. G. James Is Sworn As New Associate Justice

Governor's Surprise Appointee Poses Big Question

Raleigh, Oct. 20—(AP)—Murray G. James, Governor Scott's surprise appointee, was sworn in today as an associate justice of the State Supreme Court.

Members of the court and state officials gathered in the governor's office to see James take the oath of office to fill a vacancy left by the death of Associate Justice A. A. F. Seawell.

Associate Justice W. A. Devin administered the oath to James who will serve until his successor is chosen in the Nov. 7 general election.

Governor Scott has expressed the hope that James will be nominated to succeed himself at a meeting of the state Democratic executive committee here tomorrow morning.

However, the big question in political circles here today was whether the committee would follow the governor's wishes.

Governor Scott unexpectedly named James—an unknown in statewide political circles—to the high court last night. So surprising was the announcement that even the governor's private secretary, John Marshall, and State Democratic Committee Chairman Everett Jordan admitted they were caught off balance.

Over 7,000 Red Prisoners Taken In Single Day

Washington, Oct. 20—(AP)—The Army reported today that United Nations forces took more than 7,000 prisoners in Korea yesterday—the largest bag for any 24 hours since the conflict began.

A spokesman told reporters that 5,900 prisoners were taken by the U. S. 24th Division alone.

He also said that roads leading north and northwest of Pyongyang, the North Korean capital, are reported choked with vehicles and North Korean troops.

The landings made by United Nations paratroopers will block the main escape routes, he said, and this situation should give the United Nations Air Force a Field Day.

Suggestions And Requests Considered By Merchants

A request for more parking space in the vicinity of Hotel Proctor for use by overnight patrons headed the recommendations made by the directors of the Merchants Association at last night's meeting.

The directors turned down a request by the American Legion Post to ask the merchants to close their businesses around noontime Armistice Day. The directors voted to let each merchant act on the proposal in his own discretion. The Legion suggested closing hours to run from 10:45 to 12:30.

Other Likely Candidates For Post Look To Saturday

Raleigh, N.C., Oct. 20—(AP)—The stage was being set today for what may be a stormy session of the State Democratic Executive Committee here tomorrow.

The committee will assemble to elect a party nominee for Associate Justice of the State Supreme Court to fill a vacancy caused by the death of Associate Justice A. A. F. Seawell.

Those who are considered as likely candidates for the nomination include Attorney General Harry McMullan, Superior Court Judge Leo Carr of Burlington, former Superior Court Judge Jeff D. Johnson Jr. of Clinton, and Murray G. James of Wilmington whom Governor Scott appointed last night to fill the post until the Nov. 7 general election.

McMullan told newsmen that his friends were urging him to be a candidate for the nomination, but that he has not yet definitely decided.

Johnson, reached by telephone at his office in Clinton, said he was definitely a candidate for the post.

"I am advised," he said, "that my friends are working in my behalf for the position and that they will present my name before the committee tomorrow."

Willis Smith To Fight For Buggs Island Dam Funds

Tarboro, N. C., Oct. 20—(AP)—Willis Smith, Democratic nominee for U. S. Senator from North Carolina, said today he will fight for the federal appropriations necessary to complete the Buggs Island project.

The big dam will operate on the Roanoke river which flows through the heart of the second Congressional district.

Smith asserted at a second district Democratic rally here yesterday that "I heartily approve of what has been done at Buggs Island and I hope other funds can be appropriated to complete it."

City To Observe UN Day Oct. 24

Plans are being completed for the celebration of United Nations Day in Greenville next Tuesday in cooperation with the other cities and towns throughout the county.

Co-Chairman Jim White and Dave Wilchard of the Junior Chamber of Commerce committee which is working out plans for the celebration, said the event will be highlighted in Greenville by a formal ceremony on the court house lawn at noon Tuesday. There will be prayer services for the United Nations and world peace earlier Tuesday morning and the church bells of the city will be rung from 12 o'clock to 12:05.

A parade of the Greenville high school band and the East Carolina band will be held immediately before the ceremonies on the court house lawn. Detailed plans for the United Nations day celebration will be announced within the next two days, the committee chairman said.

Three Survived March Of Death To Red Capital

U.S. Prisoners Emerge From Hiding; Fate Of 280 Others Unknown

By TOM LAMBERT Pyongyang, Oct. 20—(AP)—Three American survivors said today, 280 U.S. prisoners of war were beaten and murdered on a Red death march from Seoul to Pyongyang, the captured Red capital.

The three said they saw no other Americans in Pyongyang, except those they marched with from Seoul. Swinging down Stalin Street—the Russian-named main street of Pyongyang—the bearded and long-haired captives were found by a group of correspondents as the prisoners marched arm in arm with three North Korean students who had befriended them. The Americans told of buddies being "beaten and murdered" on a torture march from Seoul.

The three American survivors of the death march were: Air Force Capt. William Locke, 30, Enfield, Ga., an F-51 pilot whose wife Ronda and nine-month-old daughter Karen were at Yokota Air Base in Japan when he crashed in North Korean territory near Waegwan Aug. 17.

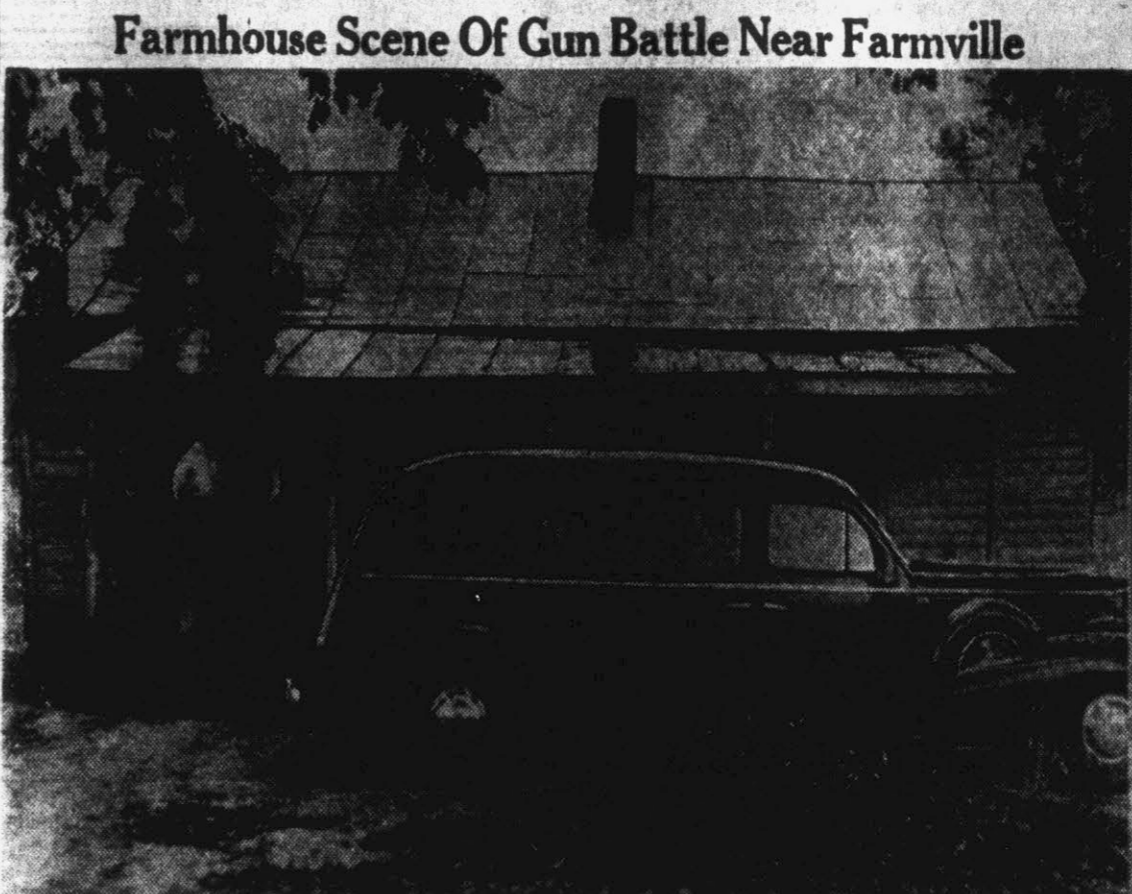
Army Lt. Alexander Makaroumis, 27, Lowell, Mass., of Company I, 29th Regiment, captured near Haidong, July 27.

Army Sgt. Takeshi Kumdat of Honolulu, Headquarters Company, 34th Regiment, 24th Division, captured July 20 when the Reds took Taejon.

They were found by a group of correspondents as they walked down the street arm in arm with three South Korean students.

Farmville's City Limits Extended

Long-Considered Move Given Approval By City Board

Farmville, Oct. 20—Farmville's Board of Commissioners has prepared for future expansion of its residential sections by extending the city limits in the northwest and northeast areas.

In the northwest section, the limits have been extended to take in six present residences on the old DeVisconti and Sheppard property in the vicinity of the country club. The other section includes expansion in the Davis subdivision. Three homes are under construction there at present.

Section A, in the northwest area, is expanded to run off North Main Street a short distance parallel to the old city limits to the country club. From there the limits run a quarter of a mile to highway 258, toward Fountain, crossing the highway and running along the east side of the East Carolina Railroad tracks, thence in a southerly direction to the present city limits. The finger of land is about 200 feet wide throughout.

The other section, known as Section B, runs down Grimmersburg

Inquest Set Tonight In Gun Duel Fatality

Second Man Trailed By Bloodhounds But Trail Lost; Policeman's Wounds Of A Slight Nature

By JOHN SPINKS JR. Farmville, Oct. 20—An inquest into the fatal shooting of Leslie Sylvester Spivey yesterday will be held tonight at 7:30—Coroner Griffin H. Rouse stated this morning.

Spivey, a 25-year-old Louisburg Negro, was fatally wounded yesterday morning when he opened fire on Policeman J. A. Gregory of the Farmville force.

The incident occurred close to noon yesterday in an abandoned farmhouse about four miles from here on the Walstonburg-Pountain road.

Meanwhile, another Negro who was hiding on the property when the shooting occurred escaped into the woods just after the incident. Chief L. T. Lucas was about to arrest the man when Spivey opened fire on Gregory.

Members of the police department and the sheriff's office tracked the unknown Negro with bloodhounds until late yesterday afternoon called a halt to the trail. Policeman Gregory stated this morning he did not think the Negro could be identified if seen again.

The shooting occurred just after Lucas and Gregory had investigated a routine wreck on the highway near the farmhouse. It was later determined that Spivey had stolen the car that was wrecked and had holed up in the farmhouse overnight. The car was stolen in Sims in Nash County Wednesday night.

The officers found a trunk full of clothes in a smokehouse behind the house. They are believed to have belonged to Spivey and the other Negro. A half-gallon jug of liquor was also found in the house.

Spivey's death marked the second time Gregory has killed a Negro in Cincinnati, Oct. 30—(AP)—Goodline of duty. The first fatal shooting occurred about three years ago when he killed a Negro after he had

Big Aerial Operation Virtually Unopposed; Seal Off Three Escape Routes 80 Miles South Of Manchuria; ROKs Ordered To March To Border

Tokyo, Oct. 20—(AP)—Thousands of American parachute troops leaped to the kill in Red North Korea today.

General MacArthur, who directed the spectacular aerial climax in a 15-hour on-the-spot flight, said on his return to Tokyo:

"The war is very definitely coming to an end today."

Less than 24 hours after United Nations troops seized the Red heart of North Korea—Pyongyang—the U.S. parachute battlers were writing the final pages of the U.N.'s historic first armed police action.

The aerial operation—80 miles south of the Manchurian border refuge for straggling Red remnants—was virtually unopposed.

The Americans sealed off two highway and two railroad escape routes.

Cruising over the area, General MacArthur puffed on his corn cob pipe and told correspondents: (the AP's Tokyo bureau chief, Russell Brines, accompanied MacArthur):

"Closing the trap should be the end of all organized resistance."

The parachute troops were moving—by that time—toward the towns of Surchon and Runchon, 25 miles north of Pyongyang.

"I don't see any opposition," he said. "It looks like it was a complete surprise."

This was the apparent climax of the historic United Nations campaign, born in blood with the June 25 Red invasion of the Korean Republic. The Soviet-satellite North Korean regime had fled.

Red Premier Kim Il Sung and his government were believed to be either in far North Korea, Manchuria or Soviet Siberia. Some prisoners said he was in Incheon, 80 miles north of Pyongyang.

Before the parachute troops took off for combat General MacArthur landed in Pyongyang at an airbase in the center of the city.

He ordered Lt. Gen. Walton H. Walker, the American Eighth Army commander, to send South Korean troops to the Manchurian border as fast as they can move.

Staff officers said conclusion of the organized fighting would be followed by an extensive mopping up campaign which will continue until all evidence of resistance is gone.

American troops will remain in Korea until that time. But apparently neither they nor British Commonwealth soldiers will go that far.

The Red capital was practically secure. U. S. First Cavalry division troops and South Koreans had only a mopping-up job in the bomb-blackened city of 700,000.

MacArthur has indicated he will keep these troops short of the politically explosive Manchurian and Siberian boundaries.

South Korean forces will operate there, he has indicated, wherever resistance may crop up.

The big paratrooper jump started at 2 p.m. (12 midnight EST), after a six hour delay because of bad weather.

The chutists landed without opposition, except for scattered mortar fire during the first half hour they were on the ground.

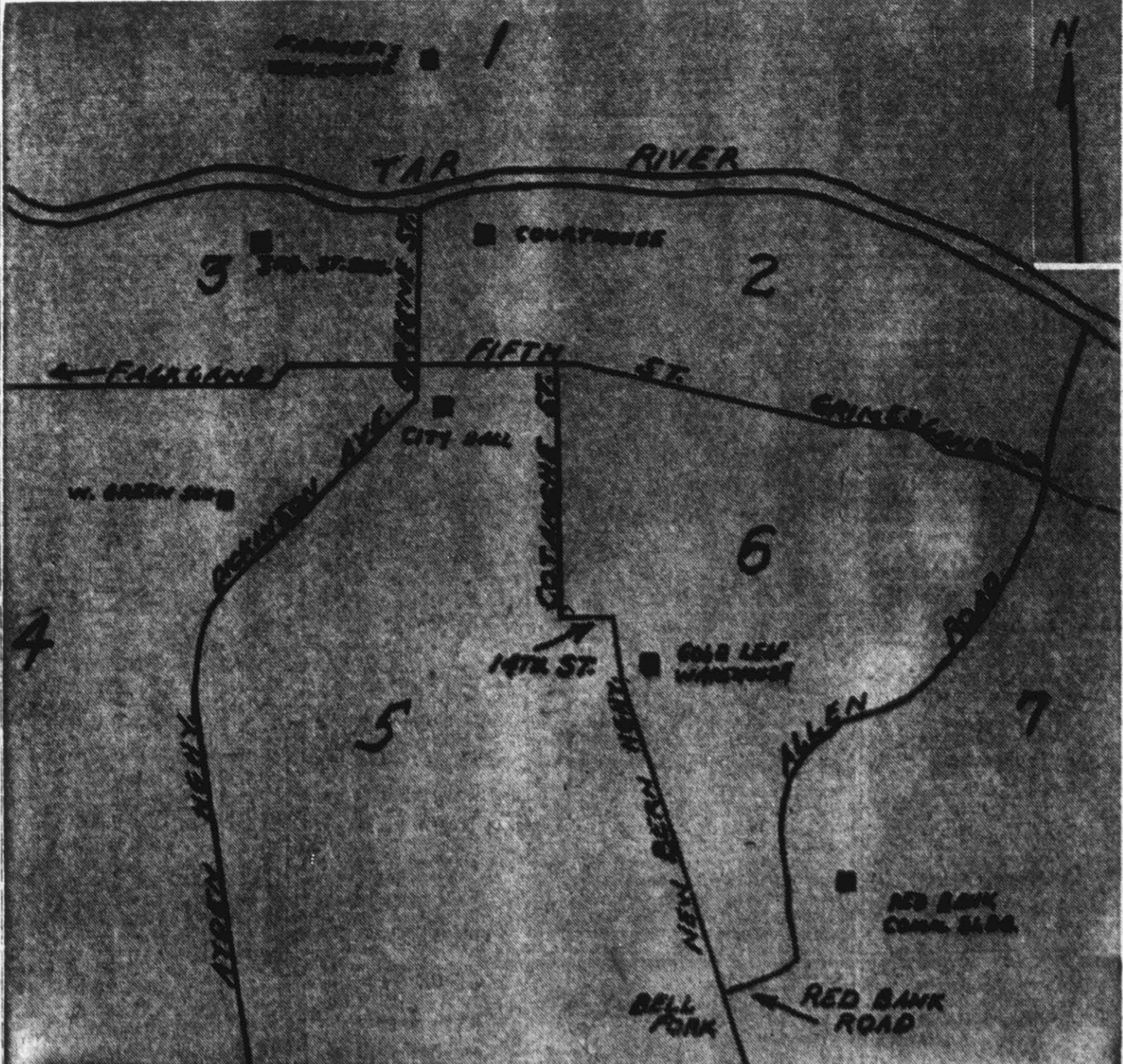
The Red mortars were silenced quickly.

American artillery, dropped by air in the first combat attack involving the parachuting of such equipment as heavy 105-mm. howitzers, opened up on the Reds right away.

Precinct 1 includes all that area in the Township north of Far River. The registration and polling place is Farmers (Tripp's) Warehouse. The other six precincts have their voting places at the indicated spots. Note there is no Township boundary on the map. Precincts No. 1, 3, 4, 5 and 7 include all the area to their respective Township boundaries. The new registration is for persons living in Greenville Township only. They may register either tomorrow and next Saturday or at any time during the week at the registrars' homes. Registration time at the polling places is from 9 a. m. to sunset.

Building For Peace

United Nations' Plan Represents Most Powerful Organized Peace Move Ever Made; Fight Against War Began Half A Century Ago, And We May Be Seeing Its Fruit

The United Nations' adoption of the plan to halt aggression anywhere and everywhere by force if necessary, represents the most powerful organized peace move ever made.

It tacitly recognizes that until human nature is changed mankind is going to resort to war at times, and be restrained.

In effect it acknowledges that there will be occasions when only force, or a display of force, can turn the trick.

This far-reaching project is given teeth by a provision requiring that U. N. members place specified units of their armed forces at the disposal of the peace organization to meet crisis. It represents a perpetuation of the emergency measure under which the U. N. was able to send its own forces into Korea to end the aggression from the North.

True, the program still has to go through the formality of being passed by the General Assembly. However, the big majority by which it was adopted in the Assembly's political committee ensures its passage in the larger body.

It's just over 50 years ago that

the world saw the first meeting of nations ever assembled to discuss ways and means of maintaining peace. That was in 1899 when 26 countries met at the Hague and adopted a "convention for the Pacific settlement of international disputes."

This was followed in 1907 by the "second peace conference," when 44 states—representing virtually all the independent nations of the globe—reaffirmed the convention and added to it. The convention provided for mediation, arbitration, and international commissions of inquiry into situations likely to lead to war.

The next step—and it was a seven league stride—was the creation of the League of Nations at the end of World War I. That did some good work—but it failed in the great emergencies because it lacked the forceful action against aggressors.

In an effort to bolster the League the League of Nations was forced in 1925, with the primary idea of preventing any further German-French

Helping Our Friends

Why The United States Is Spending Vast Sums To Strengthen Friendly Governments, Peoples; Inexpensive For Russia To Gain Same Ends; Two Questions

Washington, Oct. 20—(AP)—It's all free apple-pie for the Russians when a non-Communist country begins to totter.

The more it totters, the easier it is for the local Communists to take over. And, when they do, they seize property and industry, set up their kind of business, and hitch their country to the Moscow wagon.

None of the overthrow could cost Russia much, except perhaps pay for the local Communist leaders and cash for bribes and propaganda. So for little of nothing, Russia gets a new ally and satellite.

It works the other way around for the United States, which also needs allies. The U. S. can't get by with apple pie. It has to put out cash and plenty of it to win allies and keep them out of Russia's camp.

Although a tottering country is a potential victim of Communism, the U. S. can't go in and take over. It's committed to a policy of helping other nations remain independent.

But in this age, when poverty and distress give the Communists their best chance, a nation can remain independent only so long as it has some kind of prosperity or, at least

some hope of it.

So it is to the interest of the U. S. which wants to stop Communism and needs allies, to help distressed nations. That means pumping in cash. It's been doing that, by the billions, and will have to do more.

hat brings up some nice questions: 1 How long can the U. S. stand the drain of pouring our billions without wrecking itself, which is just what the Communists want?

2 But can the U. S. afford to take a chance on not pouring out the money, since it might mean losing a big part of the world to Communism?

At this moment the plans seem to call for pouring out the money for some time to come.

Just heaps of money alone won't solve the problem. There's also the question of where and how will the money be spent.

For instance, if the U. S. concentrated alone and gave Asiatic countries a drubbing, Asia might wind up in Moscow's pocket.

But the planners don't have a cinch. In fact, on their plans the

# Tomorrow's Gardens

The Committee on Horticulture of the Greenville Garden club wishes to call attention to a disease of camellias which is appearing in some southern states. It is called camellia petal blight and since it is exceedingly contagious it is a serious menace.

For your protection all nurseries are inspected by the Department of Agriculture of the state in which they are located and if approved are issued a certificate bearing a number. While a copy of this certificate is not on every plant it is on the shipment and any dealer offering plants for re-sale will gladly show the certificate or state his source of supply.

We urge every one to use the greatest care in buying new camellias to buy only from approved and certified sources. The disease is so serious that some nurseries have been quarantined and the possibility of quarantining in certain states has been discussed.

Many questions are asked about camellias and will be answered in future articles. If any disease seems to be attacking your plants and no one locally knows the trouble send a specimen to N. C. Dept. of Agriculture, Div. of Entomology, Raleigh, N. C.

# Max Tucker Talks Of His Venezuela Tobacco Farm

Max Tucker, formerly of Greenville, and now a tobacco farmer in Venezuela, spoke to students of Latin American history at East Carolina Teachers College Thursday morning of this week. Approximately fifty students taught by Professor E. C. Hollar of the department of social studies were present to hear Mr. Tucker's remarks on economic conditions in the South American country.

Mr. Tucker is a former student at East Carolina Teachers College, where he studied for two years, and a graduate of the University of North Carolina. Four years ago he went to Venezuela representing a tobacco company. He remained there as a tobacco farmer. With Charles

Hester of Roxboro he acquired a farm, and the two young men are making a success of their venture. Students at East Carolina heard Mr. Tucker discuss his experience as a South American farmer. His farm near Caracas has 125 acres planted in tobacco, he stated. Irrigation is necessary, and water is piped from a river which flows through the farm and supplies approximately 75 gallons per second, he said.

The country, Mr. Tucker stated, is rich and money is plentiful. Oil, iron ore, and other mineral deposits make up a large part of Venezuela's wealth, he said. Gasoline, he told his student audience, sells for from eight to ten cents a gallon.

It wasn't until they checked registration records that they learned James was seven instead of one!

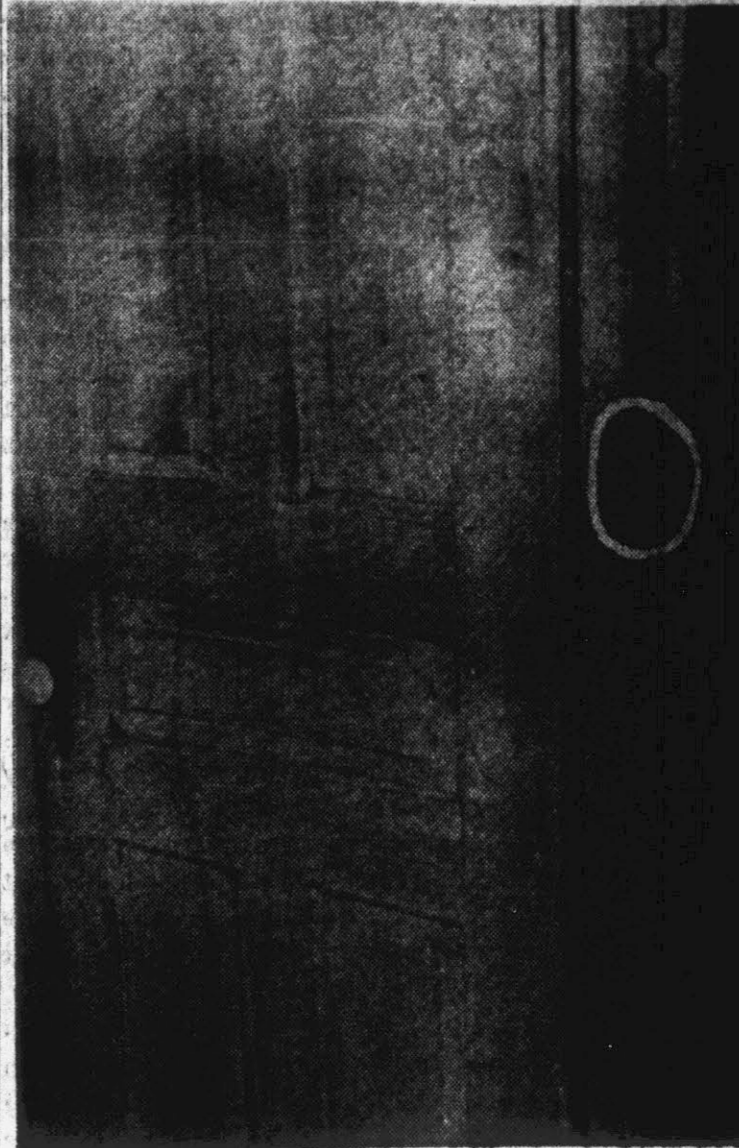

## It Is Now Up To The Committee

Governor Scott has done the surprising thing again in naming the new justice to the Supreme Court of North Carolina. But surprises have become just as much a part of Scott's administration as his outspoken manner.

It is now up to the Democratic Executive Committee to decide tomorrow whether they will allow Murray James of Wilmington, Scott's appointee to the Supreme Court bench, to carry the party colors to the polls on November 7. The leading contenders for the party nomination before Scott's surprise appointment last night were Attorney General Harry McMullan of Washington, Judge Jeff Johnson of Clinton, and Leo Carr. Although Governor Scott has not said definitely he will push James for the party nomination, it is to be expected that he will.

It is the responsibility of the party executive committee to name the candidate who is best qualified to fill the position on the Supreme Court bench. From our knowledge of the potential candidates, The Reflector favors the nomination of Harry McMullan. Unquestionably McMullan has done an outstanding job as attorney general of the state, and has time and again exhibited his knowledge of the law and ability to interpret it. His being from the first district adds another point in our favoring his nomination by the party.

When the committee members meet tomorrow, if they see fit to name Harry McMullan for the Supreme Court candidacy, we think it would be wise for them to also name a capable candidate for the post of attorney general in anticipation of McMullan's resignation. In that manner, North Carolina would be afforded a capable man to fill the position on the Supreme Court bench, and the naming of an attorney general would not be left to chance through a gubernatorial appointment.

News Behind The News

WASHINGTON, Oct. 20—While the American Medical Association is spending \$1,000,000 in its campaign to combat compulsory medical insurance on the grounds that it is part of a plot by Federal Security Administrator Oscar R. Ewing to foist "socialized medicine" on the country, the FSA is proceeding with what appears to be "socialized medical research." It's done with the authority of Congress.

And while President Truman has asked the executive branch of the government to reduce spending not essential to rearmament, the FSA is spending money for such things as "the isolation of specific granules from the cytoplasm of gland cells," "the development of insect cuticle," and "studies of the conjugated steroids."

GRANTS—The FSA spends money for these and other research projects through its Federal Health Service. Research projects are first scanned by the National Health Advisory Council, and those approved are submitted to Surgeon General Leonard Scheele for an okay. After his okay, grants are made by the FSA.

Last month, Mr. Ewing announced grants totaling \$4,708,766 for 155 search projects. The grants went to 144 medical schools, colleges and other institutions in 39 states, the District of Columbia and four foreign countries.

SAMPLING—For the study of granules from the cytoplasm of gland cells, Yale was given \$7,500 for researches planned by Sanford L. Paley; the study of insect cuticle got \$5,076 for the University of Minnesota for researches projected by A. Glenn Richards, and the stuff on conjugated steroids also brought Minnesota \$8,385 for work to be done by Saul L. Cohen.

A sampling of other grants includes: California Institute of Technology, \$9,504 for work on "transmethylation mechanism in animal tissues." Stanford, \$10,368 for research on "steroid metabolism in ankylosing spondylitis." Johns Hopkins University, \$3,499 to study "action of mutagenic agents on drosophila females." Harvard, \$7,002 for work on "standardization of pituitary gonadotropic hormones," and Columbia, \$15,444 for "age alterations affecting death rate."

There is also a grant of \$15,000 for maintaining a colony of monkeys in Puerto Rico for research purposes.

KIDNEY—One of the more dramatic projects is involved in a grant of \$6,588 to Georgetown University. This will finance plans of Dr. Harold Jaghers and Theodore Koppanyi, of Georgetown Hospital, to determine the value of an artificial kidney in preventing death from overdoses of sleeping pills.

The doctors will arrange with local police, hospitals and physicians to move in on suicidal and accidental cases and attach an artificial kidney.

Another grant of \$28,500 will finance Dr. Alfred H. Washburn, of the Child Research Council of Denver, in continuing studies of a selected group of 166 persons "from the prenatal period to death."

SIGNIFICANCE—Many, if not all, of these projects are worthy. Conceivably, these grants can lead to discoveries that will enable all of us to live longer, disease-free lives.

The complicated, Latinized terminology used in describing these ventures should not confuse them with bondfoggery. It may seem funny that the government is spending the money it takes from you in taxes for such things as "the metabolism of the vertebrate kidney, with special reference to the effects of posterior pituitary antidiuretic hormone on renal oxygen consumption" when the needs of rearming are so pressing. But levity may becloud the deeper significance: that the government has taken over control of a large part of medical research in the nation.

In the old days, medical research was largely financed by gifts and bequests of millionaires. But in the socialized state ahead there may be few millionaires and those who survive as such will find taxes reducing their ability to give.

UNITED — North Carolinians are being made conscious of the United Nations in much the same manner in which the consciousness of their forefathers was touched by the United States one hundred and sixty odd years ago. When the federal constitution was under consideration, North Carolina was one of the last states to ratify, because the people did not want to surrender state sovereignty. Americans generally, North Carolinians in particular, are slow now to accept the United Nations concept, because they do not want to surrender national sovereignty and autonomy.

PLAGS—No evidence of force or hurry has been discovered, but raising the United Nations flag at the state fair grounds Sunday and presentation of a UN flag to Governor Scott for the state capitol Wednesday, along with observance of United Nations day next Tuesday throughout the United States, combine to make Tarheels aware of the fact that United Nations is a functioning

governmental body.

IMPRESSIVE—These flag raising and presentation exercises have been impressive. Programs arranged for every community for next Tuesday carry on the significance of a world government, that in some respects will be bound to curtail individual autonomy of every participating national government. They keynote in all the exercises to date have stressed that as the United States flag more than a century and a half ago symbolized an ideal of freedom worth fighting for, the flag of the United Nations now symbolizes a lively hope of freedom and peace throughout the world.

PROTOCOL—Protocol governing use of the UN flag has not been fully worked out. It is to be flown at equal height with the stars and stripes, but to the left of our national flag. It takes precedence over state flags in position at public ceremonies, and so should be displayed between Old Glory and the State

flag—to the left of the United States banner, but to the right of the North Carolina flag.

PICTURES—Pictures have become as vital a part of the news as are the printed words on a newspaper page. Radio has taken over some of the prerogatives of the writing newsmen in coverage of all important events. That is why efforts have been made by reporters assigned to the capitol, particularly to the general assembly, to get facilities for camera and radio men as well as improved conditions for the writing boys and girls. These observations about importance of pictures are occasioned by two incidents of the past few days.

UNWILLING — Ed McMahan, utilities commissioner, jumped from his seat and caught a news photographer down the hall trying to grab a film which the cameraman had just "shot" of a public hearing in the utilities

"INVITED" ACCIDENTS (New Bern Sun-Journal)

Four out of every five so-called accidental deaths and injuries are not real accidents at all, but are "invited" or directly caused by people with death- and injury-producing habits. So says the Northwestern National Life Insurance Company which has made a study of accidents.

A new attack is getting underway on America's ghastly annual auto traffic toll of over 30,000 persons killed and nearly one and a half million injured. It is based on startling facts revealed by researchers into the attitudes and habits of the accident "repeater"

culprit, now recognized as the cause of most of our so-called accidents, says the study.

A United States government survey of Connecticut auto driving records showed that four per cent of the state's drivers had 36 per cent of the traffic accidents reported during a six-year period. More recent surveys in other states have established that between five and ten per cent of the drivers regularly contribute more than half of the total traffic accidents recorded in those states, the study says. British and American researchers going back through thirty years of casualties have demonstrated that

about 20 per cent of the population consistently have 80 per cent of all accidents of all kinds.

When the persons with the accident-producing habits are removed from any group of people, total accidents for the group nose-dive with startling suddenness, the study says. A large public utility concern employing several hundred truck drivers cuts its traffic accident rate 80 per cent by simply taking the drivers with the bad accident records off their trucks and transferring them to other jobs—where they continued to have accidents, but hurt themselves instead of killing and injuring other people with their trucks.

## Business Today

Inflation, by most definitions, is an increased ratio of buying tools—money and credit—to the supply of things purchasable. In normal times, the surest and quickest way to reduce inflation is to increase the amount of goods available.

In times such as these, the government has three tools with which to deal with inflation. They are credit controls, which reduce credit buying power; taxes, which reduce cash buying power, and price controls. The latter, it is often pointed out, do not cure inflation. Instead, they cure the effects, or at least postpone them.

The government is now trying credit controls. Consumer credit has been restricted, housing credit has been limited, and there are indications that bank credit will be shrunk by an increase in Federal Reserve requirements.

If credit controls don't halt inflation—and the rises in wages and profits may create cash spending power faster than credit controls dry up credit spending power—the government will have to try one or both of the other major weapons.

Controlling prices is a difficult, unwieldy and expensive proposition. Furthermore, as has been pointed out here, there are almost insurmountable difficulties in rolling prices back to the pre-Korean days, since wages have advanced so much since then. Furthermore, it may not be good politics to freeze wages and unless wages are frozen, it is impossible to freeze prices. Every cent of every price consists of wages, profits and taxes, and as long as wages and taxes are rising even elimination of profits entirely wouldn't bring prices of many articles back to pre-Korea levels.

So it looks as if it will be taxes. The Administration appears strong for this treatment. The statement chairman of the National Security Resources Board, is significant. He voiced the hope that price and wage controls could be avoided, but saw the necessity of more credit controls and higher taxes. Mr. Symington's views are usually cleared with the White House before release.

The tax rise, though, sure, is not imminent. After Administration recommendation, Congress will have to act. It will be under pressure from every group and bloc, not to keep taxes as they are, but to raise them on someone else. But this pressure may not be as strong as the pressure to do something about inflation. Curiously enough, one of the ways to bring down the price of butter is to leave people with less money to buy butter.

It is unlikely that taxes can be raised before the first of the year, and it seems more probable that Congress will let individuals get their current taxes paid before the March 15 deadline before con-

fronting them with higher withholding taxes. At present, a good guess would be that personal income taxes would advance as of next July 1, with corporation taxes going up earlier, perhaps as soon as January 1. But that's not a forecast; there are too many pressures and the war and economic picture is changing too fast to be sure of anything—except that taxes will eventually be higher.

**CHURCHILLISM IN REVERSE**  
Business has often damned governmental actions as being "too little and too late." Just now auto dealers, home builders, durable goods retailers and finance companies are complaining that current credit restrictions are "too much and too early."

**AS FAIR A SIGHT AS ANYONE'S SEEN**  
Nothing like a million dollars in cold cash to make eye pop. So at the All - Electrical Exposition opening in Los Angeles today, there will be \$1,000,000 on display. It represents the amount spent each week by the television industry for planning. It will be cold cash, all right. It will be displayed in a refrigerator. Guarded, of course.

**CHRISTMAS PAPER SUPPLIES ADEQUATE**  
There will be ample supplies of holiday wrapping paper and Christmas boxes this season, despite the crowding shortage of paper and boxes. Most of the holiday requirements have already been produced; the remainder will come along, all right, because it always commands premium prices. And there's little likelihood that any will be diverted for military requirements.

**CONSIDERATE — AND BUSINESS-BUILDING**  
Signs of the times: A Birmingham new car dealer requires salesman to phone every buyer three times in the first 30 days after purchasing an auto, to check on performance, to suggest care, and to recommend the dealer's service department.

**NEW AND HOT**  
BLINDS: A new plastic tape that can be wiped clean with a damp cloth, won't shrink or stretch and won't fade in the sun is being featured on Venetian blinds by Hunter Douglas Corp., 150 Broadway, N.Y.

**LOCK:** Installing fluorescent lamps is sometimes difficult. To remedy this there is a small device which guides the prongs in place and then serves as a lock to hold the lamp in place. (It is by Edison Electrical Co., 351 Weybosset St., Providence 3, R.I.)

Korea — (AP) — Let's tell the Army recruit right out loud that he's joining the Army to fight.

After we tell him that, let's assure him that if he lives long enough he'll also get an education, learn a trade and live a reasonably secure life with retirement guaranteed.

The Korean war has kicked in to the discard the fancy-pants promotional idea that the Army is an institution where the recruit gets everything but a fight.

This is a blossomed after World War II, as the best way to induce youths to join up. Picture posters showed well-fed soldiers traveling in comfort, lounging in a library reading good literature, or cheerfully learning a trade.

Now all those things are all right. They should be part of our Army. But the harsh fact is that the infantry exists solely to fight when a fight is necessary. It's pretty clear that in this world we now live in the American Army must be ready to go into battle on short notice. That means an infantry which is tough, well trained and able to take care of itself.

Everybody knows the American occupation army in Japan wasn't ready for the Korean war. It was soft, trained for occupation duty rather than combat.

The first Americans in battle faced a rough foe, trained on the battlefields of China and Manchuria. They weren't prepared even for the sounds of combat, which in themselves are terrifying to the green fighter.

Most of those youngsters had come into the Army because that promotional campaign promised everything except a fight. And when the fight did come it was a four-ris; show which cost many lives. The troops were not prepared for war, either physically or mentally.

I remember those early heart-breaking days of this campaign when our troops were in retreat. Always they were in retreat, then—fighting desperately for time, but always falling back.

But out of this heartbreak and agony was refined a new American army. The softness gave way to hardened skill. Bewilderment changed to battlefield cunning. The men learned to protect themselves . . . how to meet the enemy on equal terms.

Now they are the victors. These green divisions have captured the Red's own North Korean capital, Pyongyang. This is a battlewise army now. The men in the line know the tricks of the trade of fighting. They have a poise and an assurance that wasn't there two months ago.

They know that to be an infantryman means you have to fight. They have no illusions about their jobs, or what it means to be a soldier.

And I hope in the future no

other soldier has any illusions about his job. It will be a poor recruiting campaign which fails to impress upon him that there may be a foxhole in his life as well as an all-expensive tour to the far places of the world.

## Washington Letter

Washington—Uncle Sam maintains a fabulous \$90,000,000 a-year "department store."

In the Federal Supply Service's Washington center, some 40,000 samples are in stock, and they keep coming in at the rate of 200,000 a day from business houses all over the world.

These samples are tested. If the item is found good, and the government can afford it, the sample is retained and Uncle Sam orders volume lots.

When an item is accepted as the only item of its kind for a specific use, then a government purchasing agent from any agency must purchase that type for periods of from three months to a year, depending on the type involved.

If Uncle Sam wants to keep the item in stock and has run out of it after the stated period, he reopens the contract with the manufacturer and asks for up-to-date samples. Sometimes he makes suggestions as to how the item may be improved.

Every sample is tested to a fare-thee-well. If an item is found wanting in some respect, the sample is returned to the manufacturer.

I walked through a labyrinth of aisles crammed with everything you could think of. "You name it—we have it," said the young man showing me around.

There were croc' at sets for veterans hospitals, reformatories and prisons, as well as tennis racquets, golf clubs and soft ball sets. There were several different types of wheel chairs. Mattresses, modernistic mail sorting cases, electric clocks, fans, cages for the Institute of Public Health and government hospitals to keep guinea pigs, white rats and rabbits in.

There were floor sanders, card filing cases, waste baskets, a blasting device bought for the U. S. Army Engineers, lamps of all kinds, floor wax, beauty equipment, kayaks, fish traps, ladders to help salmon get over dams, inkwells, parachutes to drop supplies, boxes and books and books.

Expensive things like watches, thermometers, chronometers and such are kept in special lockers, but while the temptation to snatch an item here or there is great, seldom does the agency miss anything.

## Democratic Committee's Session To Make History

Raleigh, Oct. 20.—The meeting of the Democratic state executive committee scheduled to be held in the hall of the house of representatives Saturday morning at 11 o'clock may prove to be a very important occasion.

Purpose of the session is to nominate a candidate for associate justice of the supreme court for an unexpired term of the late Justice Seawell, who died last Saturday leaving more than two years of the term for which he was elected in 1944.

Doubt as to procedure in filling the vacancy was dispelled Wednesday morning when Chief Justice Stacy and the associate justices of the supreme court rendered an advisory opinion, to Governor Scott, to the effect that an election must be held.

Even before that opinion had been issued State Chairman Everett Jordan had prepared telegrams to all members of the state executive committee calling a special meeting for Saturday morning to nominate a candidate. The messages hit the wires within a few minutes after the governor's office released contents of the advisory opinion.

Action must be fast because of proximity of election day and physical limitations upon printing and distributing ballots. Raymond Maxwell, executive secretary of the state board of elections, also had anticipated the opinion and had arranged by telephone to have the state printers on the job, with paper and type composition—except name of the candidate—ready so that presses can start rolling within ten minutes after nomination is made. This will give time, but none to spare, to assure delivery of ballots to the 2,000 precincts before the polls open on November 7. Packaging and distributing two million ballots is not an easy task.

As this article is being written there is considerable doubt about who will get the nod from the Democrats, and whether Governor Scott will tender immediate appointment to that nominee—or if he will name someone immediately to serve until the election returns have been certified.

## Censors Hamper Reporting War

By SEYMOUR TOPPING

Saigon, Indochina, Oct. 19.—(AP)—French military censorship and denial of accurate information are preventing foreign correspondents from cabling factual, comprehensive accounts of the serious reverses being suffered by the French army in North Indochina.

Military authorities are refusing to furnish war correspondents with facilities normally accorded them. French army censors make deletions in dispatches without advising the sender. Correspondents have been advised by their home offices that some messages are arriving after delays of up to 72 hours, so badly cut as to be unintelligible.

Dispatches have been censored or subjected to long delays for reasons other than what is ordinarily considered military security. Messages have been tampered with on political questions affecting the French army.

American correspondents are being obstructed in their efforts to report fully on the Indochina crisis as the United States accelerates and expands its military aid program to this country. Their complaints have been registered with the American legation at Saigon.

## Czechs Turn Out Own Racing Cars

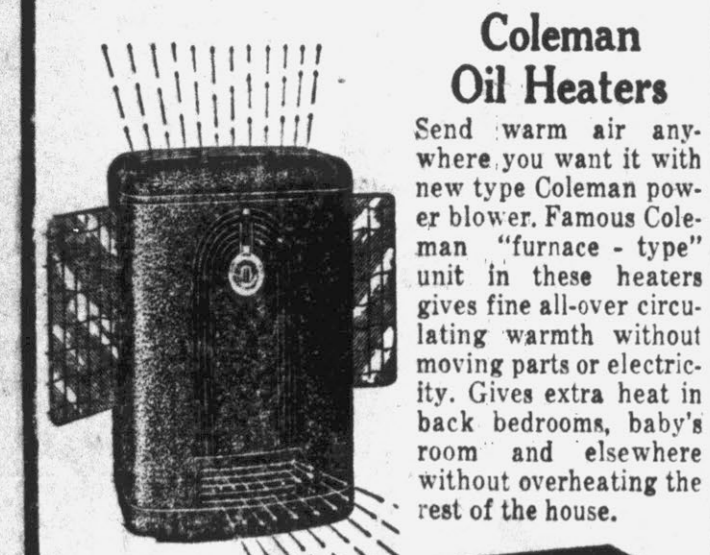
Prague—(AP)—Czechoslovakia, short of foreign racing automobiles for her expert drivers, has started making her own.

### How to Grow Through Prayer

JESUS TAUGHT US TO PRAY IN SECRET TO GOD, OUR FATHER.

Scripture—Matthew 6:5-15; Luke 11:1-13; Philippians 1:3-11; Colossians 4:2-4.

SOMEONE in World War II said, "There are no atheists in fox holes." When men are desperately in need of help, with no human near to give it, even the toughest and least believing is driven to call upon his Maker.

It is true also of those who never experienced the terrors of war, persecution or other dangers. When troubles come, nearly all of us resort to prayer. Why is it, then, that so many of us forget to pray daily? When the sun shines for us, we apparently forget God—using our Father in Heaven as a last resort when disaster strikes.

We wouldn't treat a human friend that way, would we? Why, then, do we act so to God? At the beginning of Jesus' mission, He taught His disciples how they should pray, and His words were intended for all Christians everywhere. His words on this subject occur in the Sermon on the Mount.

"And when thou prayest, thou shalt not be as the hypocrites are: for they love to pray standing in the synagogues and on

bread." Just as simply and naturally as that—even asking that we may have food to sustain our bodies while we are on earth.

"Forgive us our debts as we forgive our debtors." Can we indeed forgive those who hurt us? If not, why should we expect God to forgive us our sins?

Jesus told a parable then about a man who had unexpected guests. He went to a friend's house—although it was midnight—and knocked.

The friend answered, but when the man said he wanted bread, the friend said all his household were in bed for the night, and he couldn't supply the need. The man knocked again and again, and his friend rose up and gave him what he asked for.

"And I say unto you," said Jesus, "ask, and it shall be given you; seek, and ye shall find; knock, and it shall be opened unto you."

If a child asked his human father for bread, would the father give him instead a stone? If he asked for fish, would he give the child a serpent?

Are there such people in the world today? They get their reward, as Jesus said. People tell them how beautiful their prayers are, but are such prayers likely to be heard and answered as are those which are the outpourings of a soul asking help to live as our Father wishes us to live, or to receive strength to bear some great sorrow?

"But thou, when thou prayest, enter into thy closet, and when thou hast shut thy door, pray to thy Father which is in secret; and thy Father which seeth in secret shall reward thee openly."

Then the Lord told them how to pray, simply, reverently, to the Father of us all:

"Our Father which art in heaven, Hallowed be Thy name. Thy kingdom come. Thy will be done in earth, as it is in heaven."

"Give us this day our daily bread."

"If ye then, being evil, know how to give good gifts unto your children: how much more shall your heavenly Father give the Holy Spirit to them that ask Him?"

We need not always be asking our heavenly Father for help in our prayers. We can thank Him for all our mercies—for the kindness of people we meet and for our friends; for the beautiful world we live in, for the goodness of human beings, the majority, in spite of the hard-heartedness of many, and the terrible cruelties from which the world has suffered these many years.

God is good, and His goodness is manifest in many, many ways in the everyday life of all peoples. Paul, in spite of imprisonment and almost certain martyrdom, thanked God in his letters to his friends and fellow Christians in the churches which he and others had established.

"I thank God upon every remembrance of you," he wrote to the church at Philippi. "Always in every prayer of mine for you all making request with joy."

"Being confident of this very thing, that he which hath begun a good work in you will perform it until the day of Jesus Christ."

**Baruch Calls For  
 All-Out Defense  
 Economic Curbs**

Rochester, Minn., Oct. 20—(AP)—Bernard M. Baruch says he favors an all-out military preparedness program for the next two years, hedged with stern measures on the home front to combat inflation.

"Korea is no final arena of decision," the 80-year-old financier and adviser to several presidents declared. "We must now always be prepared for war. At the same time we cannot permit ourselves to be gutted by the inflationary potentialities of our preparations."

Baruch delivered the Plummer-Judd Memorial lecture here last night before the annual meeting of the Mayo (medical) Foundation.

Necessary to insure peace, he said, are these six steps:

All out mobilization for the next two years "until we have balanced Russian's rearming; creation of a single, temporary, independent mobilization agency, reporting directly to the President; a thorough-going priority system; an appeal board to adjust unfair hardships; a general ceiling over all prices, wages, rents and fees, and a tax scheme heavy enough to pay full defense costs while eliminating profiteering."

Baruch said action affecting every segment of society must be taken to combat inflation.

"Will it," he asked his audience of 1,500, "be the national interest or the selfish interest which is to prevail? That is the test of mobilization, of inflation, of democracy—of survival."

"Now the nation is falling in that test. Various pressure groups are clamoring 'give me mine' and the government has encouraged this selfish race by not taking the action necessary to stop it."

"That is why I am so impatient with those who, while admitting all this, went to arm slowly—a little this year, a little more next, and so on for perhaps five years, perhaps longer. This limping approach to mobilization encourages new Soviet adventures."

**Poetess Millay  
 Dies In New York**

Austerlitz, N. Y., Oct. 20—(AP)—Poetess Edna St. Vincent Millay, who once wrote of death that she would not "give him a leg-up," is dead.

She died alone, as she had lived since the death of her husband, Eugen Jan Bossevain, about a year ago.

Miss Millay, 58, apparently suffered a heart attack early yesterday, her doctor said, after she had worked all night editing proofs of some new poems. Her body was found in the afternoon at the foot of the stairway in her big white house on East Hill.

Dr. Oscar Wilcox said she probably had started upstairs to bed and fell as pain struck. She had been dead about eight hours when her body was discovered by caretaker James Pinnie. The body was moved to a funeral home in Chatham, near this Berkshire Hill community.

A Pulitzer prize winner, Miss Millay scribbled her poems in cheap notebooks and sometimes had difficulty reading her own handwriting later. She frequently worked all night composing the sonnets and often lines that gained her fame.

A sign at the gate of her home has warned off casual callers for years. "No admittance except by appointment," it reads.

Miss Millay penned one of her best-known poems, "Renascence," at the age of 19, while still a school girl in New England. It reads (in part):

"I would I were alive again  
 "To kiss the fingers of the rain,  
 "To drink into my eyes the shine  
 "Of every slanting silver line,  
 "To catch the freshened, fragrant breeze  
 "From drenched and dripping apple trees."

Stunned policemen were puzzled about what to do. The three youngsters cannot be arrested. Maryland law holds a child is not responsible for criminal acts until he is seven years old. The case was put up to the State's attorney's office.

Sgt. Elmer Bowen pieced together this story.

Mrs. Ernestine Carmichael left her infant son asleep in his crib about 6 p. m. and slipped out to the store. Three little neighbor boys were playing in her back yard.

The boys sneaked into the house and into the baby's room. The baby began to cry.

One boy, six, picked up a nursing bottle and bashed the baby in the face. The other six-year-old hit the baby in the face with his fist.

The third boy, five, lifted the baby from the crib by the arms and swung it around and around. He lost his grip and the baby dropped to the concrete floor, on its head.

The boys picked up the baby and tossed it back in the crib.

Mrs. Carmichael returned in 15 minutes to find her son bleeding from the head. She swept him up in her arms, ran into the street, hailed a cab, and took him to a hospital. He died there three hours later.

# Justice Dept. Outlines Rules For Anti-Subversives' Control

Washington, Oct. 20.—(AP)—Rules for forcing registration of Communist groups were officially laid down today by the Department of Justice.

Their application appeared certain to touch off a series of hearings and heated legal actions, with actual registration delayed for years.

Under the new anti-subversive law, Communist organizations have until Monday to sign up voluntarily. After that, registration by force is called for.

But this cannot be done until President Truman names the five-man bi-partisan subversive activities control board set up in the act. The Communist party has said it does not intend to register and supply its roll of members, estimated by the FBI to number about 54,000. And Communist "action" and "front" groups have shown no signs of compliance.

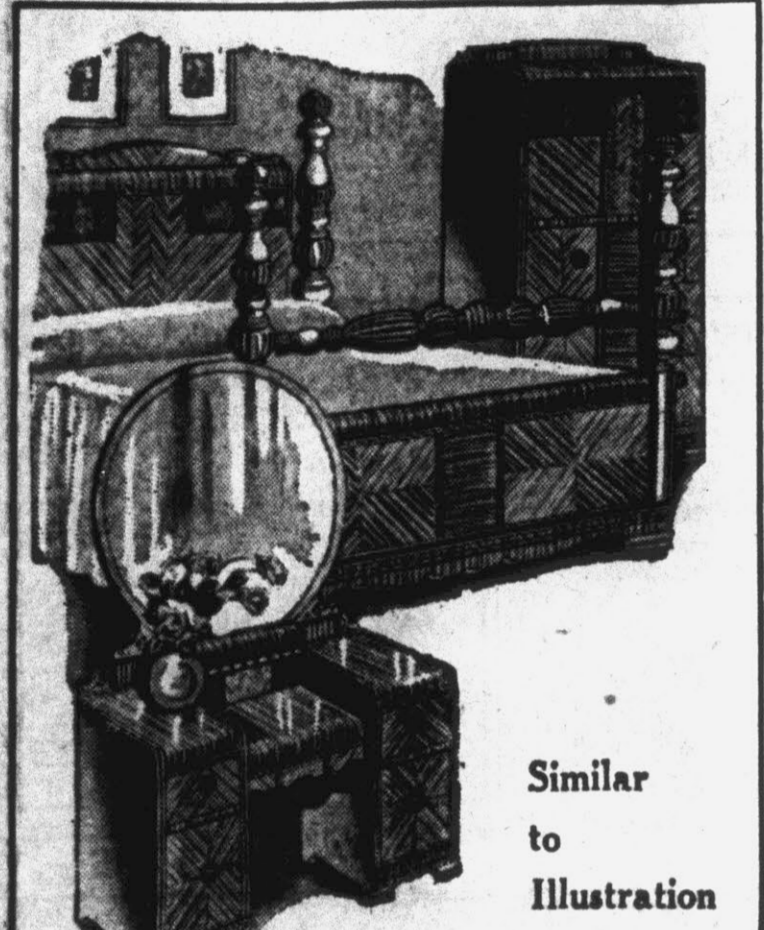
This leaves it up to the attorney general to certify to the board that such-and-such groups regarded by him as Communist have failed to comply with the law.

### Police Car Gone

Farmville, Oct. 20.—Wanted: One police car, License 348857. A car belonging to Policeman J. A. Gregory was stolen last Friday night from in front of the police station. Gregory stated he had just parked the car, taken the keys out of it, and gone into the station.

In view of this, some officials estimate it may take two years to get the party actually registered.

### Drivers Cleared Of Road Deaths

A Pitt county coroner's jury at a session held in the Pitt county Court House Tuesday night, cleared of any blame, drivers involved in two recent highway fatalities, which took the lives of two pedestrians.

The jury ruled that both George Buck and Joe Stancil came to their death by unavoidable accidents over the past weekend and that no charges be brought against the drivers.

### Oil Truck Turns Over On Highway

Another highway accident was reported by the Greenville Highway Patrol office this morning when an oil truck from Greenville turned over near Falkland.

Patrolman Paul G. Whitley, investigating officer, stated that a truck driven by Thomas M. Hazelton, Negro, of 1411 Railroad Street, Greenville, turned over just outside of Falkland about 10:00 this morning when the driver applied his brakes on wet road causing his truck to turn over. Whitley said that Hazelton told him he was going about 15-20 miles an hour at the time of the accident. Several witnesses verified his story. Whitley listed a combination of slick tires on the truck, wet pavement and falling rain as the cause for the accident.

The truck, which belonged to the Quality Eastern Oil Company of Greenville, was damaged to the extent of about \$100. The driver was not injured.

Still another report of an accident last night was made at the local patrol office but investigation of the accident has not been completed as yet. The accident was reported to have occurred near Bethel.

Thus the toll for the month of highway accidents in the Pitt County area has gone up to 21, with three persons killed and several others injured.

The heaviest docket of the year confronted Judge J. W. H. Roberts and Solicitor Ed Bloom at today's session of Police Court. More than fifty cases were docketed for trial. Numerous cases were continued on request of attorneys.

Hearing of motor vehicle traffic violations, especially collisions, consumed most of the forenoon session of court. Numerous important cases were on the docket for trial.

The case that featured the morning session was the trial of Carrie Williams, 30-year-old Negro woman, charged with assaulting Delphia Moore, Negro, with deadly weapon—a foot high statue of Edgar Bergen's Charley McCarthy. The assault occurred at 446 West Third street. It was testified that the woman had served five years at the insane asylum in Goldsboro. The court gave her one year in State Prison.

The three were the only survivors of a group of 263 American prisoners of war marched here from Seoul in late September and early October.

The three Americans had hidden under a school and had been fed by the three students.

They came out today as the city fell to American and South Korean troops.

The trio said the Red Koreans told them they were being moved from Seoul to Pyongyang for "safety."

Captain Locke said he pleaded with North Korean officials not to move the men and to give medical attention to the wounded.

The airman said the North Koreans replied:

"We already got enough atrocities listed against us so a few more won't make any difference."

Captain Locke said that during the death march Americans "died like flies from starvation, cold, pneumonia, and dysentery."

future of the world seems to depend.

Meanwhile, in addition to the billions to be spent in economic aid, the U. S. plans to spend vast billions on arming itself and its allies.

The Russians, of course, have to spend a lot of their money on arms, too. So in that way, at least, there's a drain on them.

In western Europe alone so far this country has spent \$9,528,990,000 through the Marshall plan—ECA, the economic cooperation administration—which is the economic help for Europe.

In Asia, with its many hundreds of millions of people, in much poorer economic shape than the Europeans

and in danger of being overrun by Communism, this country, through ECA, has spent for less: \$618,775,000; Korea (\$130,000,000); China, before the Communists took over, and later Formosa \$106,704,000; Indonesia (\$1,987,000) Indonesia \$669,000 and Thailand (\$678,000.)

For the fiscal year which began last July 1 and ends next June 30, Congress voted ECA another \$9,000,000 to spend around the world. Of that sum about \$185,000,000 is being set aside for the Asiatic countries just mentioned. But Korea will surely get special help.

Now the U. S. is going to give another kind of help through the point four program. Under that one the U. S. will give technical help—send to backward countries experts in various

problems such as farming, malaria control, health services, and so on.

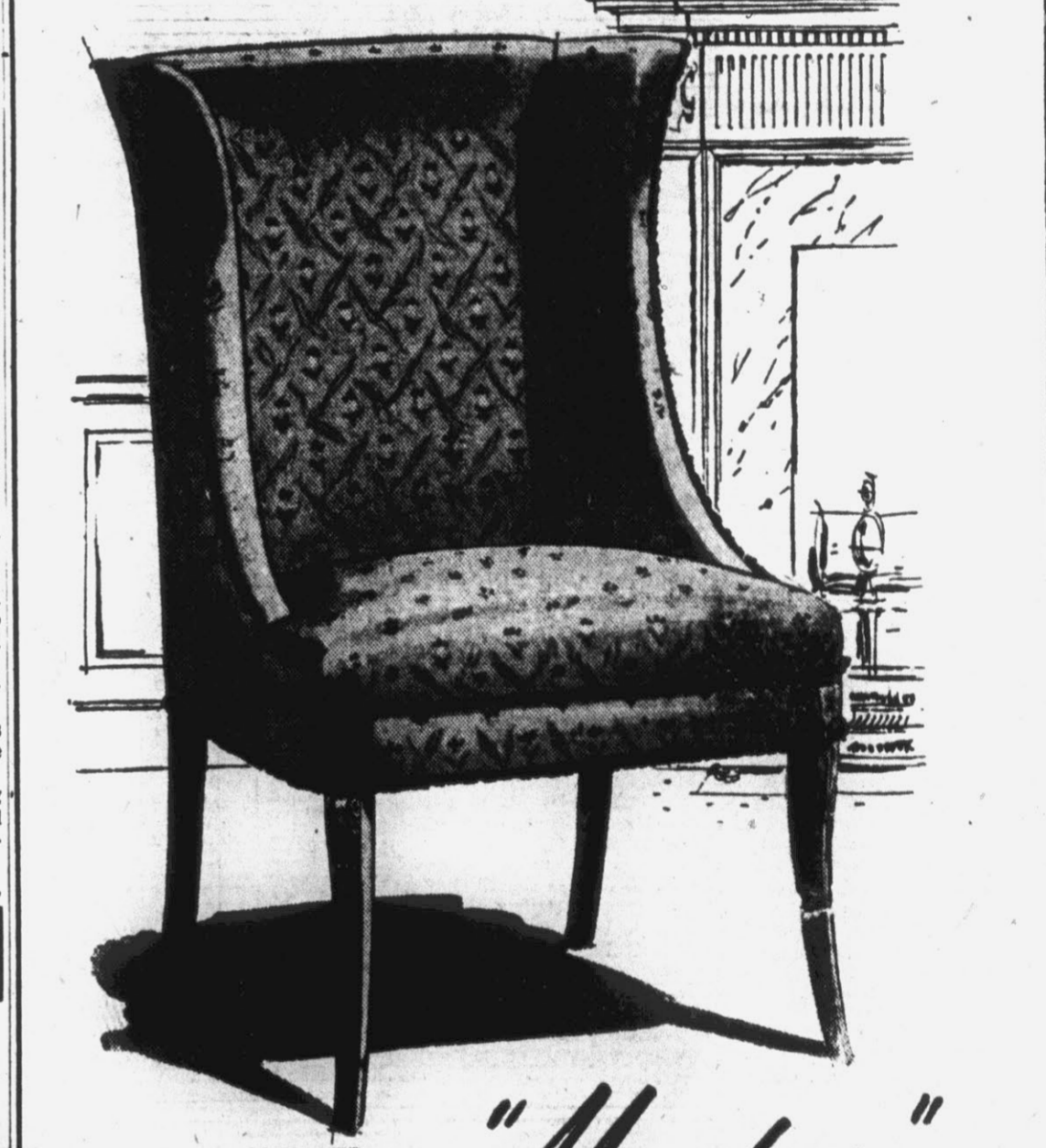
