

Added Strength Picked Up By Troops-To-Europe Plan

Senator Russell Has Some Modifications For Connally Resolution But Bilateral Approval Certain As Wave Of Support Grows

Washington, Feb. 23—(AP)—President Truman's plan to send more troops to Europe apparently gained strong new support today in the Senate.

Chairman Russell (D-Ga.) of the Senate Armed Services committee indicated he would back Chairman Connally (D-Tex.) of the Foreign Relations committee in a resolution which would endorse in advance any troop commitments Mr. Truman might make to North Atlantic defenses.

Russell told reporters he wanted some changes in the resolution but he hinted strongly he thought he and Connally could get together. He said he would wait until they reached a final agreement before making public the changes he proposed.

Connally expressed confidence an agreement would be reached. "It will be a bilateral resolution," he declared when reporters told him of Russell's attitude.

Harold Stassen, former Republican Governor of Minnesota and now President of the University of Pennsylvania, was due to testify on the troops to Europe issue today.

The two committees are considering a resolution by Senate Republican leader Wherry of Nebraska. This measure would seek to bar the President from sending troops to Europe until Congress has set out a policy on the question. Connally proposes to substitute his resolution for Wherry's.

He has proposed that it state simply that the success of the defense effort requires the assignment by North Atlantic Treaty members of troops to the European force under Gen. Dwight D. Eisenhower but that the President should consult with congressional committees before making specific troop commitments.

Declaring that America would be in a "desperate position" if western Europe fell to the communists, Russell said:

"The main objective of the resolution is to avoid a war."
Gov. Thomas E. Dewey of New York, 1948 Republican presidential candidate, is scheduled to testify before the committee tomorrow.

Two other Republican leaders, Senator Taft of Ohio and Wherry, are scheduled to set out their views next week.

Stassen and Dewey favor aiding Europe with manpower, while Taft has said he would not object to a limited number of troops being sent abroad. He wants Congress to limit the number. Wherry is against sending any troops at all.

Air Force Calls Up Principal Of County School

Garland Bailey, principal of the Bell Arthur school for the past three years, today gave up his duties at the school to report to Maxwell Air Force base, Alabama for active duty with the air force.

Orders From Stalin

Recent 'Policy Statement' Contained Veiled Order To Communists Everywhere To Intensify Their So-Called Peace Campaign; Example Of Effectiveness

Communism's "peace" machine is gathering momentum since Prime Minister Stalin's policy statement to the Moscow news-press Pravda a week ago.

The key to that statement was contained in one brief sentence which proclaimed: "The wide campaign for the maintenance of peace as a means of exposing the criminal machinations of the warmongers is now of firmer importance."

This was a proclamation which could be mistaken by the unwary as a call to all nations for peace. Students of Stalin's methods, however, recognized it as primarily intended for a directive to communist leaders throughout the world.

It was an order to intensify the peace crusade in an effort to hamstring the defensive rearmament campaign of the Democracies. The western powers were piling up too much strength for Russia's comfort.

This long has been Stalin's method of giving orders direct to his workers in the field, without going through the Muscovite captains. It gives an added punch of authority to the directive, and puts the Red

Pitt Draft Board Gets 2 New Orders For Men

Pre-Induction Tests March 14 For 100 Men, And "The Balance Of Available Men" For Exams On March 16

Pitt's draft board this week received orders from the state selective service headquarters to send 100 men for pre-induction exams on March 14 and "the balance of your men available" for pre-induction exams on March 16.

Compliance with the directive will mean the county's manpower pool for selective service will be completely exhausted by mid-March unless changes are made in the rules governing the men who may be called for military service.

"I am unable to give the number of men who will be in the March 14 pre-induction call," Board Clerk Selma Evans said, "and I don't think we'll be able to determine the number until about March 1." She explained some men in the draft age bracket have not been classified, and the classification of these men will determine the number available for pre-induction exams on March 16.

"After these two calls in March, we'll have only the men who reach their 19th birthday each month available for pre-induction exams," Evans explained. She added, however, that there are "right many" Pitt county men who have passed the pre-induction examination and have not yet been called for induction. Likewise there is a relatively large number of men in the county who have passed the pre-induction examination and have been deferred until the end of May when they complete their school year.

She estimated the Pitt board has approximately 200 men who have passed the pre-induction exams and have not been called or induction. The county received a call for only 50 men for induction during the month of February and so far the county has been called on for only 50 men for induction in March. At that rate, the backlog of men who already have passed the pre-induction exam will be sufficient to supply the demands on the county through May.

The two pre-induction calls which will be issued by the county board next month will consist principally of 18-year-olds.

Clerk Evans said unless changes are made in the draft regulations, the county will have no men available for pre-induction exams after March 16. She pointed out that the county board has between 200 and 300 married men with no children registered, and the board has approximately 650 18-year-olds registered with it.

Evans said she has been somewhat surprised by the fact that a number of men who passed their pre-induction exams on February 12, already have come to the draft board and requested that they be included in the 50 men from Pitt county who will be sent for induction on February 28. She said approximately 15 men already have volunteered for the call.

After that date, the next induction call slated for the county will be on March 20 when 50 men are to report for active duty.

First Approach

Lake Success, Feb. 23—(AP)—The United Nations Good Offices Committee, was reported today to have made its first approach to communist China to see if Peiping will reconsider and discuss Korean peace terms with it.

Diplomatic sources said the three-member committee had made its move in the last day or so through Swedish government contacts with Red China. The committee is awaiting an answer before making its next move, it was said.

The committee is composed of Nasrallah Entezam of Iran, president of the General Assembly; Sven Grafrstrom of Sweden and Luis Padilla Nervo of Mexico.

Committee members maintained complete secrecy on their action and have told newsmen they would have nothing to say.

Magazine Team Arrives In City

A reporter and photographer representing Life Magazine arrived in Greenville today to begin work on a story to be published in the national magazine week after next in connection with the large number of men who have been rejected by the army for failing selective service mental examinations.

A survey made of the large number of rejections from Pitt County swung the national spotlight on Pitt County with Pitt being the first county in the nation to turn in a complete report based on a investigation of the mental test failures.

Bob Kelly, photographer from the New York office of Life Magazine, arrived in the city early today to join Jack Riley, Life's representative in the state who came in late last night.

The group will visit various sections of the county in which six Pitt County men live who have been rejected for service in the army because they failed the draft-mental exam. Of the men, three are interviewed, all are holding down steady jobs and making a good living. J. H. Rose stated this morning. The list of men includes two bakers, one shoe repairman, a painter, construction worker and an auto mechanic.

Pictures and stories will be compiled showing the men performing their daily jobs by which they earn a living, Rose said.

The idea behind the story and the recent survey was to show that the army's mental tests were eliminating a lot of men eligible for service, but because of the nature of the tests were rejected.

Three white men and three Negro men are included in the coverage to be made of the county.

RFC Files Reportedly Called For

Three Officials Say White House Asked Data Concerning Lawmakers

Washington, Feb. 23—(AP)—Three officials of the Reconstruction Finance Corporation told senators today they understand the White House has ordered copies of the lending agency's files on loan correspondence with Congress members.

"This testimony brought an immediate recess in a Senate Banking subcommittee's hearings on RFC lending. The members angrily demanded that RFC officials come back in 30 minutes and say who ordered the files sent to the White House."

The three RFC officials had insisted they did not know who had asked for the files.

Testimony that they understood there had been a request for the files was given by W. Elmer Harber, chairman of the RFC board, William E. Willett, a director, and Arthur Merritt, executive manager for the Board of Directors.

Each, when asked who ordered the files, replied: "I don't know."

The report of the White House move in the situation came immediately after Senator Douglas (D-Ill.) had said he had heard "a group friendly to the RFC planned a counter-offensive" in which it would attack Senate and House members who had communicated with the RFC.

"I serve notice here and now," Douglas declared and pounded his desk for emphasis, "I am not going to be intimidated in these hearings."

The session opened on an angry note with Senator Fulbright (D-Ark.), the subcommittee chairman, accusing the RFC of planting reports he had tried to influence an RFC loan.

His first two days of hearings brought frequent mention of William M. Boyle Jr., chairman of the Democratic National Committee, but no testimony linking Boyle directly with any efforts on behalf of RFC borrowers.

Jaycees Have 120 Trees To Set Out

Greenville's dogwood tree population will be on the increase by Saturday afternoon if the plans of the Jaycee dogwood committee do not hit a snag in the next 24 hours.

Co-Chairman Jimmy Wells of the dogwood committee of the Junior Chamber of Commerce said members of the Greenville Jaycees yesterday dug up approximately 120 wild dogwood trees which they will begin planting in the city tomorrow. Practically all of the 120 trees left when the current orders were placed by local citizens who have placed orders for the trees with the Jaycees. If there are any trees left when the current orders are filled, they will be planted on city property.

President Dan Saleed of the Junior Chamber of Commerce said it will take the Jaycees almost three weeks to plant the trees which already been ordered. He estimated the club this spring will plant approximately 300 dogwood trees in the city. That is the number the Jaycees planted last spring in connection with their continuing city beautification project.

The trees which are being planted by the Jaycees sell for \$1 each, and orders for the trees may be given to any member of the Junior Chamber of Commerce.

Charles Wilson Broadcasts His 'Case' Tonight

Washington, Feb. 23—(AP)—Mobilization Boss Charles E. Wilson takes to the people tonight his contention that the nation's defense program is being run fairly and not, as organized labor leaders argue, that it favors big business.

Before that, the labor officials arranged a new conference to consider what to do about a peace gesture from Wilson. His suggestion that they pick one of their number to serve as one of the deputies in his Office of Defense Mobilization (ODM).

Also up for discussion at this United Labor Policy Committee (ULPC) session was the union officials' reaction to three days of conferences with Economic Stabilizer Eric Johnston. They have been trying to convince Johnston a proposed wage ceiling ten per cent above the levels of Jan. 15, 1950, is not high enough.

Tax Listing For County Improves

Small Valuation Gain For County Expected Over Last Year; Nearly 17,600 Abstracts Filed To Date

A total of 17,407 tax abstracts were listed by the people of Pitt county during the listing period from January 2 through February 10.

County Auditor Allan Powell said today the number of listings is approximately 250 less than the number of abstracts filed with the county last year. But before the books are closed, Powell said, "We will go higher than last year; but there still are a lot of people in the county that haven't listed this year or last year. The listing has been better this year so far as the value of property is concerned than it has ever been before. There are still some people who have not listed, but we are trying to check up on them and get the property on the books."

Although figures for the farm census of 1950 were not available, Powell said only 89 per cent of the farm tracts were included in the census last year, and 91 per cent were included in the census this year.

Red China Admits Spread Of Unrest

Death Penalty Drastically Extended; Peiping Says Underground Resistance Risen Since Korea Outbreak

Hong Kong, Feb. 23—(AP)—Communists, extending the death penalty drastically, today admitted the underground had killed thousands of Red militiamen and that open defiance was spreading.

In an astonishing announcement, Peiping conceded that resistance had risen with the outbreak of fighting in Korea.

Some observers here, however, believed the announcement was a intended primarily to justify a widespread purge which they expect to increase in intensity.

The Reds ordered immediate nationwide imposition of the death penalty for any and all actions which might be construed as "opposition" to government authority.

Observers said that by giving the penalties highest government sanction, Peiping also apparently was trying to take some of the heat off regional and local governments. Dissatisfaction with local governments was reported widespread.

The Chinese communists in the Peiping announcement admitted that peasant opposition to land reform is spreading rapidly, "armed defiance to the communist regime is getting out of control, and that thousands of Red militia and government officials have been killed by "counter revolutionary" agents.

U. S. Spearheads Of Allied Offensive Take Over Outer Defenses Of Hoengsong; Fight-And-Run Tactics Adopted By Communist Forces

Tokyo, Feb. 23—(AP)—Tank-led American forces punched swiftly up the mountainous spine of central Korea late today and occupied freshly vacated Red foxholes overlooking Hoengsong, key communist defense point.

The twin U. S. spearheads were setting the pace for the powerful allied offensive that shoved ahead virtually unopposed all along the muddy 60 mile front.

Fight-And-Run
Brief but bitter Red resistance was met in some sectors earlier today. This indicated the communists are using fight-and-run tactics against the 100,000-man United Nations Red-kicker drive.

AP correspondent Stan Swinton reported American forces advancing on Hoengsong in middle sector of the front were within a mile and a quarter of the burned-out town. The push carried four miles.

"American soldiers occupied foxholes dug by the communists for themselves while tanks and dive bombers dropped tons of missiles into the town," Swinton reported from outside Hoengsong.

"At dusk, the American tanks and troops pulled back slightly to make themselves secure for the night in full possession of the hills overlooking the Hoengsong valley."

Swinton said allied gunfire on Hoengsong was restrained on the possibility that American prisoners were still being held there.

Fyongchang Taken
On the east flank of the rugged, twisting warfront, American forces pushed unopposed into rubble-dotted Fyongchang, 25 miles southeast of the main objective—Hoengsong.

Allied forces were closing in on Hoengsong, central Red defense point 40 miles north of the offensive kick-off point, Wouju. A field dispatch reported stiff Red resistance on a line east and west of Hoengsong early Friday. Soon afterward the sector was reported quiet.

Also suddenly still was the area north of Chipyong, 20 miles west of Hoengsong. There the Second Battalion of Canada's Famed Sweepers Patricia Regiment swept easily through Red opposition astride the Seoul-Hoengsong road west of Hoengsong.

It was the first action of the Korean war for the Princess Pals. Their entry brought to six the nations in the current ground force drive against the Chinese and Korean Reds. Others are Americans, British, Australian, New Zealand and South Koreans.

The far western and far eastern sectors were comparatively quiet. Allied troops south of the Thuring Han River near Seoul were under some communist artillery, tank and mortar fire. U. N. forces have made no large-scale assault on the now useless former South Korean capital.

Naval Bombardment
Allied naval vessels continued to pound both the eastern and western shores of the peninsula Thursday for the ninth straight day. This featured a new bombardment by the U. S. battleship Missouri 186 miles north of 38 at the northeast coastal city of Songjin. The Missouri's 16-inch guns hurled one-ton shells at railroad yards and command posts.

Background On RFC

The Purpose Of The Reconstruction Finance Corporation And How It Works; Investigations Of Its Actions; Criticism Of Members Of Five-Man Board

Washington, Feb. 23—(AP)—Senators are digging around in the vitals of the RFC, the Reconstruction Finance Corporation.

Since almost all its business is with businessmen, RFC is pretty much unknown to the ordinary citizen who works for someone else.

So this is the background of RFC and what's happening now:

Roughly, it lends government money to businessmen for projects on which they can't get loans from other sources, such as banks.

For example: Jones has a plant and wants to expand it at a cost of \$25,000. For some reason, he can't get it from a bank; He goes to RFC.

RFC is supposed to investigate him and his plant to see whether such a loan would be a good risk.

Say it finds his plant, as it stands, is worth \$75,000 and could be seized if Jones failed to repay RFC the \$25,000.

In such a case it might decide he was a good risk and let him have the money. He'd have to pay interest on it, of course. That's the general idea. The

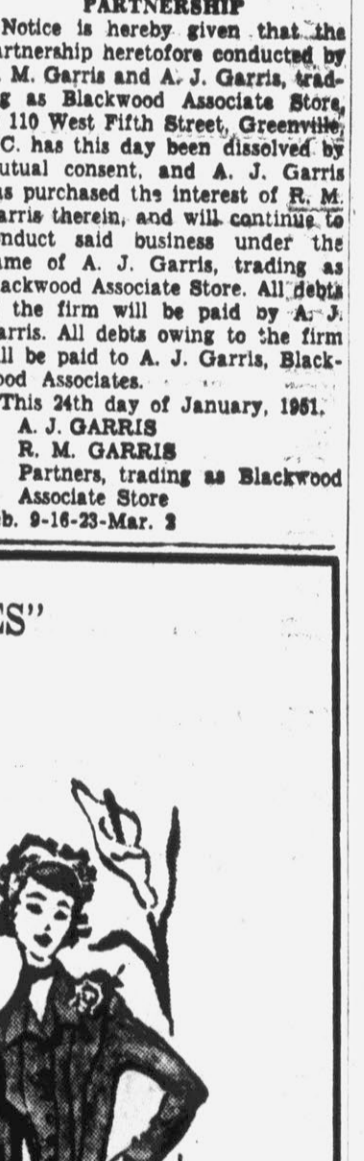

sword of righteousness against the international outlawry and despotism of an enemy of Freedom... and our hands are dirty.

If public conscience, which sleeps so much of the time, can be aroused, it should be directed towards a great moral crusade. Not in behalf of our neighbors, but on a very personal basis. It is sorely needed.

The Highway Picture Isn't So Black

It should come as no surprise to anyone that North Carolina's primary highway system should be found below current standards by the State Highway Commission. Only the amount of spending (an estimated \$305,000,000) required to bring the network "up to date" is all startling.

The results of the survey were probably pretty well known by the commissioners before the study began. For several years now, emphasis of the state has been placed on secondary roads; and the degree of improvement attained is apparent to any motorist.

The picture of our primary roads, as painted by the Highway Commission survey, is probably not quite as black as it sounds. The term "below standard" is misleading. Standards are based on the most recent developments of highway engineering, and as such, are constantly rising. A top-quality road of 1940 would not be so rated by the standards of 1951.

Unquestionably, the "average" condition of North Carolina's primary highways can be raised to surpass the quality of roads in our sister states through the expenditure of much less than the \$305,000,000 mentioned. Though it's highly doubtful that this can or should be undertaken at any time in the very near future.

National Whirligig

News Behind The News

WASHINGTON, Feb. 23—Vice President Alben W. Barkley has heaped more political troubles on President Truman's overburdened shoulders by notifying the White House boss that he would like to run again in 1952, and that he does not take kindly to reports that he ought to retire to a Kentucky pasture because of his age. He will be 75 next year.

The Barkley decision, although not entirely unexpected, comes at a particularly embarrassing moment for the White House, in view of the fact that several other loyal Democrats are also clamoring for the honor. It threatens to promote jealousies, dickering and a race for position that might embroil Mr. Truman.

Further complications arise from the fact that many of his friends think Mr. Truman will not run again, but will try to stage a political coup with the nomination of General "Ike" Eisenhower. And, as with the Republicans, there are many veteran Democratic regulars who see no reason why the great honor should fall to the military hero.

CANDIDACY—Senator Brienn McMahon has just announced his candidacy for the vice presidency, with the proviso that Mr. Barkley does not hanker for it. It is understood that the Connecticut Senator, who corals many headlines as chairman of the Joint Atomic Energy Committee, was inspired to this move by reports that Attorney General J. Howard McGrath of Rhode Island planned to toss his hat into the vice-presidential ring.

Obviously, there cannot be two candidates from the same section of the country. Although both are Catholics, they believe the religious bigotry that helped to swamp Al Smith in 1928 has vanished. They attribute its disappearance to the racial and social tolerance of the Roosevelt-Truman era.

Meanwhile, the Americans for Democratic Action favor a ticket of Eisenhower for President and Senator Paul Douglas of Illinois for the second spot.

DELEGATION—In fact, it is generally believed that Mr. McMahon announced his vice-presidential ambitions at this time to insure that he will control the Connecticut delegation next year instead of the A.D.A.-ers. If the present White House incumbent wants another term, Mr. McMahon will be a Truman man.

EX-GOVERNOR Chester A. Bowles and Senator William Benton fell in with the McMahon plan at recent conferences. They had no choice, for the atomic chairman has played politics so skillfully that he has made himself the state leader.

But the two erstwhile advertising partners are prominent A.D.A.-ers, and Mr. Bowles led the abortive Eisenhower-for-President movement in 1948, when it seemed that Mr. Truman might be sidetracked. Mr. Bowles is a key figure in this left-wing faction.

SPLIT—If President Truman taps General Eisenhower for the presidential nomination, he may split the party in a way he does not anticipate. The McMahon grasp for domination of the Nutmeg delegation is, quite likely, the first indication of a possible division.

As many leading GOP-ers prefer to select a candidate from the ranks of party regulars, so many Democrats do not want an outsider like General Eisenhower forced upon them. Their first choice in the event of a Truman aidestep is Chief Justice Fred Vinson of Kentucky.

AMBITIONS—A Vinson nomination, naturally, would eliminate Mr. Barkley for No. 2 man on the ticket, since there could not be two men from the same state.

It is this possibility, as well as the growing, intra-party opposition to a Truman-Eisenhower tieup, which tends to nourish such ambitions as those entertained by Messrs. McMahon and McGrath.

Because of all these conspiratorial considerations, as well as others, Mr. Barkley tipped his hand so far in advance. Despite his age, he looks better than he has in years, due to his loss of thirty pounds.

He has cut down on society diodes and is conserving his strength. Neither he nor his new young wife want to move from the Capital to Paducah, Ky.

RETREAT—The anti-Eisenhower moves and mutterings in both party camps have alarmed the European commander's personal and political friends to such a degree that they now deprecate further mention of his political prospects and aspirations.

Since they are the ones responsible for his headline advancement, they are really applying the brakes to their own amateurish enthusiasm.

They attribute the recent Taft attacks on the Eisenhower program for rearming Western Europe to the General's prominence, even though they do not accuse the Ohio Senator of petty motives. They do not want their hero lined up too openly against such a figure as Herbert Hoover. In fact, after their first skirmish with the professional politicians, they are beating what our Korean commanders describe as an "orderly retreat."

Their latest cry is that General Eisenhower's important assignment in preparing against possible Russian attack should not be hampered or embarrassed by any discussion of his political future.

Somebody Told Me

By I. J. (Jack) EDWARDS, JR.

Wife Rachel and I were discussing the war last night and compiled a profound statement for the press:

There are two schools of thought on being informed about the war in our way of thinking. One is to glance at the newspaper headlines on the war, and take in about half of what you hear on the radio. This way, you have a general idea about what's up and don't concern yourself about the problems of the world.

The other plan is to follow the war step by step, taking in every move and every trend in the national emergency. W.R. and I have decided that a happy medium between the two attitudes is the ticket. After all, it's our duty as American citizens to keep ourselves informed, but on the other hand there's no point in turning gray before your time.

W.R. and I agreed that we are not "up" on the situation, so we resolved to learn more. You don't have to look far to get information. In fact, information is so

abundant that it scares many readers away. And so much of the information tends to be alarming.

A good example of this alarming information is an article I read last night which said that in an American rifle company of 180 men, 37 cook, keep records, or do something besides fight. In a Red rifle company only two men do anything but shoot at the enemy. The Red soldier has been trained from birth as a beast-of-burden, and he can stay happy on black bread, twist tobacco and vodka. To this I say, thank God for the American standard of living. But this situation remains alarming.

Our Army employs more men to do the same job that the Reds do with fewer. Our 81-mm mortar, to give an example, is operated by a seven-man crew, while the Reds do the same job with four. Then, too, our Army uses men for weapons that are for defensive, and some that are of questionable value. For example, we man light mortars, which most soldiers

think aren't worth a cent.

The Soviet infantry battalion of 556 men has a total firepower of 170 pounds per minute, while the American infantry battalion of 837 men has a total firepower of 1200 pounds a minute. Over all, our divisional line of battle involves just over 7600 men with a per-minute firepower of 5.4 tons, and the Soviet line comprises just under 5000 men with a firepower of 6.15 tons. In other words, our Army uses 50 per cent more men than the Reds do, and yet the firepower is 13 per cent less.

The consolation is that you can't beat American production of men and machines. However, with a steel capacity of over 100 million tons a year, two months ago we were only using it at the rate of seven tons a year for armament. Russia is now using steel at the rate of 20 million tons a year, which is 80 per cent of her total output. This means that we've got to get into high gear fast.

And I thank you.

Around Capitol Square

Raleigh, N. C.

FIGHTING—The five hundred officials of cities and towns who came to Raleigh Thursday wore their battle armor. They left home in fighting mood and this spirit was fanned at what amounted to a pep rally held at the hotel preparatory to a public hearing in the afternoon on pending bills to extend state aid to municipal streets.

The morning occasion was a specially called membership meeting of the North Carolina League of Municipalities, and it was attended by representatives of cities and towns ranging in size from less than one thousand population to more than one hundred thousand. They had come ostensibly to discuss the "legislative program." Actually they had come to sponsor enactment of Senate Bill 120, commonly known as the "Powell bill" although it bore signatures of 38 other senators.

OBJECTIVE—The primary objective was and is to get a larger share of state gasoline tax money allocated for public roads inside corporate limits of cities and towns. It developed early in the session that the municipal group recognized that developments to date had placed them in position of taking the Powell bill or nothing. Reference was made to the "Royster bill" offered by Rep. La-

mar Gudger and signed by four or five representatives. Both house bills will have hard sledding in taxes, subject to vote of the people. The Royster bill has been given an unfavorable report by a committee and the municipal group accepts as fact that any tax bill will have hard sledding in the assembly and face almost certain defeat at the polls. So they must back the senate bill providing without additional tax that the state assume full financial responsibility for all streets forming links in the state highway system and distribute proceeds from half a cent a gallon gasoline tax for work on other streets, the distribution to be on a formula taking into account population and street mileage.

FEELING—There was evidence of keen resentment of some tactics being used against the proposition to give streets more help from the state. It might be too much to say the municipal folks were actually mad—but they didn't miss that status very much. Mayor Dan Edwards of Durham, vice president of the league and chairman of its legislative committee, referred to "deliberate effort to promote confused thinking" because it is easier to defeat a sound proposition by confusion

than by logic. Mayor Robert Crow of Graham voiced resentment at Senator Julian Allsbrook's suggestion that enactment of the bill would precipitate a "rat race" along municipalities. He thought that was a gratuitous insult to elected officials in the cities and towns.

RESPONSE—Further evidence of intense feeling was given in the resounding applause accorded a resolution of confidence and loyalty in President Ben Cone immediately after he announced that he was calling a meeting of the city council in Greensboro to resign as mayor of that city, because of action taken by the council Tuesday condemning the mayor's activities in behalf of the municipal league program for street aid. A telegram from Mayor Ed Lanier of Chapel Hill opposing the league position was greeted with loud boos, while messages of endorsement from mayors of Blowing Rock, Mars Hill, Winterville and other towns were loudly applauded. Mayor Marshall Kurfrees of Winston-Salem got a big hand upon his reference to "complications brought about by shenanigans" and further statement that what this group wants is to have highway funds "allocated" and not "diverted."

What Other Papers Are Thinking

Within His Rights

Senator Hoey is being criticized for merely expressing the opinion that the North Carolina General Assembly should ratify the twenty-second amendment to the Federal Constitution limiting presidential terms to two. Some of his critics find no fault, however, with efforts of Governor Scott to coerce this same General Assembly into enacting legislation which the governor desires.

The senator, moreover, in no sense attempted to turn the heat on the legislators. He merely expressed a hope, which was his right. On the other hand, the governor has even gone over the heads of the law-makers in an appeal to the people to build fires under their representatives to force them to act in favor of pet hobbies of the chief executive.

Opponents of the two-term limit for presidents offer no argument in support of their position other than that such an

amendment would be a slap at the memory of President Roosevelt. Mr. Roosevelt's precedent-breaking four terms are freshest in many minds, but back in the twenties when Calvin Coolidge had finished out the Harding term and served one in his own right, the Democrats tried to get a bill through Congress to bar him from another, but were unable to do so. There was, of course, no more reason for limiting Coolidge at that time than there would have been for restricting Roosevelt's colossal ambitions nor those of any other President now or later.

The whole issue is entangled in politics. Democrats in 1928 wanted restrictions to bar a Republican. Republicans and some Democrats want the limitations now to keep another Democrat from gaining a stronghold on the highest office in the land.

The amendment should be ratified by the North Carolina legislature now on its merits, and for no other reason. No man, regardless of his politics, should

be President longer than eight years. It is true that the people voted for Roosevelt four times, and it is likewise true that a lot of pressure lay behind those performances. The man in office has a tremendous advantage from the standpoint of prestige, patronage and pull, and that of himself had a lot to do with the long Roosevelt tenure, as it would with any man of any party.

Unlimited service for a President is a menace to democratic processes, regardless of what political bias may dictate in a nod toward an incumbent. No man is indispensable in this or any other office, nor should any other man be permitted to serve longer than two four-year terms.

Thirty-two or thirty-three States have already ratified the proposal. Only three or four more, as the difference may be, are needed to make the proposal a part of the Federal Constitution. North Carolina ought to ratify at this session and thus help to throw these safeguards around the principles of democracy in the United States.

Business Today

 The price of clothing is going up. The only question is how much.

Spring apparel, as you may have noticed with a wince, is higher than last fall's wear. Fall apparel will be even higher. If present conditions continue, next spring's clothing will be still higher.

Most of our clothing is made of cotton and wool. The powerful cotton states bloc in Congress is opposed to freezing farm cotton prices, and congressmen from the wool states won't stand for a wool growers' freeze.

The general price ceiling order doubly exempts both farm cotton and wool from the price freeze. Paragraph S-1 exempts any raw and unprocessed agricultural commodity when sold by the producer, S-3 specifically exempts raw wool when sold by the producer and S-4 specifically exempts cotton.

In addition, a large part of our wool is imported. We could, conceivably, forbid importers to pay no more than ceiling prices for imported wool but, since foreign prices are rising, that would simply cut off imports.

As prices for raw wool and cotton rise, processors and manufacturers will have to operate at a loss or ask for higher ceilings. There's no doubt which they will do.

Labor costs are going up. This week 70,000 workers went on strike for higher pay. And whether the Wage Stabilization Board sticks to a 10 per cent rise formula or gives way to pressure for a 12 per cent boost, there will be a sizeable increase that will be justification for apparel manufacturers, as well as all others, to gain higher ceilings.

At the meeting of the National Association of Retail Clothiers and Furnishers in New York this week, representatives that wool apparel will be 30 to 35 per cent lighter next spring. Suits that cost \$65 last fall will cost \$85 this fall, Elmer L. Ward, president of the Palm Beach Co., said.

Both retailers and manufacturers are interested in blends. Mixtures of rayon and nylon can stretch wool supplies. This is important because of the large amount of wool the government requires for uniforms. Orlon may have even greater values in blending or as an outright substitute for wool, but this will not come into quantity production until next year.

In addition to the rise in the figures on the price tags, there are likely to be a lot of hidden price rises in both men's and women's clothing. Manufacturers making lines in two price brackets will be tempted to add a few extras to their low-price line and sell it in their higher line. This will be especially common in women's apparel, and almost no amount of policing by the OPS can prevent it.

SECRET
ON MILITARY AWARDS
 The Munitions Board is tightening the secrecy about government contracts.

It is now listing only names and addresses of firms awarded orders, eliminating details about quantity and price.

This makes it harder for firms seeking subcontracts, since they can no longer tell whether a contract is large enough to permit subcontracting.

It is also an annoyance to contractors' civilian customers; now they can't tell how much worse a price they are getting than the government gets.

CUTTING PAPER WORK SAVES THREE WAYS
 The prospect that governmental controls will cause an increase in paper work is causing many companies to re-examine their own.

A Cleveland company eliminated 172 forms and reports. It brought about a triple saving: in clerical help, in printing bills and in storage space.

AUTOS BY THE POUND CHEAPER THAN STEAK
 An Albuquerque, N.M., auto dealer, is pricing his cars by the pound. That's not entirely new, but the dealer added a novel gimmick.

He displayed 1940 and 1950 models with a sign reading: "In 1940, steaks was 32 cents a pound, our car 94 cents a pound. Today steak is \$1.18 a pound for the same old beef, and our car is 85 cents a pound. And compare the value in the two cars!"

The display was a huge success. The National Automobile Dealers Association reports.

PATRONS COME BACK. SEE SELVES ON SCREEN
 Speaking of gimmicks, a San Francisco restaurateur has a peach. He takes movies of his happy customers and then shows them in the restaurant a few nights later. So many people come back to see how they looked that business is up 35 per cent.

Washington—About the most important thing for a Washington hostess to know is rank—whom to place above whom in a receiving line or at a dinner table. The rules are rigid. They are set chiefly by the State Department's protocol boys, by custom and by the social arbiters. If you place a gent below the salt when he should be up front you are a goner socially.

Wife of new members of Congress can find the answers in their Congressional Club Cook Book, which devotes four pages to protocol. Publication of the book was held up two years ago, until the State Department decided just where the Department of Defense would rank in the table of precedence for the cabinet.

It also awaited on a decision as to whether the chief justice should outrank a foreign ambassador at formal affairs.

Also there was much controversy as to what rank a governor of a state should have if he came to town. Much to the happiness of everybody, a list was finally settled on.

This is the way you would seat your guests (if God forbid!) you should ever wish to entertain all the big names at one time:

The President comes first, then then vice presidents, speaker of the House, secretary of state, UN representatives, ministers of foreign powers, associate justices and cabinet members.

Then governors of states, senators, acting heads of executive departments, chiefs of staff to the commander-in-chief, former vice presidents and the members of the House of Representatives.

The rank of a Supreme Court justice (if you're having two at a time) is determined by the length of time he has served on the bench, except for the chief justice, who outranks all.

Diplomatic rank is determined by the length of time a man has served in Washington. Wilhelm Munthe de Morgenstjerne, ambassador of Norway, is the present dean of the corps.

Cabinet rank is determined by the order in which the department was created, except in the case of the Department of Defense, which was upped to the former rank of the War Department, next to the Treasury Department.

Length of service determines the rank of senators except for the president pro tem. It's the same for the House, except for the speaker. The speaker is third in line for the presidency and therefore ranks "way up on the table for precedence in Washington.

Elon, sixth seeded, knocked out Appalachian as Ben Kendall scored 16 points for the winners. Appalachian was behind 11 points, 37-26, at halftime, and closed up

Groat Seeking Record In Duke-State Encounter

Richmond, Va., Feb. 23—(AP)—Dick Groat, Duke University's phenomenal guard, bids for a new national single-season scoring record tonight as the Blue Devils meet North Carolina at Durham.

Groat collected 33 points the last

time the two teams met, when North Carolina took a 71-68 decision. He needs 25 more tonight to tie the national individual scoring mark of 740 points in a single season, set last year by another Southern Conference star, Chet Giermak of William and Mary. Groat now has 717 points in 29 games.

But for North Carolina, victory is virtually a "must" if the Tar Heels are to keep their chances of gaining a berth in the conference tournament at Raleigh next month. They now possess a 9-7 circuit record.

While North Carolina ties into Groat and Duke, Maryland plays an equally important game against George Washington University in Washington. If Maryland wins, the Old Liners will move into a favored position to graze the eighth, and last, position in the tournament, regardless of how North Carolina fares against Duke.

A victory for Maryland would make the Old Liners' league mark 11-7 and only VMI's hitherto important Keydets would stand between the team and a certain bid to the dribble derby.

Hopkins U. Says Let Spectators Get In Free

Baltimore, Feb. 23—(AP)—Is it the "evil" of large gate receipts which has drawn some colleges down the road to the current "basketball fix" scandals?

A world-famous university here believes it has the solution.

Let spectators in free, says Johns Hopkins University.

They've been doing that at Hopkins now for 15 years.

Here's the philosophy:

"If intercollegiate athletics have any value other than monetary, they should be financed by the university and controlled by the educational and not the monetary values."

Hopkins appropriates \$40,000 a year for athletics. That lets the university field teams in 13 intercollegiate sports and pays for their traveling expenses.

No guarantees of any sort are paid to opponents and none are asked of them. Hopkins rivals pay their way to Baltimore to play for nothing.

In return, they can keep all the gate receipts from their home crowds when Hopkins is the visitor.

Contrast that with the picture in the New York City area where the lure of attractive gate receipts brings major college teams into Madison Square Garden for basketball games.

Some say that's the underlying cause of the current scandals in which members of teams from C. C. N. Y., Long Island U. and Manhattan College are facing charges of



For instance, I believe we get a reflection of this in the report that Britain has told Washington she opposes any attempt by United Nations forces to reconquer North Korea.

Not for one moment is it suggested here that Britain is seeking cover. However she presumably is anxious to avoid getting involved in a major war with China—and

who can blame her.

India a is moving carefully, and has been most insistent in trying to make peace between the western world and her vast Chinese neighbor.

It is situations like this which the communist parties abroad are trying to capitalize.
