Govm't Morality Inquiry Suggested

Fulbright Proposes Commission Investigate Moral Standards in Government; Moves To Bring RFC Probe To Early End; Says Purpose Is Served

Washington, March 13 (AP)—Senator Fulbright (D-Ark) suggested today that a commission of distinguished citizens be set up to investigate "moral standards in government" and look into the conduct of Congress itself.

It is too demanding a task, he said, for the Senate Banking subcommittee whose efforts have already touched off a federal grand jury investigation aimed at uncovering any law violations in the making of big government loans.

The subcommittee, of which Fulbright is chairman, has accused an influence ring with exerting pressure on the Reconstruction Finance Corporation (RFC), the multi-billion dollar government lending agency. The subcommittee has said the ring reaches into the White House.

Fulbright moved to bring the subcommittee's inquiries to an early end because, he said, it has served its purpose—to investigate the RFC. But he said it has turned up findings which might merit creation of a group somewhat similar to the Hoover Commission to conduct "a general investigation of moral standards in government."

"I am quite willing to propose it," he told reporters.

And, he said, any such study "ought to include an examination of congressional relations" with various government agencies, presumably including the RFC.

Fulbright said it would be "embarrassing" for any Senate committee to inquire into the conduct of senators. He said such an inquiry if carried very far might easily wind up in "personal vendettas" which would endure and interfere with Senate efficiency.

"The Senate shouldn't be a censor of senators," he said.

Republicans members of the subcommittee indicated they would resist efforts to halt its investigation now. One of them, Senator Capehart (R-Ind), told a reporter he will protest to the Senate and "demand that this subcommittee be given additional time and funds with which to carry on."

"We've only scratched the surface," he said.

The subcommittee is in recess today, with a windup of its work this week or next week in sight unless the Senate overrules Fulbright's recommendations. Fulbright said the group has completed its formal agenda, and that yesterday it was straggling a point where it was straggling far ahead from the job the Senate assigned it, an inquiry into RFC affairs.

Fulbright said he now plans to hear testimony from two more RFC directors and maybe take testimony on a couple of other matters before calling quits.

Any broader inquiry, he said, should be handed over to the Senate Investigations Committee, headed by Senator Hoey (D-NC), or to a special study group patterned after the Hoover Commission.

Red Tide On Move

While Communist China Is Negotiating Peace With Tibet, Red Maps Claim Portion Of India And Burma As Chinese Territory; Growing To New Threat

Quietly but inevitably the Red avalanche is moving westward from communist China into new fields of conquest.

Tibet, already occupied by invading Chinese troops, is now studying a Peiping peace offer which would in effect make this little state in the "roof of the world" a part of China.

The proposal provides that the Chinese recognize Tibetan autonomy and freedom of religious activity under the Dalai Lama "within the framework of the Chinese People's Republic."

The Chinese would have absolute control of Tibet's defenses. All Tibetan foreign relations would be controlled by Peiping.

India is watching with cautious concern as this drama unfolds on her Himalayan frontier to the north. The position is rendered more grave by the fact that Peiping last November issued maps showing as Chinese territory an area 300 miles long and 100 wide in India's great province of Assam which lies up against Tibet.

Indian surrender to this Chinese claim in Assam would cost New

## Strength for the Day

**ONE REBUKE SUFFICED**  
Great men are men who face facts. Weaklings live in a world of fantasy and often try to over-compensate for their weaknesses by all sorts of irregular behavior.

Admiral Farragut's father was a naval officer, and being sent down to New Orleans to look after the treason of Aaron Burr, he took his son with him. Young Farragut was boisterous, given to drinking and gambling, and accustomed on all occasions to make a rather disgusting spectacle of himself. One day his father said: "You expect to be a naval officer, but no boy ever trod this quarterdeck with such principles as you have and such habits as you exhibit. You are on the way to being a poor, drunken, miserable sailor before the mast, kicked and cuffed about the world and left at last to die in some fever hospital in a foreign clime. You will have to change your whole course of life if you ever want to become a man."

The boy was stunned. He thought he was fast becoming a man with his impudent show of unruly behavior. His father's words were like the drawing of a curtain between the boy and his future. We all know what the boy Farragut became—not only a great admiral but a man conspicuous for his strong Christian character. He did an about-face, and the result was a growth of character before which his fellows in later years stood in reverence.

## No Need To Delay If Revaluation Wanted

The Pitt county commissioners in the passage of their resolution opposing the revaluation of all the property of the county, have in effect said to the people of the county that they don't think this is the time to get all the property in the county on an equal valuation footing; and that they are quite content to keep piddling around until "normal" times return.

What "normal" times are, we can't answer... and the commissioners probably can't either.

The commissioners voiced in a portion of their resolution the same note The Reflector sounded some weeks ago. It would be defeating the purpose of the project to attempt to "equalize" the valuation without making a complete revaluation. The commissioners in their resolution said "to attempt at this time to revalue certain real property in the county without attempting to have a complete and thorough examination of the tax value of all real property in the county would result in an intolerable and impractical burden..."

The commissioners are right. A slipshod method of "equalization" without a complete revaluation would be "intolerable and impractical."

But The Reflector still maintains that a complete revaluation would be neither intolerable nor impractical since it would put all the property in the county on the tax books at the same percentage of its net worth. That is what Pitt county needs. But it is something which the county commissioners apparently do not want done. It would make every property owner in the county pay a proportional share of property tax according to a set standard of values. Something which the county does not have now, and something which apparently the commissioners wish to keep the county from having.

What is the result of the valuations now on the county tax books? Just this: Some property owners are paying taxes on 10 to 15 per cent of what their property is actually worth; and some are paying taxes on 40 to 50 per cent of what their property is actually worth. It is only fair that everyone should pay on the same percentage basis.

The proposals for making surveys of inventories will help the county have, for tax purposes, the valuation of property which has been escaping the county books. But it will do nothing to equalize the real property valuation inequities which are already on the tax books.

The matter of the revaluation of all the property in the county would be expensive, there is no doubt; but it would put all the property on an even footing, and after all, that is the way the property tax structure supposedly would be set up. The expense for getting it that way would be justified.

Wayne county is now in the process of revaluation. It let a contract to an impartial property valuation company for \$52,000 to revalue all the property in Wayne county. Altogether the revaluation will cost Wayne county between \$60,000 and \$65,000.

000. And how much property is it going to add to the tax books of the county? The county auditor says he expects it to add less than two million dollars worth of property to the books; but it will get all the property in the county on the same percentage valuation basis. And that is what the people and the officials of Wayne county want.

The Reflector believes that is what the majority of the people of Pitt county want; and we know that is what they are entitled to.

We believe, in all fairness to all the tax payers of the county, large and small, the county commissioners should take measures to see that all the property in the county is on the tax books at the same percentage of its actual value.

Procrastination by the county commissioners will not help the situation. If the commissioners ever intend to have a revaluation as they implied in their resolution, they may as well do it now and stop horsing around.

## More Responsibility In This City Election

This year the regulations governing the filing for offices in the city of Greenville government are being changed by the legislative act requiring all candidates for city offices to file at least 30 days prior to the election.

In the past the filing period for candidates for mayor has closed 10 days prior to the election, and the period for aldermen has closed five days prior to the election.

All of which means those people who are thinking of seeking office in the city elections in May have less than a month to make up their minds and get their names filed with the city clerk.

Likewise the system of electing aldermen has been changed so that every voter in the city has an opportunity to vote for a candidate for each of the five seats on the board of aldermen which must be filled at this election.

The changes in the election regulations mean the candidates will have to declare their intentions earlier than in previous years; the candidates will have to get the voters of a larger cross section of the people than in previous years; and the individual voter will have to give consideration to the election of men to fill more posts than he has had the opportunity to vote on in previous years.

## National Whirligig

News Behind The News

By RAY TUCKER

WASHINGTON, Mar. 13—The Kefauver Committee's indictment of the Internal Revenue Bureau's laxity in handling the income tax returns of known and big-time gamblers is substantiated sensationally in the case of a notorious figure who literally lived in the shadow of Capitol Hill, and only a few blocks from the Treasury.

The late "Jimmy" La Fontaine—he died a year or so ago—was not a nationally known character, but he operated the plushiest gambling casino in this part of the country. His sprawling, unshiny, mid-Victorian place stood just over the Maryland line, an easy drive from downtown Washington. A high, wooden fence added to its exterior ugliness. Inside, it had style.

It was the playground of politicians, members of Congress, executive officials, lawyers, the sporting element of the Capital and Baltimore. Hardly an important political dinner ended without somebody suggesting that they stop at the evening "with a few hours at Jimmy's place." Any adult living in this area, who did not know about "Jimmy's place," was only half bright.

RAIDED—"Jimmy" ran a good house—no excessive drinking, no wrangling with or among the customers, no noise, no debauchery of the kind frequently associated with "joints." If a visitor happened to clean up, he was given an escort so that he would not be robbed or waylaid on the way home.

The place was raided periodically, and for appearance's sake, by the police of Henry Mencken's Free State. But it always opened again for business as usual. Federal "dicks" never bothered him. They "laid off."

Posthumously, it develops that "Jimmy's" operations became so big that "big shots" of the New York underworld demanded that they be cut into his business. In fact, they once kidnaped him to enforce their demands. For several years before his death, he was only the nominal owner and operator, and it broke his gentle heart. So, he died.

CHEATED—"Jimmy" lived modestly, almost poorly, in a row house in a broken-down section on the edge of Capitol Hill. He gave generously to charity and he was a beloved neighbor. His wife adored him, and she survived him by only a year.

On his death, he left an estate of approximately \$2,000,000, and half of it consisted of cash which he kept at home. The District of Columbia police furnished a guard on the day it was discovered and taken to a bank for deposit.

Now, despite "Jimmy's" widely known source of income, and despite the visits of thousands of high officials to his place, the Internal Revenue Bureau discovered belatedly that he had cheated the government—taxes by \$1,000,000 over the last twenty years—from 1930 to 1950.

Although it is impossible to figure averages in income tax cases, that amounts to a mathematical underpayment of \$50,000 a year.

"HOT"—As the Kefauver report says, there was no attempt to check on "Jimmy's" chargeoffs for business expenses, gambling losses, promotion, protection money and charitable gifts. Worse still, the indictment says, there was the same sort of neglect with respect to far bigger operators than La Fontaine.

Whereas small taxpayers are frequently hauled in by Internal Revenue to explain and justify a few dollars in deductions, the Kefauver investigators estimate that Uncle Sam has been deprived of many millions of "hot money profits" through this kind of negligence or, perhaps, cooperation with the crooks.

HEALTH—James A. Farley has raised the delicate issue of presidential health in a way that will not make him welcome at the White House, in view of Mr. Truman's age and the physical and mental strain which another term might impose on him. Writing to the New York "Times" in approval of the 22d amendment, the former Democratic National Chairman says:

"We saw tragically in the case of President Roosevelt an utter breakdown of his great strength in his third term. Worse, we saw his nomination in 1944, when it was widely known among political leaders that he was a dying man."

Mr. Farley and the "political leaders" may have been aware of F.D.R.'s condition, but it is obvious that his own doctor was not. Or, if he was, he deliberately deceived the American people. Here is the record:

## Somebody Told Me

If you want to know how rough life is under the Communist rule, read this:

In the Chinese city of Wuchow, Dr. William L. Wallace, a Baptist medical missionary and superintendent of Wuchow's Stout Memorial Hospital, was for 15 years on the best of terms with the priests and sisters in Wuchow. Despite the fact that they were Catholics and Dr. Wallace was a Southern Baptist from Knoxville, Tenn., they got along amply. Even during the war years, Dr. Wallace stayed in China and kept on this work, treating malaria, skin ulcers, and other sickness in the hospital.

When the Communists took over, Dr. Wallace, then 42, continued his work in spite of their opposition. Communist propaganda about the wicked Americans had no effect on the citizens of Wuchow, for they had known too long that no such thing could be true of Dr. Wallace.

The story has just come to light, but it was on December 19th that Communist soldiers knocked at the hospital gate and claimed to have a sick man who needed attention. When the gate opened, they rushed into the grounds, surrounded Dr. Wallace's house, got him out of bed and searched his quarters. They claimed to find a pistol under his mattress. Dr. Wallace said he had never owned a gun; his servant swore that it had not been in the room before the Communists came. But in spite of all, the Communists took Dr. Wallace away to jail in his pajamas, and tried to get him to sign a confession. When he refused they called a "denunciation meeting," but not one Chinese came forward to condemn him. The Reds then arrested six members of the hospital staff as "reactionary pro-Americans." None of them has been heard from since. Dr. Wallace was paraded

through Wuchow and returned to jail in a state of collapse. Last week the U. S. State Department announced that Dr. Wallace had died in prison February 10th. The only possible sentence the Communists could have passed on him was that he went about doing good. He will be mourned by thousands of Chinese."

The State Department says that many American missionaries are in jail at various places in Communist China, but refused to give details for fear of having their source of information discovered. God bless America. And I thank you.

## Around Capitol Square

Raleigh, N. C.

TRAVEL—It is almost impossible to compute amount and value of travel-tourist-vacation business. Any aggregate amount is bound to be an estimate based on a few instances of provable data. Predictions for the future also must be based on experience records. Combination of these factors would seem to justify the forecast that more people from outside the state will visit North Carolina this year than ever before; that more North Carolinians will have a look-see at parts of the state away from their homes; and that the travel dollar will constitute a larger share of Tarheel income. Many observers expect "tourist business" this year to cut loose more than three hundred million dollars, making it a cash crop second only to tobacco as a source of individual and general state income.

FACTS—The forecasts are based on known facts, such as: The state advertising division during February replied to 6,744 inquiries about places to spend vacations in North Carolina, compared with 4,894 during February of last year. February travel count on the Blue Ridge Parkway was 42,748, compared with 39,160 for the second month in 1950. The Great Smoky Mountains National Park reported 28,591 travelers this year compared with 24,811 in February last year. This despite the fact that the weather was much colder this year and travel conditions in the mountains not so pleasant. Registrations at Iock-

hart Gaddy's wild goose refuge in Anson county totaled 24,000 during January and February, compared with 12,000 all of last year. More than 2,000 persons visited Fort Raleigh on Roanoke Island in February, a 73 per cent increase over last year.

EFFECTIVE—Charles Parker, state advertising director thinks that cumulative effect of state advertising over a period of years is largely responsible for the increased popularity of this state, but he believes almost equal credit belongs to resort operators and caterers who are backing up the advertising by providing more adequate accommodations at reasonable prices.

WATER—Deficiency of ground water throughout North Carolina, a spectre foreseen by engineers and geologists years ago, is becoming apparent to the average person. There have been in recent years temporary water famines at Winston-Salem and Raleigh, with less serious shortages at numerous other cities, although the situation has never been as desperate anywhere in North Carolina as around some of the metropolitan centers of the north and east. Conditions in many municipal reservoirs now are giving concern to health authorities and administrative officials about prospects for the summer. Lakes which normally at this season are fully up to or above what is considered normal waterline are reported from six to thirty feet be-

low. Low reservoirs at the season when heavy rainfall and snow cannot be expected to replenish them occasion worry for municipalities and utility companies dependent upon water generation of electricity.

FARMS—Farmers are getting worried, too, both about supply of drinking water and for vital moisture in the soil. An eastern Carolina farm operator said he had been forced to deepen half a dozen wells on his farms, and faced necessity for doing the same thing at several other tenant houses. An operator of a dairy in reply to observation by your reporter that the extreme cold winter had held back his pastures, said it wasn't so much the cold as lack of moisture in the soil. A big tobacco grower complained that he had to haul water for his plant beds half a mile farther this year than ever before, because the stream which he had used for a generation had gone dry for the first time in his memory. All participants in a sort of informal round table discussion the other night agreed that these conditions are not presently serious enough to cause other than mild inconvenience, but they reiterate a definite warning of desperate times ahead unless steps are taken to conserve and replenish the supply of ground and surface water.

## What Other Papers Are Thinking

SUPERIOR COURT

(Washington Daily News)

The Beaufort County commissioners voted recently to continue the March 18 term of Superior court in the county provided Walter Cahoon, district solicitor, would agree.

Mr. Cahoon is quoted as saying that he felt that such a continuance should not be granted at this time on account of the jail cases awaiting trial. Mr. Cahoon is probably right in his views. It is unusual to continue a term of court. And those awaiting trial behind jail bars have a right to be heard.

But there is another side to the matter, and this side should be given prominence also. The Daily News has made a long and hard fight to get the court calendar cleared in Beaufort County. It is not now in the clearing stage, but it could be cleared in one week if sincere efforts to do so were made.

The action on the part of the commissioners to continue the term is a courageous set on their part. The fact that the commission of court is prominent is a contributing factor in the attitude of the commissioners. As much as the Daily News would like to see the docket cleared so that we could try fresh cases all the time, we agree wholeheartedly that the best interests of Beaufort county would have been served at this time in cancelling the term of court.

However, we are not criticizing Mr. Cahoon for his stand. We are praising the stand taken by the county commissioners.

It is time that more governing bodies stand up and allow themselves to be counted. Just why did the commissioners ask that the term be continued? The administration of justice is expensive. If only eight or 10 cases can be tried, then the same number of jurors must be

called as if 35 or 30 cases could be heard.

The commissioners were acting solely to save the people of Beaufort county from extra expense. It wasn't an easy decision to make, and when one attempts to criticize courts, then sometimes he gets into trouble.

The commissioners have the right to expect the courts to try cases without unnecessary delays, quibbling, uncertainty, and indecision. They have a right to expect that the pocket books of their constituents will be protected. And that is exactly what they were trying to do. They tried, but failed. Perhaps the time for whispering is over and the time for speaking in clear ringing tones is here.

Anyway the term of court will be held. We can all hope that the court will expedite the business at hand to the satisfaction of all concerned.

# Business Today

By ELMER ROESSNER

These are topsy-turvy days for credit executives. Some of the people most likely to pay their bills aren't, and some of those least likely are meeting obligations ahead of maturity.

The causative factors are consumer credit controls on one hand and the high rate of employment on the other.

Controls, as embodied in Regulation W of the Federal Reserve Board, require higher down payments and shorter maturities, which mean higher monthly payments. Many families, as a matter of practice, as well as necessity, buy many of their goods on the installment plan. When Regulation W raised the size of down and monthly payments, these families got together, the money necessary for initial commitments went ahead as before. The installment payments were doubly increased: first, by the higher prices of the articles purchased and, second, by the shorter maturities.

Before Regulation W a family needing a \$1,000 used car might pay \$200 down and \$33 a month, plus interest and other charges, for 24 months. Today, an equivalent car may cost as much as \$1,500. This calls for a \$500 down payment and \$67, plus interest and charges, a month for 15 months.

Once the down payment was taken care of—and it's no secret that many dealers have cooperated by granting fictitious allowances for trade-ins and adding the difference to the total price—the higher monthly payment appeared feasible. Often, the monthly payments have run heading into the higher cost of food, etc. It is significant that the number of auto repossessions has risen. Some dealers report that the rise is frightening.

In a lesser degree, a family pledging its future income for furniture and appliances have faced the same problem of monthly payments higher than for previous purchases and higher expenses for other things.

Some who have been good credit risks before aren't so good now. On the other hand, the high rate of employment and recent rises in wages and salaries have increased the income of many families. Many who have been rated as doubtful credit risks are now making payments on time and clearing up back debt. In fact, this may be a good time for credit executives to re-examine old accounts they had rated as uncollectible. Some of the debtors

may now be in position to pay off old debts.

NO NYLON HOSIERY INCREASE EXPECTED

While there is no immediate danger of a shortage of nylon hosiery, the National Association of Hosiery Manufacturers points out that all nylon users are on allotment and there is more likelihood that allotments will be decreased rather than increased in the years ahead.

In 1950, the industry produced 42,000,000 dozen pairs of 15 and 20 denier hosiery and 14,000,000 pairs of 30 denier and heavier. If the ratios between light and heavy deniers had been reversed, total production would have been only 35,000,000 pairs, the association points out.

## Washington Letter

Washington—As a builder of an atomic bomb shelter Mrs. Alf Heiberg, wealthy Washington matron, says she is a "100 per cent flopper." Mrs. Heiberg, former wife of Gen. Douglas MacArthur, set about building a shelter in the sub-basement of her Georgetown home when she decided the city's defense plans were inadequate.

Now the wife of an Air Force colonel, she called in a contractor and six men with pickaxes and machines. They took out eight loads of dirt from under her historic, 20-room mansion. She figured the shelter would hold more than 100 people. Then came the District of Columbia building inspectors. She didn't have a permit. They led her to put the dirt back or they'd condemn the house.

"I'd already spent more than \$700 to take the dirt away and now I had to buy more dirt and spend as much putting it back," she told me. "They said I'd have to put in ventilating machines—my own electric machine to pump fresh air in—special lights, lathes, first aid operating table, oxygen tent, hundreds of blankets."

But it wasn't until she was told that the steel doors she'd ordered to the tune of \$75 to \$100 would have to be replaced with doors of lead that the project was abandoned.

"The whole thing became completely chaotic; I've learned everything not to do," she said. "Nothing I read about building bomb shelters told me what to do. My contractor told me he was just the man to do the work since he knew as much as anybody else about bomb shelters, which was nothing." Mrs. Heiberg reluctantly has reached the conclusion that her own bomb shelter probably would not have worked anyway.

"It was told that if I built the shelter the whole house would fall in on us. As it is, without the shelter, we'll stay upstairs and the whole house will fall in on us anyway. The thing to do is pray."

Mrs. Heiberg nevertheless is still pretty concerned over the capital's plans for meeting an atomic bomb attack.

"If I ever get my hands on the man who put out the city civil defense leaflet telling everybody to 'keep calm' I'll say something to him," she said. "Just imagine, it says 'Keep Calm'—not even 'Try to be calm.' Be calm how, may I ask?"

The schedule of the speaking team in this area has not been announced as yet, but is expected to be made public in the near future, the local Army Recruiting office revealed yesterday.

# Promises Rent Office For Area

Washington, March 13—(AP)—Housing Expediter Tighe Woods has promised a rent office for Wilmington, N. C., within two weeks to help give rental relief in the area surrounding Camp Lejeune.

Woods made the announcement yesterday after a visit from Brig. Gen. John T. Seiden, Deputy Commander at the huge Marine station.

Seiden brought Woods a letter from Maj. Gen. Ray A. Robinson, camp commander, describing housing conditions in a 75-mile radius of the camp.

Robinson declared that "landlords and property owners are not averse to charging enormous rentals for dwellings that are little more than shacks with dirt floors."

Woods said reports from Housing Office representatives who already had investigated the area were the same as the Marine report.

Woods said Gov. Kerr Scott had promised full cooperation and added that action in the area surrounding the Marine Air Base at Cherry Point should be expected also soon after the Wilmington office is established.

# Terrorists Take Toll In Malaya

Kuala Lumpur—(AP)—Communist terrorists destroyed or damaged \$1,800,000 worth of property in the Federation of Malaya in December, 1950.

Of this total, \$1,300,000 represented damage to buildings, bungalows, laborers' lines, rubber stores and engines. During December, terrorists held up 49 motor vehicles, robbed passengers and burned cars causing a loss of \$264,338. Terrorists also murdered 128 persons in Malaya in the same month.

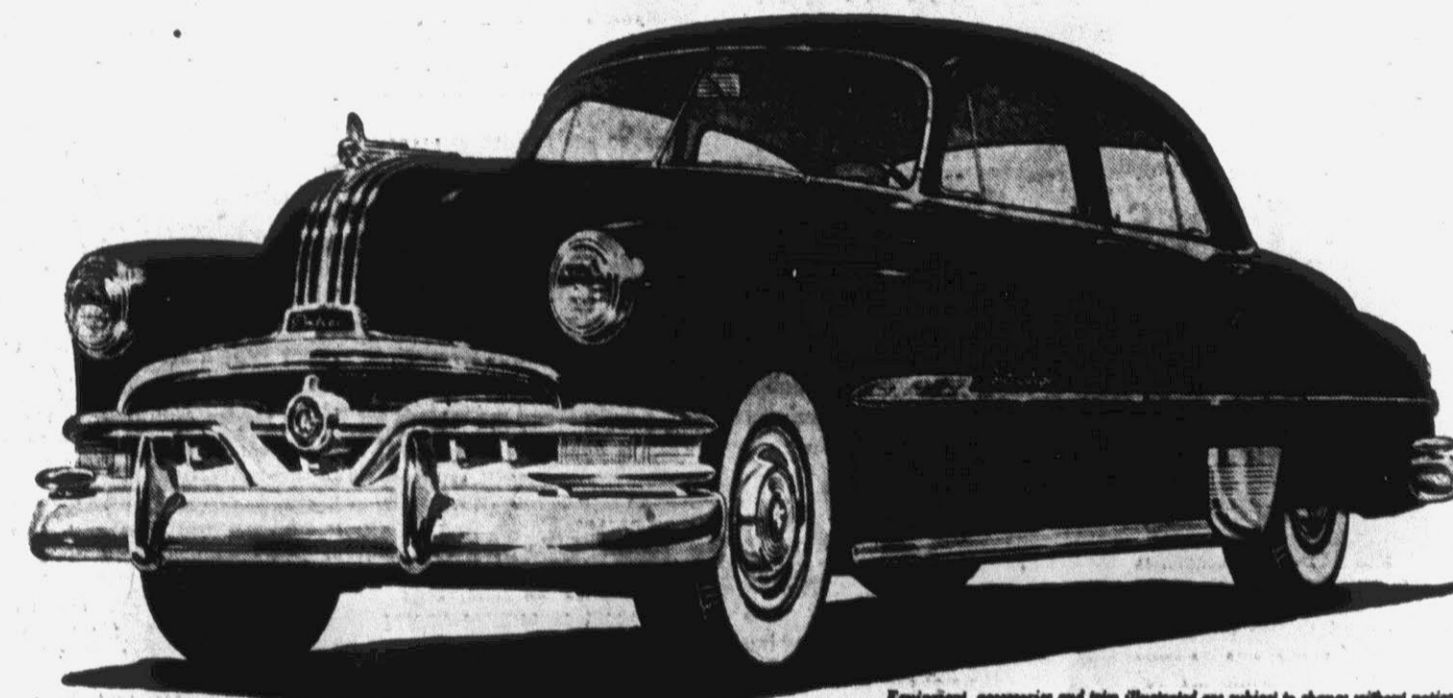
Firemen were summoned when a passerby noticed smoke coming from under the house. An alarm was turned in from box 135.

# Pirate Baseball Squad Now At 31 Men; Hard Schedule

## About 75 Percent Of Number Are New Men; Opening Game Slated For March 20 With Upsala College Here; 21-Game Card

In preparation for East Carolina's baseball debut March 20, Coach Jack Boone has cut his squad to 31 men, about 75 percent of whom are new men on the team.

March 20 sees the Pirates assume the toughest schedule since Boone has been coaching at the college. Beginning with Upsala College (N. J.) in the opener here, the Pirates take on a 21-game schedule that includes games with six service teams. According to Boone those teams will provide the stiffest opposition to his boys this year considering all the professional players that have joined the ranks since last spring.

To cope with the service team games, plus games with the regular North State Conference opposition, Boone has some likely prospects in the newcomers in addition to his already-touted talent that is back from the 1950 team.

The veterans from last year's squad who will be available are Sonny Russell, Jack Wallace, Billy Smith and George Sauls, all infielders; Fred Soles, Jim Corbin and Leon Jones, all outfielders; and Martin Byrd and Richard Hobbs, pitchers.

The outlook at the present is only fair to middling: good strength in the outfield and infield but an untested pitching staff for the most part. However, Boone has seven new additions to his mound crew, in addition to Byrd and Hobbs, to work with this season. Most of them are freshmen, having played ball in their various high schools last year, and many come to East Carolina with high recommendations. Three juniors playing for the Pirates for the first time, having transferred from junior colleges last fall. Of interest to fans in Greenville is the addition of Julian Vainright to the pitching staff. Julian is a freshman this year, having entered

East Carolina from Greenville High School where he pitched for Coach Bo Farley's Phantoms. He's a right-hander.

# Chandler Reportedly Plans To Resign Within 6 Months

Miami Beach, Fla., March 13 —(AP)—Baseball Commissioner Albert B. (Happy) Chandler will resign his post within the next six months regardless of whether his successor is elected, it was learned today.

A close friend of the commissioner told the Associated Press that Chandler had debated the idea of quitting immediately after his repudiation by the major league owners yesterday, but was advised against it.

As was the case in St. Petersburg three months ago, the magnates voted not to reelect Chandler to a new term. In a written secret ballot, nine owners voted for Chandler

and seven voted against him. He needed 12 for re-election. The former Kentucky senator's seven year contract ends April 30, 1952.

"Happy knew he was licked Sunday after a talk with Clark Griffith of Washington, his staunchest supporter," the Chandler intimate said. "He suggested resigning then but was advised to reserve decision until he talked with his closest friends among the baseball magnates."

"Chandler knows he cannot hope ever to be re-elected now. He is sick of baseball and disgusted with the way he has been mistreated by some baseball men. He wants to get out of it as soon as possible and return to his first love, which is politics."

"Furthermore, Happy is a man of great pride. He won't allow himself to be a mere figurehead in any business he is in. That's what his position has been subjected to now."

The crestfallen Chandler was meek and mellow yesterday in sharp contrast to his attitude at St. Petersburg when he was bitter and battling and vowed he'd serve out his term to the last second. This time he said he would do anything the club owners wanted him to do, and that he would make it, as easy as possible for them, to elect a new commissioner.

## Witness Freed In Bribe Scandal

New York, March 13—(AP)—Robert Sabatini, a material witness in the college basketball bribery scandal, was freed today in \$35,000 bail.

The 60-year-old witness posted bail yesterday before General Sessions Judge John A. Mullen.

Sabatini had been in jail since Feb. 18. Authorities describe him as a "person who had gambling contacts" with Salvatore T. Solazzo, alleged master briber of players.

Solazzo, a jewel merchant and ex-convict, is held without bail. He was named last week in a bribery indictment, to which he pleaded innocent.

Eddie Gard, former Long Island University player and confessed intermediary for Solazzo in getting college basketball stars into the game-fixing conspiracy, testified again yesterday before the grand jury investigating the scandal.

Gard, held in protective custody at his own request, is slated to be the chief prosecution witness at Solazzo's trial.

## Hard Play And Upset Prelude To Semifinals

Brigham Young Trims St. Louis; St. Johns Comes From Behind To Stay In Running; Wolfpack To Meet Seton Hall

New York, March 13—(AP)—Third-seeded Brigham Young breeched into the semi-finals of the National Invitation Basketball Tournament last night, but St. John's, the No. 1 entry, was almost ousted.

While Brigham Young trimmed St. Louis with surprising ease, 75-58, St. John's had all it could do to nip fired-up St. Bonaventure, 60-58, before 10,124 at Madison Square Garden.

St. John's, trailing by 14 points early in the second half, stormed back and finally gained the decision in the last three seconds when center Bob Zawoluk connected with a dramatic field goal.

St. John's uphill victory can be traced to two factors:

1. Close ball-hawking in the second half, and
2. Clever, but obvious, strategy by coach Frank McGuire.

St. Bonaventure clogged up the middle during the first half and walked off with a 32-22 lead at intermission. The Bonnies upped it to 40-26 after five minutes. Then St. John's, desperate now, switched tactics.

From a routine lay-back defense, the Redmen employed an all-court pressing defense, hawking the ball, and St. Bonaventure became flustered and disorganized.

In five minutes, St. John's tied the score, 48-48.

The lead see-sawed but with 40 seconds left the teams still were tied at 58-58. St. John's, in possession, called time and McGuire told his team to freeze the ball until the final seconds, then flip it to Zawoluk and let nature take its course.

Caldwell paused and drew a pipe

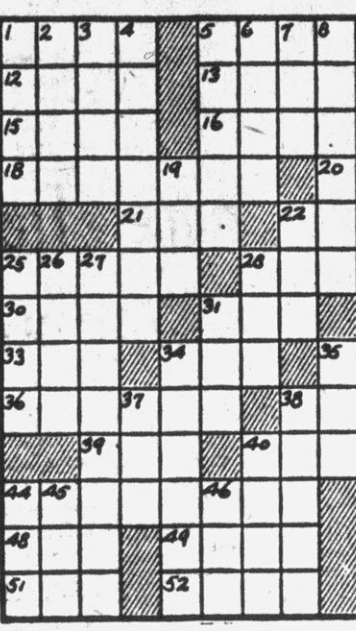

## Last Of State's Secondary Road Bonds On Sale

Raleigh, N. C., March 13—(AP)—The last of the \$200,000,000 in secondary road bonds — \$75,000,000 worth—will be placed on the auction

block by the state.

The Council of State yesterday authorized State Treasurer Brandon Hodges to sell the bonds. The action came after the Highway Commission indicated it is now in position to use the funds for more road work.

The bonds were approved by Tar Heel voters in a special referendum in June, 1949.

Hodges said he likely would advertise the sale for mid-April, but added that the exact date won't be set until after March 26.

# Meetings Of The General Assembly No Novelty In New Bern's History

Raleigh, March 13—Formal session of the general assembly scheduled to be held in New Bern Wednesday, March 14, will be a novelty for members of the 1951 legislature and for present citizens of the community. It will be old stuff for the continuing general assembly and for the first permanent capital of a province which later became a state.

More sessions of the North Carolina general assembly have been held in New Bern than anywhere else except Raleigh, and some of them were more hectic and important than any held elsewhere. Long before New Bern was designated by Governor William Tryon as the "permanent" capital of North Carolina the general assembly had frequently met there.

Since 1794 only three legal or formal sessions of the general assembly have been held outside of Raleigh. They were one day sessions at Edenton in 1947, at Charlotte in 1938, and at Elizabeth City in 1941. Prior to 1794 the assembly wherever it was invited and was convenient.

A comprehensive history of the general assembly would be essentially in history of the province and the state. That cannot be attempted in one newspaper article. Colonial records are not readily available for casual research, and it is difficult to say just when or where the first "general assembly" or "legislature" of North Carolina convened. It is known that a governor's council, lineal ancestor of the general assembly, was

set up prior to 1670. The councilors had little real authority and were regarded as informal advisers to the governor, who had been appointed by the Lords Proprietors with approval of the King of England.

The first really representative general assembly convened at Edenton on November 1, 1725. That was near the close of the Proprietary Government. Richard Everard was governor under appointment of the Lords Proprietors and he continued in office through the transition period of ownership of the colony back to the crown, which was effectuated about 1733 or 1730. This first assembly was in session only two days but was reconvened in April of the following year for a full week.

During the entire colonial period only the governor could convene, prorogue and dissolve the general assembly. Parliamentary procedure permitted the governor, when he was displeased with action of the assembly, to dissolve the session and immediately reconvene it for de novo action on the same subject. Consequently there were many one day sessions—sometimes eight or nine separate meetings of one general assembly.

There is record that the assembly met several times at New Bern during 1744 to 1760. Meantime, there were three sessions at Wilmington in 1746, 1754, and 1759. After the New Bern meeting in 1760 Governor Arthur Dobbs took the assembly back to Wilmington for its regular sessions of 1761, 1762 and 1764. Governor Dobbs died in March, 1765, and was succeeded by Governor William Tryon, who established a "permanent capital" at New Bern and every session was held there until 1775.

Governor Tryon built a magnificent "palace" at New Bern which became one of the wonders of the New World. Lavish expenditure, such as spending \$80,000 for the palace (?!) inflamed the people and contributed to the zeal with which North Carolinians sup-

ported the revolution. The Tryon palace was burned in 1798. It is now being restored by the state with aid of private contributions at many times the original cost. But that is another story. We are dealing here with meetings of the general assembly.

The last assembly held in North Carolina under authority of the British crown was convened in New Bern by Governor Joseph Martin on April 4, 1776, and remained in session through April 8. Those were five hectic days. Expert parliamentarians frequently could not tell whether a formal session of the general assembly prorogued by the royal governor, or a meeting of a committee of the whole house, or a popular convention, was in progress. The same group one hour would be a regular assembly convened by royal edict, and the next hour a convention of patriots defying authority of the governor and the king who appointed him. Finally the assembly under leadership of Edward Starkey of Onslow and John Harvey of Perquimans, dissolved itself. Governor Martin fled from the palace to a British warship anchored in nearby Neuse river.

During the interim between the flight of Governor Martin and adoption of the constitution of 1776 the affairs of the province were administered by a provincial council, which later became a safety council, but which should not be confused with the wholly advisory and impotent governor's council of a century before. The provincial council was named by the provincial congress, an elected representative body, which first met at New Bern in August of 1774. The second provincial congress also met at New Bern in 1775, simultaneously with the last royal general assembly.

Throughout that whole period there was conflict and confusion among the several agencies which continued until the first legislature under the constitution was convened in New Bern on April 7, 1777. That body elected Samuel Ashe of New Hanover as speaker of the senate and Abner Nash of Craven as speaker of the house of commons. That was the beginning of constitutional government in North Carolina. Prior to that time government had been administered by appointees of the king or the Lords Proprietors. From 1776-77 until now, North Carolinians have selected their legislative and executive officials by popular vote, direct or indirect.

During the first eighteen years of constitutional government North Carolina had no fixed capital. The first assembly, as stated, met at New Bern in 1777. Other meetings at New Bern included the first sessions of 1778 and 1780; the second session of 1784; full sessions of 1785, 1791, 1792, and the second session of 1793 (which in fact was held in June of the following year and was the last meeting outside of Raleigh until the one-day session at Edenton in 1937).

Hillsborough was the meeting place for five assemblies; the second sessions of 1778 and 1780; only sessions held in 1782 and 1783, and the first session of 1784.

Halifax was host to two meetings, the third session of 1778 and the second in 1779. Fayetteville had five sessions: 1786, 1788, 1789, 1790, and the first

session of 1793. The assembly met once in Tarboro in 1787 and once in Smithfield, the second session of 1779. First time the assembly met near the present site of the capitol was the first session of 1781, held at Wake Court House in the village of Bloomsbury, near the home of Joel Lane.

Meantime the state was growing and it became necessary to establish a permanent seat of government. The 1787 assembly at Tarboro ordered a convention to be next year in Hillsboro to consider the matter. But it was the general assembly at New Bern in 1791 which named a commission to lay out the capital "within ten miles of Isaac Hunter's home."

So it is that when the 1951 general assembly visits New Bern it will be on historically hallowed ground. It was there the last royal legislature convened, and the first under constitutional government. It was there the provincial council was set up and the permanent capital at Raleigh effectuated.

The experience of a general assembly convening in New Bern will be novel to the folks participating in this meeting. Historians will cite the occasion as a less important item going to prove that history repeats itself.

## Two Slain After Scolding Episode

Rutherfordton, N. C., March 13—(AP)—Two students who became angry over a scolding killed their superintendent and a school chum last night, Sheriff Vance Wilkins reported.

He said Billy Ray Powell, 16, and Hugh Justice, 19, are in jail and will be charged with murder. They admitted shooting Prof. W. E. Sweat and Wade Johnson, 15, the Sheriff added. Powell and Johnson were roommates.

The Sheriff gave this account: Prof. Sweat, head of Alexander School at nearby Union Mills, summoned Powell and Justice to his office and reprimanded them about their grades. They became angry and borrowed a .22 single-shot rifle. They lay in wait for the superintendent and as he locked his office door Justice shot him. The two youths fled and found Johnson. Powell shot him after accusing him of tattling about an infraction of rules.

Powell and Justice then went to a small store and told the proprietor what they had done. He investigated and found the bodies. V. T. Cooper, a faculty member, also said the two boys came to his home and told him what they had done.

## Pegler Calls For Election Inquiry

Washington, March 13—(AP)—The Senate Elections Committee announced yesterday that it has been asked by Councillor Westbrook Pegler to investigate three senatorial campaigns.

Chairman Gillette (D-Iowa) made public a telegram to the committee urging that it question Arthur J. Goldsmith, whose address was given as the Waldorf Tower, New York.

Pegler said Goldsmith should be questioned "regarding source of money and disbursement in the campaign and in the campaign against Pat McCarran." Gillette said he presumed Pegler was referring to former Senator Graham (D-NC), who was defeated in a primary runoff against Willis Smith of Raleigh, N.C. last year. Senator McCarran was reelected last year.

The telegram also urged a "searching examination" of "Albert J. Lasker and his wife as to the campaign which knocked off Burt Wheeler." Wheeler, a Montana Democrat, was defeated in the primary election of 1946.

## Mundt Calls For GOP And Dixie Demo Coalition

Winston-Salem, N. C., March 13—(AP)—Sen. Karl E. Mundt (R-SD) has called on Southern Democrats to combine with Republicans to defeat Truman forces in next year's presidential elections.

He told Republican meetings here and in High Point yesterday that he "would not be embarrassed to work closely with Democratic Senators Hoey and Smith of North Carolina, Byrd of Virginia, and Russell of Georgia if such a coalition can be achieved."

Mundt added: "These men, although they are Democrats, favor the same type of government the Republican party is interested in." He added that Southern Democrats may be the "possible salvation of the United States" from what he called the invasion against free enterprise and curtailment of states' rights.

## Liberty Ships Ordered Out Of 'Mothball Fleet'

Washington, March 13—(AP)—The Maritime Commission has ordered 41 Liberty ships, including three at Wilmington, N. C., out of its "mothball" fleets to carry Marshall Plan cargoes abroad and bring back defense-needed ores. For increased tonnage to carry Marshall Plan cargoes of grain.

# Scott Says Adjournment Date Will Hinge On Revenue Report

Raleigh, N. C., March 13—(AP)—Governor Scott declared today much will depend on this month's revenue report—before the legislature can figure on an adjournment date.

A joint appropriations subcommittee now is studying the matter of State spending for the next two years. It has before it a \$459,500,000 budget proposed by the Advisory Budget Commission and some \$80,000,000 additional requests made by state departments and institutions.

Scott told his Tuesday morning news conference if the subcommittee were to return a split report, current talk of the legislature adjourning early in April might be averted.

Scott was asked to comment on

a statement made by Senator J. Hampton Price yesterday that "I can see no need whatsoever for any new taxes to be levied by this general assembly."

Price, chairman of the Senate Finance committee, made the statement to Charlotte Observer correspondent Wade Lucas.

Price declared inflated prices are bringing in, and will continue to do so, enough money to increase the recommended \$303,000,000 State Budget for the next two fiscal years by \$88,000,000, or the recommended spending advocated by Governor Scott.

Scott said today he would be mighty happy if inflation would make up the \$38,000,000 difference.

In line with this, the Governor

said Revenue Commissioner Shaw had queried revenue officials in the 40 states with either sales or income taxes, or both. Scott declared that so far 25 states have answered Shaw's questionnaire, which asked the other states to advise in their expected revenue estimates the change, percentage, during the next fiscal year.

The Governor declared that Shaw's estimate for North Carolina so far is the highest estimate made for any state of those responding so far.

The Governor said it is "not just a question of not wanting to increase taxes." He explained "the whole program" of his opponents in the General Assembly, "seems to be just an effort not to let this administration do anything more."

# Greater Charity Hospital Aid Is Said Endorsed

An overwhelming majority of North Carolina legislators favor more adequate State payment to hospitals for the care of charity patients, according to a report made today by district chairmen of the North Carolina Hospital Association.

The Association is backing House Bill 410 calling for 50% state payment towards the cost of charity patient care, provided the remainder is paid by local governments. The bill is now in the hands of the Joint Appropriations Committee's subcommittee. Estimated cost of the proposed program is \$1,800,000 per year instead of the current \$300,000 annual state payment.

District chairmen reporting were Sam K. Hunt, Memorial Mission Hospital, Asheville, District 1; W. R. Peters, High Point Memorial Hospital, High Point, District 2; J. P. Richardson, Presbyterian Hospital, Charlotte, District 3; M. E. Yount Jr., Alamance General Hospital, Burlington, District 4; E. T. McKeithen, Moore County Hospital, Pinehurst, District 5; and C. D. Ward, Pitt Memorial Hospital, Greenville, District 6.

Ward, of Greenville, reported, "A number of new hospitals have been built or approved in this area of the State. Sentiment here, therefore, is unusually strong for more adequate state payment because the community leaders close to these new and prospective hospitals are aware that they will not be able to weather the financial handicap of heavy deficits on charity care."

# 'Troop A' Report For February Is Released Today

The regular monthly report issued today by the Greenville State Highway Patrol office, headquarters for Troop "A" which covers the eastern section of the State, revealed that seven persons lost their lives on the highways during the month of February while 119 others were injured.

# Colder Weather Seen For Tonight

A forecast of colder weather tonight with possible freezing rain was received from the Greenville Weather Bureau this morning.

The colder weather forecast for tonight would come as a follow-up of the rain which began to fall in the Greenville area early this morning.

When the thermometer did not reach the freezing mark, as it had in the past three days, the lowest temperature recorded at the local weather station stood at 38 degrees with a high of 60 reported yesterday afternoon.

By eight o'clock this morning only a trace of rain had fallen but by noon today more than a tenth of an inch of rain was recorded at the station.

The cold front moving in around Greenville came on the heels of a warm spell and threatens to usher in the first official day of spring, which will come on March 21, with a cold shoulder.

Assault on a female: Willie Dudley Jr., Negro, paid \$20.

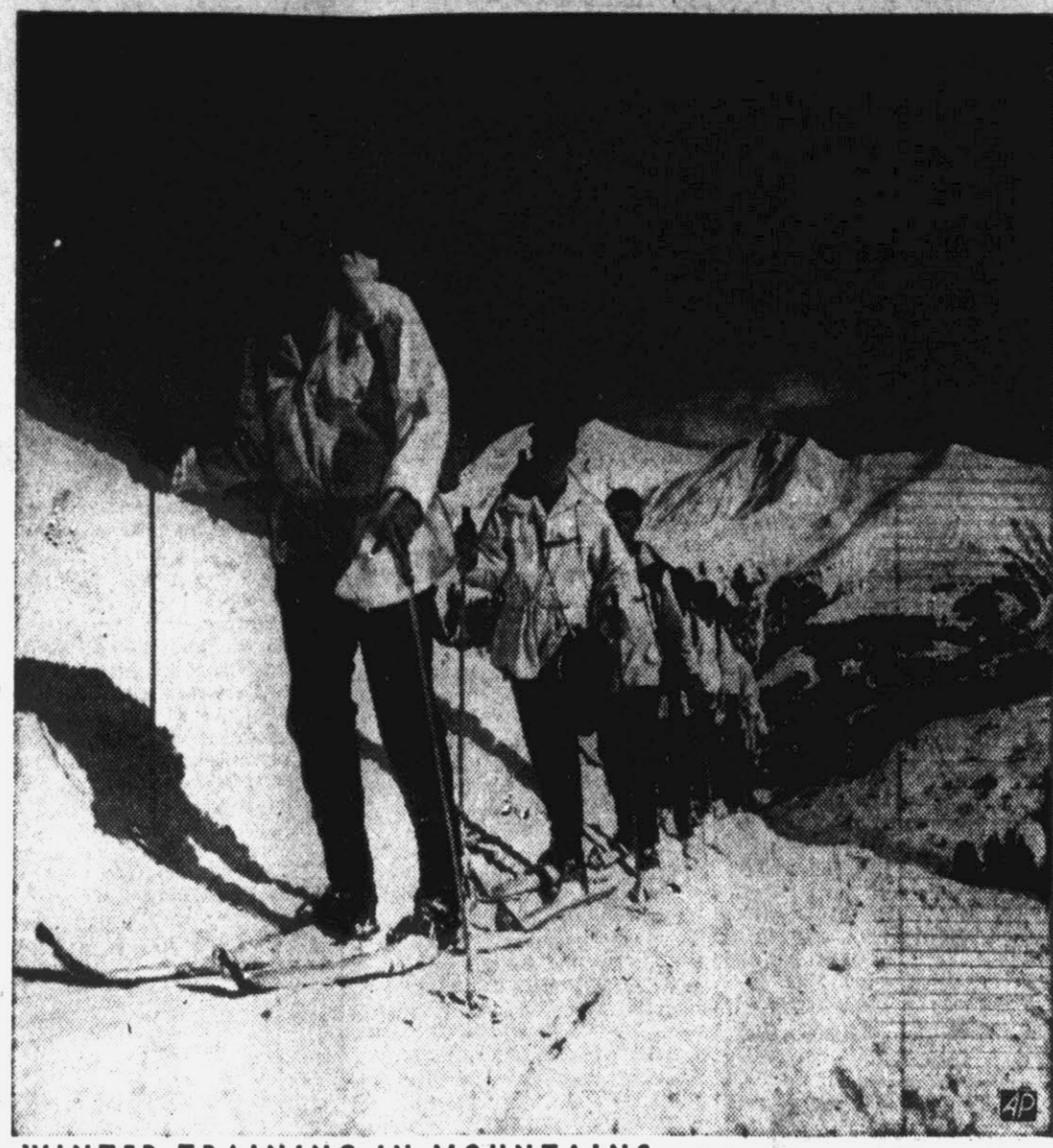

# Student Group Acts As Jurors In N.J. Court

New Brunswick, N. J.—(AP)—One morning in 1936 several students in the news reporting class at The State University's School of Journalism found themselves moved out of the spectators' seats in Judge George Morrison's District Court in New Brunswick, and sworn in as jurors. That was the beginning of a unique learn-by-doing program which Professor Hubert Ede's reporting classes have been carrying on regularly for the past five years.

"The reason I like to have students serve on juries is that they do such a fine job. I don't know that I've ever had any better, more serious jurors than the Rutgers kids," Judge Morrison said.

"There is an age requirement of 21 years for jurors in this state," Judge Morrison explained, "but we hit on the practice of getting both attorneys in a case to waive that limitation, and it's worked out fine."

# Give Verdict Of Accidental Death

Bethel, March 12—A Pitt County coroner's jury, investigating the highway death of Fred Mayo, who died of injuries sustained when his automobile was in collision with a logging truck near Bethel on March 1st, returned a verdict of accidental death, and ruled that no action should be taken against the driver of the logging truck.

Mayo was pinned in the wreckage of his car which was totally demolished when the truck jackknifed and collided with the auto. He died some 24 hours after he was admitted to Edgecombe General Hospital with both arms and legs broken and internal injuries.

The driver of the logging truck, George Robert Riddick, of Belvedere, was confined in a Williamston hospital for treatment of his injuries, but he was not seriously injured.

# Sky 'Tunnels' Used For Safer Atlantic Flying

London—(AP)—Aircraft flying from London to Paris, Brussels and Amsterdam are now operating a plan for greater safety in the air.

Airways used in the plan are, in effect, sky tunnels ten miles wide within which civil aircraft flying at heights between 3,000 and 11,000 feet are separated from each other at intervals of 1,000 feet. Aircraft in an airway are under the control of the ground organization and their movement is regulated so that no two aircraft can be in the same place at the same height and time.

Trans-Atlantic air traffic has been using an airway from the Irish Sea to London for six months and eventually the airways system will cover the British Isles.

# Brazilian Trees Offered Iceland

Reykjavik, Iceland—(AP)—Trees of Brazilian origin may decorate gardens and parks in the capital of treeless Iceland in a few years.

Kaj A. Svanholm of Rio de Janeiro has offered the city 5,000 eucalyptus plants from Brazil. He visited Iceland last summer and thinks they might grow well.

Last fall the Iceland government sent a special envoy to Alaska to gather seeds for Iceland's forestry program.

tions are more or less international.

So that's the way the position stands along the Indian frontier. The conference in Tibet over the Chinese demands is said to be dominated by pro-communist Tibetans. However, a small group of leaders insist there is still a chance of maintaining independence and a mission reportedly has been sent to Peking to ask Red Generalissimo Mao Tse-Tung to soften his terms.

The big question naturally is what, if anything, is anybody going to do about this imbroglio along the "roof of the world." Barring Nehru's declaration that India would defend her frontiers, there has been no obstruction placed in the way of Peking.

The U. N. has had a look at the

situation, but hasn't made any move to intervene. As a matter of fact, if the U. N. did decide to intervene, it first would have to puzzle out what it could do about it. It isn't a position which lends itself to easy treatment.

But he'd hardly forget, certainly around election time, to get his face in focus on TV pretty often.

There was a great lack of cheering when one member of the House—Rep. Javits, elected from New York on the Republican-Liberal Party ticket—elected the House doings be televised.

He thinks it's a good idea, pointing to the "highly successful" TV coverage of the United Nations' debates in the Security Council and General Assembly.

That's all just a kind of optimistic notion about what might come of televising Congress. The Washington Post recently raised another point in an editorial critical of televising congressional committee investigations regularly. It said:

"The regular use of television in committee investigations would certainly encourage the inquisitors to put on a show instead of calmly seeking information. Witnesses likewise would be tempted to resort to spectacular stunts and colorful charges."

That editorial grew out of the predicament of James J. Carroll, nationally known maker of betting odds, when he walked out of a St. Louis hearing conducted by the Senate's Kefauver Crime Investi-

gating committee. He strode out because cameras were set up in the hearing room to televise him testifying. He said this was an invasion of his privacy and an outrage to his sense of propriety.

The Post took the position that witnesses in a courtroom don't have to face TV cameras and witnesses before a congressional investigating committee shouldn't have to, either, against their will. The Kefauver committee, very much put out by Carroll's performance, wants to test whether a witness can be forced to appear on TV. So it voted to ask the full Senate to cite him for contempt.

If the Post is right about the effect of TV cameras on congressmen, maybe TV of both houses would make congressional doings worse instead of better. I'd still like to see it tried.

# Development Of Slums Advocated

Raleigh, N. C., March 13 (AP)—Spokesmen for Tar Heel cities today urged passage of a bill aimed at redevelopment of slum areas.

The action at a public hearing before a House Judiciary committee in the hall of the House.

Rep. Robert Lassiter of Mecklenburg, an introducer of the bill explained the measure to the committee. He said a subcommittee named to study the bill will work over it a while longer before making a formal report to the full committee.

Lassiter said the bill is different from redevelopment measures defeated by past legislatures and "is not one drafted in Washington." Under the bill, cities could name redevelopment commissions empowered to acquire slum areas, clear them and then use the property for public purpose or sell it to private enterprise for industrial or residential use.
