RFC Business Is Brought To Stop

Loan Applicants Staying Away In Drove While Agency Being Probed; Public Hearings To Be Reopened; Rep. Hays Declines To Repeat Influence Charges

Washington, March 15—(AP)—The Reconstruction Finance Corporation (RFC), denounced in Congress and subject of a Grand Jury investigation, reported today borrowers now fear to approach it for loans.

"The RFC is like a morgue," said C. Edward Rowe, a member of the huge government lending agency's board of directors. He told a reporter business men are evidently afraid to apply to RFC for loans lest, somehow, they find their names in headlines.

He spoke amid growing charges in both houses of Congress that the RFC has fallen prey to an influence ring with White House roots, and that it should be abolished.

Rowe himself is one of those under fire. A Senate Banking subcommittee headed by Senator Fulbright (D-Ark) announced it would reopen public hearings, probably Monday, to hear his testimony and that of another director, Walter Cosgriff. The subcommittee has accused Rowe of subservience to outside influences, but has made no accusations against Cosgriff.

Meanwhile Rep. Hays (D-Ohio) declines to repeat before the Fulbright subcommittee charges he had voiced in a House speech Tuesday that two senators he did not name exerted influence to help get \$18,500,000 of RFC loans for a company headed by Guy Gabrielson, Republican National Chairman.

Senate Republicans put their shoulders behind a drive to (a) put the RFC out of business, (b) block a White House move to reorganize the agency, and (c) keep alive the Fulbright subcommittee's investigation.

The Republican Senate Policy Committee announced those decisions last night, after a coalition of House Democrats and Republicans had lost by a narrow margin in an effort to reorganize Truman's RFC reorganization plan. The coalition mustered only 200 of the 218 votes it needed.

Fulbright, who has directed the public airing of RFC affairs, protested that the move to abolish the agency is far too drastic.

The three Republican members of his subcommittee, however, rebelled against his plans to call a halt to the public hearings.

Fulbright told reporters proper strategy would be to accept the President's plan to replace the five-man RFC board with a single administrator, then adopt legislation creating safeguards against abuse of RFC powers.

He suggested the House vote yesterday gives a hint that RFC foes could not muster a two-thirds majority to pass an RFC repeal bill over a veto by Mr. Truman. He said he hopes Congress won't risk winding up without forcing any RFC shakeup at all.

Seek To Salvage Famed Ironclad

Cape Hatteras, N. C., March 15—(AP)—Diving operations looking toward possible eventual salvage of the famous Civil War ironclad warship, the U. S. Monitor, may get underway here in May.

The Monitor sank about 1,000 yards off shore while sailing south from Norfolk Harbor where it had fought to a draw with the Confederate ironclad Merrimack.

Talk-Fest Analysed

Observer Lists Percentage Of Wordage From United Nations Members And Compares This With Dues Payments; Red Block Is Obviously Getting Money Worth

One of the most devastating analyses of the talk-fest regularly sponsored by the United Nations is presented with humorous undertone in the March issue of "United Nations World" magazine by correspondent Peter Khiss.

A deluge of more than 600,000 words swept through the 50 plenary meetings of the U. N. Assembly above in 1950. Of this stupendous flood 40.78 percent came from the five-nation Soviet bloc—the championship record.

By contrast, the United States talked 4.49 percent of the wordage. Having established these relative figures, Author Khiss pulls this rabbit out of the hat:

The Soviet Bloc percentage of U. N. dues for 1951 is 10.18 as against the United States percentage of 38.92.

That seems to say that the Red bloc talks approximately eight times as much as America, and is assessed roughly a quarter as much in dues. The reader can draw his own conclusions as to the significance of this financial computation.

Five Percenter Probe Opens Its Private Hearings

Rep. Nixon Again Brings Former Target Into Picture As Influence Man

Washington, March 15—(AP)—Senator Nixon (R-Calif) declared today a federal employee described as President Truman's very good friend apparently "used his White House entree" to push a bid for a government loan.

Nixon said he will continue to insist that a Senate committee investigating "influence peddling" get to the bottom of the matter. The government worker's boss promised to help.

The committee, meanwhile, took behind closed doors for a few days its inquiry into the activities of "five percenters" who trade on influence in the defense contract field. Senator Hoyt (D-N.C.), the chairman, said the committee staff needs time to study "several tips and leads" regarding such activities.

The five percenter term has come to be applied to influence men who charge a fee, often five per cent, for help in getting government contracts for others.

The federal employee to whom Nixon referred is Joseph Major, who works for the General Services Administration (GSA). That is one of the government's biggest purchasing agencies.

Major's name first popped up two years ago during a similar investigation by the Hoyt committee. He was sharply reprimanded by the committee then for steering prospective surplus property customers to a five percenter while he (Major) was employed by the War Assets Administration, forerunner of the GSA.

The diary of RFC Director Walter Dunham, produced at the banking group's hearing, said that on Nov. 4, 1949, White House aide Donald Dawson called Dunham "and made an appointment for Mr. Dunham to see a Mr. Joseph Major, who is a very good friend of the President and Mr. Dawson, interested in applications submitted by the Community Hotel Corporation."

Dunham told the banking subcommittee there was no indication Major was interested financially in the application.

Raleigh, N. C., March 15—(AP)—Highway fatalities jumped 21 per cent during January over the same month a year ago, it was reported today.

A total of 85 persons were killed on Tar Heel streets and highways during the first month of this year. The Department of Motor Vehicles said. This compared with 70 deaths during January of last year.

Fountain Doctor Voted Honor By Pitt Society

E. Bruce Beasley Named Doctor Of The Year For Second Time In His Career; Has Practiced In Fountain Since 1913

Dr. E. Bruce Beasley of Fountain has been named by the Pitt Medical and Dental Society Doctor of the Year for the second time in his career.

Dr. Beasley, a general practitioner for the past 38 years, was named by the Society's selection committee during the recent March meeting. He also had the honor bestowed upon him in 1949.

In making the selection, the committee considered many doctors of the county, taking into account the service they have performed for their communities and the county as a whole. In choosing the Fountain doctor the committee members stated that "no one more worthy was known than Dr. Beasley" to whom to give the honor.

He was born at Colerain in 1888 and attended the University of North Carolina for his academic degree and medical training. Later he received his medical degree at the University of Pennsylvania in 1911.

Following graduation he interned at Queen's Hospital in Honolulu as resident physician. In 1913 he returned to the States and located in Fountain the same year. He has practiced there ever since.

One society member expressed the feeling of the society at large when he said concerning the selection: "Gentlemen, he has filled a place in his community that most of us can only hope to approach."

Concerning his service to the community, the committee listed five qualifications that were pertinent to the selection. They are: "Continuing unselfish service, lack of consideration for his own health and self preservation, overcoming physical disability with devotion to duty and self-reliance, failure to find after 38 years of practice a dissatisfied or unappreciative patient, and his complete adjustment to life which has undoubtedly been one of the reasons for his continual health."

Frost Predicted For Pitt Tonight

The sudden cold snap which has gripped Eastern North Carolina and Greenville for the last few days, and which had threatened to usher in a chilly Easter, is due to die out Friday and Saturday, the Weather Bureau reported.

While the thermometer was predicted to reach the high fifties by early afternoon today, the mercury was expected to slide back down to a chilly 29-30 degrees tonight, with forecast of a heavy frost.

A fairly large frost fell over the area last night as the mercury went down to a cold 29 degrees low, and a warning was issued by the Weather Bureau to all farmers with plants exposed to see that they are protected before night.

The highest temperature reached yesterday was 43 degrees, an estimated 11 degrees below normal for this time of the year.

State Bonus For War Vets Is Put Before House

Raleigh, March 15—(AP)—A bonus for veterans of both World Wars was proposed on legislation tossed in the House hopper today.

Rep. George A. Long, who introduced the bill, proposed increased taxes upon beer, wine and liquor to raise revenues for the bonus.

Under the bill, the question of paying the bonus and levying the increased taxes would be submitted to the approval of the people in an election.

Maximum amounts to be paid veterans under the bill would be \$500 for those who served in the U. S., \$750 for those outside the United States, and \$1,000 to next of kin of those who died from wounds or illness incurred in service.

Long estimated that the tax increase would raise \$2,000,000 a year. He said that under the bill veterans would receive payments each year until they reached the maximum.

It's A Bright Day, This Deadline For Filing Taxes

Senate Prepares For Hot Debate

Troops To Europe Issue Promises Heat-Ed Argument

Washington, March 15—(AP)—The Senate cleared its decks today for debate on a resolution backing the Administration's plan to send four additional U. S. divisions to Western Europe. It promised to be "long and heated."

In sending the Senate resolution to the floor, the Foreign Relations and Armed Services Committees, acting jointly, also approved a virtually identical resolution which would require the approval of both houses of Congress.

That move, and others engineered by a coalition within the joint committee, fall far short of pleasing the Administration which has contended the President alone has power to order troops to Europe without advance congressional approval.

The resolution says in part: "It is the sense of the Senate, in the interest of sound constitutional process, and of national unity and understanding, congressional approval should be obtained of any policy requiring the assignment of American troops abroad when such assignment is in implementation of Article 3 of the North Atlantic treaty; and the Senate hereby approves the present plans of the President and the Joint Chiefs of Staff to send four additional divisions of ground forces to Western Europe."

Morale Booster

The recapture of the capital was a magnificent morale booster to Republican Koreans. But the allied command had its eye on a target of far more military importance.

That target was vital Chunchon, in central Korea eight miles south of the 38th parallel.

The Reds must hold that key strategic base if they intend to remain in South Korea.

Big Red Force

Air observers have estimated possibly 120,000 Chinese in ridge positions south of Chunchon.

Crack American divisions were advancing toward the Red stronghold.

The U. S. First Marine Division was at the gates of the no-man's-land of Hongchon, 15 miles southeast of Chunchon.

U. S. First Cavalrymen, across the Hongchon River in force, controlled hills west of Hongchon, roughly 15 miles south of Parallel 38.

President Again Blames Moscow For Arms Race

Truman Defines U.S. Rearmament As War Preventive And Self Defense

Key West, Fla., March 15—(AP)—Russia had notice today from President Truman that the United States is rearming primarily to prevent war but also "to meet such a conflict if it is forced upon us."

He again challenged the communists to agree upon a foolproof control of atomic and other weapons "to enable the world to find peace."

Until this is done, he said, "it is essential to our national security that we build up our defenses as quickly and vigorously as possible."

Mr. Truman gave this definition of the United States' rearmament program in a letter made public at the Little White House here last night.

"It is, above all, an effort to prevent a world conflict, while at the same time it is an effort to prepare our defenses to meet such a conflict if it is forced upon us. What we are striving for is peace and international order."

The letter was addressed to Senator Flanders (R-Vt.) and a bipartisan group of senators and representatives who wrote him Feb. 26 suggesting he propose the lifting of the Iron Curtain, complete disarmament under the United Nations and immediate establishment of a UN police force.

Mr. Truman may have something further to say on the tense international situation at a news conference at 3:30 p. m. (EST).

He invited reporters over to the presidential quarters for a conference on the law—his first meeting with the press since he flew here from Washington March 2.

Remnant Of Capital's Population Grets Returning UN Forces With Shouts And Tears; City Probed For Reds; General Advance Continues Along Wide Korean Front

Tokyo, March 15—(AP)—Seoul's remnant population of old folks and children roared an ovation today to United Nations troops searching his torn remains for communists.

Recapture by the allies Thursday marked the fourth time the Republic capital has changed hands since the war began June 25.

The main communist garrison quit the flanked city in the general Red retreat all across Korea. But Korean civilians said the bomb-blasted, fire-blackened and booty-trapped city still held a few communist troops disguised in civilian clothing.

Of the normal 1,500,000 population, only about 200,000 remained to greet the returning South Korean and American troops.

Advance Goes On

East of Seoul, tank-led allied columns ground slowly and steadily toward strategic Chunchon, the Reds' last chance for a foothold in South Korea.

At points along the advancing allied line, U. N. units were less than 18 miles from Parallel 38, once the dividing line between Communist North and Republican South Korea.

Recapture of the old Korean capital of Seoul was bloodless. Elements of the South Korean First Division and the U. S. Third Division speared into the city Wednesday night. The South Korean troops pulled out at darkness but the Americans stayed on.

Then the divisions sent in men in strength Thursday.

At first all was quiet. But soon the timid, frightened people came out of their wrecked houses by

ones, by twos, by groups. Tearing welcome Word spread quickly that the United Nations soldiers were back. AP correspondent Jim Becker, who went into the city Wednesday night and again Thursday, reported:

"The women threw themselves at our feet and sobbed hysterically. Tears coursed down the cheeks of tired old men. Children outflung their right to grab our hands and touch us."

A story, Becker wrote, was a sorry sight.

Three of its nine men represented labor, three represented business, and three represented the public. The board blew up a couple of weeks ago when the three labor members walked out.

They were sore about the wage policy agreed on by the other six members: that employers would be able to give general wage increases of no more than 10 per cent above what the pay was in January, 1949.

"Parents must assume the responsibility for teaching safety to the children," he concluded. "They must set the example by always driving in a manner required of the children."

When a question from the floor was asked about the rules and regulations concerning bicycle riding in the city, he stated that he was planning to conduct a class sometime this summer in bicycle riding for the children of the community.

Kittrell, a long time friend of the speaker, introduced Mr. Gene Booth, superintendent of Kinston City Schools, who chose for his topic, "The Crisis in American Education." "The crisis in education," said Mr. Booth, "cannot be separated from the crisis in contemporary society. Education cannot lift society by its bootstraps nor can it fall to be influenced by the rather depraved taste of modern society. A spiritual revolution in our society will do much toward solving the crisis in education. Americans have learned to bridge the gap between great distances. Why cannot we learn to bridge the gap between individuals with a spirit of friendliness?"

Mr. Booth called attention to the fact that, the America is a very

young country, it has the oldest public school system in existence. To maintain this system, however, Americans are spending less than they do on whiskey, cosmetics or automobiles. Russia spends twice as much to perpetuate communism as the U.S. does to perpetuate liberty through its public schools.

Mr. Booth has very recently represented the U. S. government in Japan as director of education. There he saw what the lack of freedom has done to the individual and urged his listeners to preserve the freedom which they have here in America.

Dr. George Pasti Guest Speaker At Clio Club

A short business session was held, presided over by Miss Elizabeth Norman, president. The club voted in favor of having Book Club Day this year and that it be in the form of a tea. Probably not one person in a hundred believes that life ends forever with the last breath. From the most learned to the most ignorant, there is the feeling that somehow, somewhere, the enterprise of living we have begun here on earth continues after death.

But it is the devout Christian who, above all others, is influenced by this belief. He not only believes in the immortality of the soul; he does something about it. His decisions day by day between what he considers right and wrong are influenced by this belief. We are told that in the early days of the Christian Church it was the message of Christ's resurrection and the belief in the persistence of life after death which led to the phenomenal growth of the Christian community.

If you believe in the immortality of the soul, let that belief do something to you day by day.

Who Will Shoulder The Responsibility?

North Carolina was struck this week by tragedy as two high school youths shot to death their principal and a fellow student on the school campus. Yesterday another school youth in another section of the state threatened the lives of truant officers and exchanged gunfire with police officers before surrendering.

What is the youth of the state coming to? Why this sudden outburst of dramatized gun play? Some people maintain it is the result of the literature filled with crime which children read today. Others attribute the condition to the detective programs which jam the radio networks and keep the attention of millions of children for hour after hour. Still others attribute the condition to the gangster and murder pictures which the children see in their favorite movie theatre week after week.

All of these may have a part in influencing a youngster to experiment with delinquency. But for the most part, the fundamental problem lies in the home where the children fail to receive the proper attention and the proper instruction.

Of the three North Carolina youths who made the headlines this week in shooting incidents, two were orphans, and one lived with his widowed mother.

Will such tragedy as has hit the state this week spread among the youngsters of the state? Only the parents of the state, through their actions toward their children, can answer the question.

An Expensive Quantity Of Red Tape

After struggling 15 months through government red tape, the Greenville Utilities Commission is on the verge of receiving final approval for a \$910,000 loan which has been tentatively approved for many months.

Now all that remains is for the aldermen and the members of the Utilities Commission to approve three stipulations which will clarify a question posed by Secretary Easterling of the State Local Government Commission . . . a question which threw a monkey wrench into the negotiations for the loan.

Even though the loan now appears in sight, the 15 months which have elapsed since the Utilities Commission began steps to secure the REA money have been costly indeed for the city and likewise for the 2,500 or more people in rural areas who have been delayed many months in securing electric service.

When the procedures first began, the members of the commission were given the impression that the loan would be granted within six months at the very maximum. The original estimates of the cost of constructing the 300 miles of rural lines proposed by the commission was set at approximately \$300,000. But since the time the estimate was made after the surveys of the territory were completed, the cost of materials and installation have added about \$100,000 to the original cost esti-

mate for the construction of the 300 miles of lines.

Had the negotiations gone through without delays, the people in the rural areas to be served by the new lines would have had electric service for many months. But now the critical condition of materials makes the installation of the new lines somewhat uncertain.

The government should be thorough in its investigation before loans from any federal agency are granted. But an undue amount of government red tape which seems ever present in negotiations with the federal agencies has in this instance cost the local Utilities Commission heavily, and has likewise penalized a large number of rural people who have been patiently waiting for electric power to be made available to them.

Small Print With A Big Meaning

There are lots of stories with morals; and there are lots of stories which make us realize just how gullible we, the public, are when it comes to matters of government action.

One of the best examples of the public's half-hearted interest in activities which affect local government is the one from Grand Island, Nebraska. A petition was circulated by the local newspaper asking the city council for a better recreation program. But buried in the petition, which was signed by 35 people, was the request, "that I be hanged by the neck until dead."

All of which goes to show that folks are apt to scan matters of importance and in most cases overlook the "small print" which may be significant.

For the most part, government action which the people push through will not bring to an individual a form of direct violence such as requested by the Nebraska petition. But there are many schemes which are harmful to the public interest that get support from a large number of people simply because the individuals giving the support do not look for the small print which may be concealed in the overall explanation of the matter.

Just as the petition in the small Nebraska town, there are a lot of public propositions which have hidden meanings. And in a lot of instances they are overlooked by the public at large. The adverse results of the hidden meanings usually don't come to light until the harm already has been done, and then preventive steps are tardy.

But the Nebraska incident gives a warning. Be wary of the person who asks your support for a proposition affecting your local government. Be sure you find any "hidden phrases" which may be well-cloaked in the overall proposition.

National Whirligig

News Behind The News

WASHINGTON, Mar. 15—Although Administration spokesmen condemn Senator "Joe" McCarthy's accusations as "the smear technique," the Democratic National Committee has inspired the same sort of strategy against Senator Robert A. Taft in a deliberate effort to weaken his chances for the Republican presidential nomination next year.

In the belief that millions of people resent the Wisconsin Senator's methods, the Democrats now charge that Senators McCarthy and Taft are co-conspirators, who are equally blameworthy. According to this theory, the Ohio Senator is willing to stoop to any sort of tactics for a party or personal advantage. They seek to destroy the impression that, no matter his other faults, Mr. Taft is a man of integrity and high principles.

It is significant that one of the first to link the two Republicans was Mrs. Roosevelt in her newspaper column. The same theme is now sung regularly by newspaper columnists and writers, who make no secret of their partisan sympathies and their antagonism to Mr. Taft. It is not necessary to mention their names.

OSTENSIBLY—Another group indulging in these same tactics consists of several feminine writers, who have made a heroine of Senator Margaret Chase Smith of Maine. They criticize Mr. McCarthy because he ousted the Maine member from a Senate subcommittee of which he is chairman. They hold it against Mr. Taft because she was dropped from the Republicans' Senate Policy Committee, which he heads.

Mr. Taft replies that she was bumped off the McCarthy body without his knowledge. Anyway, he says, he has no right to interfere with a committee chairman. And in view of her disagreements with the leadership on so many issues, she was no more entitled to a place on the Policy Committee than a Dictocrat is to membership in the President's Cabinet.

COMPLIMENT—The Truman-Boyle shift of strategy amounts to a high compliment to Senator Taft in a reverse sort of way. It also marks a distinct reappraisal of political values and possibilities on the part of the White House politicians.

Only a few months ago, the President's friends and advisers expressed eagerness for a Taft nomination in 1952, figuring that Mr. Truman could defeat him easily.

But that was before Korea, and before Senator Taft was reelected by an unprecedented majority in the face of united labor opposition. It now appears that they look on "Mister Republican" as their most dangerous foe, with the exception of General "Ike" Eisenhower.

It also reflects Administration admission that its ancient demand for Taft-Hartley repeal is a dead issue. Abandoning that anti-Taft weapon, they now believe they can damage him most seriously by tying him to the "McCarthy smear." In other words, to echo a familiar phrase, they mean to discredit him on the theory of "guilt by association."

LID—The inside story of the more explosive chapters of the Fulbright investigation of R.F.C. indicates that both the Senate investigators and Administration defendants engaged in questionable political practices. It does no credit to the Fulbright group, despite the hygienic nature of their disclosures.

The more recent revelations, which show definitely that the White House and the Democratic National Committee brought influence on R. F. C. directors, would have been brushed up if President Truman had not characterized the Fulbright report as "asinine" at a press conference. That so infuriated the committee that it decided to "blow the lid."

LATE—Previously, Chairman Fulbright had tried to persuade Mr. Truman to get rid of the present directors by placing it under a single administrator. He made several trips to the White House on this question. He always refused to discuss his talks with Mr. Truman after each visit.



Somebody Told Me

Since so many people kick Uncle Sam's Army, I think it's about time I wrote a column and attempt to counteract some of those kicks. After serving for 39 months in World War II, I naturally have my share of kicks against the Army, but we have to reason this thing out and decide whether or not the Army is such a bad organization to be in.

There are several reasons why it's a good deal. In my opinion, the main advantage is retirement in 20 years under a well-paying plan, or in 30 years on an even better-paying plan. Another good reason is that our army is by far the best dressed, best equipped, best fed, and most progressive in the world.

The main kicks against the Army during WW II came from GIs who wouldn't have been civilians under any circumstances. When an emergency comes, it's the American spirit to get into gear and put out the fire. But in the process of getting into gear fast with millions of men, a great deal of regimentation is necessary. And it's the American spirit to dispense with regimentation. There's where the kicks come.

The Army's caste system is necessary in order to develop discipline, but that system is also responsible for many complaints. During WW II there were officers who were commissioned after two or three years as enlisted men, and many of them declared, "I'm going to be a good Joe, eat with the men, and let them forget all of that 'sir' business." Brother, it doesn't work. Enlisted men lose their respect for officers who are loose with the military manner, and invariably take advantage of the officer who tries to be a good Joe. There are some who appreciate the informality of officers, but there are others who are given an inch and take a mile.

Around Capitol Square

DEMOCRACY — The right of petition and the right to be heard on legislation affecting any citizen are cardinal principles of democratic government. Public hearings on pending bills are granted by committees of the general assembly upon request of any interested persons, firms or corporations. These hearings are time-consuming, boring to legislators and regular attendants upon committee meetings, and more often than not accomplish no real purpose toward constructive legislation. It is traditional policy to afford every person the right to have his say before a tax is levied upon him; and to permit every agency, department or institution of the state to be heard before an appropriation is made for any desired purpose, and to let any interested citizen speak for or against proposed legislation in which he is interested. That takes time and repetitious arguments are boring—especially when made by a person who obviously knows very little about the subject under discussion. But it is democracy and it is the North Carolina way.

SLOW — Democratic processes are bound to be slow. Majority vote of the general assembly, like majority popular vote among all the people, depends upon intelligent comprehension of the issues involved, and this understanding can be obtained only by discussion and study. In a dictatorship, where one man only has the power of decision, which is often grounded in prejudice, there can be swift action. Sometimes under our system of prolonged public hearings committee chairmen are accused of "railroading" bills without affording adequate opportunity for individual presentation of views by every citizen who wants to say something. It is obvious that if the chairman did not call a halt sometime the legislature could never get around to the job of voting on the measures. For that reason it is sometimes hard to tell where democratic processes are interrupted by dictatorial tactics; or where failure of the legislature to heed suggestions of administrative officials constitutes rebuff rather than acceptance of responsibility.

ILLUSTRATION—Consider, for example, the meeting of a house judiciary committee Tuesday of this week. The committee regularly meets in the council room of the state bar in the justice building. Sessions of the board of law examiners required that room Tuesday and the committee had to transfer its meeting to the hall of the house of representatives. There were three public hearings scheduled—on the question of extending juvenile court jurisdiction to 17 years olds; the urban redevelopment or modified "slum clearance" bill, and matters dealing with the board of barber examiners. It was agreed that since the house would convene at twelve o'clock only 30 minutes could be given to any one subject. Everybody knew that wasn't enough time to let all those speak who desired to say something on these important matters. Everybody also realized that unless some limit were fixed the general assembly could not get through its business before mid-summer—if then.

What Other Papers Are Thinking

BORDERING ON TREASON (Williamston Enterprise)
A nationally-known newspaper columnist and a contemptible rabble-rouser of the first water recently went on record as apologizing for his part in advancing the sale of government bonds in World War II. He charged that the government had "sold out" the purchasers.

What the nasty scoundrel overlooked is that Americans got their money's worth when Hitler and Company were wiped out. If the dollar isn't worth but 50 or 60 cents today, the government isn't reneging on its obligation—it is paying dollar for dollar. But Westbrook Pegler apparently would have the government pay back two for one, plus interest and then turn around and tax the little man to make up the difference.

If anyone's actions ever bordered on treason, those of Pegler, in our humble opinion, border on it. Yet, he is the haughty guy who questions the patriotism of everyone else. We had rather bargained for bonds back yonder knowing that every dollar was a direct contribution but would help our country than to have played the black markets with great success while our country went down in defeat. Pegler has a right to state his opinion, but in our estimation he and others of his ilk are doing more to cause confusion and wreck the country than all the strikers and commies put together.

CLASSIC CASE (Raleigh News & Observer)
There can be rejoicing that no children were injured in an accident near Kinston when a school bus collided with a car driven by a school teacher. This is, however, something in the nature of a classic case. School teachers are no more subject to safety regulations than anybody else. School bus drivers, though they move precious loads, should not be subject to special penalties. But where a school teacher, who does have a special duty to teach safety, and a school bus driver collide, the case should not be dismissed as unimportant because no child was hurt. The responsibility should be carefully determined and seriously dealt with. If we can't stop collisions between school buses and school teachers, we might as well stop trying to prevent any accidents at all.

Business Today

By ELMER ROESSNER
Some economists are giving considerable uncomfortable thought these days to the inventory position of American business. The totals are so high that it seems certain that some firms must be overloaded.

Department of Commerce figures put the total value of inventories at \$63,100,000,000 as of the end of January, compared with \$51,800,000,000 at the same date a year earlier. This indicates an increase of more than eleven billion dollars, or 22 per cent.

Manufacturers' inventories showed an increase of \$9 billion dollars; wholesalers, \$2 billion; and retailers, \$2 billion.

Increased book value, of course, is responsible for a large part of the rise. But the increase is so much that it also looks as if hoarding was also a factor. This is corroborated by the fact that warehouse space is filled in many cities.

The coming cuts in civilian production will tend to liquidate abnormally high inventories. A retailer, wholesaler or manufacturer with a warehouse full of toasters will be in a good position when restrictions on copper, chrome and steel make toasters hard to get—provided, of course, that he can finance his inventory.

It is in financing of unwieldy stocks that the danger lies. When our wholly putative merchant with a warehouse of toasters is called upon to meet his bank payments, he may have to start selling toasters fast, regardless of future shortages. This could result in dumping and cause other merchants and banks to get nervous.

That possibility isn't entirely theoretical. There have been spotty breaks in television prices as some dealers struggled to clear stocks before new models arrived, or for other financial reasons. One day's trade paper reports include: "Shortage threatens no longer scarce Chicago bedding dealers," "Philadelphia lamp producers find customers, not stocks, short," "New York appliance dealers fear clearance ads may hit already slumping sales," and "Heavy drapery stocks concern stores, N.Y. resident buyers report."

Those reports were culled out of many most of the others were bullish. But they were disquieting, especially in view of the fact that many consumers are "bought up" and are equipped to sit tight for a while.

A large New York store now has ten hat bars in operation. "The new craze with American women is buying hats at bars," it says in advertisements.

Hal Boyle's Column

Washington, March 15—(AP)—This is the day millions of Americans swear, "Never Again." Never again, they say, will they put off making out their income tax returns until the last day.

But they're other put-off-ers will. Every year, the income tax people say, millions do not get the dismal chore done until the last minute.

It would be worse if it weren't for the fact that so many are entitled to tax refunds.

"I don't know why," said the income-tax man coyly, "but people who have money coming to them usually get their returns in early."

Although the income tax has grown into its present size, only fairly recently, its roots go far back.

In 1692 England had a tax on farm land income. But not until 1799 did William Pitt put through an outright income tax.

When the proposal came up for a graduated income tax in England, such as we have here now, it met with considerable criticism. (Under a graduated tax, those with higher incomes not only pay more taxes, but they also pay at a higher rate.)

The U. S. had its first national income tax during the Civil War. Its biggest year was 1866 when 460,170 persons paid \$73,000,000.

Compare that with 1950 collections. Some 50,000,000 persons paid \$1,937,000,000. Corporations clipped in another \$9,927,000,000. We have advanced-reduced (take your pick) a long way.

States have had income tax levies since 1789. Massachusetts, South Carolina, Pennsylvania and Virginia had income taxes before the Civil War.

But it remained for Prohibition to put most states into the income tax business. They made up in income taxes what they lost in liquor revenues.

The national income tax died after the Civil War, but it had a revival in 1894.

When it was passed, as part of a tariff bill, Rep. David Albaugh De Armond (D-Mo) purred:

"The passage of the bill will mark the dawn of a brighter day, with more of sunshine, more of the songs of birds, more of that sweetest music, the laughter of children well fed, well clothed, well housed."

"Can we doubt that in the brighter, happier days to come, good, even-handed, wholesome Democracy shall be triumphant?"

The birds didn't sing for everybody, though. Mark Sullivan says in "Our Times" from which I'm getting most of this information (R-Ohio) said:

"This attempt to array the rich against the poor... is Socialism, Communism, Devilism."

Joseph H. Choate, a prominent lawyer, sniffed that it was nothing but a "Communist march."

The Republicans, as the party of the Outs, naturally blame the Ins for everything. Listening to the arguments, one gets the idea the Democrats invented taxes.

STORE COLLECTIONS UP, BUT SO WERE SALES

The Federal Reserve Board reports that department store charge account collections were 12 per cent higher in January than they were a year ago. At first glance, that seems to indicate people are paying their bills faster.

However, December department store sales were 12 per cent higher than a year ago, so acceleration of payments is pretty small.

GEORGIA SALES TAX PREVIEW U.S. LEVY

Georgia, in adopting one of the highest sales tax ever imposed, will serve as a sort of guinea pig for the proposed federal sales tax.

Other states have sales taxes, but few have the 3 per cent rate imposed by Georgia and few apply it so broadly. Beginning April 1 all retail transactions, admissions, utilities and transportation will be taxed, as will gasoline, beverages and cigarets, already subject to other state taxes.

The effects on sales, standards of living and attempts at evasion may give an idea of what will happen if a Federal sales tax is enacted.

SUMMER SUIT INCREASE FASTER THAN OTHERS

More men are wearing summer suits, the Clothing Manufacturers Association of the United States says on a basis of Census Bureau figures.

Total production of men's suits rose 19 per cent last year, but the gain in summer suits was 26 per cent. Rayon and other non-wool suits made the largest gain.

Washington—Peppery Virginia-born Lady Astor, first woman member of the British Parliament, went on what she calls a "ramble" here the other day and dished up some of her choice opinions on men and the world in general.

In this country on private business, Lady Astor—often a heading target for varying degrees of censure and praise—bluntly announced she doesn't care what people think about her. "It's what I think about them that counts," she told wives of the nation's lawmakers and went on to say what she thought about their husbands.

"Some politicians don't live right, but who is living right?" she asked. "Wives of politicians should be proud of their husbands. The average politician is far better than the man who sits at home and criticizes him. I'm not a socialist," she rambled on. "I loathe them. But I'm for social reforms."

Lady Astor discussed movies, modesty, cowboys, Communism, psychiatry. She said she was glad she was born before psychiatrists became fashionable. Her mother married at 16 and said she didn't want children, but Lady Astor reported:

"She had 11, of which I was the seventh unwanted. I think a child should be taught obedience and right from wrong."

Her Ladyship also told a couple of jokes off the record and said in winding up that she was "tired of people who forget that America's foundations came from England."

One of the five beautiful Langborne sisters of Virginia, she will be 74 in May. Trim, erect, spirited. Married 15 years younger. Married at 18 to Robert Gould Shaw, she was divorced six years later and took her son to England, where in 1808 she married Waldorf Astor, conservative member of Parliament.

The Astors have four sons and a daughter. They live at Cliveden, a country estate near Plymouth. She was Plymouth's member of the House of Commons for 25 years, until 1945. Her husband is its Lord Mayor.

Climate, Soil Govern Choice In Garden Crops

The home gardener has to take several factors into consideration when selecting the vegetables for his garden.

First, of course, are climate and soil conditions. Avocados won't grow successfully in Wyoming. But Wyoming gardeners raise some mighty fine corn-on-the-cob.

So the crop has to fit the local climate and soil. The advice of experienced gardeners in your neighborhood, or of experts at your state agricultural college, will help you select the vegetables that will grow in your garden.

After the vegetables are chosen, the gardener then has to decide what varieties of these he will plant.

Seed growers constantly are creating new varieties, some resistant to disease and weather conditions; others capable of producing larger crops and still others tailor-made for certain regions.

The department of agriculture has a list of vegetables and varieties that it recommends to home gardeners. But it also warns that such recommendations, on a nationwide basis, have to be fairly general because of the varied conditions throughout the country. Many of these recommendations will be of old, well-established varieties.

In addition to the old reliables, there are many new varieties that the experienced gardeners of your neighborhood, or local agricultural experts, can tell you about.

For instance the government's model garden plan calls for the planting of Earliana and Marglobe

Americans Earn Highest Income Of All Peoples

Lake Success—(AP)—United States citizens enjoy by far the world's biggest average per capita income—\$1,450 a year—recent U. N. survey states.

The survey, made by the U. N. Statistical Office, covered 70 countries having about 90 per cent of the world's population and still more of its income. Figures were based on official and semi-official statistics for 1940 and on tentative estimates prepared by the U. N. Statistical Office.

The survey also revealed these facts: Eight countries having one tenth of the world's population received in 1940 over half the world's income. They were the United States, Australia, Canada, Denmark, New Zealand, Sweden, Switzerland and the United Kingdom.

Kuala Lumpur—(AP)—Communist terrorists who lay down their arms and surrender to the British are being entertained at tea by the Selangor branch of the Malayan Chinese association.

Pactolus Ruritan Hears Potato Crop Endorsed

Pactolus, March 15. The Pactolus Ruritan Club, meeting in their regular monthly session Monday night at the Community Building had as their guest speaker, Jesse Summers, Extension Potato Specialist, and pun and pun, Martin and counties.

Guest of the club for the night was H. S. Ferguson, farmer of Route 3.

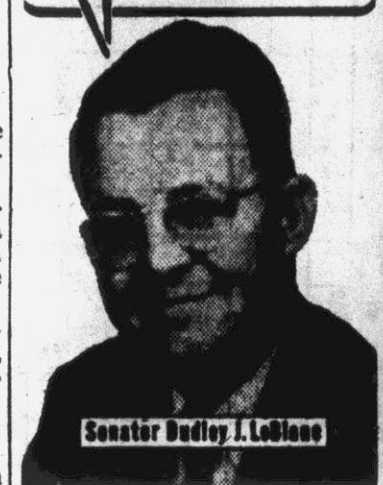

two were one, and explode both alibis.

Five Are Freed In Flogging Of 2 Men

Conway, S. C., March 15—(AP)—Five men charged with flogging a crippled farmer and his nephew went free in General Sessions Court yesterday when a jury acquitted three of them and the two others were exonerated by directed verdicts.

The five were charged with conspiracy and assault and battery of a high and aggravated nature. Conviction would have carried a maximum penalty of 10 years.

Gore and his nephew, J. C. Gore, reported that they were dragged from their homes Jan. 17 by a gang of robed and hooded men. J. C. Gore is a World War II Purple Heart veteran.

The Gores said the men took them to a schoolyard near the Gore home, and beat them, after proclaiming "Oh, God, we hate to do this."

Gore and his nephew said they were told the beatings were for neglecting their families.

The jury deliberated one hour and 45 minutes before returning innocent verdicts for J. C. Creel, a service station operator, Harvey Johnson, a hardware store operator, and Jack Causey, a mechanic.

Judge James M. Brailsford directed innocent verdicts for Dr. A. J. Gore, an eye specialist, and Almond Chestnut, a farmer. Lawyers for Gore and Chestnut contended the state had insufficient evidence against them.

One other man, D. C. Guyton, also was indicted in the flogging case, but was not tried yesterday.

A parade of witnesses testified that Causey, Creel and Johnson were at places other than the schoolyard near the Gore home when the floggings were said to have taken place.

Then Sam Gore said he wanted to withdraw charges because "I felt uneasy about my own self."

S. C. Peach Crop Unhurt By Frost

Spartanburg, S. C., March 15—(AP)—Frost hit this big peach belt last night but did not ruin the crop. An early survey indicated the potential yield was not reduced to below good crop proportions.

Henry Gramling, a leading grower, said tiny peach formations that developed from early blooming suffered most and some buds not yet open were hard hit.

Fresh buds just opened apparently were not harmed. Gramling referred to the heavy bud crop and said many orchards could have a 75 per cent kill and still have a crop left, with larger and better peaches.

It was the consensus that if growers got through last night all right, that a good crop could be harvested. Another frost between now and early April could cause great damage, however.

The normal yield in this belt is 7,000 carloads. Last year the crop was ruined by a late frost and damage was estimated at \$8,000,000. There were only 2,000 cars in 1949.

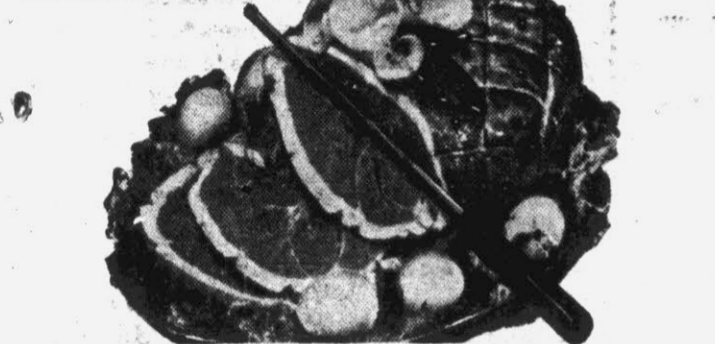

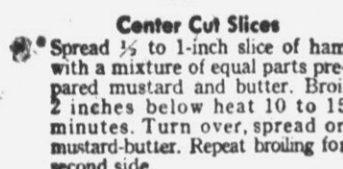

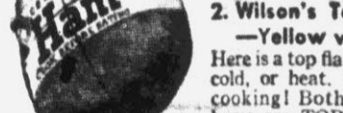

Red-hot Seton Hall and Brigham Young, champion of the Sky-line Conference, tangle in the other game at 8:30 p. m. The winners clash Saturday for the championship.

Seton Hall, impressive conqueror of high-scoring DePaul and North Carolina State, is rated by rival coaches as the hottest team in the tournament at the moment.

However, St. John's playing in the friendly confines of the Garden, remains the tournament favorite.

Dayton will provide the test for the No. 1 seeded entry. The Ohioans showed plenty of class and drive in eliminating Lawrence Tech, 77-71, and four-seeded Arizona, 74-68.

Meineke, a 6-foot-seven 170-pounder who is also a tremendous rebounder and floor man, scored 30 points in the first game and 37 in the other. His 67-point total makes him high man of the meet.

Coch Tom Blackburn of Dayton said, "St. John's impressed me as a great club, showing a lot of poise and fine coaching. We can take them only if Meineke can outdo Zawoluk."

NAIB Backs Proposal To Prevent Team Raids

Officials Miffed After Tourney Participant 'Lifted' By Sponsors Of Another Basketball Tournament

Kansas City, March 15—(AP)—The National Association of Intercollegiate Basketball has endorsed a plan designed to prevent "raids on potential NAIB teams" by other tournament sponsors.

The NAIA tournament and the National Invitation Tournament were mentioned specifically.

NAIB officials were miffed last week after Montana State, a previous NAIB tournament participant and counted on for the current meet, was elected as a team-at-large for the Western NCAA play-offs here March 21-24. No official complaints were made, however.

Under the plan endorsed by the executive board yesterday, the NAIB's 368 members will be required to state their post-season plans starting next season. Failure to do so will result in a two-year ban from the NAIB.

It also was decided that all teams would be required to participate in district playoffs in order to gain a tournament berth. In the past, several districts have named conference winners and tournament champions to the field of 32 teams here.

The executive board also dissolved the district at large and the extra spot was given to Texas. In all future tournaments Texas will receive two bids, with the line dividing the state extending approximately from Wichita Falls to San Antonio.

Two sparsely settled areas of the West, which formerly comprised two districts, have been realigned into District No. 6 which includes Colorado, Nevada and Utah.

Dykes To Train Young Umpire In Florida Camp

West Palm Beach, Fla., March 15—(AP)—Jimmie Dykes, manager of the Philadelphia Athletics, has taken on the job of getting umpire Joe Paparella into form for the 1951 season.

"Young man," Dykes greeted Paparella on his arrival at the A's training camp here, "Have you ever been to spring training with me before?"

"No, sir," replied the arbiter, grinning.

"Then stick around and pay attention," Dykes commanded. "By the time we break camp, we'll have made an umpire out of you."

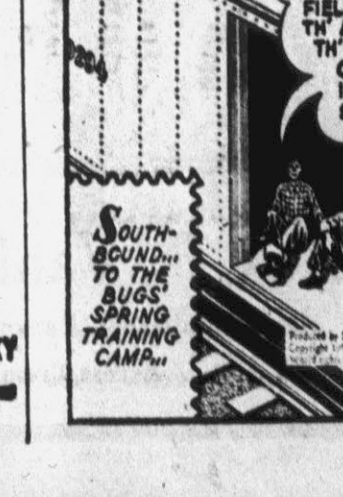

Iran Parliament Approves Plan Nationalize Oil
Tehran, Iran, March 15—(AP)—Iran's Parliament unanimously approved today a proposal to nationalize all the nation's oil resources, including the wells of the huge, British-owned Anglo-Iranian Oil Company.

By a standing vote the Majlis (Parliament) confirmed the decision of a special parliamentary oil commission endorsing nationalization and gave the commission another two months in which to work out specific details.

Some deputies said there still was a slim possibility that actual nationalization might be averted by negotiations between the Anglo-Iranian Company and the government. But the vote today put Parliament on record as approving the take-over.

Warmer Weather Ahead For South
Atlanta, March 15—(AP)—The South, beset the past few days by some rough wintry weather, will gradually warm up this weekend and get back to normal.

The weatherman forecasts sub-freezing temperatures tonight for most of the southeast. But the mercury, he says, will start climbing tomorrow and will keep on the upgrade Saturday and Sunday.

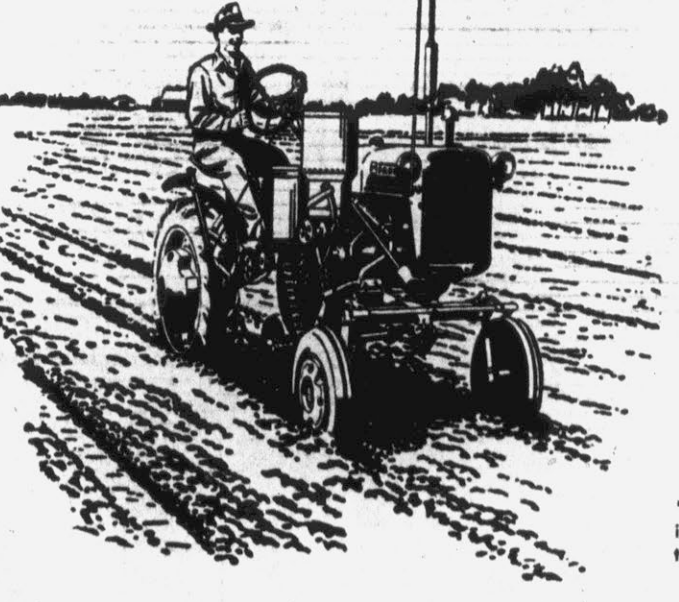
