Those under criticism, including his administrative assistant, Donald S. Dawson, are honorable—all of them are, Mr. Truman said.

Two calls for Pitt men for Army pre-induction examinations, one Wednesday and the other today, have left the county manpower pool pretty well drained.

Washington, March 16—(AP)—House investigators looked for new leads today in a probe which has turned up back at high prices surplus military goods it sold cheap in Germany.

Members of the committee said "the ringleader" in some big surplus goods deals was a Briton named George Dawson.

And Chairman Bonner (D-NC) said the group had received testimony that U.S. goods were being resold to the U.S. by the British Ministry of Supply. He raised the question whether this could be "morally right."

Dawson's name figured repeatedly in testimony about intricate but profitable dealings in trucks, auto assemblies, electronic and radio equipment and other materials in demand since the Korean war's outbreak.

Rep. Curtis (R-Mo.) commented: "Our preliminary information is that George Dawson has made over \$1,000,000 in this business."

Secretary of the Army Pace told the committee surplus army equipment costing \$1,000,000 was turned over to the Western Germans in 1947 and 1948 at 21 cents on the dollar for disposition by a German state corporation, "STEGS."

After fighting started in Korea, Pace testified, all surplus sales were frozen Sept. 15, 1950, and about \$75,000,000 worth of equipment "recaptured" by the army.

"As of yesterday (Wednesday)," Pace added, he had ordered the rest frozen.

A Broader Alliance

Mediterranean Area May Be Eventually Included In North Atlantic Defense System; Military Viewpoint; Diplomatic Problems Involved In That Area

General Eisenhower told the Senate Foreign Relations committee, just before going abroad to assume his North Atlantic command, that from a strictly military viewpoint he would like to see Spain, Turkey, Greece and Yugoslavia brought into the setup. His point was that if these countries were backed by strong American air and sea forces, the Atlantic Pact countries would have "a really strong flank instead of a weakness."

### Find Three Dead In Locked Garage

Greenwich, Conn., March 16—(AP)—Mrs. Winifred Rockefeller Emery, a grand-niece of the late John D. Rockefeller, and two of her daughters were found dead last night in the garage of their home here.

Police said the socialite wife of Brooks Emery, president of the Foreign Policy Association, locked herself and her daughters, Winifred, 12, and Josephine, six, in the garage and after starting the motor of one of the three cars in the building placed the two girls in the rear seat of another car. Her body was found lying on the garage floor between the two cars.

Police Captain David W. Robbins said that the triple-tragedy was undoubtedly murder and suicide. Dr. C. Stanley Knapp said death of all three was due to carbon monoxide poisoning.

The tragedy was discovered shortly after 8 o'clock last night when a maid who had spent the day in New York returned to the estate. Unable to find Mrs. Emery, she tried to enter the garage in which she had heard a motor running.

The maid, Clementine Zeller, became alarmed when she found the garage door locked. She telephoned to Mrs. Emery's sister, Mrs. Jean Model who lives nearby. Mrs. Model, unable to leave her home at the moment, called Mrs. Avery Rockefeller who called police.

## Strength for the Day

MEASURING STICKS

The apostle Thomas was a doubter. He is spoken of only three times in the New Testament, but always he is presented as a fine and courageous man yet one who could never bring himself to accept anything on faith. He always wanted to have things "proved" for him. When Jesus rose from the dead, Thomas declared that he would not believe even if he saw the risen Christ. He would have to touch him—feel the print of the nails in his hands and thrust his hand into the wound in his side.

The great Danish sculptor Thorvaldsen has pictured Thomas as a man with a measuring stick in his hand. He demanded that everything come up to his measurement. The measurement which other people applied to situations meant nothing to him. There was only one kind of valid proof, and that was the proof he demanded. Furthermore, it was physical proof—the testimony of one or more of the five senses.

When Thomas beheld the risen Lord and had the opportunity to put his measuring stick against that divine figure, he threw the measuring stick away and made a confession of faith which is unparalleled in the whole New Testament. He referred to Jesus as "My Lord and my God." The chronic doubter had come to see that there are values in this universe above his power to conceive—measuring sticks more accurate than his.

## So Many Owe So Much To So Few

The title "Doctor of the Year" which has been accorded Dr. E. Bruce Beasley of Fountain for the second time in the physician's career is indeed an honor coveted in medical circles, and an honor which is held in high esteem by all the people of Pitt county.

In selecting Dr. Beasley as the "Doctor of the Year," the Pitt County Medical and Dental Society has indeed chosen a man who has devoted his life to the welfare of the people of the community in which he lives. For the past 38 years Dr. Beasley has ministered to the people of the Fountain community. He has proved himself a leader not only in the field of medicine, but also in phases of community activities.

In this day and time, the physicians who usually get their names jotted down in the medical archives are the specialists who perform delicate operations or the physicians who discover new drugs for combating disease. But the man who keeps the community active and on its feet through summers and winters is the general practitioner . . . the man who was once known as the "country doctor."

The general practitioner is the physician who is close to the hearts of the people of the community. He is the doctor who works hard all day and far into the night to tend the sick. He is the doctor who is called any hour of the day or night in all sorts of weather . . . and always responds to the call.

The County Medical and Dental Society have indeed selected a physician worthy of the distinction "Doctor of the Year." The people owe homage not only to this physician who has been honored by his fellow doctors, but likewise to all the physicians of Pitt county who toil long hours to keep the people of the county in good health.

The doctors in Pitt county are relatively few, but the service they render is felt in every home in the county.

## The Bonus Due The Veterans

Do the North Carolina veterans of World Wars I and II feel that the state owes them a special bonus for having served in those global conflicts? Do the veterans feel that it is the obligation of the state to hand over to each of them a fat check as a token of appreciation for helping preserve the freedom of this nation?

We haven't polled all the veterans of the state, but we believe both questions would be answered negatively by the veterans.

Most of the veterans of the state probably could put to good use that \$500 or \$750 they would receive under the legislation which has been proposed in the General Assembly. But such a token of gratitude is shallow indeed.

For the most part, we believe, the veterans of World Wars I and II were keenly aware of the peril which this nation faced when they were called to arms for the protection of the American way of life. They answered the call, not because they expected the state to pay them in dollars and cents for the hardships and sufferings which they would endure; but so that a way of life which they wanted for themselves and their children would be preserved on the face of this earth.

The veterans who have answered the call to arms once during the past decade want most of all a peaceful world in which people may live under freedom. The veterans who answered the call to arms 34 years ago watched their sons march off to war a quarter of a century later because of the mistakes which the leaders and the followers of this nation and the world had made. They are reluctant to see their sons leave once more for the battlefields . . . or their grandsons earmarked for death in a foxhole.

There is not a group in North Carolina more keenly aware of the pricelessness of freedom and the American way of life than the veterans. Neither is there a group in North Carolina which is more keenly aware of the horrors of war.

North Carolina's obligation to her veterans can not be paid in dollars and cents. Rather it must be paid by the citizens in the preservation of the American way of life for the posterity of this state, and through efforts to prevent the necessity of again sending thousands of young Americans to the slaughter blocks of the shell-torn battlefields.

## National Whirligig

News Behind The News  
By RAY TUCKER

WASHINGTON, MAR. 10—The Administration's apparent indifference toward the problem of nationwide racketeering and alleged use of improper influence at Washington will be attacked from a fresh angle when Attorney General J. Howard McGrath and his aides appear before House-Senate Appropriations Committees to justify increased funds for the Justice Department.

Treasury Secretary John W. Snyder will be subjected to the same sort of cross-examination, in view of disclosures that big-time gamblers and notorious underworld characters "got away with murder," as Senator Estes Kefauver notes, in evasion or underpayment of income taxes.

IMMUNITY—Two of the most successful gambling operators and income tax evaders—the late "Jimmy" La Fontaine and Sam Beard—conducted their business inside and on the outskirts of the Capital. Although now charged with having defrauded the government of more than \$5,000,000 in taxes, both seemed to have enjoyed a peculiar immunity for their gambling and financial operations.

Beard was molested twice, serving a total of six years in two stretches. Despite this evidence of his activities, he is now being sued by the government for a total of \$4,300,000 in taxes, interest and penalties. The La Fontaine estate recently turned over \$1,000,000 of unpaid taxes.

RECORDS—The dates in these chapters of crime and punishment are interesting. La Fontaine defrauded the government from 1932 to 1950, according to the official figures. The checkup on him was not made until last year, or almost a year after Senator Kefauver began to reveal the extent of the alliances between organized crime and organized politics.

Beard served eighteen months for income tax evasion, and paid a \$12,500 fine, but that was back in 1933, and the case against him was made during the last year of the Hoover Administration, according to the records.

In 1936 he served 33 months for a gambling conspiracy conviction. The current \$4,300,000 action covers the years 1944-1947. Both men were relatively small shots, compared to bigger game wounded by the Kefauver investigators.

INTERSTATE—Attorney General McGrath will undoubtedly argue on Capitol Hill, as he has in the past, that the violations uncovered by the Kefauver Committee related to local or state laws, and that they did not fall within his jurisdiction.

He took that attitude when he hurriedly called a conference of local and state officials here in an attempt to head off creation of the Senate committee.

But every speaker at that powwow, including Mayors, Governors and police officers, warned him of the interstate character of the gambling syndicates' operations, and their use of interstate facilities to conduct their operations out of New York, New Jersey, Miami, Chicago, Kansas City, St. Louis, Los Angeles, etc.

HELPLESS—Mr. McGrath's conferees also emphasized that an orgy of crimes of a definite federal nature had been spawned by the conditions they described. They referred to gang killings, income tax frauds, bribes of public officials, divisions of evil territory, illicit liquor deals, interference with federal elections.

They told him that they were helpless to cope with the situation because it was a national rather than a local problem. But the only result of their analysis of the nationwide crime wave was a McGrath proposal for enactment of an anti-slot machine law. Although these profits constitute only a small fraction of the underworld take, and so far that is the only official result of the Kefauver revelations.

DUTIES—Few members blame J. Edgar Hoover, Director of the Federal Bureau of Investigation, for the Administration's failure in this field. They recognize, being politicians themselves, that he must take orders from the Attorney General, and that he cannot initiate action which might prove politically embarrassing to the higherups.

But it is pointed out that, according to the official statement of departmental duties and functions, "the Attorney General . . . is chief law officer of the United States. . . . The Director of the Federal Bureau of Investigation has general charge of the investigation of offenses against the laws of the United States."

KNOWN—The key word is "investigation." The Attorney General can always ask the FBI to investigate conditions which even remotely suggest that federal laws are being violated. Mr. Hoover's agents all the time in pursuit of other activities. They have known for years of the facts which Senator Kefauver has brought to the surface.

Instead, FBI agents have been chasing bank robbers, and tracking down Communists. While this is important, in view of the tremendous increase in the number of agents and appropriations for this bureau, it still had plenty of men for getting the goods on the criminals fingered by the legislative branch of the government.

Incidentally, the total amount of money stolen from banks by the FBI's pet criminals does not begin to match the gamblers' estimated annual loot of \$20,000,000,000.

Somebody Told Me that last night's column boosting the Army was an attempt to sell myself, since I stand a good chance of being called with the 13,000 reserves on tap to leave soon.

"You're mighty right," I replied, "when you can't change something, you might as well get satisfied with it, and fast." Never will I forget the conversation I had with the Rev. Bob Bradshaw when I was home on leave during WW II. At that time Mr. Bradshaw was minister of the Jarvis Memorial Methodist Church here. We were discussing the war, and all the time the boys in service were losing from their families, education, or businesses.

"Now wait a minute, Jack," he said, "let's don't say that the boys are 'losing' that time. After all, all life is living, no matter what you're doing and where you are."

Mr. Bradshaw had a point that deserves emphasis. Life has certain rewards, no matter how hard times are, or how out of place you might feel. You must admit that it's not often that I get philosophical on you, but no one should feel as if they are "losing" part of their lives, and that point should be made.

Most Greenville people realize that Mr. Bradshaw was known affectionately by Greenville's young people as "Uncle Bob." When Alice Ruth Bundy of Greenville and Johnny Harper of Rocky Mount were planning their marriage, I told Johnny, "Uncle Bobby married us, too. He has such a mild manner that he puts you completely at ease."

Before the ceremony Johnny and Uncle Bobby were in the "hole," where the preacher, best man and bridegroom sit while the singing is in progress, trying to make conversation to keep from getting nervous.

Being in a strange church and with a strange preacher, Johnny was trying to push the conversation. He knew if he stopped talking, it would seem like hours before the ceremony would be over.

"Mr. Bradshaw," Johnny commented, "you don't look very much like Mr. Edwards."

## Around Capitol Square

Raleigh, N. C. By LYNN NISBET Daily Reflector Bureau

RELIEF—In opinion of William Peek, superintendent of schools in Madison county, Dr. W. A. Sams, Madison's representative in the general assembly, is in need of financial assistance from the school teachers. Mimeographed copies of an open letter to principals asking them to solicit contributions from their teachers have reached Raleigh. Casual investigation indicates the letter is authentic, but that its distribution among members of the general assembly as well as among Madison county teachers is a Republican device to embarrass the Democratic school superintendent and the first Democratic representative from the county in 20 years.

NEED—The letter sets out that Representative Sams is a member of both education and appropriations committees, and is deeply interested in legislation pertaining to schools and school teachers; that due to a heart attack, the representative must keep his wife in Raleigh with him, and that the additional expense of maintaining her and necessary for taxi fares to and from the capitol, as well as paying somebody to assist him up the capitol steps, imposes heavy burden upon the doctor. "It is quite possible," says the letter, "that Dr. Sams may have to come home before the end of the session unless some of us who are interested in legislation which he supports can help him with his financial burden."

NOT A PARTY—The letter also makes it clear that the writer, Superintendent Peek, has not discussed the matter with Dr. Sams, "nor does he know of my intention to write it." It continued: "Further, I want every teacher to know that the suggestions contained in this letter are motivated in forthcoming educational legislation and that they want to keep those in Raleigh who have the interests of the school system at heart."

PRESSURE—The language of the letter contains no assessment or threat of reprisals for failure to come across, other than that implied in the fact the letter was written. One of the complaints of Republicans in connection with election contests in several mountain counties has been that school teachers were required to contribute to the Democratic party. Evidence of actual assessment or threat has not been adduced, but it is commonly accepted as true that solicitation has been made in some instances, at least. During the 1949 session a mountain county representative boasted that the school folks in his county had sent him some expense money. The practice was rather general during the prolonged sessions of 1931, '33 and '35. It was pointed out then that recipients of such assistance from special interests were in the same category as those using corporation retainer fees to pay legislative session expenses.

NEWSPAPERS—Thursday was newspaper day in the general assembly. The North Carolina Press Association mobilized its heavy artillery to oppose one bill and favor another pending before house judiciary committees. The bill designed to prohibit publication of the name of victim of rape was opposed, and another to prevent impounding and secrecy of pleadings and court orders—except in cases involving adoption of children and other domestic relations problems except upon agreement of all parties or upon order of the resident judge—was favored. In both instances the newspaper folks argued that the public has a right to the information sought to be withheld, and that the editors can be trusted to use discretion as to what is published. It was further argued that prohibition with respect to use of names and the keeping secret certain court records contravenes guarantees in both federal and state constitutions for freedom of the press. It was noted that proper zeal for protecting some persons, might well result in violating legitimate rights of others; and that libel laws afford relief for any person injured by publication of material that is false or maliciously damaging.

BIG GUNS—More than a dozen editors and publishers representing morning and afternoon dailies, semi-weekly and weekly newspapers, came to back up their spokesmen. Speaking against statutory infringements of a free press were President Henry Bell and Secretary Beatrice Cobb of the North Carolina Press Association; Mrs. Elizabeth Swindell, president of the Associated Dailies of the N. C. Press Association; Sam Ragani, chairman of the North Carolina News Council; William C. Lassiter, attorney for the state press association and its auxiliary groups; Galt Braxton and Lee Weathers, publishers of afternoon newspapers.

Meanwhile, it behooves all involved to accept the law, to make its provisions work as effectively as possible and to cooperate in a manner which recognizes the transcending public interest and the continuing problems which are entailed: problems which have interpretation and application of the law sharply to the forefront. The least that the political forces who have engineered this legislation can do is give their statutory child the opportunity to work out as best it can without further interference or harassment. The State Highway Commission's responsibility, with the act that it did not want become the law, is to carry on under its stepped-up assignment.

## Business Today

By ELMER ROESSNER

Future shortages of executive talent are worrying some boards of directors more than future shortages of manpower.

That the manpower situation may become serious is conceded, but it may not become critical. But the shortage of executives, ranging from shift foremen to executive vice presidents could be even worse.

Ewan Clague, Commissioner of Labor Statistics in the Department of Labor, recently estimated that a total of 4,000,000 men will be needed in defense industries by the end of year. In addition, by that time the armed services may have less than 1,000,000 men.

Against this need are 1,500,000 unemployed, plus the youths reaching employment age, older men returning to work, and several million employable women. In addition, the cutbacks in civilian production will divert many more workers to defense industries.

If this is not enough, overtime will help. Extension of the work-week from the present 41 1/2 hours to 45 hours, the World War II average, for 13,000,000 manufacturing production workers would be the equivalent to adding the production of 1,000,000 men.

But the need for executive abilities may not be so easily satisfied. Industry is losing executives to the army and to the Washington bureaucracy just at the time it needs more top men to manage the new plants in building and step up production. And most industrialists agree that, with few exceptions, it takes longer to make an executive out of a man than a craftsman out of a boy or woman.

Methods of locating and developing executive talent was one of the most frequently discussed problems at the recent meeting of the American Management Association in Chicago. There was a general agreement that management had better start programs for finding suitable material and training those who showed ability to lead.

"Management could afford, once, to assume that it would usually be able to find the right man when it needed him," James

C. Worthy, of the Sears Roebuck personnel department, told the conference. "It cannot so assume today, and those businesses which are not alive to that fact, and which are not taking steps to deal with that problem may find before very long that they have overlooked one of the vital conditions for economic survival."

TRAVEL TOPS SCOTCH AS DOLLAR-MAKER

American travelers are more important to Britain than American Scotch drinkers.

"Travel has become Britain's largest single dollar-earning business since the war," said Sir Harold Boulton, American representative of the British Travel Association.

The British counted 124,345 U.S. citizens visiting England in 1950, 38,839 spending 72 hours or less on the way to other destinations, and 11,000 Britishers back for a visit from the States.

300,000 AMERICANS FOOLING PEOPLE

Perhaps people are losing their hair faster these days. Whatever the cause, the toupee industry grossed \$5,000,000 last year and expects even larger sales this year, according to Louis Pader, large New York manufacturer.

He estimates 300,000 Americans wear them. The largest increase among men has been in the 35 to 40 age group, presumably to compete with younger men for jobs—or girls.

GOVERNMENT KEEPS ACCOUNTANTS BUSY

This is a wonderful year for accountants.

The rise in income tax cause thousands more taxpayers to turn to accountants for aid in getting but their returns.

Washington, March 10—(AP)—From February until November of last year, Walter Rogers of Pampa, Tex., busily ran for the job of representing his district in Congress.

## Washington Letter

Washington—Though she notes jokes about the high cost of living, the subject has long ceased to be a joke to American housewives and particularly to Mrs. John G. Lee of Farmington, Conn.

Mrs. Lee is president of the League of Women Voters of the United States. She is the mother of four children and has two grandchildren. She maintains a big family home in Connecticut and a small apartment in Washington.

"It's the average housewife who must fight against inflation," she says. "She is alternately furious and terrified at the rising spiral of inflation, which has not only knocked her household budget for a loop but has devalued her property and threatened her savings."

Mrs. Lee says the League of Women Voters, most members of which are average American housewives, is "determined to make its membership aware of the forces which bring on inflation, the disastrous effect it can have on the possible steps to avert such an economic catastrophe."

To do so Mrs. Lee and other leaders of the League have prepared a 23-page pamphlet called "Building Our Economic Defense." It will be used throughout the United States by the League's 100,000 members in some 2,000 discussion groups.

"Inflation has already cost the government three billion dollars in higher costs since the start of the Korean War," it states. "Such inflation is as dangerous as the most effective form of sabotage."

"This sad state of affairs has come about even before we have really mobilized for an all-out defense effort," Mrs. Lee explains. "As more and more factories turn to production of war materials, there will be fewer and fewer goods for Mr. and Mrs. America to buy."

The League pamphlet suggests the following ways to help save off what the League terms an "economic catastrophe," none of them very pleasant remedies, Mrs. Lee opines:

1. High taxes—Bigger armies, more airplanes and all the other items that mean more preparedness have to be paid for some time. If we pay for them now we will have less money with which to bid on the available consumer goods.

2. Stricter credit controls—This means goodbye to the "dollar down and a dollar a week" sort of thing. We'll have to save the money ahead of time to buy a television set or a new car.

3. Buy more bonds—Money in bonds is more likely to "stay saved" than if it is surplus in a checking account tempting us to new purchases.

# Brigham Young And Spunky Dayton To Meet In Finals

New York, March 16—(AP)—The Brigham Young "polished" poise against the never-say-die grit of little Dayton tomorrow night in the finals of the National Invitation basketball tournament.

Brigham Young, classy champion of the Skyline Six, is the favorite, but don't try to sell that merchandise to the lads from Ohio. These eager beavers, dark-horses at every pole, don't convince easily.

A howling crowd of 16,815 counted them out last night at Madison Square Garden when top-seeded St. John's collapsed there at the final whistle and carried them, crippled and reeling, into a five-minute overtime.

Dayton's two big siege guns—towering Don Meineke and fat, trickily Leland Norris—were on the sidelines for excessive fouls and two other stalwarts, Charley Grigsby and Dick Campbell, were hobbling around on lame legs.

With big Bob Zawoluk still in there shooting 'em for the Brooklyn jaxmen, Dayton's chances could have been purchased at any counter for a plugged nickel.

But the spunky Flyers whanged out a 69-62 overtime victory in the semi-final that long will stand as a monument to unadulterated pluck. They simply refused to be beaten.

Brigham Young moved into the title round on an entirely different pattern, chilling the blast-hot Seton Hall team, 69-59, with such graceful ease and professional finesse that the joust tended to be boring.

Seton Hall supporters probably never will be convinced that coach Honey Russell, a balding old pro, didn't lose the game for the New Jerseys before the first ball was flipped by starting Walt Dukes, his seven-foot Negro sophomore center.

Normally, Russell lets Dukes sit out the first few minutes of a game because the human broom-stick has a deep-seated aversion to opening up. This time the coach changed tactics.

"Walt has a superstition of something about it—never likes to start," Russell said. "But I don't believe in that stuff."

Dukes started while the New Jersey fans chanted warningly from the balconies: "Don't start Dukes! Don't start Dukes!"

Superstition or not, the tall sophomore didn't have one of his best nights. Mel Hutchins, BYU's six-foot-five smoothie, kept him well covered, although Dukes scored 17 points.

BYU plays in the NCAA at Kansas City next week.

## Marshall Claims Another Record

Cambridge, Mass., March 16—(AP)—Sophomore John Marshall, Yale's Australian aquatic ace, has added the National Collegiate 1,500 meters free style record to his collection of world's Olympic and national swimming titles.

The 20-year-old Melbourne youth last night thrashed his way to the new mark of 18:22.8 in the 11th annual Invitational Individual Championships of the Eastern Intercollegiate Swimming League in Harvard's pool.

Marshall, who is National A.A.U. champion in the event, was only 3.8 seconds off the world mark of 18:19.0 set by Japan's Hironoshin Furuhashi as he smashed the college standard of 18:38.3 made by Jack Taylor of Ohio State last year.

There was more than a tinge of blue to the event as Marshall led three sophomore teammates across the line in the fastest of three heats.

Second place went to Wayne Moore in 18:44.5 with Olympic 1,500 meters titlist Jimmie McLane third and Frank Chamberlain fourth.

So swift was the heat that the first five finishers held those rankings in final standings.

## Basketball Games Not Drawing Big Crowds As In '50

New York, March 16—(AP)—Blame it on television, the international situation, or repercussions from the "fixed" games scandals, but attendance at college basketball games showed a decline today for the season just ended as compared with a year ago.

The sock in the basketball pocketbook was felt especially in the big city arenas, where the crowds just didn't rush the gates as in years gone past.

Attendance at the Boston Garden doubleheaders fell off 36 per cent this season, for instance. The Cleveland arena figure was down 41.1 per cent, and New York's Madison Square Garden off 24.8 per cent over the 1949-50 season.

All this was disclosed in a cross-section survey of attendance figures submitted by various schools and the eight big-city sports arenas where the popular doubleheader programs are held. All figures are based on home games only.

The largest overall drop in attendance by sections came in the Far West—13 per cent. This was for representative school in the Rocky Mountain and the Pacific Coast area.

In the east, the decline was 10.5 per cent; in the southwest, it was down 4.5 per cent.

# Walter Mulbry In Line For Chandler's Baseball Office

Strasota, Fla., March 16—(AP)—Walter Mulbry is in line to take over the duties of baseball commissioner temporarily if and when Happy Chandler resigns.

The four-man executive council quietly set up that move Monday night at Miami Beach when it refused to accept the resignation of Mulbry as secretary-treasurer of baseball, a \$30,000-a-year job.

"The executive committee is backing Mulbry to the limit to carry on until the commissioner resigns," said Will Harridge, American League president yesterday.

"Then we will set up the machinery for him to act in the commissioner's capacity until a new one is elected. He probably would have complete charge of all player disputes."

Harridge spoke as a member of the council which met secretly some four hours after Chandler was refused a new term by the club owners. Other members are Ford Frick, National League president; Warren Giles, president of the Cincinnati Reds; and Tom Yawkey, president of the Boston Red Sox.

The Mulbry-Chandler situation broke into the open yesterday after weeks of "off the record" treatment of the break between the commissioner and his old sidekick of the political wars. No reasons for the break were given.

Chandler sought to fire Mulbry before he left office. Under the major league agreement, however,

he does not have the power. An attempt was made to oust Mulbry at Monday's joint meeting of the major leagues where Chandler was finally repudiated.

Giles, acting at Chandler's request, reportedly charged Mulbry with "disloyalty" at the closed meeting, listing a bill of particulars.

Reached in St. Petersburg, Mulbry declared "loyalty is a two-way street. It isn't only the underling who should be loyal to his superior. It works both ways. I have no idea what any bill of particulars could contain."

Informed of Harridge's announcement at his Kentucky home, Chandler said, "a lot that is in there is news to me. I have nothing to say."

## Accused 'Fixer' Faces Deporting

New York, March 16—(AP)—The Justice Department has moved to deport Salvatore Sollazzo, the master briber in the college basketball scandal here.

But the Manhattan District Attorney hopes to convict him of bribery and make him serve a sentence before any deportation.

A warrant of arrest was served on Sollazzo in his jail cell yesterday in proceedings for deportation to his native Italy.

Grounds for a deportation order, the Justice Department said, include past convictions for crimes involving moral turpitude, entrance into this country without a visa, and misrepresentation of himself as an American citizen to immigration authorities.

After the warrant was served on the 47-year-old Sollazzo, a spokesman for District Attorney Frank S. Hogan expressed hope that the deportation proceedings would be held in abeyance until after his trial in a state court and possible sentence.

Sollazzo, a jewel merchant and gambler, is held without bail on a bribery indictment.

# Dad Would Take Place Of Wounded Son Returned To Korea Battlefront

Baltimore, March 16—(AP)—The soldier's father sat quietly in his chair. The shadow of sleepless nights clouding his face made him look older than his 44 years.

He didn't want to talk about the letter he said he had written President Truman Monday. He answered questions frankly enough, but you could tell he didn't want to harp on the subject. He hoped the copy of the letter in his hand told the story.

And it seemed to.

He—Langdon P. McAninch, Sr., a truck mechanic—was asking the President to let him take the place of his 21-year-old son who was back on the Korean front, 23 days after he had been wounded in the leg.

"If we are so short of men that the wounded don't have time to heal their wounds," the letter said, "send me over. Let me take my son's place. I'm twice as old, so I'll do twice as good a job."

Then it said he was including excerpts from letters written by his son, PFC Langdon P. McAninch, Jr., Third Cavalry.

"Dear Mom:

"I thought I'd better drop you a line, hoping that it will reach you before the telegram, to let you know that I'm not seriously wounded."

In the same brisk tones of his father, he told of the attack the morning of the 28th of January. His patrolling platoon was half-way across a valley "when all hell broke loose." "I never ran so fast in all my life."

"Then it happened. A Chink mortar shell exploded about 15 feet

behind me. The good Lord was with me, that's all I can say. A piece of shrapnel tore into my left knee, and the rest tore into the bank around me x x x."

The young soldier was evacuated back to a hospital in Pusan to recover. Then came this letter:

"Dear Pop:

"I returned to my company last night. Believe me or not, I'm happy to be back. I don't believe I'll be much good. I used to be able to take these hills running, all the way. Now I can't even walk up them. That piece of shrapnel did something to my knee. I can't bend it much anymore x x x."

"Combat's a funny thing. Before I got hit nothing bothered me. Since I've been hit, I'm scared. Everything makes me shake, especially artillery going off."

Then—

"2-22-51—I Think

"Today I didn't go up the mountain with my platoon. I just could not make it x x x."

"2-25-51

"Here I am back up on the mountain with my platoon. As soon as I get back down on level ground, I'm going to start riding the sick book until they do something about my knee x x x."

"2-28-51—I Think

"Hello, Folks:

"We're waiting for the rest of the Army to catch up with us. We're the fightingest regiment over here xxx well, I have to clean my rifle now, so I'll say so long xxx"

That's what his Dad liked—the last one. It showed his son wasn't just a complainer. No, he had missed all the wars himself. But now—

He just leaned back and said nothing more.

## Port Terminals Ask Hike In Charges On Railroads

Atlanta, March 16—(AP)—South-eastern port terminal men today demanded sharply increased charges from railroads for loading their cars at port warehouses for inland shipments.

A spokesman said yesterday the group was seeking the same increases granted the railroads since 1947 by the Interstate Commerce Commission.

J. Roger Stanfield of Jacksonville, Fla., said the railroad increases amounted to 75 percent, but that in the same period they have allowed the port terminals only a 25 percent hike in loading charges.

The terminal representatives are organized into the South Atlantic Ports Association headed by Col. H. E. Boyd of Wilmington, N. C. They presented their demands at a joint meeting with the Traffic Executives Association of the southern carriers.

Stanfield explained that rates charged by the port terminals depended on agreements reached by them and the railroads. He said that an effort had been made in

## Cotton Second Only To Steel In Defense Needs

Declaring that cotton is second only to steel in importance in the defense program, M. G. Mann, general manager of the Farmers Cooperative Exchange of North Carolina, told 180 Pitt cotton farmers last night the nation must meet its cotton goal of over 16,000,000 bales this year.

Meeting at the Armory for a barbecue dinner, the cotton farmers were urged by Mann and two State Extension Service specialists to meet the Pitt goal of 14,000 acres. And they were assured that if they use the recommended methods of production they can produce a bale per acre.

J. A. Shanklin, Extension cotton specialist, and G. D. Jones, Extension entomologist, were present to outline recommended procedures for more and better cotton.

Jones, who worked with Pitt farm agents last summer during the boll weevil attack, told the farmers it doesn't make any difference how the weevil poison is put on the plants—so long as the dust or spray gets on them. And, he said, if this summer is similar to last summer, the importance of insect control is paramount to production of a bale per acre.

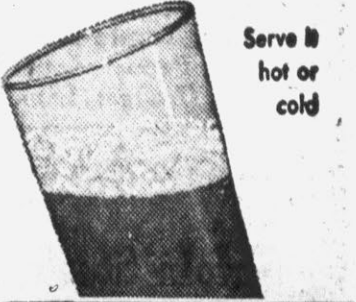

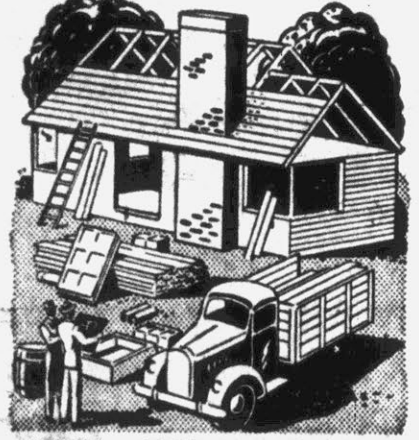

## Stubborn Chute Won't Fall Down

Asheville, N. C., March 16—(AP)—The Southern Railway system today was still trying to find a way to demolish a huge concrete and steel coal chute in the Asheville yards.

Division Superintendent E. R. Oliver, Jr., of the Southern today was wondering if the wiser course wouldn't be to surrender the present yards to the old chute and build new switching facilities elsewhere.

Greenville firemen were called shortly after noon yesterday to Five Points, where a small amount of heating fuel had escaped from a transport truck.

The firemen washed the oil from the streets to prevent any possible fire.

The oil was spilled from a Harvey Oil Company truck as it was discharging oil into a tank. An estimated eight gallons of oil was lost.

The loss of oil marked the third time in recent months that oil and gasoline transports traveling over the city have had fuel to spill from their tanks.

Chief A. E. Cahoon, Navy recruiter for the Pitt County area, announced this morning that there are numerous openings for qualified veterans and non-veterans for enlistment in the Navy.

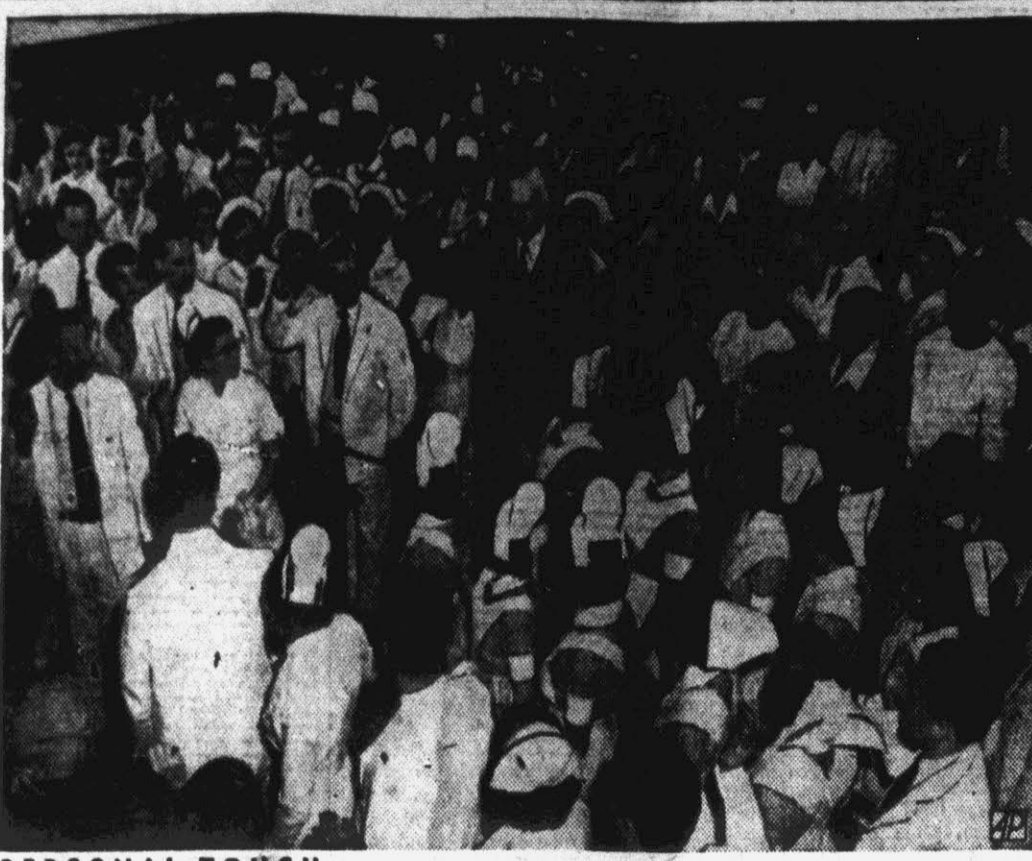

(Continued from page one) ribly overcrowded. As a result, he said there was a general demoralization among the displaced persons. The camps and the people were dirty, the mortality was low, the birth rate high, the criminal rate was low, and the black market operations were at a high rate.

"The miracle is that they emerged as well as they did," Fishbein declared. "It's pretty hard to be moral when you are living six married couples to a room with several adolescent children also."

He told of the notorious black market operations of the members of the American army of occupation and of the millions of dollars it cost the United States government.

"The living in Europe is hard," the speaker stated. "People have to lie to stay alive. It is something we can not picture because we have not been under these pressures." The displaced persons who are being brought to America, he said, bring with them strange culture patterns and ideals which must be absorbed into the culture pattern and ideals of the American system. The solution of the problem of absorbing these people, Fishbein said, lies in the practice of the ideals which the Americans preach. "We must not look upon these people as inferiors. The hope lies not in isolation, but in cultural exchange. You can not love your neighbor unless you get to know him; and you can't get to know him unless you let him be your neighbor in the first

(Continued from page one) Turkey, Yugoslavia and Italy but of northern Africa and the Middle East.

Scattered about the Mediterranean are the immensely rich Iranian and Arabian oil fields.

Control of the Mediterranean also means control of the Dardanelles which lead to the Russian dominated Black Sea. Sealing up of the Dardanelles would turn the Black Sea into an inland lake, thereby depriving the Soviet of an effective base for naval operations.

One of the difficulties which the western powers might encounter in trying to consolidate this great zone lies in the fact that all is not love between the Middle East and the West.

For one thing there is considerable feeling against Britain. This includes the very sharp differences between England and Iran over the oil concessions held by Britain, and between London and Egypt over disputes revolving about the Sudan.

(Continued from page one) ten days after Pearl Harbor. There was haggling. But labor agreed not to strike during the war—all except Lewis. And management agreed not to shut down its plants during a dispute.

Both sides agreed to submit their disputes to a government agency. On the ashes of the old NDMB, Mr. Roosevelt decided to erect a new board, called the War Labor Board (WLB). He did this on Jan. 12, 1942. Like the old NDMB, it had 12 members: four each representing labor, management and the public.

There was quite a difference between the old NDMB and the new WLB. Mr. Roosevelt gave the latter far more sweeping powers: over wages, hours, and other management-labor matters. WLB was a real boss.

And Mr. Roosevelt backed it in ordering disputes settled, or the government, such as the Army or Navy, would take a plant to carry out WLB's orders and keep war output going. Although it had many stormy days, WLB lasted throughout the war.

This time-to control inflation during re-arming by putting a lid on prices and wages at the same time—Mr. Truman created the Wage Stabilization Board (WSB) last fall. It had, unlike the 12-man earlier boards, only 9 members: three each representing labor, management and the public.

But WSB blew up on Feb. 15, 1951 when all three labor members, including CIO and AFL men, walked out. They protested a decision by the other six members

### limiting general wage increases to 10 per cent over what wages were in January, 1950.

For weeks now an effort has been made to revive WSB or create a new board. Until yesterday Mr. Truman had not appeared in the picture at all. In person, anyway. He had left the job of putting WSB's pieces together to Eric Johnston, boss over prices and wages.

On Wednesday Johnston complained that the White House was not helping him in his difficult task. And last night Mr. Truman stepped in. He announced this in Key West where he's vacationing:

He'll appoint a "national advisory board on mobilization policy" to be made up of 17 men to be appointed by him. He'll name the chairman, and, as for other members, he said:

Four will have had business experience, four experience in labor, four in farming. The others evidently will represent the public.

This probably parallels, in a way, that White House conference which Mr. Roosevelt called in 1941 although that one had no farmers on it.

Out of the advice of this board may come some answer for setting up a new WSB although this 17-man board apparently is not intended to be, itself, such a board but merely an advisory board to the president.
