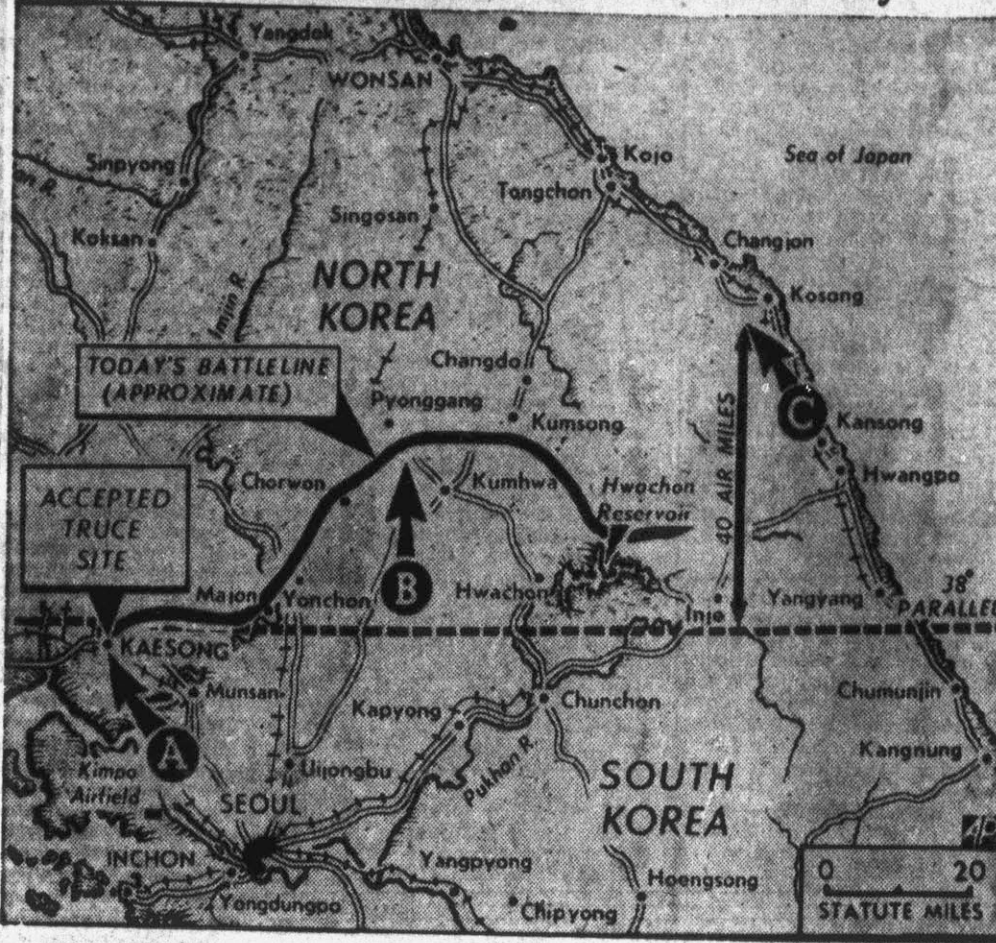

Glorious Fourth, A Hectic Holiday

Thousands Jam Beach For Annual Good Time

A day at the beach used to be a leisurely affair—a lazy, unhurried, take-your-shoes-off-and-set-a-spell day.

That is, any day but the Fourth of July.

A good part of the American People was at Atlantic Beach this past Wednesday, following the premise set forth 175 years ago: Practice Your Independence. Atlantic Beach patrons did just that and with the capital I to boot.

That sandy stretch of the Atlantic seaboard was a proving-ground for everything that personified independence. The moving mass of brown-backed humanity resembled nothing ever seen before on the streets back home. Rather, it looked more like an unholy version of the Four Freedoms garbed in a million scanty bathing suits, cooling and unclogging and doubling back over itself in a thousand variations on the theme of let's get away from it all.

But each one of the thousands of persons who flocked to the beach Wednesday swore he had a good time, regardless of the mob in the water, or around the cold drink stand, or milling around the dance floor, or lined up in front of the pari-mutuel windows at the dog track, or backed up in their cars on the causeway, waiting for the children's sand buckets and shovels. Each one had his reasons for having a good time, but mainly

because it was a good day to get away from business and the workaday world. Townspeople from all over the state, particularly from the towns and cities in close proximity to Morehead City, were there with their wives and husbands and children. There were out-of-staters there too, including a major portion of Marine Corps personnel from bases close by. They all merged, though, using the common denominator, the bathing suit, to its best advantage.

They sun-bathed, they fought the choppy surf and undertow, they danced to the music from the busy juke-box, they pitched pennies, they ate huge quantities of hot dogs and hamburgers, and they consumed larger portions of ice cold beer and cokes.

And when they got tired of the beach front, they moved back to the carnival with its Merry-Go-Round, Ferris Wheel and other mechanical devices designed to separate patron from money. And they bowed. And tiring of that, after working up a head of steam, they headed back for the beach and its crowds, but also with its cooling water.

As the sun began winding down its spiral toward the west end of the beach, the crowd began picking up its belongings and its children's sand buckets and shovels, piled into their cars and headed for home and work the next day.

Some, of course, couldn't travel farther than the dog track, turning into the parking lot for what they hoped would be their lucky night. Some picked the better dogs and won; others, who weren't too familiar with the high-

RB 700A 7-7 strung and unpredictable greyhounds, lost; and others tried to place their money on the bunny. Eventually, these went home after waiting for the highway traffic to s-b-side. On the way, they moved about uncomfortably in their cars, trying to find new positions in which their sunburn would not hurt so much. And regardless of the harrying tactics practiced during the heat of the day by most of the persons on the beach, the cool night seemed to dispel a calmness in them that enabled the great majority to get home safely.

And at home, they either flopped into bed, forgetting about their wet bathing suits lying in a heap on the front porch, or they engaged in a moment of silent prayer thanking the Lord that they had come through "another Fourth" safely.

Next day, all was business again, with each of the previous day's celebrators going through his own peculiar hustle to make up for the holiday. And the only indication that they had visited the beach on the Fourth was an occasional white streak of unburned flesh surrounded by a sun-back dress, or a loose-fitting cotton shirt circling a scorched neck.

The Fourth was quite a day, as it is every year. It only comes once, some are still saying, and they add a plaintive "thank God." But most are casting a longing eye toward September and Labor Day when they can start all over again.

There is a tomorrow. If we are growing as God intends we should, it should be better than today. Let us forget the past. Let us take a flight into tomorrow. Forgetting the things that are behind, let us press forward—as did Saint Paul—into the things that are before.

Compromise On A Third Man

The harmony which the Greenville citizens had hoped for between Mayor Lester D. Page and the board of aldermen has failed to materialize.

Both have talked peace and cooperation, but so far these desired qualities in the new city administration have not transcended the gap between words and action.

The mayor and the majority of the members of the board butted their heads at the first meeting of the fiscal year when the board would not accept the mayor's committee appointments. At Thursday's meeting it appeared for a few minutes that the mayor and the board might patch up their differences over the appointments, but then they locked horns over the chairmanship of the street committee.

The majority of the board apparently wants Alderman J. E. Collins back in the saddle on the street committee, and the mayor has firmly planted his foot against it.

Both probably have valid reasons for their stands, but the people of Greenville are not as much interested in which alderman holds the chairman's seat in the street committee as they are that the board and the mayor get to work on the city's problems and quit their bickering.

Waldrop, the mayor's choice for the post has said he is willing to serve on the committee, but hasn't the time the job of chairman requires. Collins, who the mayor opposes for the job apparently wants it so badly that at the meeting Thursday night he went so far as to propose the board take the committee appointments out of the hands of the mayor entirely and have the board arrange its own committees.

The only workable solution to the problem is a compromise between the board and the mayor.

Surely among the other seven members of the board of aldermen there is at least one man who has the qualifications, interest and the time to head the committee, and likewise has confidence of both the mayor and the board.

That is the man whom the mayor and the board should look to fill the disputed position. The sooner the matter is settled, the better off the city will be.

If Diplomacy Fails, The Soldier Must Not

The soldier, with what he had, has done his utmost. Now it is apparently up to the diplomat to achieve the goals set forth by the United Nations' directive—to drive out the invaders of South Korea and unite that unhappy land.

Deprived of sufficient strength by the reluctance of member nations to contribute more than token units; deprived of the ability to exercise the one basic concept of grand strategy, to cut off and destroy enemy supplies and reinforcements well back of the fighting front... virtually with both hands tied behind him, the soldier has fought his enemy to a standstill.

How well will the diplomat fare when he faces the same foe over the conference table? Will he do as well as the soldier? Will his hands be similarly tied by feeble, half-hearted support from the governments he represents?

He knows too well that there is no "guarantee" his Russianized counterpart can offer that is worth the breath to say the word. He must treat with the gangster on a level which he himself would be treated. The diplomat's mission is so hedged with distrust and obstacles raised by Communist spokesmen that he has virtually two strikes against him before going to bat.

And if he fails, then what? Surely we cannot look to the bloodied soldier and tell him to carry on without first loosening the bonds which deprived him victory he long ago deserved in Korea.

A Modern Paradox

The United States watches a modern paradox—a capitalist millionaire refuses to divulge information about the person or persons who posted the \$80,000 bond for the four communist leaders who have disappeared.

Frederick Vanderbilt Field has been sentenced to jail for 90 days after he was found in contempt of court for not giving the information asked for by Federal Judge Sylvester Ryan.

It seems that a person such as Field who has enjoyed to the fullest the benefits of free enterprise and democracy which his nation affords would be one of the last to want to junk it all for the tyranny of communism.

The incident, however, is proof positive of another truism. Those individuals who have to work and fight for their gains and their freedoms in this democracy are the ones who are most aware of what freedom means, and what democracy affords the individual. Many of those who have never lifted a finger to advance themselves, but who have had it all handed them on a silver platter have not the capacity to appreciate what their freedom and their democracy mean.

National Whirligig

News Behind The News
By RAY TUCKER
WASHINGTON—"I have an English friend," says W.G.B. of Old Lyme, Conn., in a curiously interesting letter, "who writes me frequently, and who at times has handed me some criticism of us that has been rather mean. If a recent letter he wrote:

"Take shipments to China. It is held wrong for anything to go to China through Hong Kong, but not wrong for Japan to continue trading. I hope that source of trouble has now been scotched. ... Pax Britannica kept the peace for a century without imposing the British way of life on anyone else." Answer: There is no real cause for angry dispute between the resident of Connecticut's picturesque artists' colony and his British chum. There is enough blame on both sides for them to argue the question sensibly, as Washington and 10 Downing Street have done.

CONTROL—Both Britain and the United States are now exercising strict control under a license system of all goods going to China and to Hong Kong. Communists. We acted as soon as the Chinese Communists entered the Korean war, while the British clamped on restrictive provisions after the United Nations called for a boycott.

In May, shipments from Japan to China totalled only \$4,200,000. All cargoes were screened carefully to make certain that they did not include strategic materials. Last November, before the Reds attacked MacArthur's forces, the monthly exports from Japan amounted to \$20,000,000. British and Dutch shipments through Hong Kong were running at a higher rate.

It is easy to get too excited over this question from a practical standpoint. Even monthly shipments of \$20,000,000 would hardly reinforce such a vast and sprawling nation as China. They would be just enough to feed a few, non-military enterprises on a strict diet.

TENUOUS—It is difficult to discuss the effects of the so-called Pax Britannica (1815-1915) here, in view of its ramifications. But there are a few major factors W.G.B. might call to his British friend's attention.

It is true that Britain underwrote the so-called Pax Britannica, but it was not the profitless century of peace for her. She preserved a tenuous peace by maintaining a balance of power on the European continent, opposing Russia, Germany and finally France whenever, by turn, each threatened her political and economic supremacy. She stopped wars or went to war whenever it was in her interest to do so.

Don't forget that the ruling regime might have sided with the South against the North in our own difficulty, if it had not been for the protests of certain great humanitarians like Cobden and Bright.

SERVICE—Moreover, during this century England gained colonies and possessions such as South Africa, India, Egypt, and rich holdings in the Far East. She also established herself in the Middle East. Finally, had she "imposed the British way of life" on all these peoples by improving their standards of living, she might not have lost India, Burma and Ceylon, and now face eviction from Iran.

Despite all these considerations, England's hundred years of "police action" did the world a service, at least during that period. But both the British and ourselves seem to be making a mess of what Kipling called "the white man's burden" now.

PROPAGANDA—"Does anyone in the United States government censor copy of this 'Romanian News'?" explodes A.A.M. of Dallas, Tex. "If not, I should like to know if the United States is equally free to send such uncensored propaganda through the mails in Rumania or any other Communist-dominated country?"

Answer: The "Romanian News" to which A.A.M. refers is a four-page, slick tabloid issued at Washington by the Rumanian Legation. It is a glorification of the achievements of a Communist regime in that country. It boasts of industrial and agricultural advances, peace movements, religious freedom, and labor unions fine treatment by the government. According to what you read here Rumania is a people's paradise.

There is no censorship of this or similar propaganda, including pamphlets, magazines, bulletins and other handsome documents, issued by the Russian Embassy or its satellites represented at the Capital. As to the question of reciprocal courtesies, don't be silly!

Anybody caught reading American counter-propaganda or listening to the Voice of America in "iron curtain" countries is asking for a one-way ticket to Siberia.

Somebody Told Me

Scanning last week's news brings three interesting topics to the front: horse meat, taxes, and GI's.
On horse meat: There is so much horse meat being eaten in Portland, Oregon, that the "Oregon Journal's" cooking expert, Mary Cullen, has been asked how to prepare a pot roast of horse. She says that in preparing this dish, you have to remember that the meat tends to be sweet. More onions should be used and fewer carrots. If the roast is cooked slowly in red wine, as some prefer, a sour wine should be used. In broiling horse filets, spread some butter over the meat because it is lacking in fat.
There was time when horsemeat was eaten only as a stunt or last resort, but it seems that those days are gone forever. Now there are three times as many horse butchers, selling three times as much meat. In the Portland market, horse loins are 35 cents a pound, while beef is \$1.14; horse tenderloins, 45 cents, compared to beef at \$1.95 to \$2.15. People who used to order the meat and pretend to be the butcher that it was for the dog now come right out and say it's going on the table. The old gray mare is more than she used to be.
On taxes: The Bureau of Internal Revenue has checked 160,000 of 1950's income tax statements and discovered that one in four returns are wrong by at least \$3, and almost always in the taxpayer's favor. Those making most errors are farmers, professional men and owners of small businesses. The errors are not innocent mistakes in addition, but in incorrect statements of income, too generous personal deductions, and bogus exemptions for dependents. Altogether such "errors," as the bureau politely calls them, probably cheated the Government out of one billion dollars.
On GI's: The brass says there is no longer such a thing as a GI. They say that no longer shall any Army handout, speech or record refer to an infantryman as a GI. The expression, of course, came out of World War II and stands for Government Issue. The Army has decided that the term is too undignified. From now on, they say, "all references to a man in the Army should identify him primarily as a soldier. The term is ancient and honorable. Webster defines a soldier as 'a skilled warrior' and never before in history has a soldier so richly deserved this definition."
Within the service, the Army will probably be able to eliminate the use of the term GI, but among the veterans of WW II, it will be hard to erase. GI Joe is probably here to stay.

Around Capitol Square

Raleigh, N. C. By LYNN NISBET Daily Reflector Bureau

VARIETY—Your reporter has been privileged to travel over a lot of North Carolina during the past two weeks. Every such opportunity is seized upon and every time there are found new things to marvel about in this greatly diversified state. There is at the same time marked contrast and striking similarity all over. For instance, last Saturday there was a boat ride on Pamlico Sound, a lunch of baked ham, and attendance at opening performance of "The Lost Colony" drama at the Waterside theater on Roanoke Island. The Saturday before there was a boat ride on Fontana Lake, a lunch of seafood, and attendance at the opening performance of "The Three Hills—A Drama of the Cherokees" at the mountain-side theater in the Great Smokies. Nothing better illustrates the variety and the unity of North Carolina than the fact that one can get a boat ride and a shrimp cocktail in the mountains, a ham dinner and a mountain climb on the beach. Don't laugh at that mountain climb reference until you've tried to get to the top of Jockey Ridge, kingdom of the Dunes of Dare, towering all of 100 feet above sea level. It's harder to negotiate than Mount Mitchell, because at Mitchell there is a foothold and something to hold on to; at Jockey there is nothing but sand and often the tracks of the climber are obliterated by winds so that he cannot follow the same course down as he took on the upward climb.

BETWEEN—These are the extremes, and in between is an incredible amount of unbelievable variety—of hills, plains, fields and forests. The folks are at the same time very much alike and very different. The ancient philosopher-poet who spoke of the "paradox that comforts while it mocks" must have had North Carolina in mind. Everywhere on the outer banks, in the mountain valleys and hills, through the piedmont and the coastal plains—are neat homes, good schools, well kept church buildings and grounds, wires that tell of electric energy and telephone contacts, aerials denoting radio and television connection with the rest of the world.

ISOLATION—There are still individual homes and small communities in North Carolina that are almost completely "isolated." There is no sectional or regional isolation any more. In addition to telephones, radio and television, there are paved roads into every large community and landing strips for airplanes within easy reach of every North Carolinian. There is an airfield, for instance, at Andrews in Cherokee county, within 25 miles of the western tip of the state, and one at Hatteras within 200 feet of the Atlantic Ocean at the extreme eastern tip. Some of these landing fields will not accommodate the huge ships of the air, just as some of the roads will not sustain heavy truck and bus traffic. But it is doubtful that any resident of North Carolina is more than thirty miles from some kind of airport and flying service, and very few are more than five miles from a paved road.

What Other Papers Are Thinking

FUTURE IN DAIRY BUSINESS (Hartford Conn. Herald)
The milk market from the outside that people in this area have depended upon for years stands a chance of turning its sales in other directions as cities grow larger.
For that reason it is important that a local supply be developed as soon as possible. This means that farmers and business men alike in the Roanoke-Chowan area must put their resources into one pool and work toward a sound and far-reaching dairying program.
Next week the Dairy Products Co-operative will officially open in Ahoskie. This plant is owned and operated by the farmers and business men of this section, but it can not begin to answer the needs of the Roanoke-Chowan area without the full support of the population.
There must be a renewed effort on the part of Extension workers, farm leaders and business men toward building interest among farmers to produce milk for the commercial market. In a like manner residents of Hertford, Gates, Northampton and Bertie counties must lend their support in the purchase of the coop's products.
A survey recently completed by the dairy Extension department at State College reveals that a less amount of milk is consumed per person in eastern North Carolina than in any other section of the state. The survey pointed out that the small use of milk in this area reflected the lack of the supply and interest on the part of farmers to diversify some of their land from row crops to pastures.
Now that a market for the milk has been established, the first step has been made toward making this section of the state more than dependent upon row crops. The dairying industry is one that continues the year around and the chances of a failure are far, far less than in the case of tobacco, corn, cotton and peanuts.
An allocation of tobacco and peanut acres means that farmers in every section of the area have land that could easily be turned to pasture and a small homestead with the milk on the market within a couple of hours after it is produced.
This new dairy, representing a great amount of work on the part of the leading farmers in the area, can mean much to this section if everyone will pitch in and help.

Business Today

The formation of pools of small manufacturers to obtain defense contracts is growing. Scores have been organized, or begun to organize, since June 19 when Secretary of Labor Maurice J. Tobin set the machinery in motion for them to obtain government contracts.

Until then, the Walsh-Neely Public Contracts Act provided that contracts could be awarded only to "manufacturers" or "regular dealers." But Mr. Tobin, under the terms of the law, authorized pools of groups of manufacturers to bid on contracts.

The authority is hemmed with restrictions. The pools must first have the approval of the National Production Authority, the Department of Justice and the Federal Trade Commission. That's to make sure the pool isn't combinations in restraint trade.

Only a few of them have received this official blessing, and most of them were organized earlier. However, under the government's program of assisting small business—or preventing it from being wiped out by the shift to military production—it is expected that approvals will now come faster.

Some government officials are frankly skeptical of whether the pools will work out. Similar pools were legalized during World War II and they didn't do so well. Most of them got tangled in the jealousies and rivalries of member firms.

However, it does offer an opportunity for survival. In some places, state and regional associations are taking the leadership in the formation of pools and, in a pool formed in New York, a large company has undertaken to bid on contracts on behalf of members of a pool of smaller companies.

Here are steps to be taken by small manufacturers who believe they can get along with their competitors: Send to the National Production Authority, or the nearest office of the Department of Commerce, for the booklet, "Pooling Production for Defense." Interest other manufacturers in forming a pool. Then, using the booklet as a guide, send the necessary information to the Pooling Section, National Production Authority, Washington 25, D. C. Then, after getting approval of the N. P. A., the D. of J.

and the FTC, get the pool started in seeking government contracts.

That's the hard part. Organization of the pool in itself won't assure contracts; it's just a hunting license. It will take work contacting government offices and submitting competitive bids. But the pool can bid on much larger contracts than a single member could.

INSTALLMENT SALES CUT \$248 MILLION
Here's one way of looking at it: Consumer credit controls cost sellers of automobiles, radios, TV sets, furniture and other durables \$246,000,000 in sales in May.

Last year, the total outstanding of installment sale credit rose \$222,000,000 from April to May. This year the total outstanding topped \$24 billion.

Charge account totals rose \$46,000,000 during May; lay rose \$49,000,000 in May, 1950.

NEW YORK (PA)—One of the nicest things about the old horse-and-buggy days was that the horse always had a stall to go to.
And he knew where it was. All you had to do was unharness the horse, give him a friendly pat on the flank, and off he'd lumber to his home in the barn. You didn't have to worry about where he would spend the night.

The automobile has never been able to develop that much plain, old-fashioned horse sense. For all its fine gears and gadgets, it doesn't know what to do with itself when day is done. It does not know where to go.

This has given rise to the most gnawing problem of the machine age: where and how to find a parking place?

Washington Letter

WASHINGTON—Americans are on the go this year, flocking to all parts of the globe by every possible means of transportation, even down to the original shank's pony.

Peak numbers are expected to go abroad, but the majority of traveling citizens will "see America first," including their vacation jaunts to the national parks, taking in geysers and glaciers, canyons and mountains, lakes and forests. The National Park System tells me an estimated record 36,000,000 to 37,000,000 visits will be paid to its 117 parks, monuments and historic areas during 1951.

Arthur E. Demaray, director of the National Parks Service, warns that since most of these millions will choose July and August for their vacations, the wise tripper, if he can, will plan to come before or after these two months.

"Also," he says, "if one of the more widely known national parks is your destination, you would be smart to make lodging reservations well in advance, or you may have to sleep in your car."

The service operates free public camp grounds in 47 of the 28 national parks. In most major parks, hotels, lodges, housekeeping cabins, cafeterias, bus transportation, saddle horses and similar services are provided by concessionaries operating under Government contract and under Park Service supervision.

Mr. Demaray says some new accommodations have been added but that since World War II they have lagged well behind public demand and will in no way approach proportionately the increase in the number of visitors.

Generally, cost of both food and lodging will reflect rising costs elsewhere. This year's accommodations will run from housekeeping cabins suitable for families and costing less than \$2 a night, to lodges where the rate per person with two or more in a room averages about \$8.50 daily with meals.

In the Yellowstone area a one-room cabin for five will cost about \$7.50 a night. Some of these cabins have three double beds, others two doubles and a single. In the Old Faithful area, where certain cabin improvements have been made, the rate is \$8.50.

Hotel facilities run from \$5 per person American plan when two or more are traveling together. Top rates are around \$30 a day for a single, also American plan.

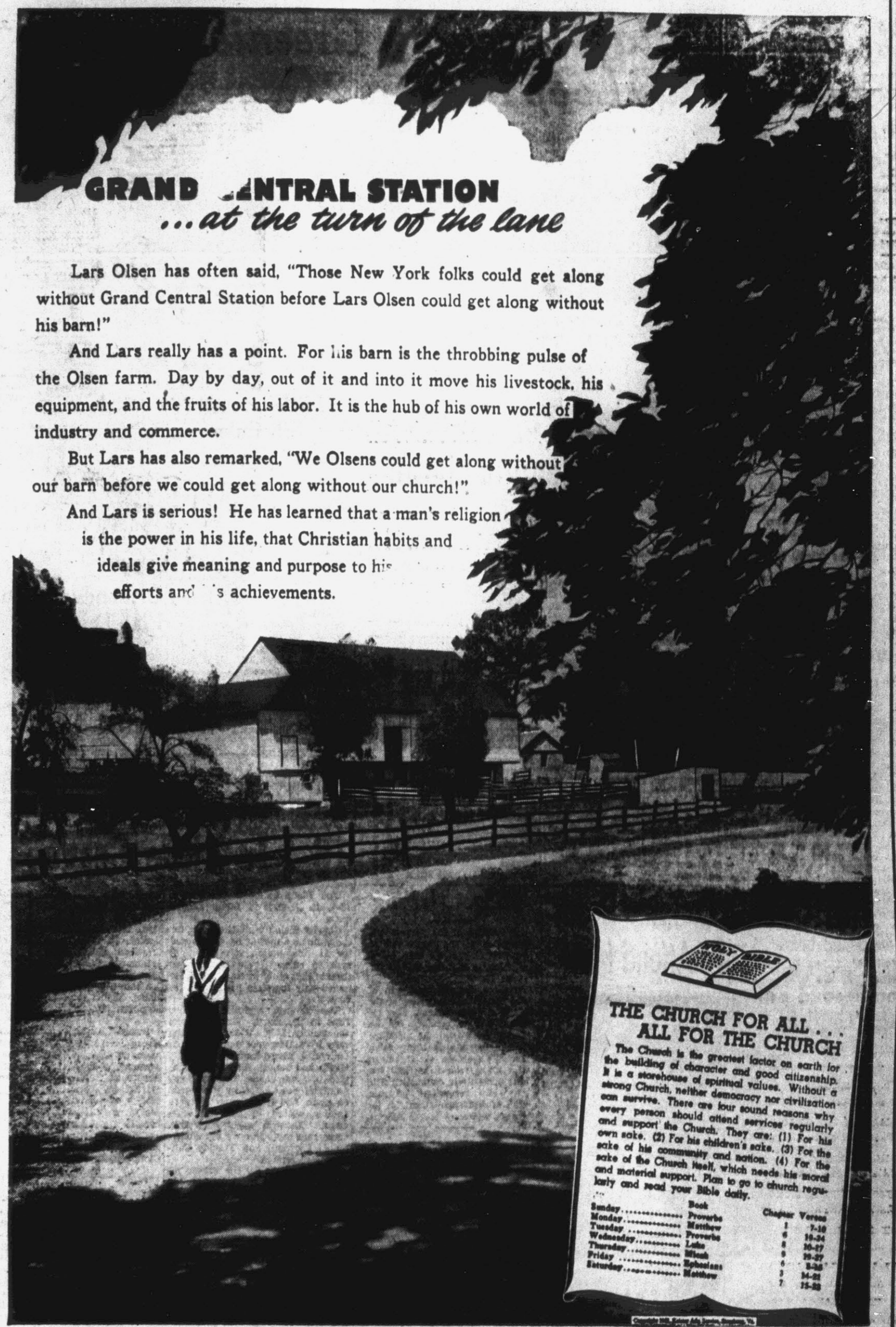

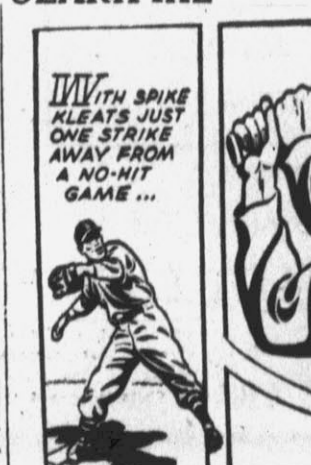

day for the six weeks' course, has for the past three years at-tended the State Drama Festival at the University at Chapel Hill held each spring. Last year she played the lead in "Sod", the Greenville Dramateers' contribution to the festival which won honorable men-tion. She has taken a prominent part in all the activities of the local dramatics group in the high school and is considered by her coaches to be very talented.

During her six weeks at Burn-sville, Miss Waters will have train-ing in all phases of dramatics. She will take three classroom courses which carry college credit, backstage work, make-up, lighting and stage direction.

Burnsville, a small school which is about five years old, was begun by Woman's College Drama De-partment as an experiment. It has proven so successful that it has become a regular part of the Ex-tension Division of the college. The community helps to support it fi-nancially by participating as an au-dience in all the productions.

The school makes a careful se-lection of its applicants, who live and work together as regular stu-dents while there.

The winning of the scholarship is a signal honor for Miss Waters.
