

Ridgway's Atrocity Report Kept Secret By Pentagon

Officials Give No Explanation For Failure To Disclose General's Estimate Of 8,000 American Prisoners Slain By Communists; Report Made Weeks Ago

WASHINGTON (UP)— Pentagon officials had no immediate explanation today about why they kept secret for weeks Gen. Matthew B. Ridgway's communication that 8,000 American prisoners of war had been reported slain by the Communists in Korea.

Press officers said they "had nothing to say" about the failure of Pentagon officials to seem aware of the Ridgway report at the time Col. James M. Hanley, 8th Army war crimes investigator, made his first report on Korean atrocities on

Ridgway's atrocity estimate — made in a routine report to the United Nations — had been transmitted to U.N. officials two days

Quizzed about Hanley's disclosure that over 5,000 American prisoners had been slain by the Reds, Pentagon officials appeared at the time to be skeptical of the figures, and promptly messaged Ridgway for

The supreme commander's office in Tokyo also termed Hanley's first report "incomplete and unscientific" and expressed the

It was disclosed in Paris and Washington last night that Ridgway's report said some 8,000

The latest casualty report lists only 10,871 American soldiers missing in action during the Korean

Vice President Alben W. Barkley, now visiting the battlefield, said the slaying of prisoners by the Reds was "an atrocious thing to perpetrate."

report added, "approximately 7,000 were reported killed by the North Koreans and the remainder by the Chinese Communists."

He added that his command had 400 "active cases" in its files and was holding 126 war crimes suspects. He said he was ready to

There was also no immediate ex-

planation of the U.N.'s failure to release the report. But a State Department spokesman said it was held up by "bureaucratic red tape" longer than usual.

Difference officials also pointed out differences between the Hanley and Ridgway reports. For one thing, they said, Ridgway blamed 7,000 of the reported murders on the North Korean, while Hanley held the Chinese mainly responsible.

Soviet Makes 'Pikers' Out Of The Millionaires

BERLIN — The swankiest layout in East Germany is the new Russian embassy on Unter den Linden in the Soviet sector of Berlin.

The block-long pile of granite will house the Soviet staff "accredited" to the Communist government of East Germany.

The huge, grim-looking structure is four times the size of the pre-war ministry. Details of its construction, the cost and who is going to pay for it, are carefully guarded by the Red NKVD (secret police). Thousands of Germans have been working on the embassy for almost four years but none of them ever laid so much as one stone upon another without being scrupulously observed by Soviet army engineers. Until a little less than a year ago, the entire area was hidden behind a board fence and the streets behind it were "off limits" to the public.

Despite all that, some information leaked out. The floors down stairs are marble with finely pictured design. Above, the floors are made of the finest German parquet wood, inlaid and carved with filigree work. Few pre-war millionaires, observers say, have ever possessed such floors.

The masterpiece is the ballroom, calculated to absorb several thousand guests. Crystal eye-drop chandeliers stretch the length of the ballroom. The kitchens, which will be called upon to serve the well-known suppers the Russians love, are already completely equipped.

Student Teachers Enjoy First-Hand Study Of Problems In Rural Schools

Rachel "Ray" of Fremont and Maxine Robinson of Angier, seniors at East Carolina College, are completing work on a project which took them to Hyde County for a study of public education in a rural area.

Through work in elementary grades in the Swan Quarter school, the two East Carolina seniors have had the experience to learning at first hand some of the problems in a small school. The cooperation of teachers in Hyde County has also enabled them to assist with various projects now in progress in the Swan Quarter school. The experience was a rewarding one educationally, they say, and add that they "had a perfectly wonderful time."

The East Carolina seniors, both of whom are student teachers in the fifth grade of the campus Training School this fall, completed a week's work in Swan Quarter November 9 and returned last weekend for further observation and consultation. Their activities have varied from observation and teaching demonstration lessons to assisting in painting classrooms.

The project was planned and carried out through the cooperation of Hyde County school officials and of members of the department of education, the Training School faculty, and student teachers at East Carolina. Conferences among these groups led to the experiment of sending student teachers to Swan Quarter to study the school there, particularly the elementary grades, and to assist teachers there with their programs. Miss Davis and Miss Robinson volunteered and were chosen for the work.

At the college the two student teachers assisted in planning their work in Hyde County by Dr. Keith Holmes, professor of education, and Mrs. Elsie Eagan supervising teacher in the fifth grade at the Training School. "Our student teachers at East Carolina," Dr. Holmes commented

recently in discussing the Hyde County project, "should be familiar with the educational problems so that they may be better equipped to teach effectively in any situation in which they may find themselves. We must give the children in the more rural sections of the state a square deal. The department of education hopes that the experiment in Hyde County," he added, "will be a precedent for other such ventures."

In Hyde County the young teachers worked with Lona Bonner, fourth and fifth grade teacher, and Mrs. Marietta McKinney, sixth and seventh grade teacher. The work done by the seniors included observation in the elementary grades, the teaching of demonstration lessons in art and language, and consultation with teachers and officials on various phases of the school program. Through the courtesy of school patrons they toured the county and learned something of the background of the pupils.

Among those who assisted in the cooperative project are N. W. Shelton, superintendent of schools, and Bettie Swindell, school supervisor, in Hyde County; Mr. Hood, principal of the Swan Quarter school; Dr. J. K. Long, director of the department of education at East Carolina; and Frances Wahl, principal of the college Training School.

Story Of Assault Case Is Highlight Of Police Court

WASHINGTON, D. C. — Jack Spain of Greenville crams a lot of activity into a day as the Administrative Assistant to North Carolina's senior Senator, Clyde R. Hoey. Some of his many duties consist of personally checking all mail and answering most of 200 letters daily; receiving an almost constant flow of constituents, many with problems to which he listens and assists in solving; keeping informed on all private bills before the senate, and supervising the period member office staff, who are under his full charge.

At an earlier period of history most of this work was carried on personally by a senator but as the volume of activities of Senatorial offices has increased it has become necessary for him to allocate much of it to an able assistant. the past, and there is no reason to believe
there will be, the campaign is likely to be
based on promises of more government
doles for the people, directed at gaining
block votes. There is likely to be a plum in
the pudding for every group: For labor, a
minimum wage of one dollar an hour rather
than the present 75 cents, plus promis-
ed repeal or at least re-writing of the
Taft-Hartley act. For the old people more
social security with possible immediate
benefits. For everybody, socialized medi-
cine. For the minorities, the Fair Employ-
ment Practices Act. For the farmers, a va-
riation of the Brannan plan for agricultural
subsidies, and for the home-makers lower
food prices because of the government sub-
sidies for agriculture.

But let's take the analysis a step further.
Who is going to pay for all this? The gov-
ernment of course. And where will the gov-
ernment get its money? From the tax pay-
ers. And who are the tax payers? The peo-
ple, of course. All of which brings us back
to the very basis of the creeping socialism
the United States is experiencing. The poli-
ticians make the promises, the government
hands out the doles, the people foot the
constantly increasing bill, and the bureau-
crats take a bigger percentage of the taxes
for the red tape involved in making gov-
ernment gifts from the tax payers' money.

If the people are not careful we may
find we have ceased to use the government
for a walking cane and have converted it
into a wheel chair. And it is much easier to
discard a walking cane and still get about
than it is to try to stand again after sitting
in a wheel chair for a number of years.
Britain as a nation bears testimony to that.

Is The Paroles System Too Lenient?

For the second time in less than a month,
a North Carolina parolee faces capital
charges for a crime committed while on
parole from the state penal institutions.

The very fact leads to one of two conclu-
sions: either the State Paroles Commission
has become careless about its judgment of
parole prospects, or else it is running in a
streak of bad luck where the parolees are
concerned. Where the lives of North Caro-
lina's law abiding citizens are concerned,
there is no room for taking a chance with
lady luck in letting convicted criminals
loose on society before their sentences are
completed.

The Thanksgiving eve murder of a Beau-
fort County man by a parolee was one of
the most atrocious crimes to come to light
in this section of the state in many months.
It certainly leaves the Paroles Commission
with the responsibility squarely in its lap.

The Paroles Commission of North Caro-
lina has as its first responsibility the protec-
tion of North Carolina's citizens from the
convicted criminals who have served suffi-
cient amounts of their sentences to be eli-
gible for return to society. The commission's
second responsibility is to seek the rehabili-
tation of criminals by returning them to
suitable places in society. The first obliga-
tion of the commission, however, far out-
weighs the second.

When the Paroles Commission returns a
person from prison to society, it in effect is
taking the responsibility for his good be-
havior. The more lenient the commission is
with its paroles, the more likely the state is
to suffer repeated criminal acts such as oc-
curred in Beaufort County. It is quite easy
for the Paroles Commission to be too lenient
in granting paroles, but it is very unlikely
that the commission could be too strict in
not granting paroles.

National Whirligig

WASHINGTON—I notice that numerous Collec-
tors of Internal Revenue and Department of Justice
officials have been fired in the Administration's so-
called housecleaning," writes G.H. of Brooklyn, N.Y.,
and several other readers. "Is the punishment to be
applied only to the 'small fry'? How about higherups
at Washington?"

Answer: In my opinion, the real offenders at
Treasury and the Department of Justice are Secre-
tary John W. Snyder and Attorney General J. Harold
McGrath. I do not accuse them of any criminal act.
But they certainly have been guilty of stupidity, in-
difference and administrative laxity. They could have
uncovered these scandals years ago, if they had been
on the job.

INDIGNATION—It is extremely significant that
every single violation has been disclosed first by the
newspapers, by Democratic investigators on Capitol
Hill, and in several instances by minor employees
outraged by knowledge of conditions.

Not a single action against the crooks and venal
office-holders has been initiated by Secretary Snyder
or Attorney General McGrath. Not until the head-
lines carried the news did Mr. Snyder express any
indignation, while Mr. McGrath remains silent.

Indeed, several judges and Assistant District At-
torneys have complained at a lack of cooperation from
Attorney General McGrath. Some have charged that
there was a deliberate effort within the D of J to
hamstring even Grand Jury inquiries.

INVESTIGATORS—Neither Cabinet member has
given a satisfactory explanation of why such whole-
sale and generally known criminal skulduggery could
go on beneath their noses for so long. In view of both
departments' facilities for checking up on their em-
ployees, there can be no satisfactory answer.

Both Treasury and Justice have the finest corps
of investigators in the country—Treasury Intelligence
and Federal Bureau of Investigation. Although the
D of J has been operated on a political basis under
the Roosevelt and Truman regimes, that was not true
of Treasury when Henry Morgenthau headed it, with
the late Elmer Irey as chief of Intelligence.

They did not hesitate to land Tom Pendergast,
Mr. Truman's political godfather, behind bars. They
forced Boss Frank Hague of New Jersey to pay heavily
in a tax compromise. They were the first to jail Al
Capone, despite his important political connections
with the Nash-Kelly machine.

FAVORS—The T. Lamar Caudle incident is il-
luminating. He was recently dismissed as head of the
D of J Tax Division by Mr. Truman, not because
of any illegality on his part, but because of his "out-
side activities."

These consisted of engaging in wildcatting op-
erations. He also took a trip to Italy to aid a wine
merchant involved with Italian banks.

His oil operations were known because he urged
former Attorney General Tom Clark to invest money
in it. Mr. Clark, now a Supreme Court Justice, refused
because of the wildcat promoters. But he did not fire
Mr. Caudle. Nor did Mr. McGrath.

In view of the Snyder-McGrath complacency, it
should be noted that the big political patronage and
money no longer consist of appointments to office, as
in the old days.

The really handsome political favors to "friendly"
individuals and corporations are handed out by Treas-
ury, Justice, the RFC, the Federal Trade Commission
and other agencies dealing with big business and
industry.

The Post Office Department, which used to be
the organization's patronage mainstay, is now headed
by a career man. But the agencies where the "paw"
flows are in the hands of presidential cronies and
party politicians.

"WEALTHY"—"In suggesting that President Tru-
man may not run again," writes M. K. of Charlotte,
N. C., "many political analysts speak of his 'wealth,'
and the fact that he can retire on a comfortable in-
come. Just how 'wealthy' is our President?"

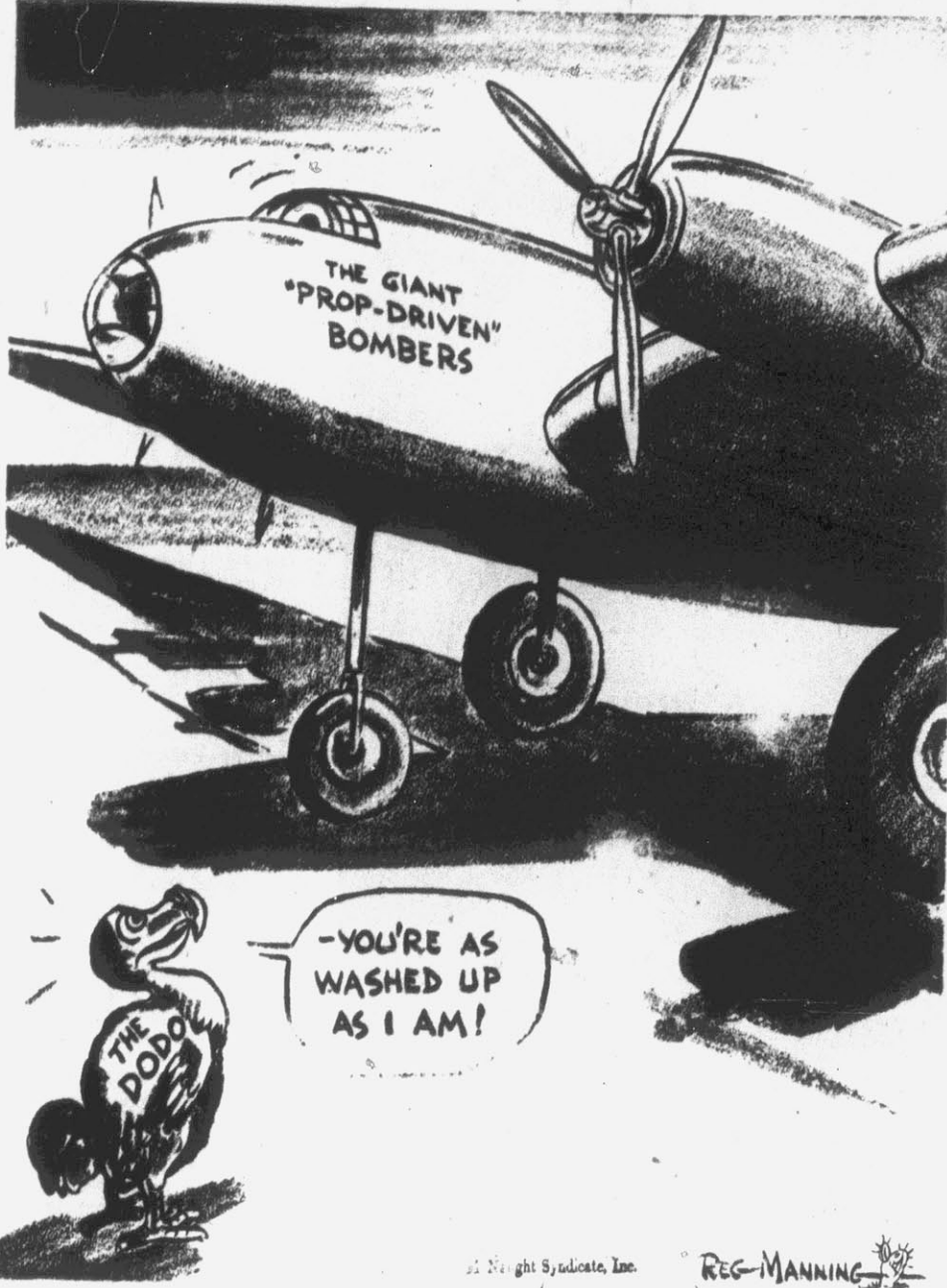
Answer: Income tax experts estimate that, based
on his salary and expense account increases, and a
fairly careful reckoning of his living costs, Mr. Tru-
man will leave the White House in 1953, if he does,
with between \$200,000 and \$300,000. He was a rela-
tively poor man when he came to Washington.

to live in style in Independence, Mo., where he owns
his own home. Then there will probably be extra
income from writing and speaking and similar sources.
It should also be noted that Margaret's income almost

Around Capitol Square

LINE—The white lines

marking traffic lanes on paved
streets and highways have long
been familiar to motorists. The
lines are black when the pave-
ment is white cement. These
lines are fairly well observed.

Within recent months there have
been added other lines of yellow
paint at dangerous points along
the highways. These yellow lines
are not respected as they should
be by automobile drivers. Robert
A. Burch, traffic engineer for
the state highway commission, is
authority for the estimate that
traffic accidents would be re-
duced by at least fifty percent
if these yellow warnings were
followed. The rule is very sim-
ple: Don't cross the yellow line
if it is on your side of the white
(or black) lane designation. Mo-
torists sort of unconsciously stay
on their own side of the center
line. Maybe in a few years they
will have the same kind of un-
conscious reaction to the yellow
lines. That will mean safer driv-
ing for everybody.

POLICY—It is the policy of
the highway commission to put
center lines on all paved roads
carrying daily average traffic of
300 vehicles or more. Pursuant
to that policy, the commission this
year painted or repainted some
12,000 miles of center lines, and
there were several thousand
miles of previously painted lines
still usable. In addition to the
center-lineing, there were painted
some 3,000 miles of yellow
warning lines. Practically all of
the lines painted during the past
year were of "night-shining"
paint, greatly increasing effi-
ciency of the purpose—which pri-
marily is to warn motorists when

they are out of line or when
getting out of line may be haz-
ardous to themselves and others.

The lining job is about over for
this year. The work cannot be
done satisfactorily in
cold weather, because the paint
does not flow freely through the
spray guns and does not dry
quickly enough on the pavement.

That fast-drying business is
right important. One of the big-
gest worries of the line painters
is the way motorists zig-zag
back and forth across freshly
painted lines, making a mess of
the highway and largely defeat-
ing purpose of the warning lines.

STANDARDIZED—Nearly
thirty years ago the late Frank
Page, then chairman of the state
highway commission, wisecrack-
ed that it "is harder to get
lost in North Carolina than it is
to find your way in most states."

That is not true now, because
highway markings have been
standardized. Different states use
different colors for some signs,
but the shapes are the same—
and in every state an octagon
sign means stop, a round sign
with crossed bars means a rail-
road crossing. In every state,
too, the center lines on pave-
ment mean the same thing. There
is right now some discussion
about universal adoption of a
standard color scheme for the
warning barrier lines. It seems
that in states where there is a
lot of snow and white lines would
be invisible, yellow or orange is
used for center-marking. That
does not affect the virtue of the
idea of having additional lines to
warn drivers of dangerous con-
ditions on the roads. Presently
the legal warning color is this

state: yellow.

SAFETY—Speaking of safety
warning signs, and markings
calls to mind the fact that de-
spite a depleted record of traffic
accidents in North Carolina sev-
eral state organizations have won
awards for good safety records.

Latest to be announced is first
place winner for the N. C. Motor
Carriers Association in the na-
tional truck safety contest. The
trophy will be presented at a
dinner meeting scheduled for the
Sir Walter Hotel in Raleigh on
the night of December 6. The
North Carolina group won the
award in competition with fifty-
one other regional, state and lo-
cal truck associations through-
out the United States.

HOT STUFF—Another feather
in North Carolina's cap is an
announcement that General Electric
has acquired the plant of the
National Chair Company at Ashe-
boro and will concentrate manu-
facture of automatic electric
blankets there. The project is
being moved from Bridgeport,
Connecticut. Several reasons are
given for selection of the
Asheboro site. Among them
is proximity to plants which
manufacture the blanket fabrics
at Elkin, Spray and Swannanoa.
Another is climatic conditions.
An important one is availability
of suitable labor, adequate power
and transportation facilities. Still
other reasons include the good
salesmanship of the state divi-
sion of commerce and industry,
the Asheboro chamber of com-
merce and the Carolina Power
and Light Company.

THE AMERICAN INDIAN

(Wilson Daily Times)

Tollie Epps called our atten-
tion to something that's gener-
ally known but seldom publicized.
It's how the welfare state in Amer-
ica works for the Indian. Sup-
posedly, he has everything he
needs including medical atten-
tion. Actually, he has next to no-
thing and the infant and tubercu-
lar mortality rates are shock-
ing. Yet the government pays
\$40,000,000 for the Navajo
tribe alone. What's wrong is that
it doesn't filter down to the In-
dians. Administration, which
means bureaucracy, takes most
of the money.

As many educated Indians have
explained, they'd be better off
if they weren't wards of the gov-
ernment. For then, like immi-
grants, they could shift for them-
selves. But they're under the
welfare state. And what is ap-
propriated to feed, house and
clothe them goes not for that,
but to maintain fat politicians
in office. Seventy-five per cent
of the Indians are illiterate, as
against colored illiteracy of 16.1
per cent and white illiteracy of
1.5 per cent. It's not something
that's new; it's been going on for
the 125 years that the Indians
have been our wards.

Wouldn't all that happen to us
if we were under the welfare
state? If you're curious, look at
any county home. Those bereft
people are cared for, in a way;
but much is lacking that elderly
people would love. The men who
should be looking out for the wel-
fare of the Indians hold them in
contempt; their sympathies lie
elsewhere. Would not the same
type of men be running your wel-
fare state, if you had one. And
would they not look with contempt
on the innocent victims who had
to apply? The treatment of the
Indians should stand out as an
apt illustration.

Business Today

If you think you have troubles,
consider your Congressman. Or
Secretary of the Treasury Syn-
der. Or President Truman.

They have more tax worries
than anybody.

This is the situation:
Even with the higher tax rates,
federal income will be from \$62-
500,000,000 to \$65,000,000,000 in
the year ending June 30, 1952.
The federal outgo for the same
year is expected to be about
\$75,000,000,000. The shortage can
be made up by borrowing. But
eventually it will have to be paid.

Except for the doubtful possi-
bility that real disarmament can
be worked out, federal expenses
for the succeeding year will be
higher and there are demands for
a larger Army, a 140-group
Air Force and a bigger Navy.
Congress appropriated \$88-
000,000,000 this year (19 million
more than is being spent) and
this may be a rough measure
of the next budget.

The question of where the money
will come from Congress and
the Administration's galling
headline, Secretary Snyder
isn't talking. He is giving the
taxpayers a few months psy-
chological rest. But you can bet
he isn't having any himself.

Congressional tax leaders said
last year that the limit of in-
come taxes had been reached.
Roswell Magill, former Under
Secretary of the Treasury, wrote
recently in the Saturday Evening
Post that a 100 per cent tax on
all taxable incomes over \$4,000
would be needed to meet the
\$10,000,000,000 increase the Ad-
ministration was asking. (It got
\$5,750,000,000, only \$2,480,000,000
on personal incomes.) Corpora-
tion rates range up to 52 per
cent; there's not much wool left
there. High liquor taxes have
brought back the bootlegger; a
further rise might make him se-
mi-respectable. Business is com-
plaining that other excise taxes
are hurting them. Some of these
levies are approaching diminish-
ing returns.

What's left? There's talk about
a federal sales tax. A committee
in Washington is studying that
and a "transactions" tax which
would be levied every time goods
changed hands. And there is
some talk about a national lot-
tery, which would be vigorously
opposed from many quarters.

Unless someone comes up with
a new idea, the only other alter-
native is more inflation—further
borrowing or the creation of money
by other means—which is a
tax on savings, annuities, pen-
sions and the like.

**RETAILER'S AD
DEFENDS HIGH TAXES**

Although others may be dis-
mayed by present and coming

tax rates, Max Hess, Jr., Allen-
town, Pa., retailer, has placed
ads in Pennsylvania newspa-
pers stressing the necessity of
high taxes in the world crisis,
concluding: "We must face the
onset of these next big-spend-
ing years with dogged determina-
tion to see them through. There
is no other way—except the way
of surrender to Stalin. And to
that we can never sink."

Congressman Francis E. Wal-
ter (D., Pa.) has promised to
read the advertisement into the
Congressional Record.

**HOUSING STARTS TOTAL
SURPRISES BUILDERS**

The National Association of
Home Builders regards the La-
bor Department report that 88-
000 new dwelling units were
started in October as "startling-
ing."

"In spite of Regulation X, al-
most no market for 4% GI loans
and fear of copper and steel
shortages early next year, home
building continues at a surpris-
ingly high level—at least 1,100,000
starts for 1951," the association's
Washington letter observes.

**UNSURVEYED, PROMOTER

bert Barschoff, 36-year-old vice
president of the Eastern Brass
and Copper Co., a metals ware-
house and processing firm.

"The small businessman today
is bewildered by restrictions on
the use of basic metals—brass,
copper, aluminum and steel," he
said.

"He can't get enough material
to continue full manufacture of
consumer goods. He can get ma-
terial to work on defense con-
tracts—but he isn't getting these
defense contracts fast enough to
stay in business."

Barschoff said there are "thous-
ands and thousands" of small
firms facing suspension of
operations.

"It is an odd thing to say,"
he remarked, "but they are be-
ing hurt more by a percentage
war than in an all-out war. In
an all-out war the government
needs things in a hurry, and the
contracts filter down quickly to
their level."

"There were a lot of casualties
in the last war. Some of those
who survived then, say they are
having even tougher going now."

"They're drowning. Any num-
ber won't be able to survive until
the third quarter of 1952, when
the government hopes to release
additional quantities of aluminum
and steel for civilian use."

Barschoff held a pioneering
"shirtleeve conference" at his
own plant last summer to at-
tack the problem. He brought to-

Rabies Season Is Not Necessarily During Dog Days

NEW YORK—(AP)—Now is the time to prepare for mad dogs and the risk of rabies from their bites.
The belief that the hot, summer dog days have any connection with rabies runs the year round, but it increases in late winter and spring.
The prevention is something the U.S. Public Health Service would very much like—namely to vaccinate all dogs. That is the only measure which will stop the disease.
In most areas the public is indifferent, until a rabies scare strikes near home. Then there is a clean-up. Meanwhile in other areas nothing has been done.

Last year nine persons died of rabies in the United States and 7901 animals. Many wild animals died without getting into the census, which is kept by the Federal Security Agency, Public Health Service, Communicable Disease Center, Veterinary Public Health Service.
The big fact is that rabies has been spreading in the United States for some years. The increase is not marked, but states hitherto rabies-free are coming into the mad areas each year. Last year added Nebraska, South Dakota, Montana and Washington.
Getting rabies is more alarming than you think, because it does not necessarily strike you down quickly. Many months afterward when you may have forgotten even that you were bitten, rabies can come on and kill. It seems to depend on how bad the bite and on the person. In last year's human deaths the quick-rabies came on in about two weeks, and death came after two to four days illness. In these quick cases immediate administration of rabies vaccine did not the least good.

The long delayed rabies cases are numerous. A boy on the way to school was bitten by a stray dog. It was a minor wound on his hand. Nothing was done for him. Five months later he came down with rabies. He died in four days.
A man was bitten by his own dog, which had been immunized. The trouble was that the bite came after the immunizing period (thought to be one year) had run out. This man had rabies and died a month and a half after the bite. Another was an 18-year-old girl bitten by a small dog playing in a school yard. Rabies came on and killed her three months later when only her friends could remember about the dog bite.

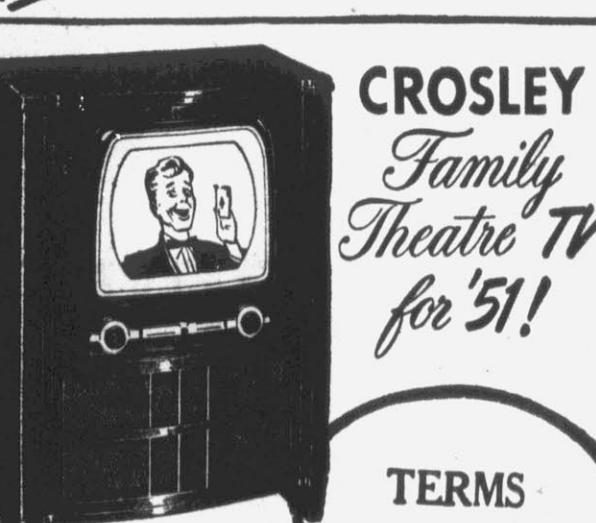

NCAA TV Blackout Called "Unlawful"

LOUISVILLE, Ky. (UP)—The court. In turning down requests to lift the "blackout" on today's game, the NCAA television committee said to do so would "upset an experimental program which has been scientifically prepared and carefully thought out." It pointed out that Louisville received football television on seven Saturdays and was blacked out on three, just as were the 51 other cities in the program.

University of Kentucky authorities said they would not attempt "outlaw" television of the game. Permission to televise was refused because the game is not included in the NCAA plan for "experimental" television of games this season.

But a statement by acting Assistant Atty. Gen. Newell A. Clapp of the anti-trust division of the Department of Justice promised to have far-reaching effect on any future NCAA television schedules.

In response to a telegram from Gov. Laurence Wetherby of Kentucky, who demanded government action on the ban, Clapp wired: "If the universities of Kentucky and Tennessee are of the opinion that NCAA restrictions are illegal, the decision as to whether or not to permit the telecast of the game is in their hands."

Clapp also informed Wetherby that the department "is greatly concerned with the entire problem of concerted action to restrict the telecasting of sports events, professional as well as amateur." He pointed out that a test case on the legality of such restrictions is now pending in Philadelphia federal court.

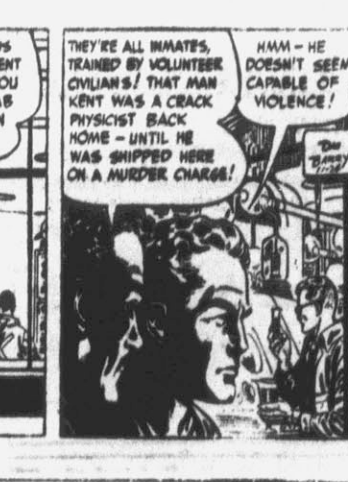

Follies Director Speaks At Exchange Club Meet

John Farrow, a resident of London, England during the great German blitz in World War II, and who directed the Service League's show, "Follies of 1951," was guest speaker at the Exchange Club last night.

Farrow, who is spending the Thanksgiving holidays with Ed and Mrs. Parkinson in Greenville, was caught up in the excitement of the show, "Follies of 1951," was guest speaker at the Exchange Club last night.

Farrow said he was appalled at the instructions being posted by civil defense units in schools and other public places, to be followed in case this country is attacked by many planes.

"Due to lack of experience," he said, "our civil defense leaders advise us to gather in a basement or other low building spot; or, if caught in the street to lie in the gutter. In England during the war our people soon learned that a basement is the worst possible place to seek shelter during a raid, since water mains frequently burst and electric power lines are exposed and gas mains are broken. As a result, basements are flooded with water, and naked electric wires and gas fumes are a menace.

"What our civil defense leaders forget," Farrow said, "is the human element of panic."

Citing a case of 420 Londoners killed in a mad rush to a shelter during the war when a young baby cried and the mother screamed, causing a mad scramble, Farrow warned against panic during a raid.

He said the best thing to do during an air raid is for each member of the family to sit quietly away from windows, separated from other members of the family. "This prevents panic," he said, "and gives each individual a chance to survive by using his own judgment. Rescue units can rescue survivors quickly after a raid and effect a quick rescue when panic is not present," the speaker said in conclusion.

Mossadegh Asks National Election In Iran's Crisis

TERHAN — (AP) — Premier Mohammed Mossadegh's government announced today it would call for immediate national elections and challenge parliament's decision to delay them until Dec. 18.

The surprise move came a day after the aged premier's return from a 47-day flying tour to the United States and back by way of Egypt. He conferred five and a half hours yesterday with Shah Mohammed Reza Pahlavi and presumably got royal support for his new decision.

The big issue is the Iranian financial crisis arising from the loss of royalties that formerly came from the Anglo-Iranian Oil Company, now nationalized by Mossadegh's regime and idle.

Mossadegh failed to get more than a promise of serious consideration on his request for a loan on a visit in Washington with President Truman.

Suez Gun Fight Flares In Dockyards; 4 Killed

SUEZ CANAL ZONE (UP) — The British announced today that four Egyptian terrorists were killed and a fifth wounded in a gun fight in the Port Said dockyards yesterday.

A military spokesman also announced that a machinegun ambush of a British military police vehicle was attempted last night, and one British soldier was stabbed in a third incident.

The deaths of the Egyptians raised the toll in the Suez Canal zone to 24 since last Saturday night. Eight Britons have been killed and 12 Egyptians were killed in riots last weekend.

The spokesman said five terrorists tried to cut through the wire barricading the British occupied area of the harbor. When discovered, he said, the Egyptians opened fire, then jumped into the water.

When they refused to turn back, British guards opened fire.

A British soldier just inside the dock gates was stabbed twice in the arm by three Egyptians who made a quick attack and then fled, he announced.

The machinegun ambush occurred in Ismailia. There were no casualties but traffic on the road was halted for the rest of the night.

In Cairo, the general congress of the Egyptian Chamber of Commerce declared a boycott on all British goods, trade companies and banks. It urged traders not to import any goods from Britain and urged by local manufacturing and imports from other countries.

The congress asked the Egyptian press to cease publication of advertisements for British goods.

Continued Warm

Summer temperatures were prevailing in the Greenville area yesterday and today and the Weather Bureau recorded 75 degrees here yesterday afternoon. This is in striking contrast to the cold weather here the earlier part of the week.

Lowest temperature here last night was 52 degrees, and at 8 a.m. today the mercury stood at 57. No rain, but lots of dew last night, Mrs. Carl E. Maiden, local observer, reported.

Yesterday a year ago, the highest temperature here was 66 degrees. Lowest that night, 30, and at 8 a.m. next day it was 40.

Skiing Togs Can Cost You Plenty

DENVER — (AP) — Plenty of skiers dress for less, but a deluxe outfit can cost as much as \$250.

Let's assume you want a pair of the new head skis which have become quite popular in the West in the last few years. The cost is about \$75 a pair. A new ski boot making its appearance here has a \$51.50 price tag. You can pay as high as \$40 for ski pants, \$40 for a hand-knit sweater, \$10 for gloves, \$12 for poles, \$5 for a hat, \$7 for goggles, \$3 for socks and \$10 for "longies."

Of course, you can always pull on blue jeans or a pair of old wool slacks, dig out a couple of sweaters and then rent skis, poles and boots from a sporting goods store for \$2.50 per weekend.

Ending Of Trade Concessions Not Hurting Russia

WASHINGTON (UP) — President Truman's order wiping out all trade concessions to Russia and Poland and banning importation of seven of their furs has more political than economic importance, government economists said today.

They said U. S. trade with those two Iron Curtain countries already is down to a trickle. But the order, they added, will point up to the entire world the split between the United States and the Reds.

It ends the anomaly, they said, of the Soviet Union and its satellites enjoying "most favored nation" treatment in trade with this country, while at the same time they are trying to undermine this nation and its interests.

The order, which becomes effective on Jan. 8, will leave only one trade agreement program — a treaty on customs matters with Hungary — in existence after that date. The Hungarian treaty cannot be terminated until July 5, 1952.

Dying Doe Gets In Her Last Kick

A female deer usually is the gentlest of creatures, which is why Ronnie Abe was so chagrined over what a doe did to him.

Abe dropped the doe with one shot. When he walked up to it, the deer sprang up, kicked him on the left foot and ran 40 yards before dropping again, dead. The kick ripped Abe's boot and left him with a wound which required three stitches.
